FIG. 7 is a right edge view thereof.

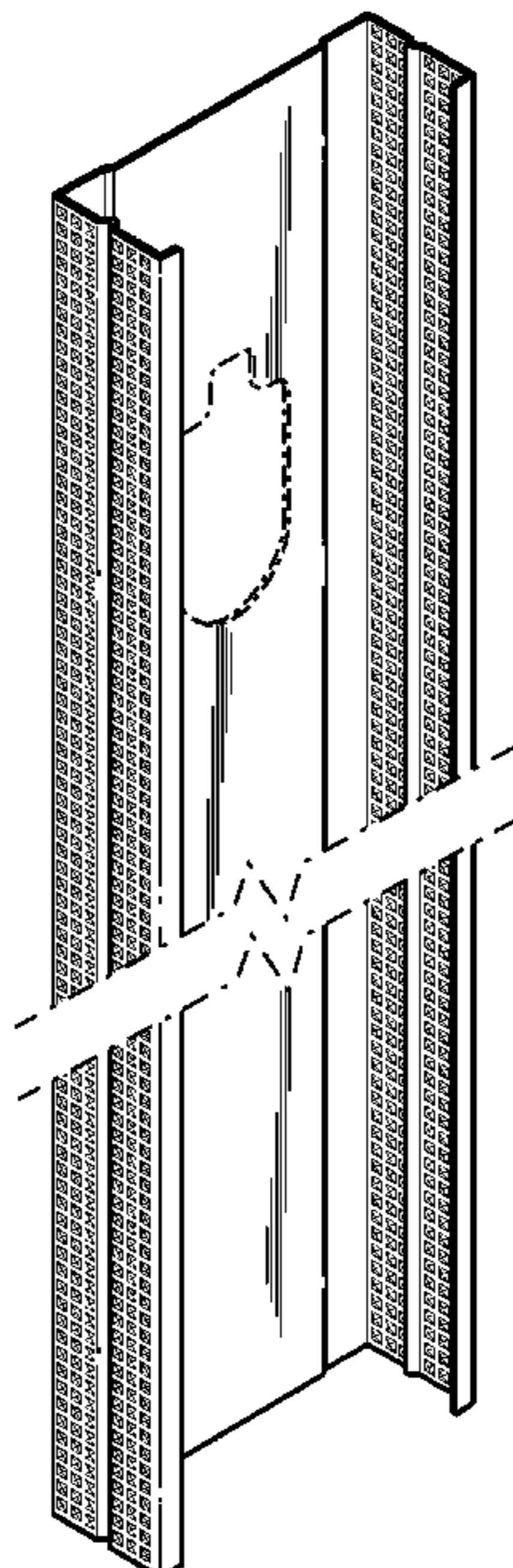
The broken-line disclosure in the figures illustrates that the

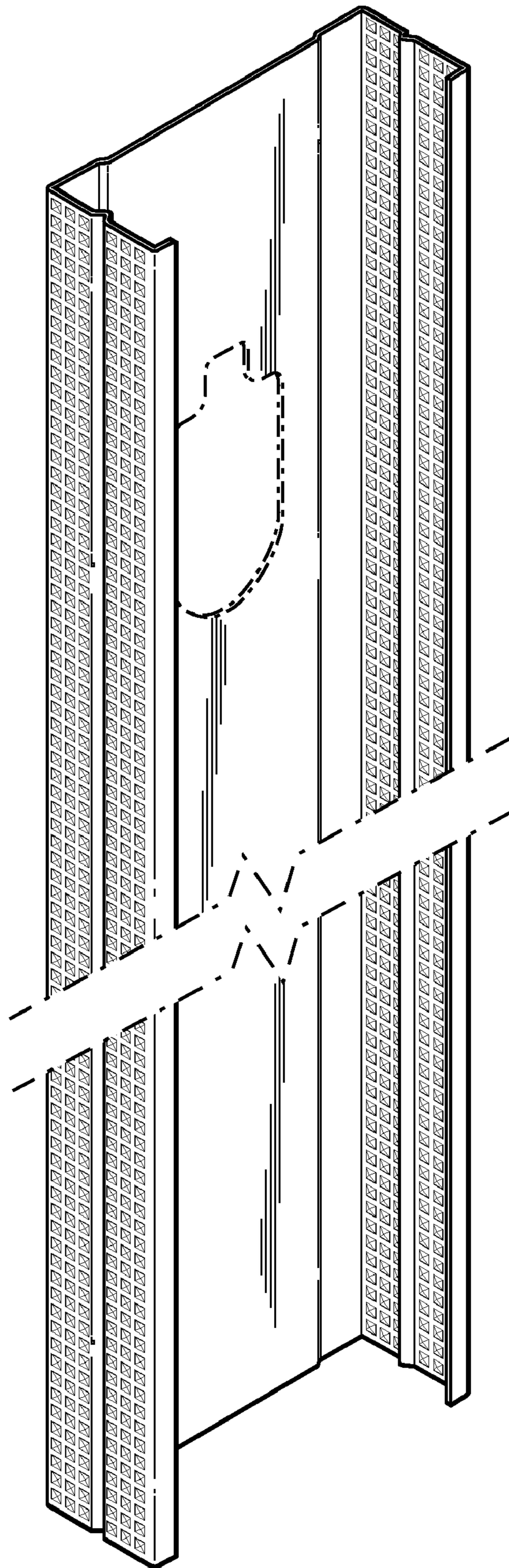

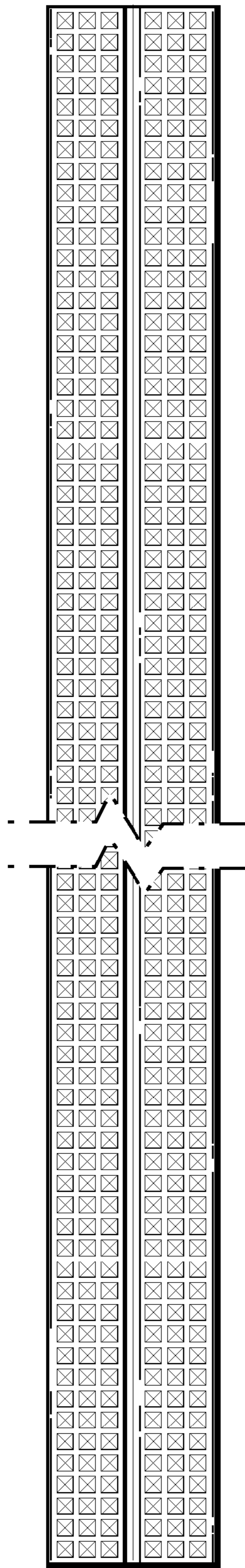

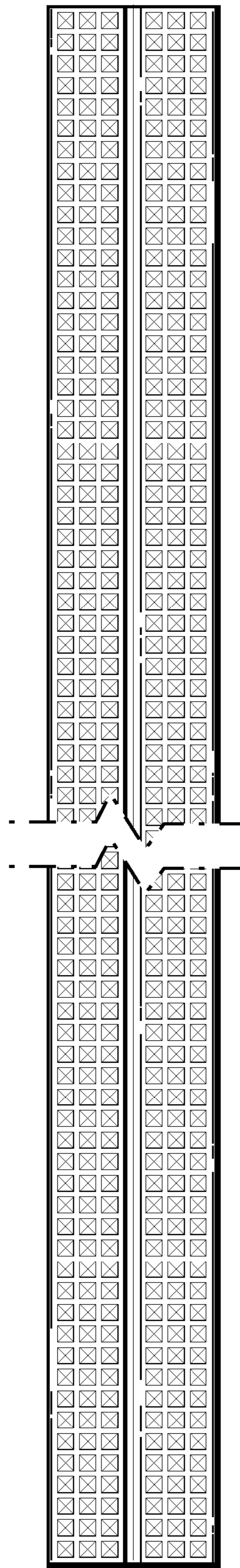

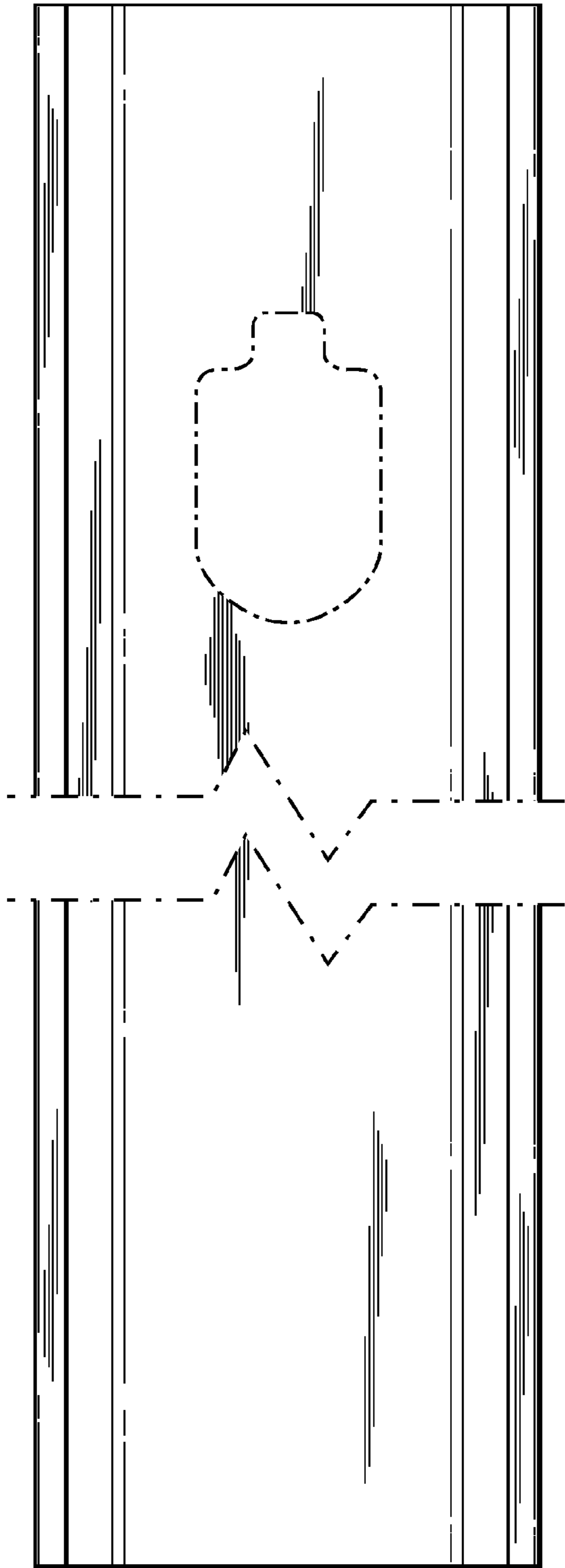

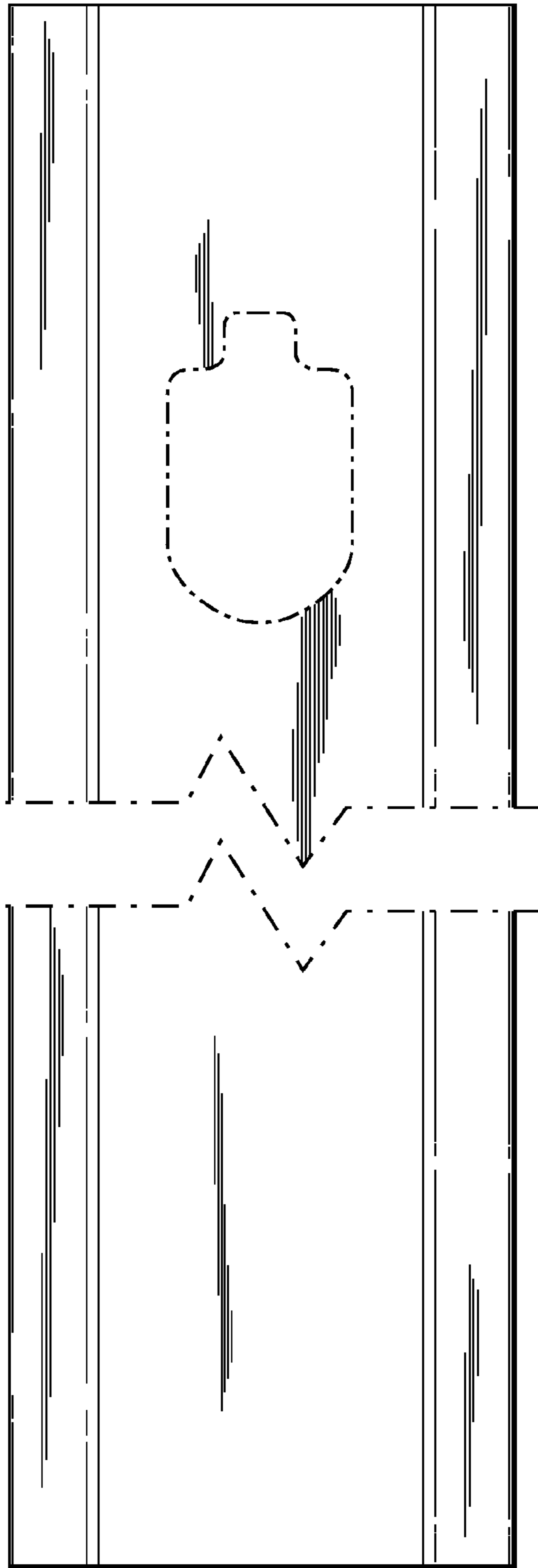
