FIG. 1 is a perspective view of decorative features for a shoe showing my new design.

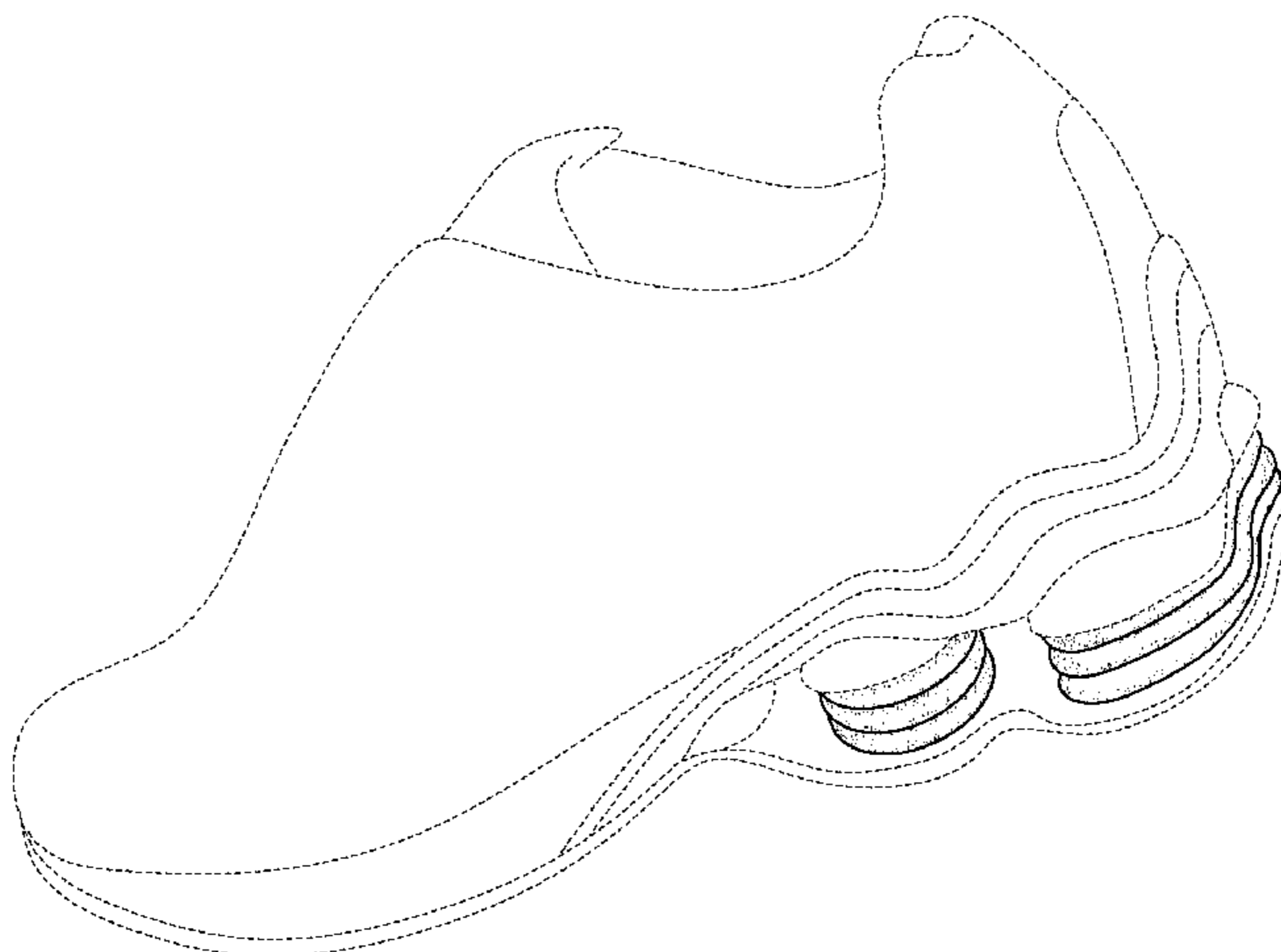
FIG. 2 is a side view thereof.

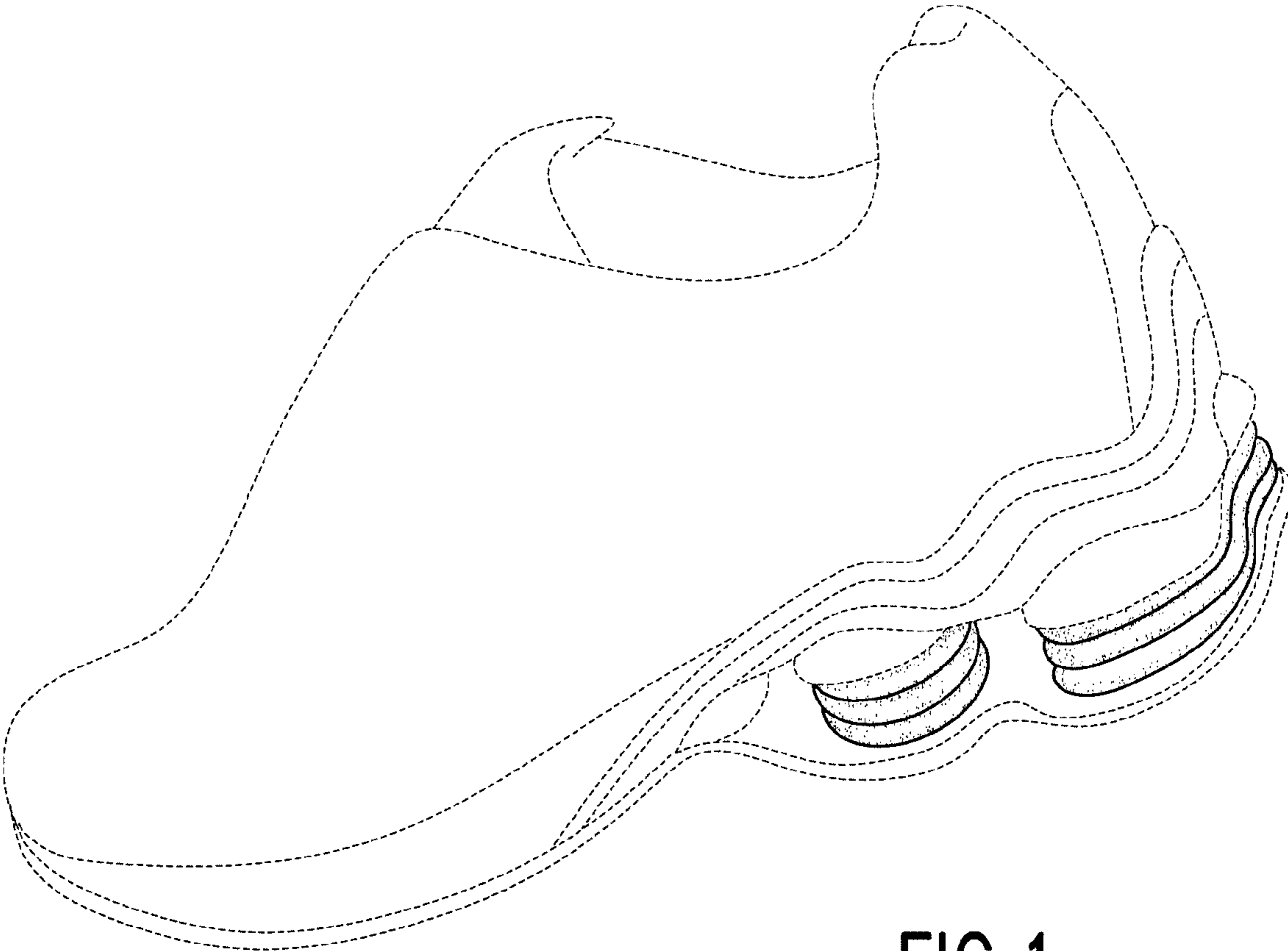

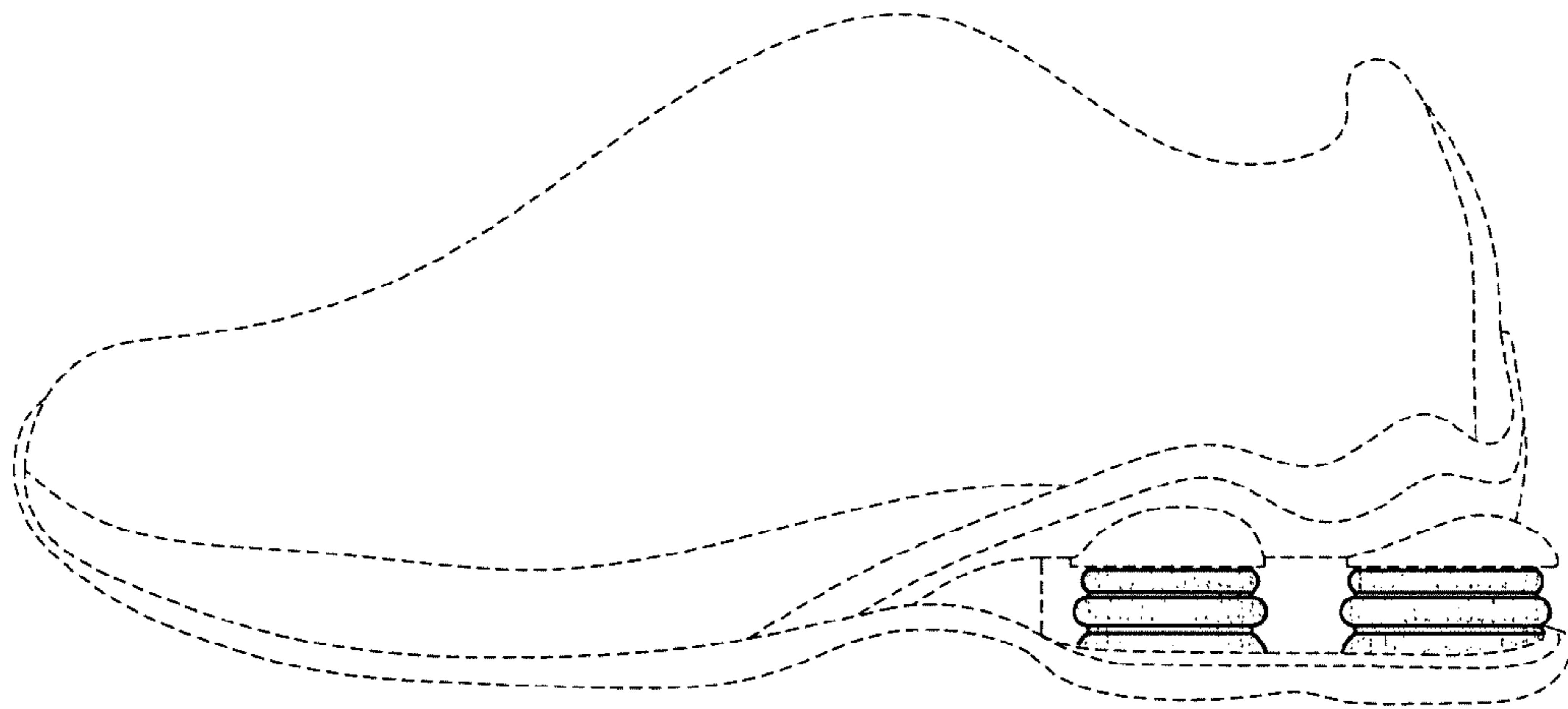

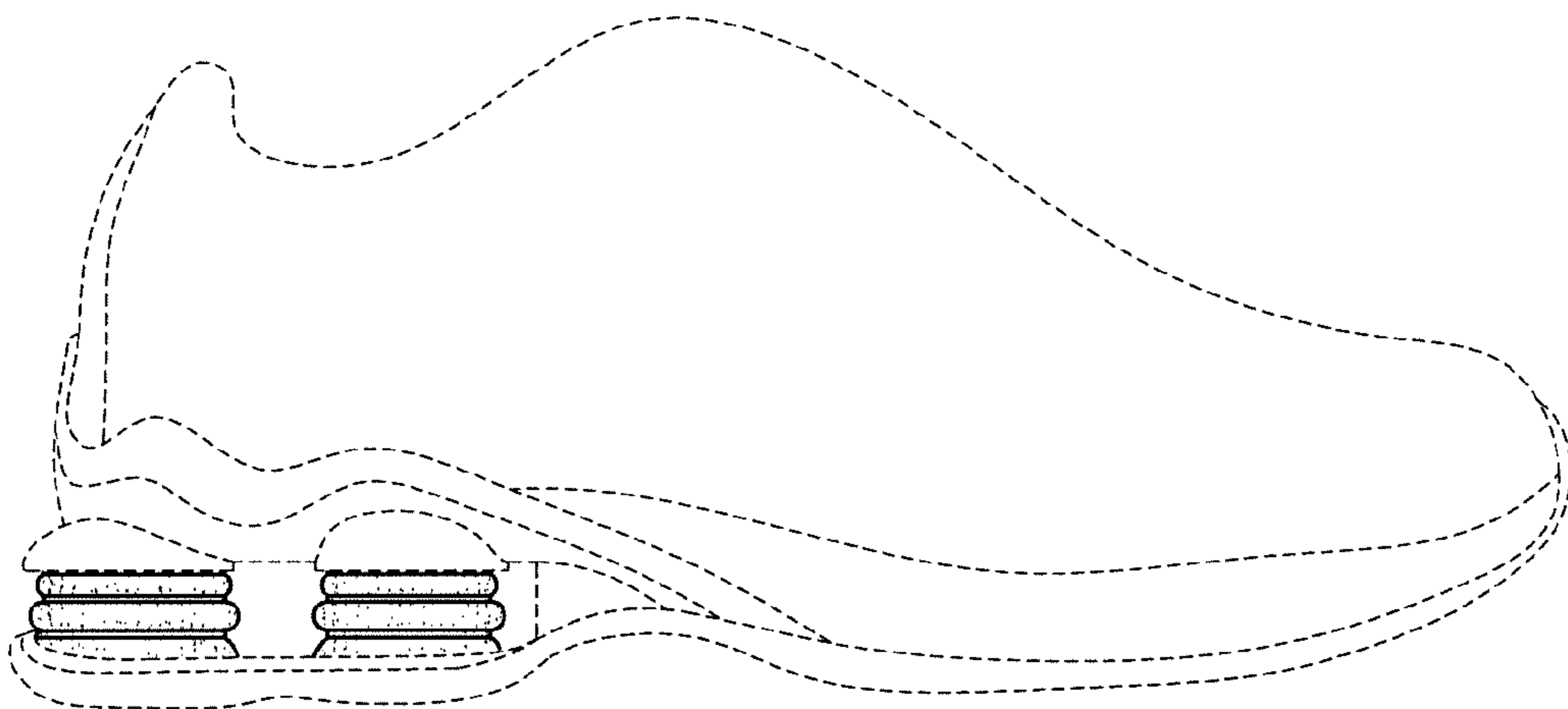

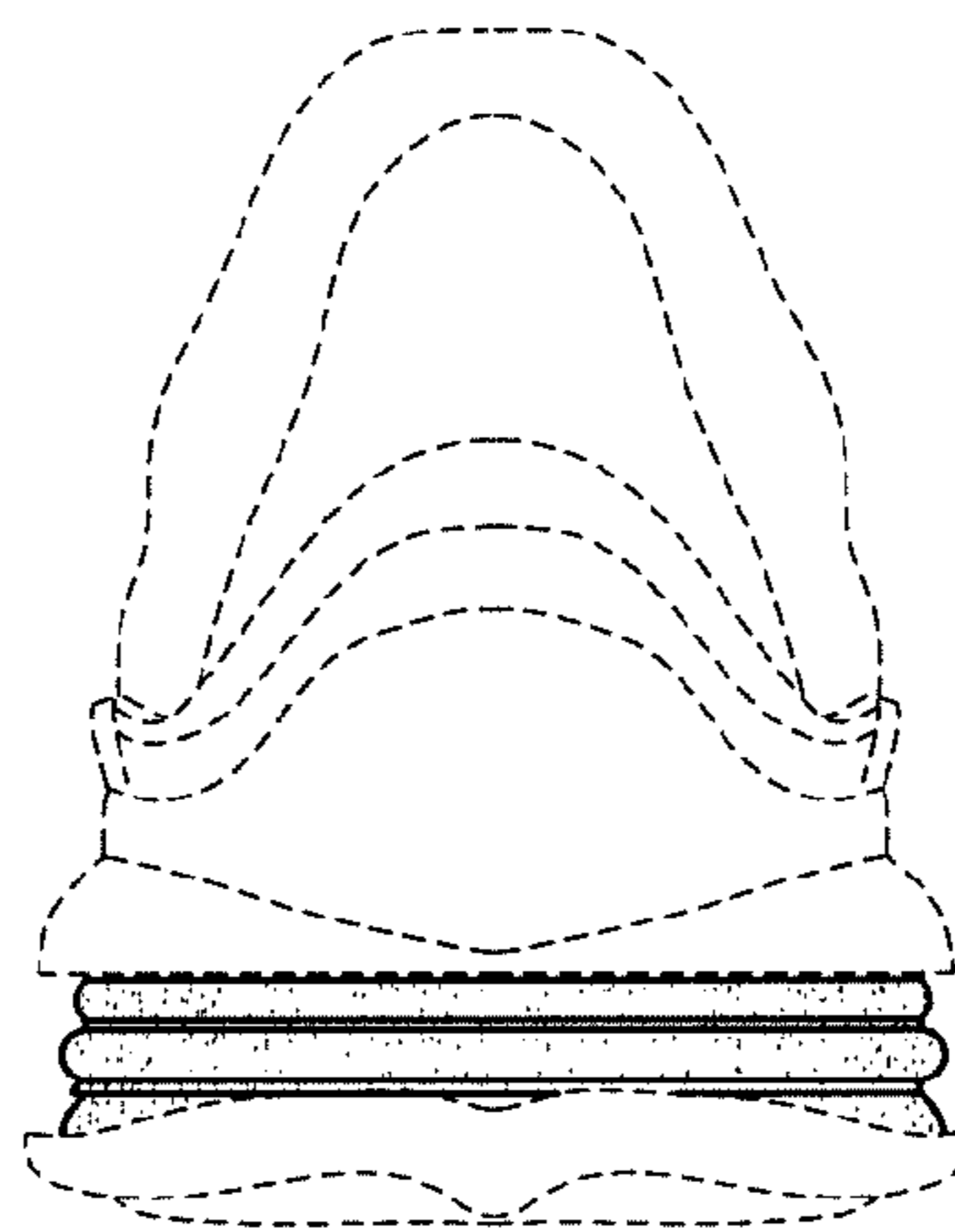
