FIG. 2 is a front right perspective view from above of the hatchet of FIG. 1;

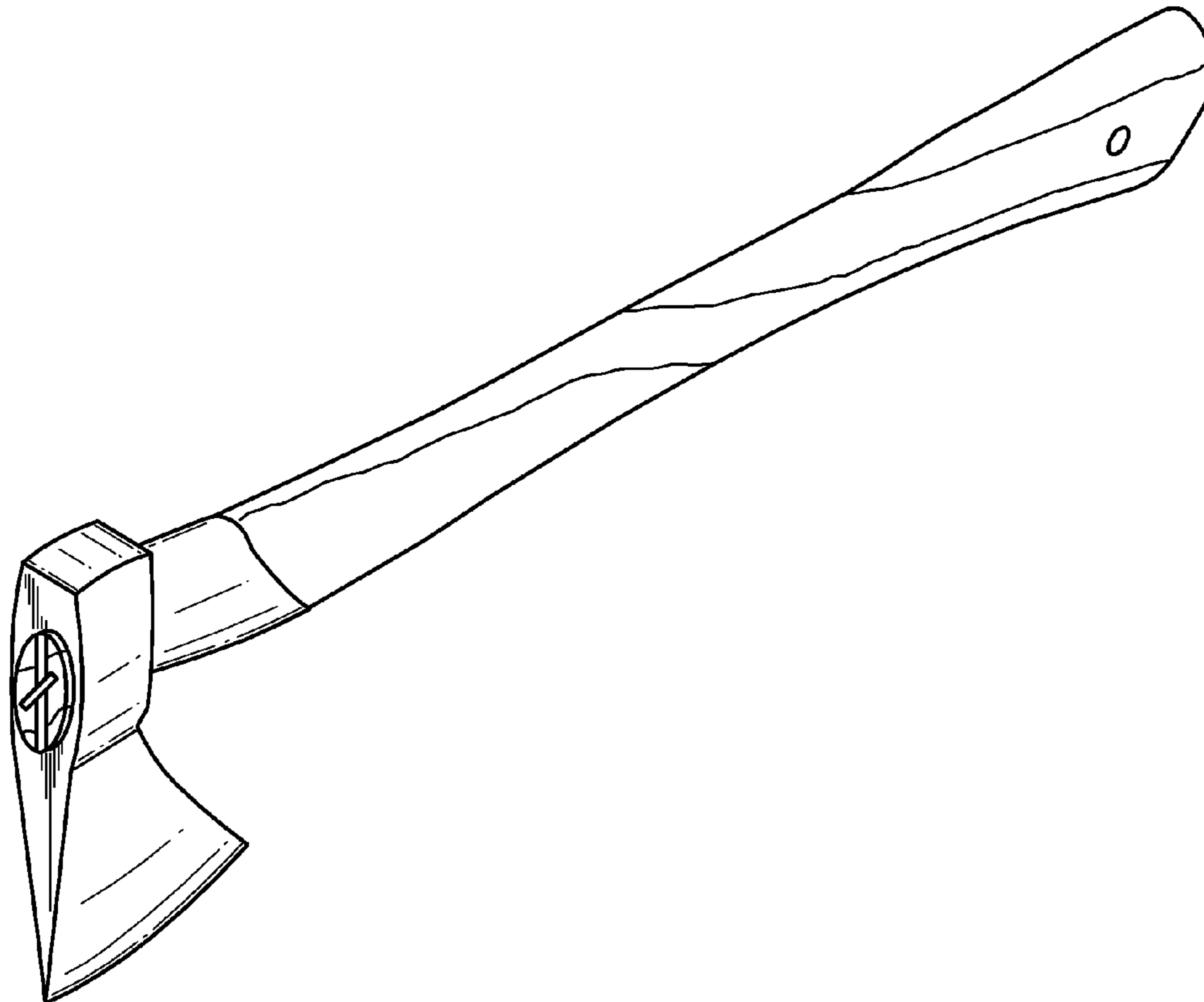
FIG. 3 is a rear right perspective view from below of the hatchet of FIGS. 1 and 2;

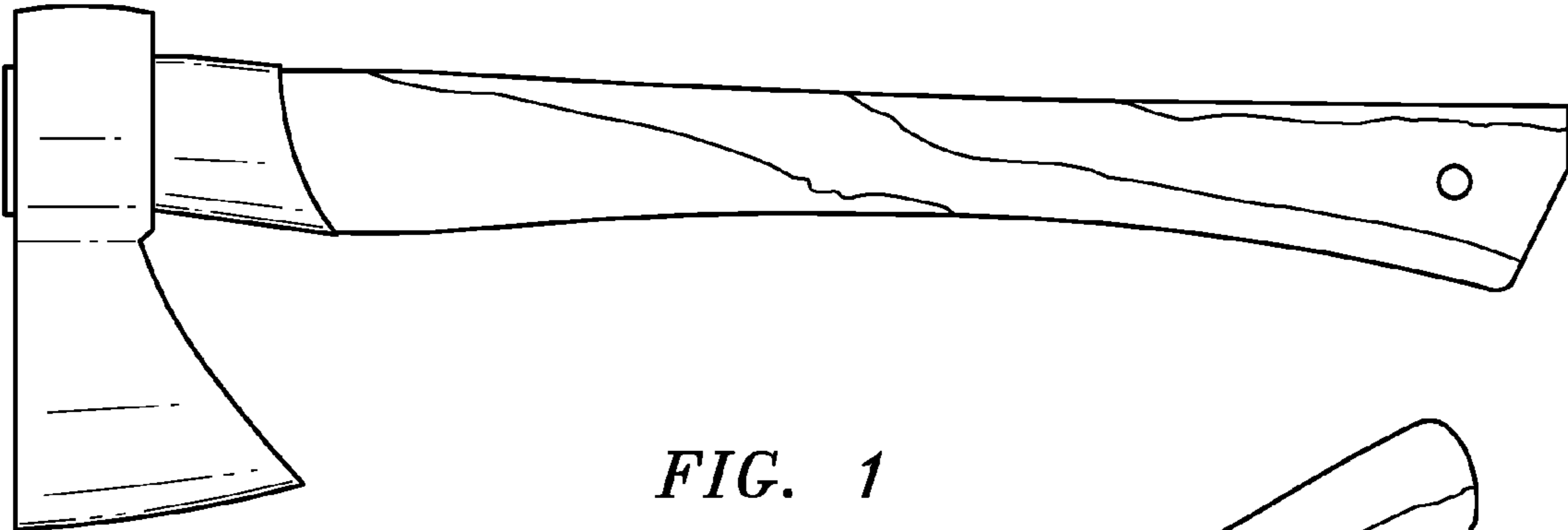
FIG. 4 is a top plan view of the hatchet of FIGS. 1-3;

FIG. 5 is a bottom plan view of the hatchet of FIGS. 1-4; and,

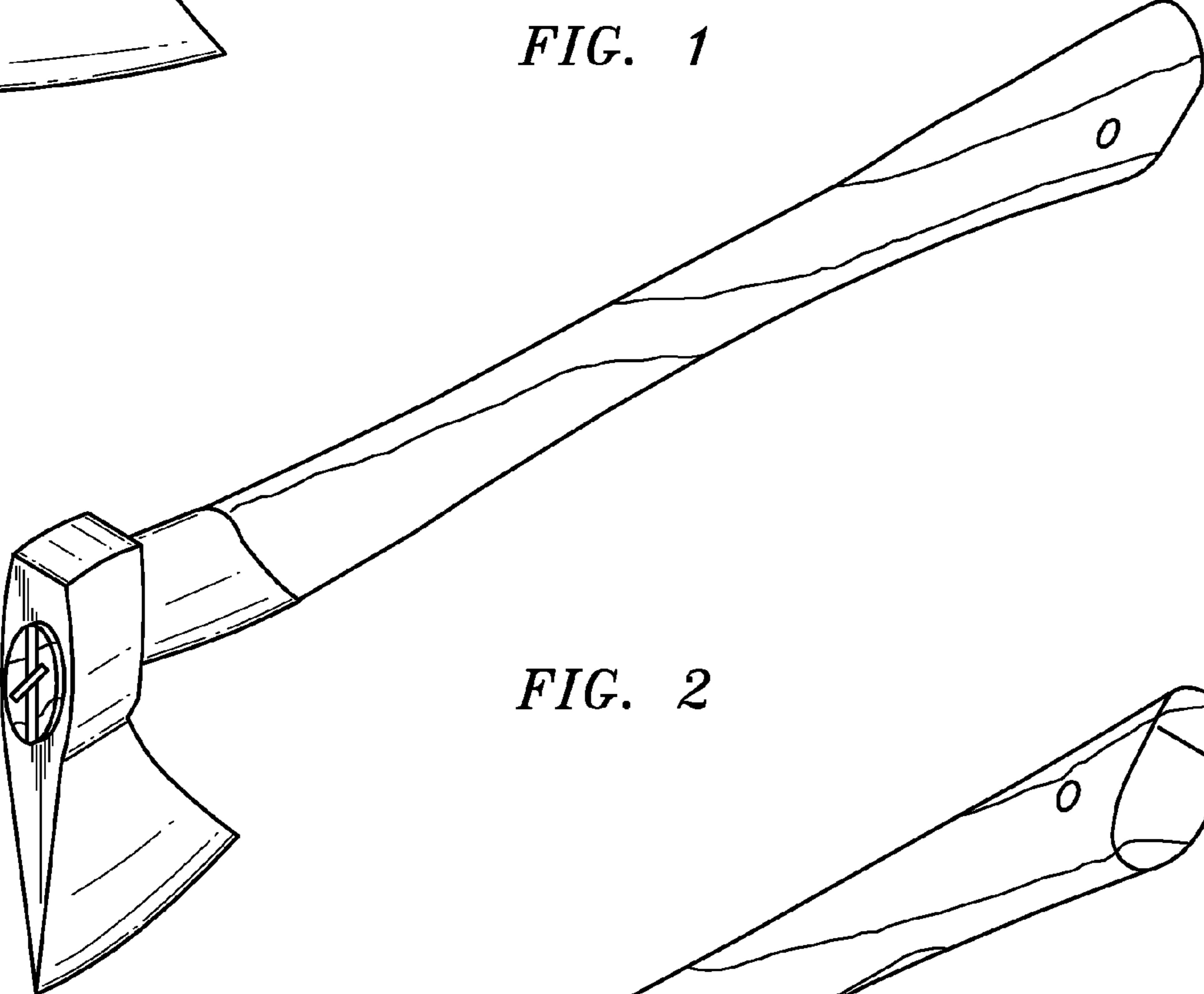
FIG. 6 is a left side elevational view of the hatchet of FIGS. 1-5.

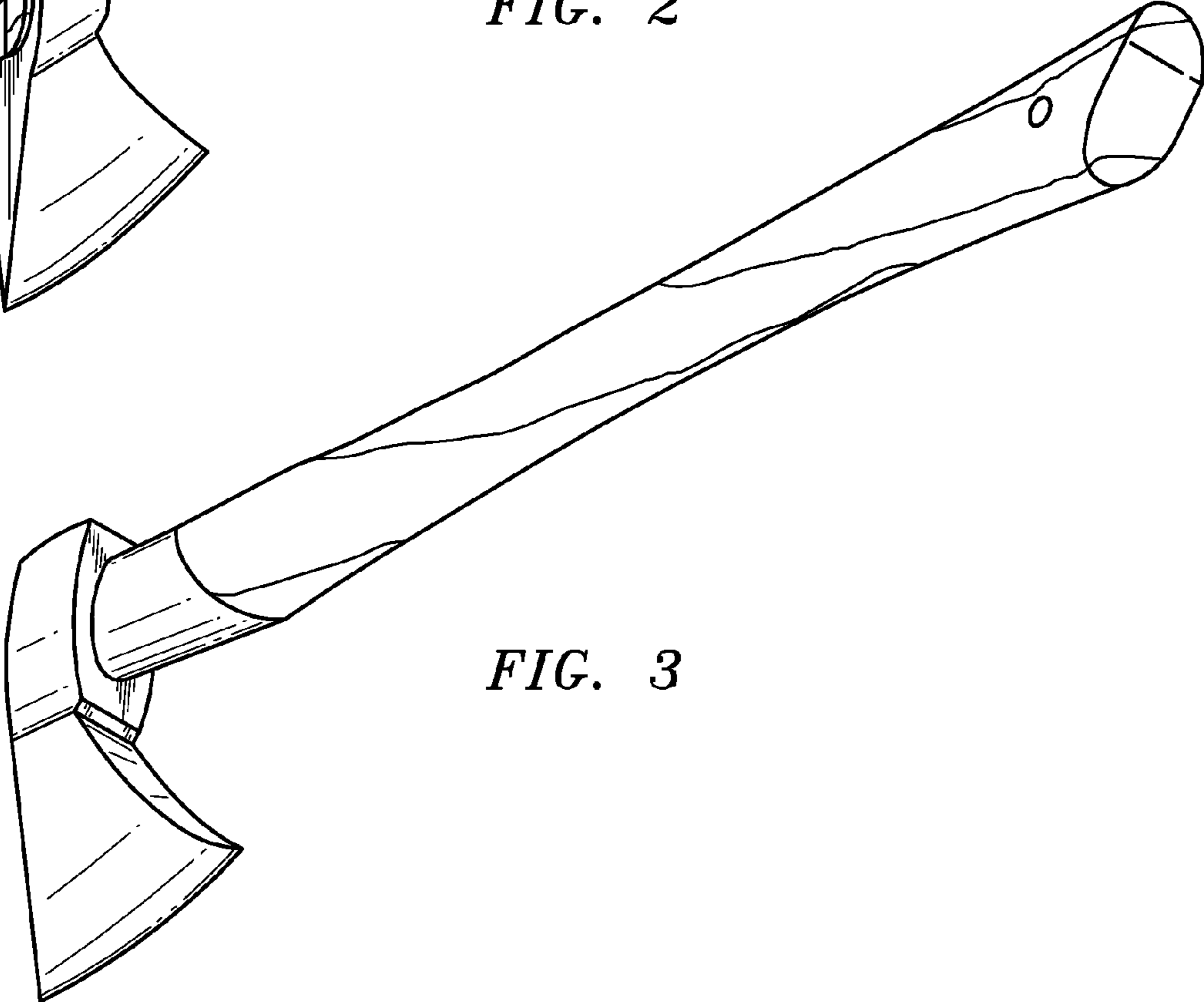

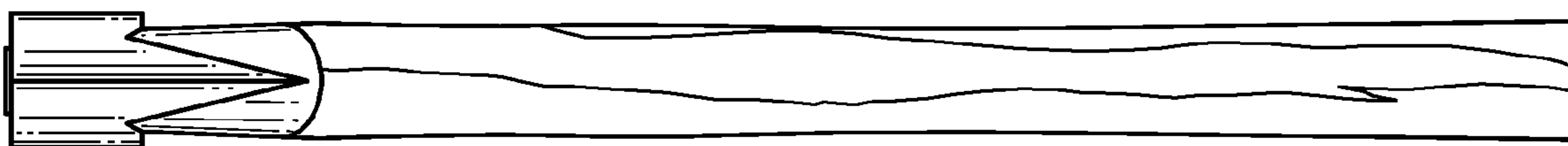

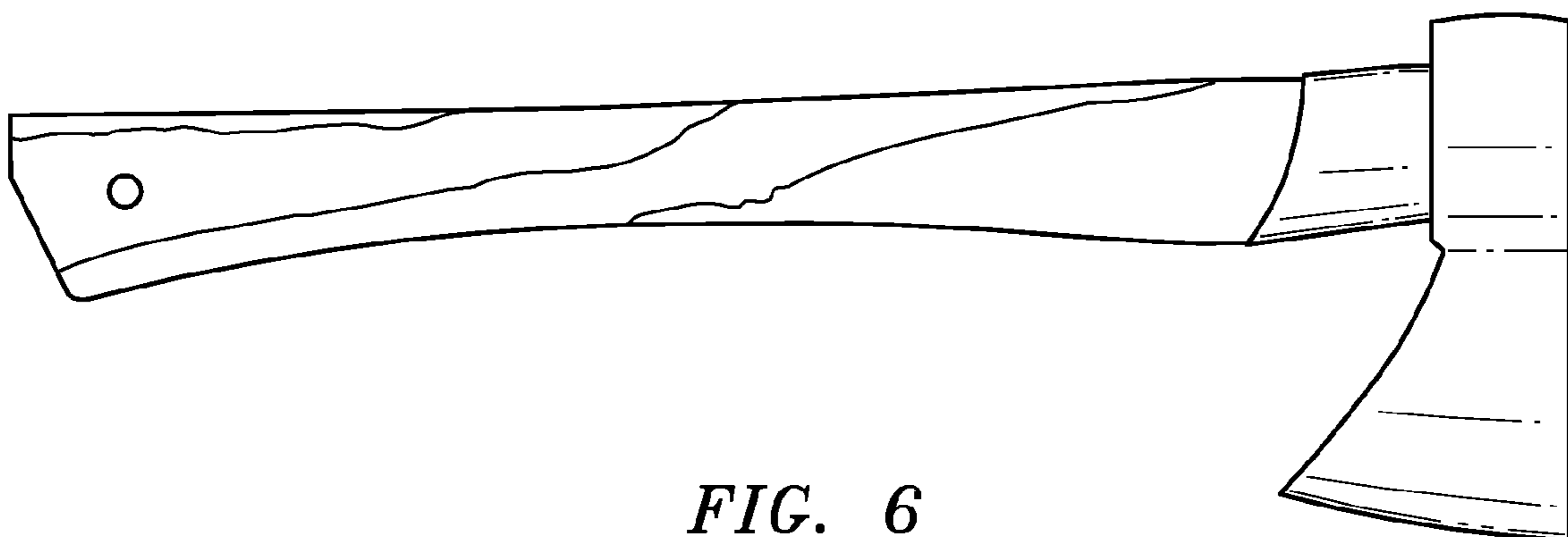
