The ornamental design for a top broom clip, as shown and described.

DESCRIPTION

FIG. 1. is a perspective view of the top broom clip, of the subject invention;

FIG. 2 is an enlarged top perspective view of the top broom clip of the subject invention;

FIG. 3. is a bottom plan view of the top broom clip of FIG. 1;

FIG. 4. is a top plan view of the top broom clip of FIG. 1;

FIG. 5. is a left plan view of the top broom clip of FIG. 1;

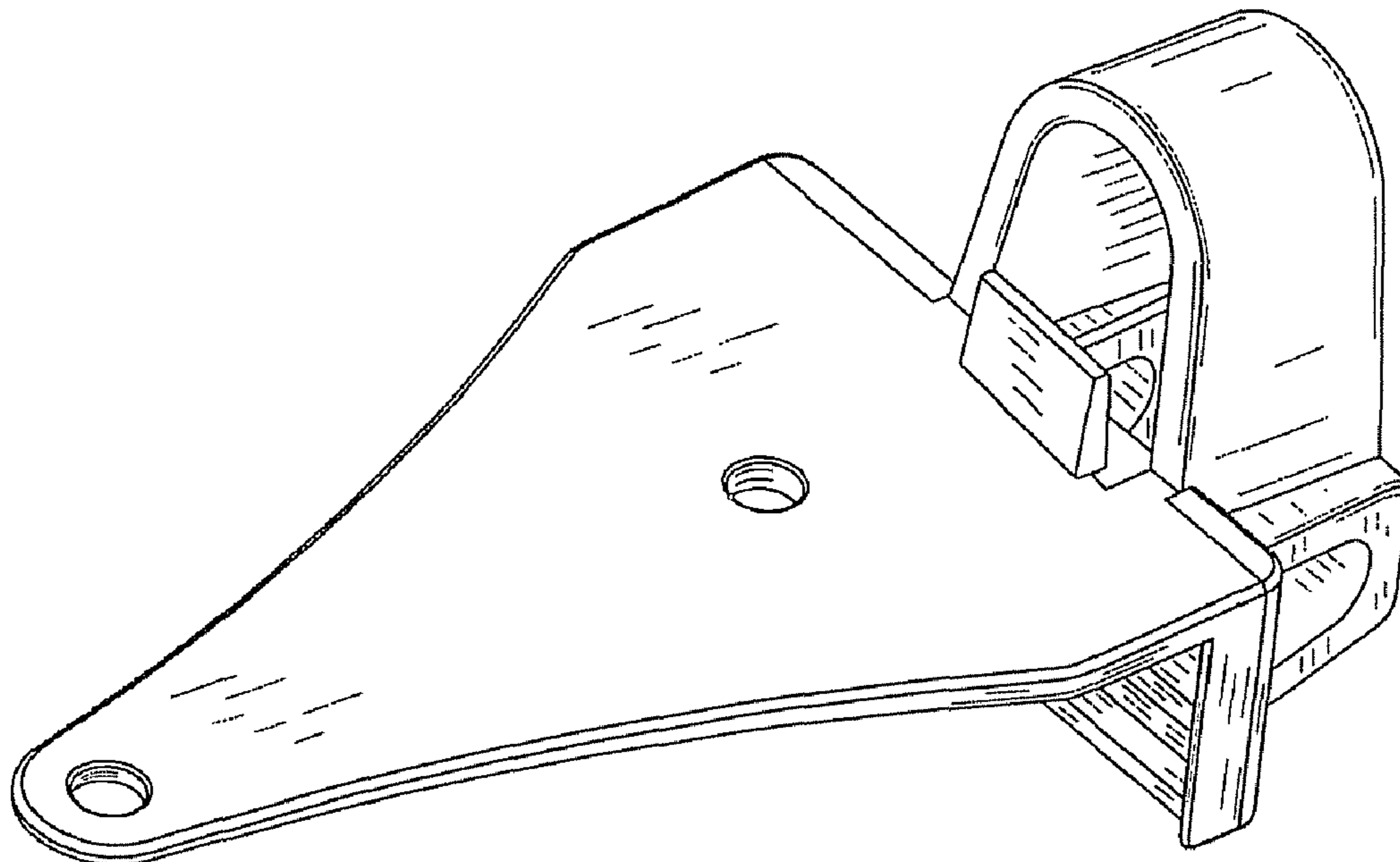
FIG. 6 is a right plan view of the top broom clip of FIG. 1;

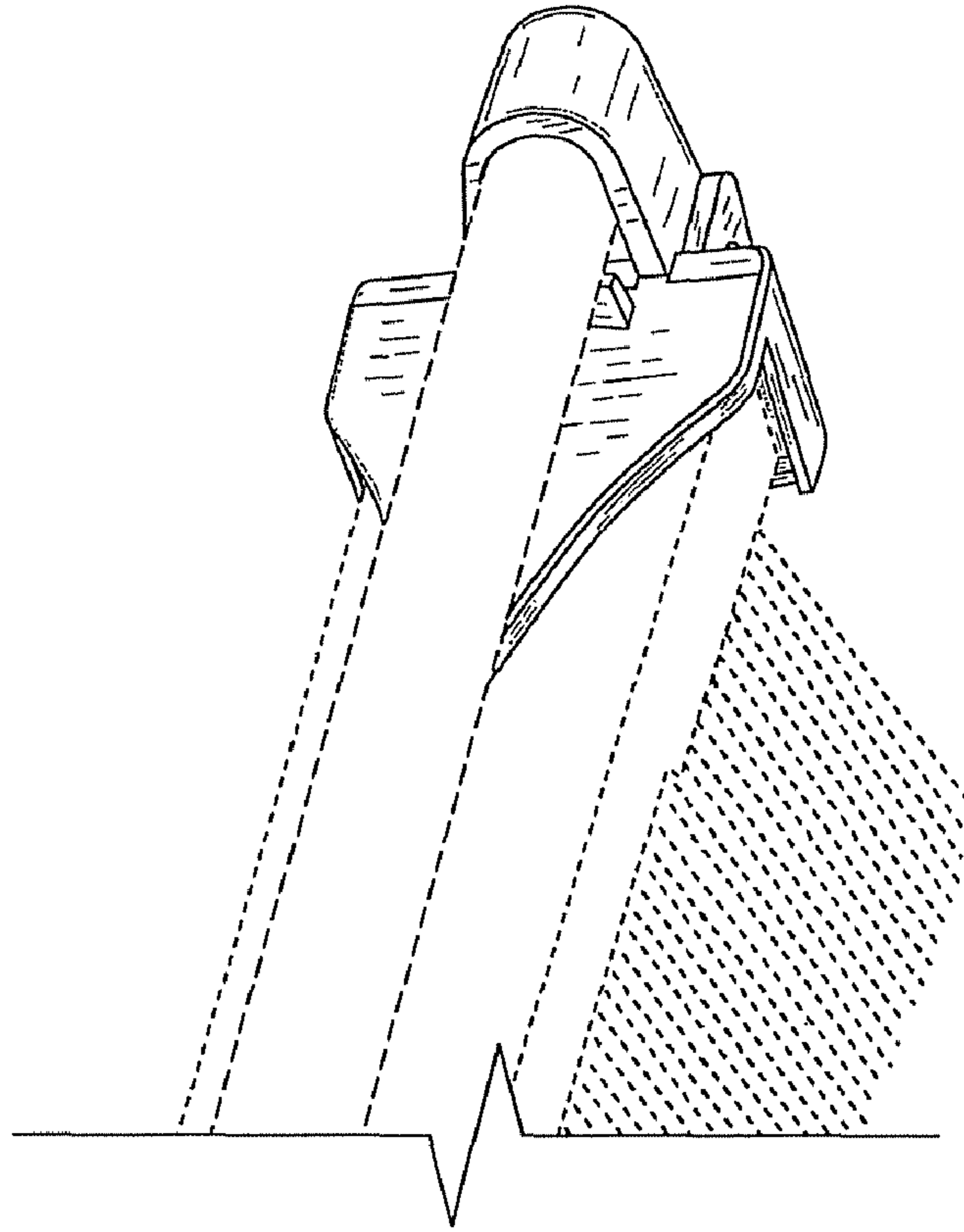

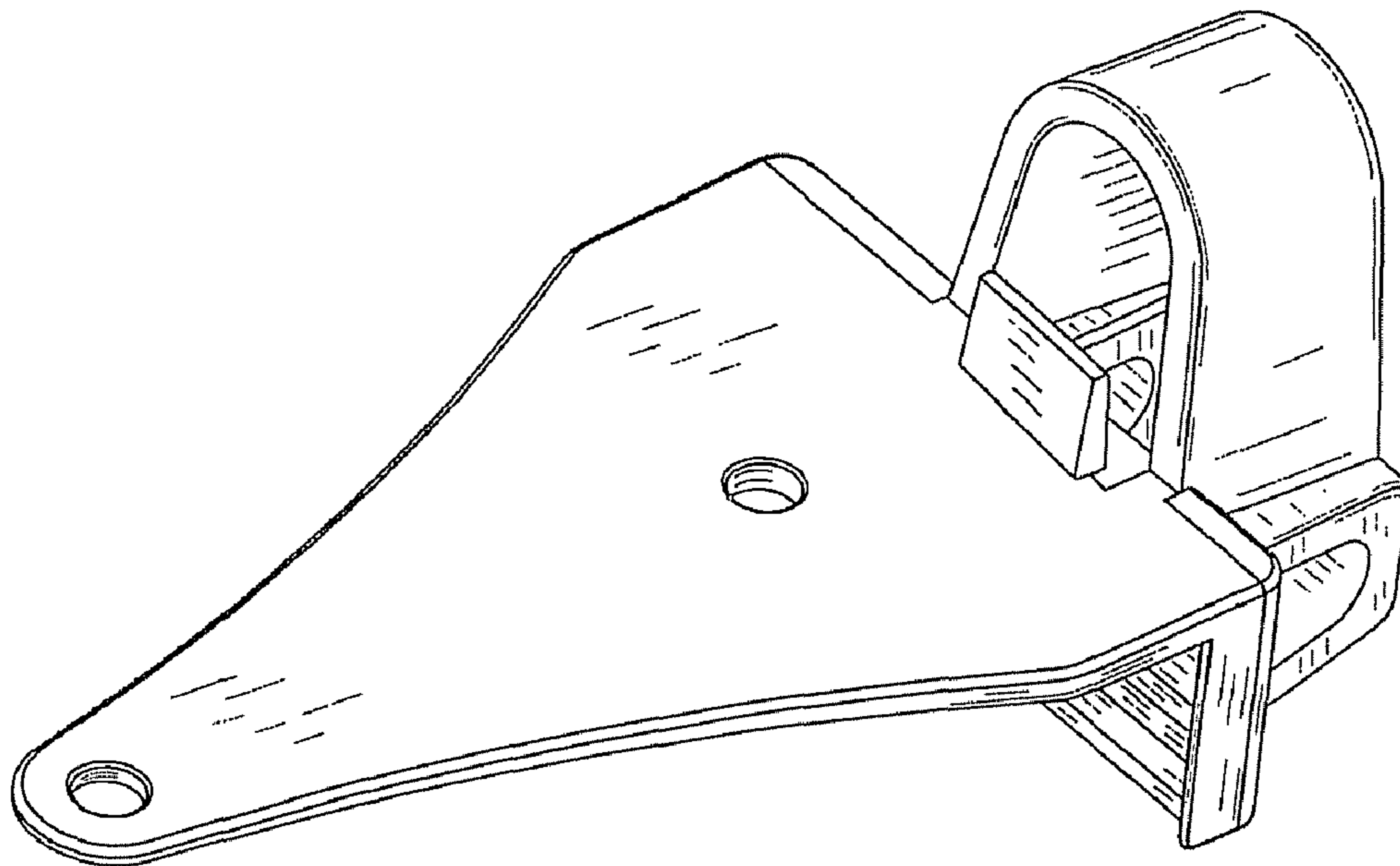

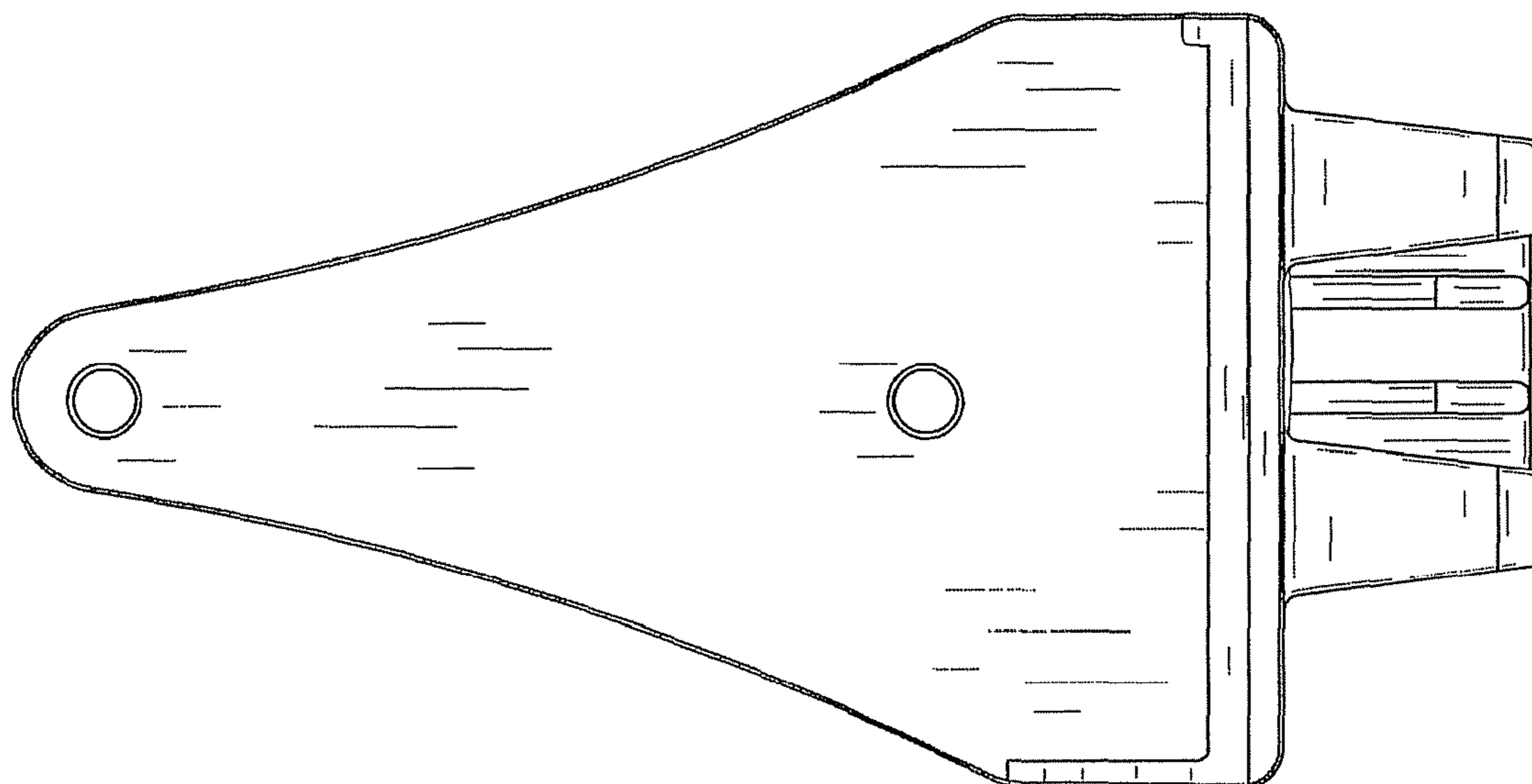

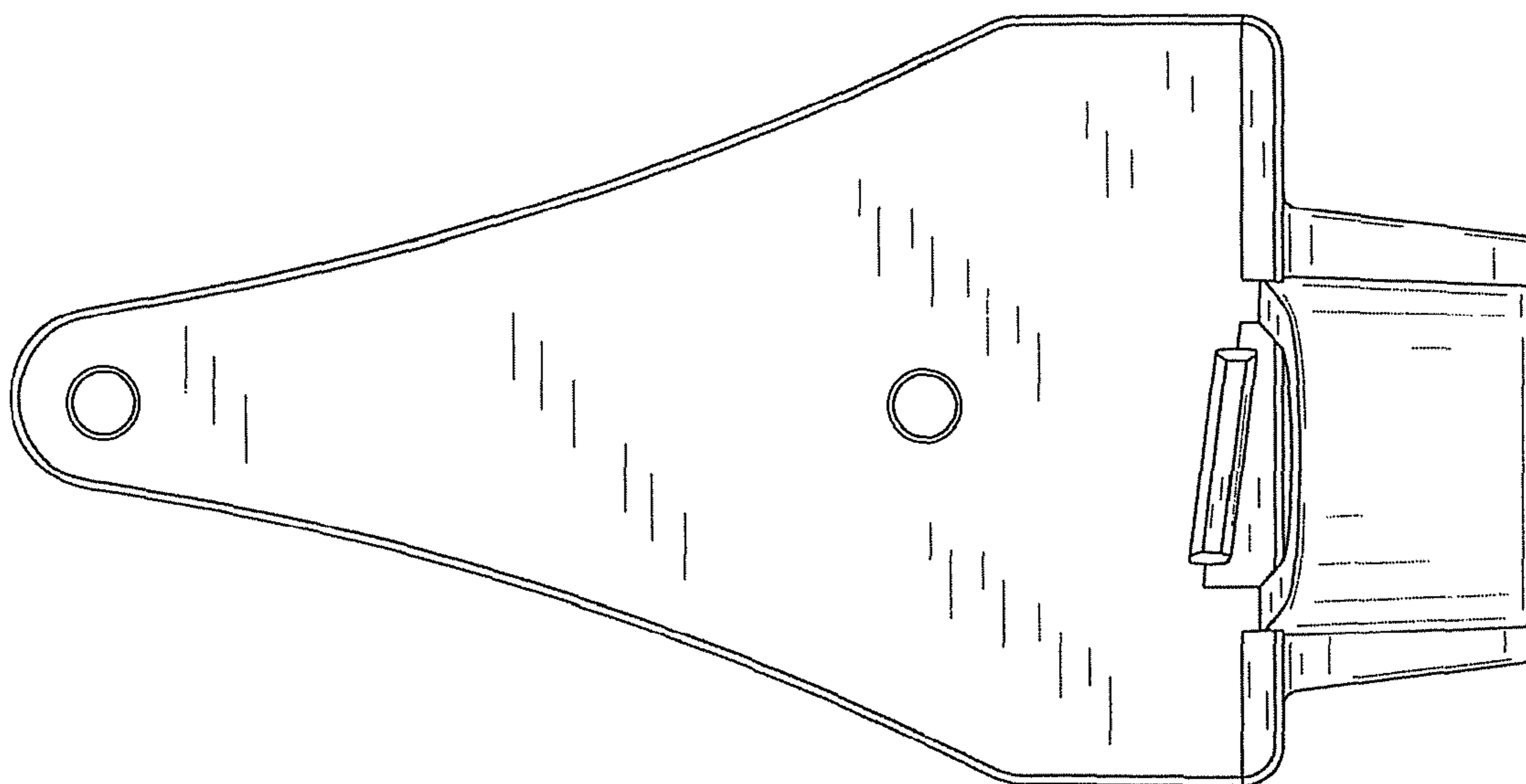

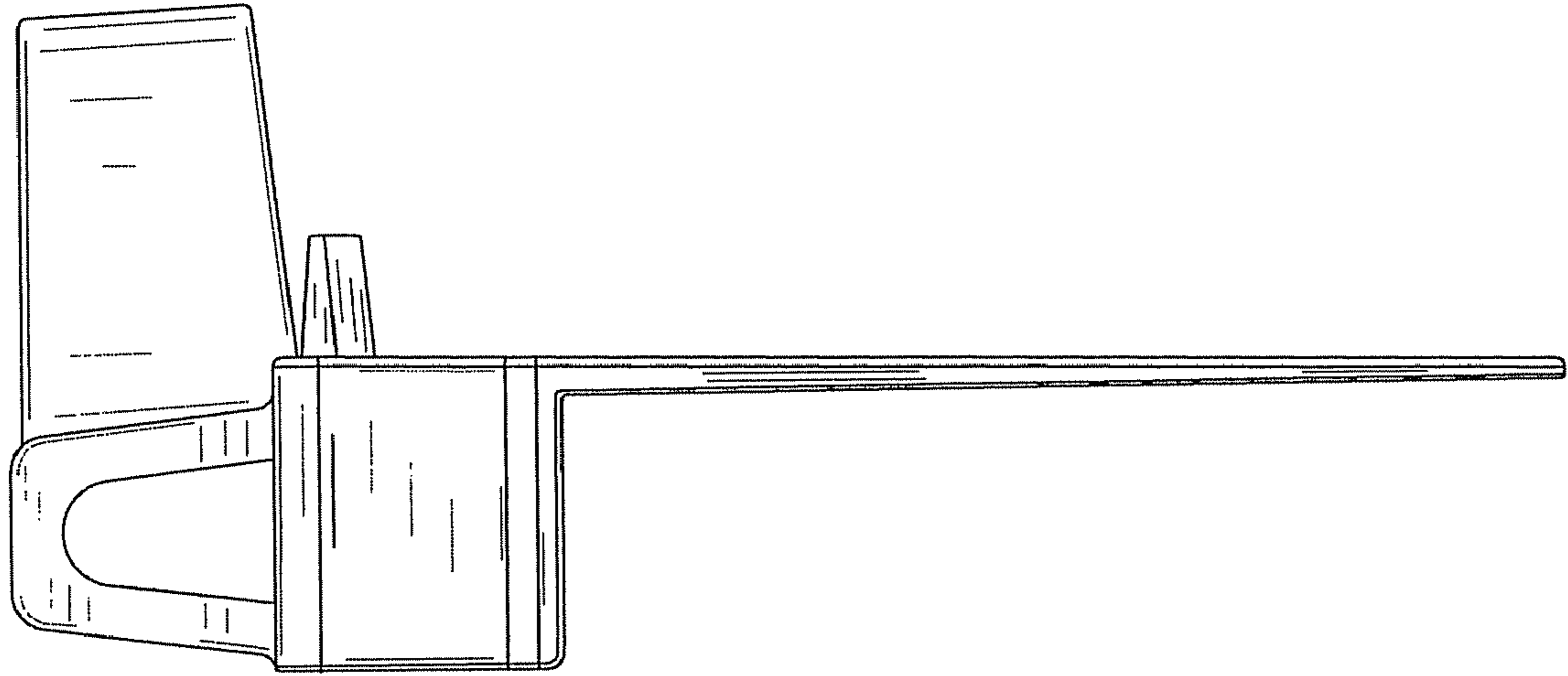

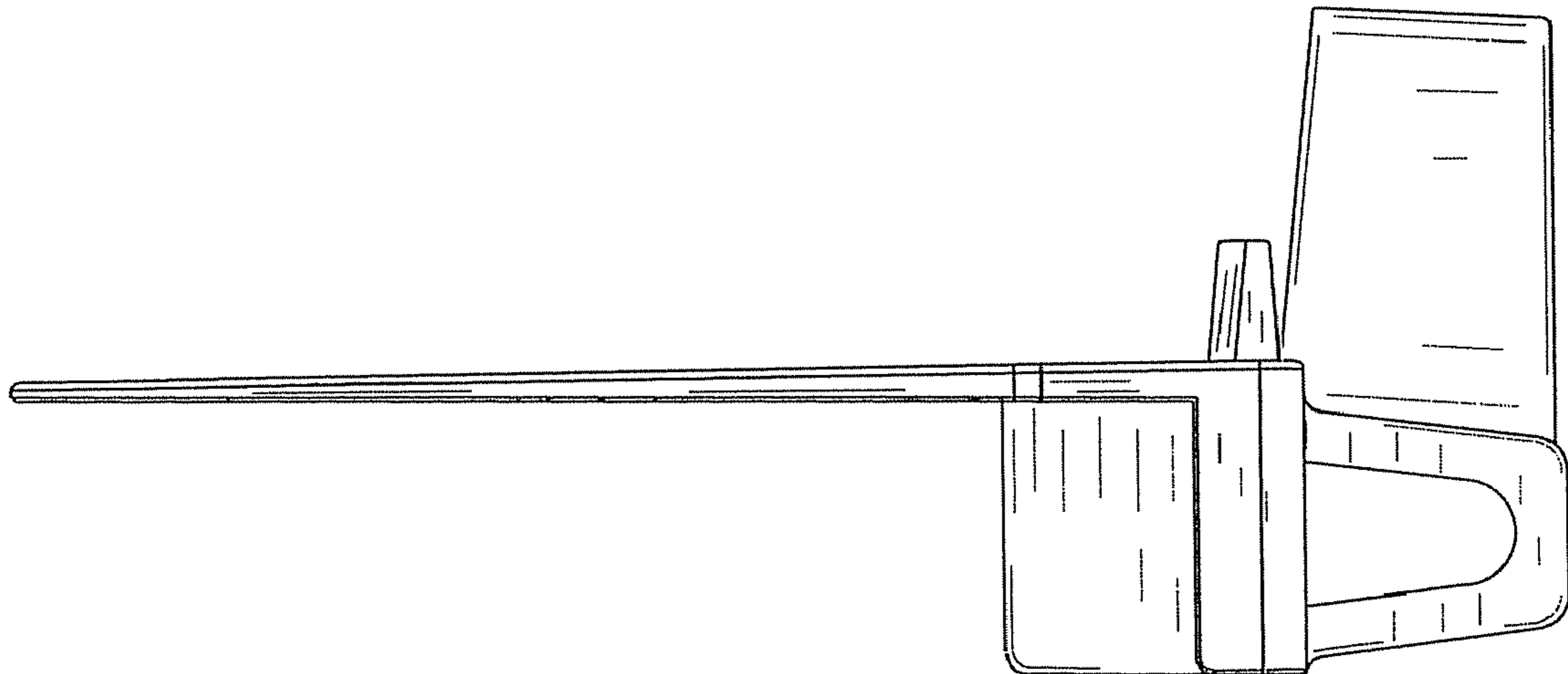

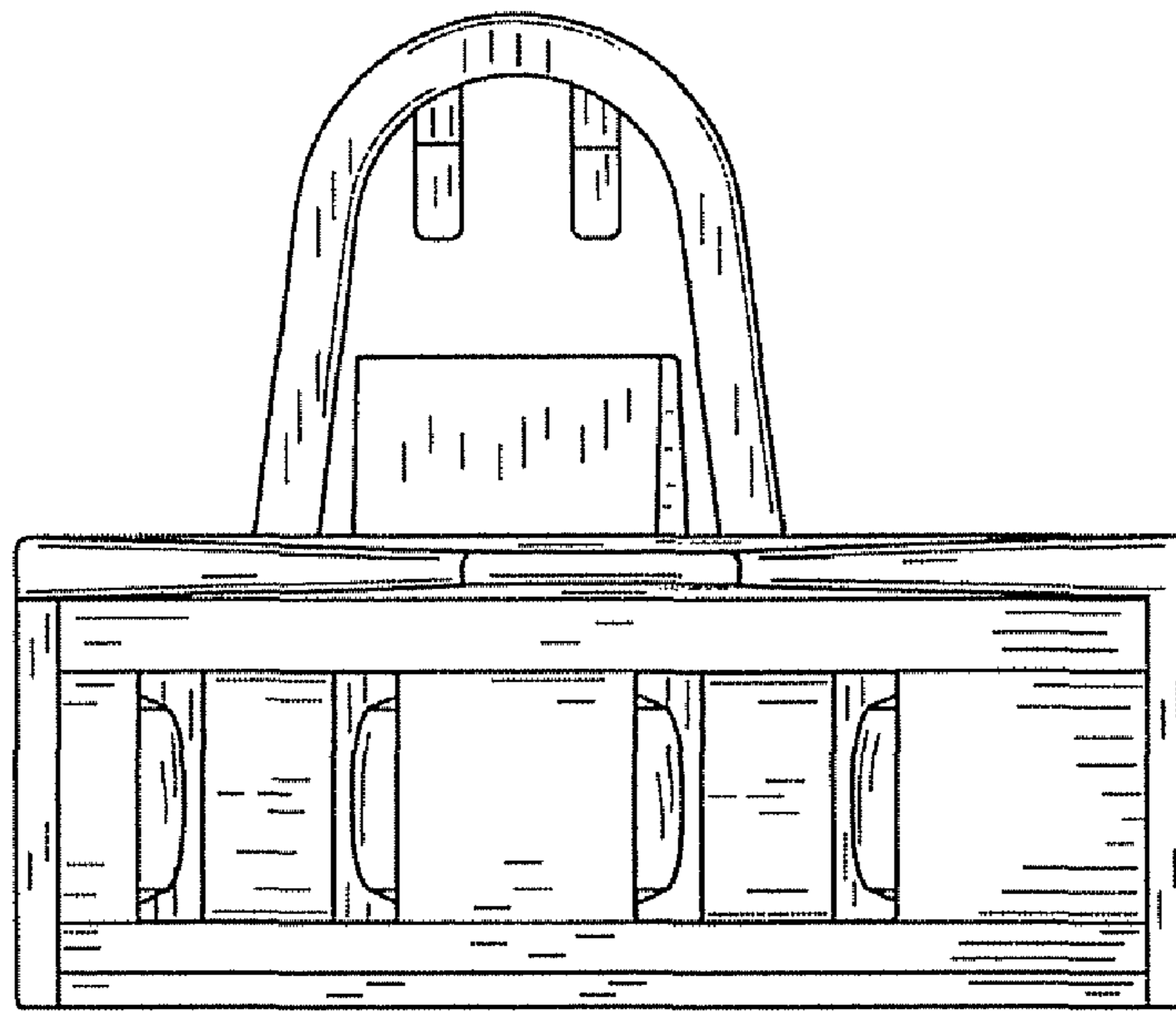

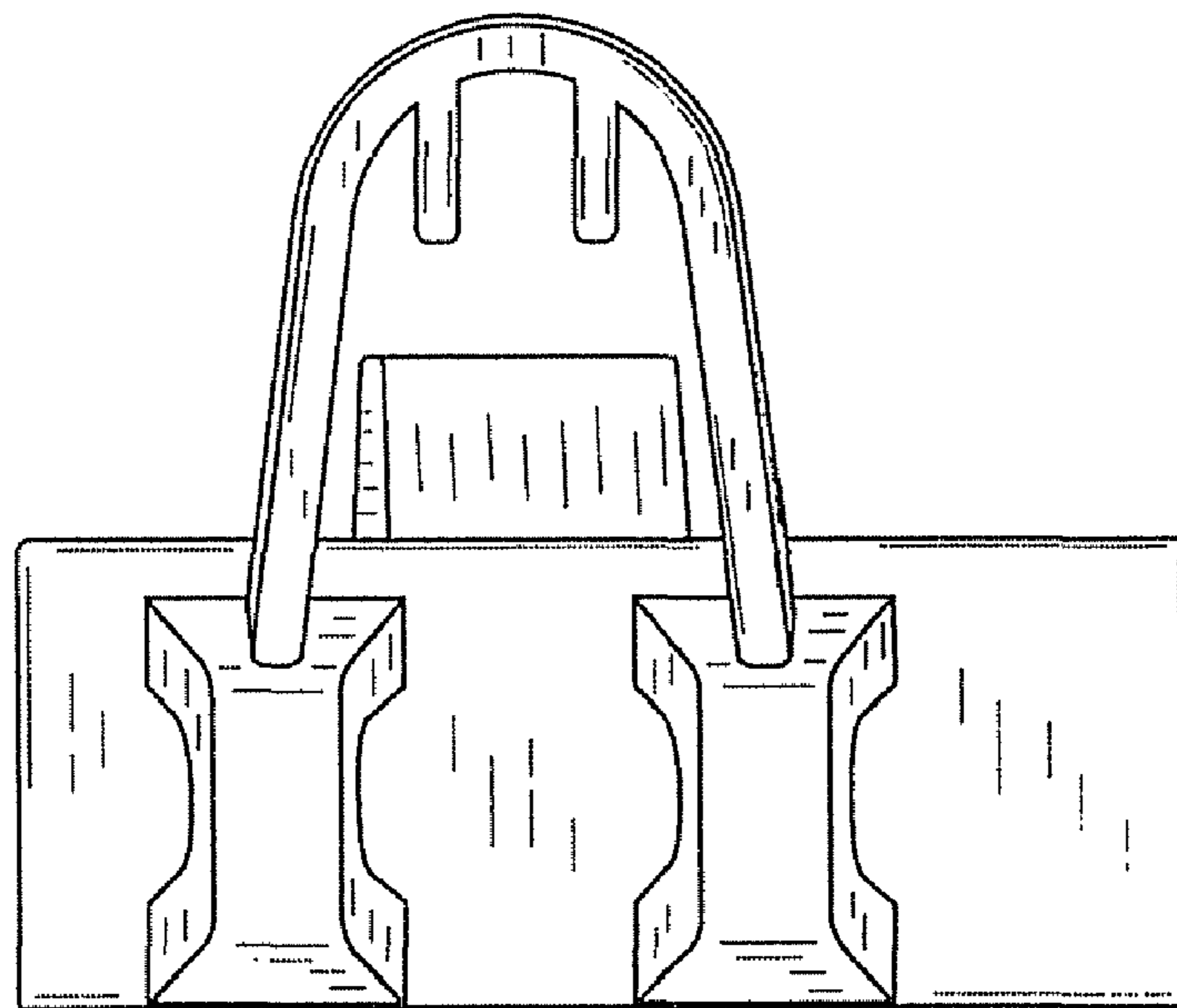
