DESCRIPTION

FIG. 1 is a perspective view of the packaging for toothbrush showing my new design from the front and right sides;

FIG. 3 is a right side view of the toothbrush package of FIG. 1;

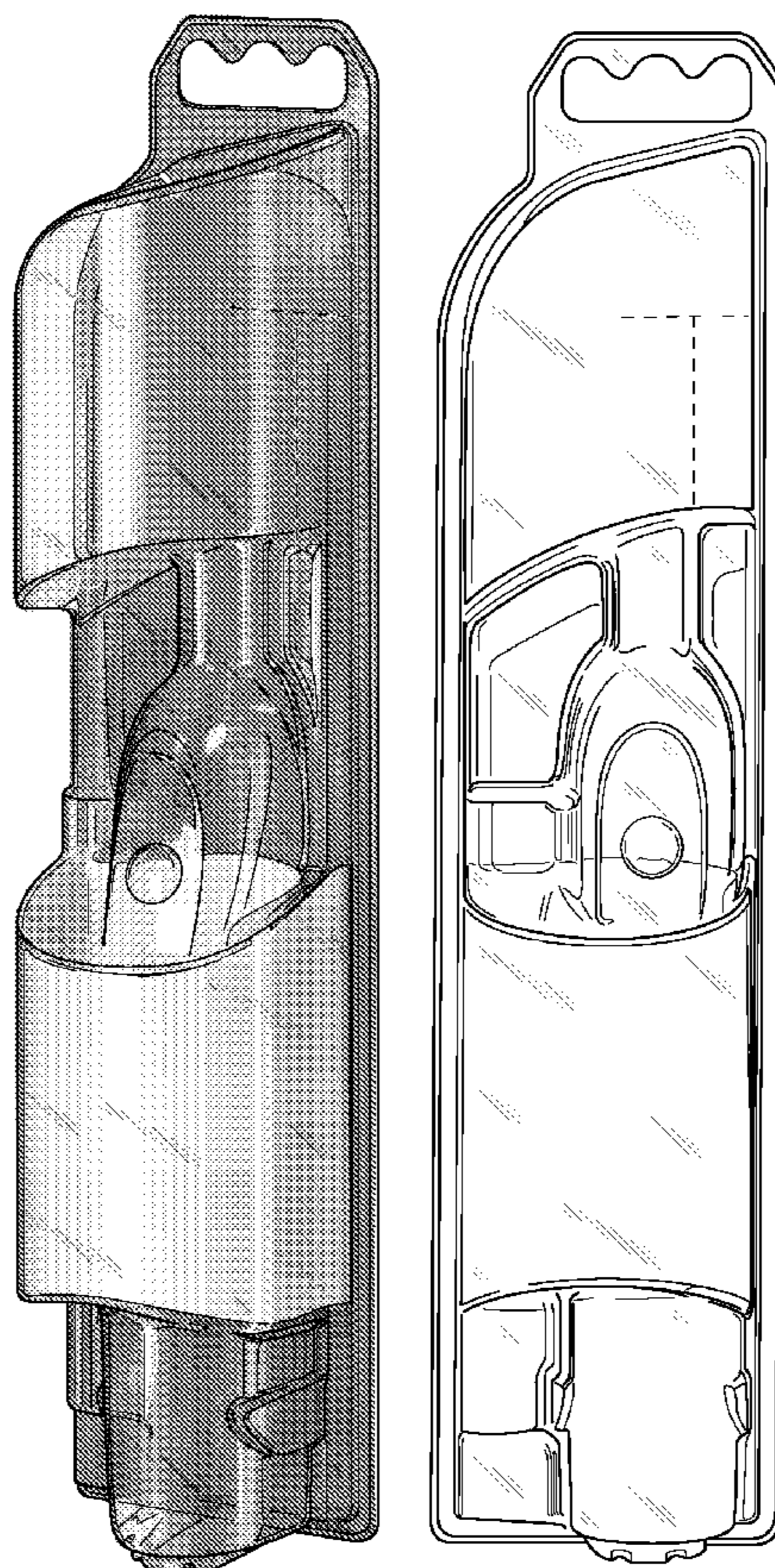
FIG. 4 is a left side view of the toothbrush package of FIG. 1;

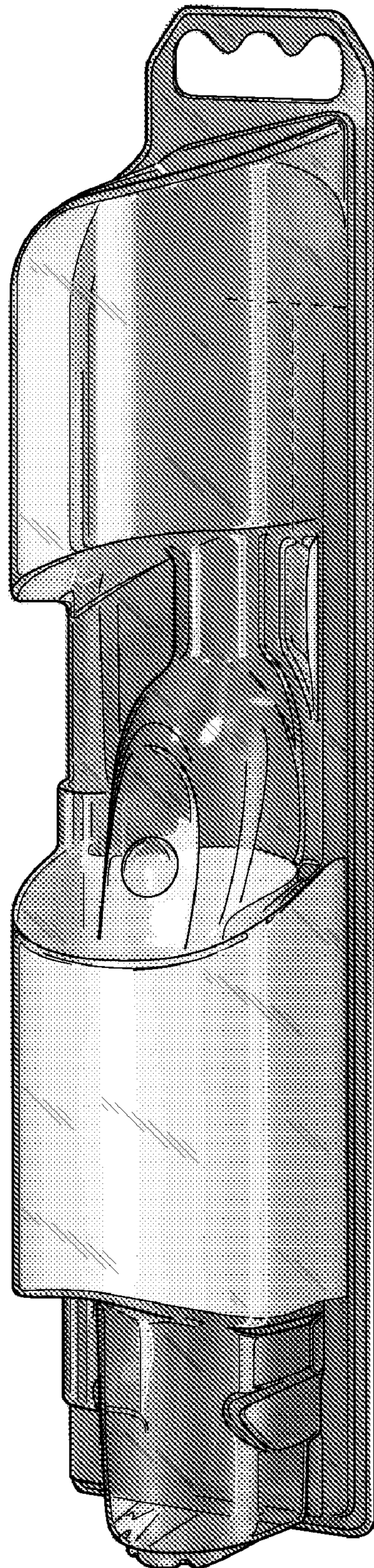

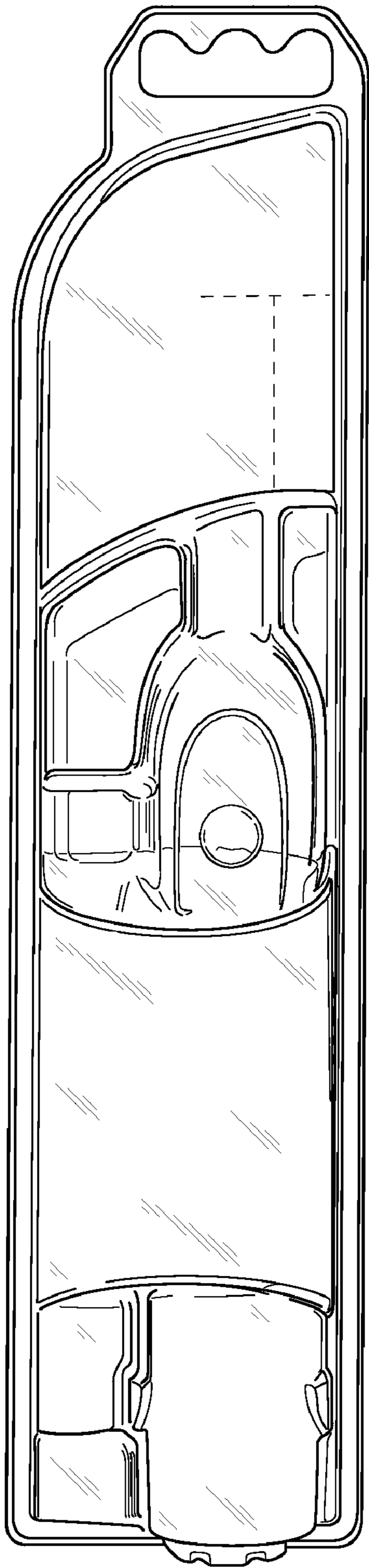

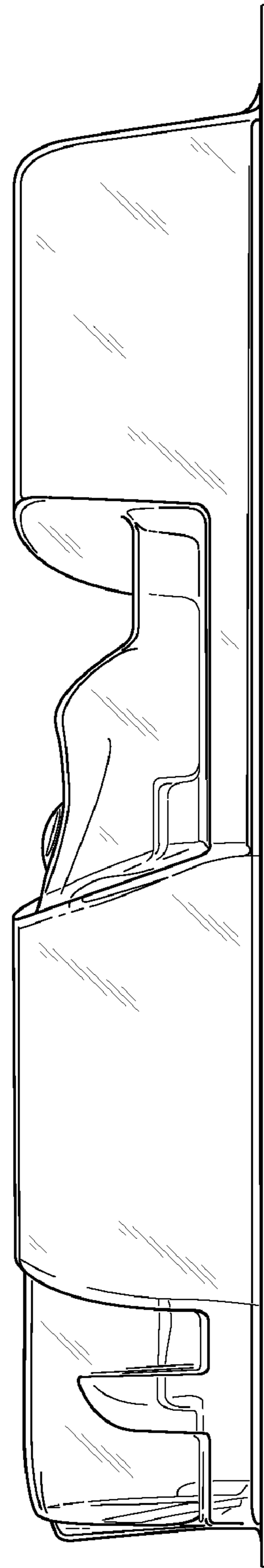

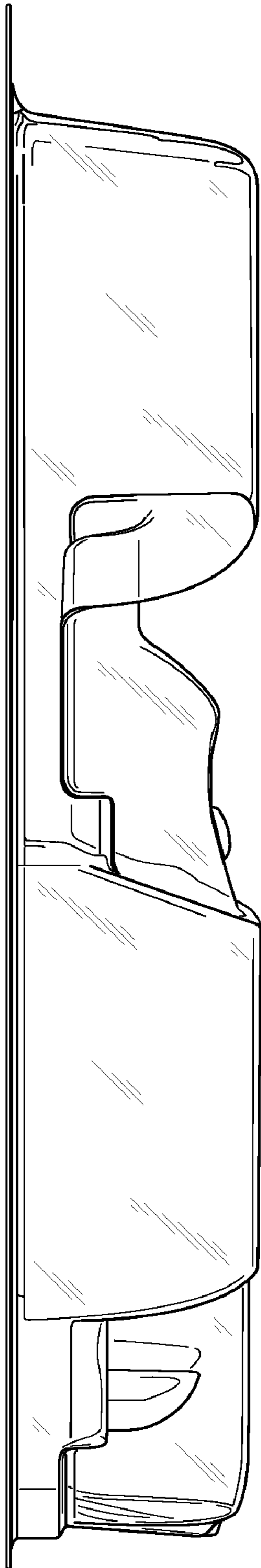

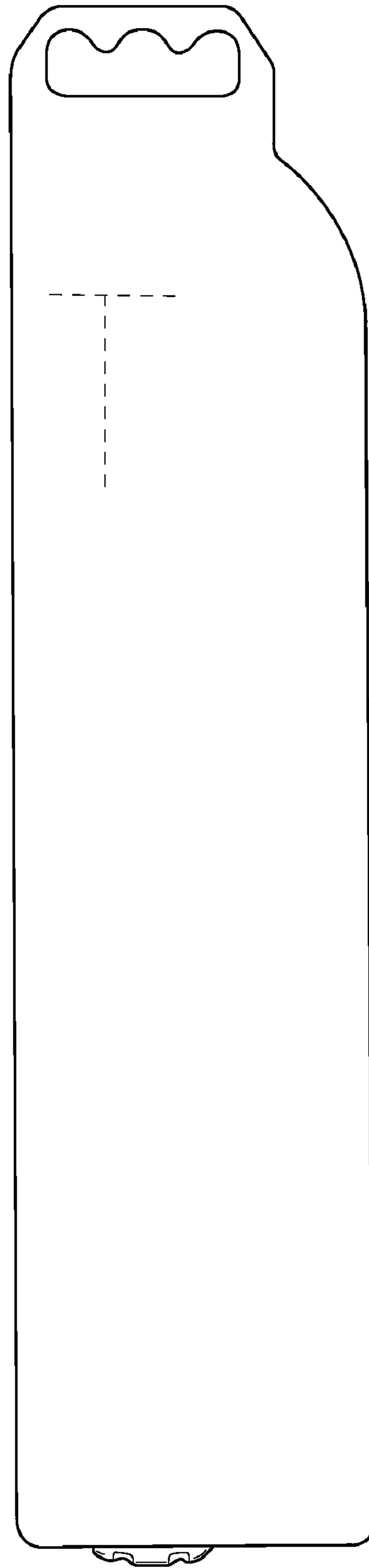

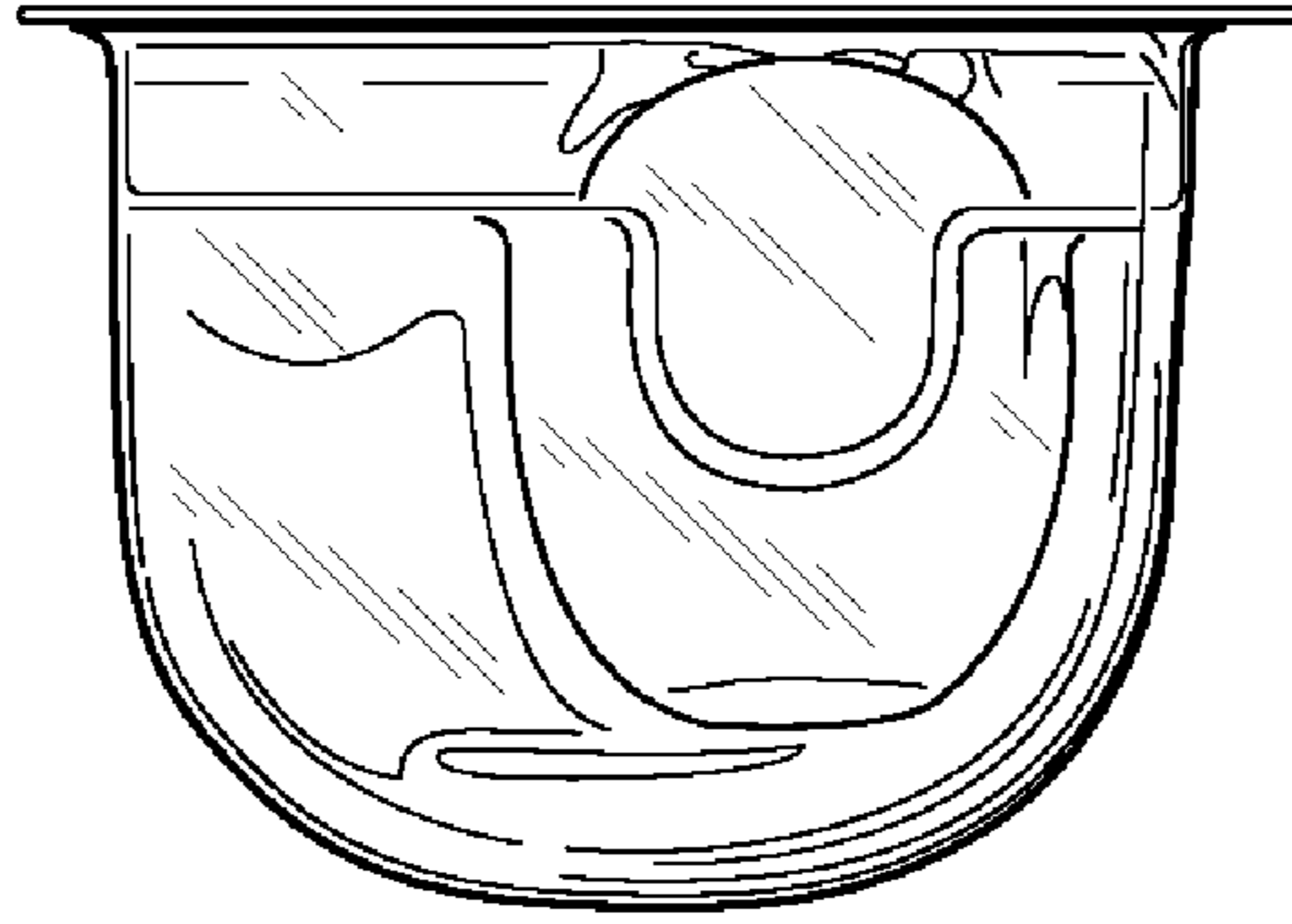

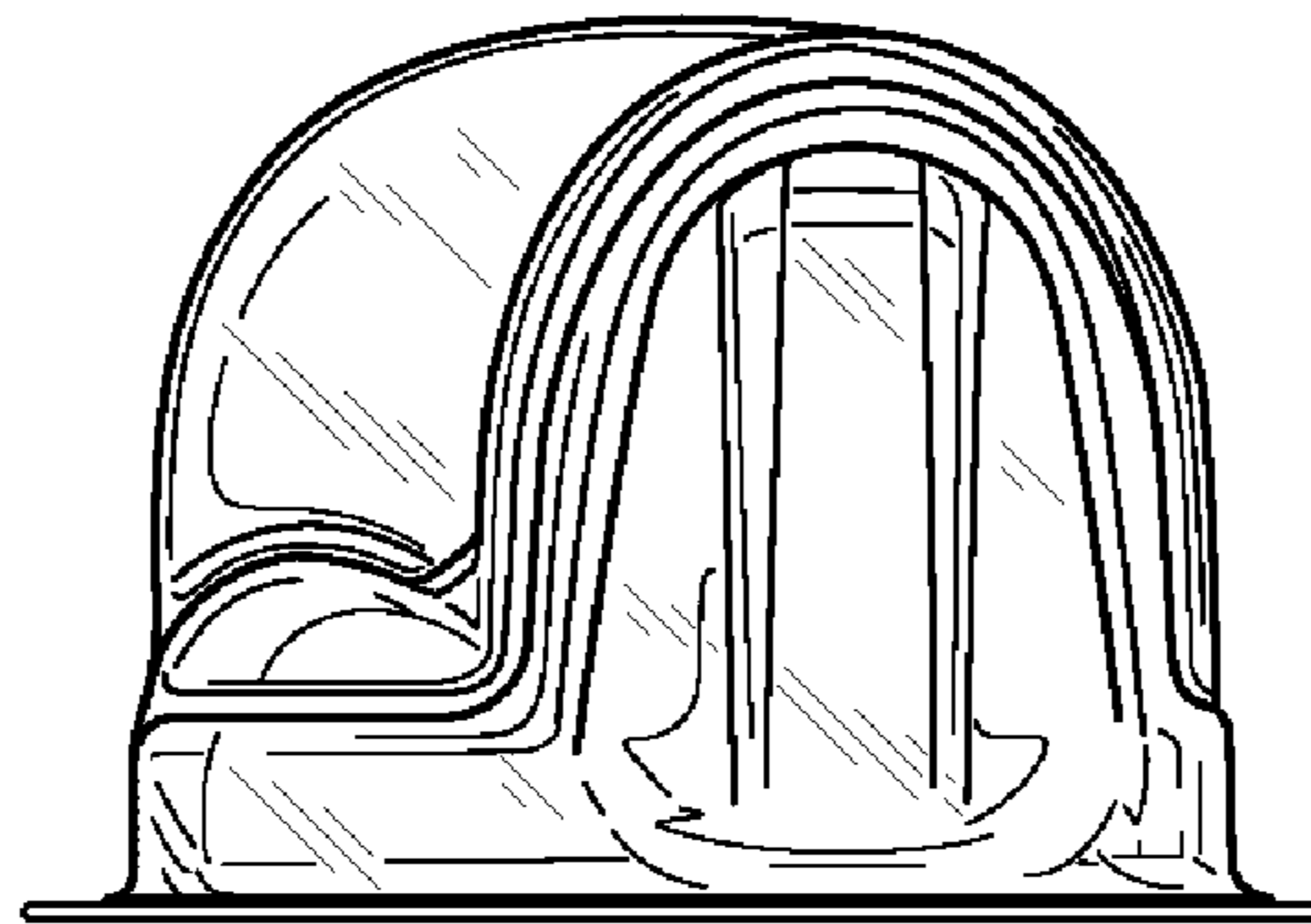
