(57) **CLAIM**

The ornamental design for a hot food container, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of a hot food container embodying our new design.

FIG. 2 shows a front view thereof.

FIG. 3 shows a rear view thereof.

FIG. 4 shows a side view thereof.

FIG. 5 shows a top view thereof.

FIG. 6 shows a bottom view thereof.

FIG. 7 shows a perspective view of a second embodiment of our new design for a hot food container, which includes an oblong vent hole.

FIG. 8 shows a side view thereof.

FIG. 9 shows a perspective view of a third embodiment of our new design for a hot food container, which includes a window on one upper side panel.

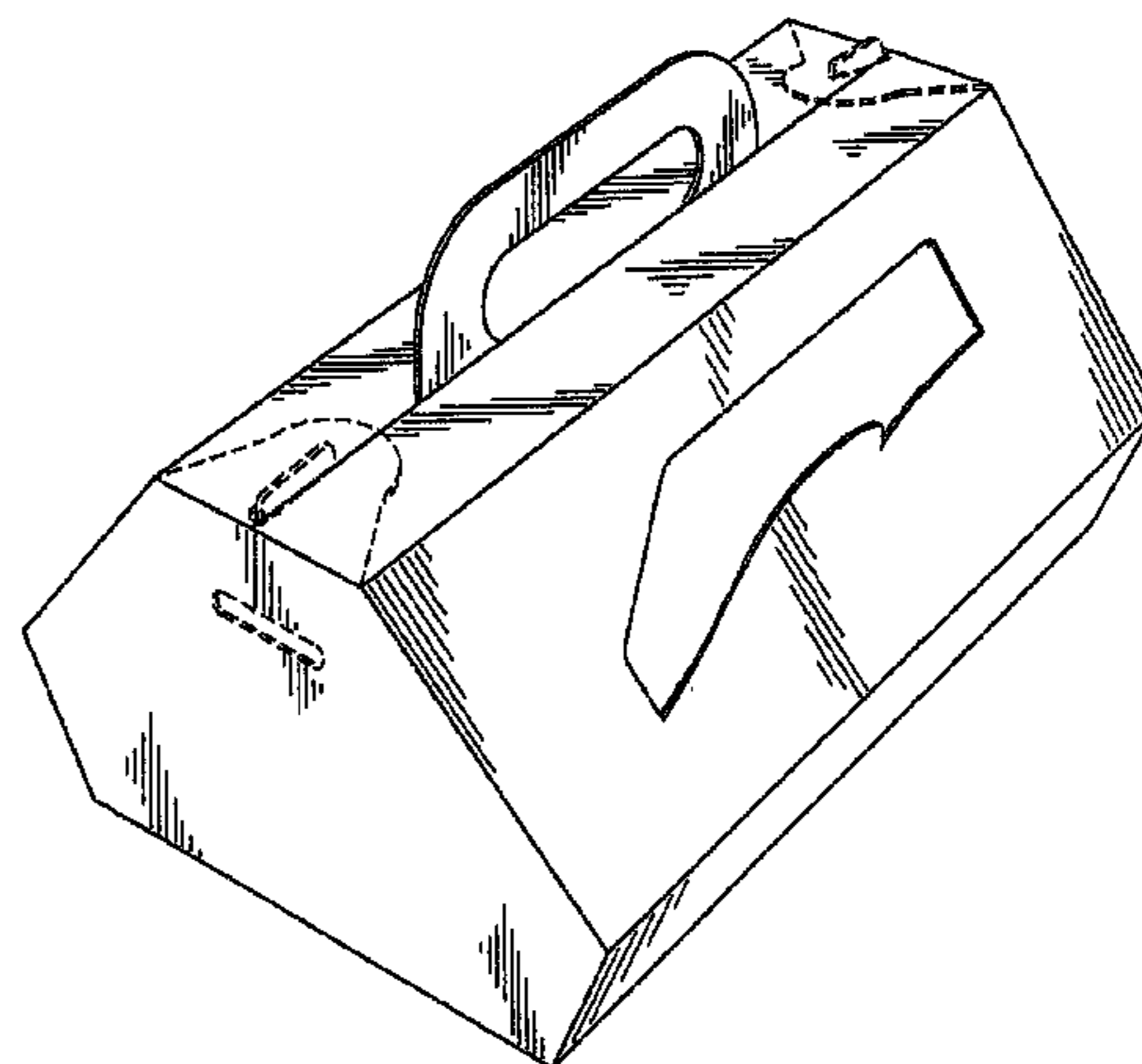
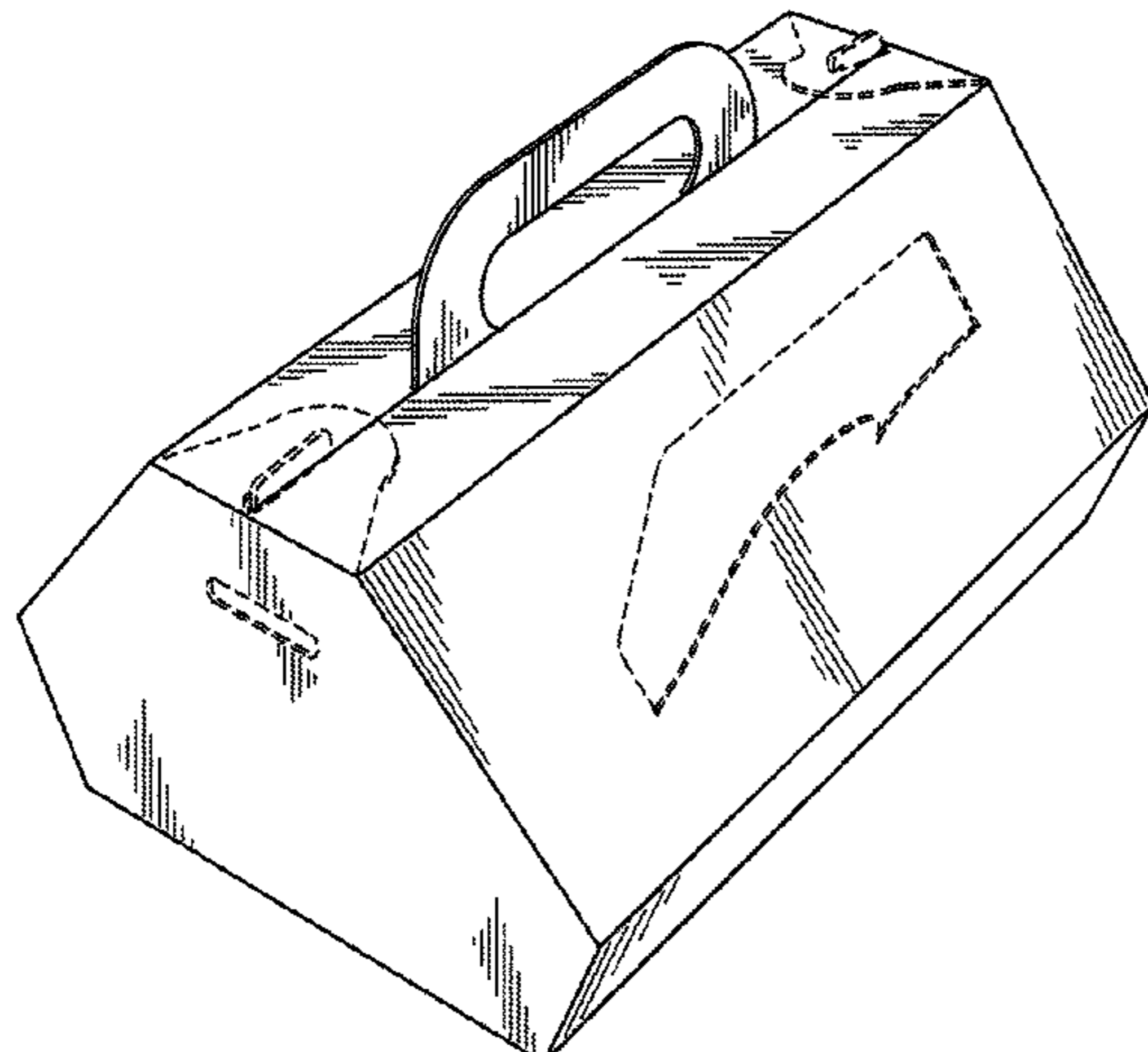
FIG. 10 shows a front view thereof; and,

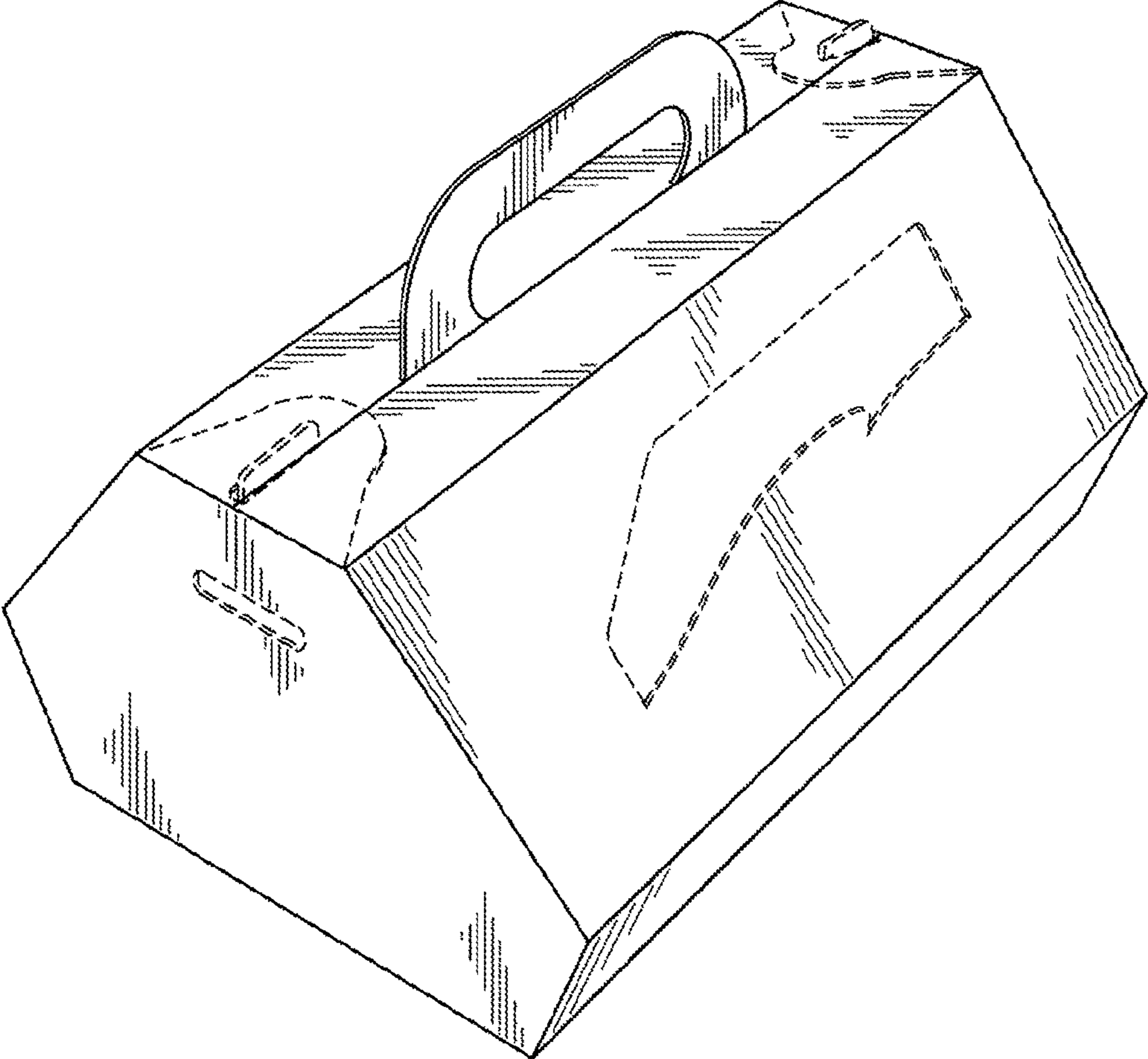

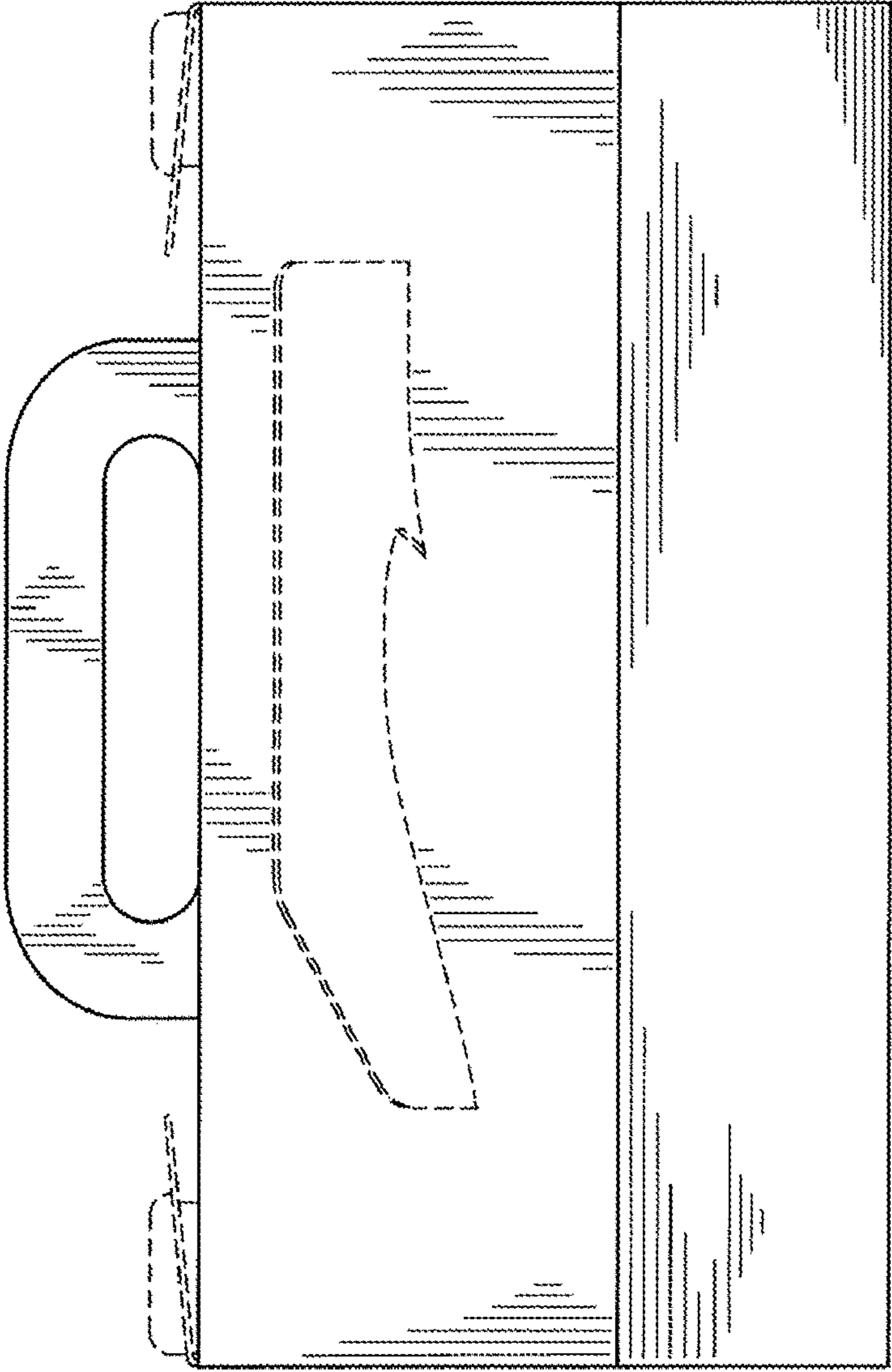

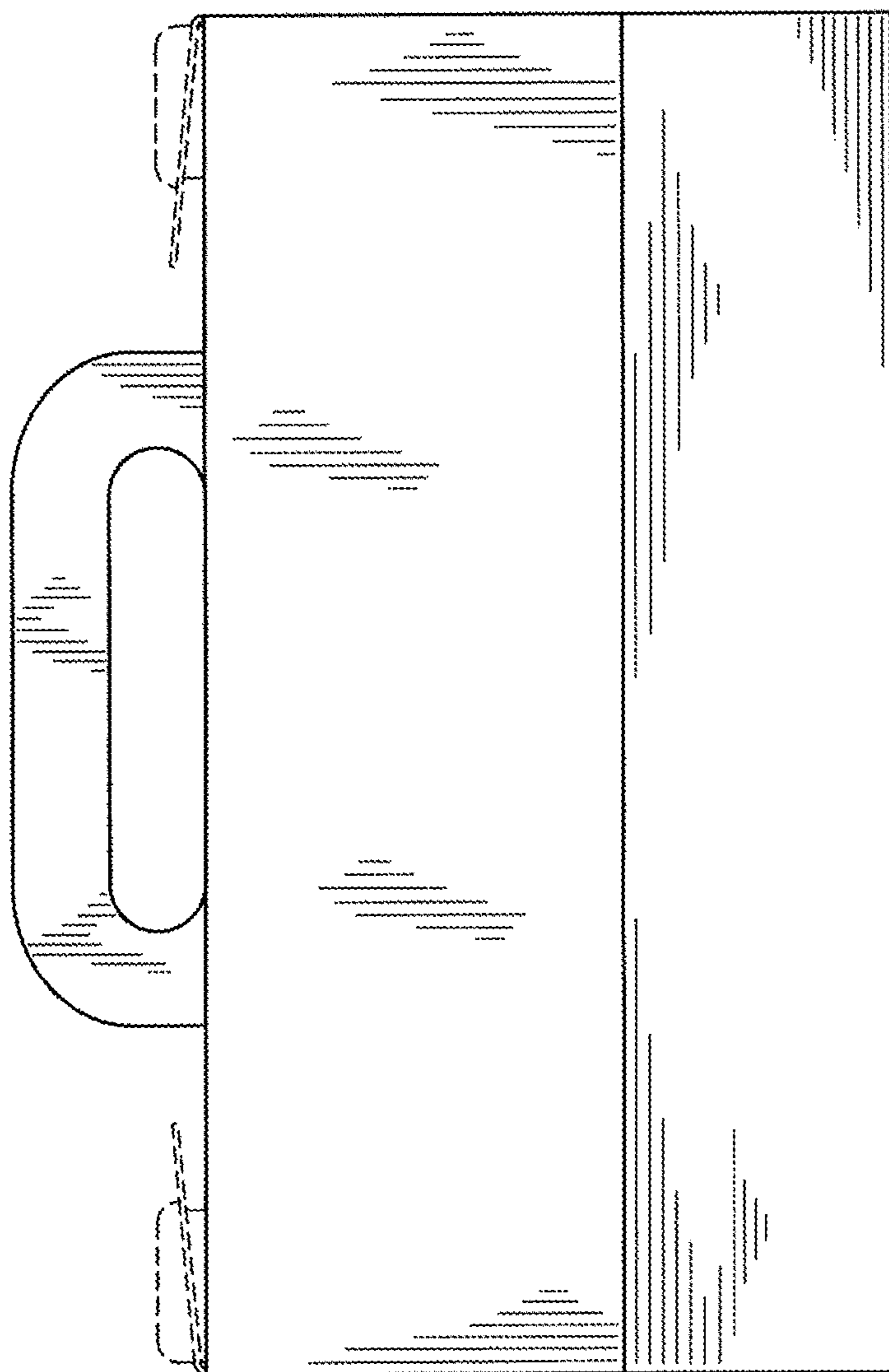

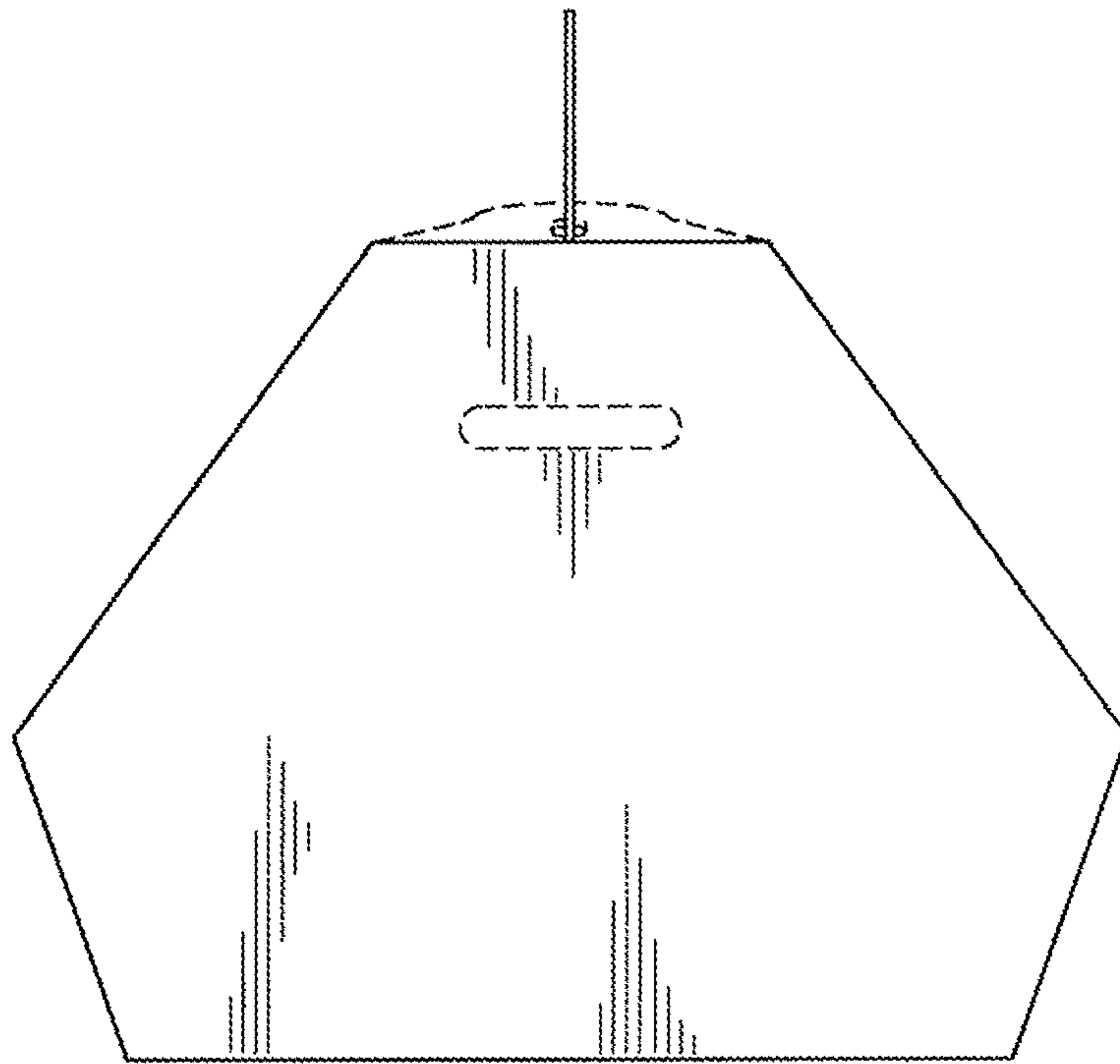

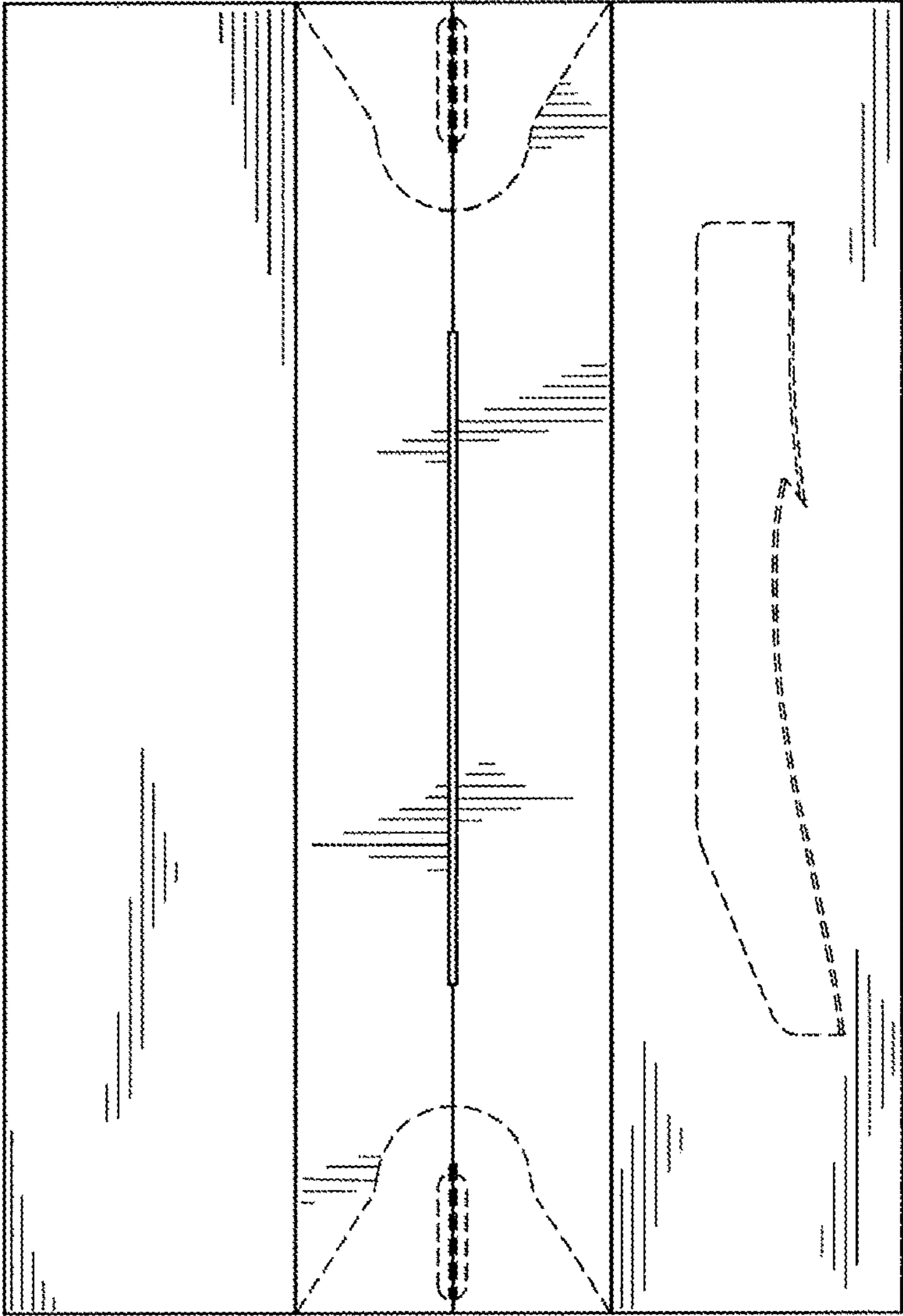

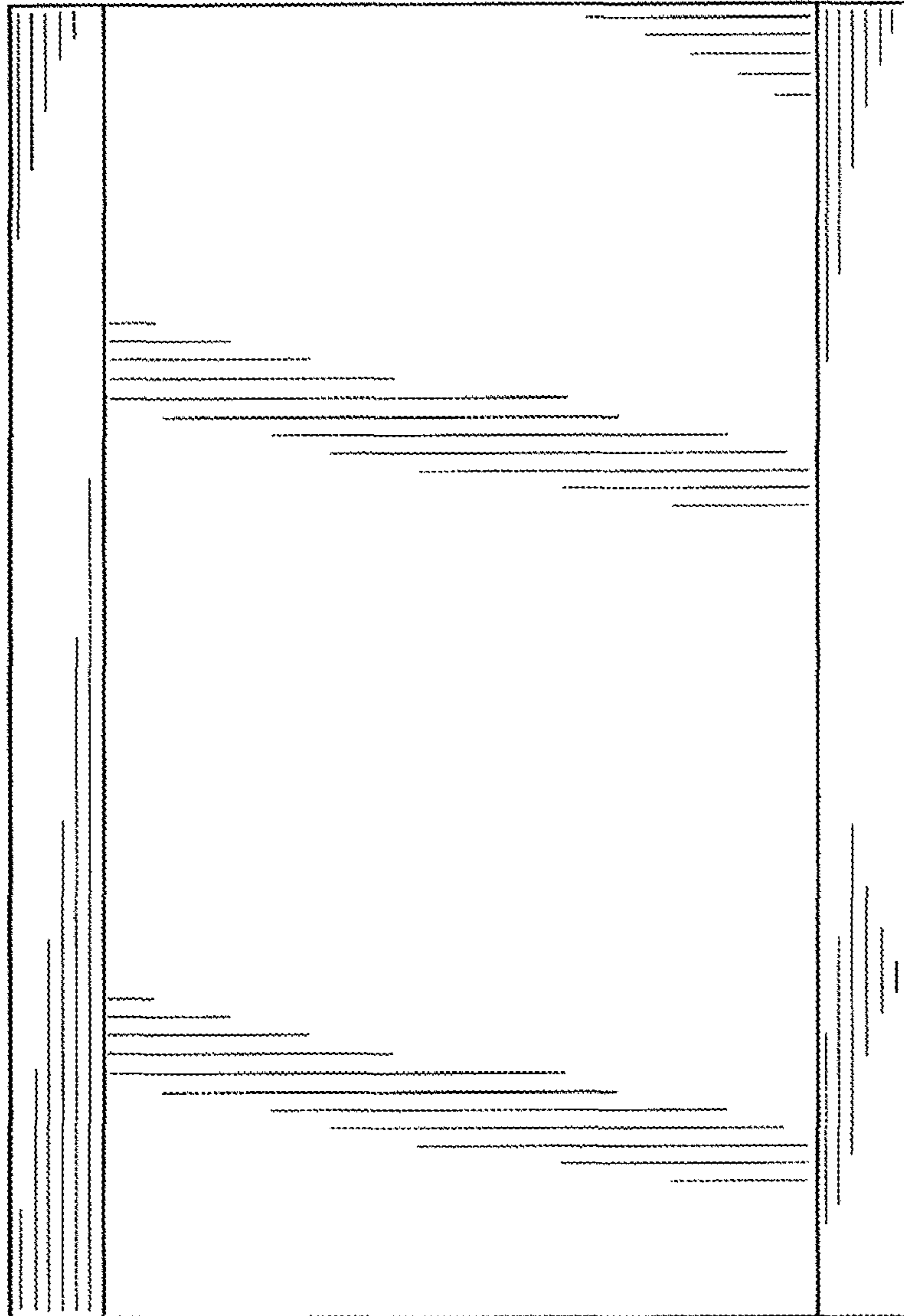

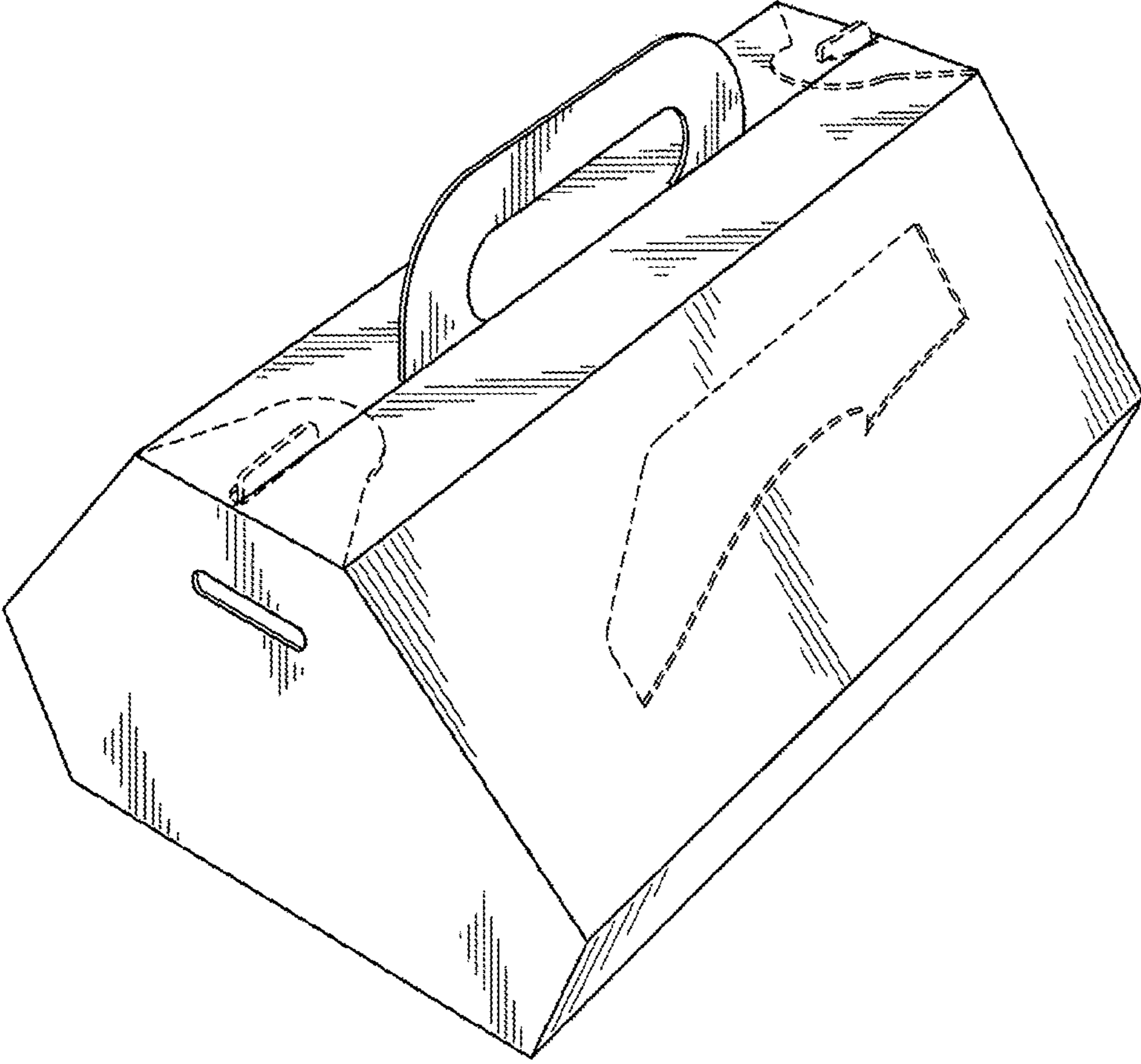

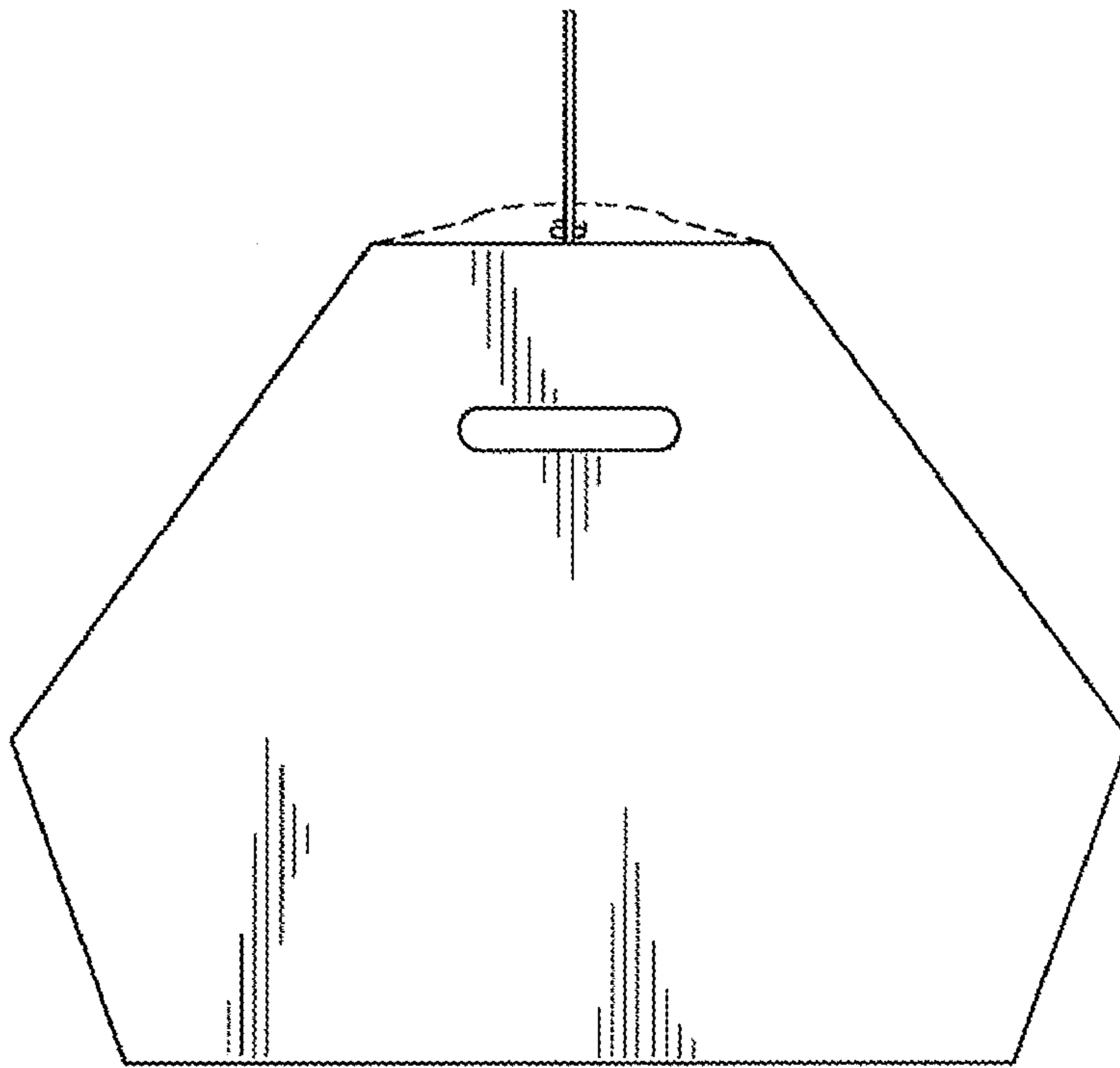

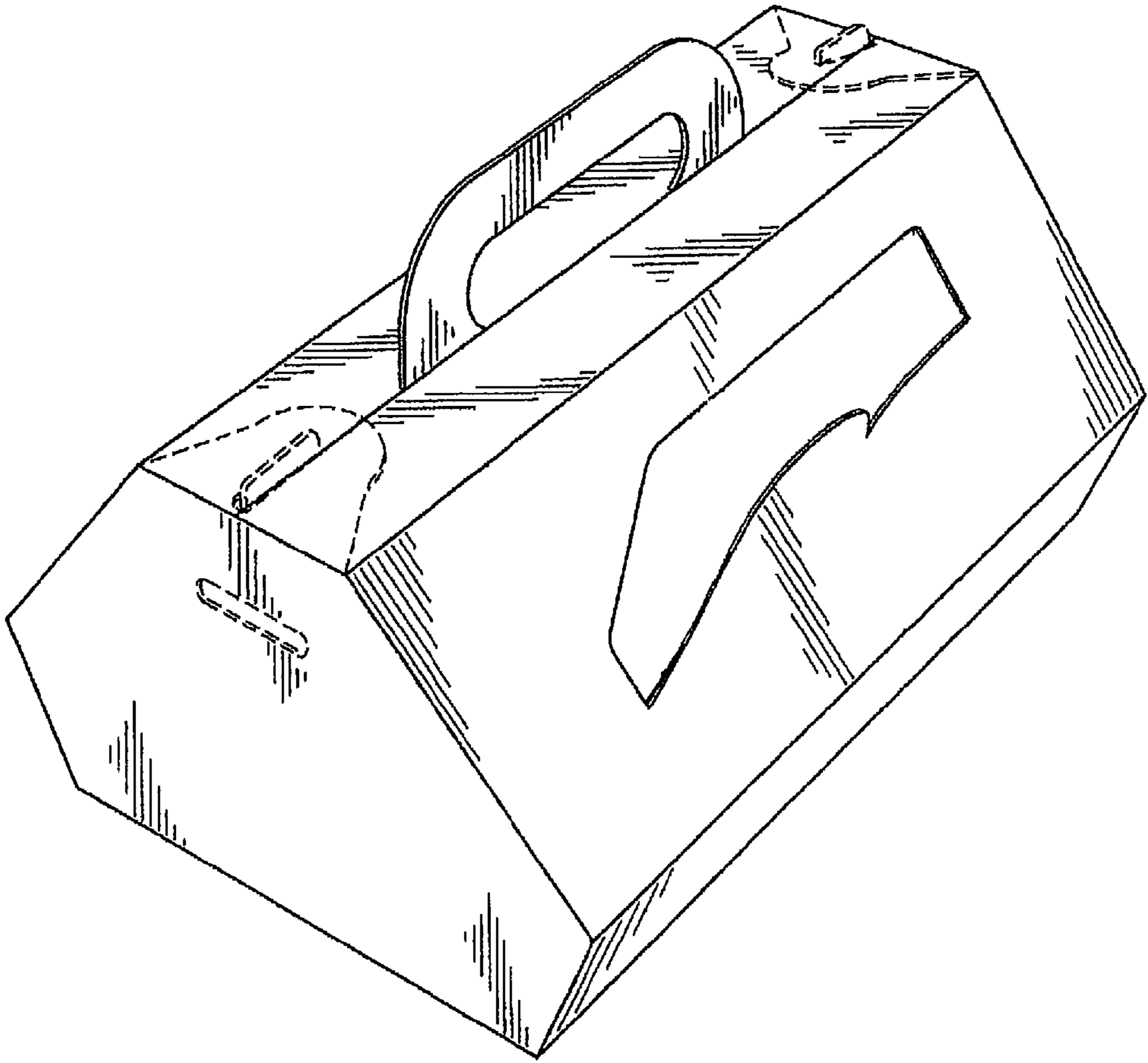

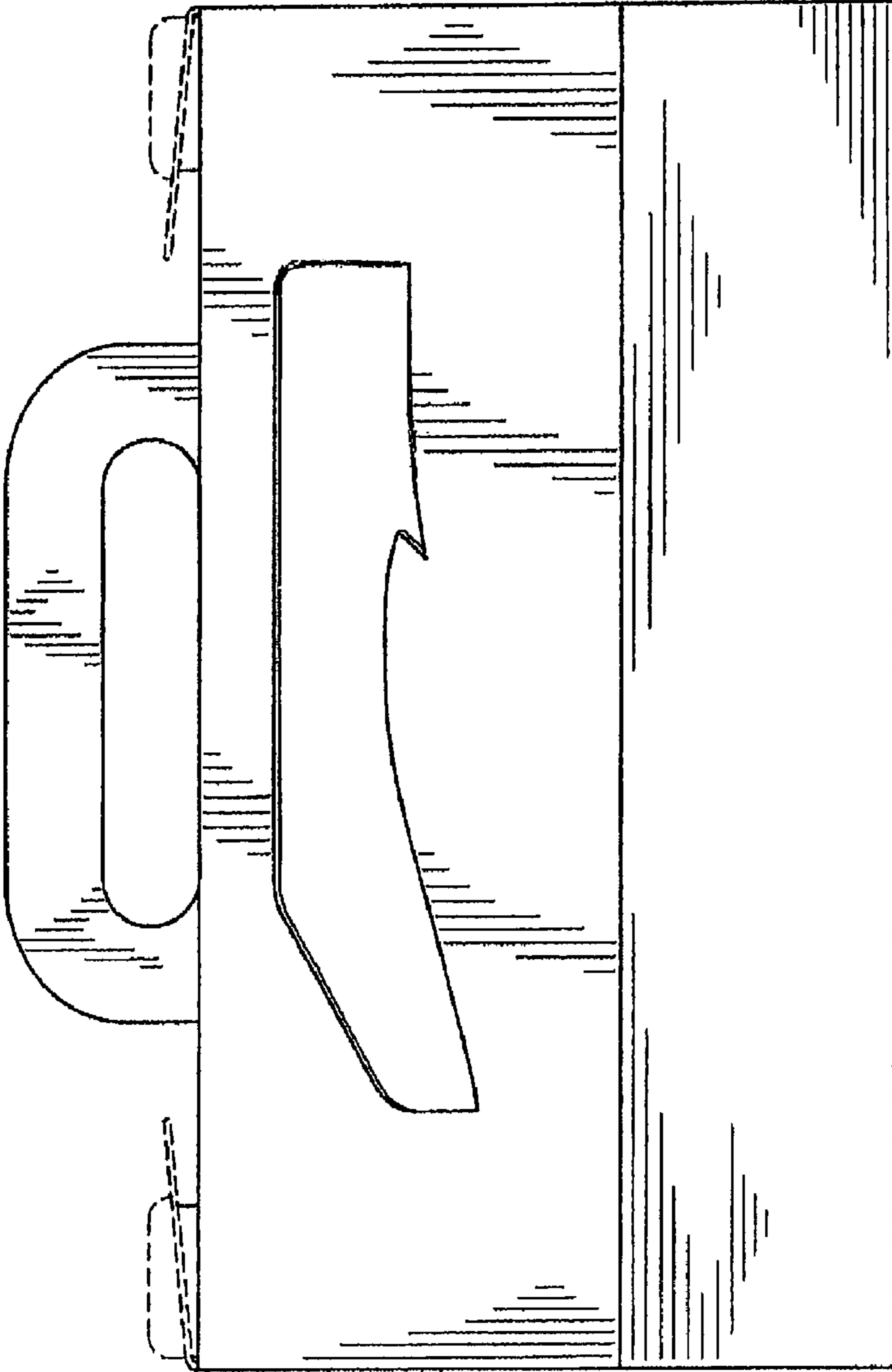

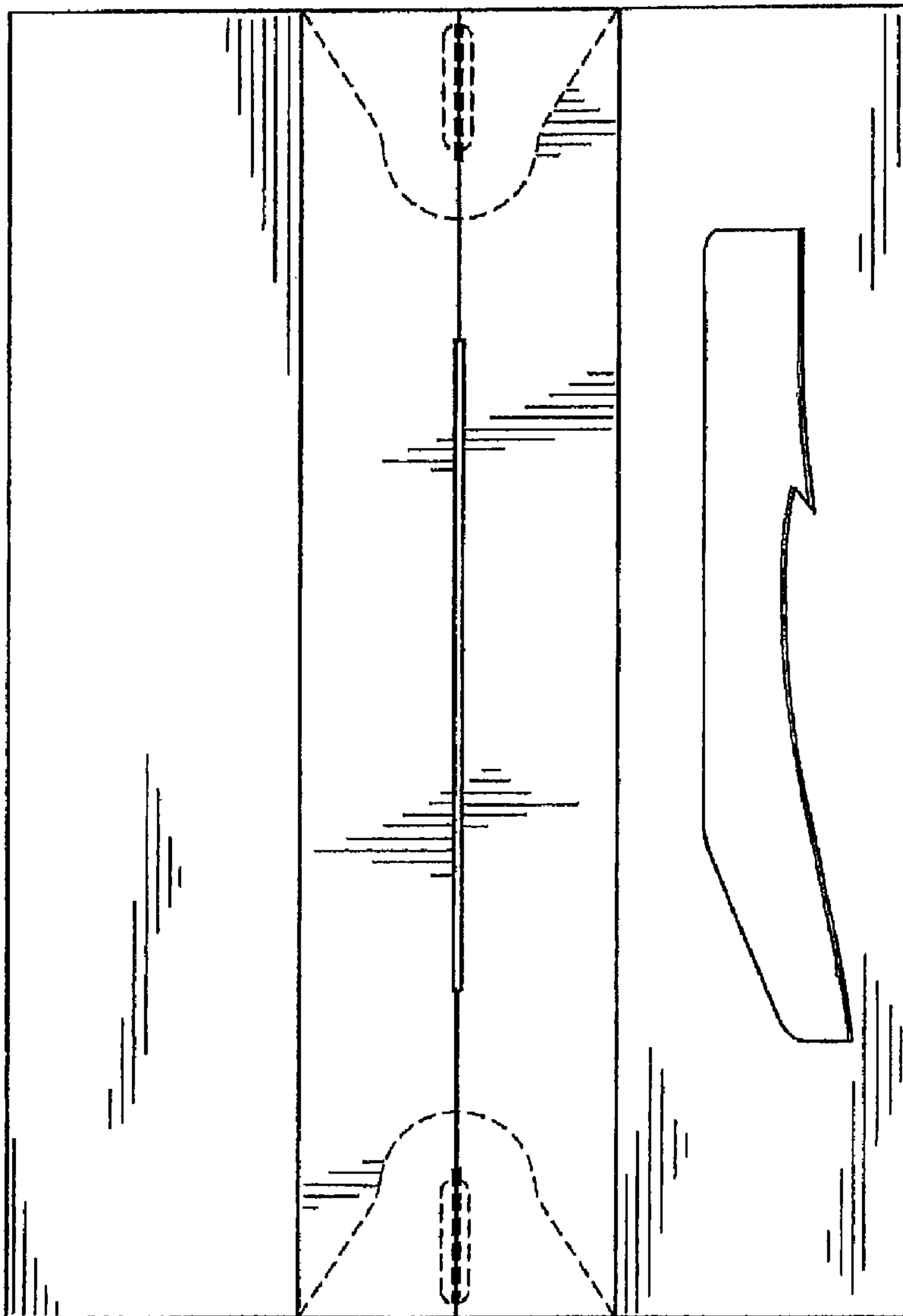
