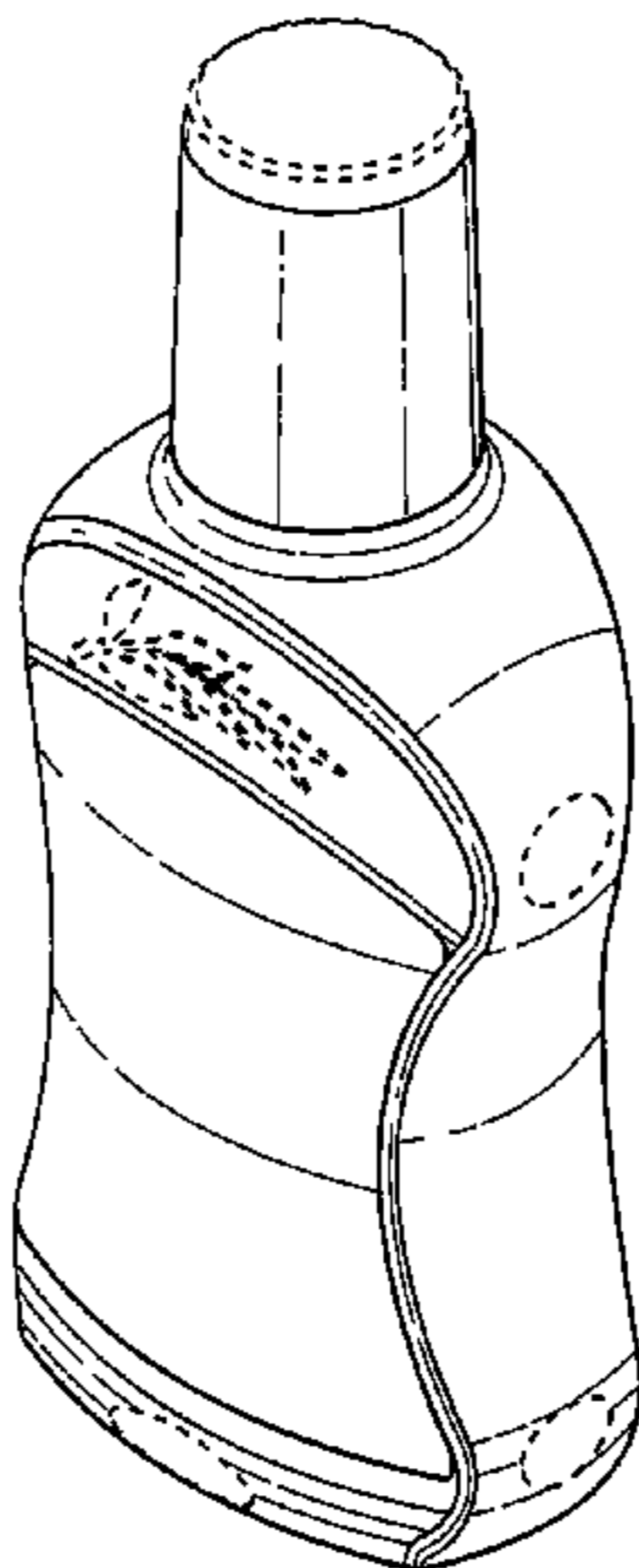
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front right side perspective view of a bottle; FIG. 2 is a front elevation view thereof, the rear elevation being identical thereto; FIG. 3 is a side elevation view thereof, the opposite side being identical thereto; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof. The broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

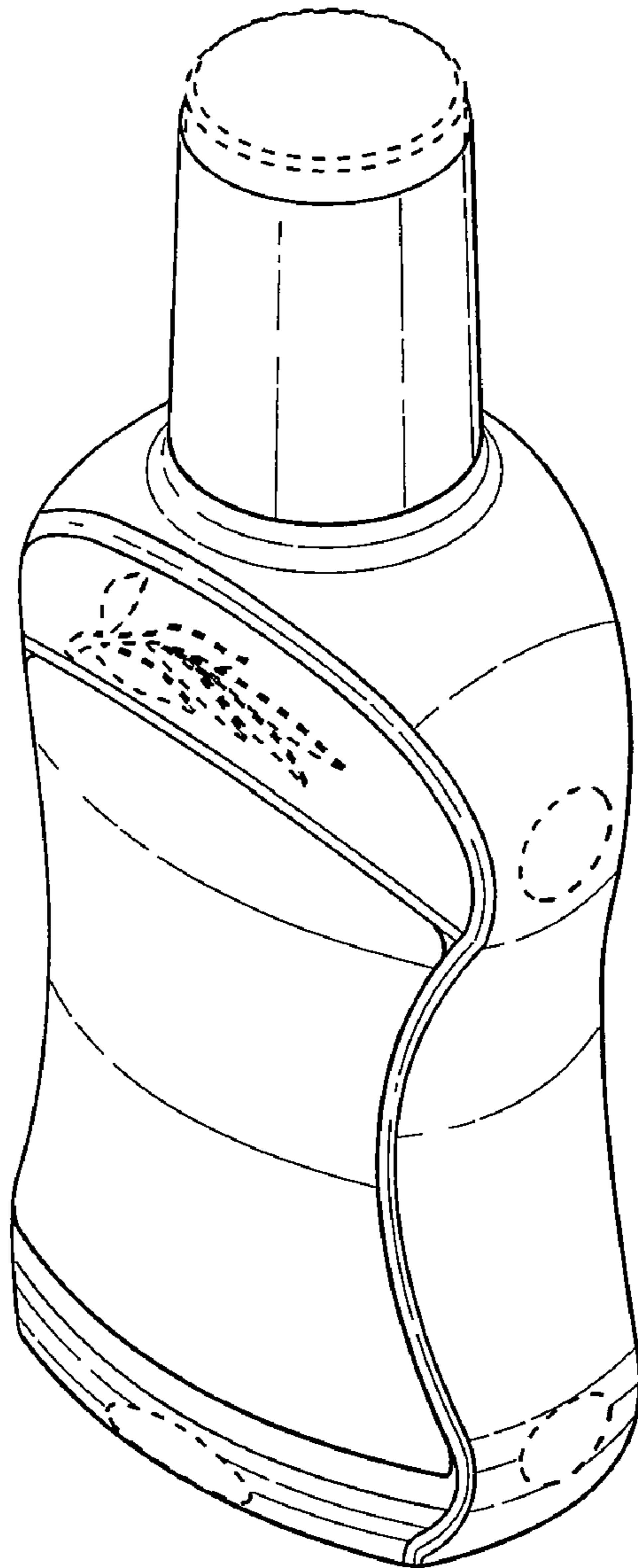

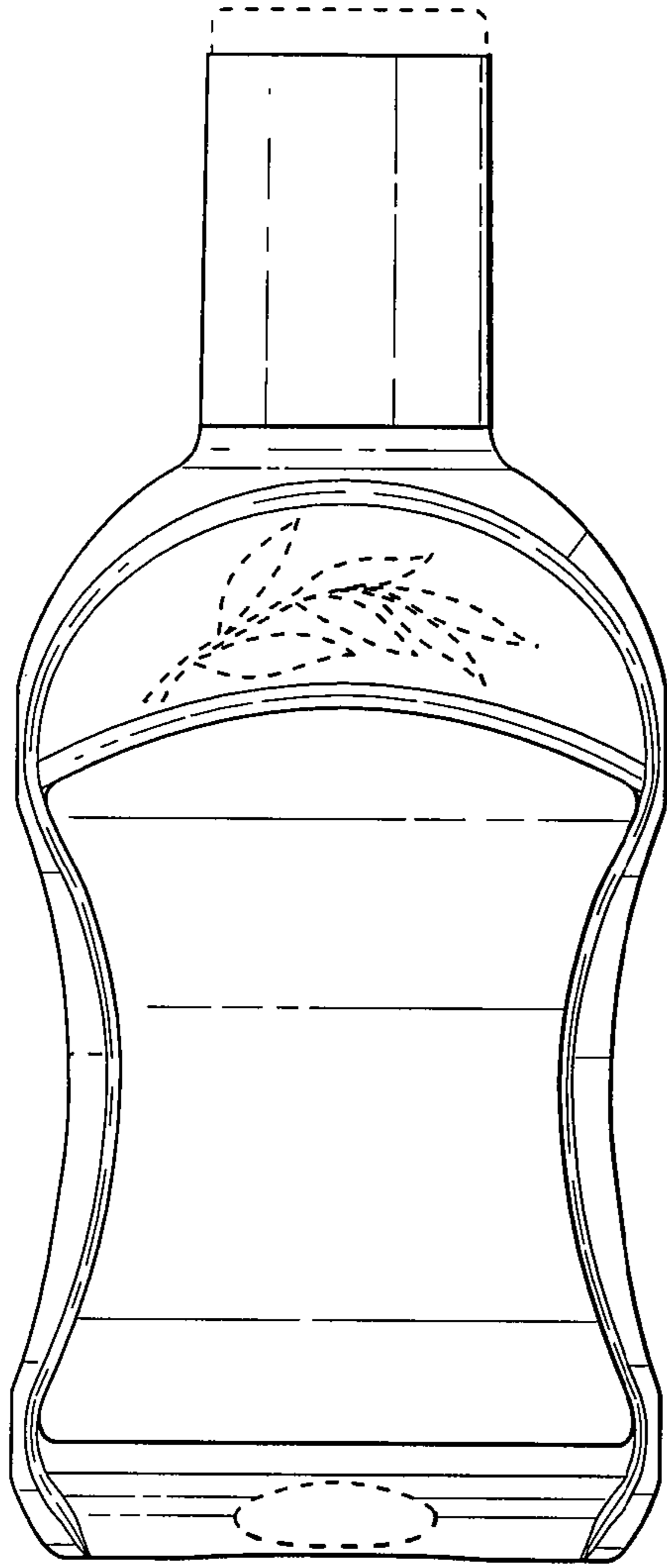

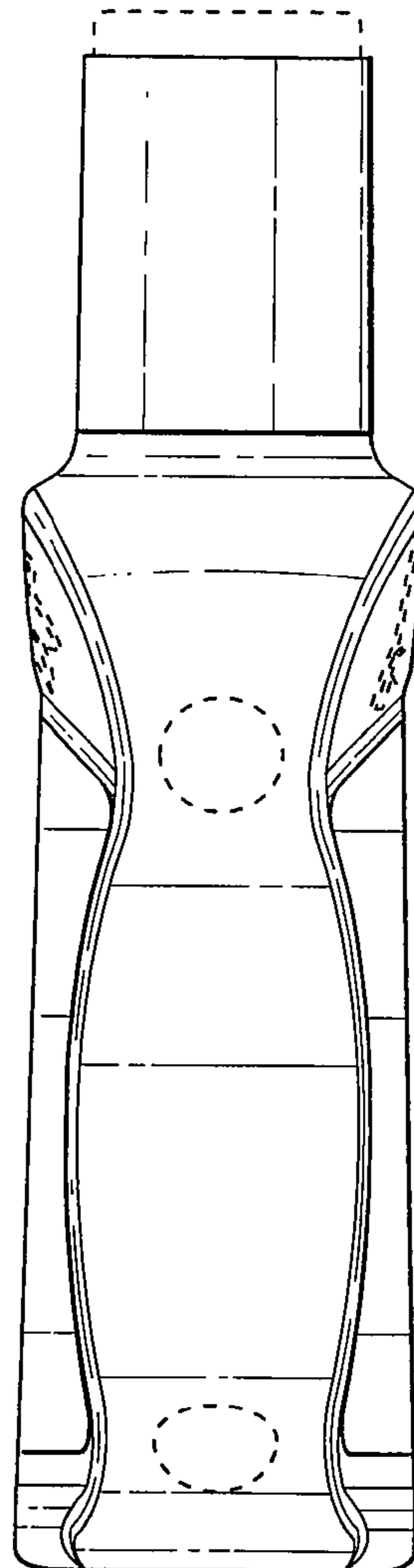

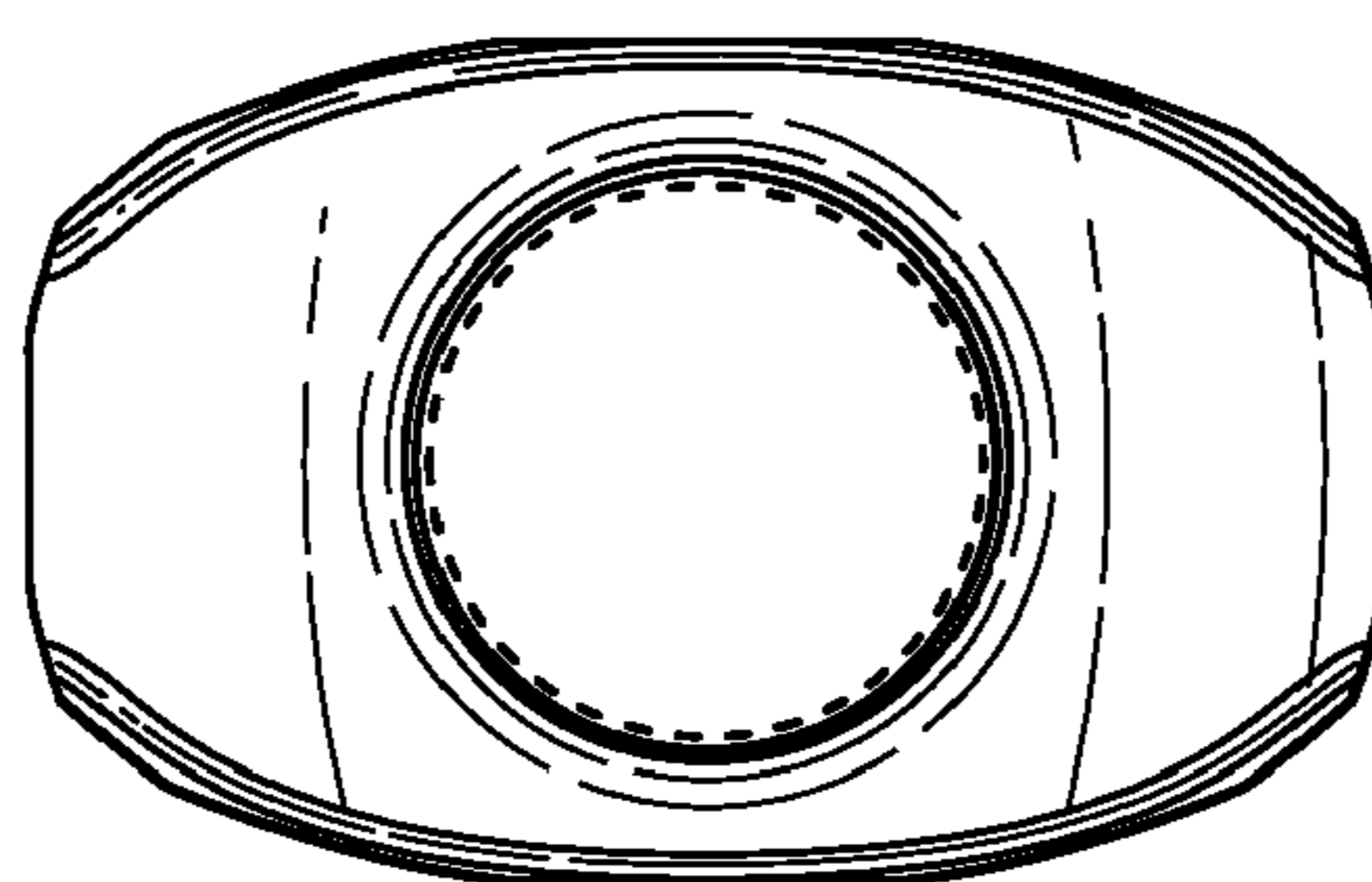
