FIG. 1 is a bottom perspective view of a container base showing my new design;

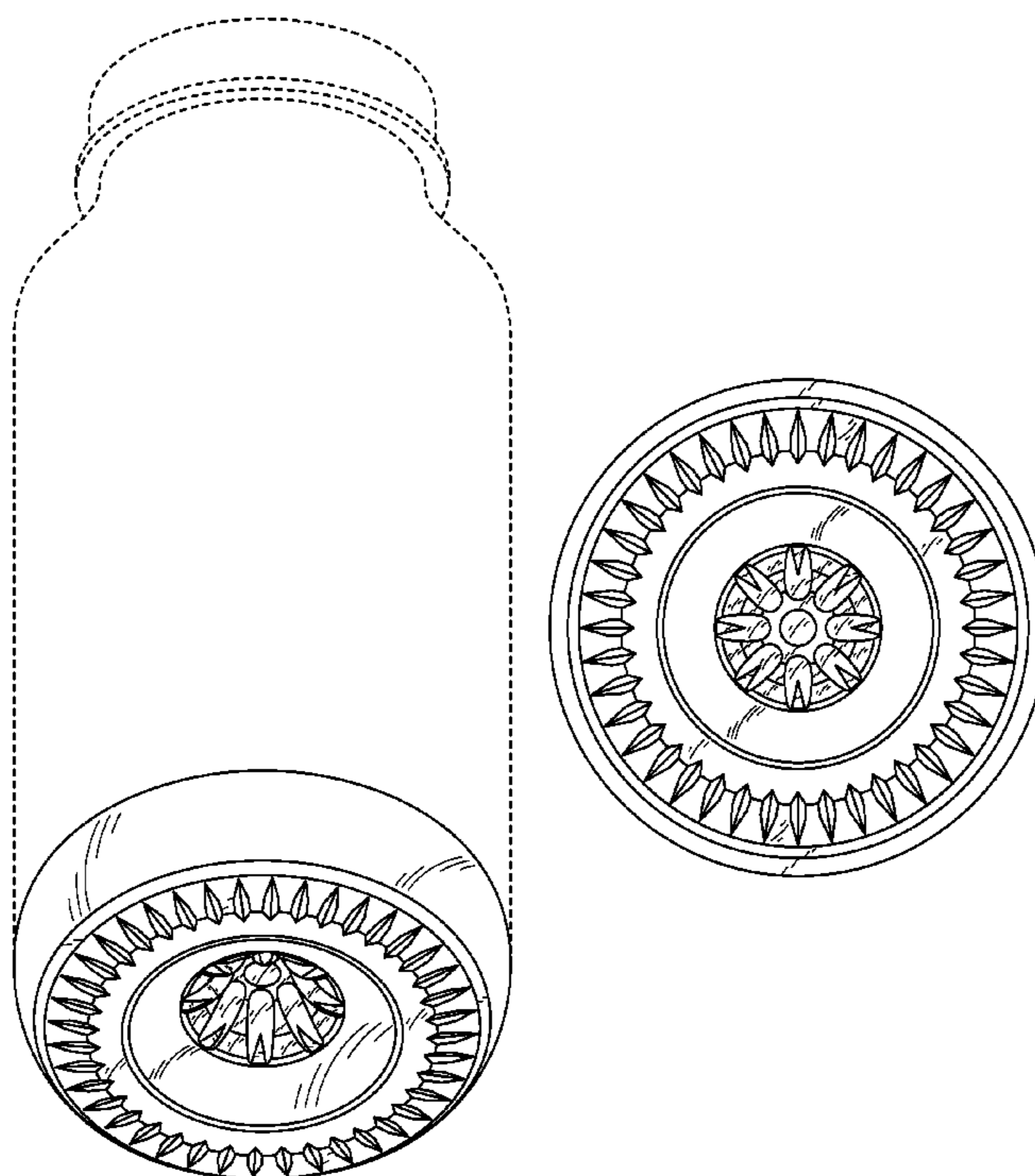
FIG. 2 is a bottom plan view thereof; and,

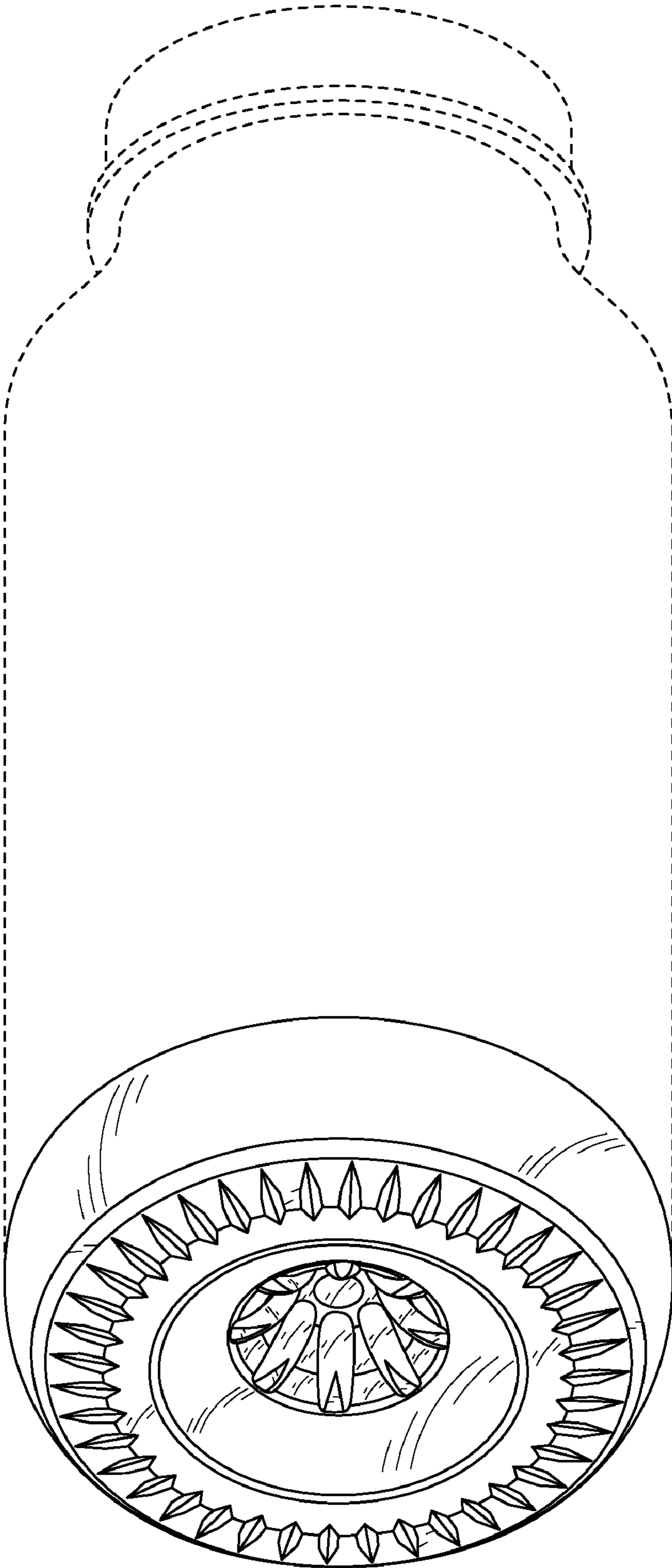

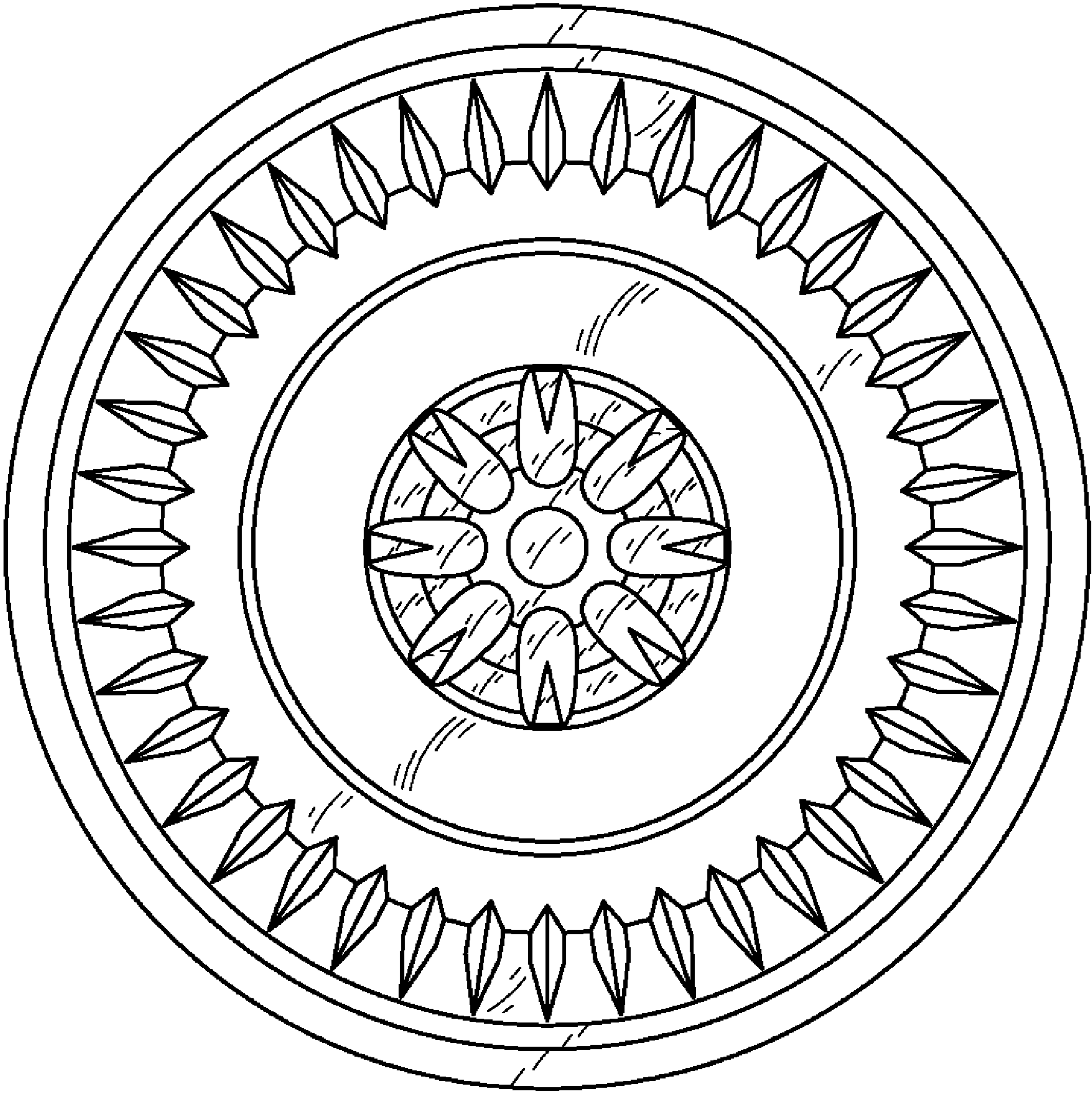

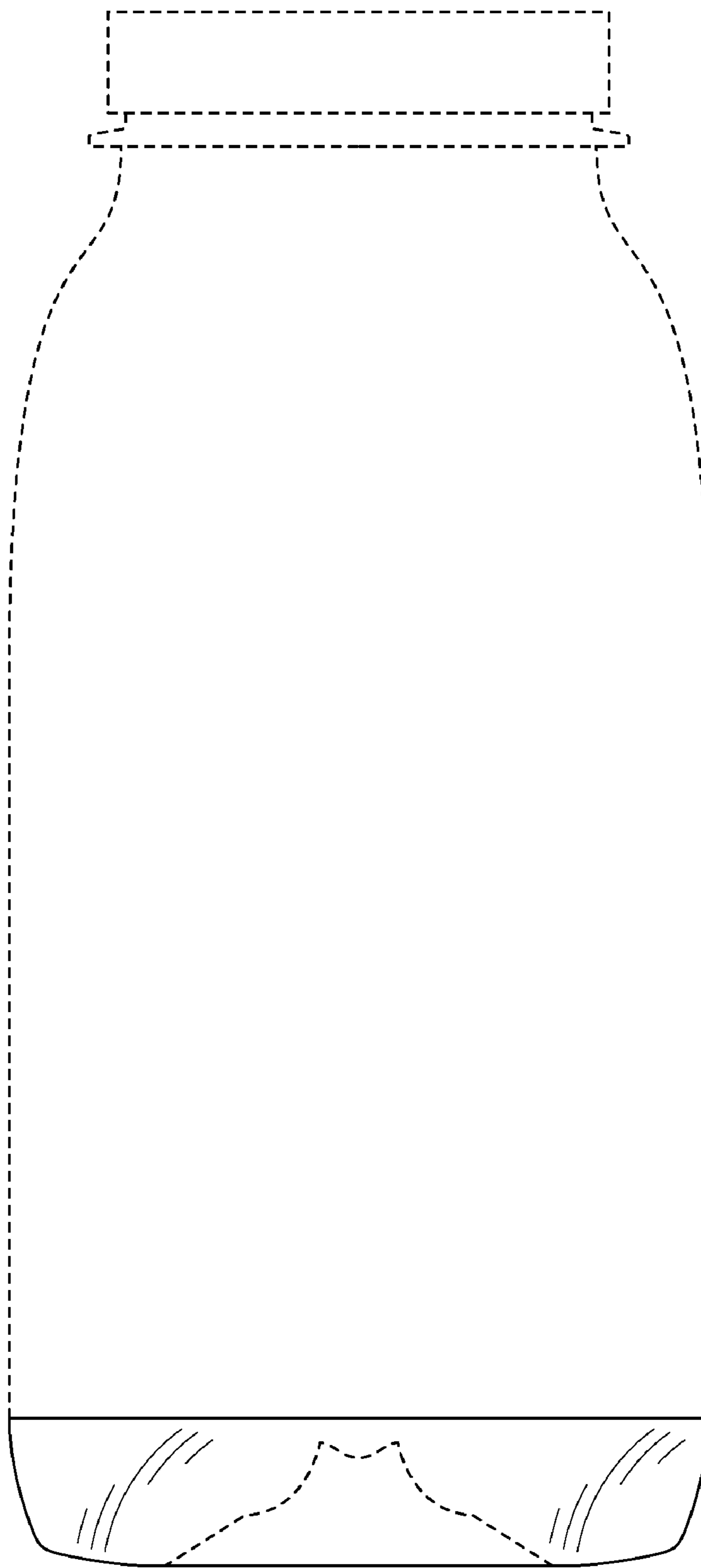
