The ornamental design for a cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, perspective view of a cellular phone showing our new design;

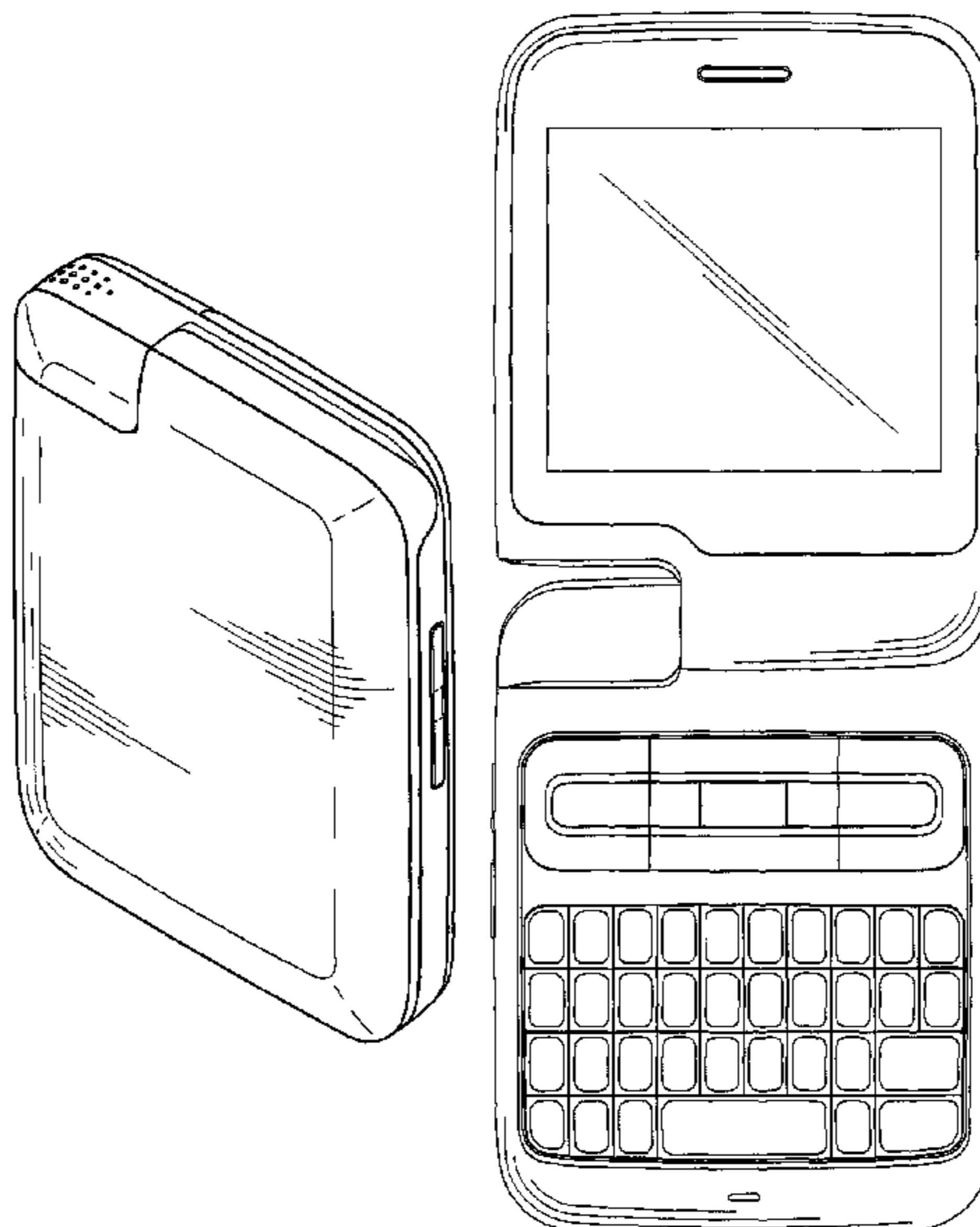

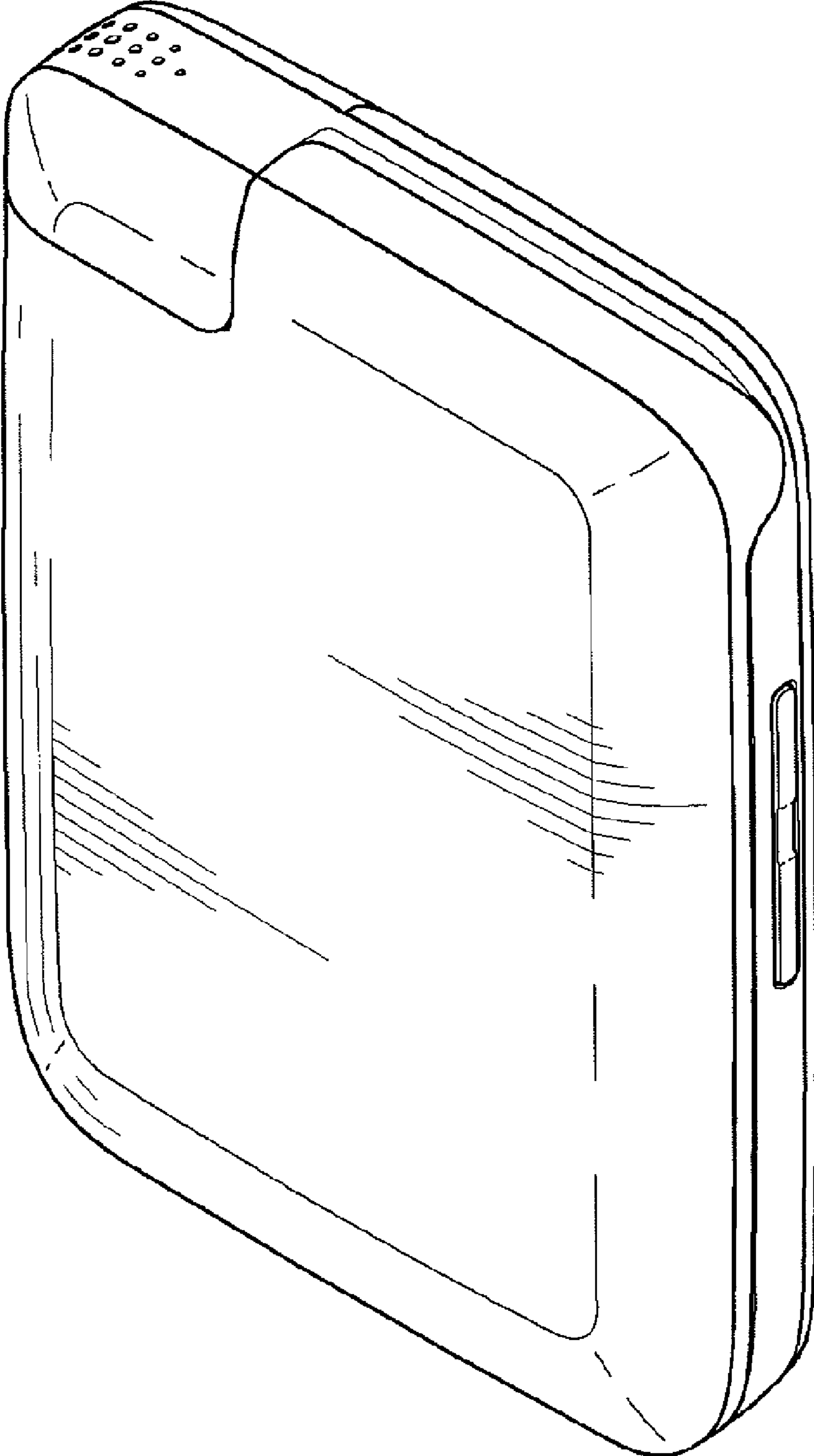

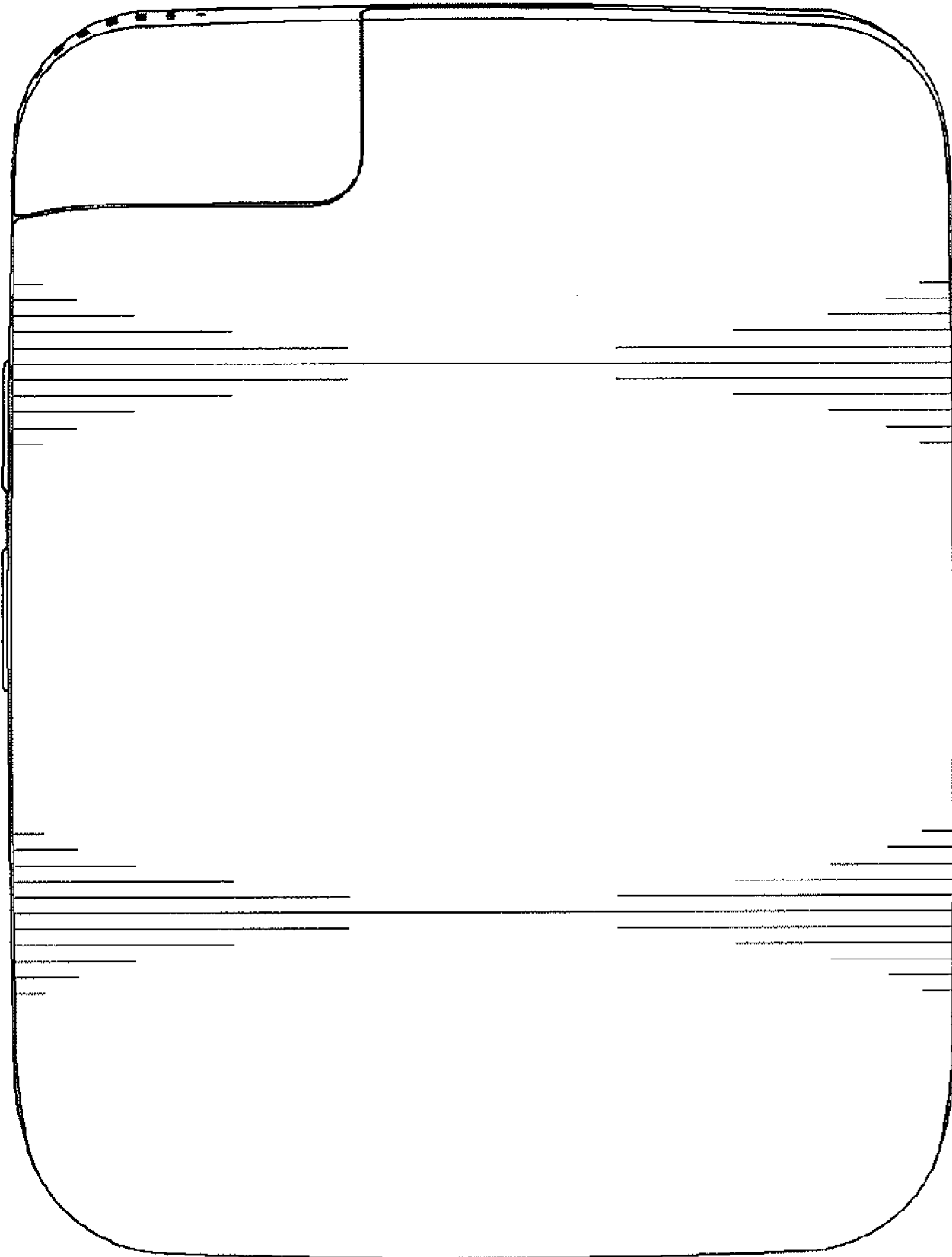

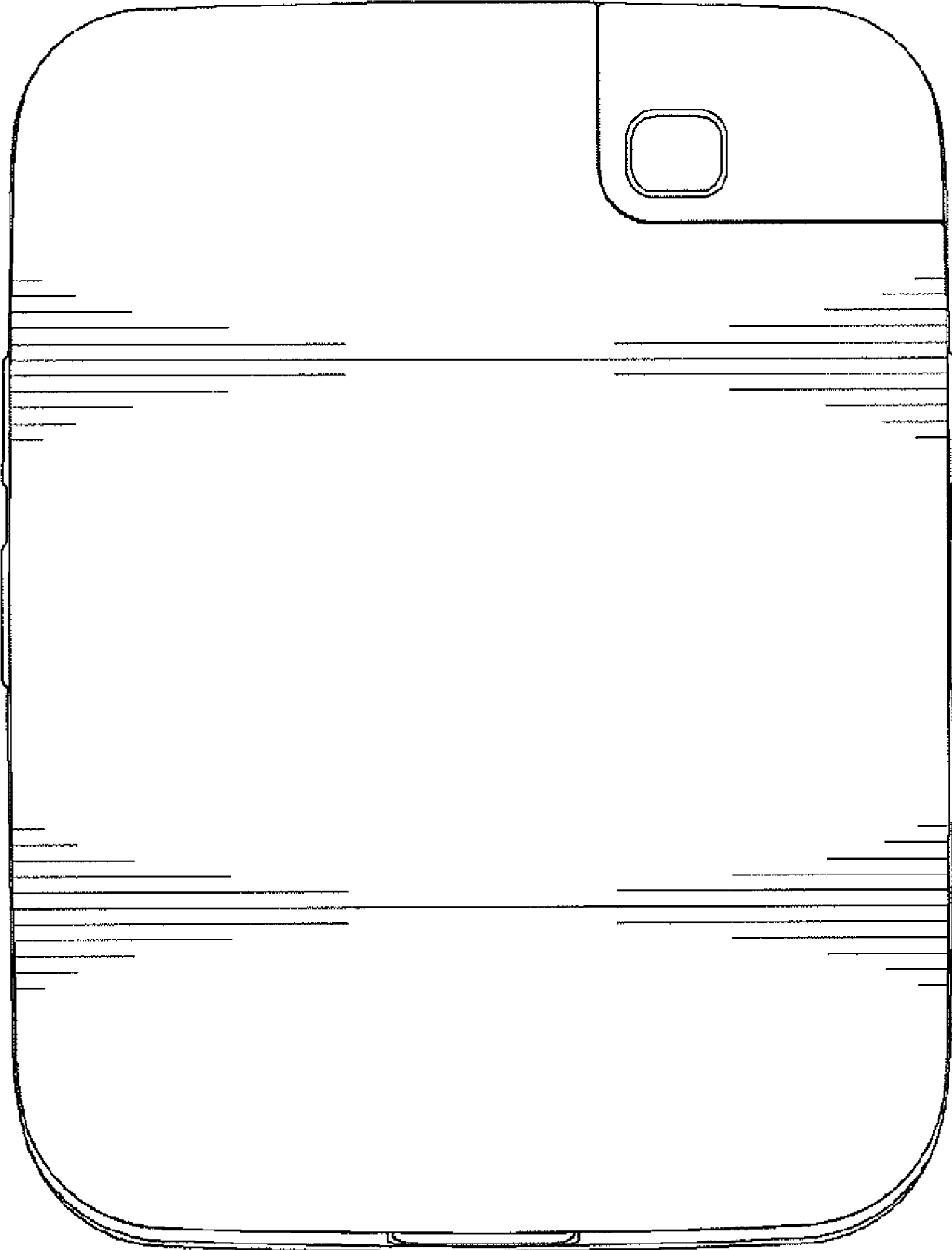

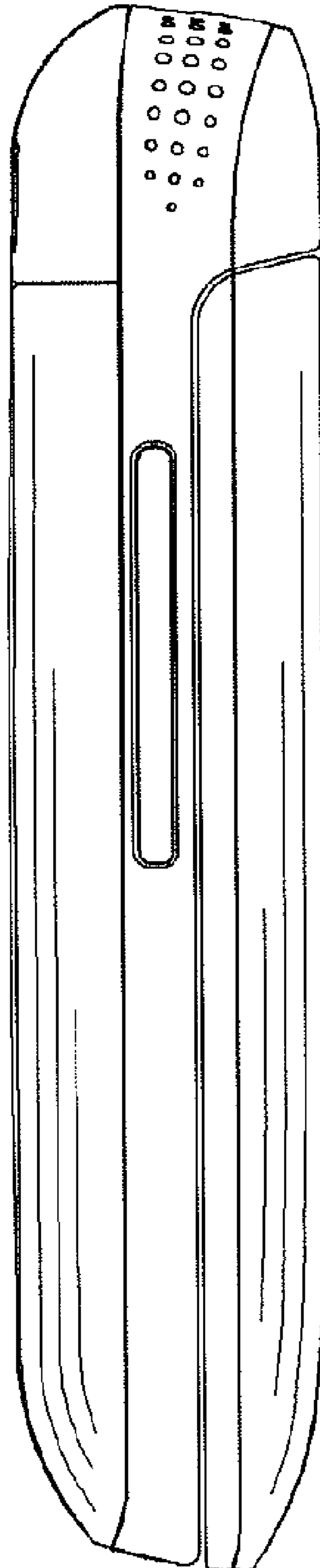

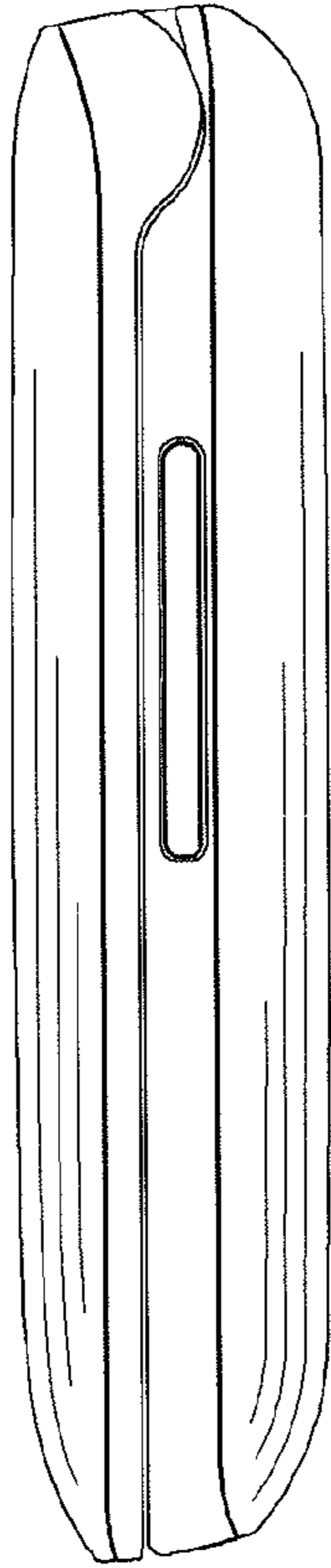

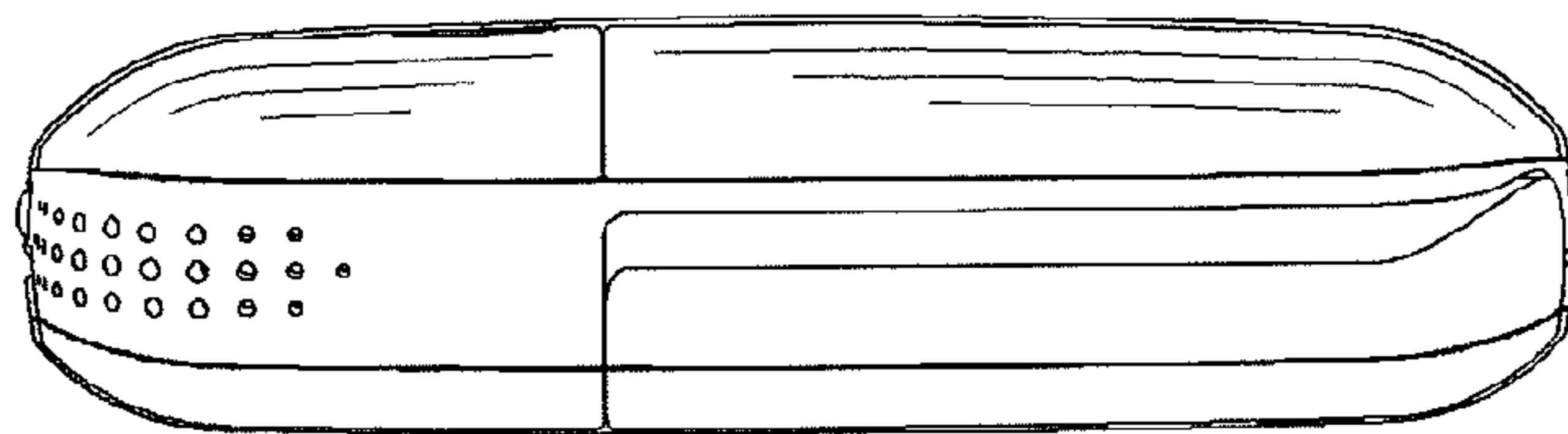

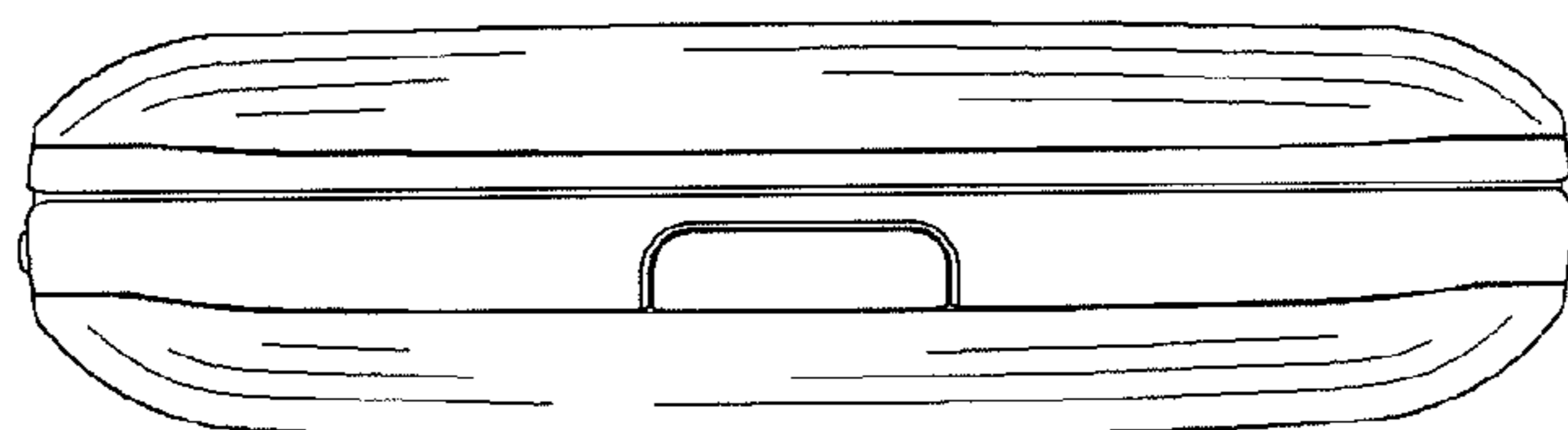
