FIG. 2 is a rear view of the stent of FIG. 1.

FIG. 3 is a top plan view of the stent of FIG. 1.

FIG. 4 is a bottom view of the stent of FIG. 1.

FIG. 5 is a right-side view of the stent of FIG. 1.

FIG. 6 is a left-side view of the stent of FIG. 1.

FIG. 7 is an enlarged, right-side view of the stent of FIG. 1.

FIG. 8 is an enlarged, left-side view of the stent of FIG. 1.

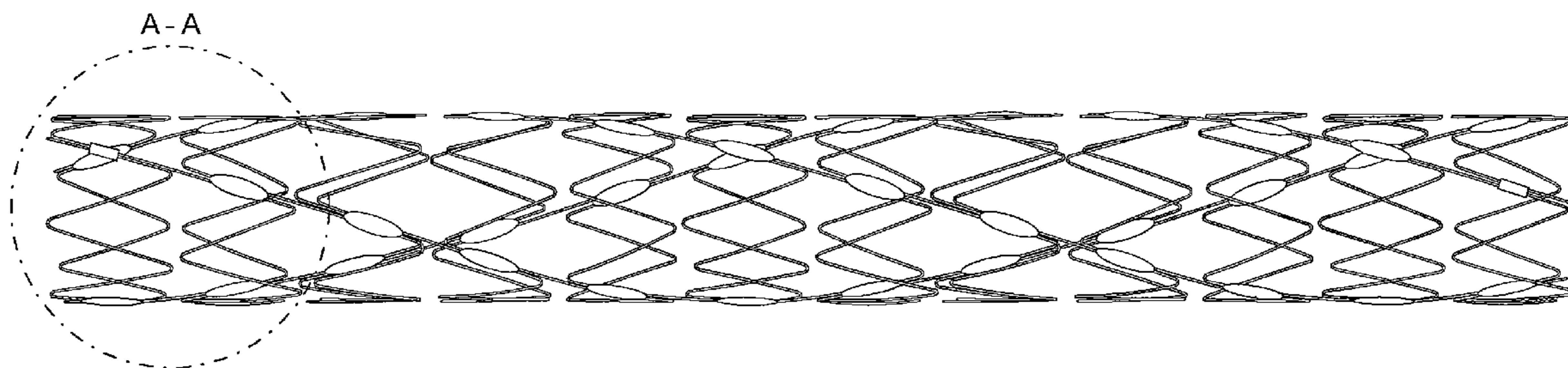
FIG. 9 is an enlarged view of the stent taken substantially along section A-A of FIG. 1.

FIG. 10 is a fragmentary, front view of the stent of FIG. 1, where the rear of the stent is removed for purposes of illustrating the front of the stent; and,

FIG. 11 is partially enlarged left-side perspective view of the stent taken substantially along section A-A of FIG. 1.

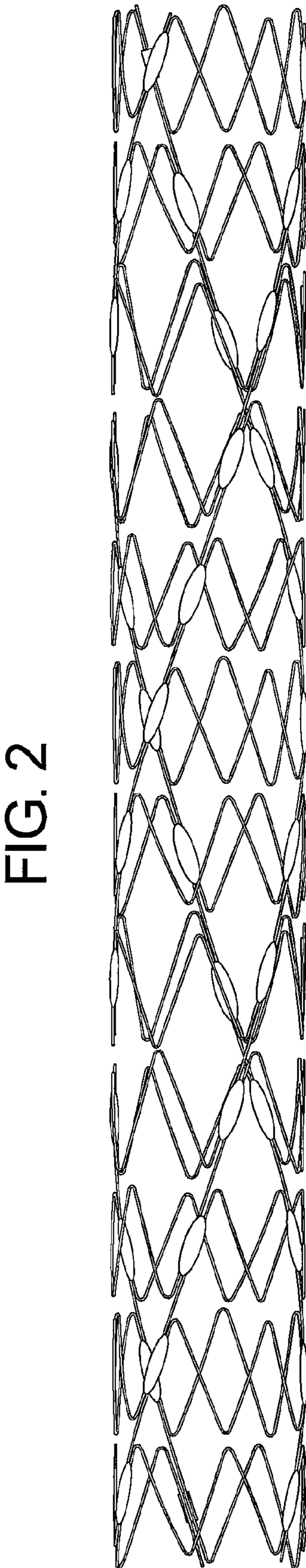
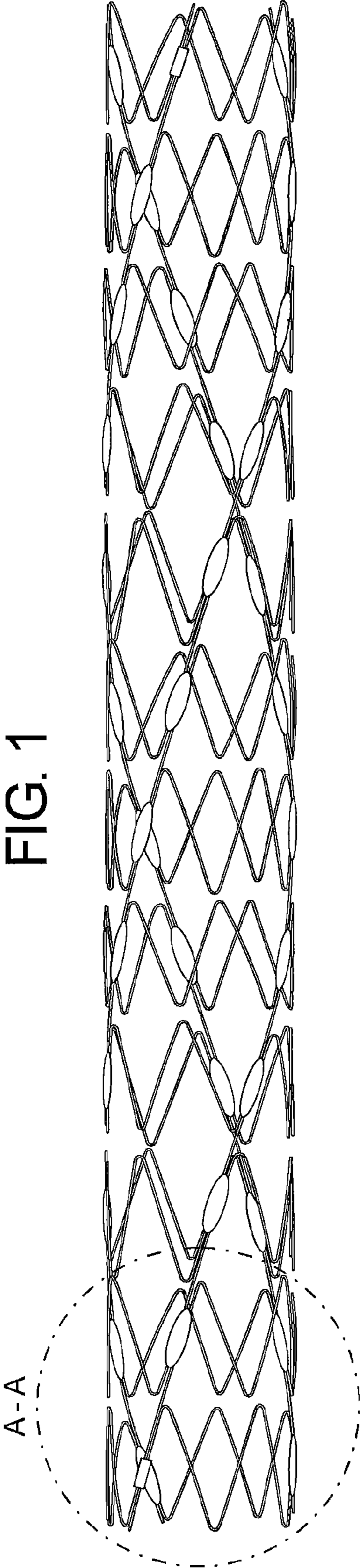

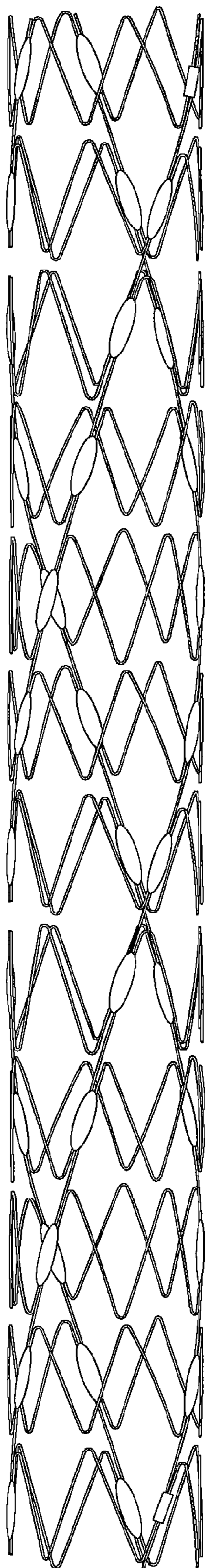

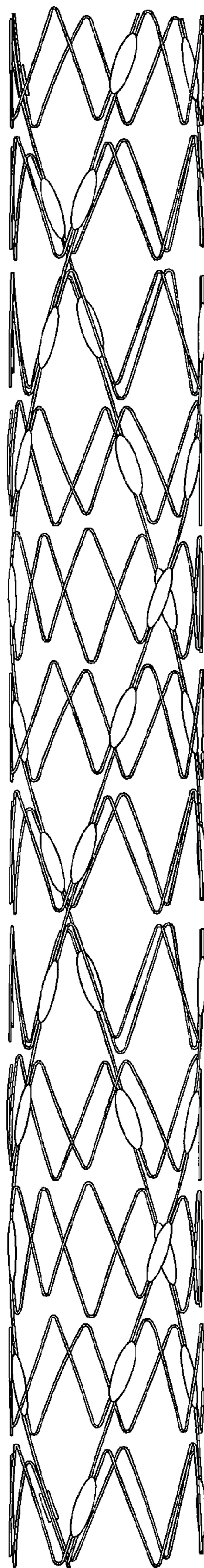

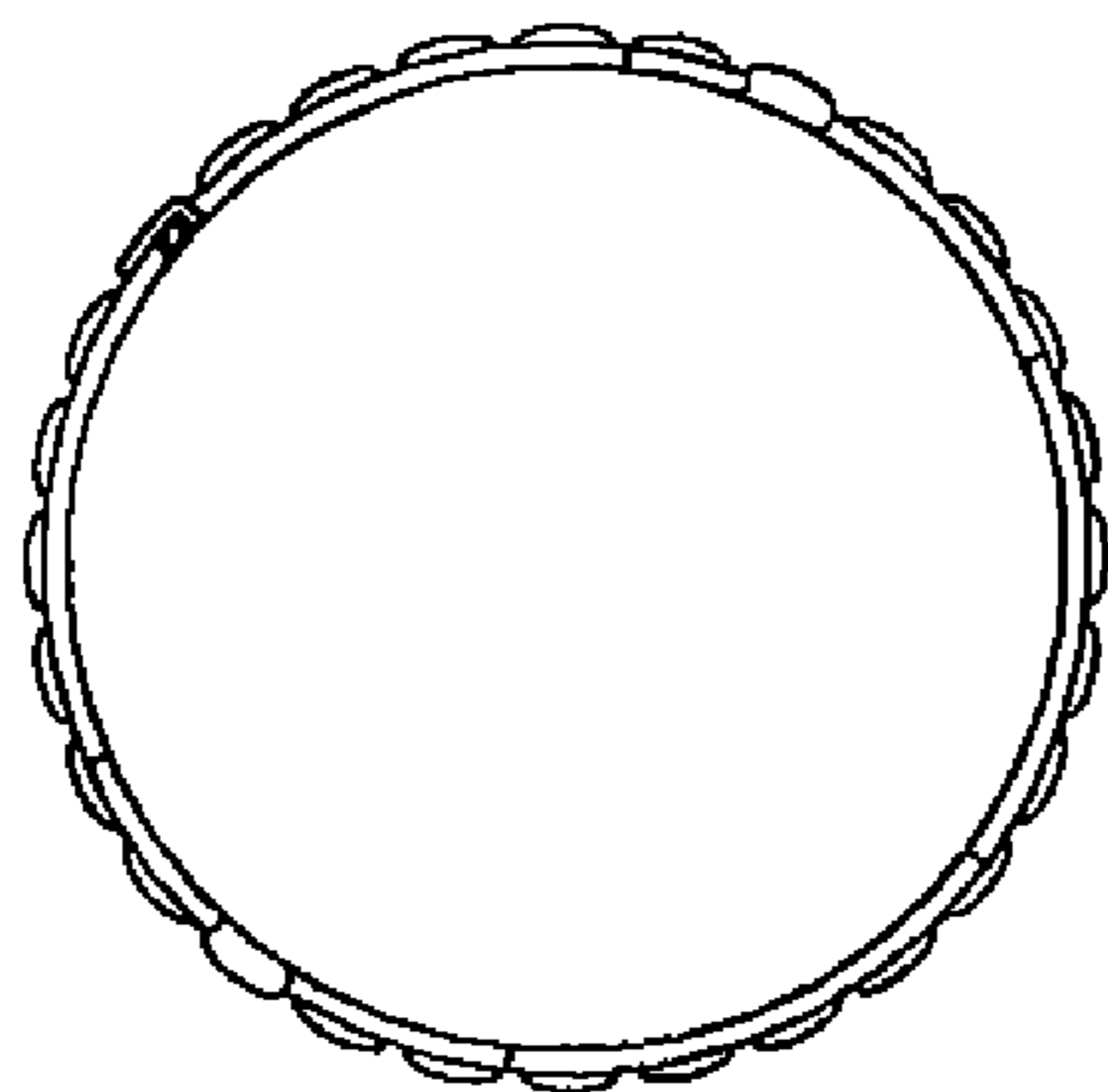

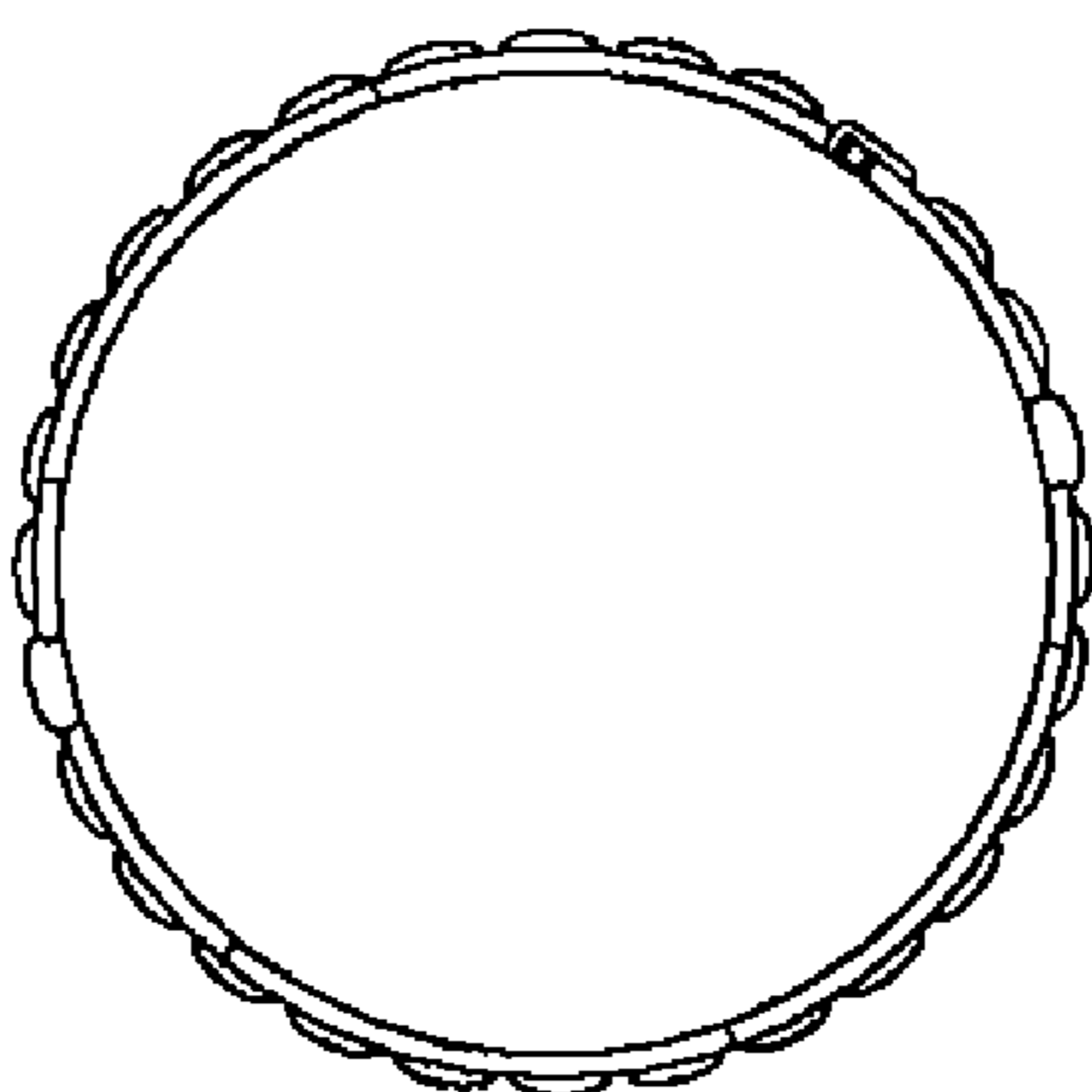

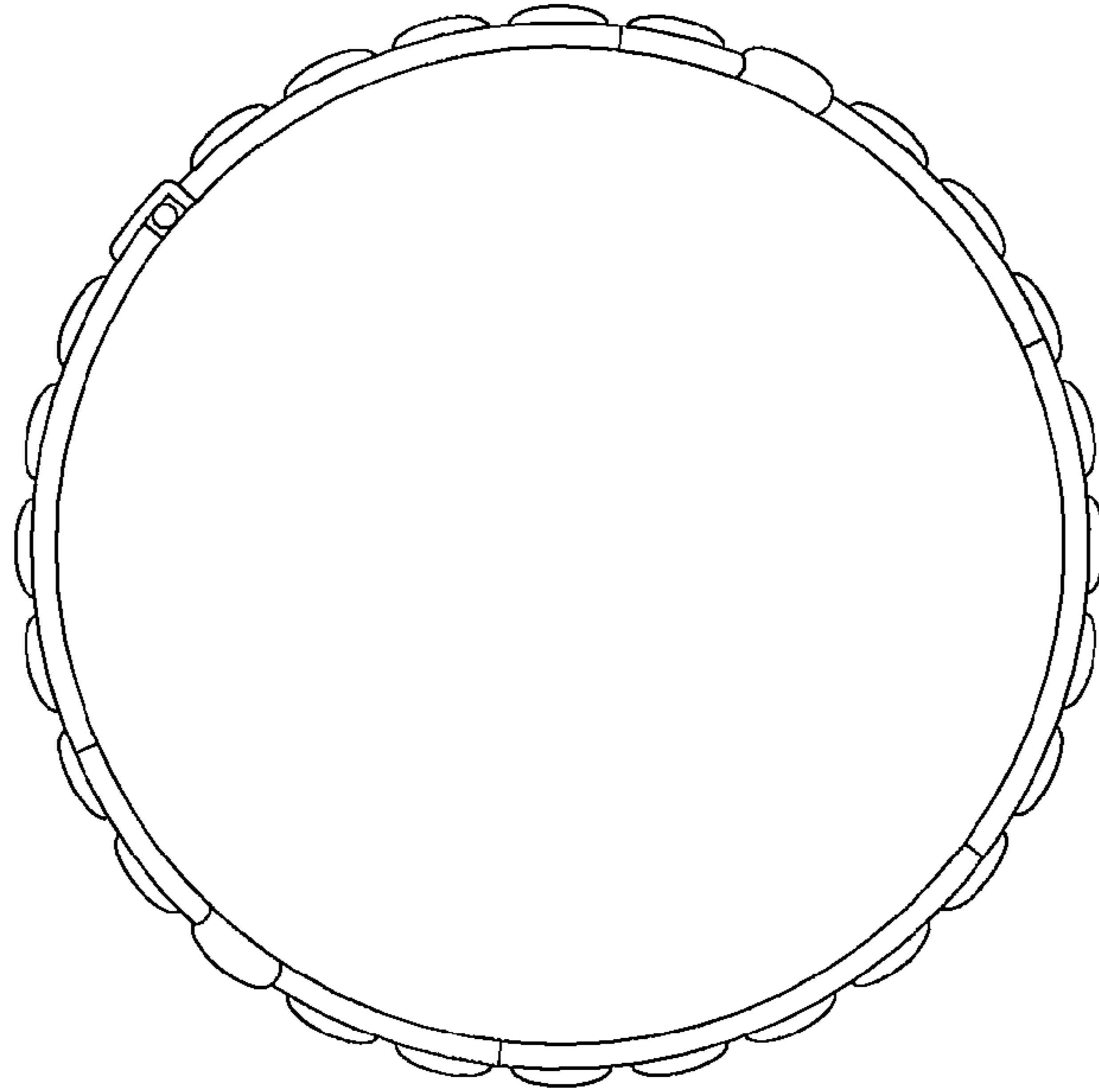

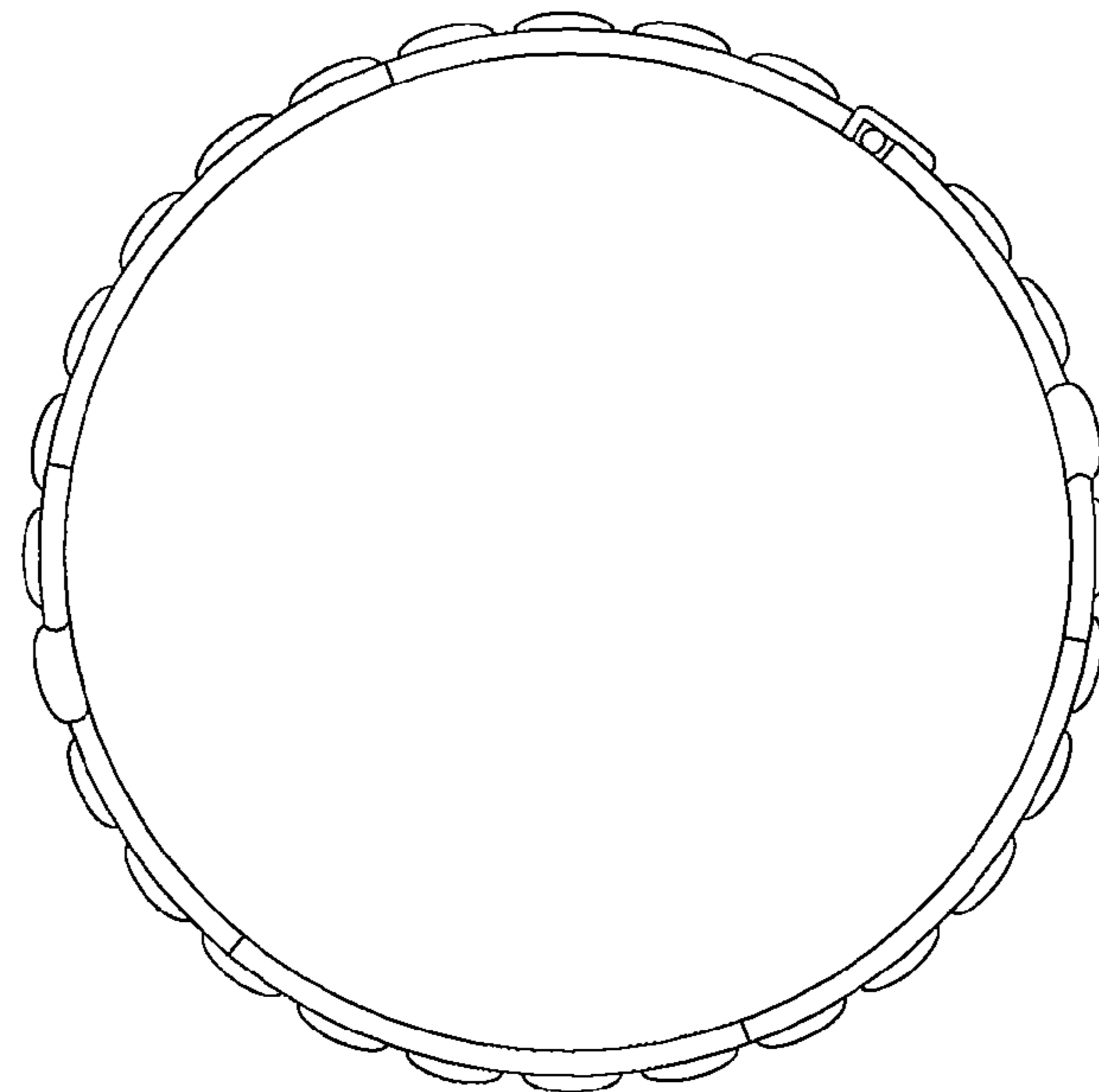

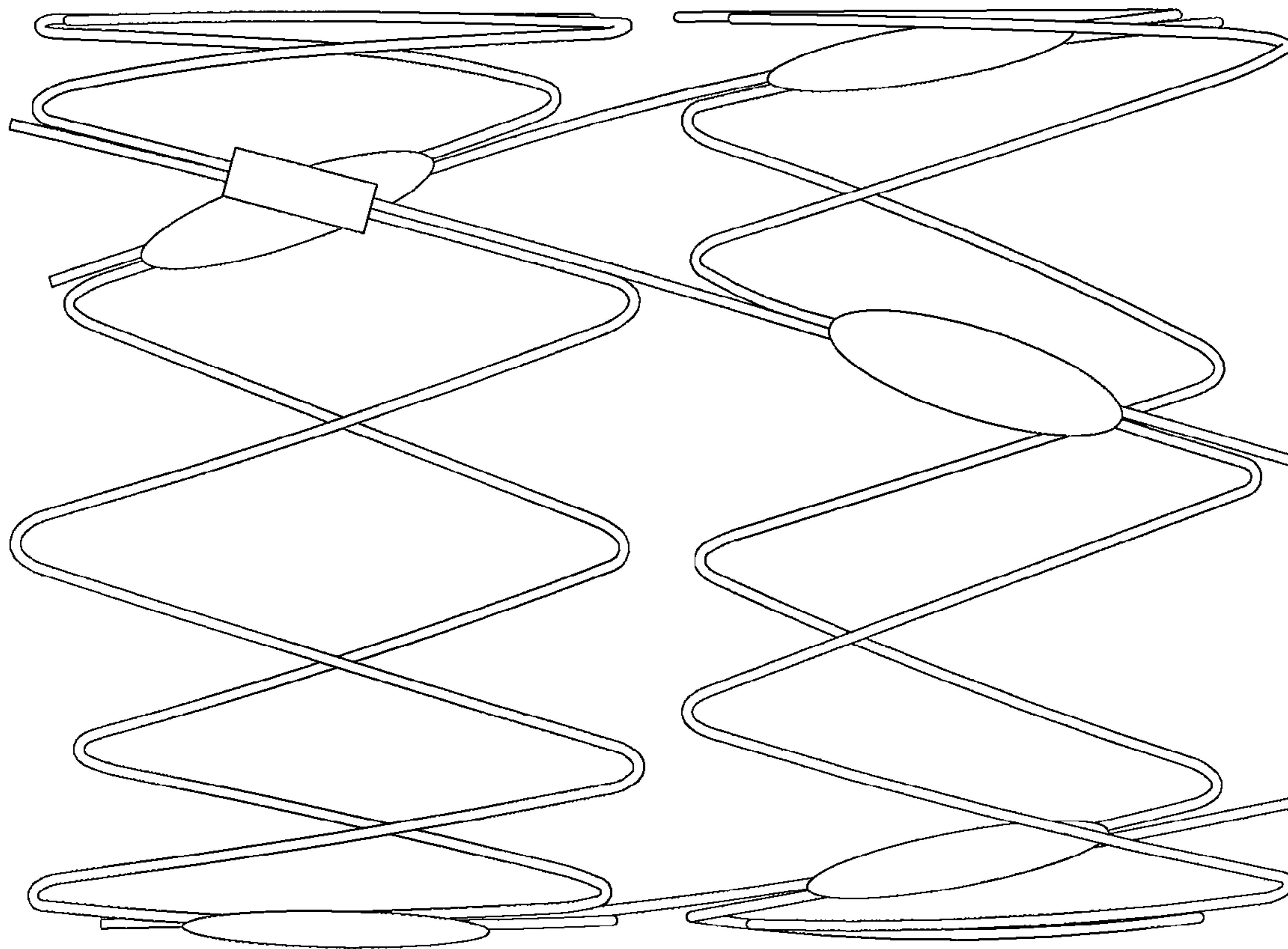

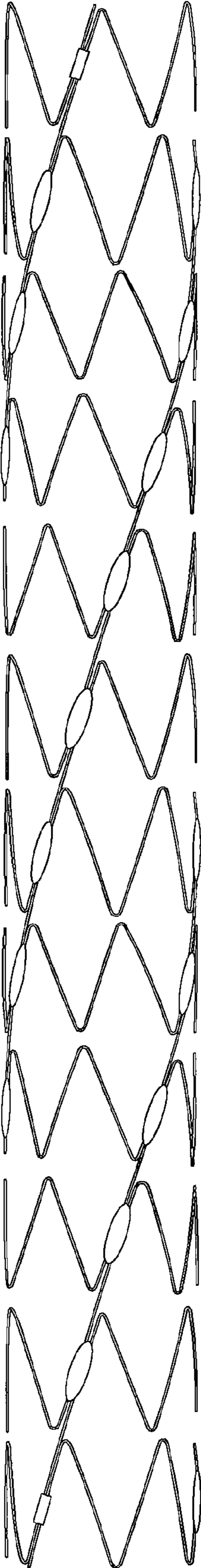
