The ornamental design for a wound bandage, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of a wound bandage showing my new design;

FIG. 2 is a lower perspective view of FIG. 1;

FIG. 3 is a top plan view of FIG. 1;

FIG. 4 is a bottom plan view of FIG. 1;

FIG. 5 is a front elevation view of FIG. 1;

FIG. 6 is a rear elevation view of FIG. 1;

FIG. 7 is a right side elevation view of FIG. 1;

FIG. 8 is a left side view of FIG. 1;

FIG. 9 is a perspective view of another embodiment of a wound bandage showing my new design;

FIG. 10 is a lower perspective view of FIG. 9;

FIG. 11 is a top plan view of FIG. 9;

FIG. 12 is a bottom plan view of FIG. 9;

FIG. 13 is a front elevation view of FIG. 9, the rear elevation view being a mirror image thereof; and,

FIG. 14 is a right side elevation view of FIG. 9, the left side elevation view being a mirror image thereof.

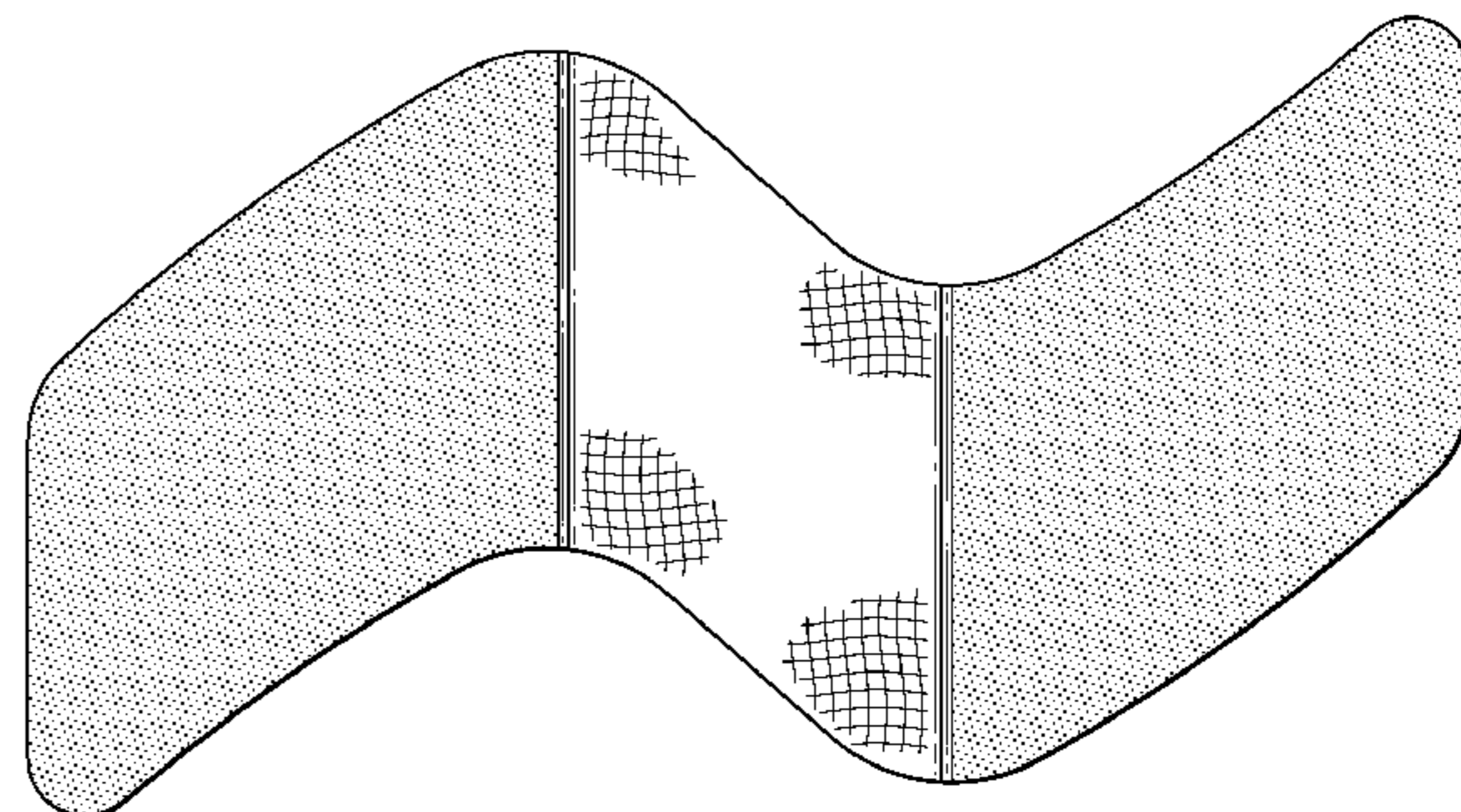
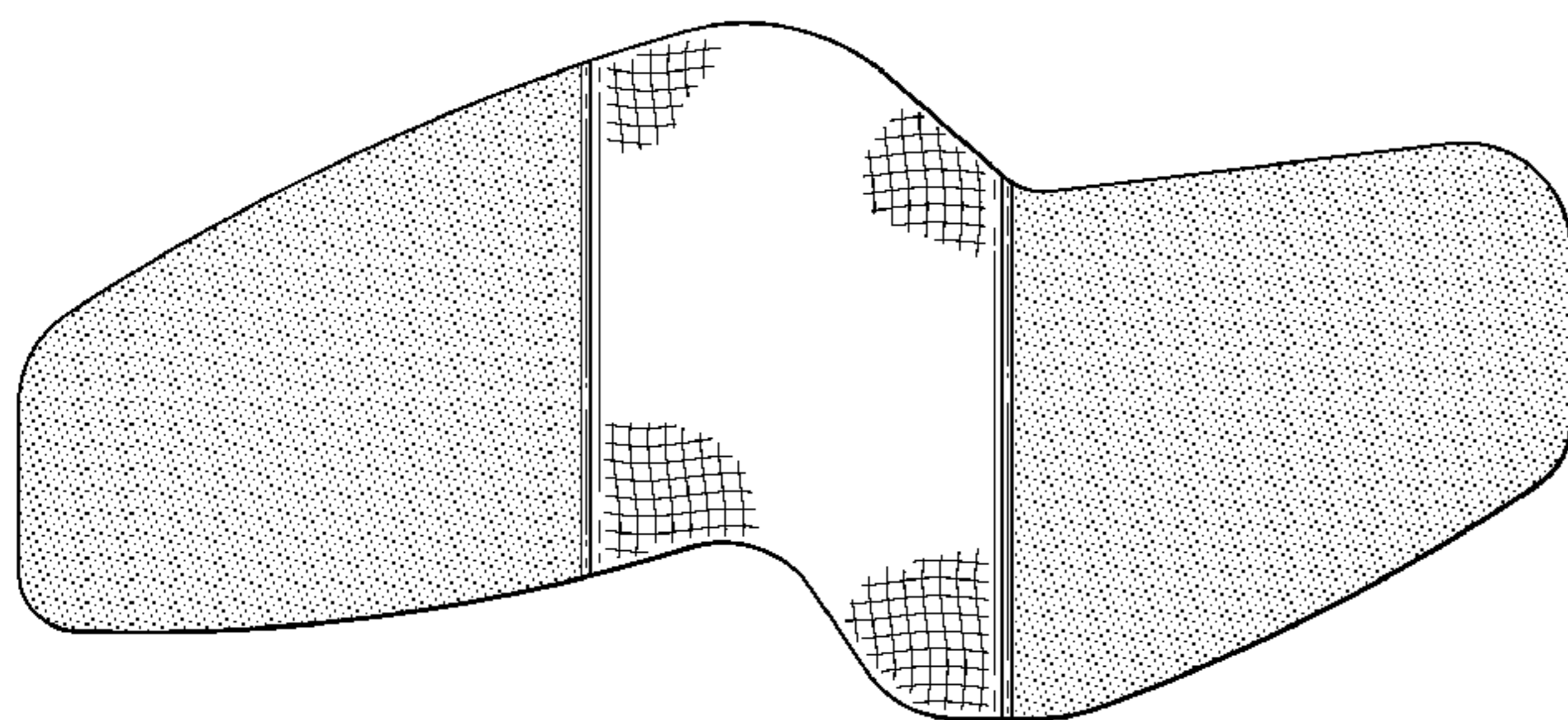

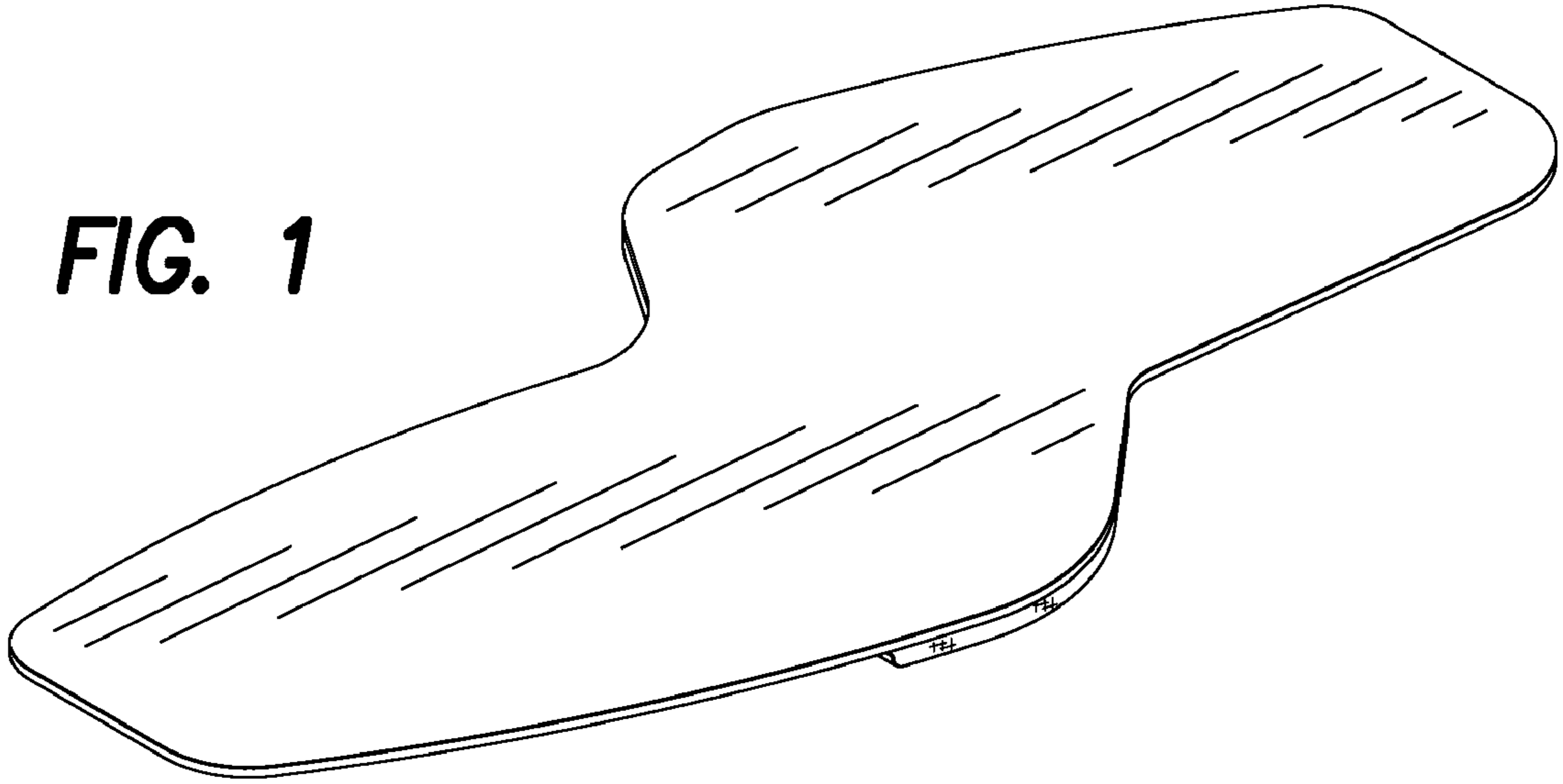

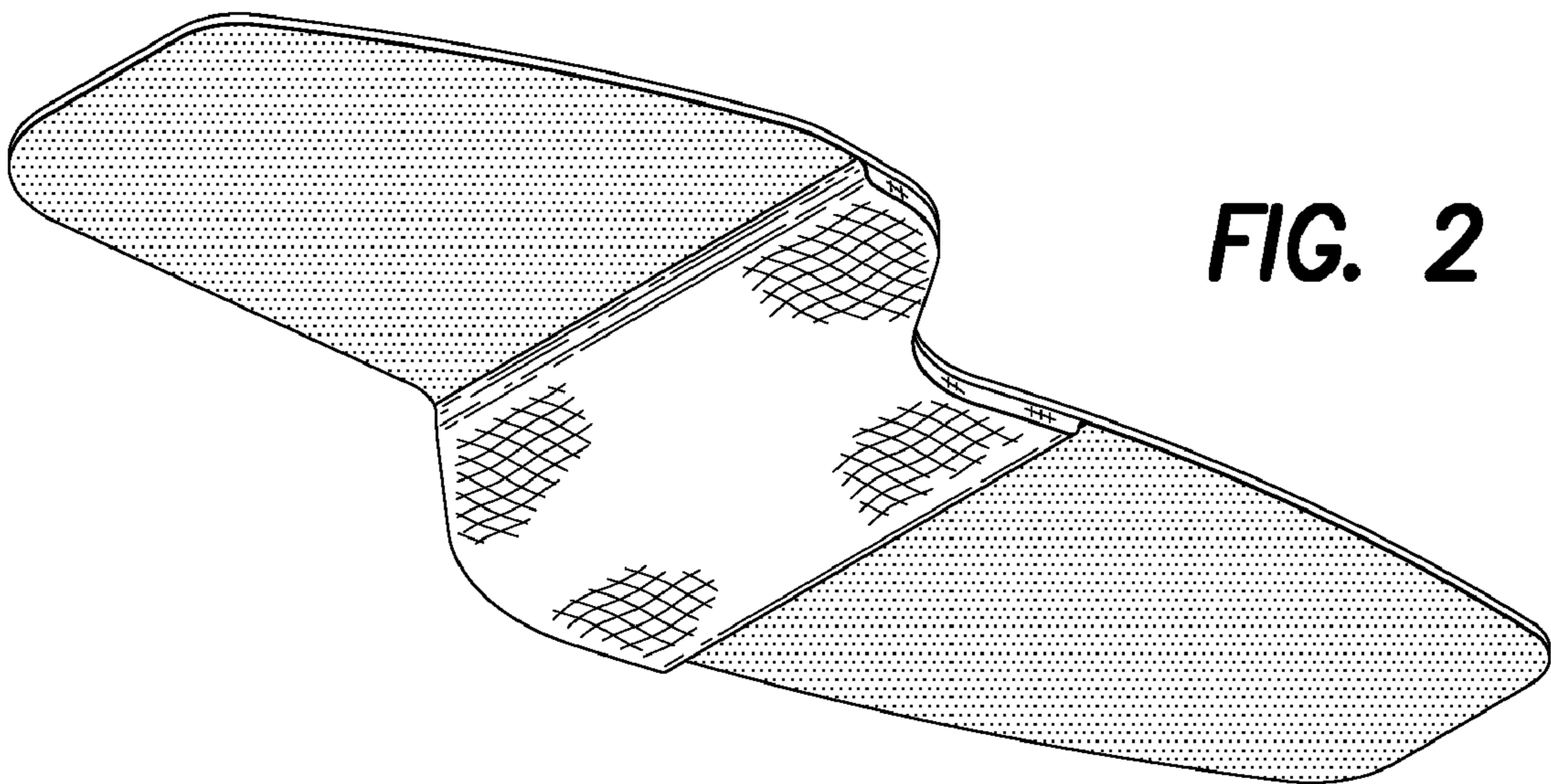

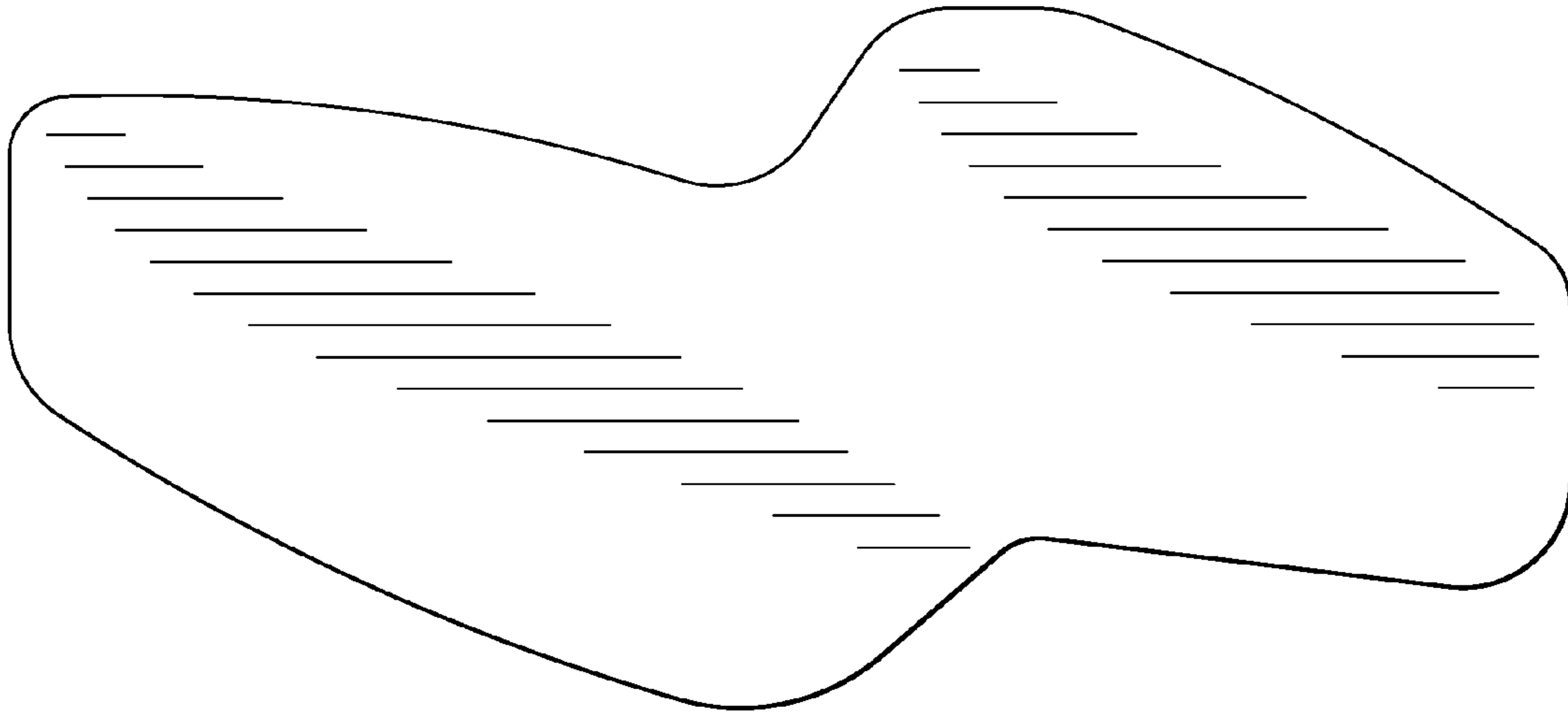

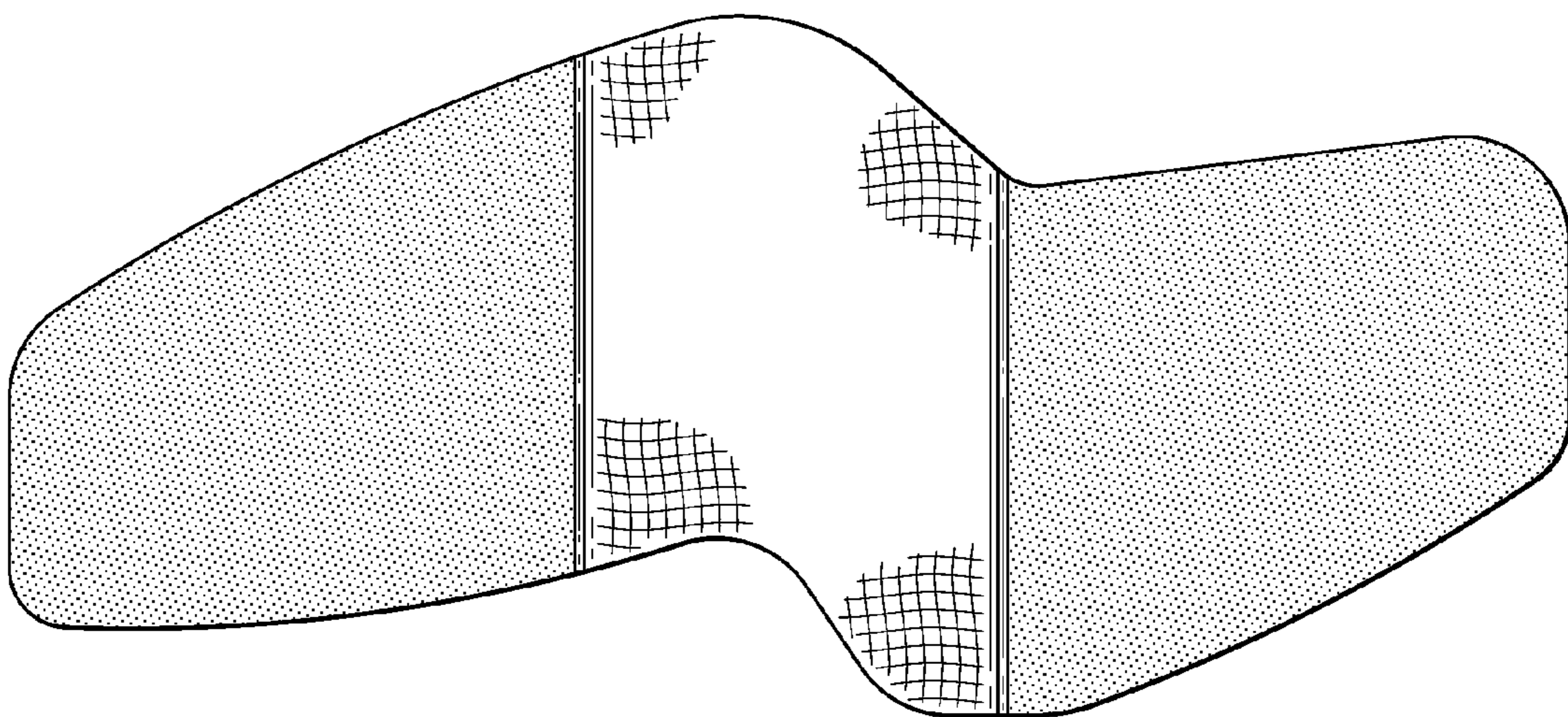

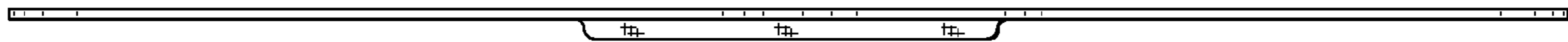

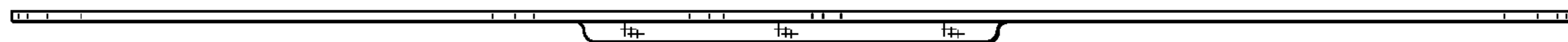

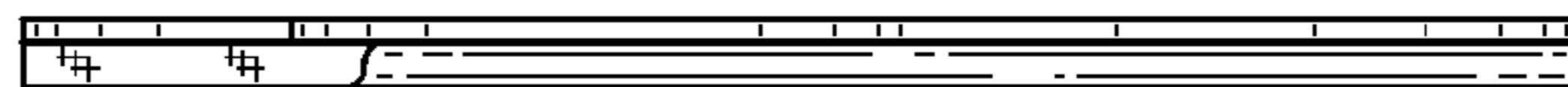

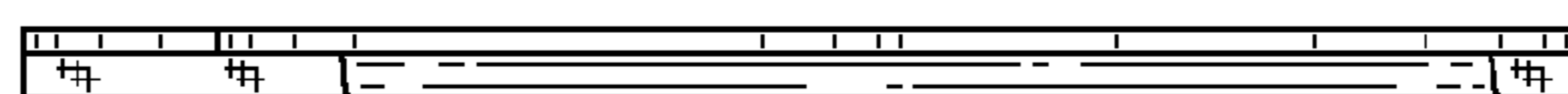

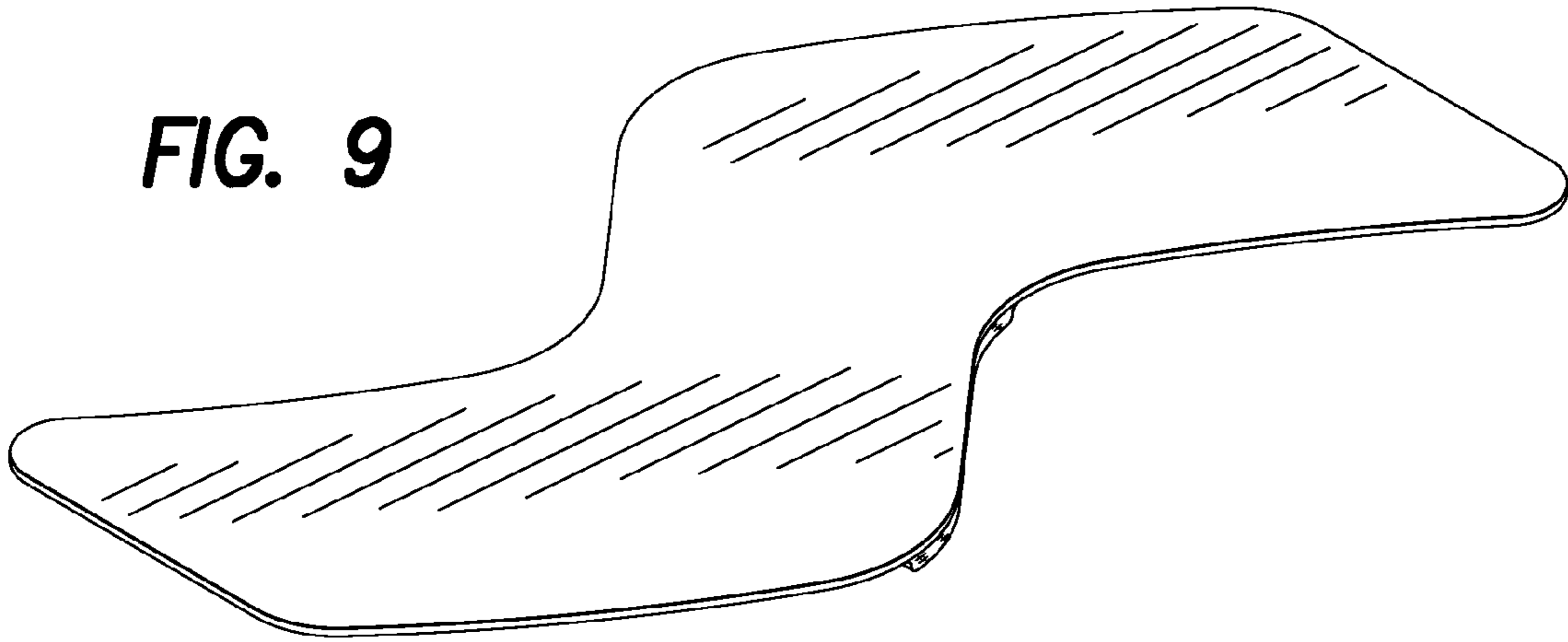

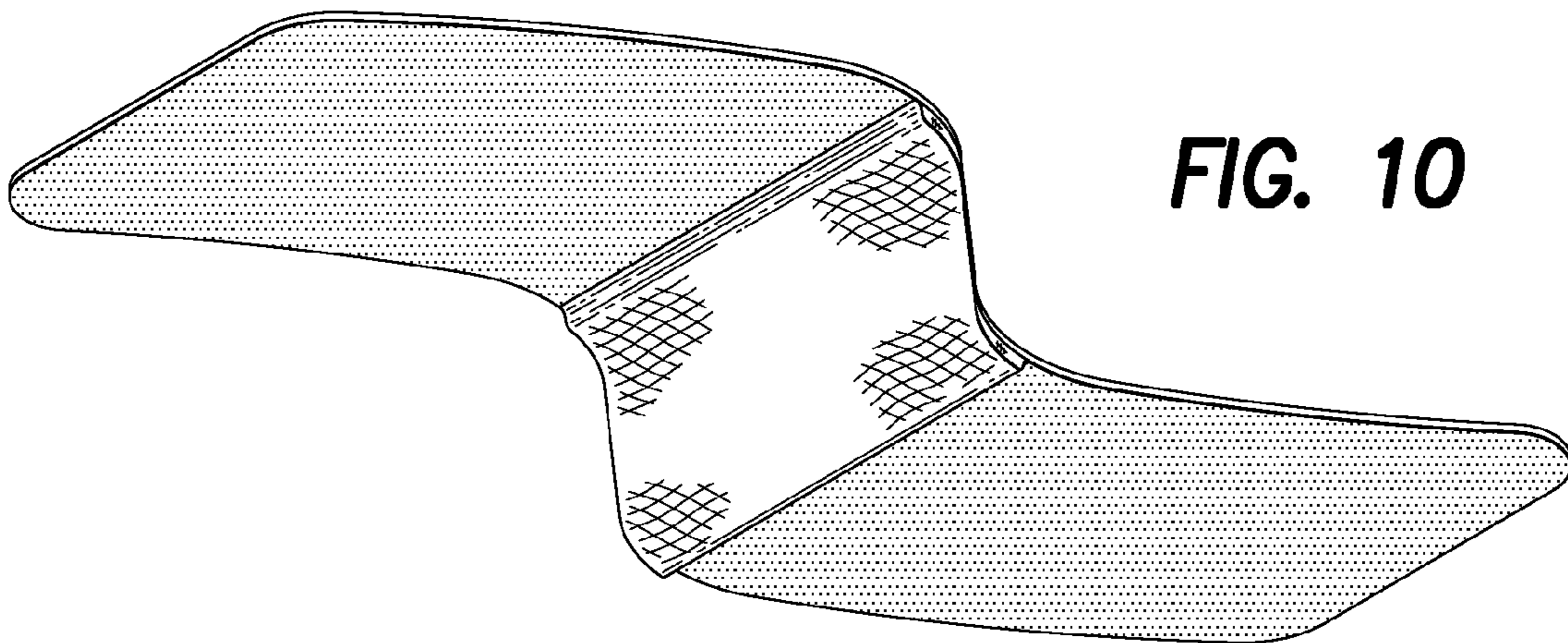

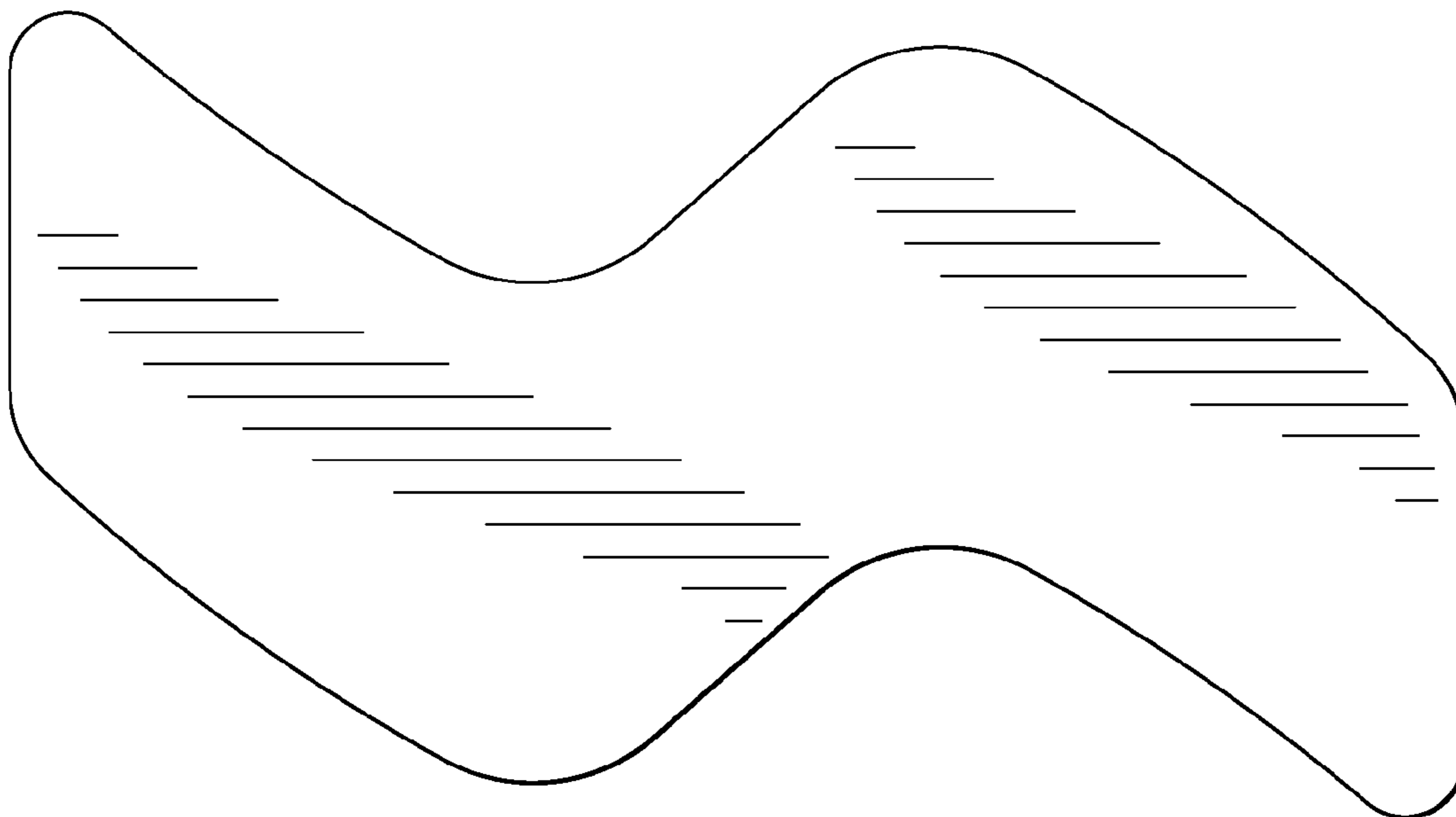

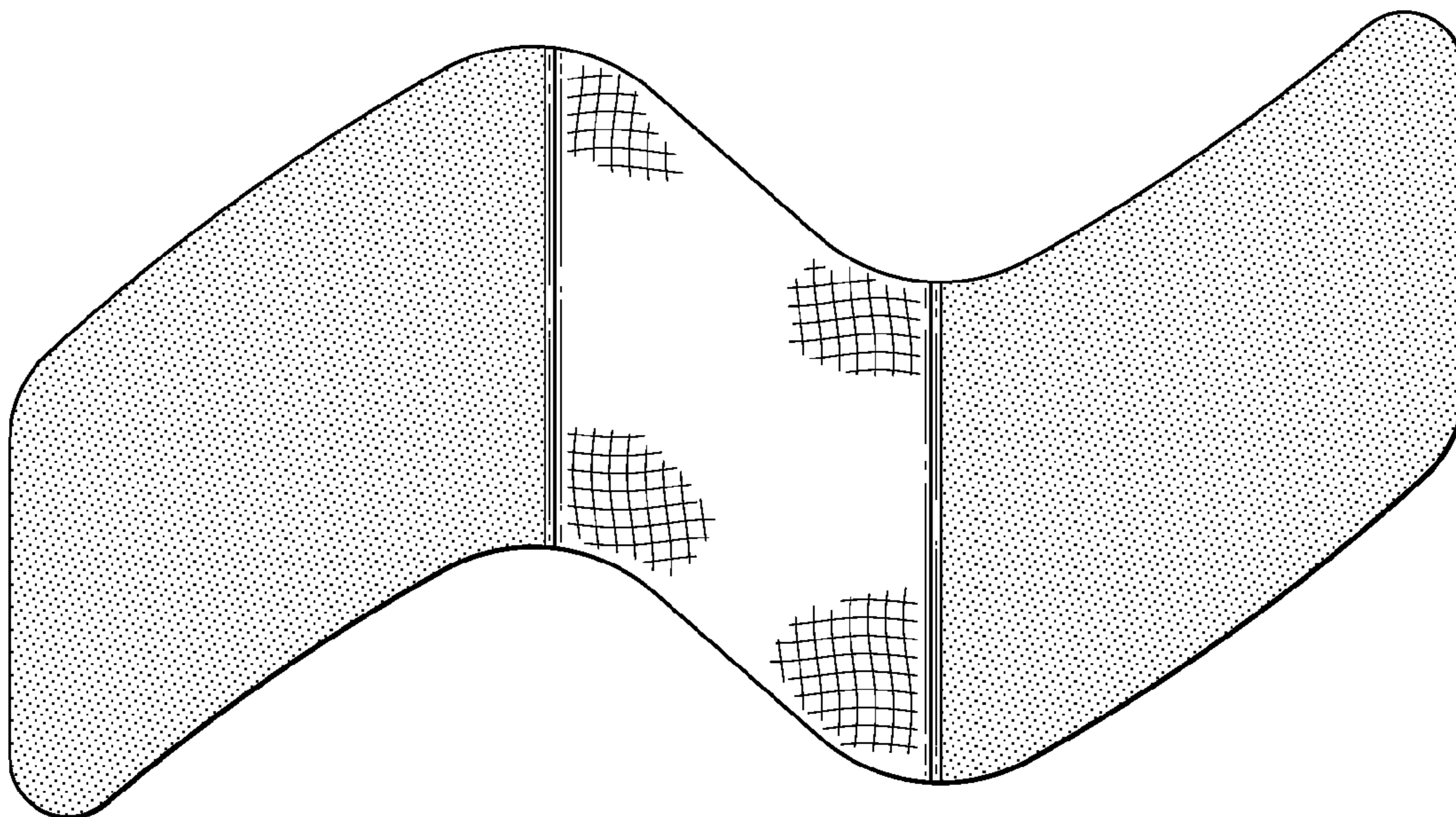

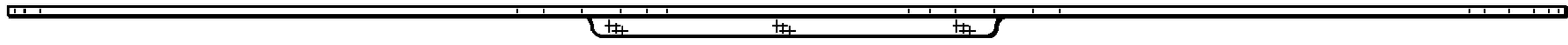
