DESCRIPTION

FIG. 1 is a top left side perspective view of the public restroom showing my new design;

FIG. 2 is a front elevation view;

FIG. 3 is a left side elevation view;

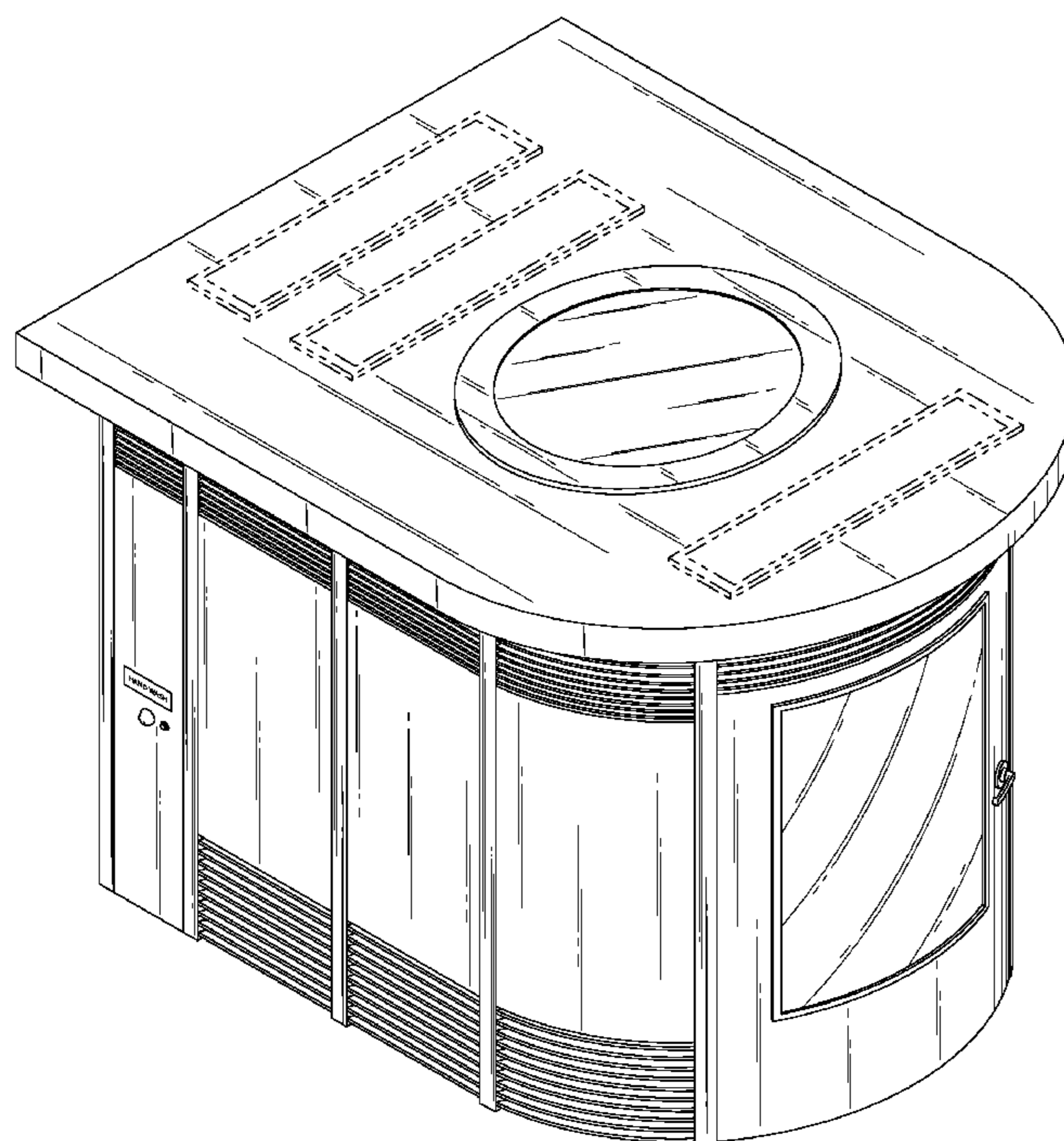
FIG. 4 is a right side elevation view;

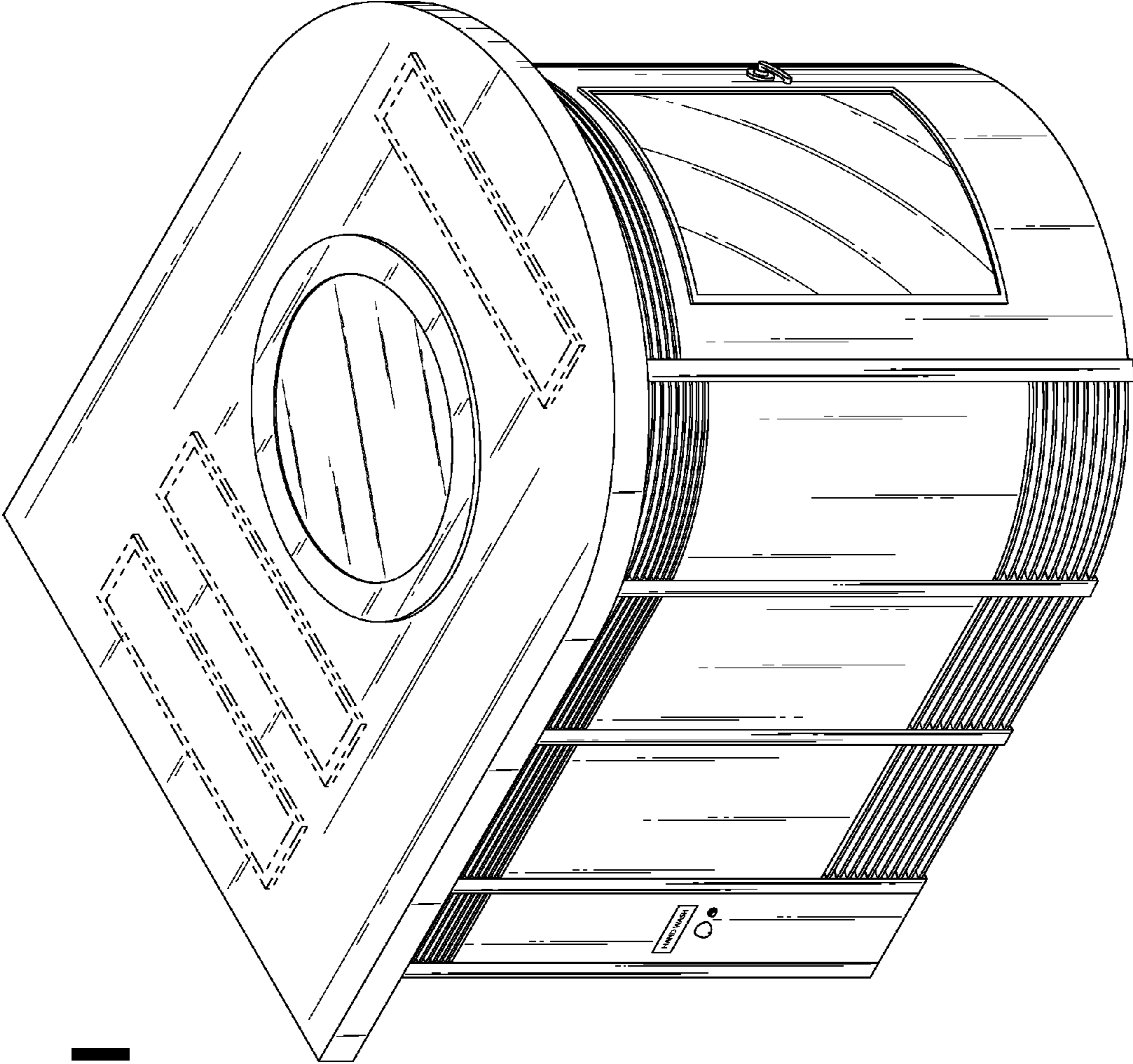

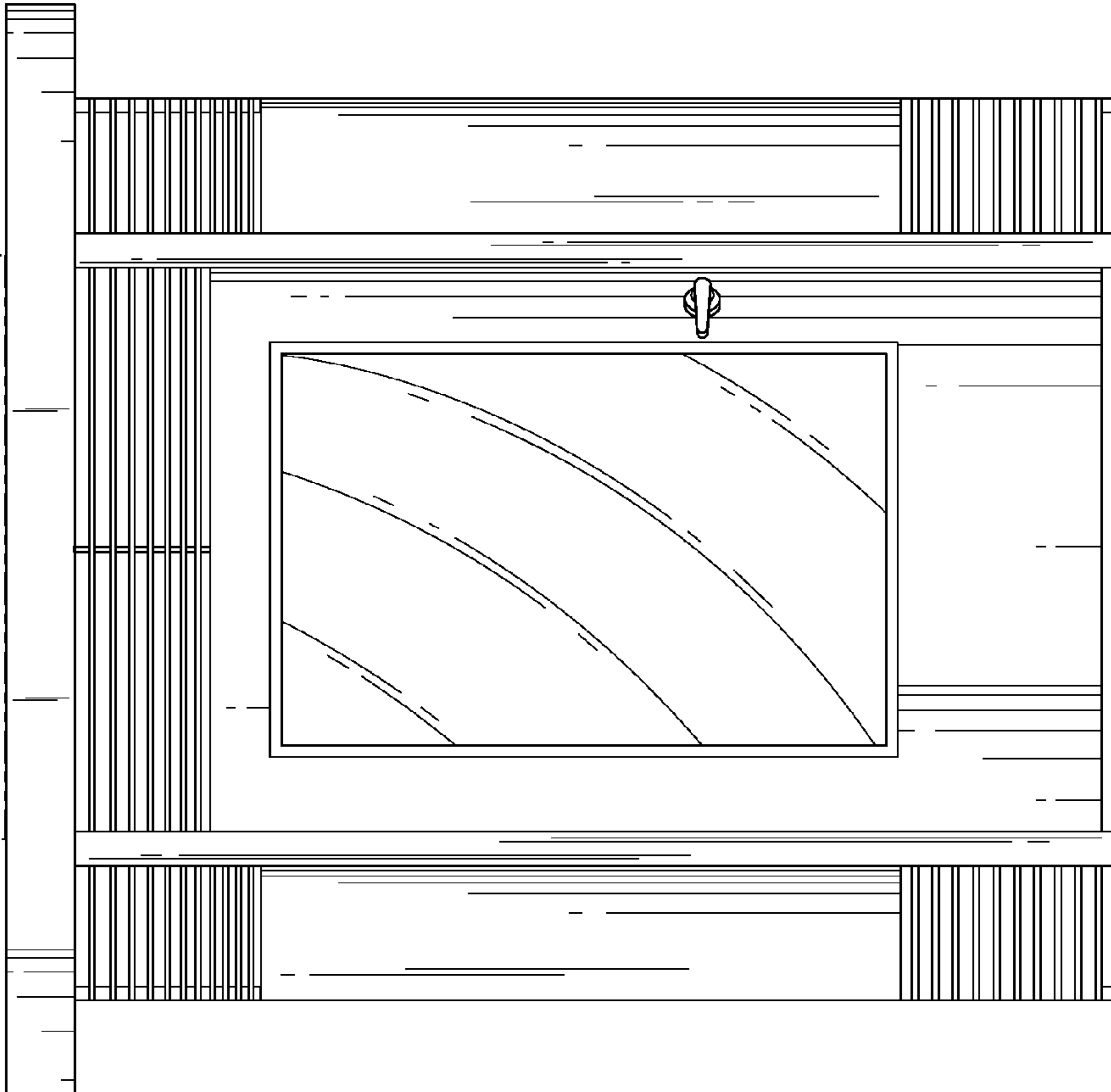
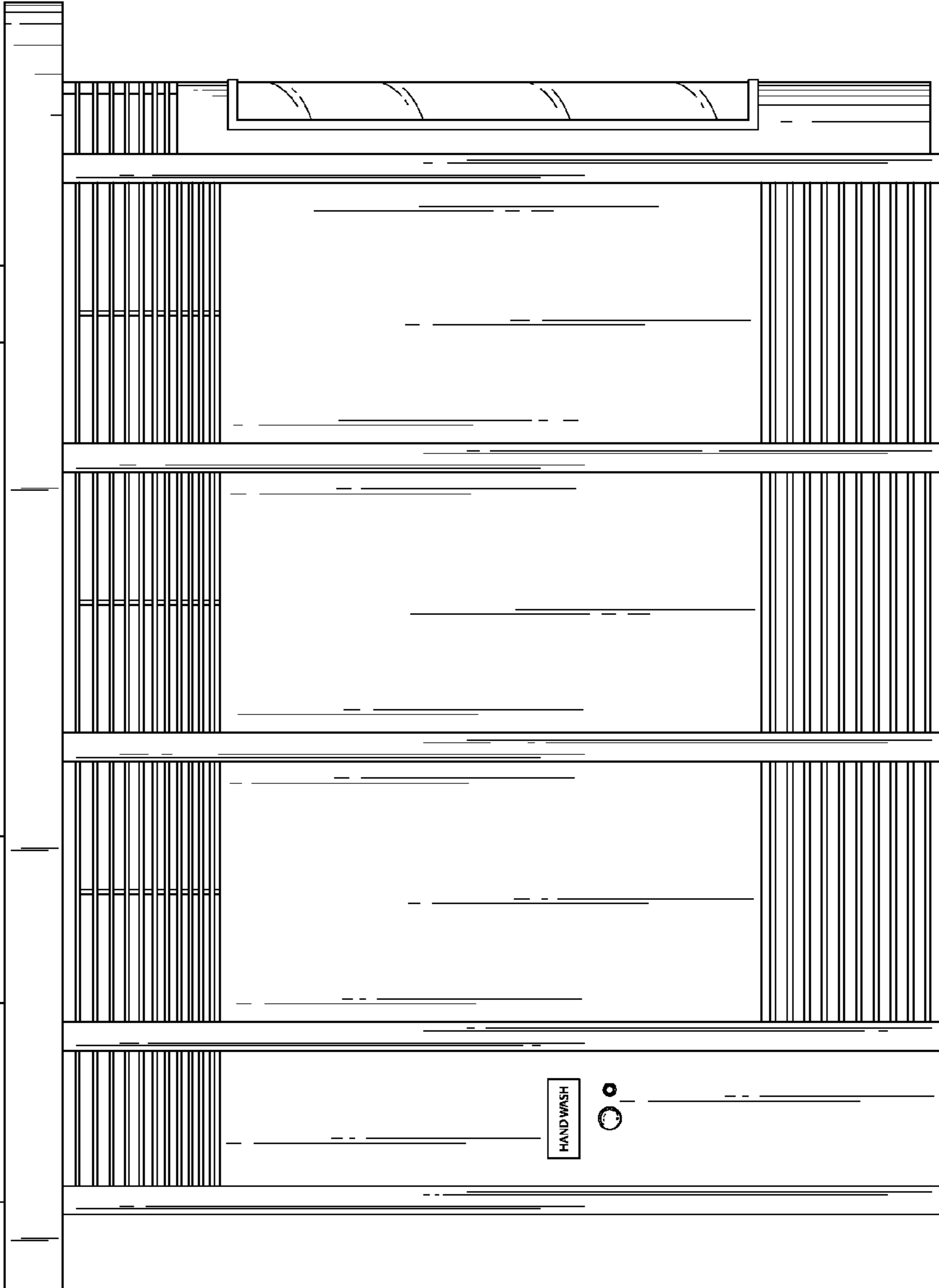

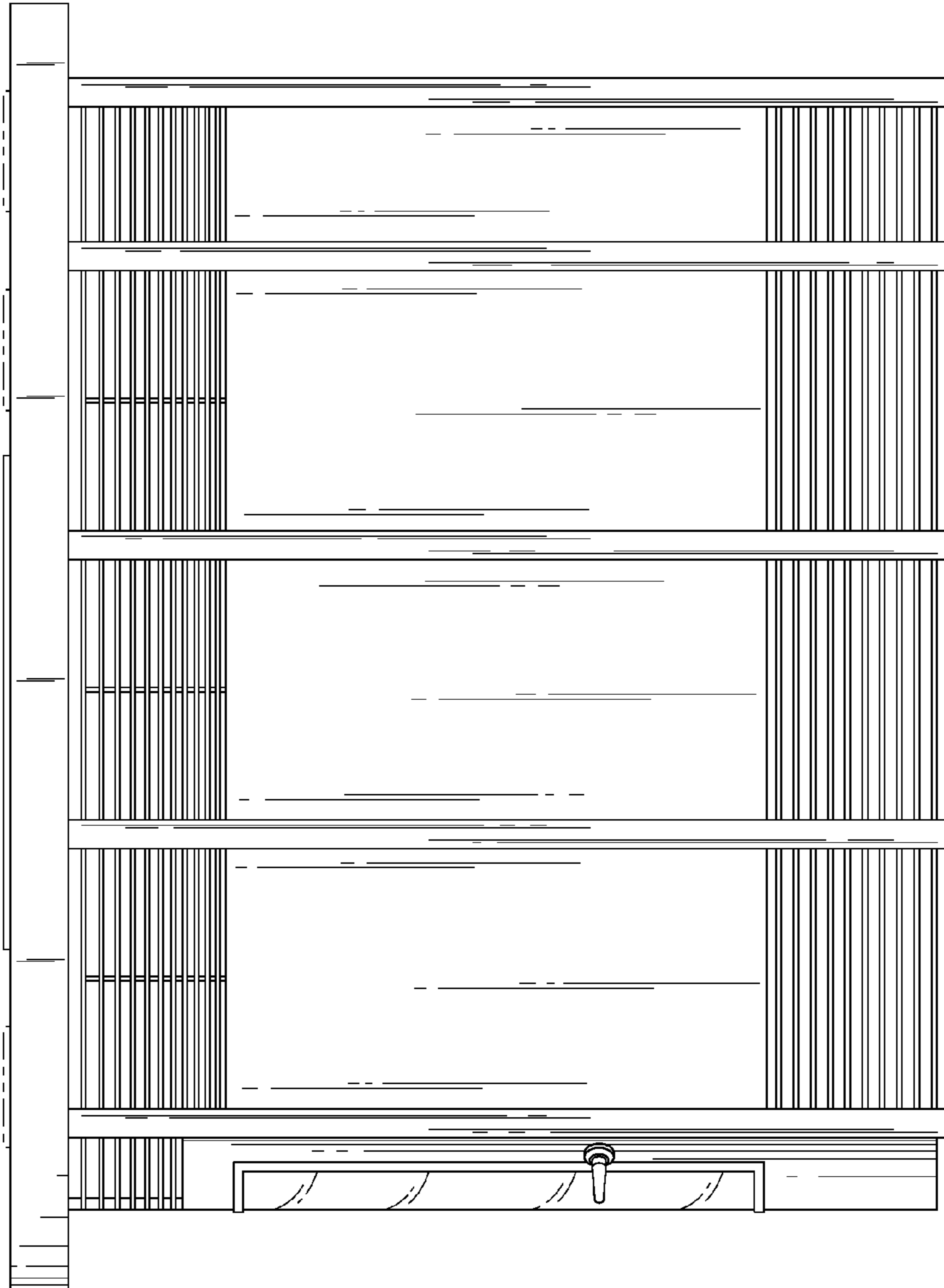

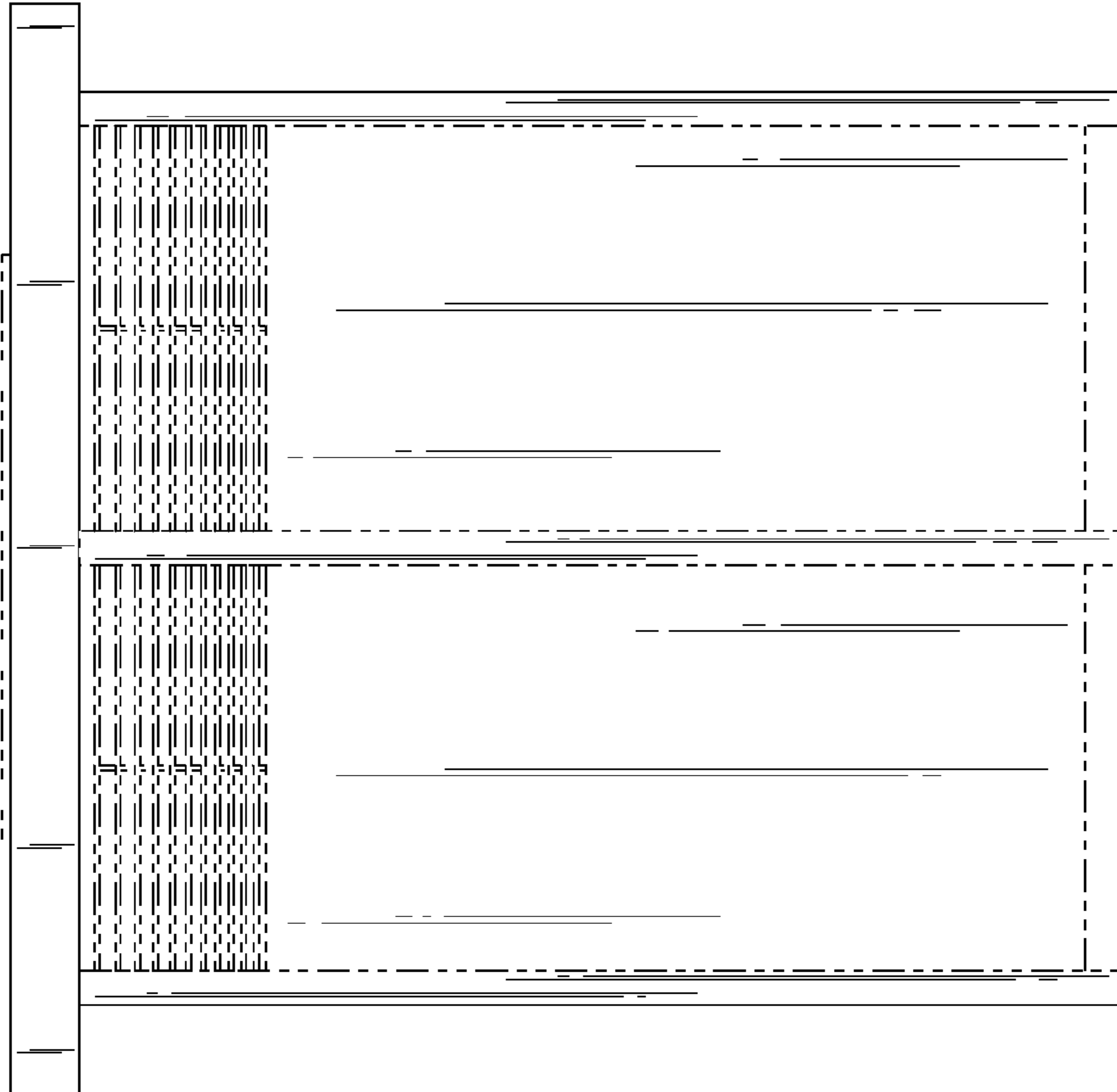

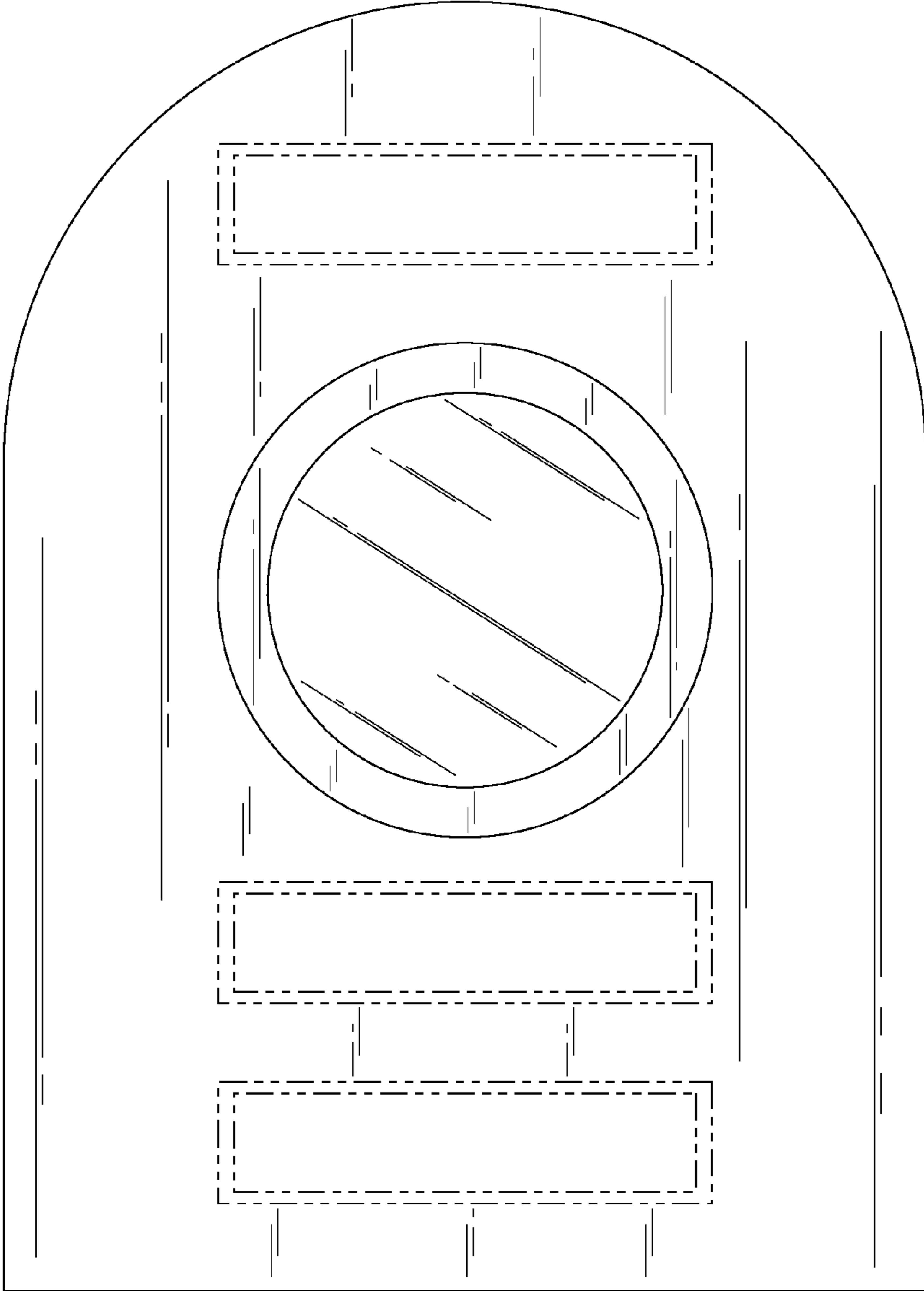
