FIG. 1 is a perspective view of a fence; the broken lines are for illustrative purposes only and form no part of the claimed design;

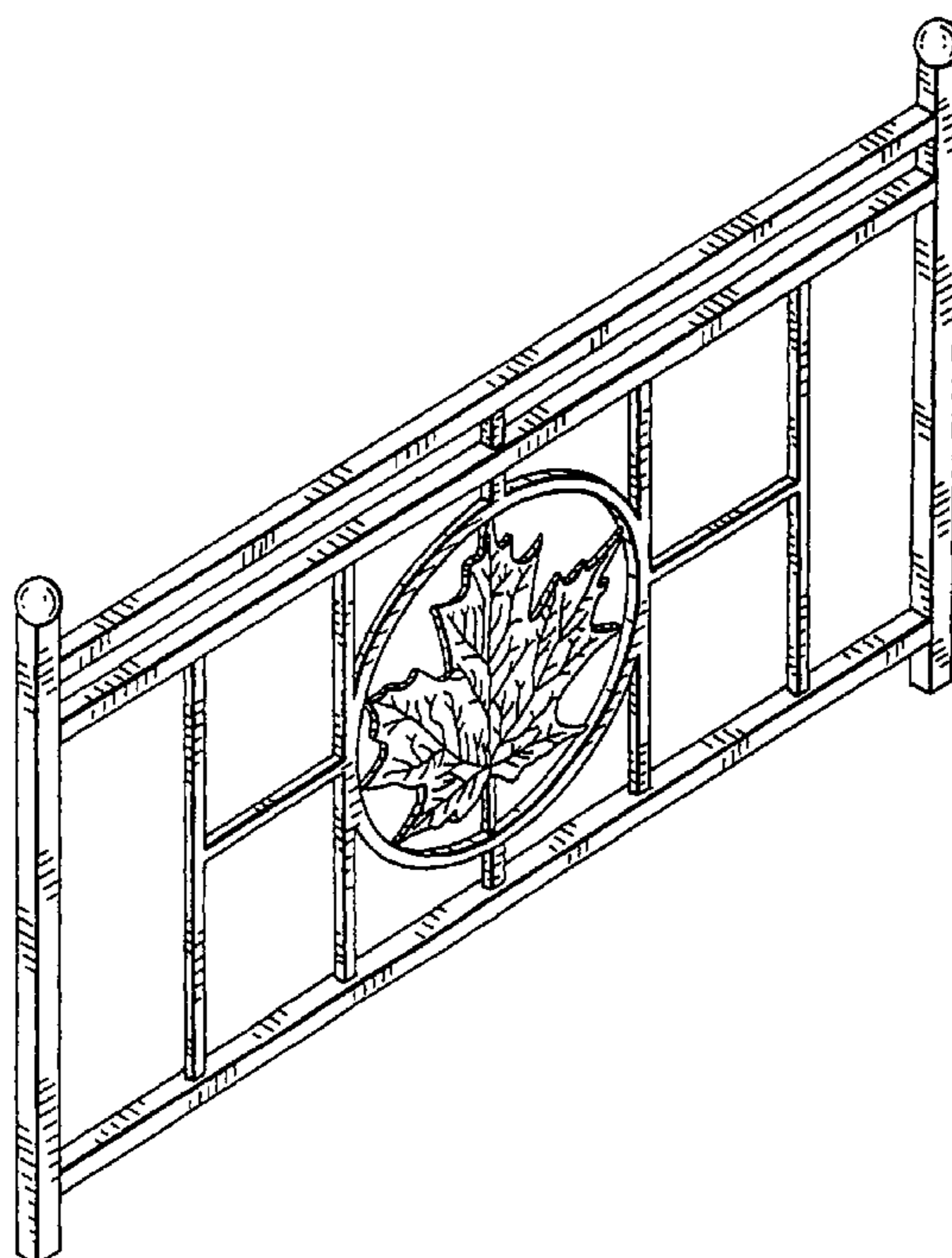
FIG. 2 is a left side view; the right side view is a mirror image thereof;

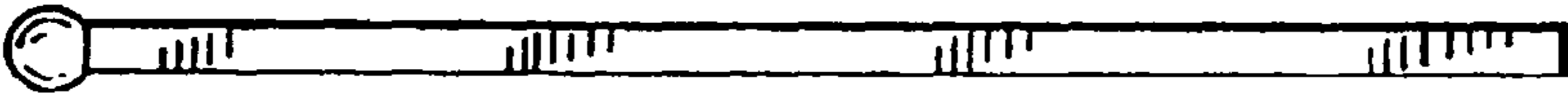

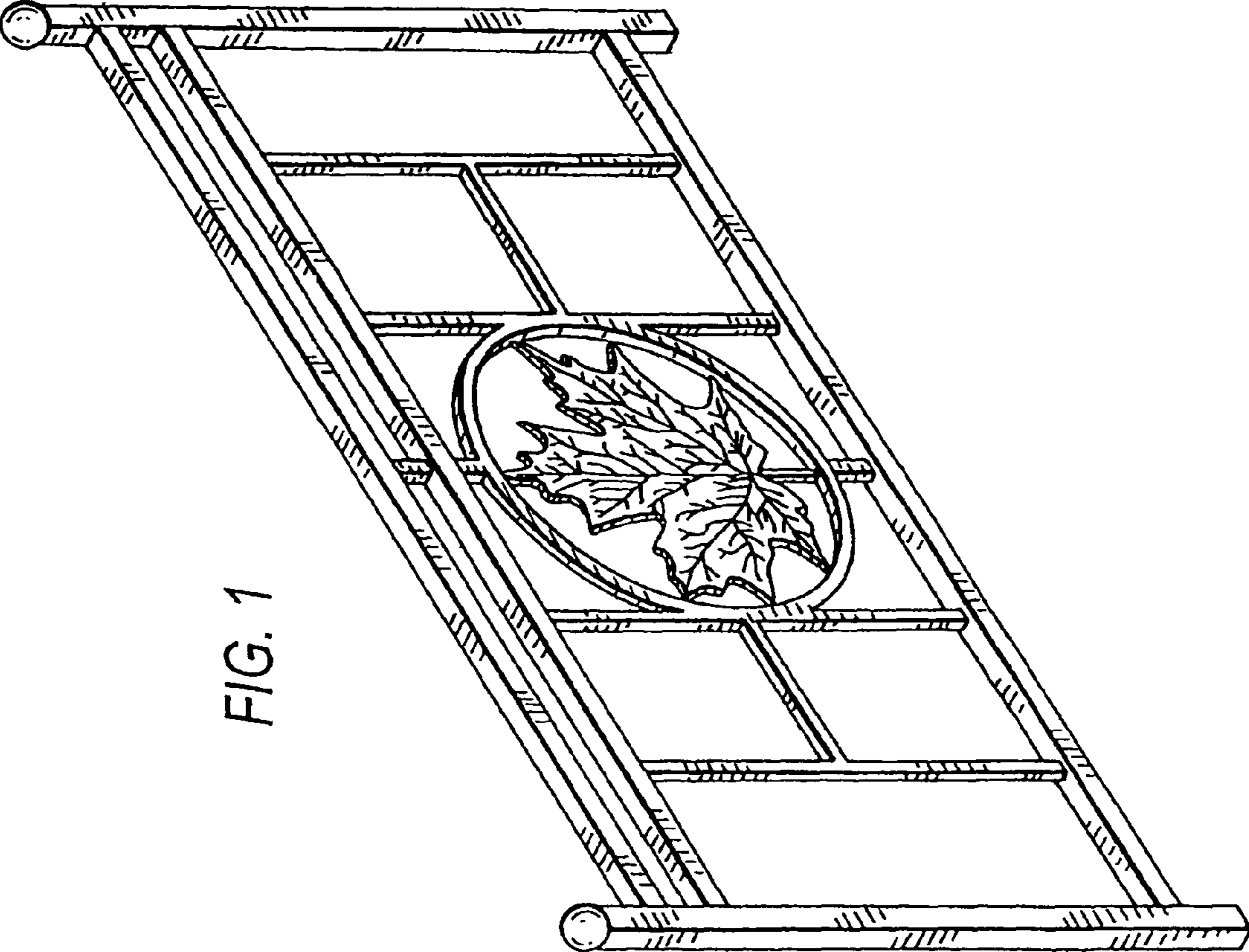

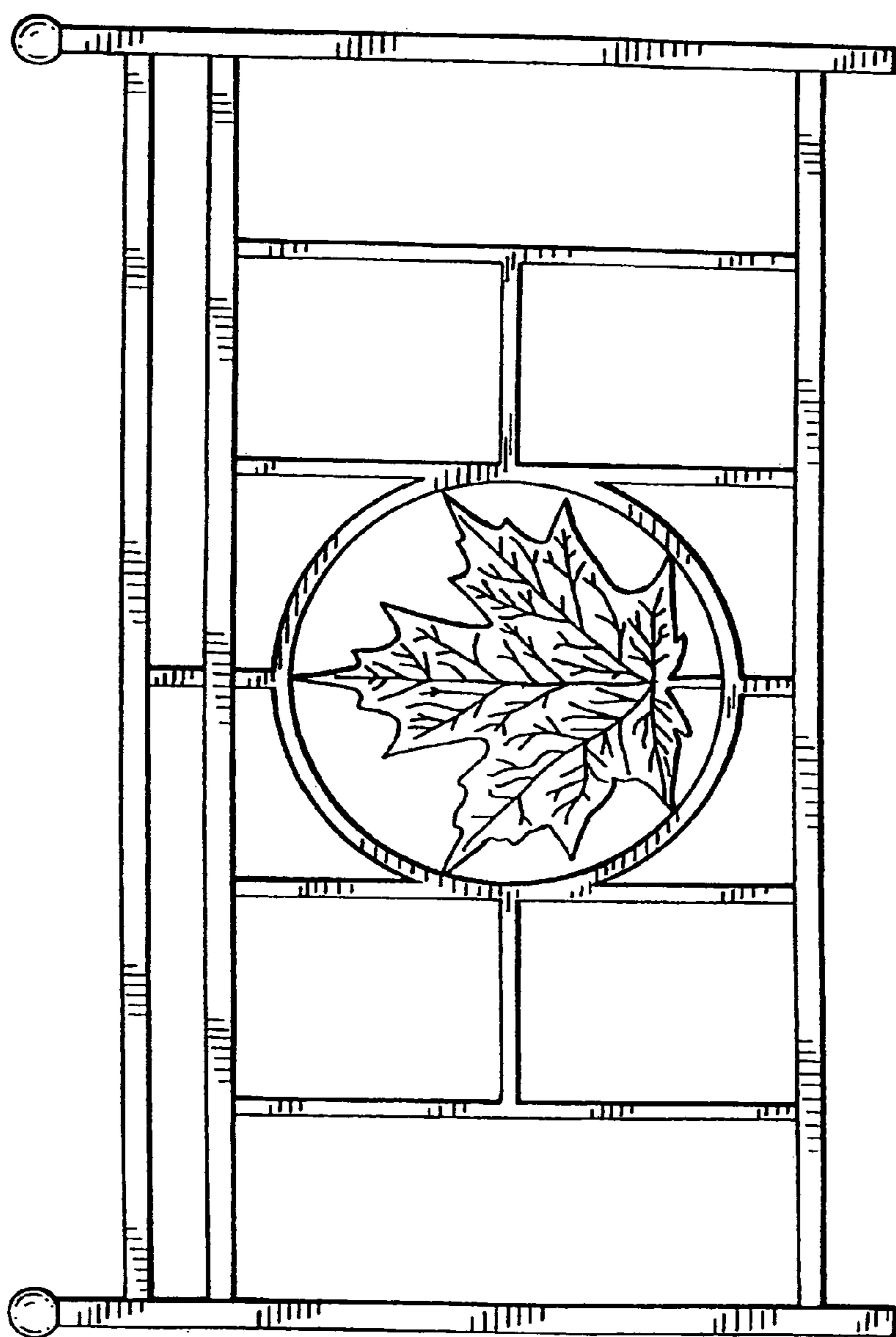
