(57) **CLAIM**

The ornamental design for a trash receptacle, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a trash receptacle shown with a door in a closed position;

FIG. 2 is a front view of the trash receptacle shown in FIG. 1;

FIG. 3 is a left side view of the trash receptacle shown in FIG. 1;

FIG. 4 is a right side view of the trash receptacle shown in FIG. 1;

FIG. 5 is a back side view of the trash receptacle shown in FIG. 1;

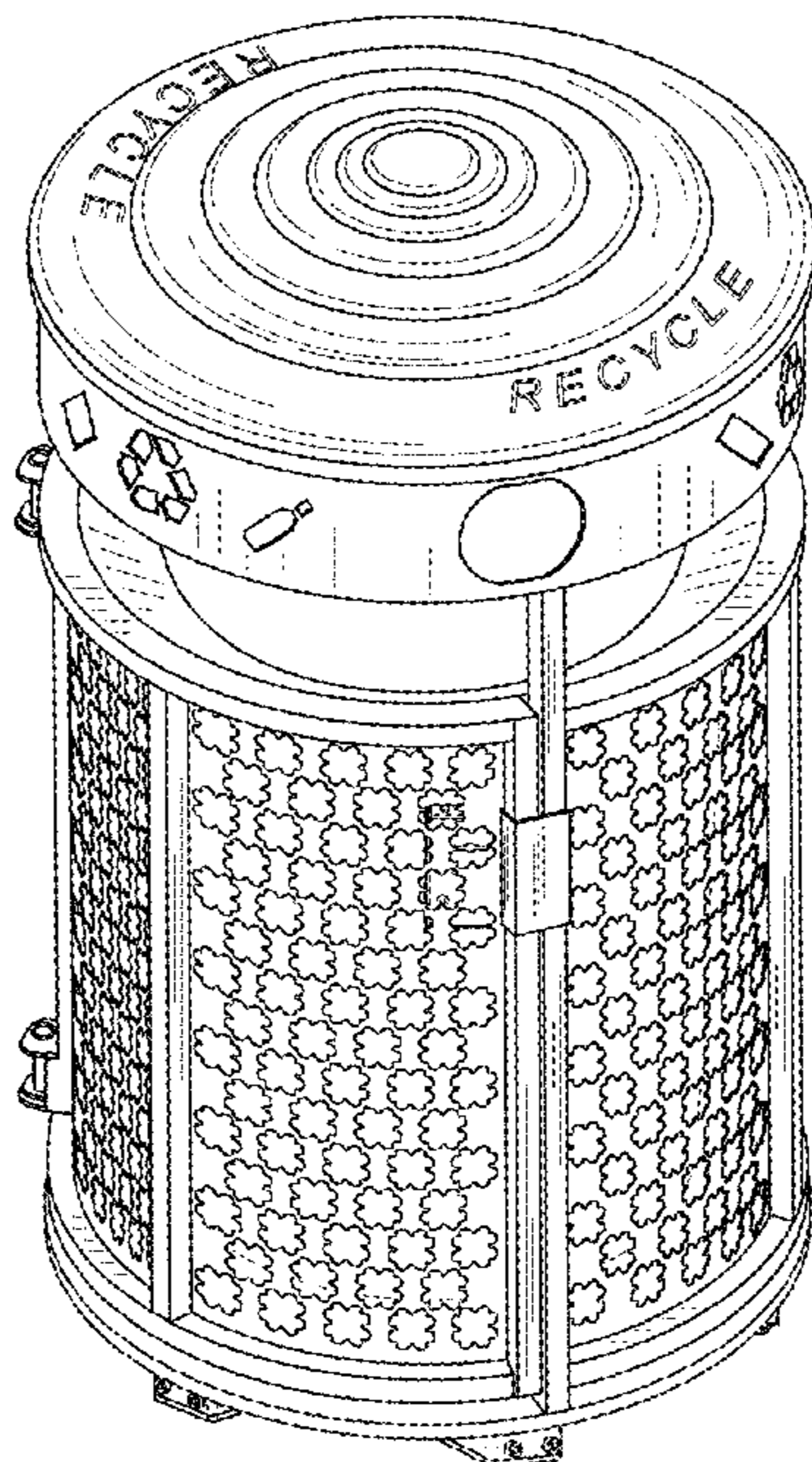
FIG. 6 is a top perspective view of the trash receptacle of FIG. 1, shown with the door in an open position;

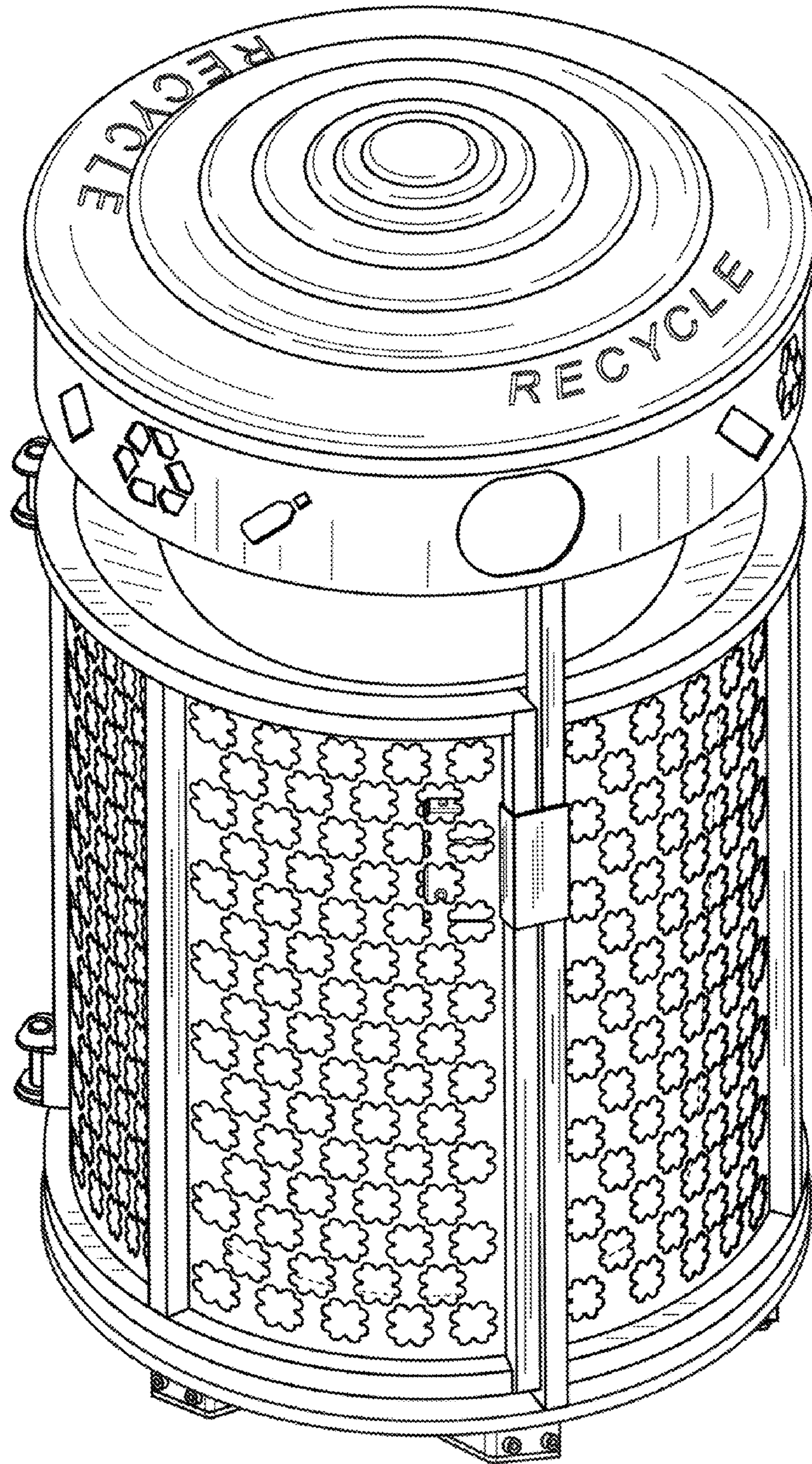

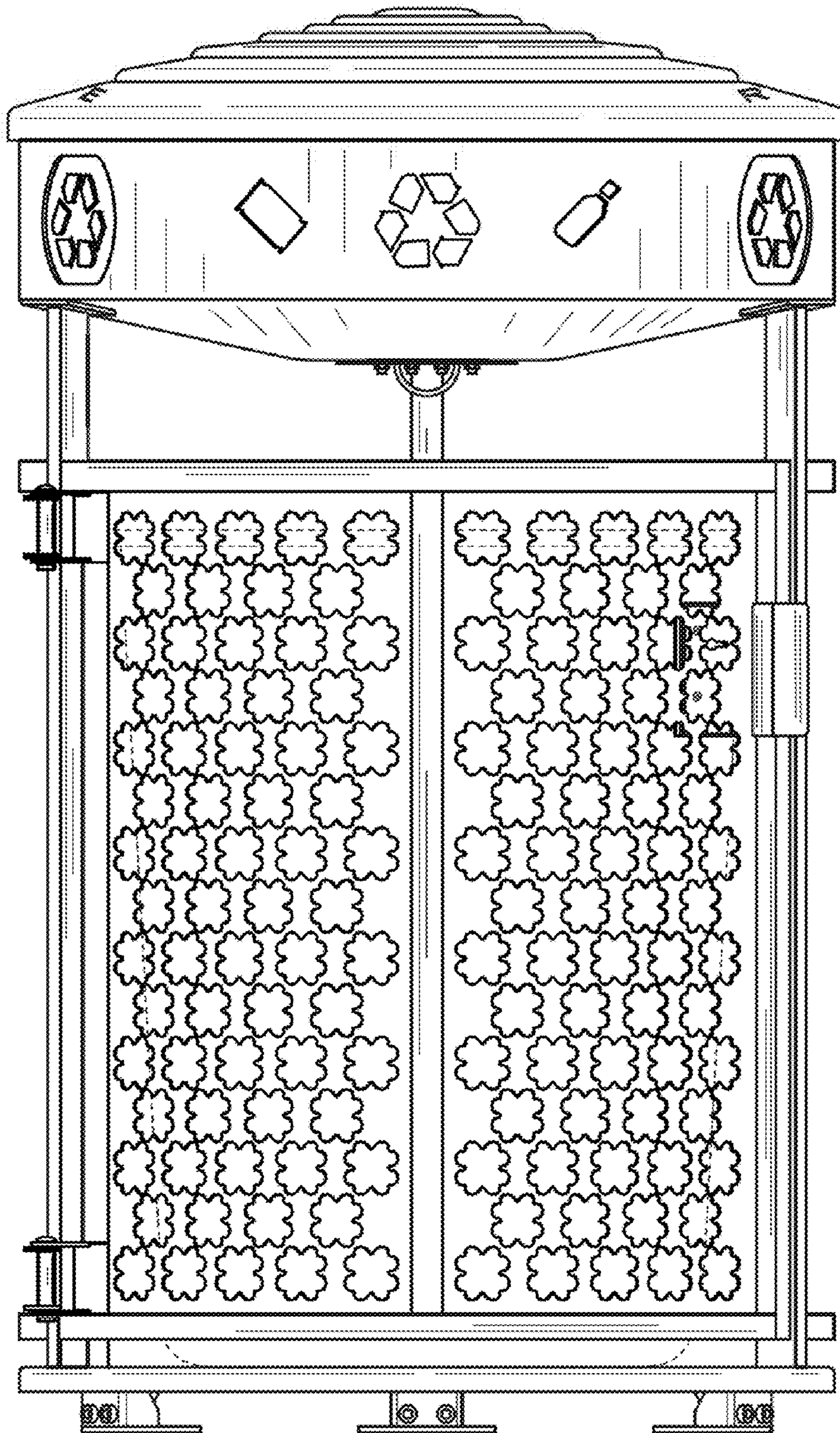

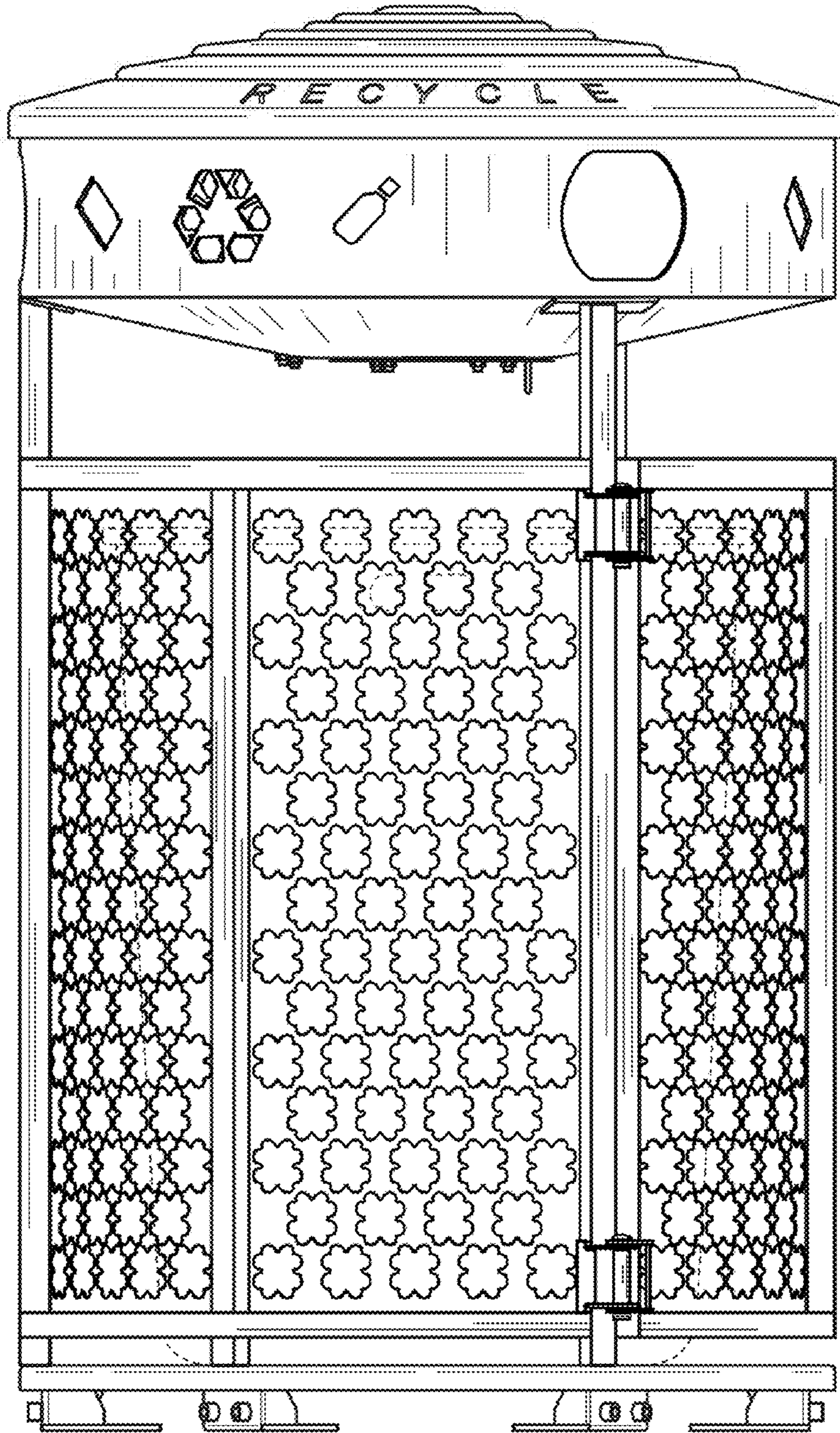

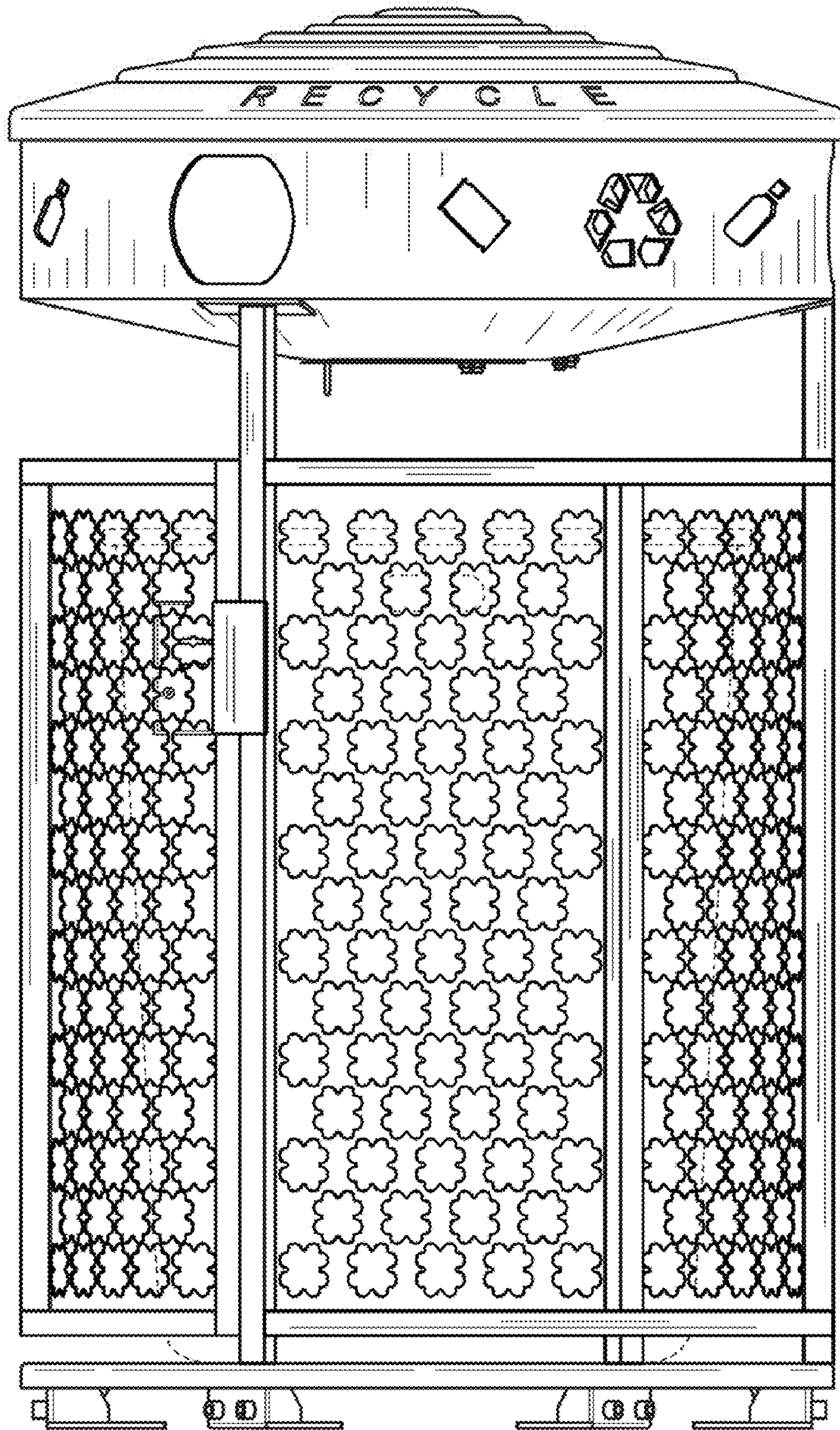

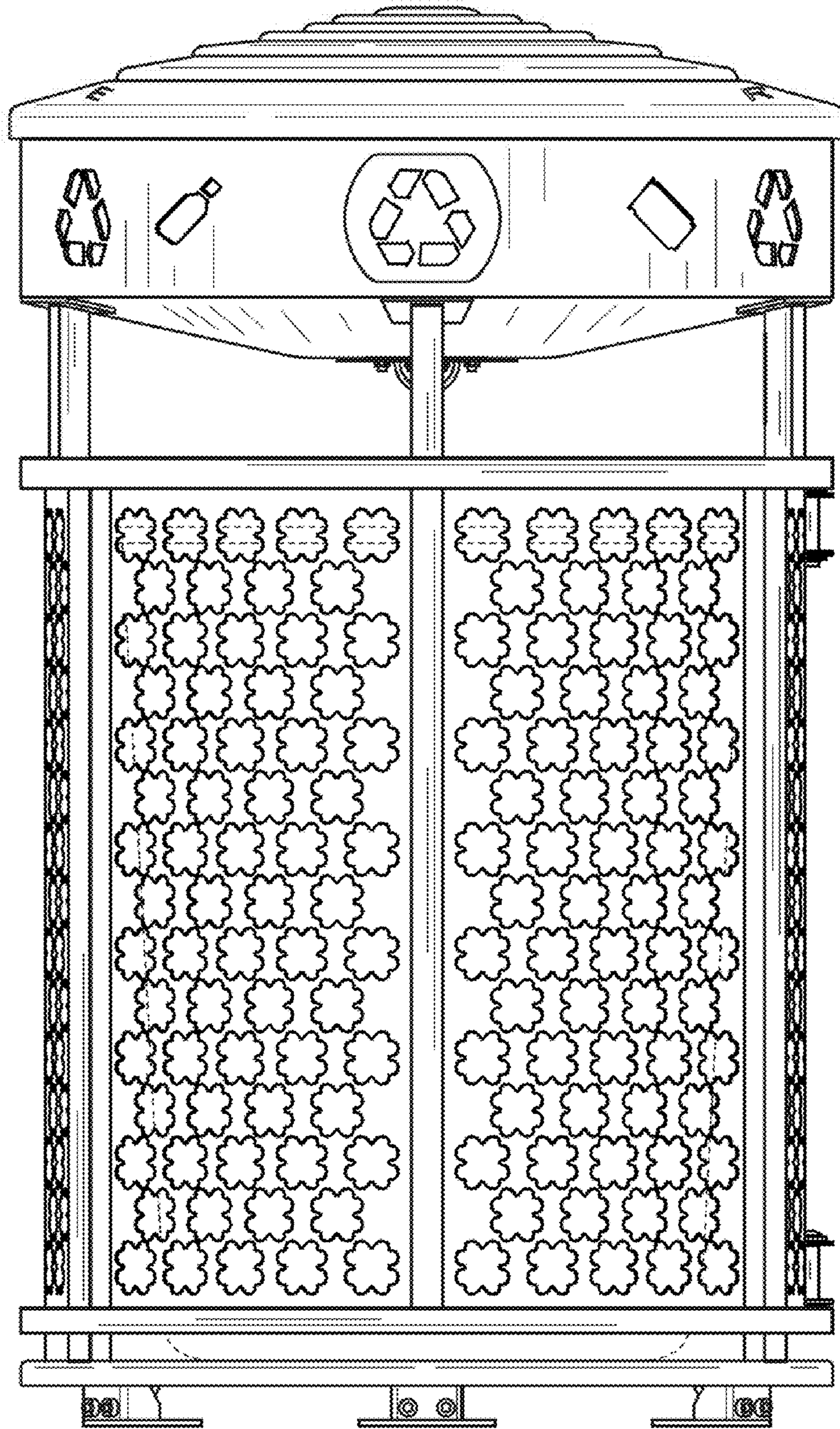

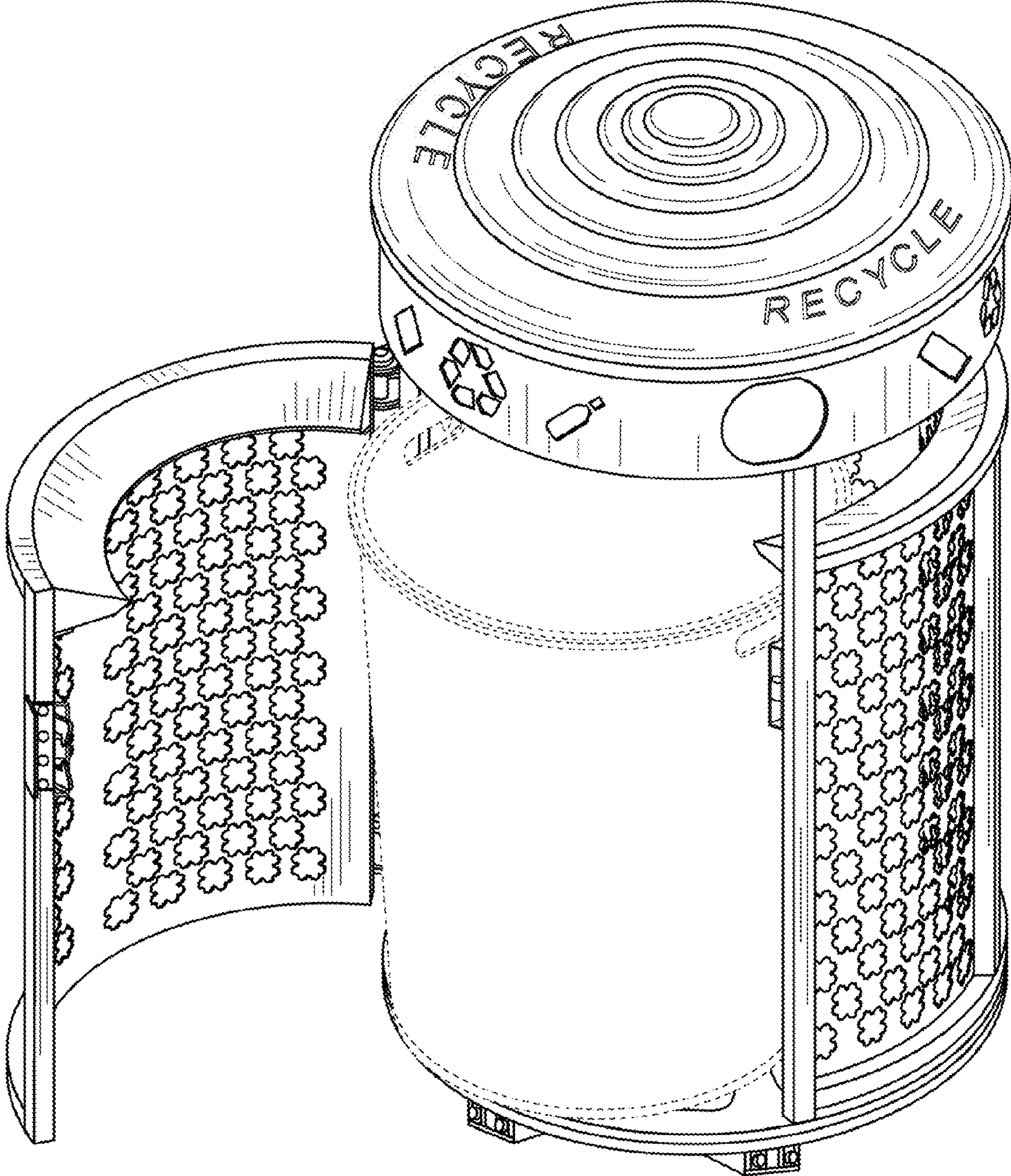

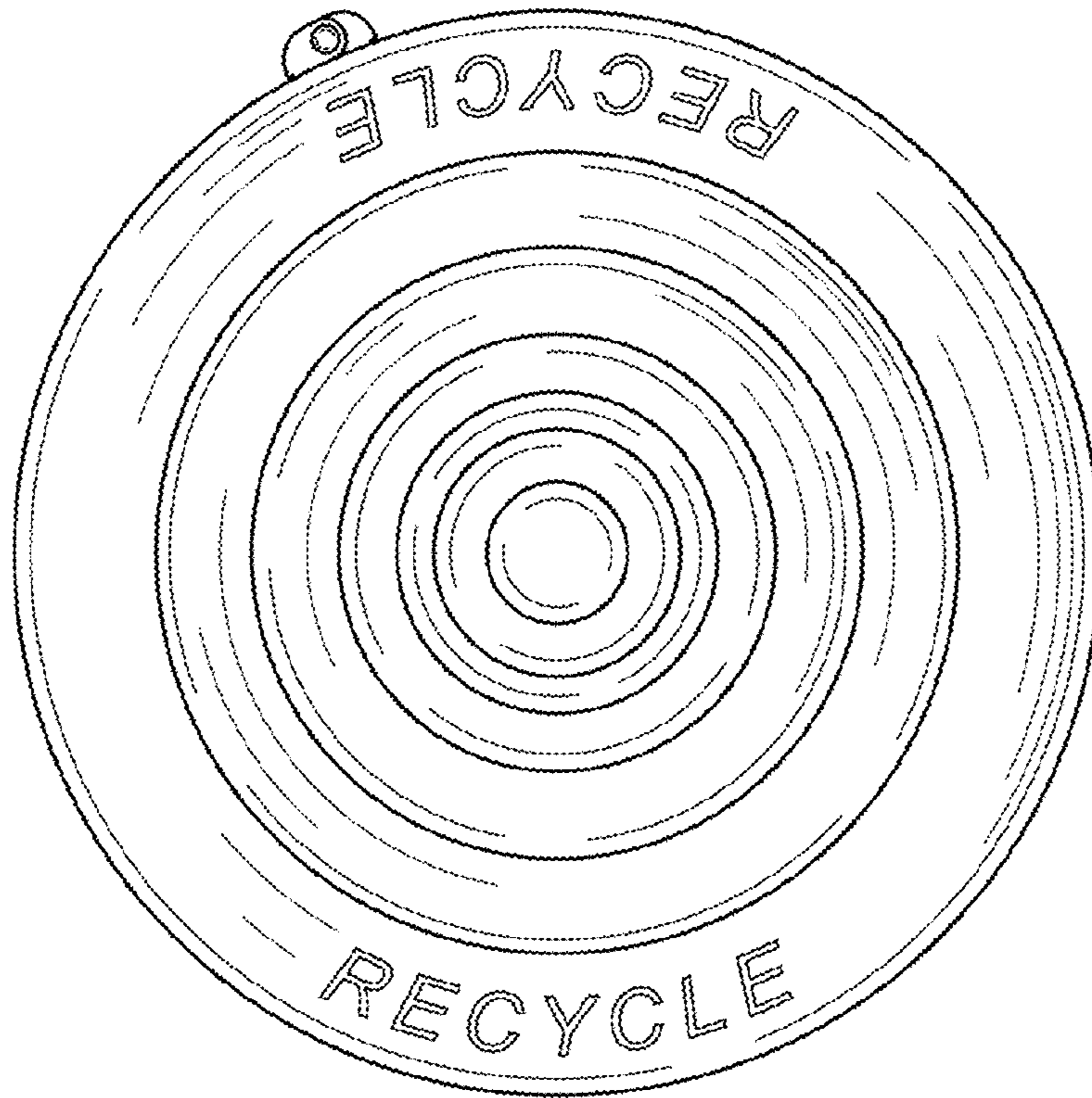

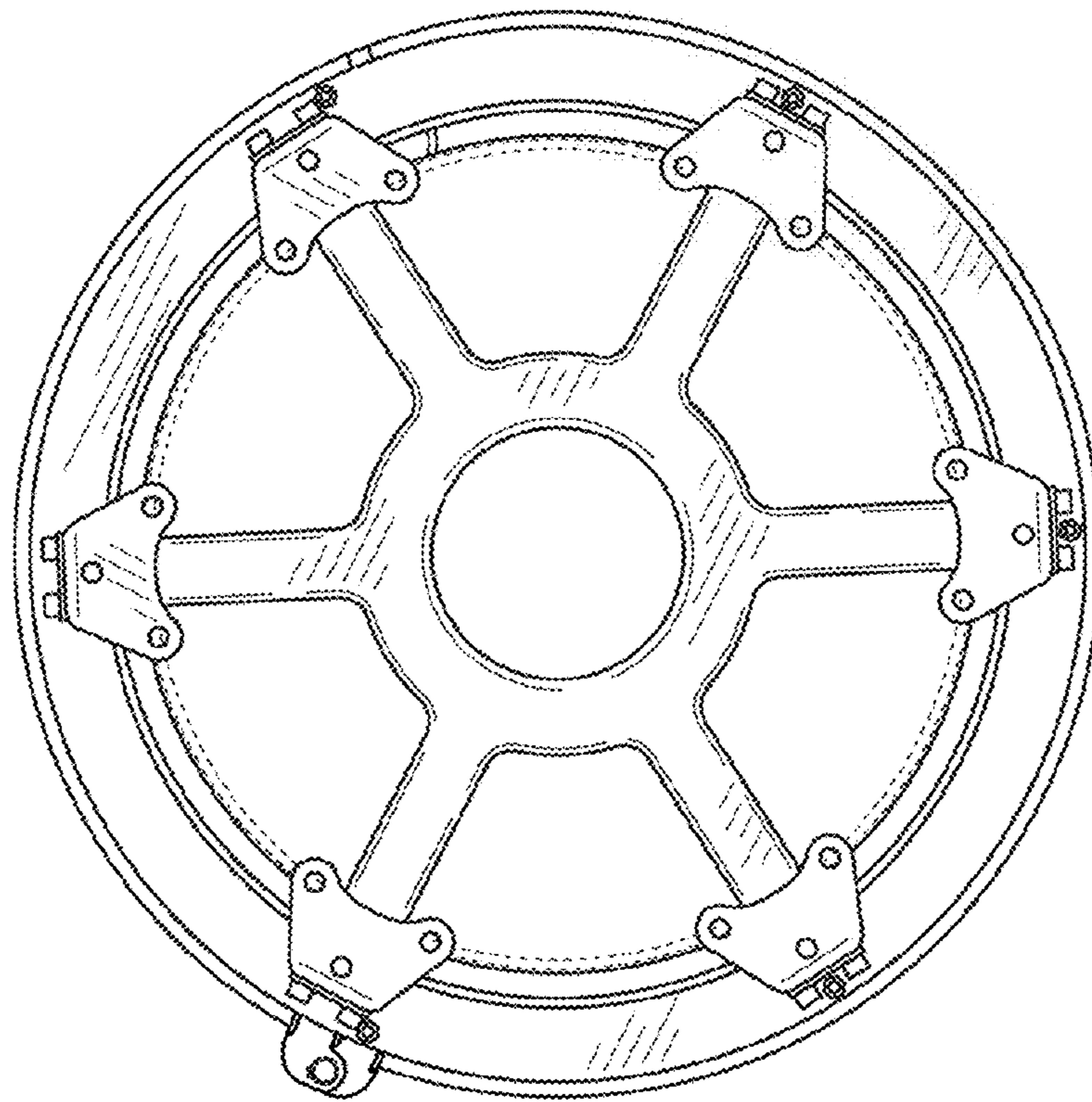
