FIG. 4 is a rear elevational view of the medical gown as shown in FIG. 1;

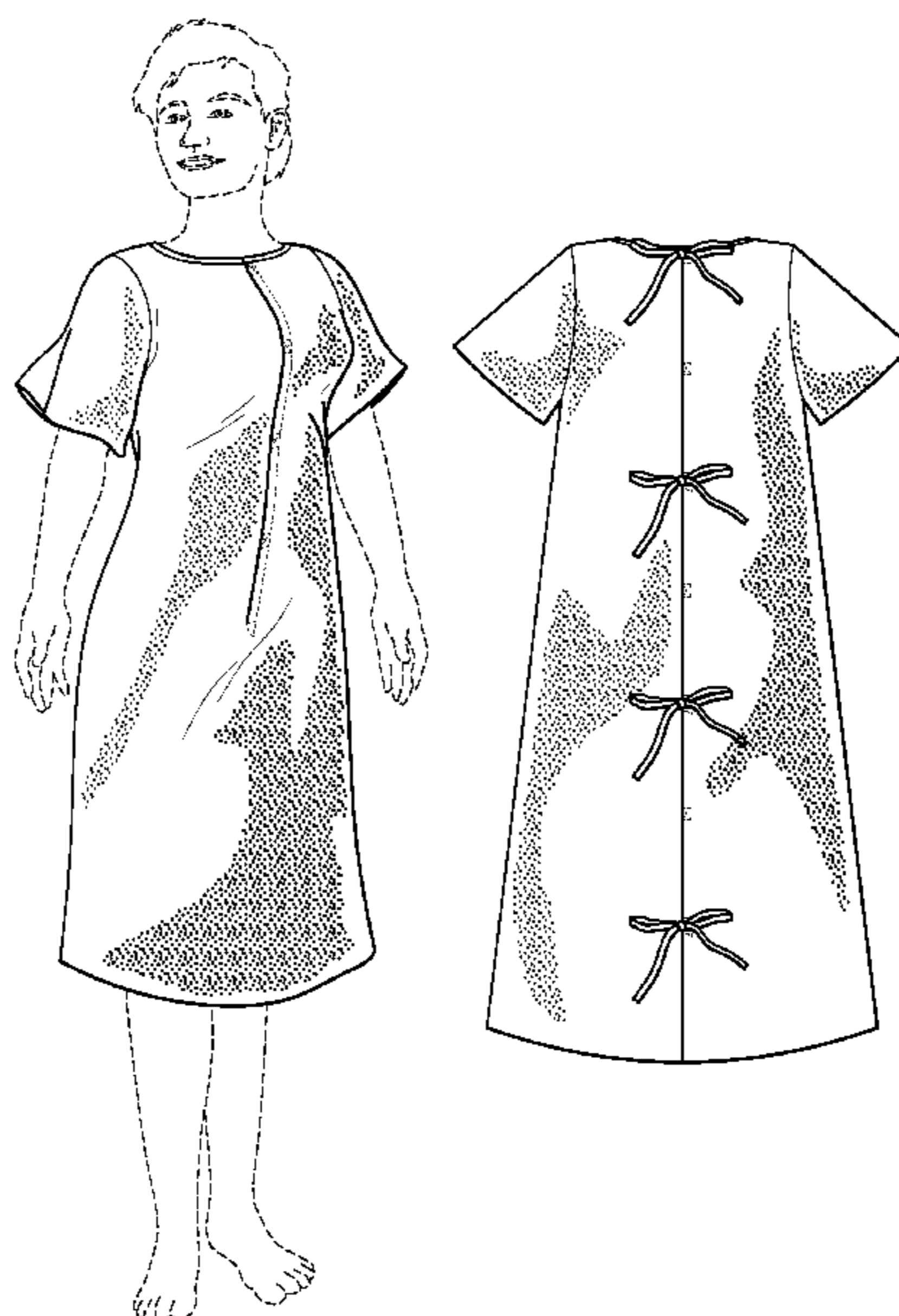
FIG. 5 is a top plan view of the medical gown as shown in FIG. 1 thereof;

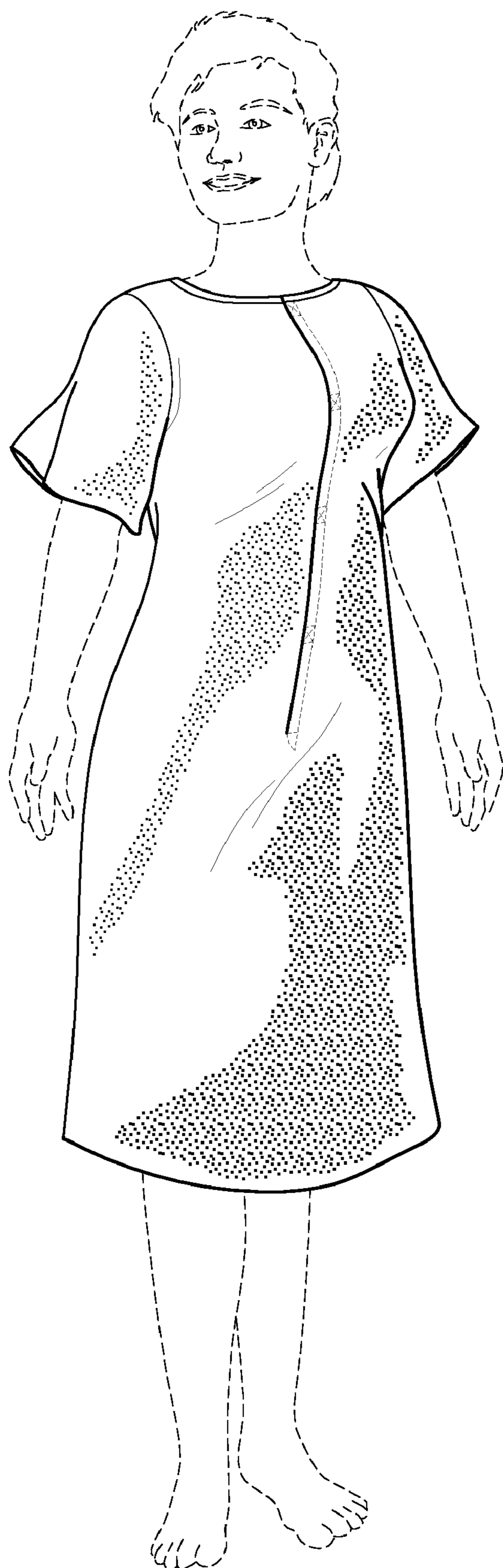

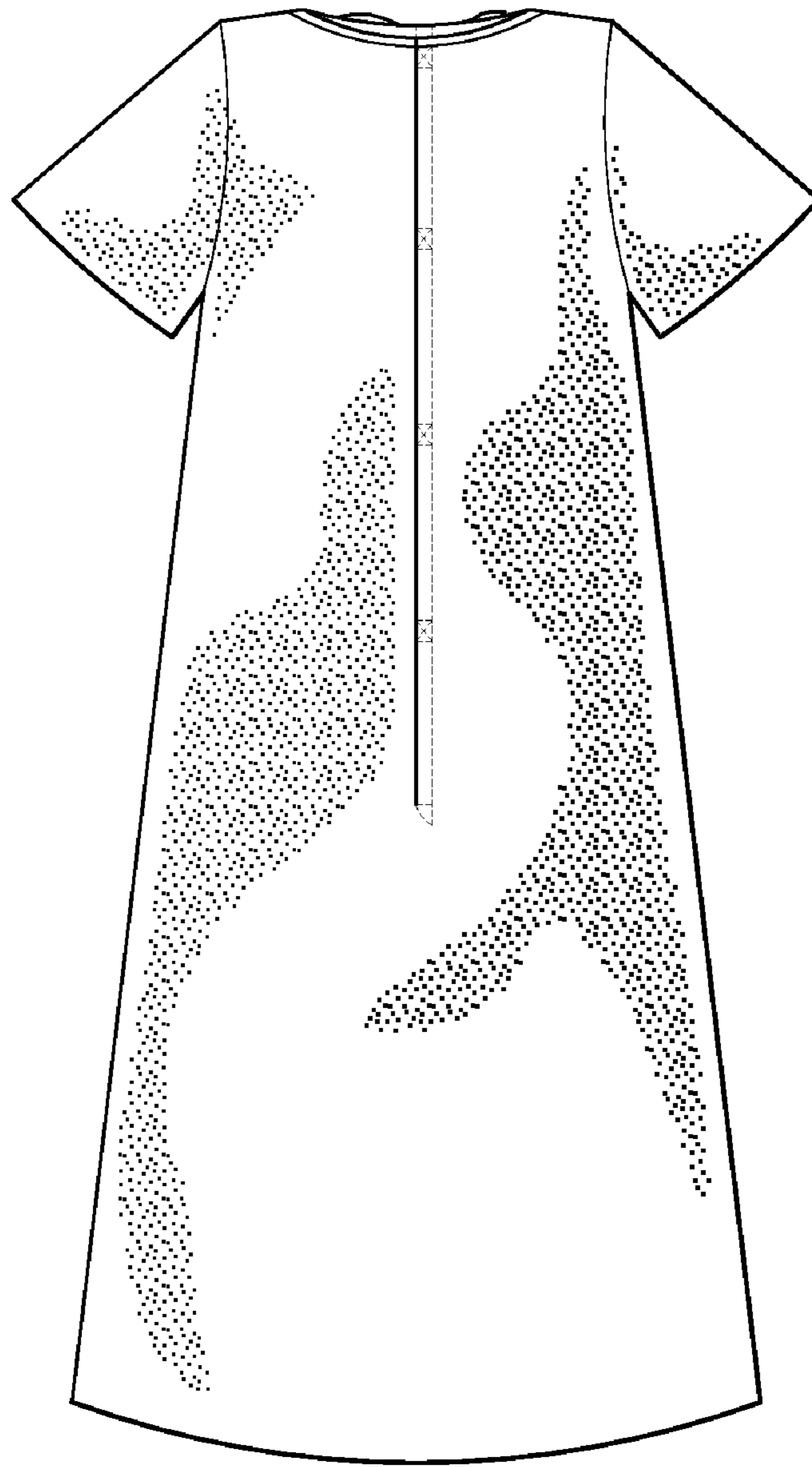

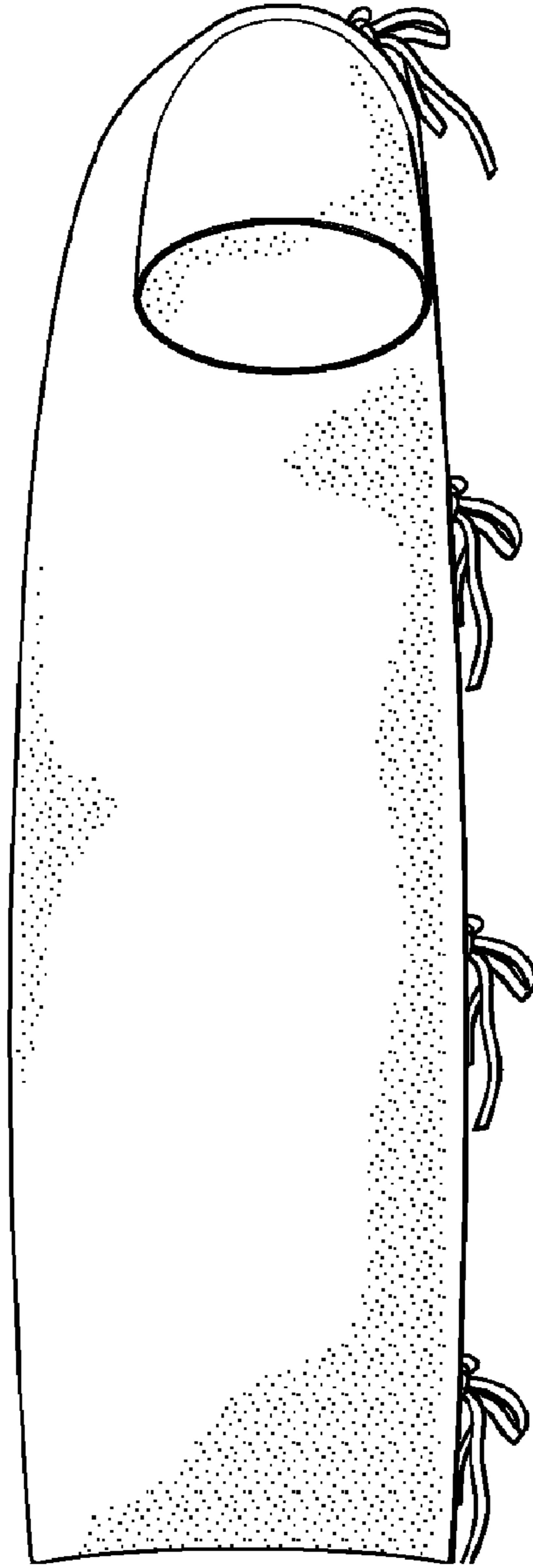

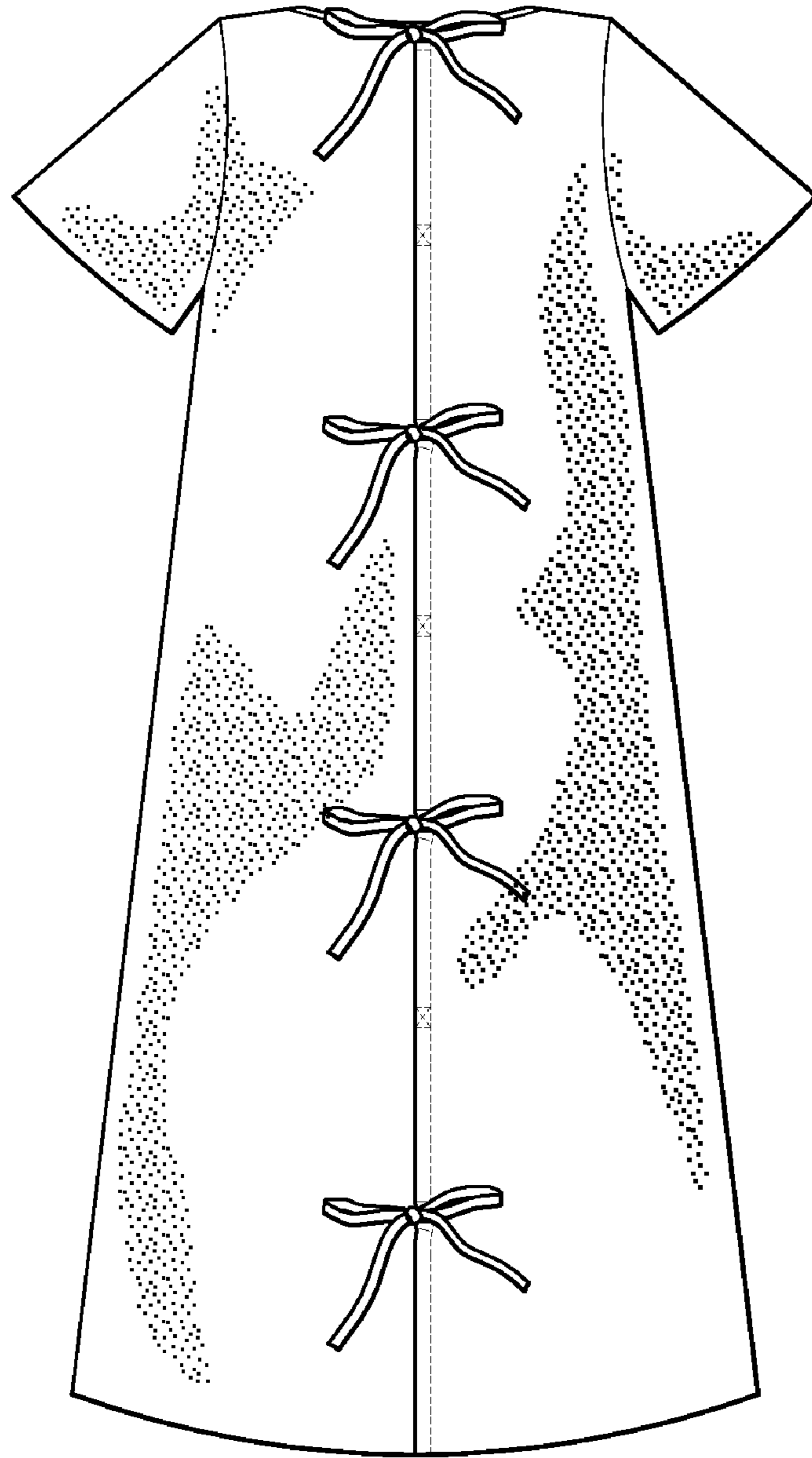

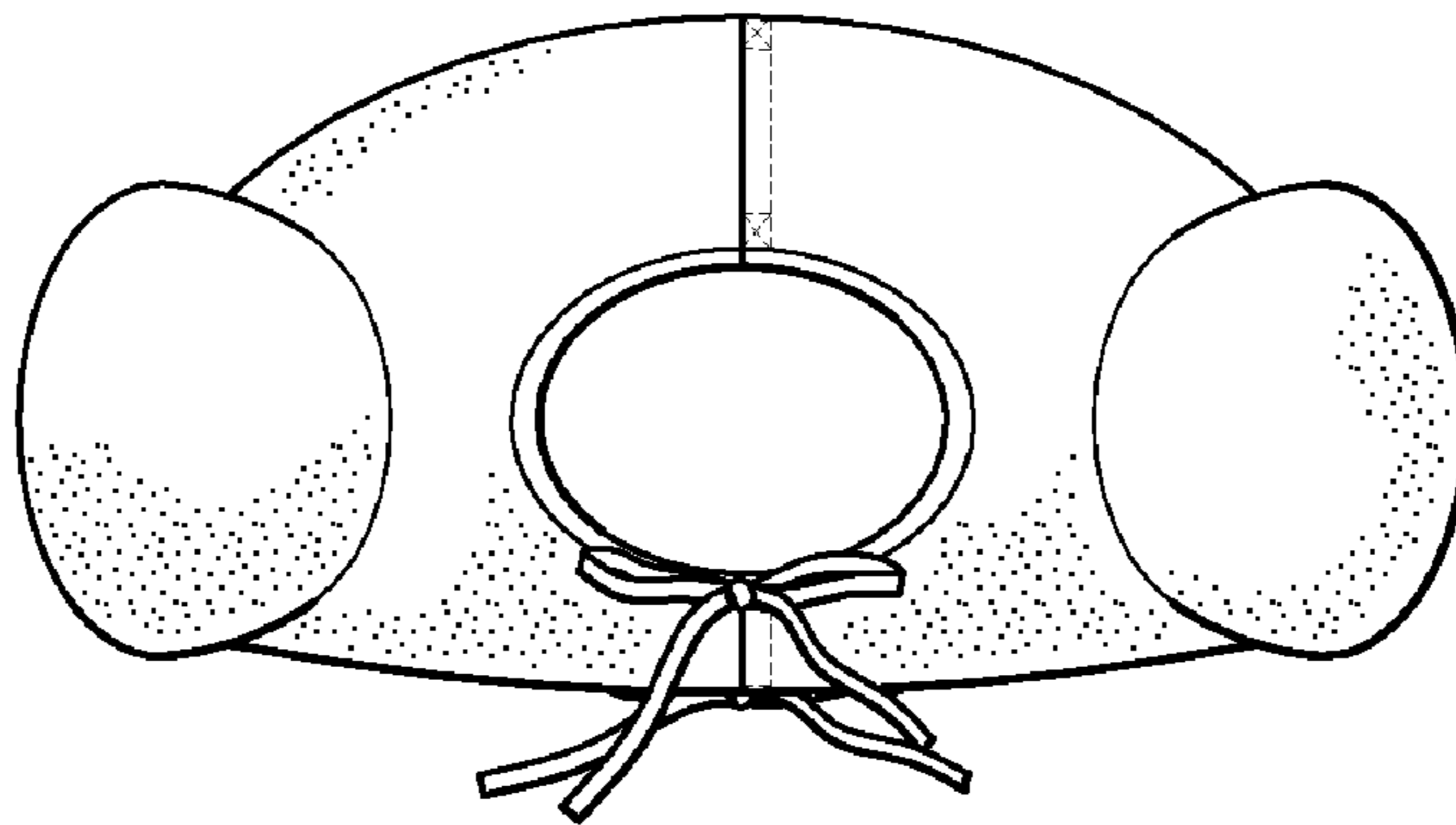

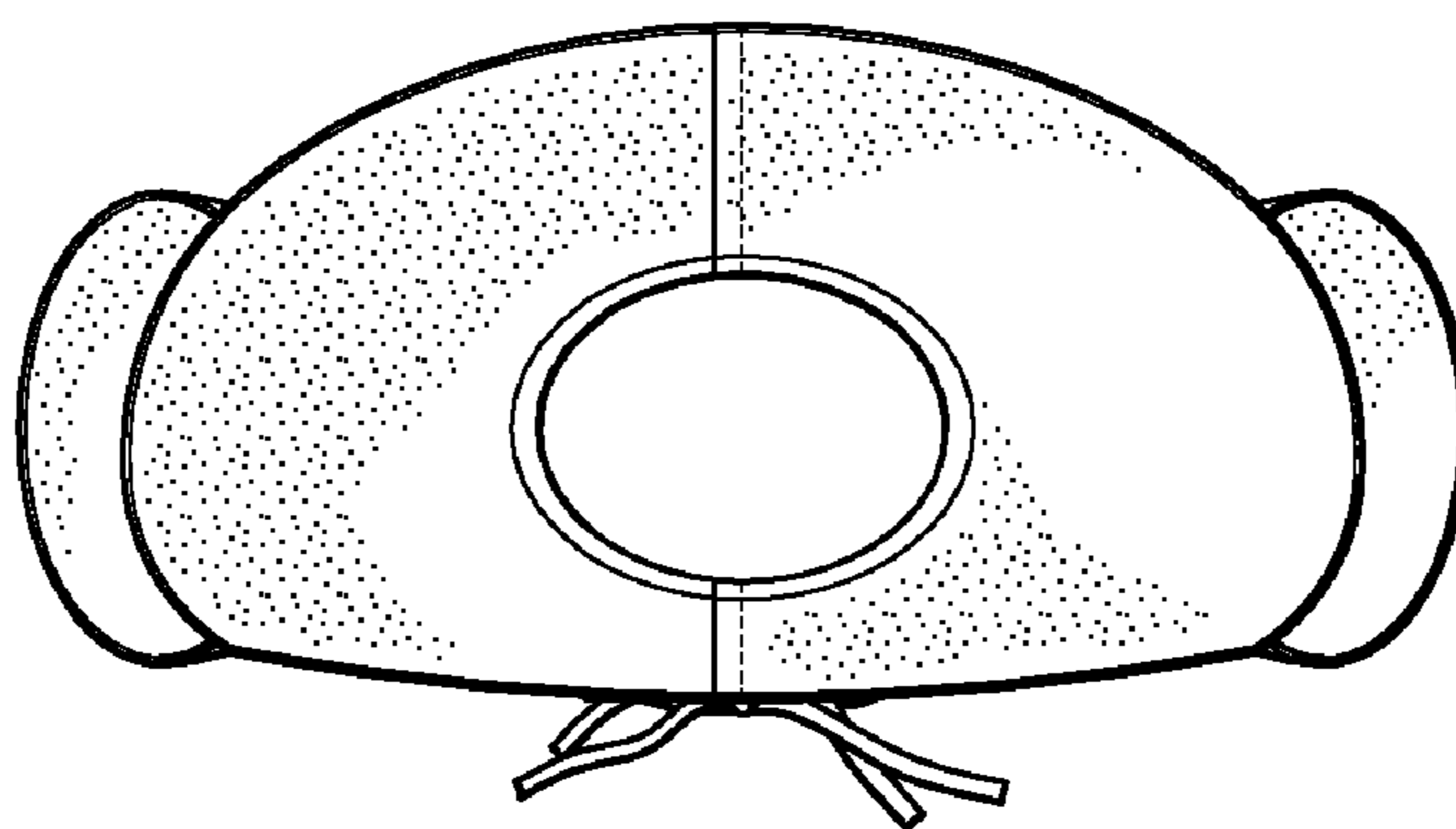

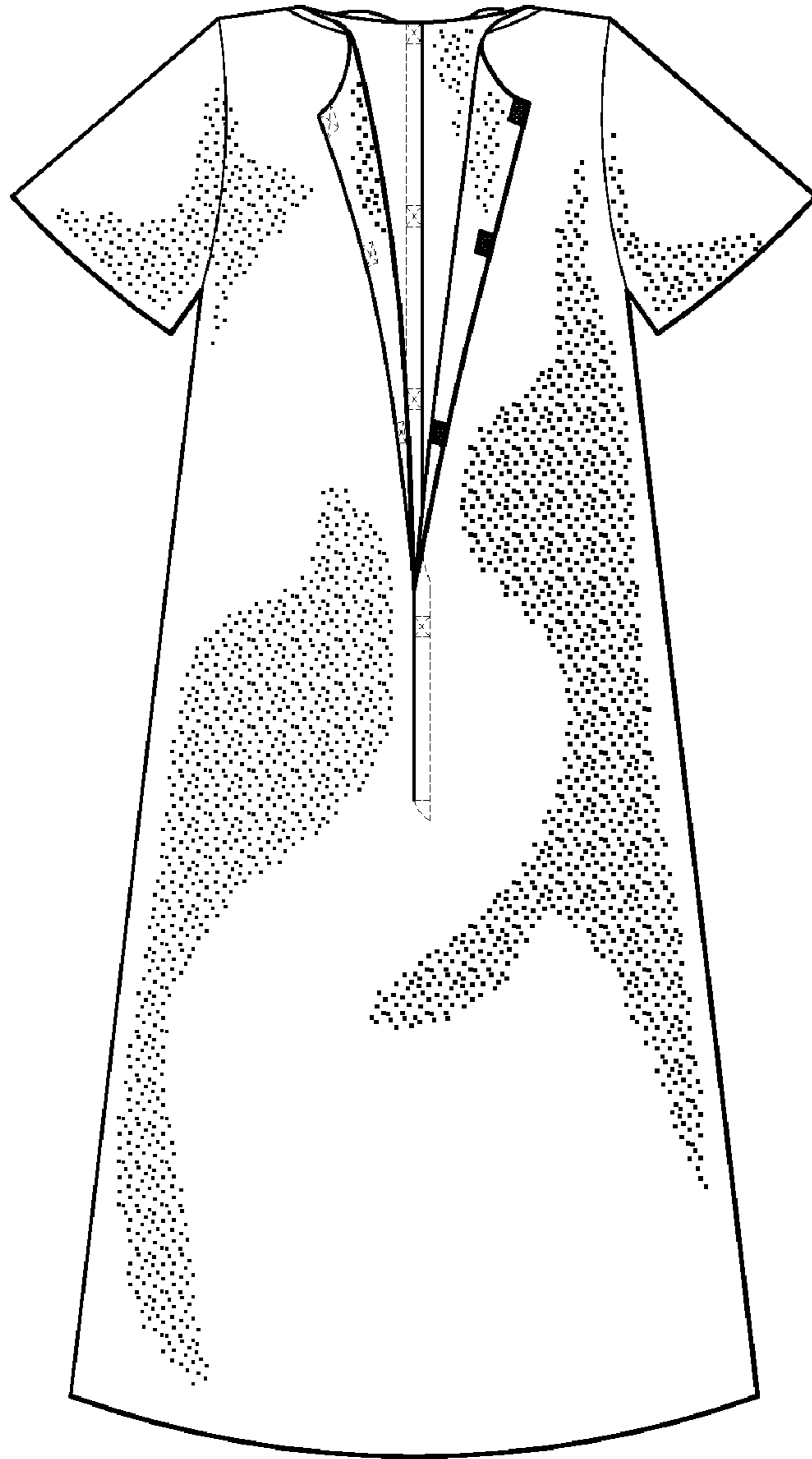
