FIG. 4 is a rear view,

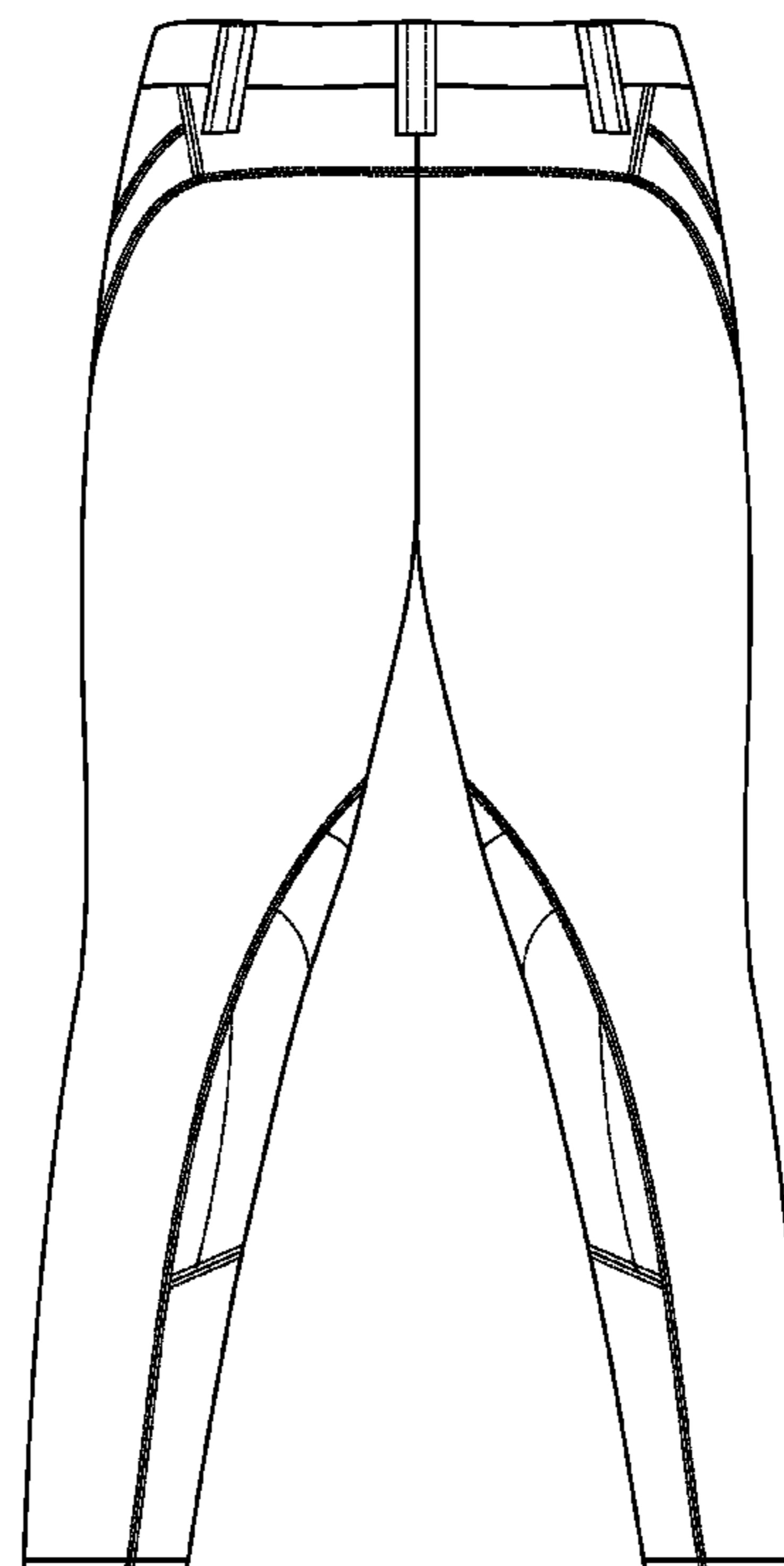
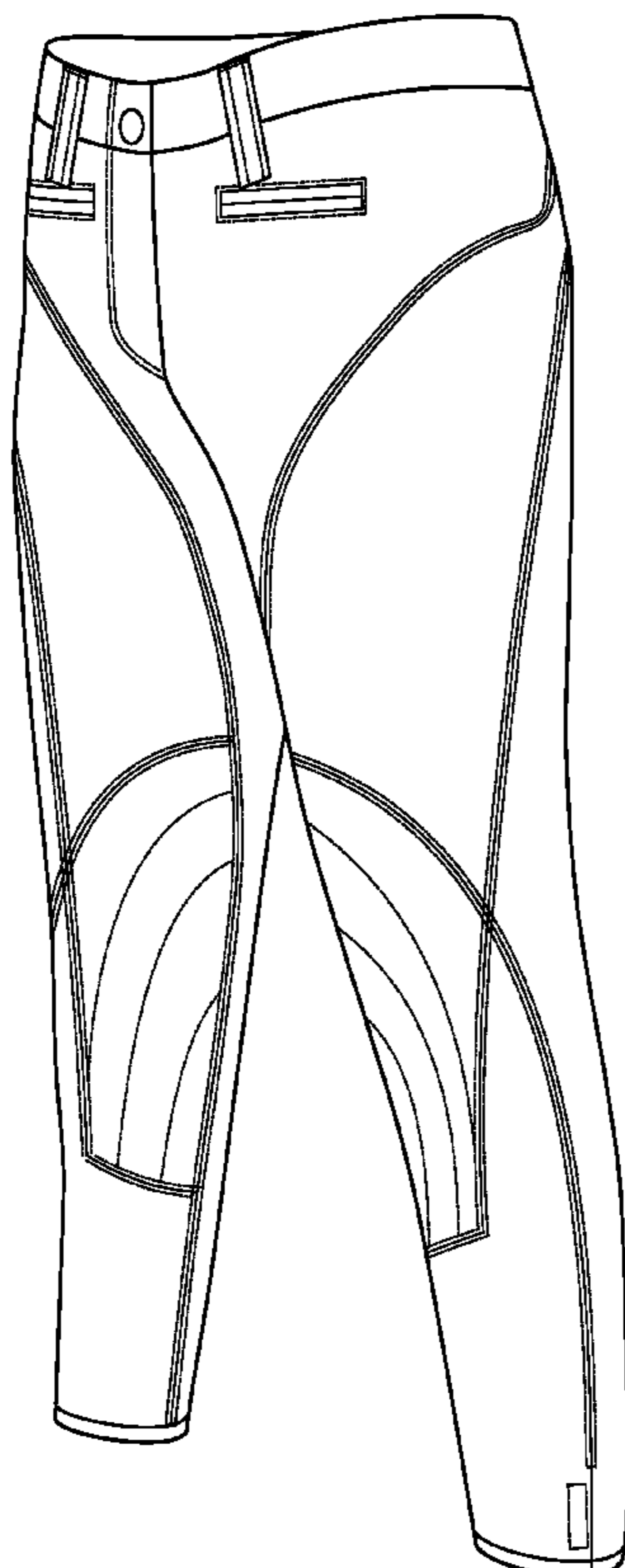
FIG. 5 is a left side view,

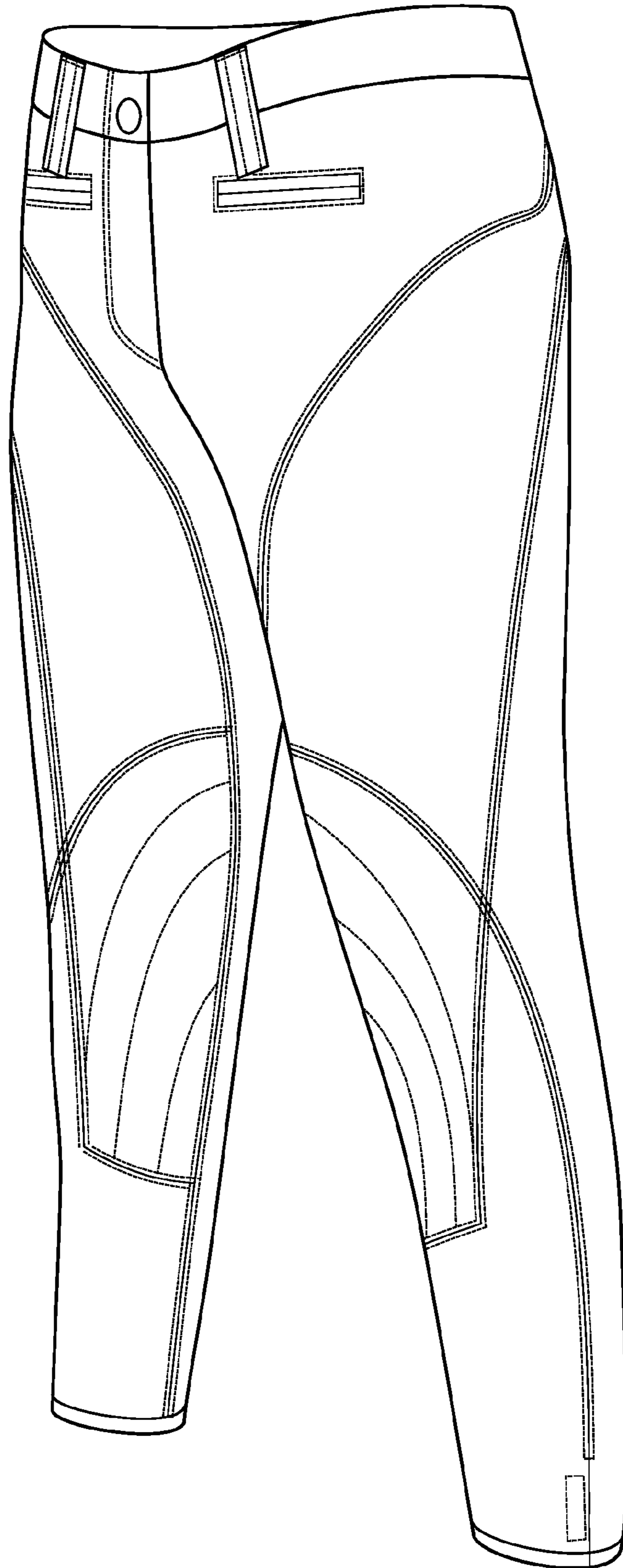

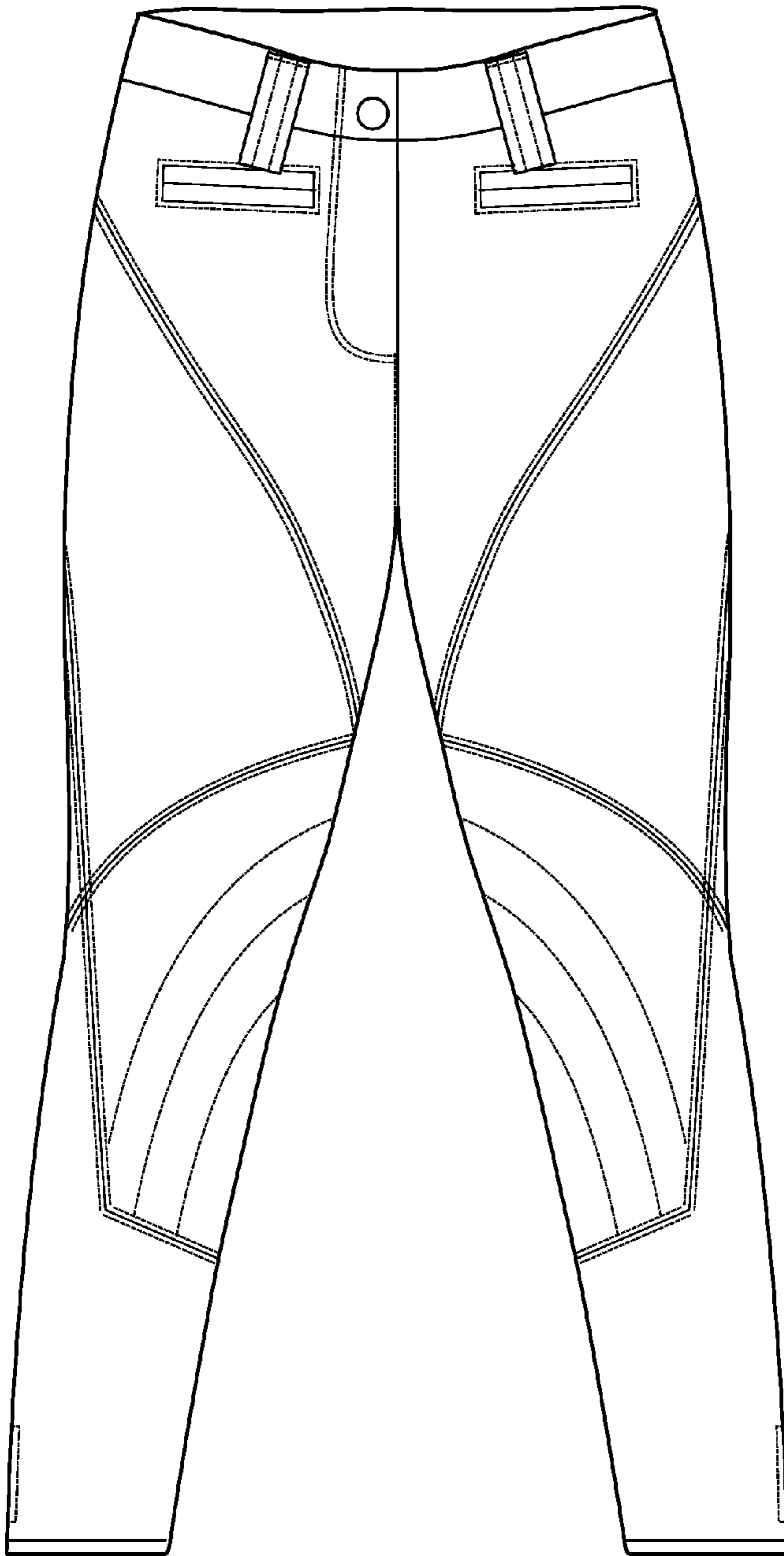
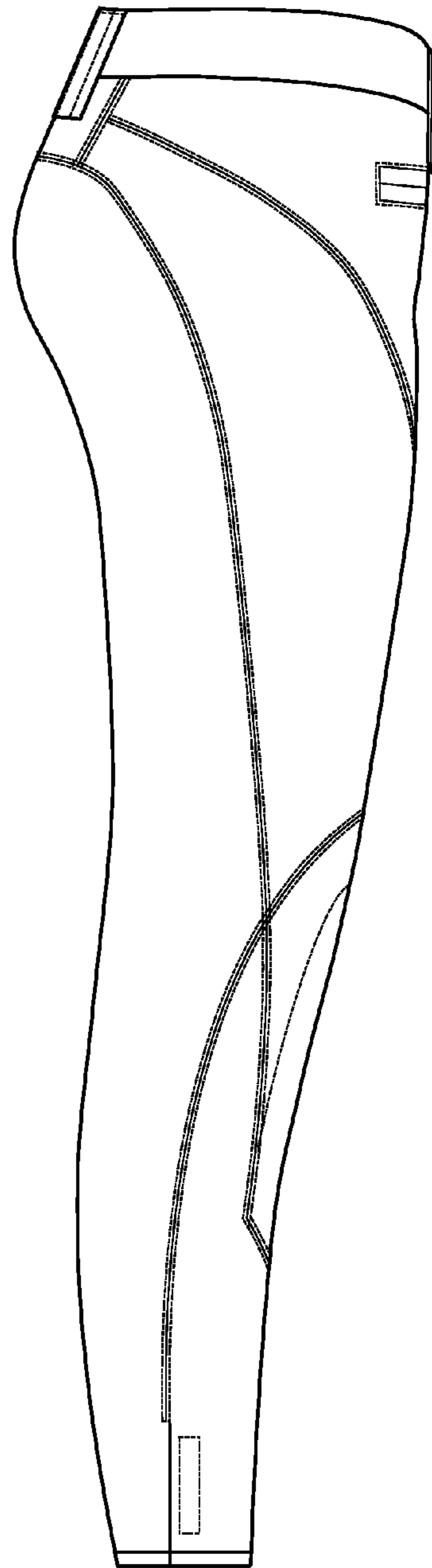

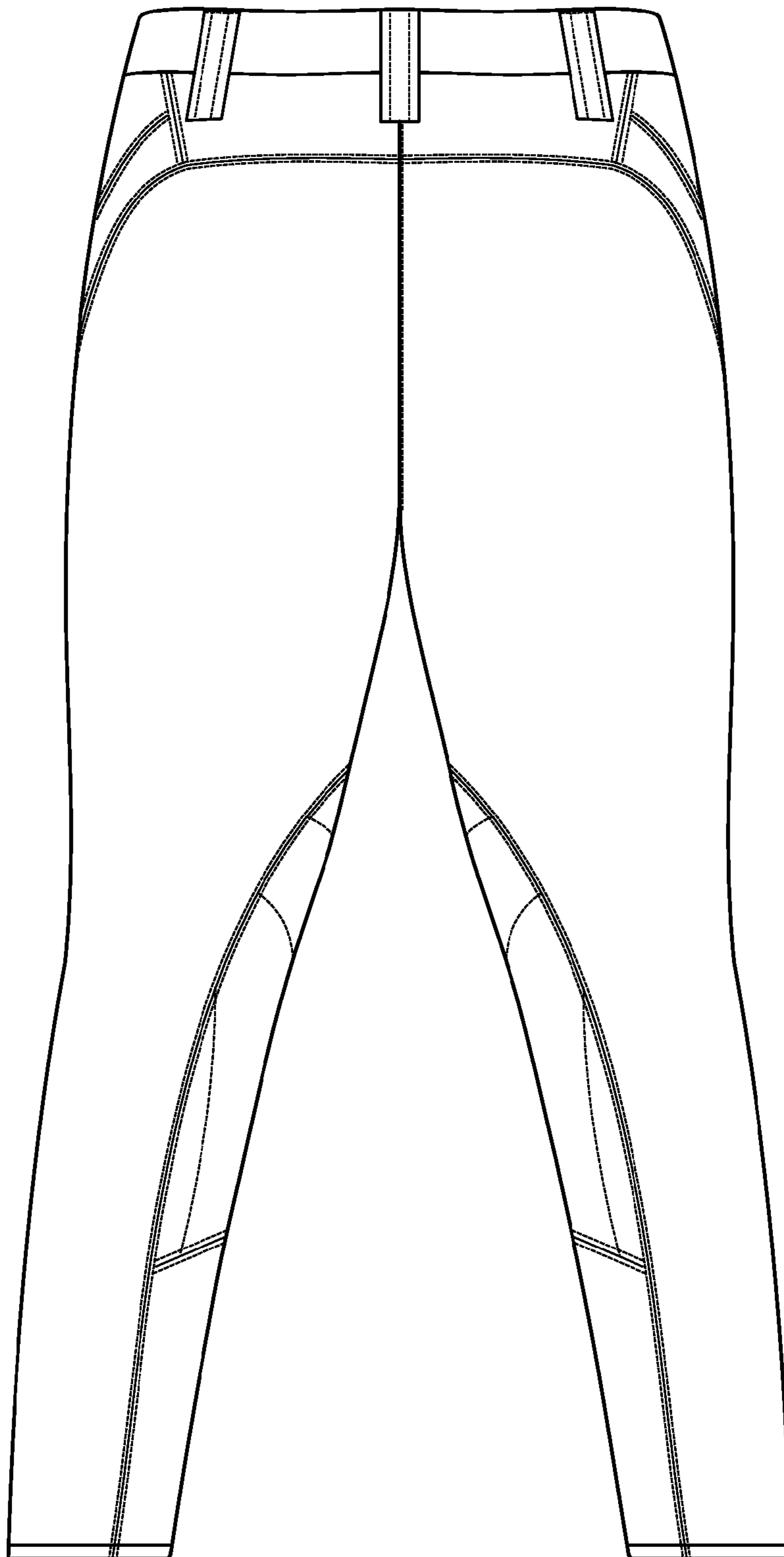
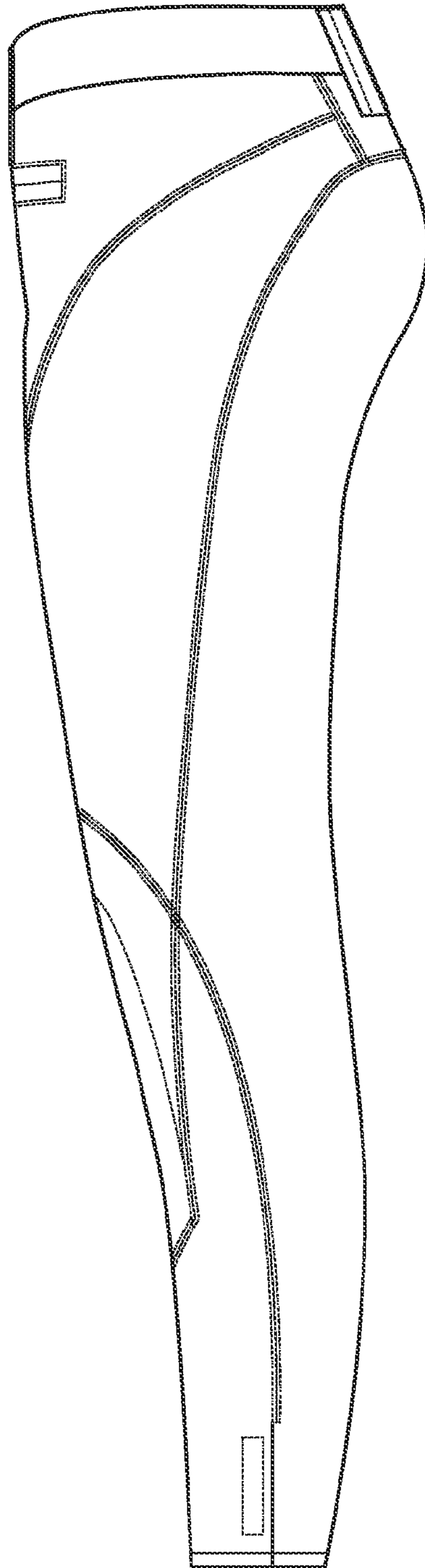
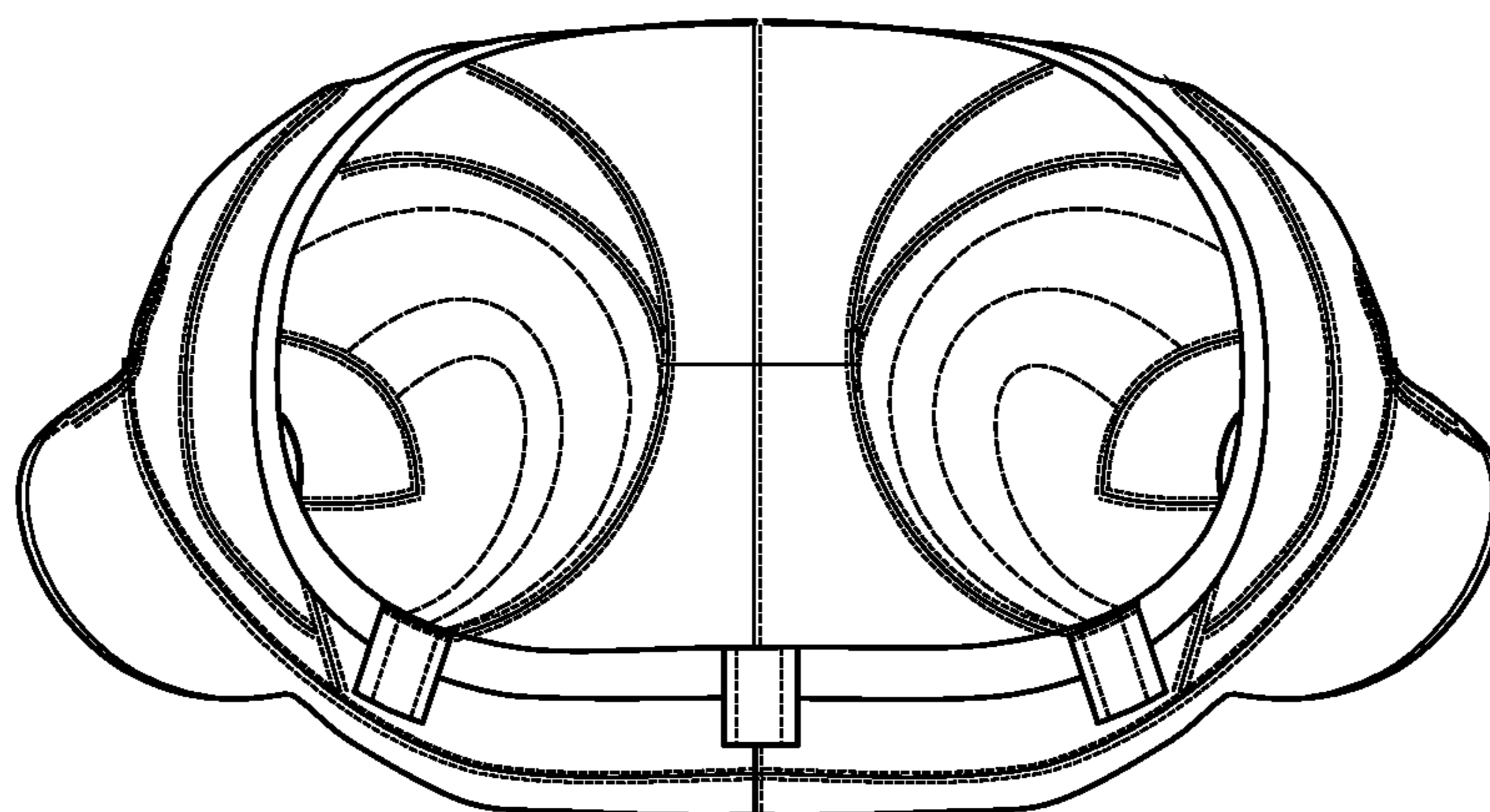
