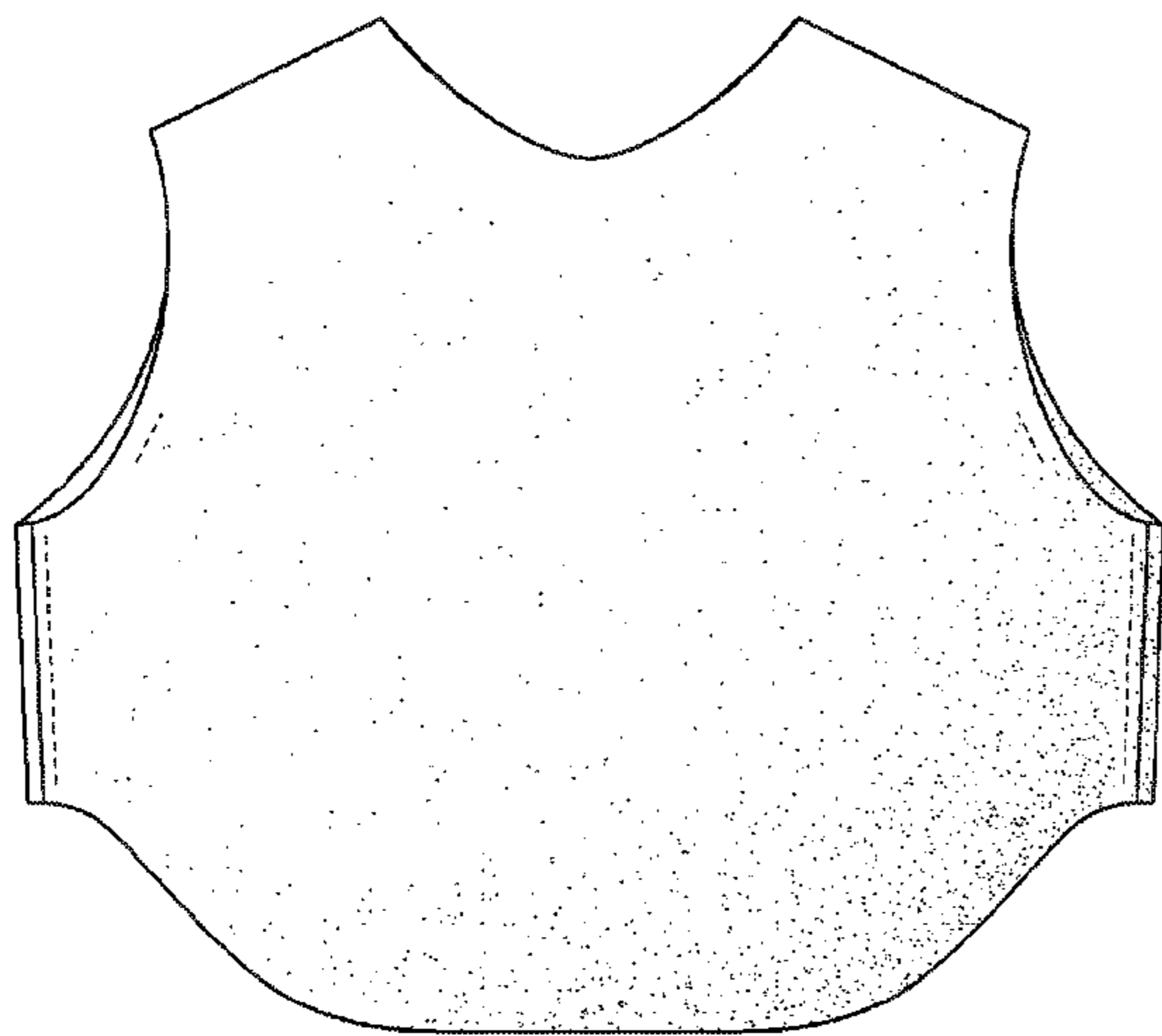

(57) **CLAIM**

The ornamental design for a bib, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bib;

FIG. 2 is a back perspective view of the bib of FIG. 1 showing the bib in a closed position;

FIG. 3 is a back perspective plan view of the bib of FIG. 1 showing the bib in an open position;

FIG. 4 is a front elevational view of the bib of FIG. 1;

FIG. 5 is a back elevational view of the bib of FIG. 1 showing the bib in a closed position;

FIG. 6 is a back elevational plan view of the bib of FIG. 1 showing the bib in an open position;

FIG. 7 is a left side elevational view of the bib of FIG. 1; the right side elevational view being a mirror image of the left side elevational view;

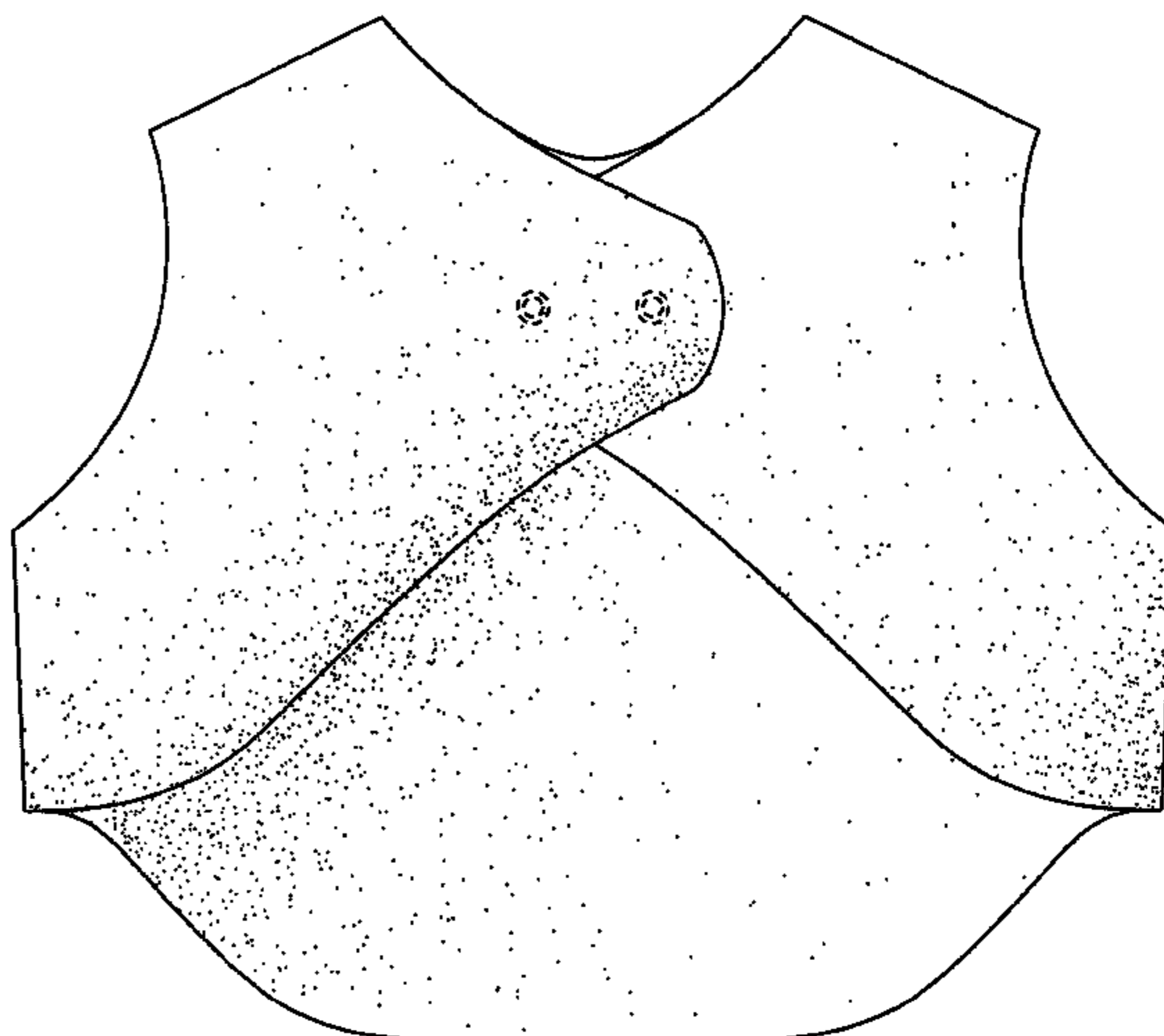
FIG. 8 is a front perspective view showing a second embodiment of the bib;

FIG. 9 is a back perspective view of the bib of FIG. 8 showing the bib in a closed position; and,

FIG. 10 is a back perspective plan view of the bib of FIG. 8 showing the bib in an open position.

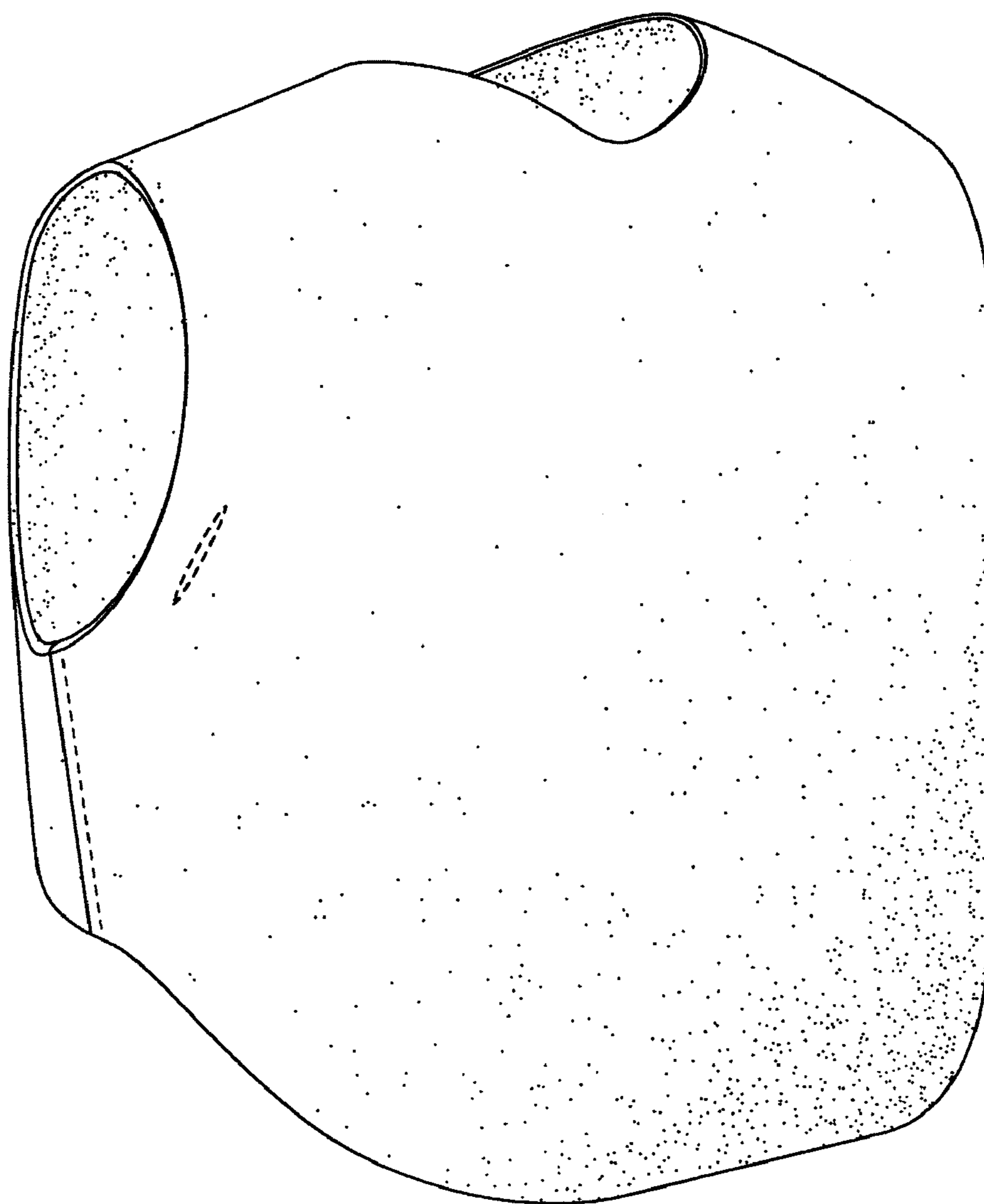

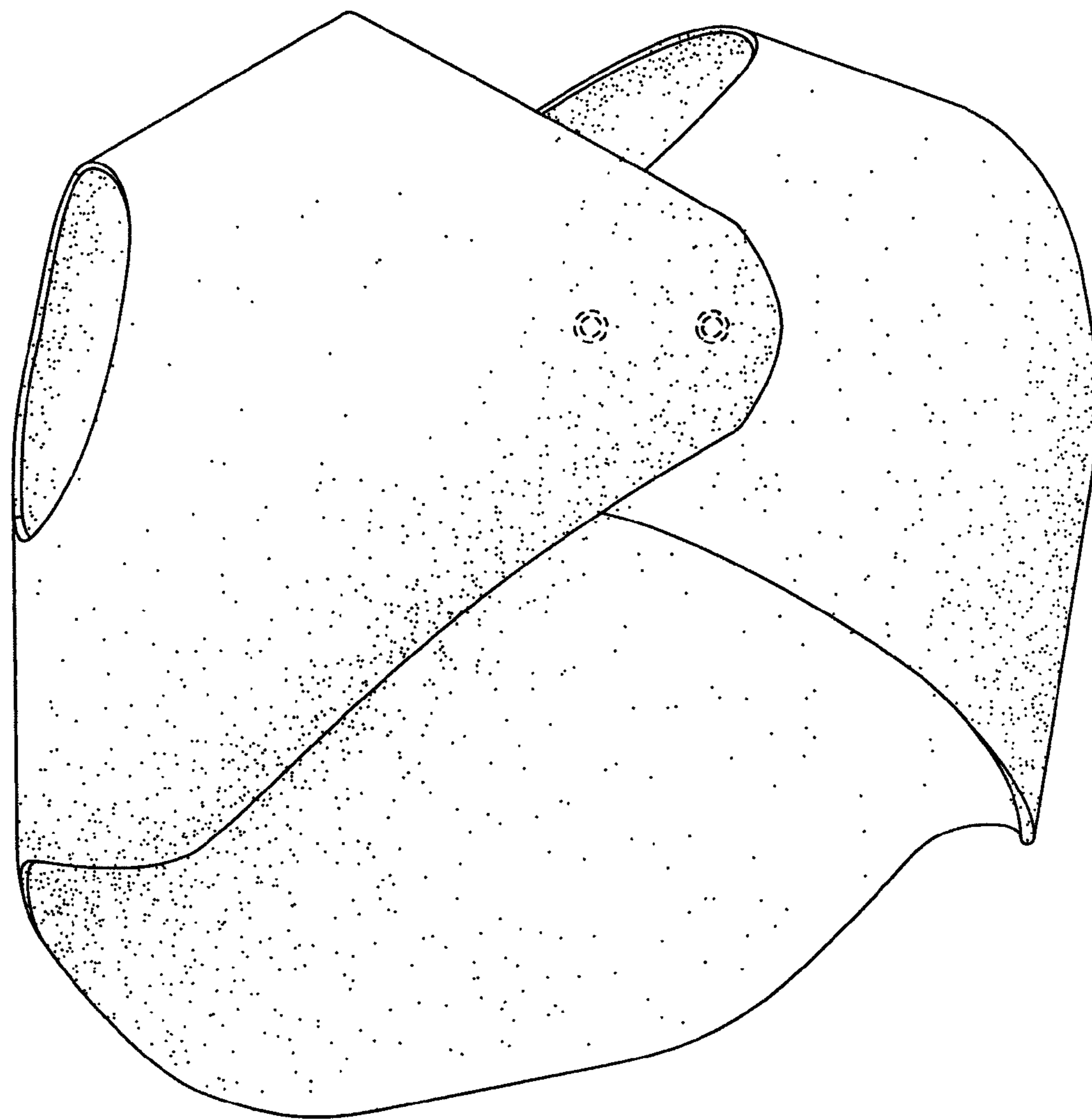

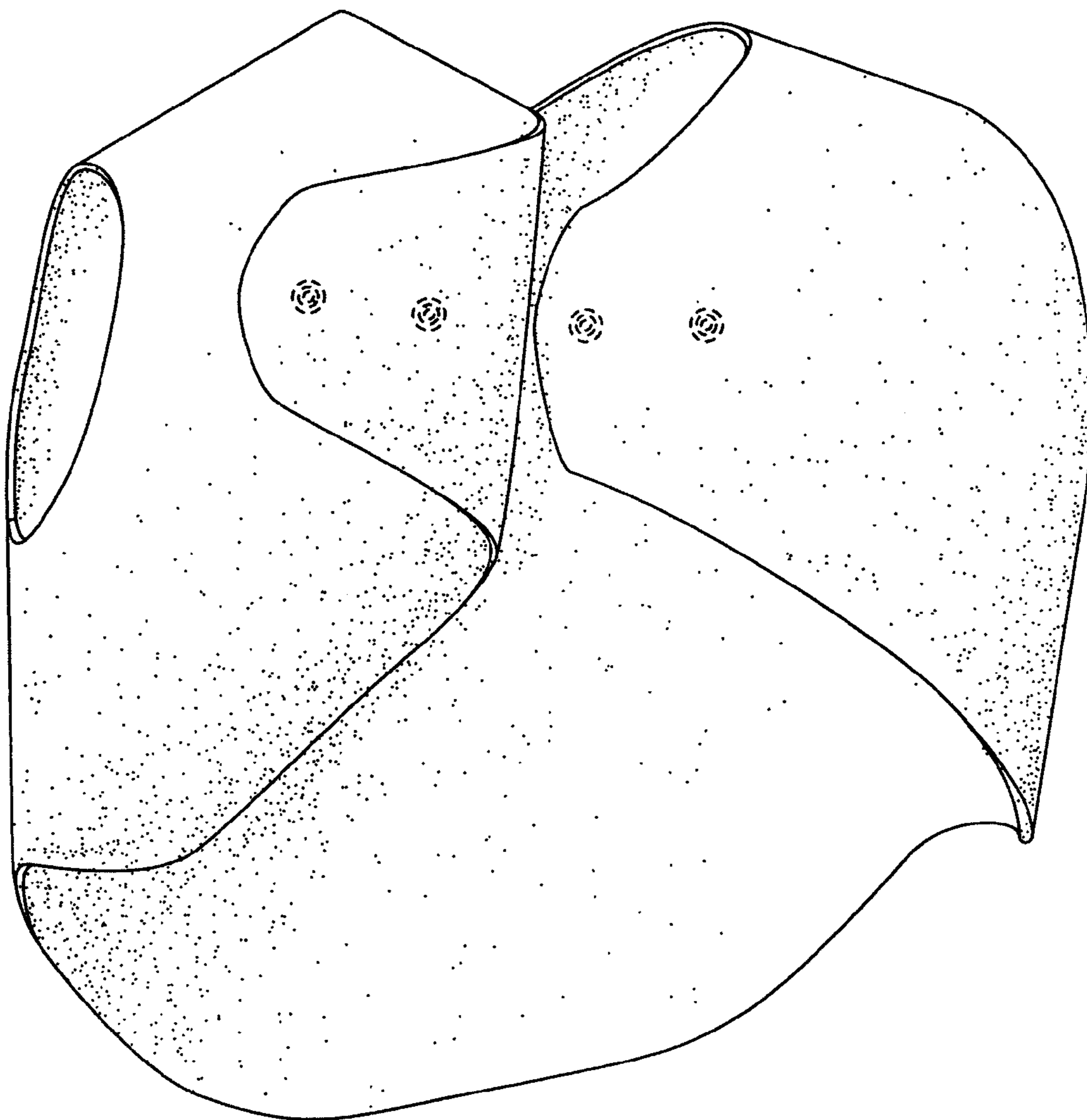

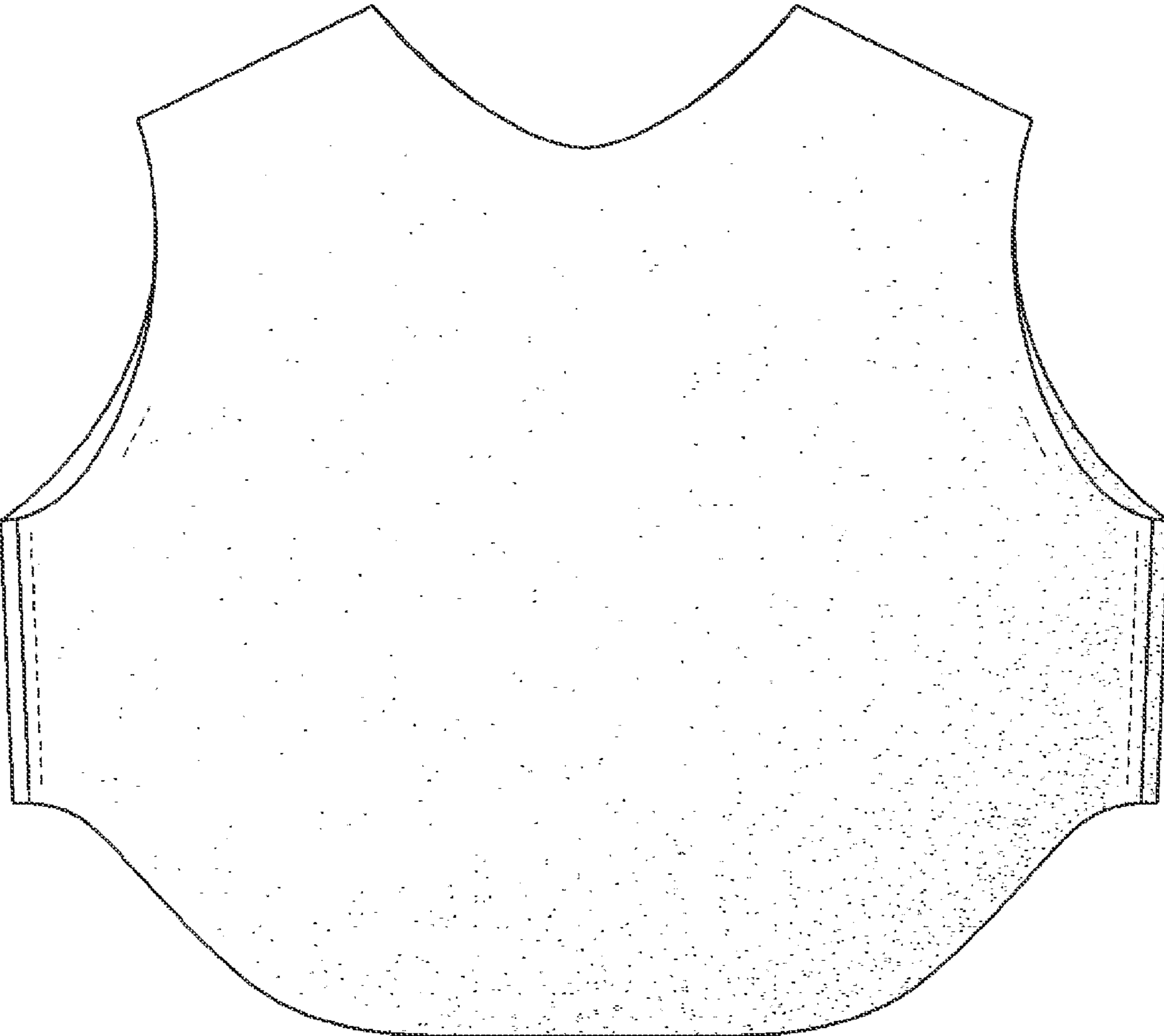

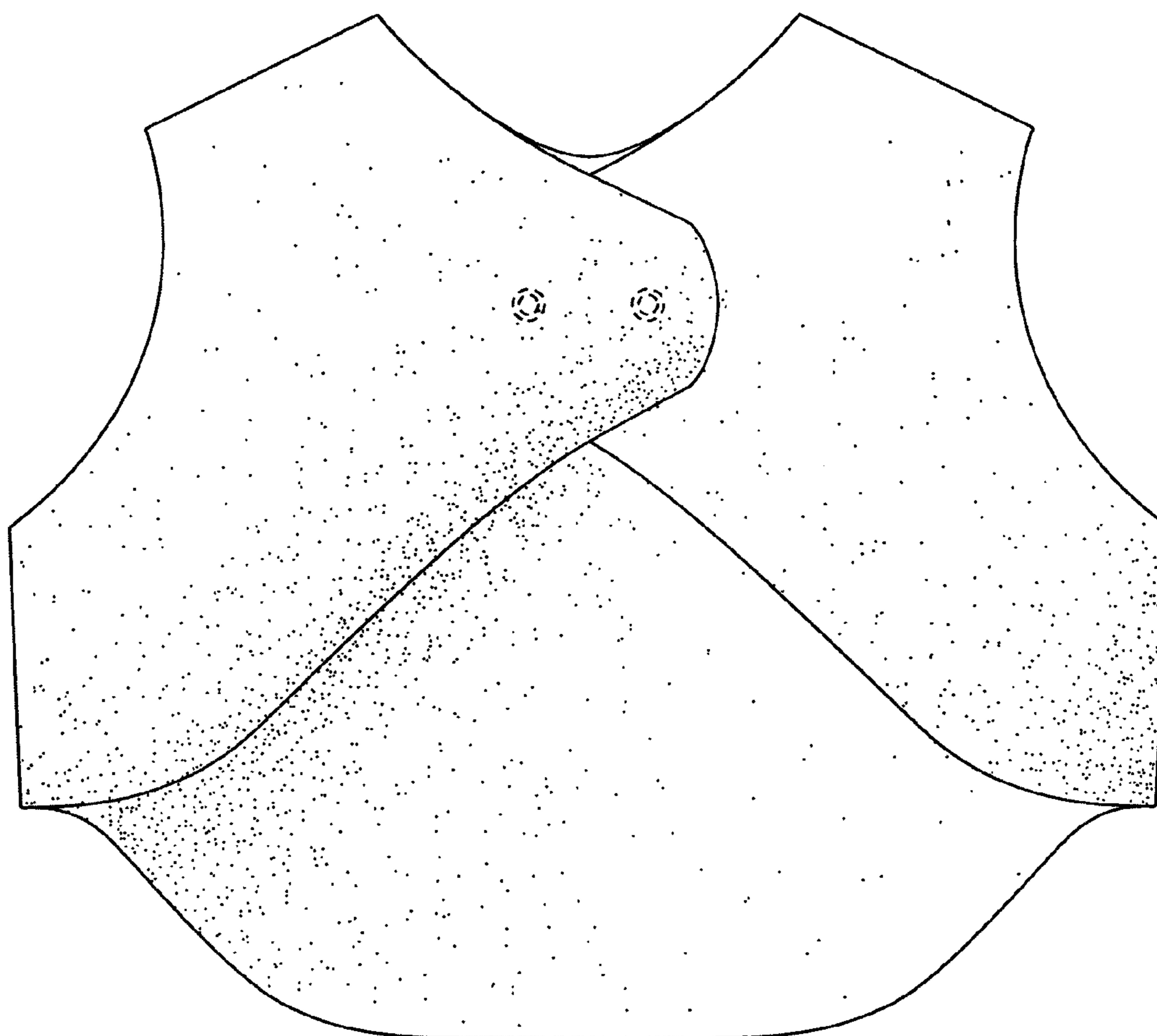

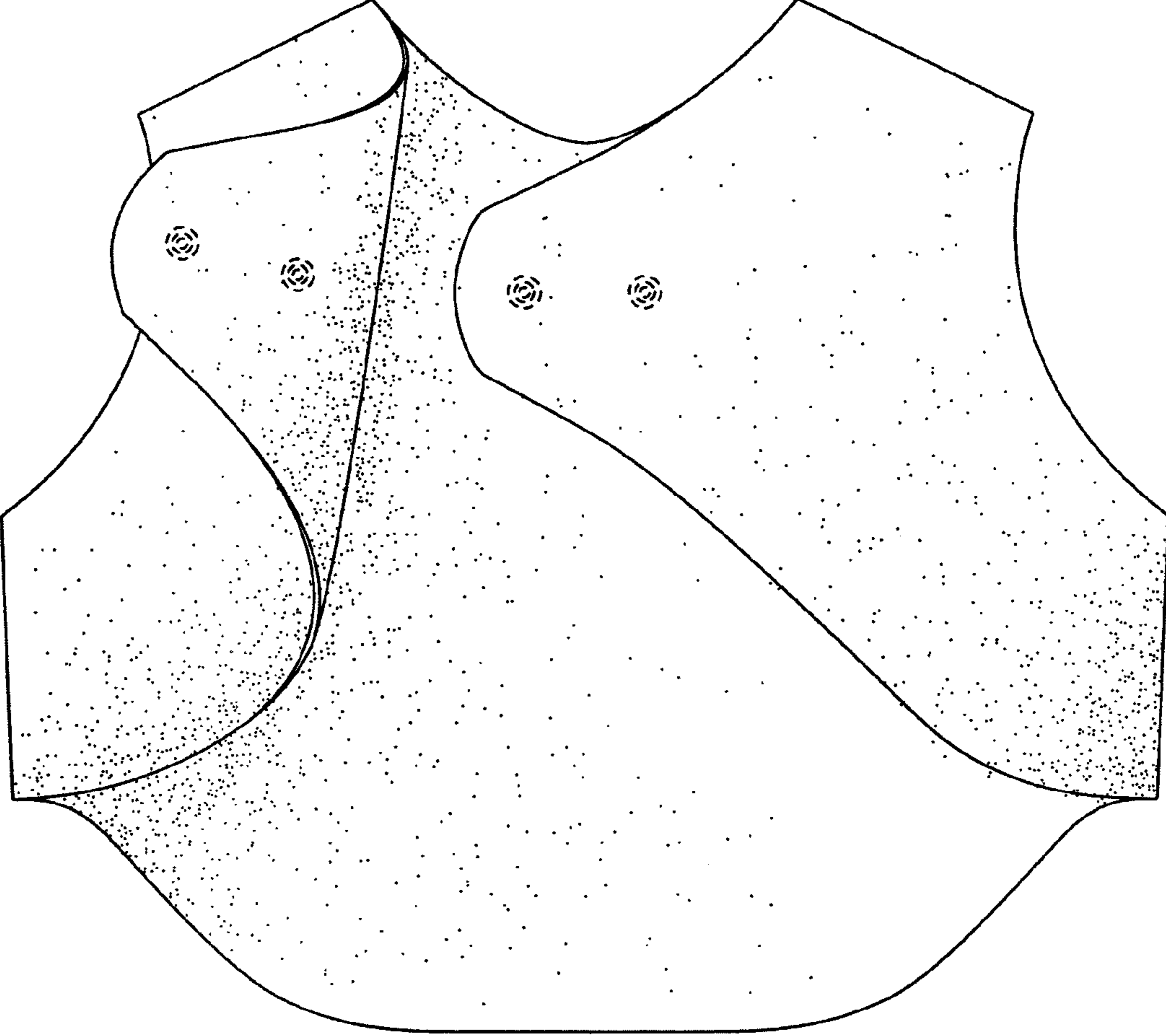

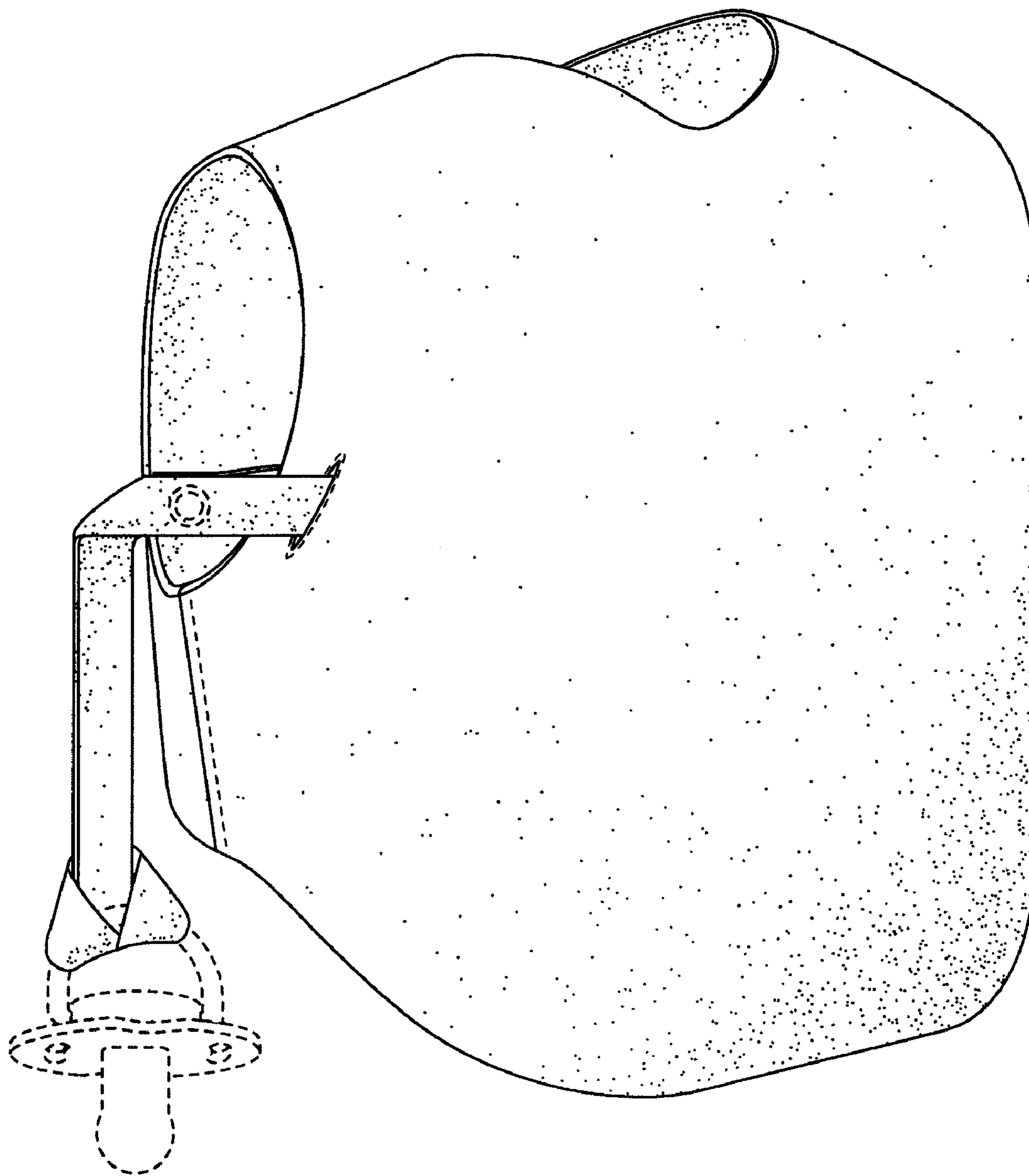

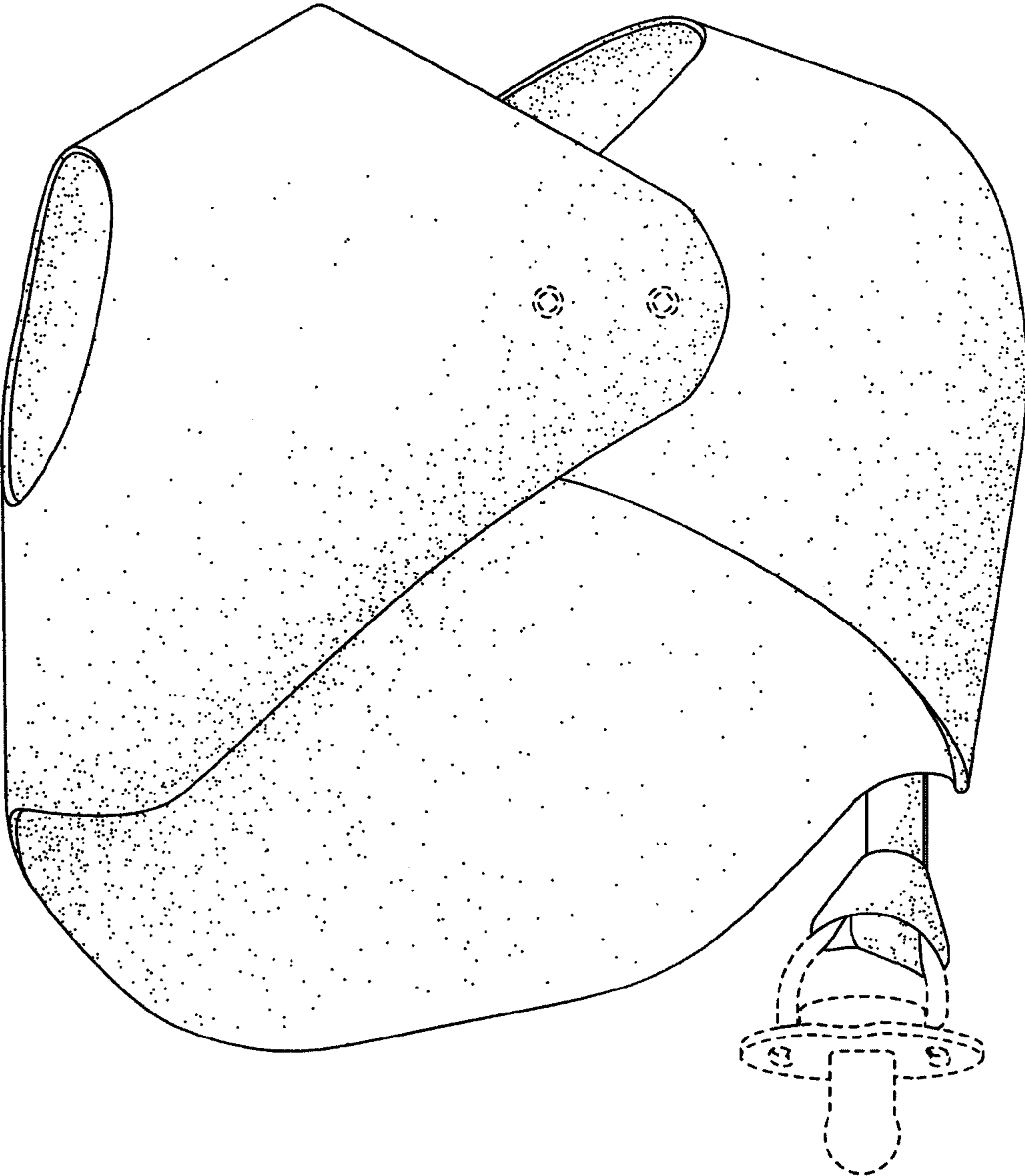

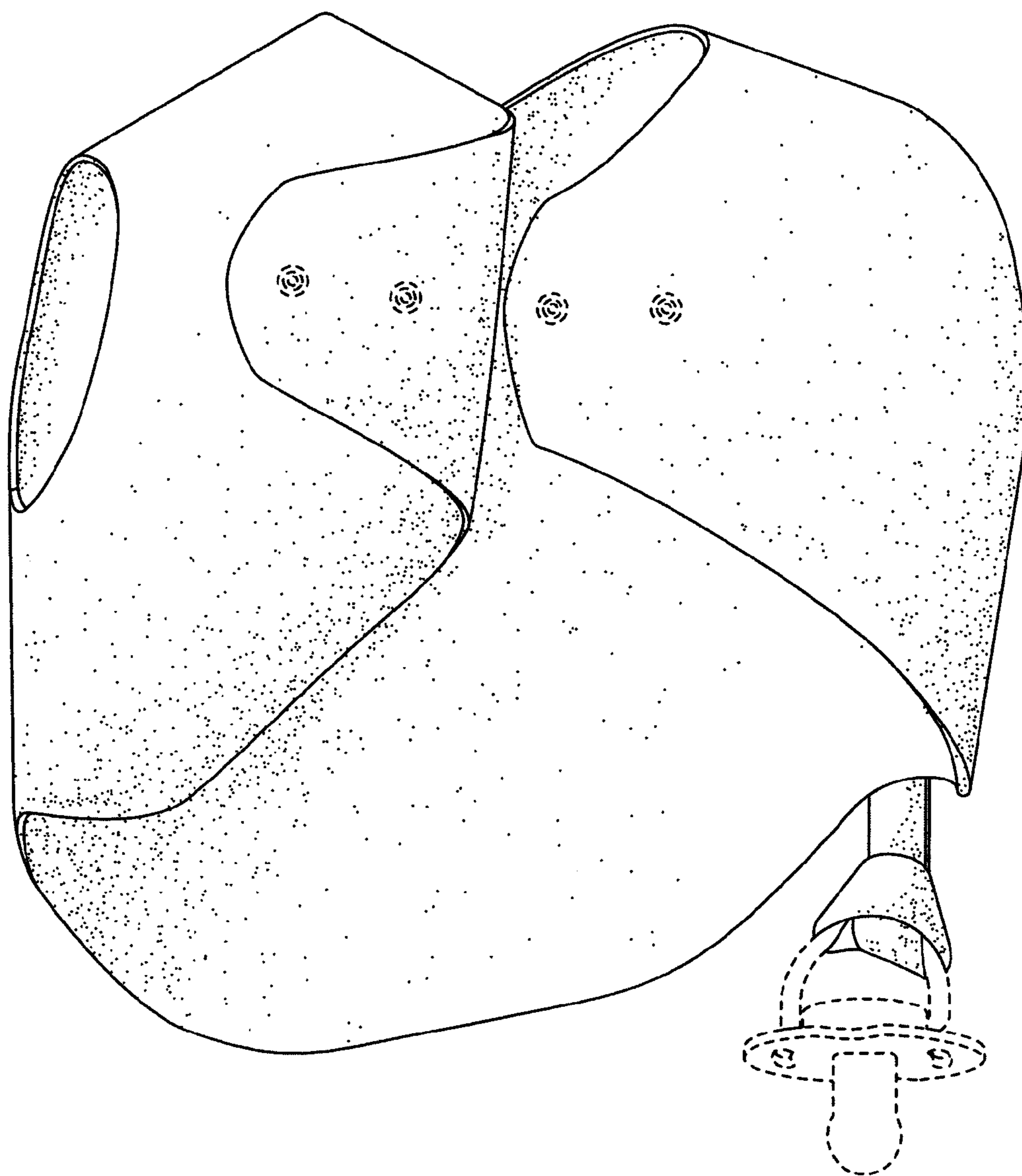
