FIG. 3 is a back view of the shoe according to the claimed design;

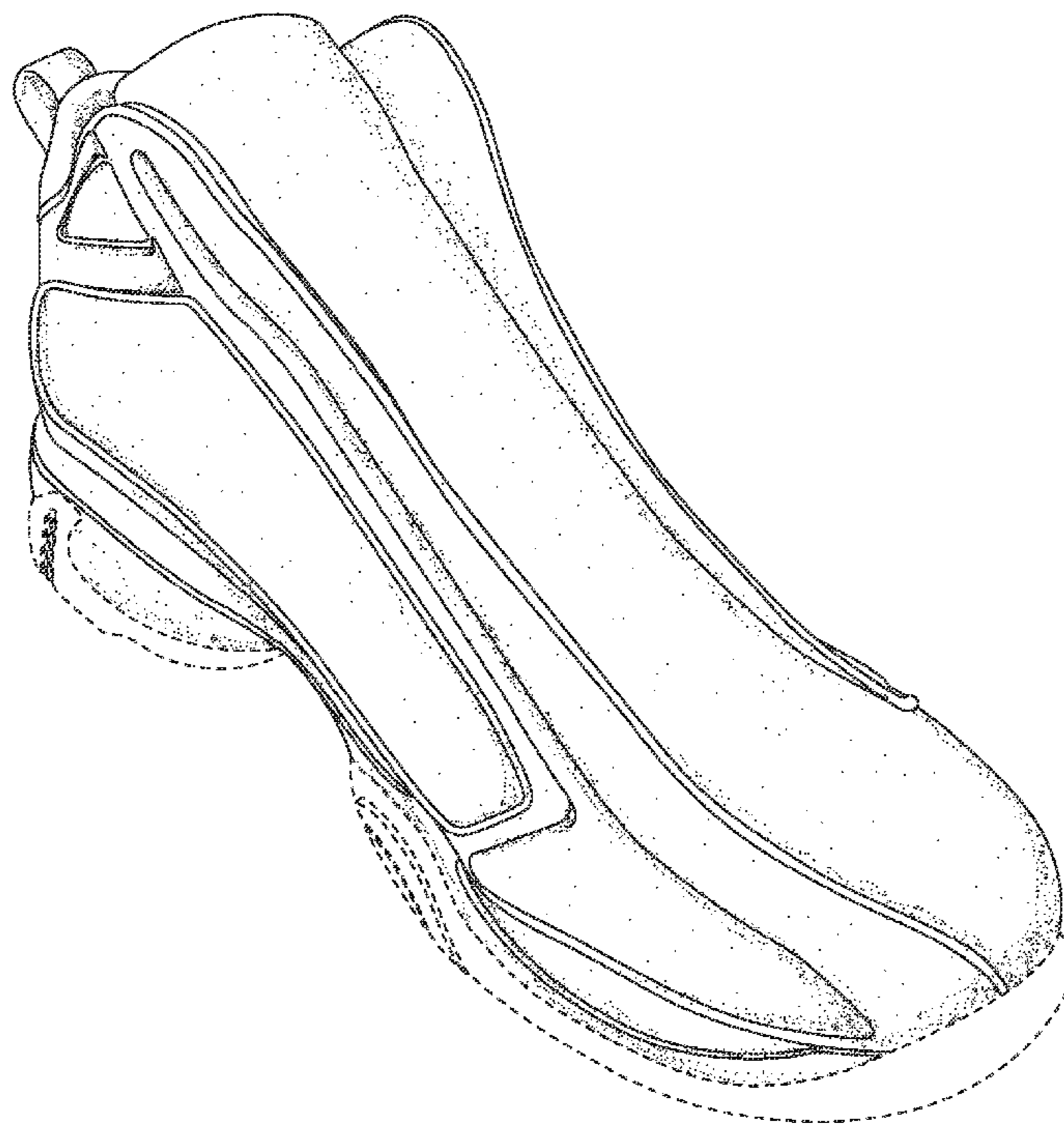
FIG. 4 is a left-side view of the shoe according to the claimed design;

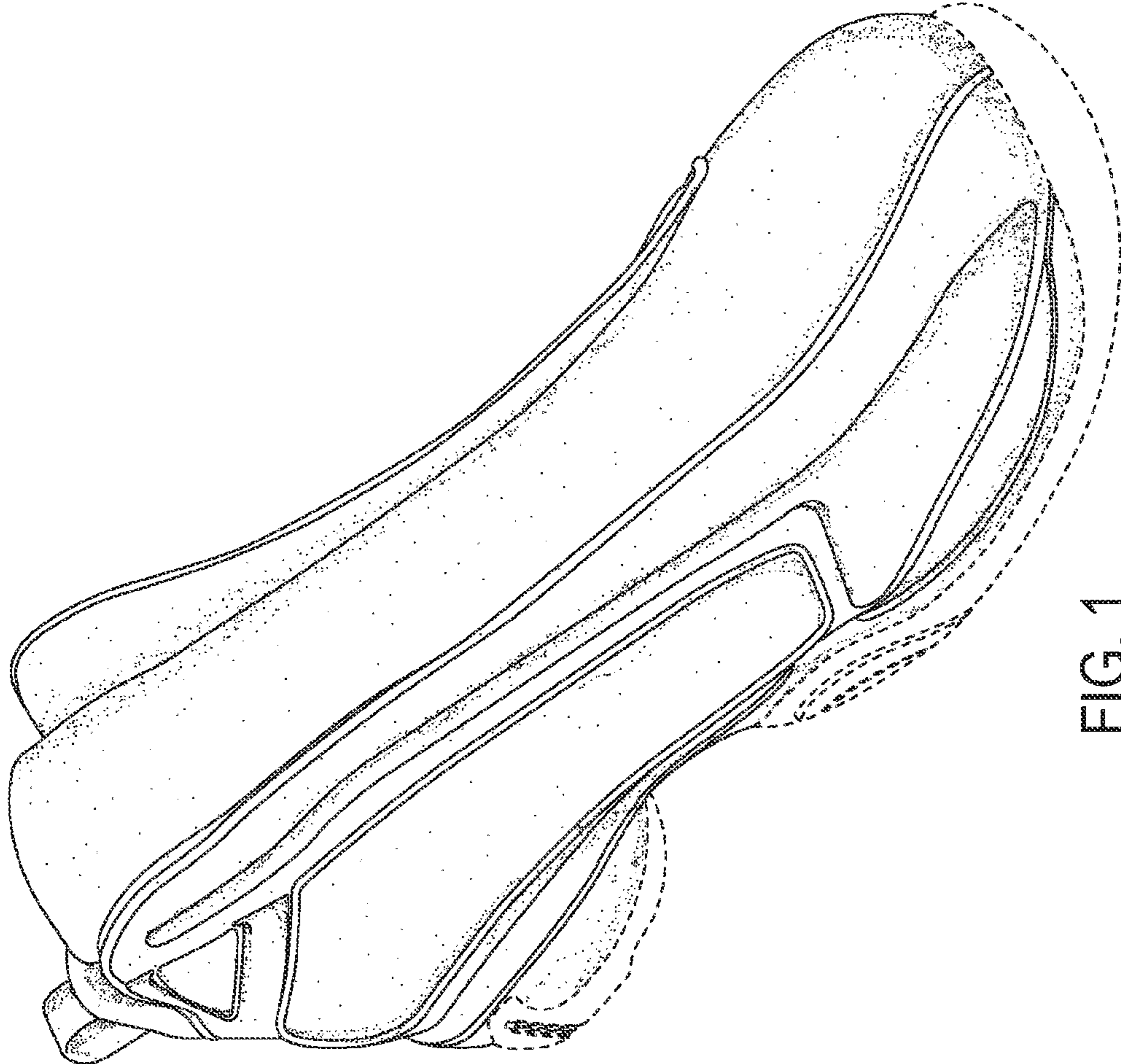

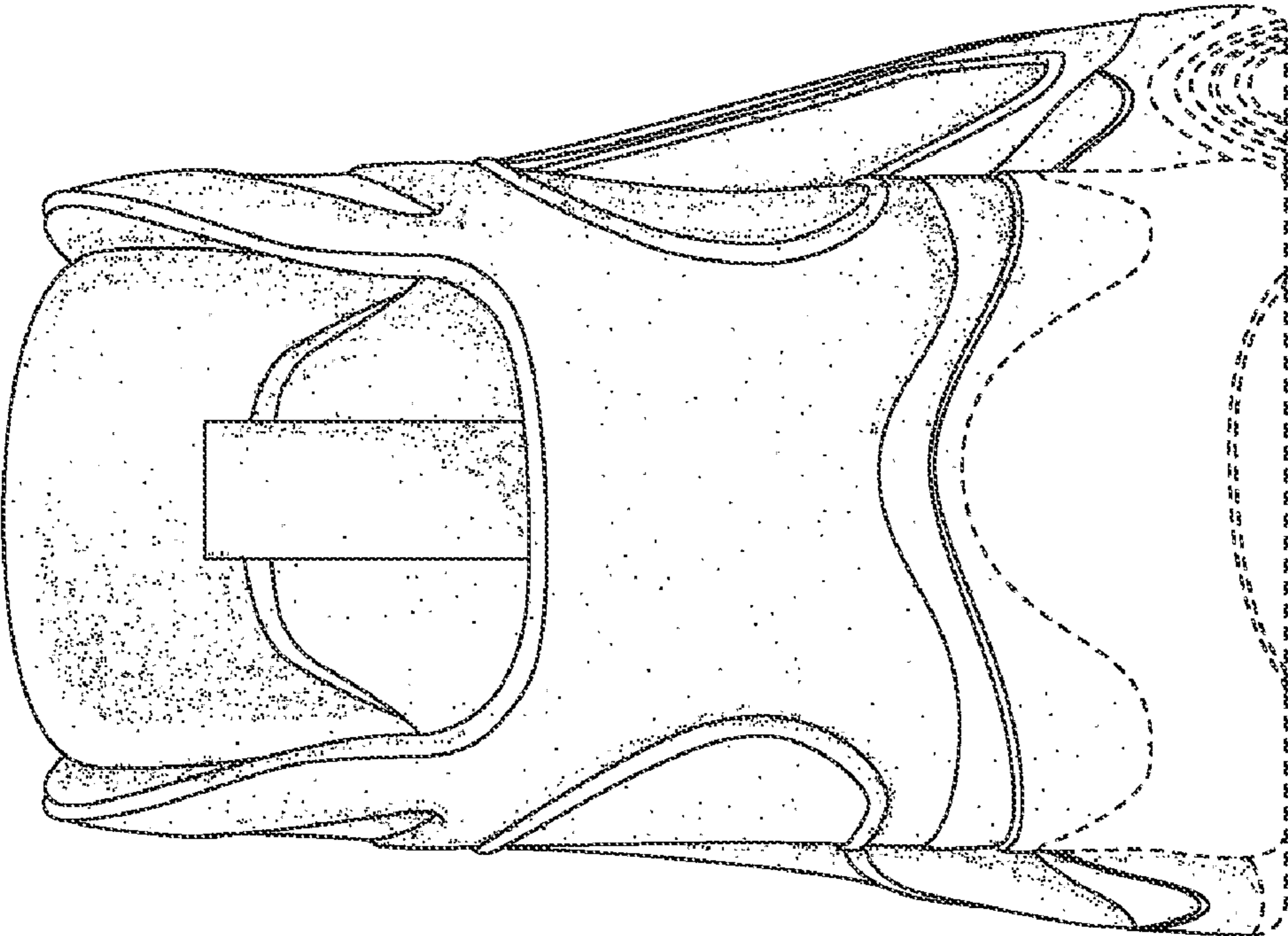

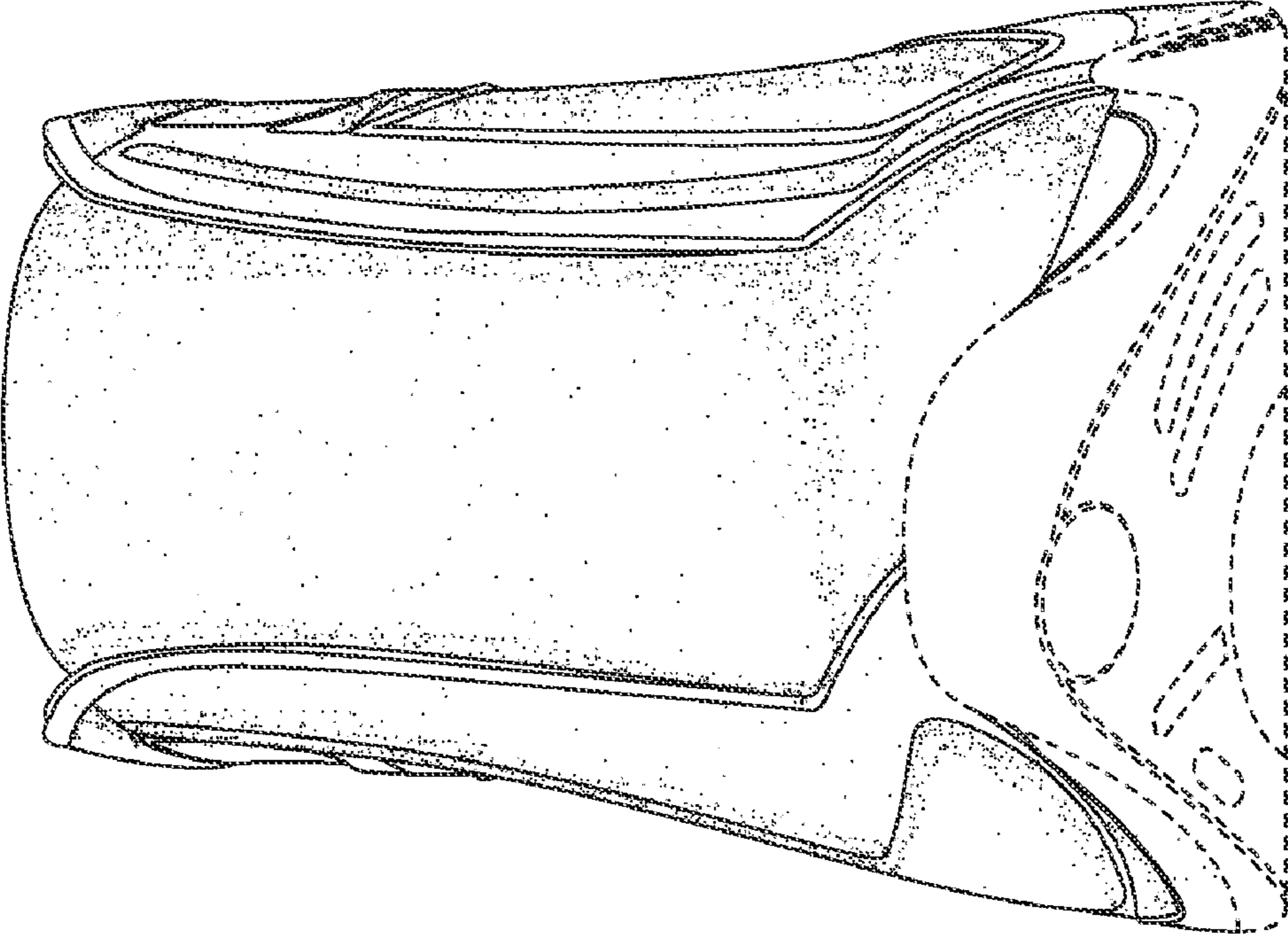

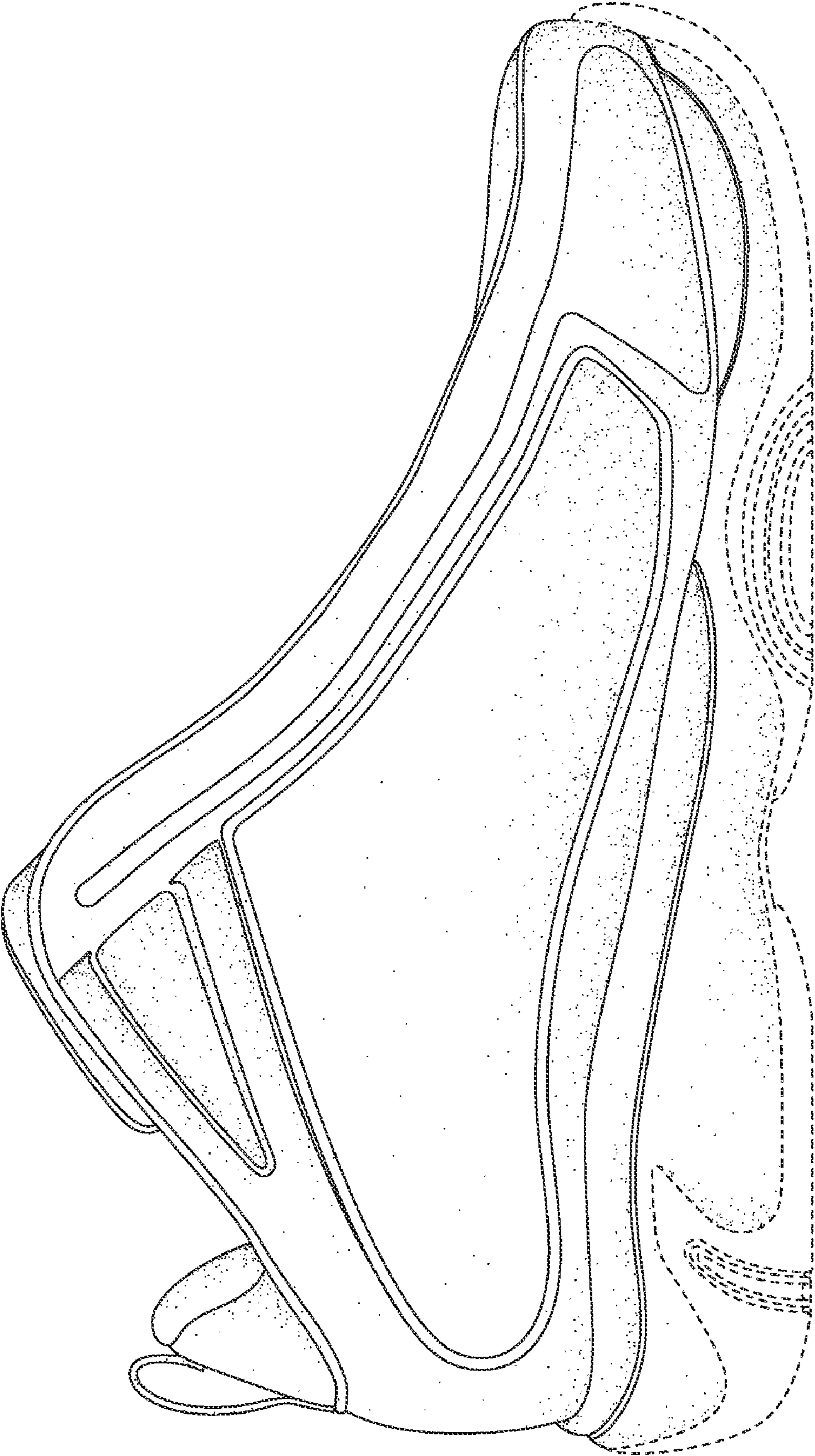

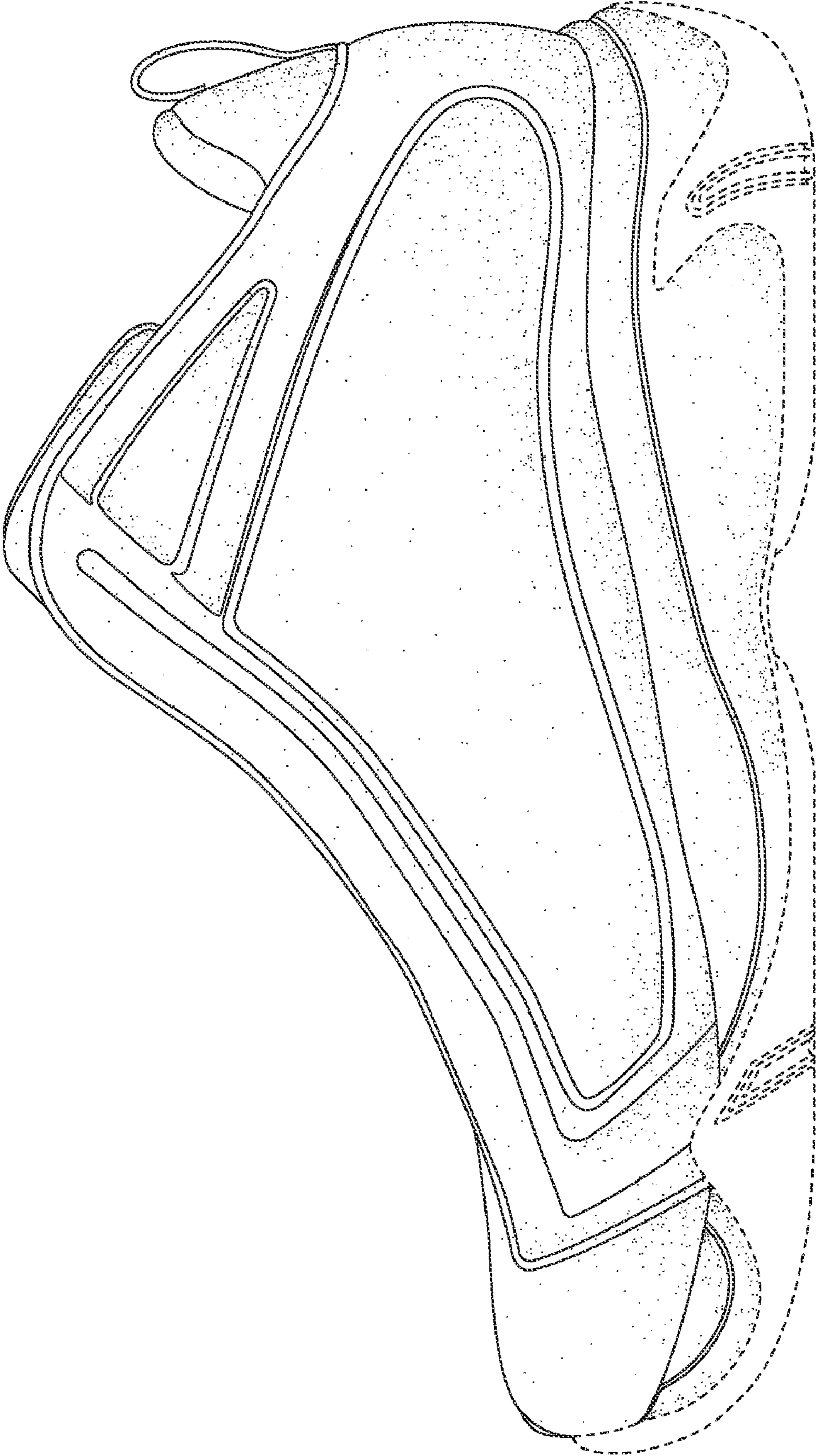

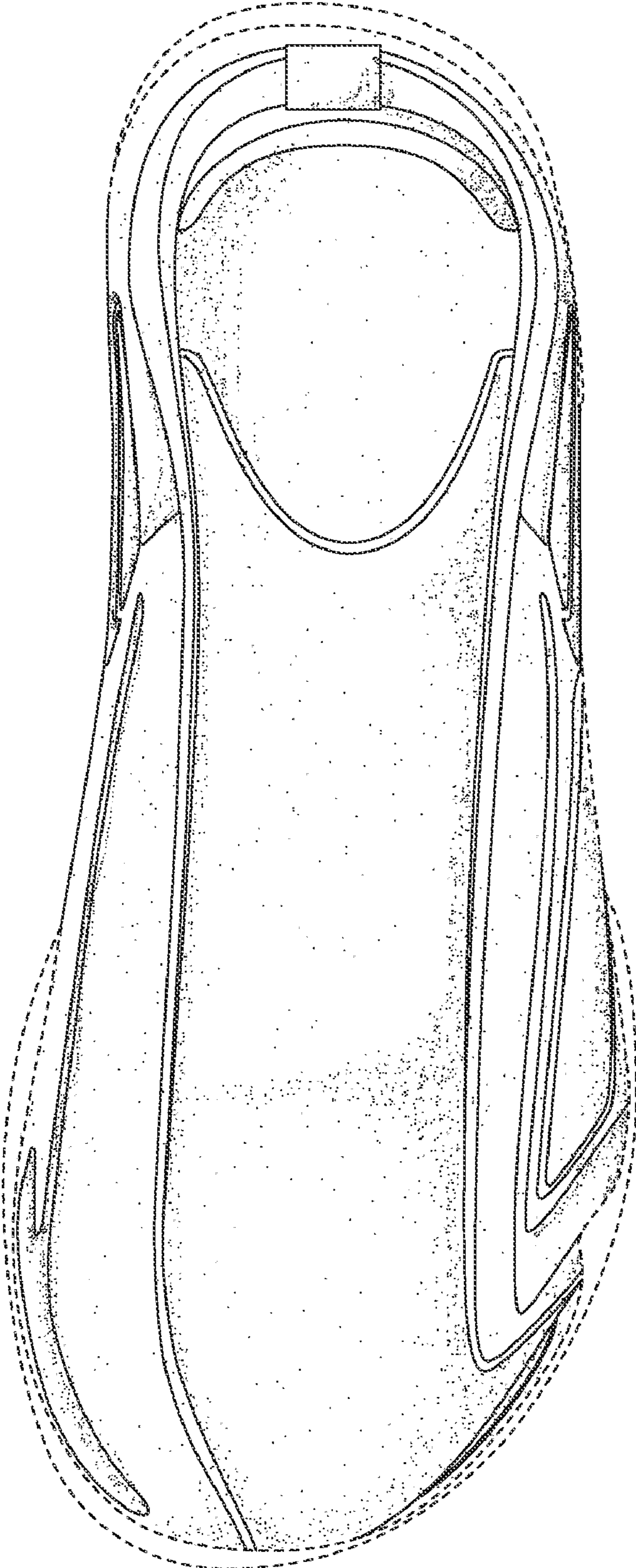

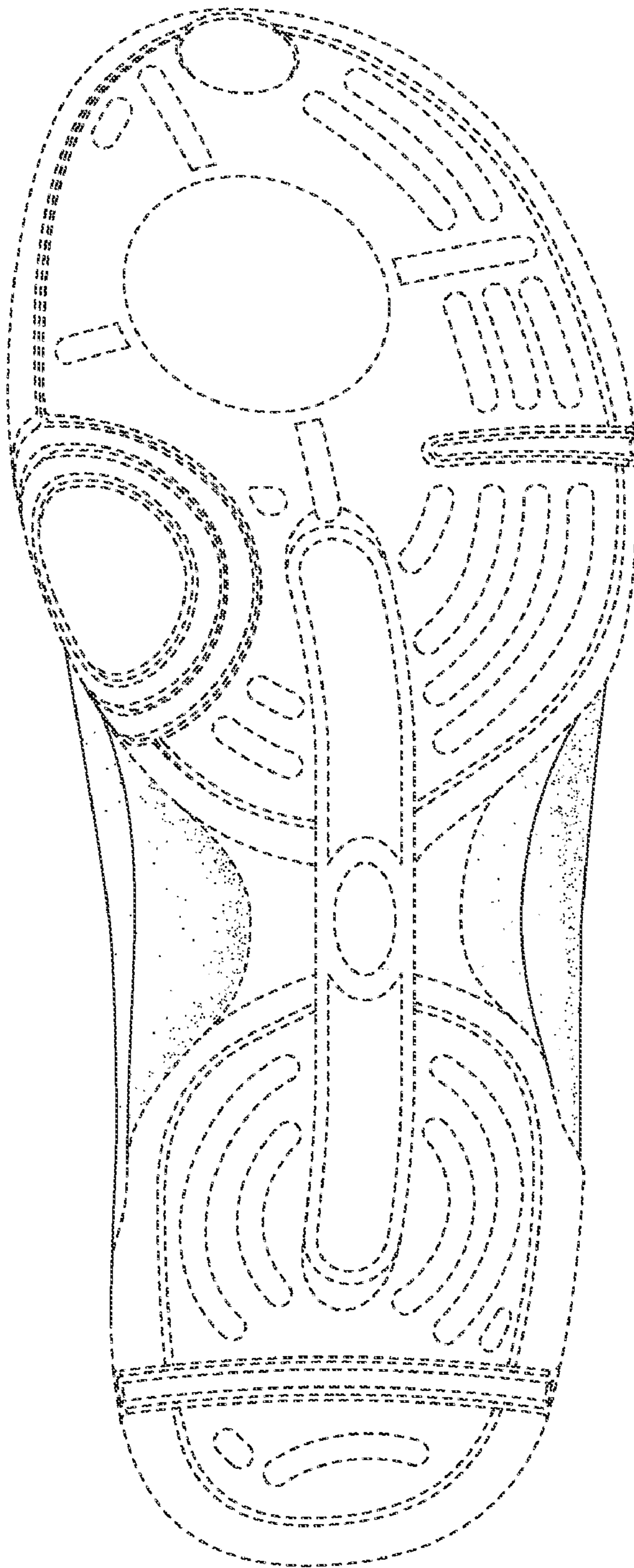
