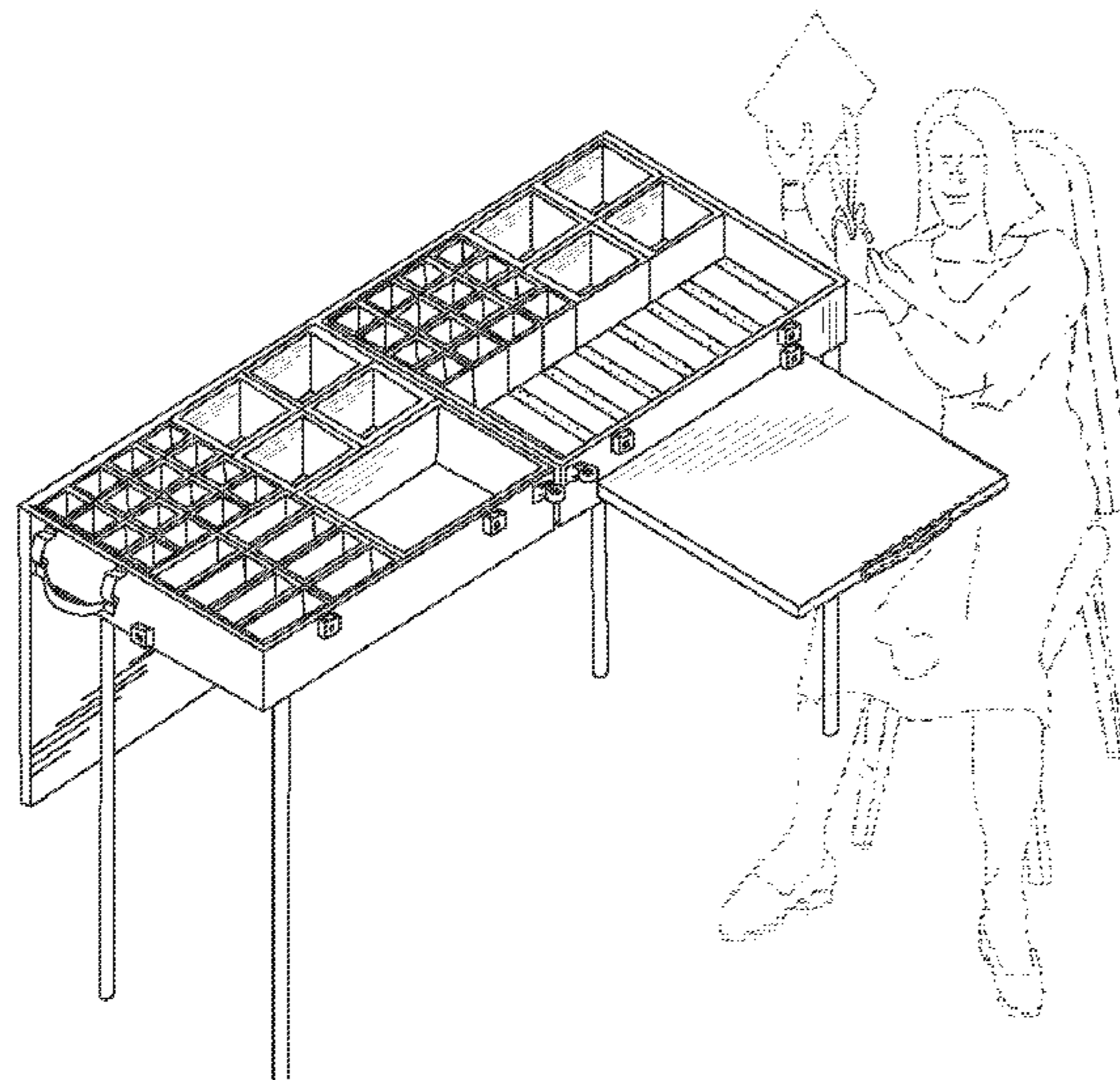
FIG. 5 is a side view of the portable folding craft table with storage according to the present invention folded for storage or transport.

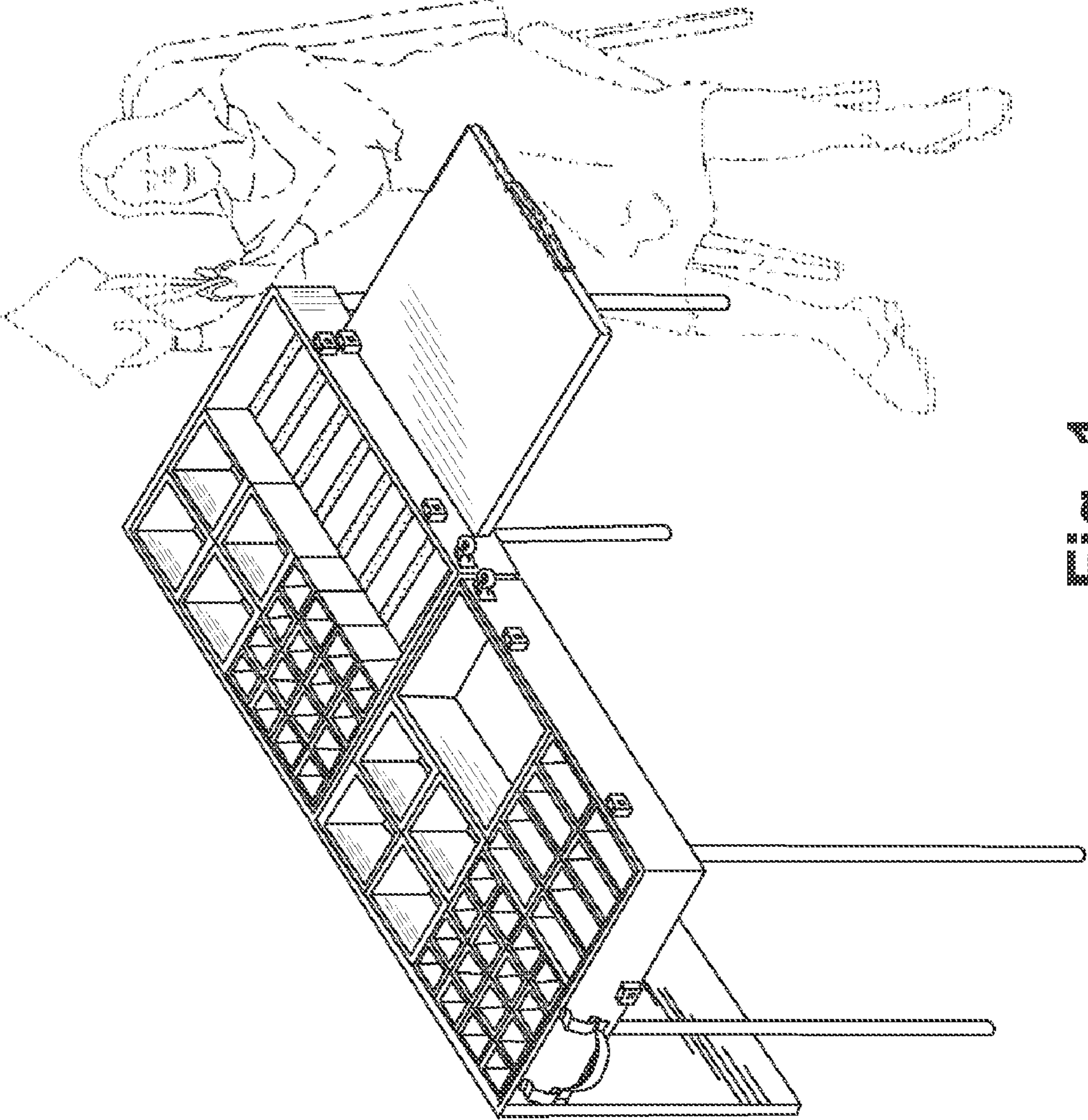

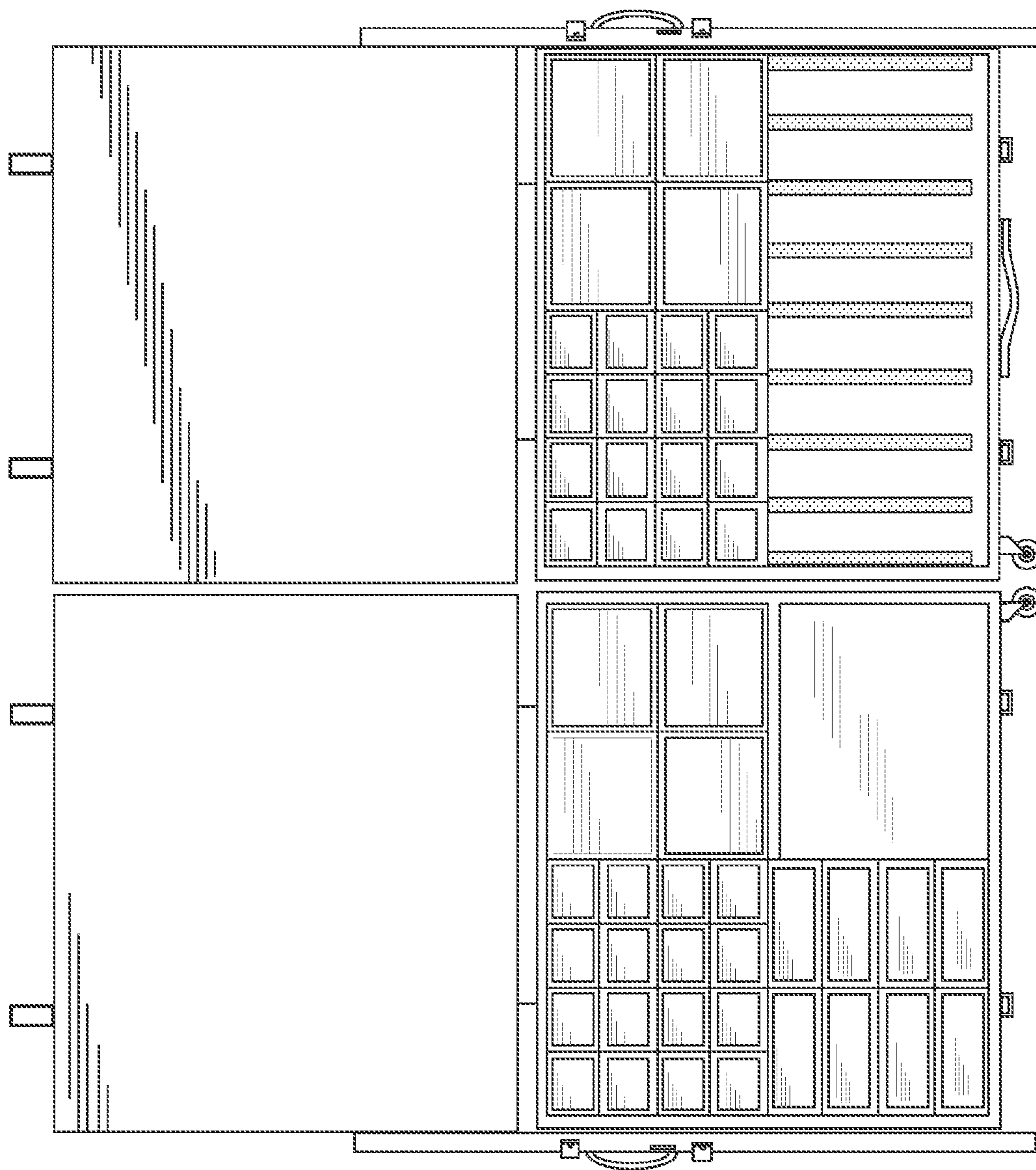

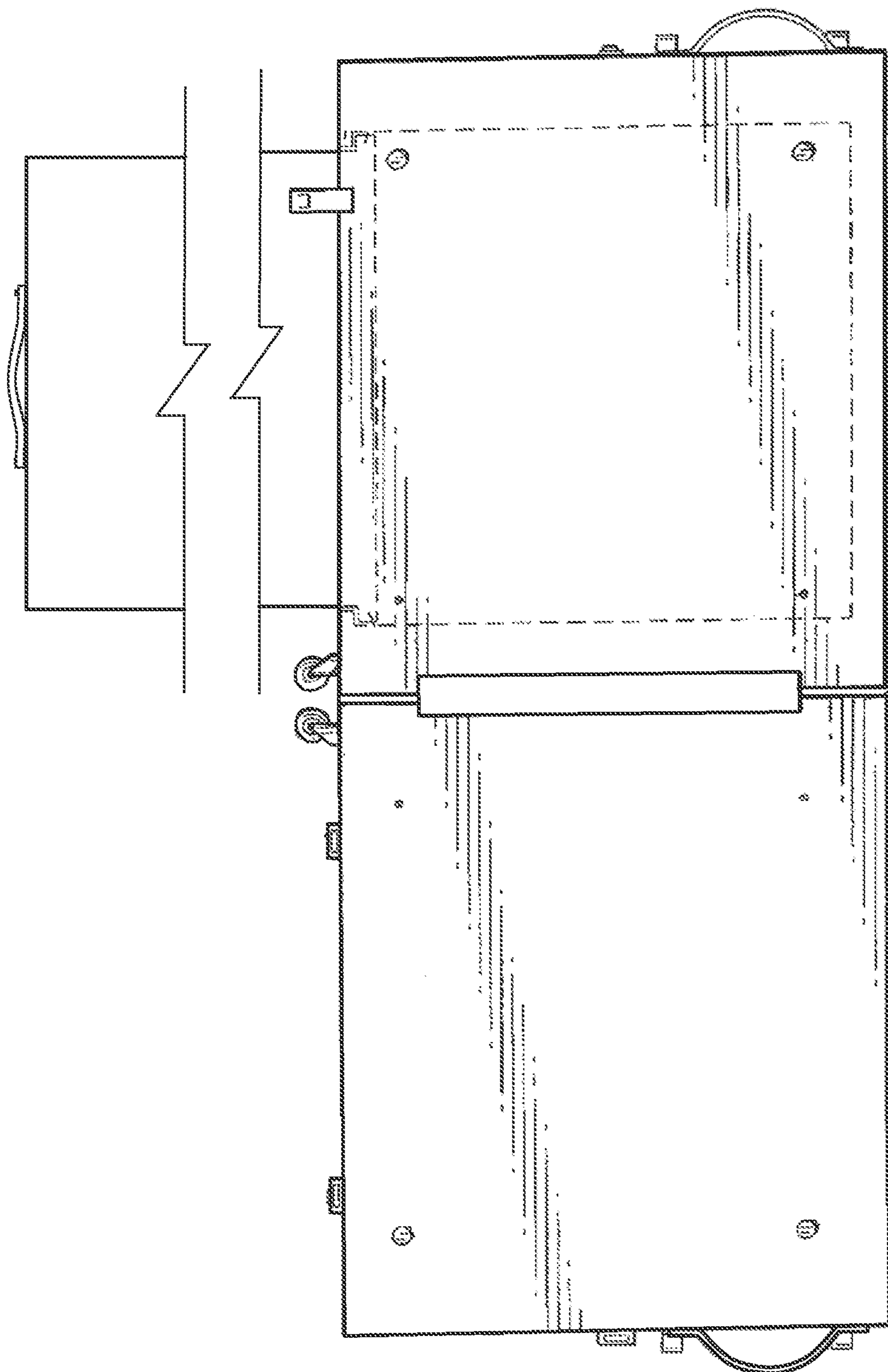

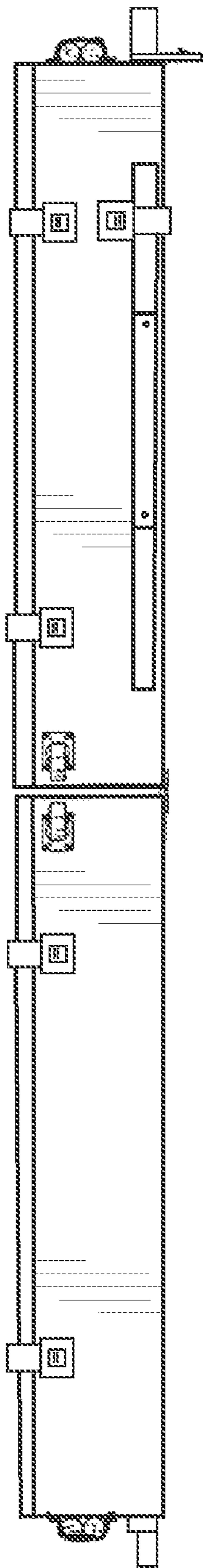

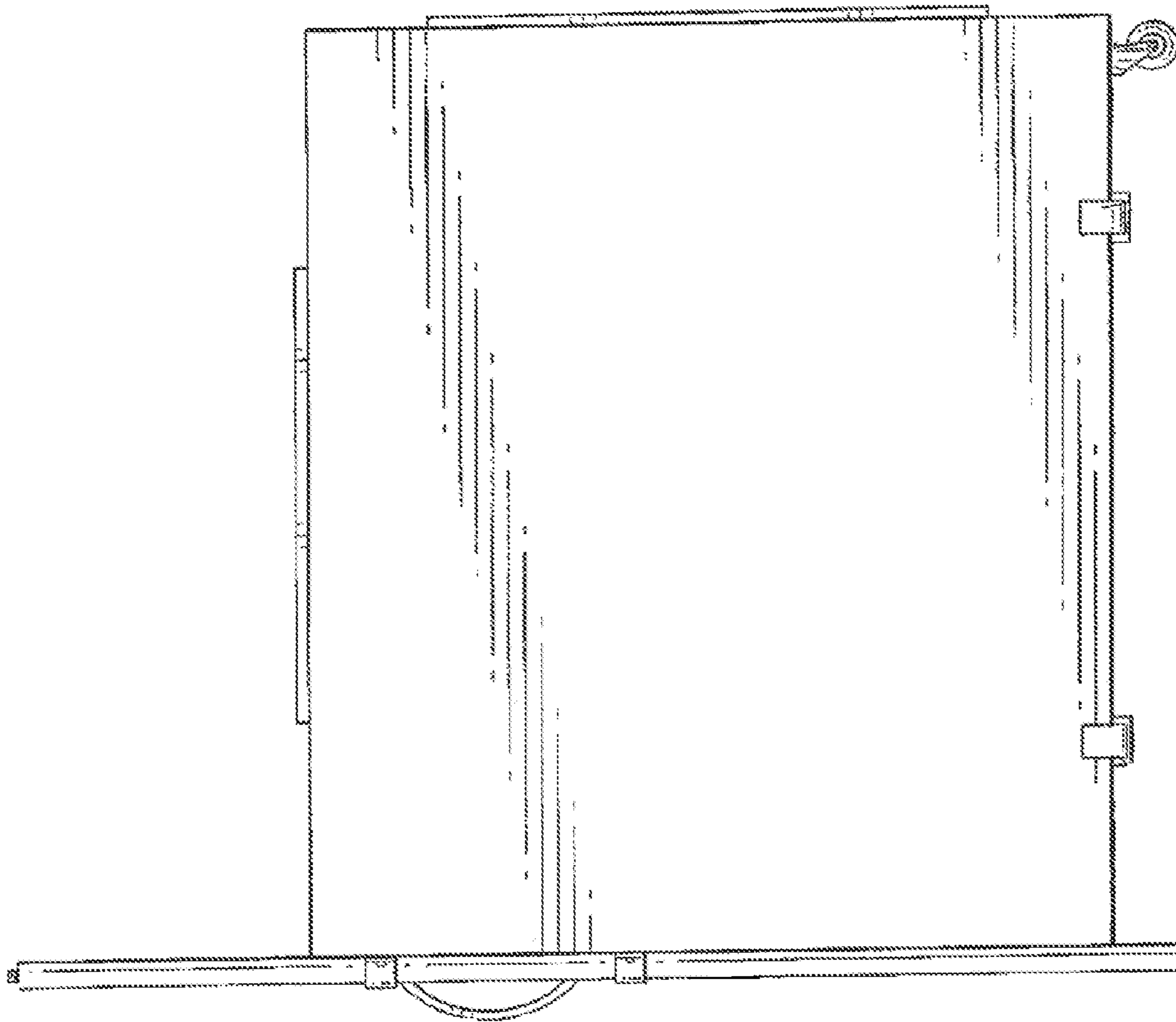

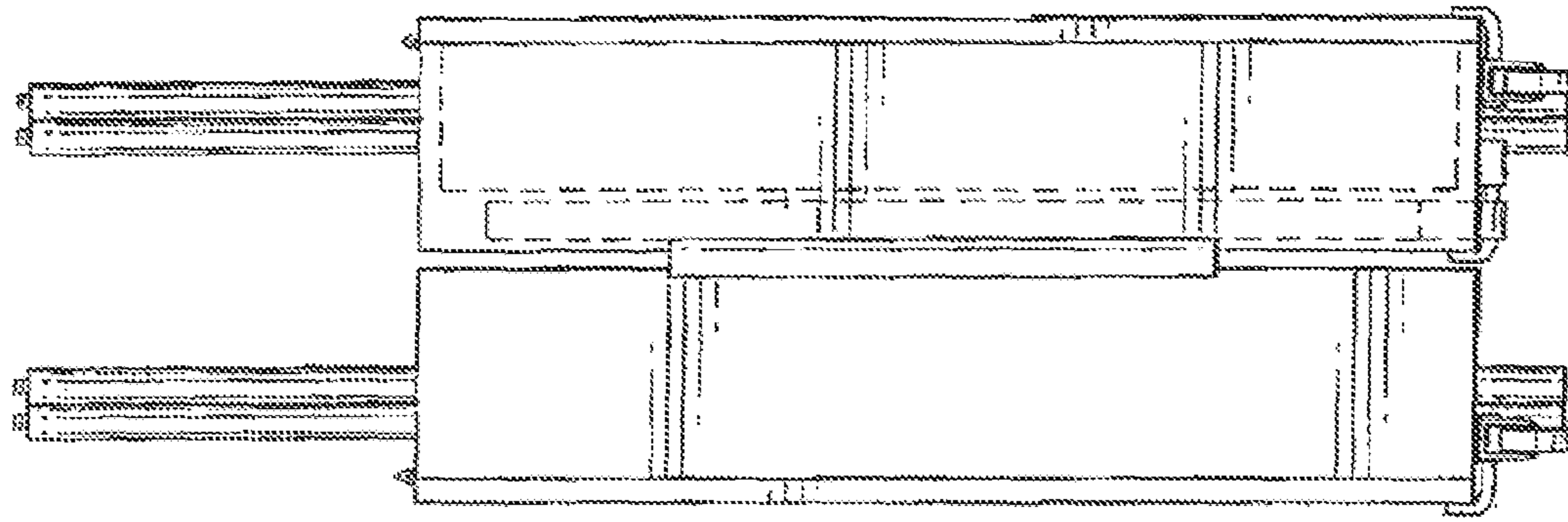

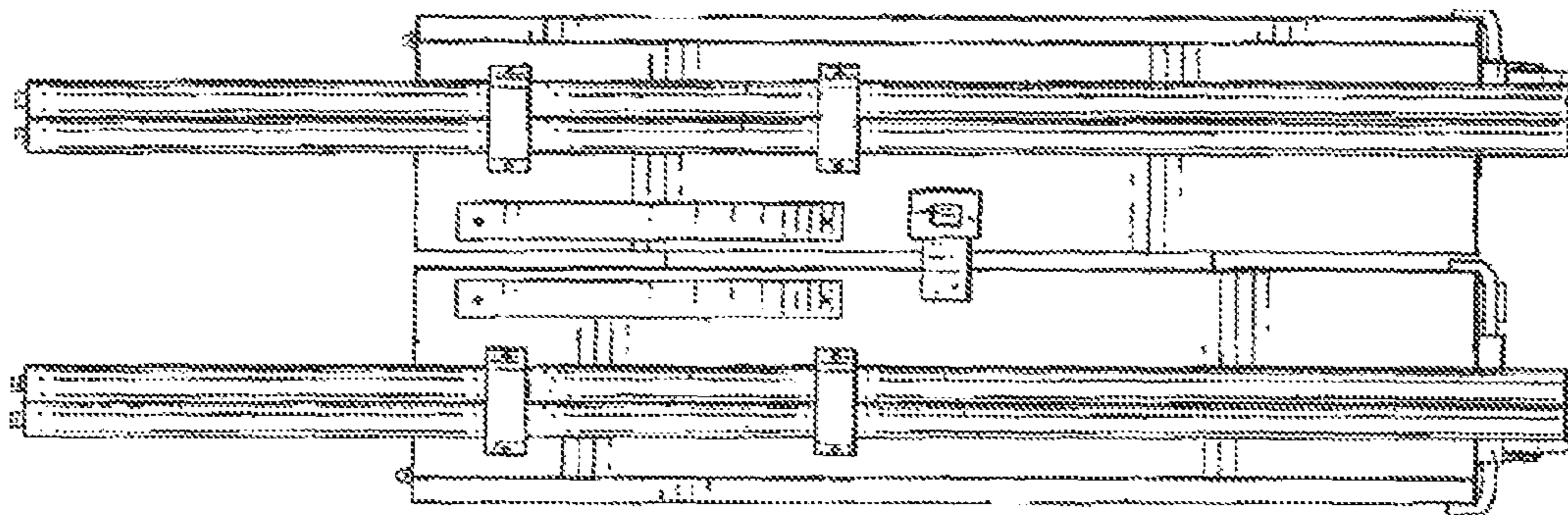
