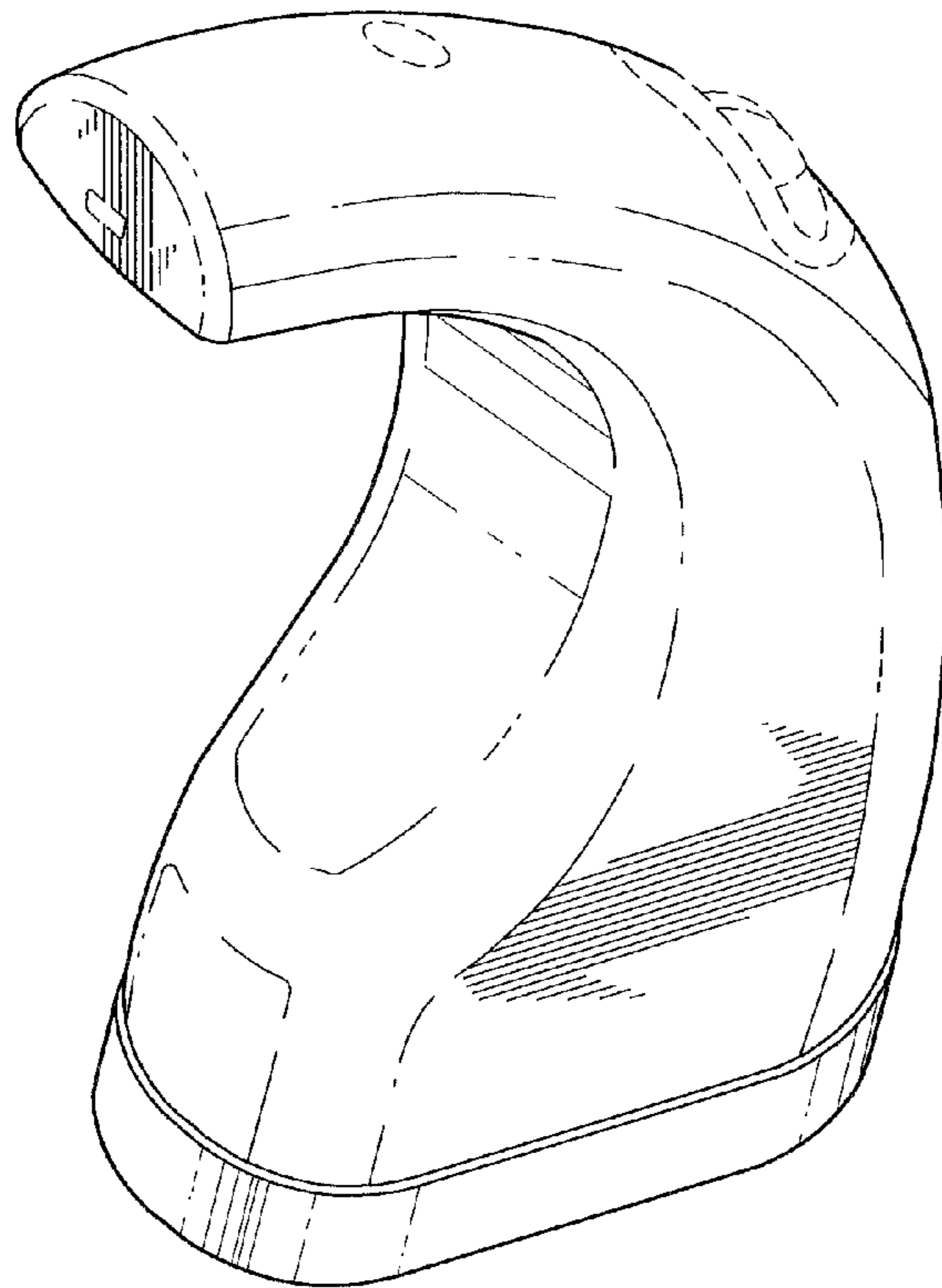

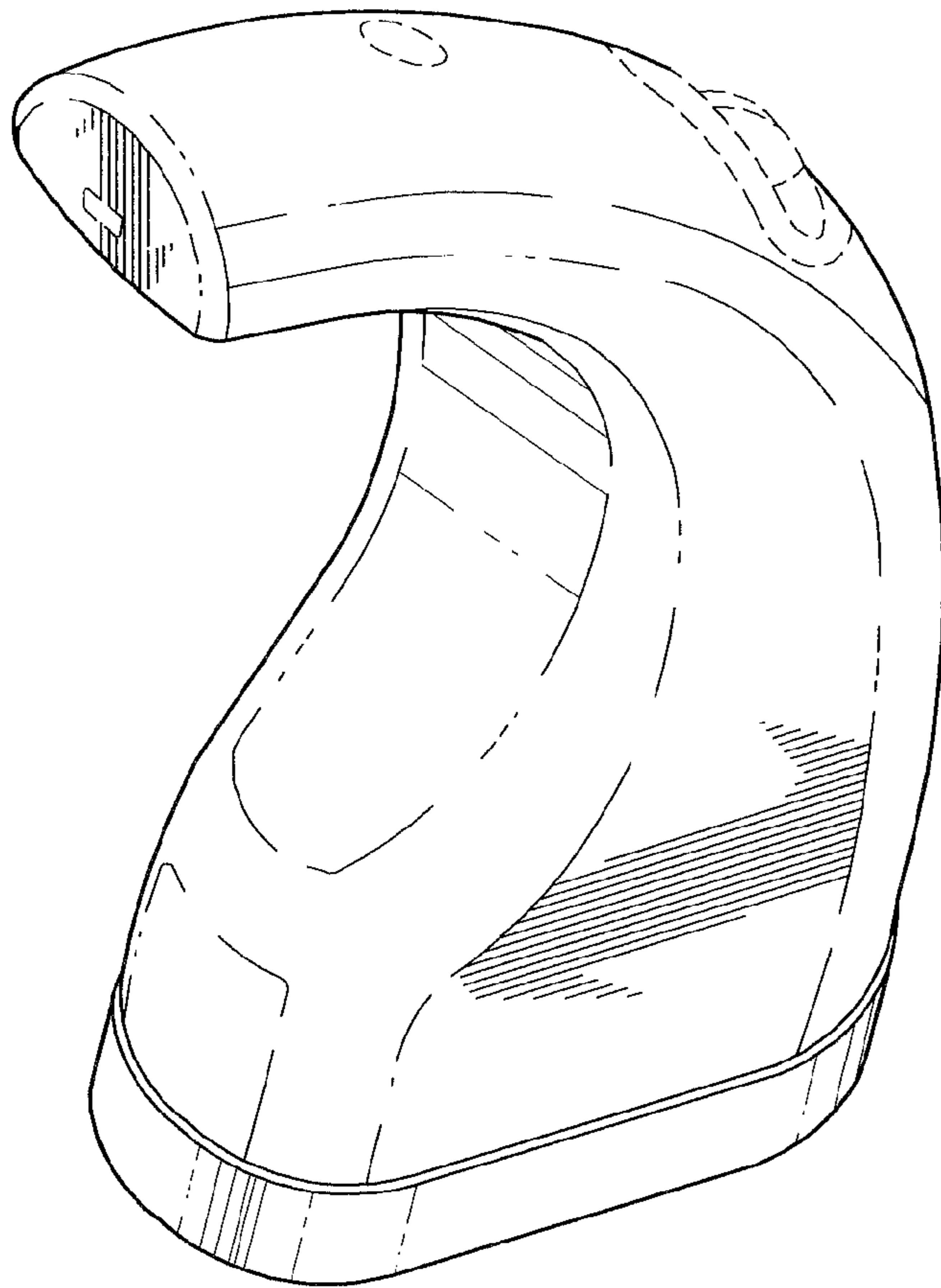
I claim the ornamental design for a soap dispenser, as shown and described.

**DESCRIPTION**

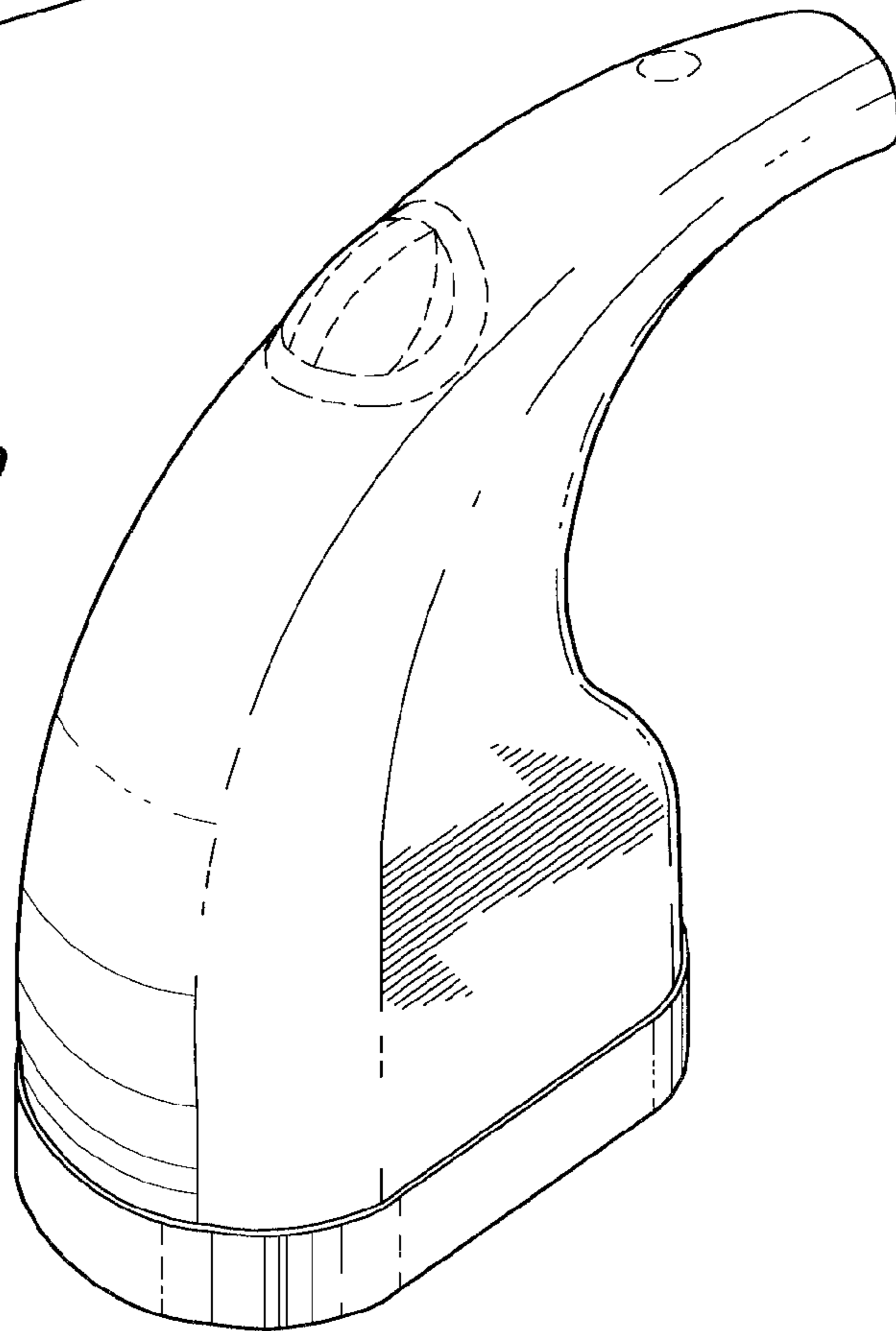
FIG. 1 is a top left perspective view of a soap dispenser.

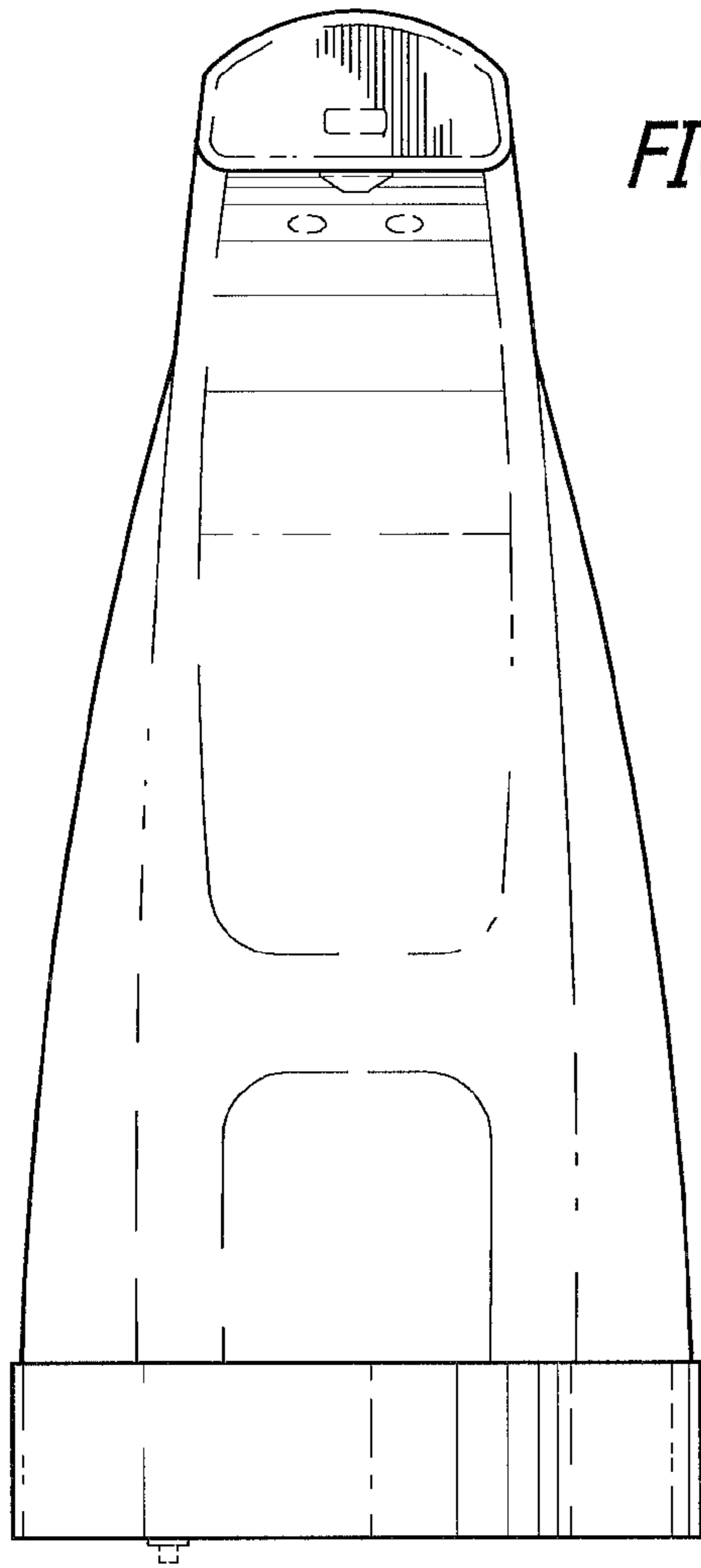




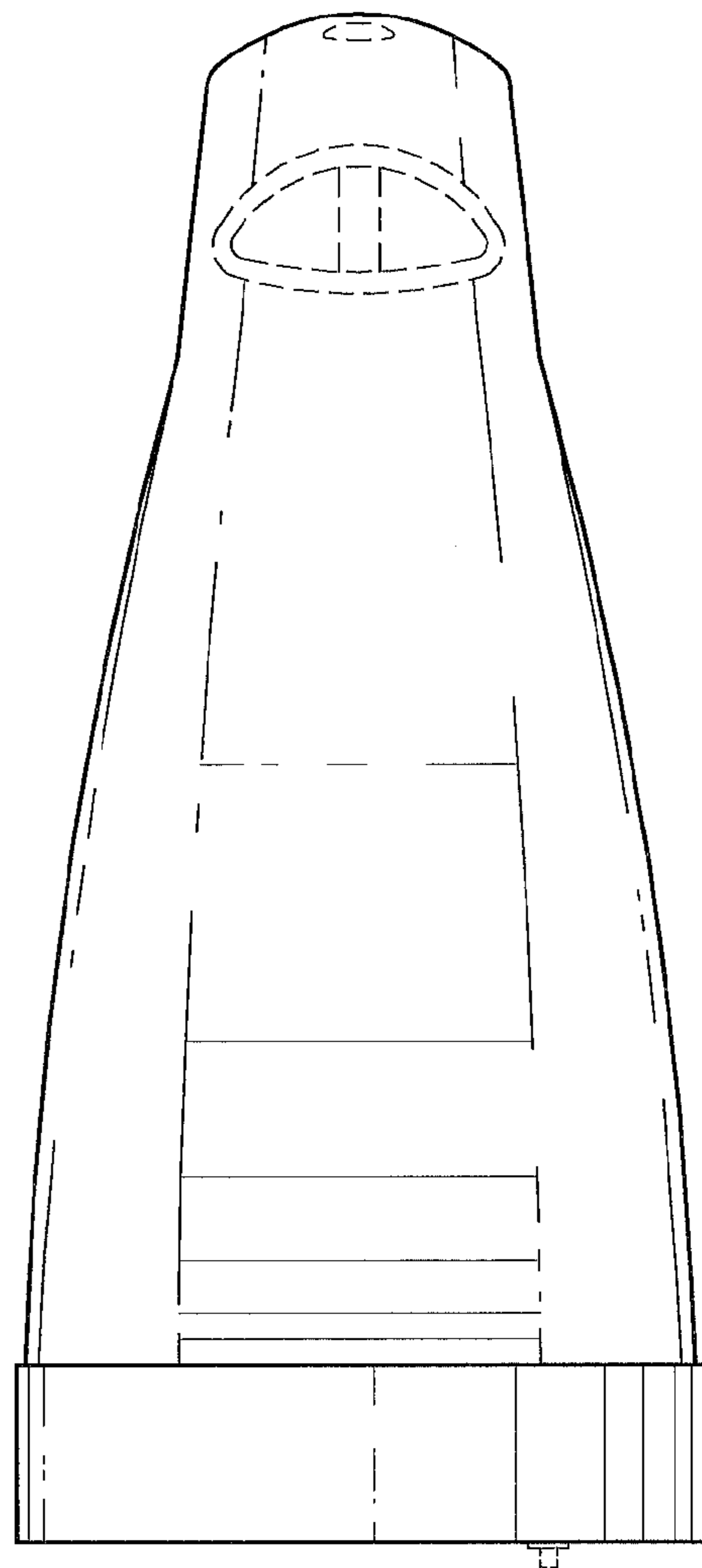

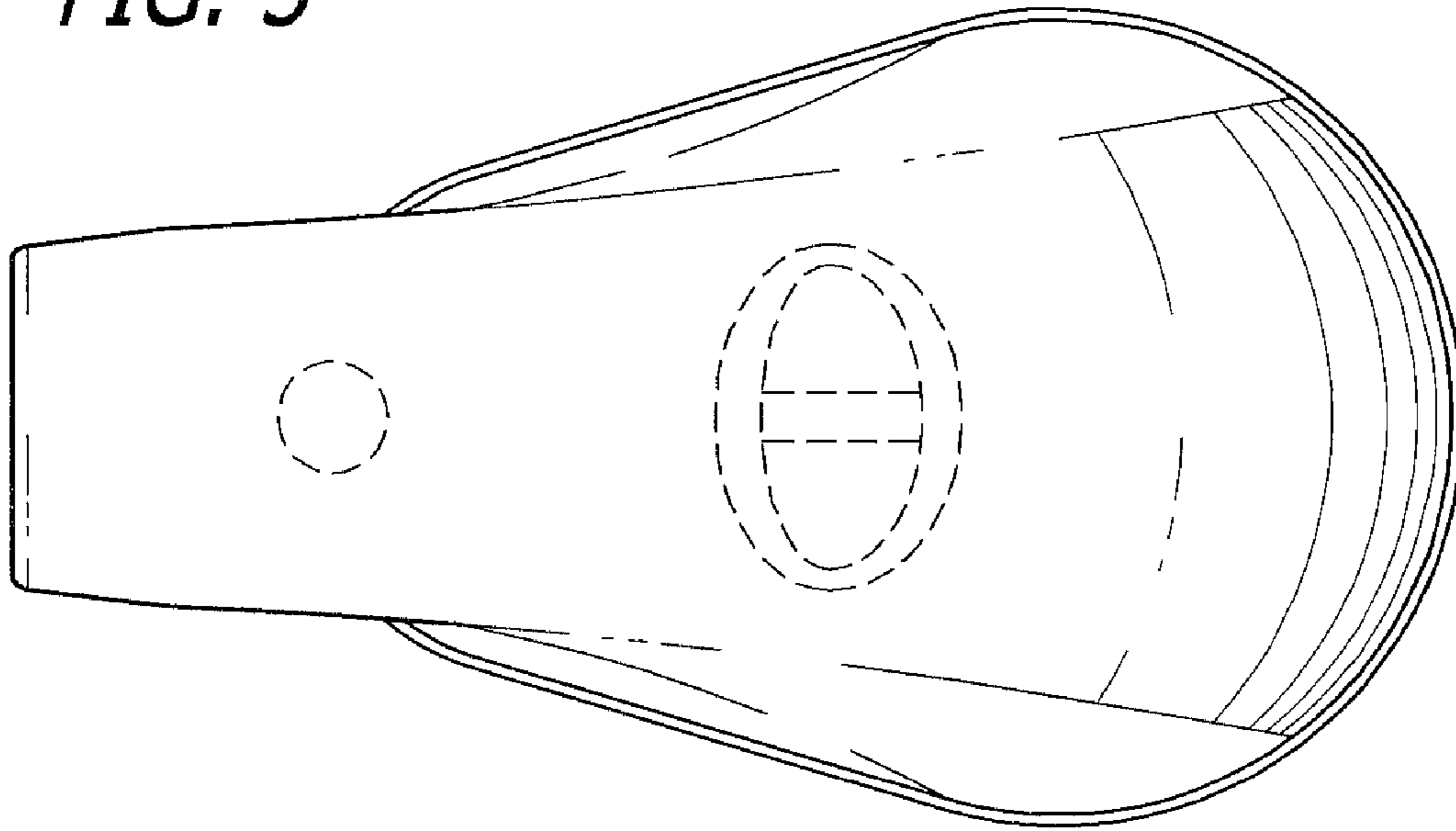

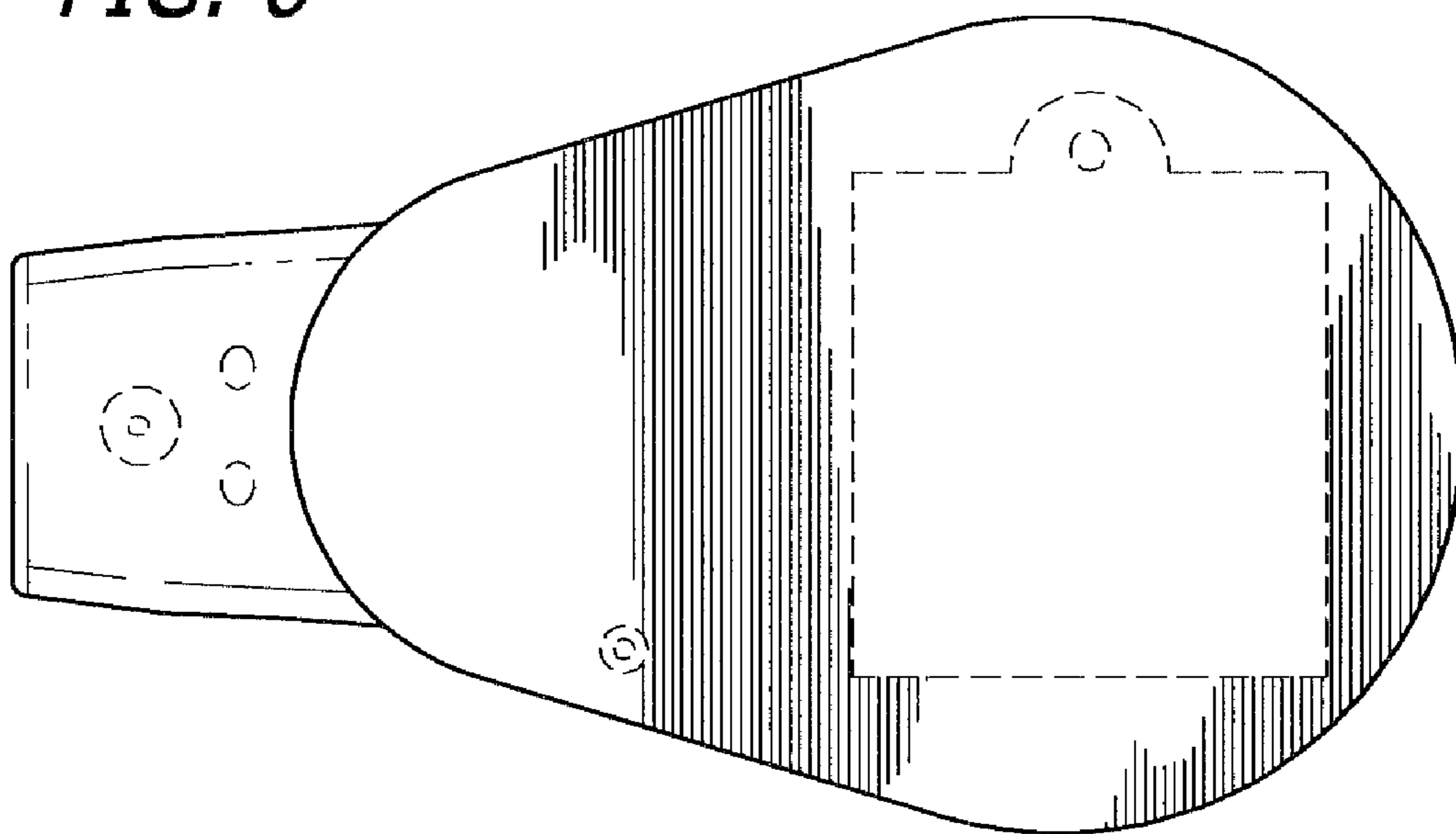

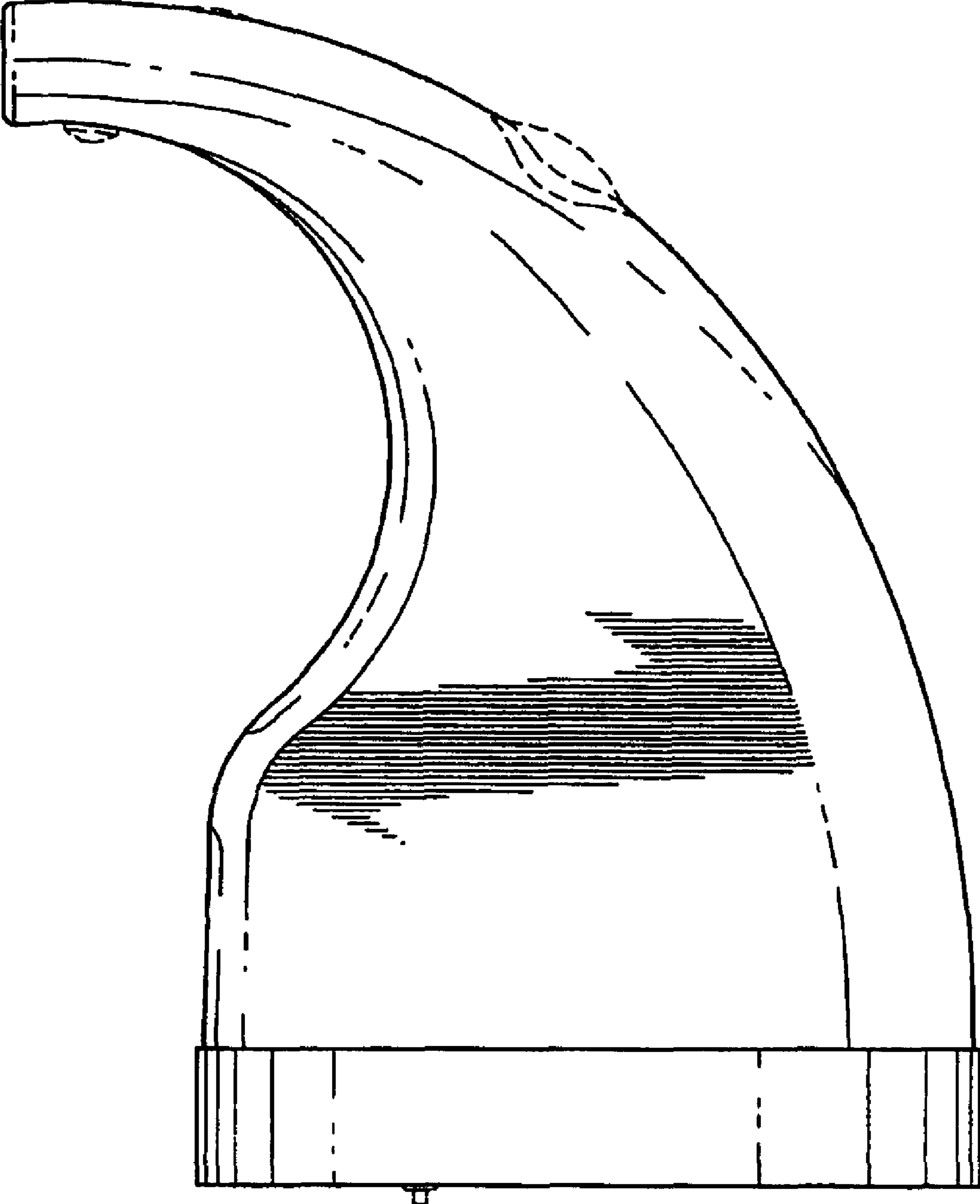
