(57) **CLAIM**

The ornamental design for a barbecue implement with multi tone hand grip, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a barbecue implement with multi tone hand grip showing my new design, the opposite side being a mirror image thereof;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.

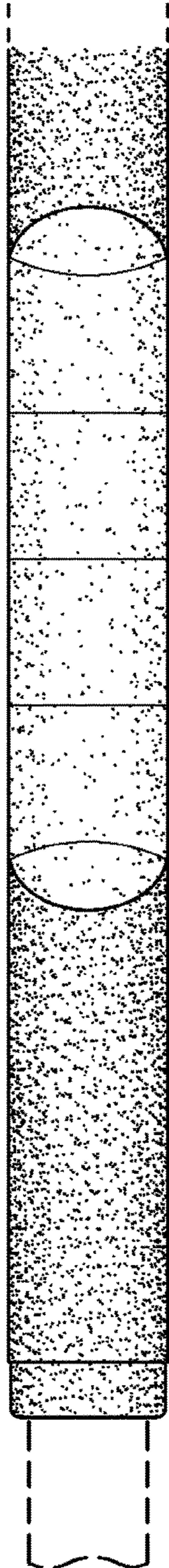

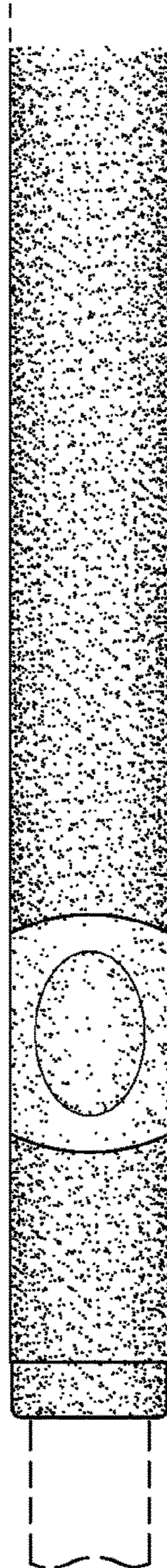
