FIG. 8 is a bottom plan view thereof.

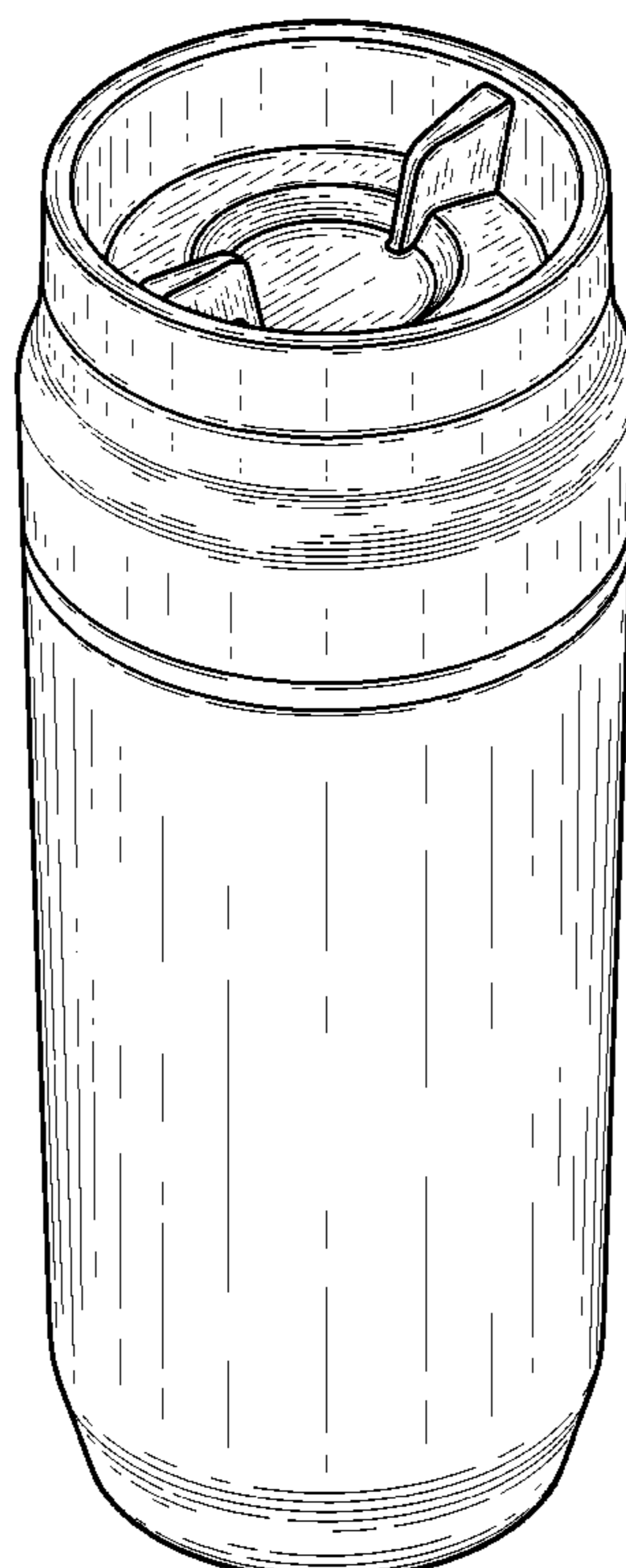
The broken lines represent portions of the beverage container that form no part of the claim.

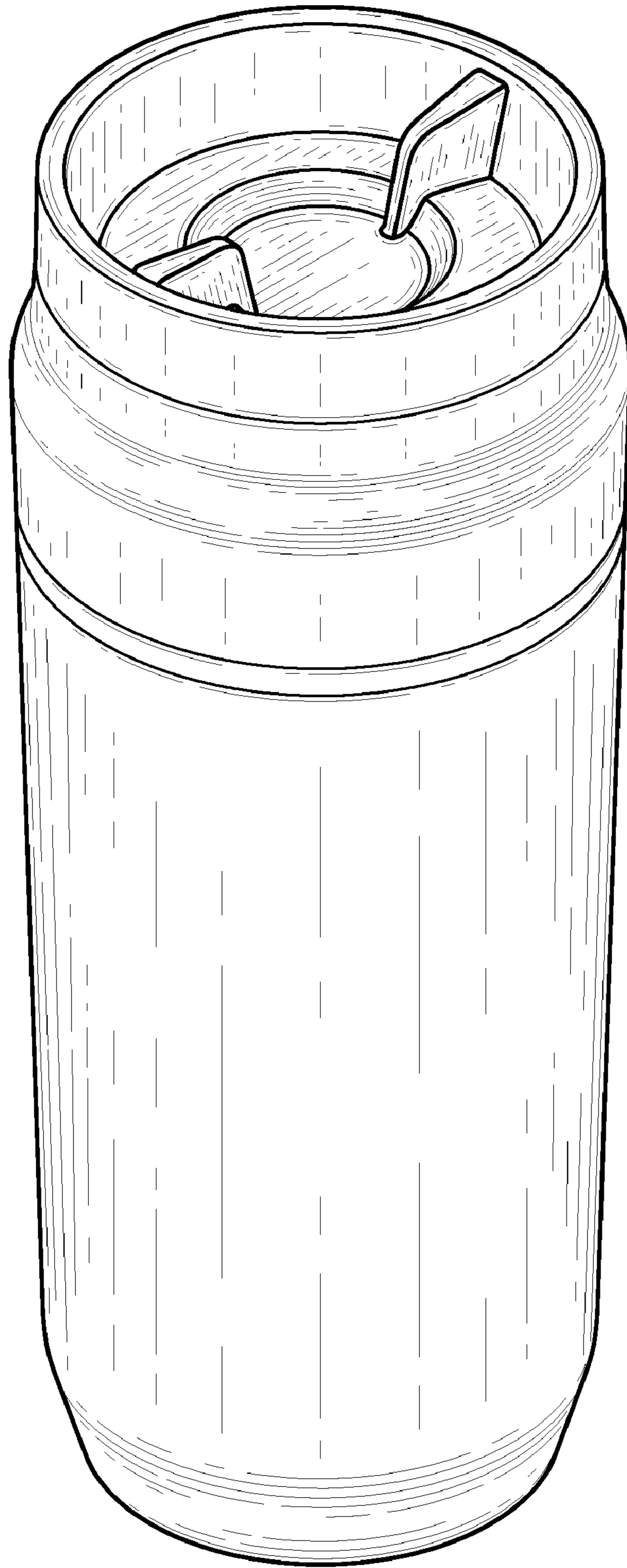

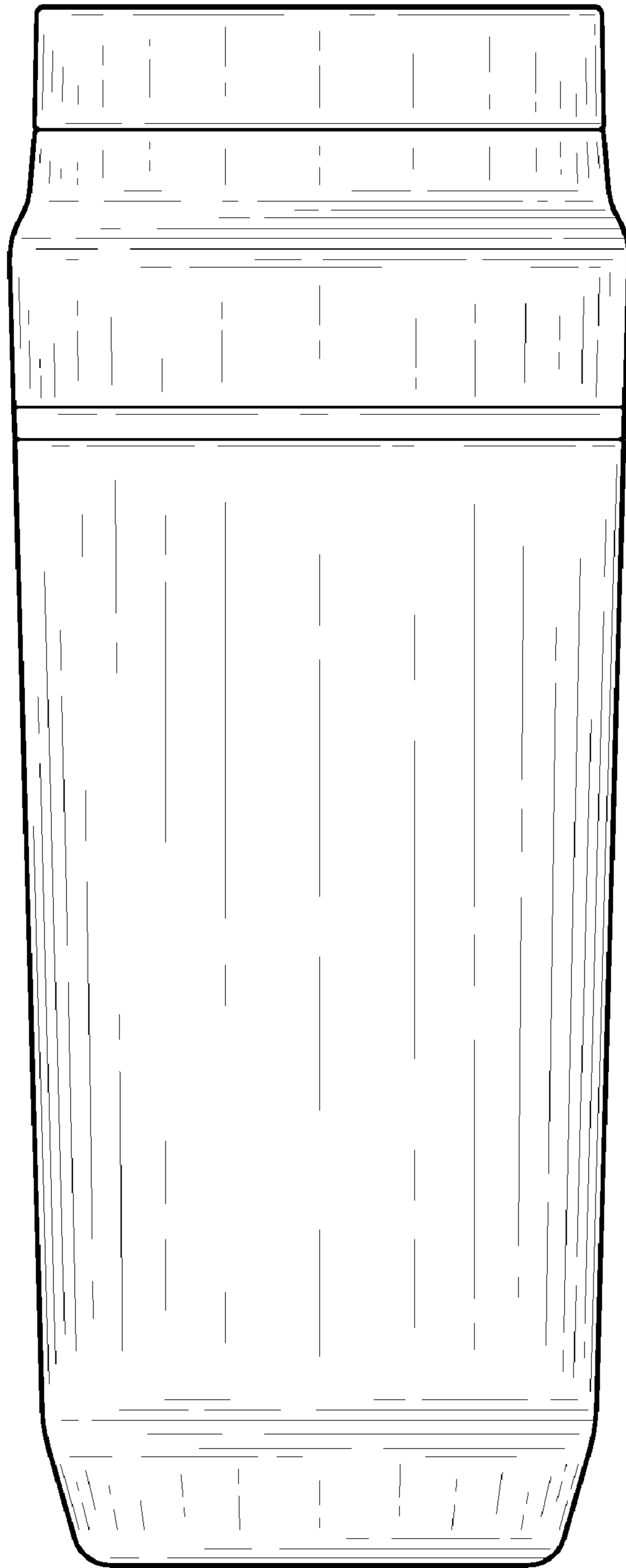

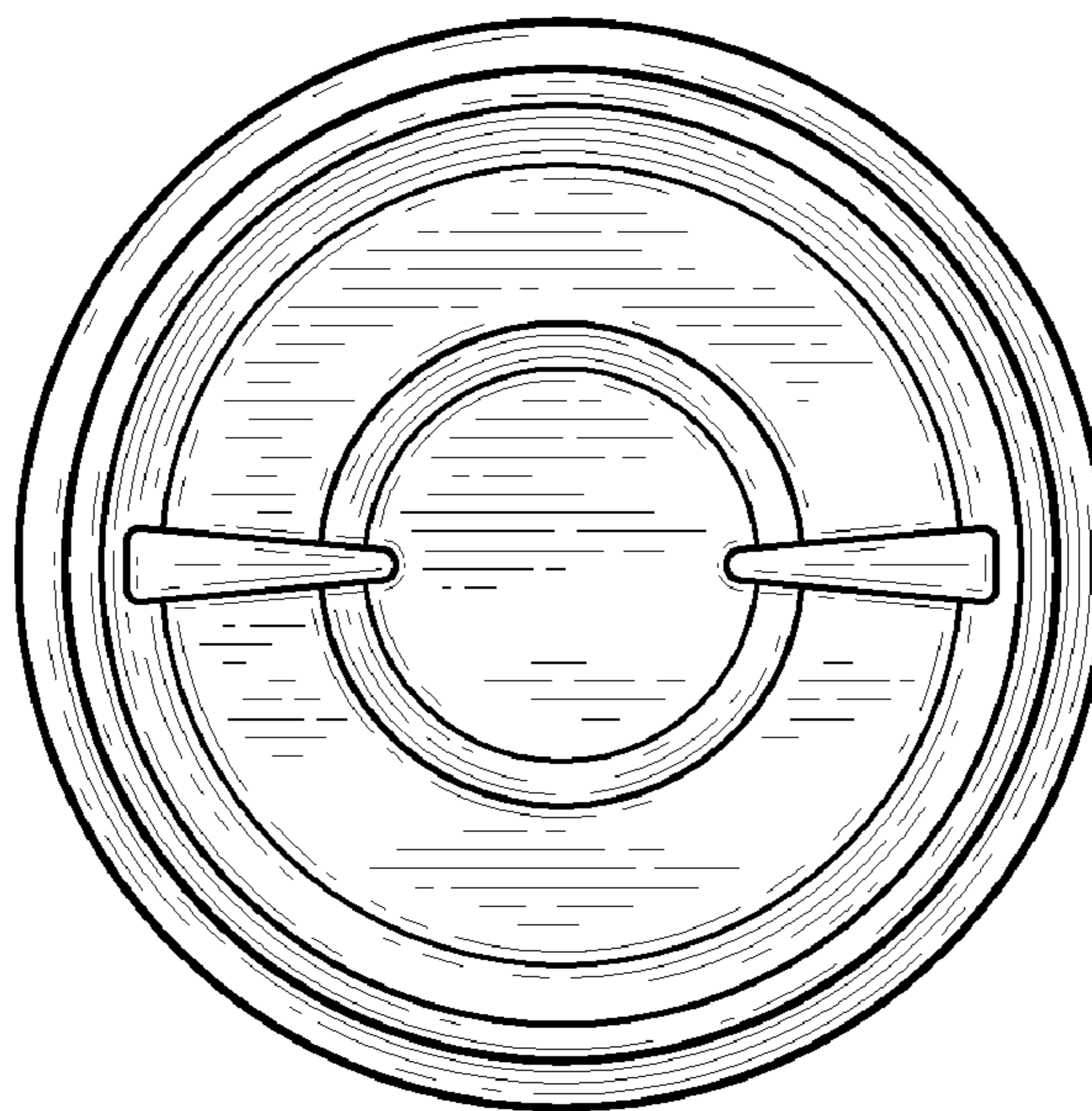

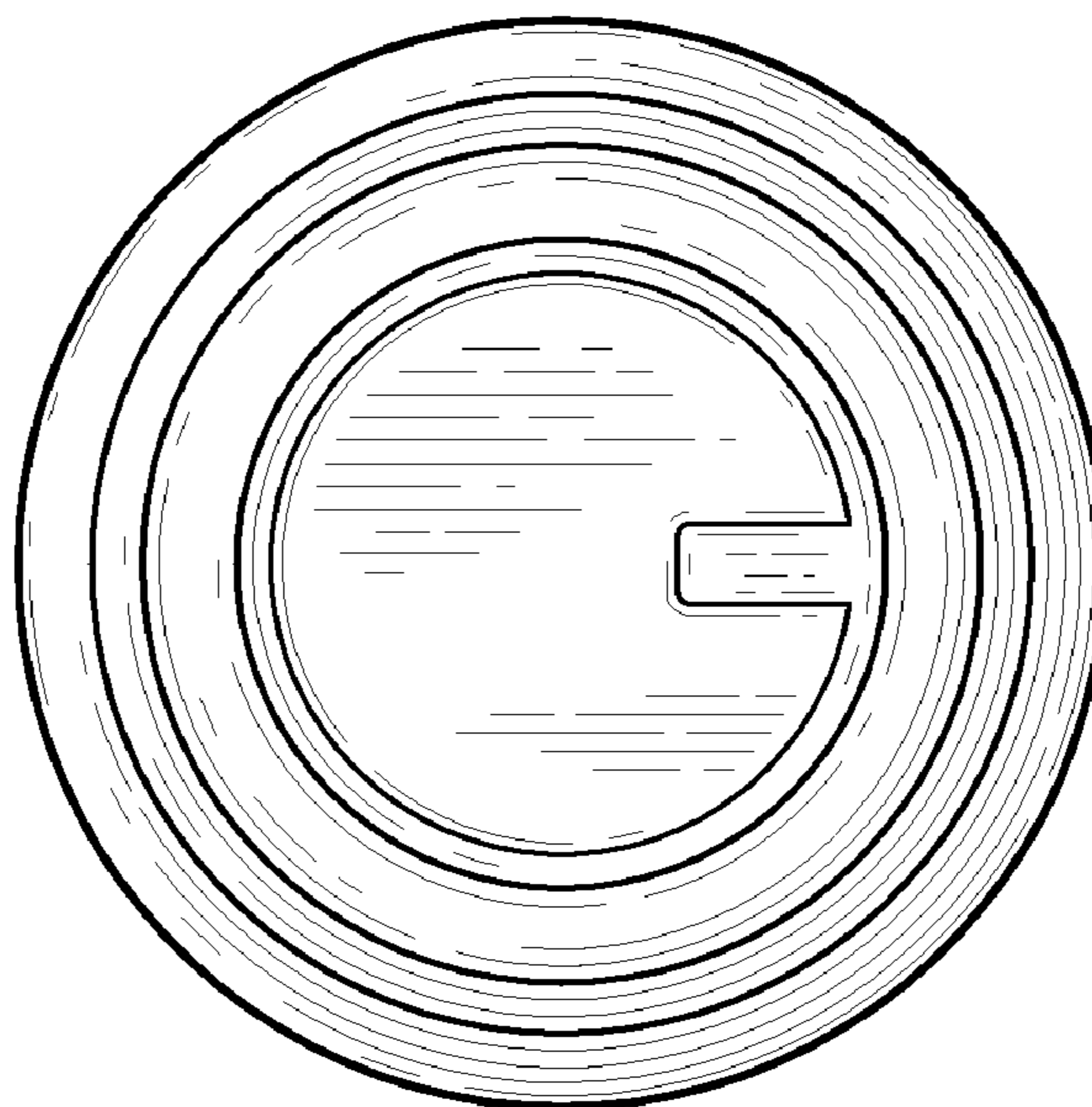

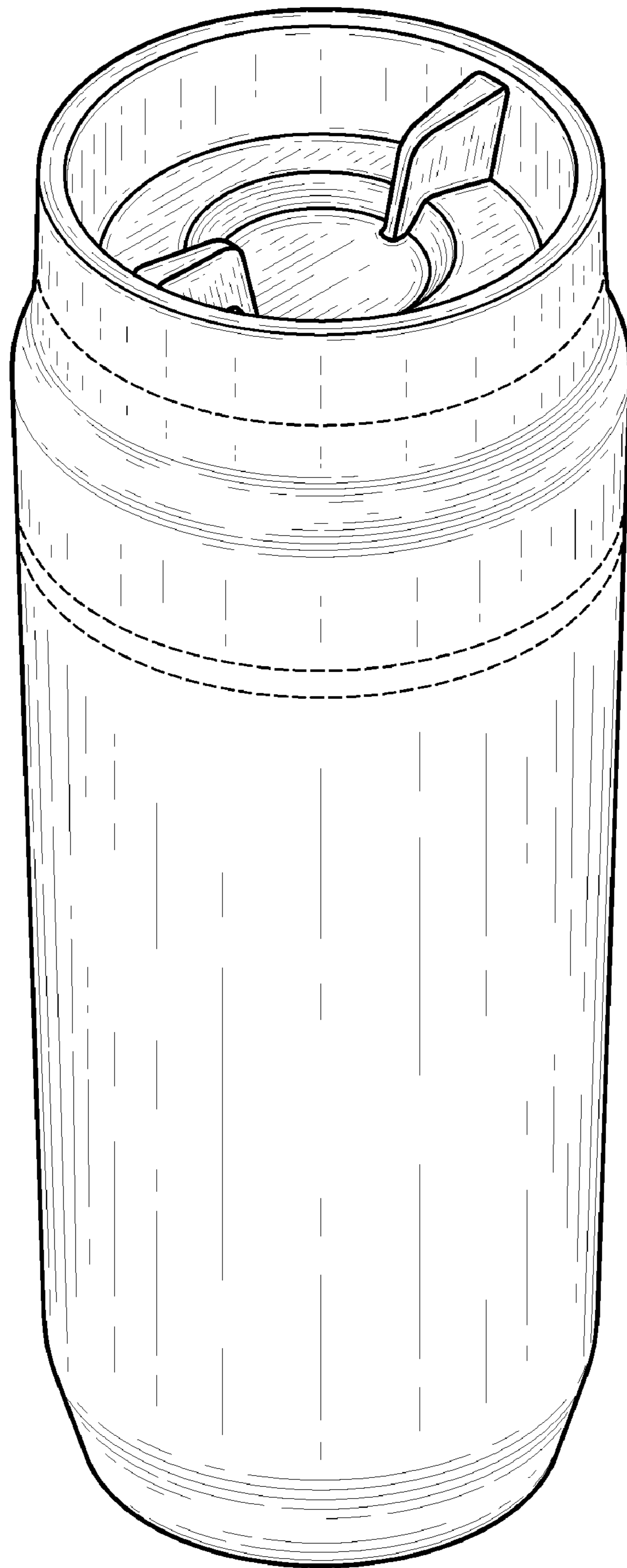

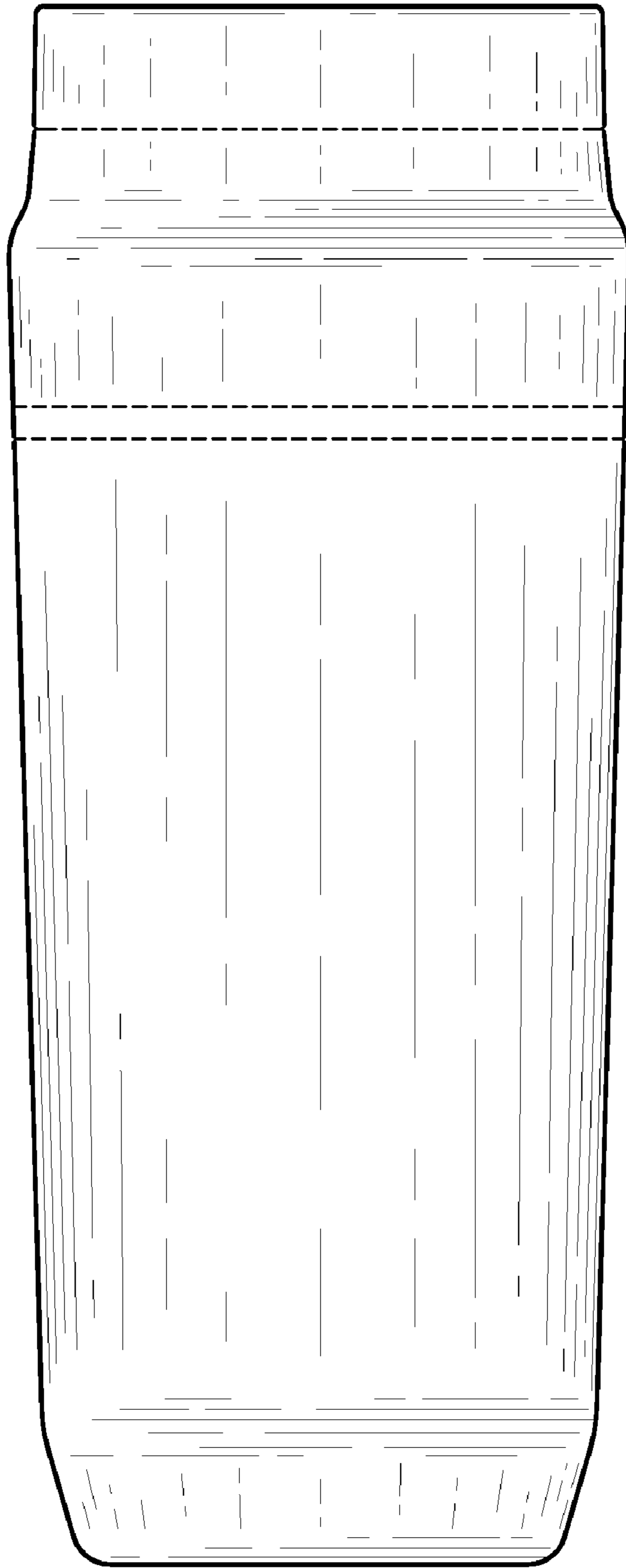

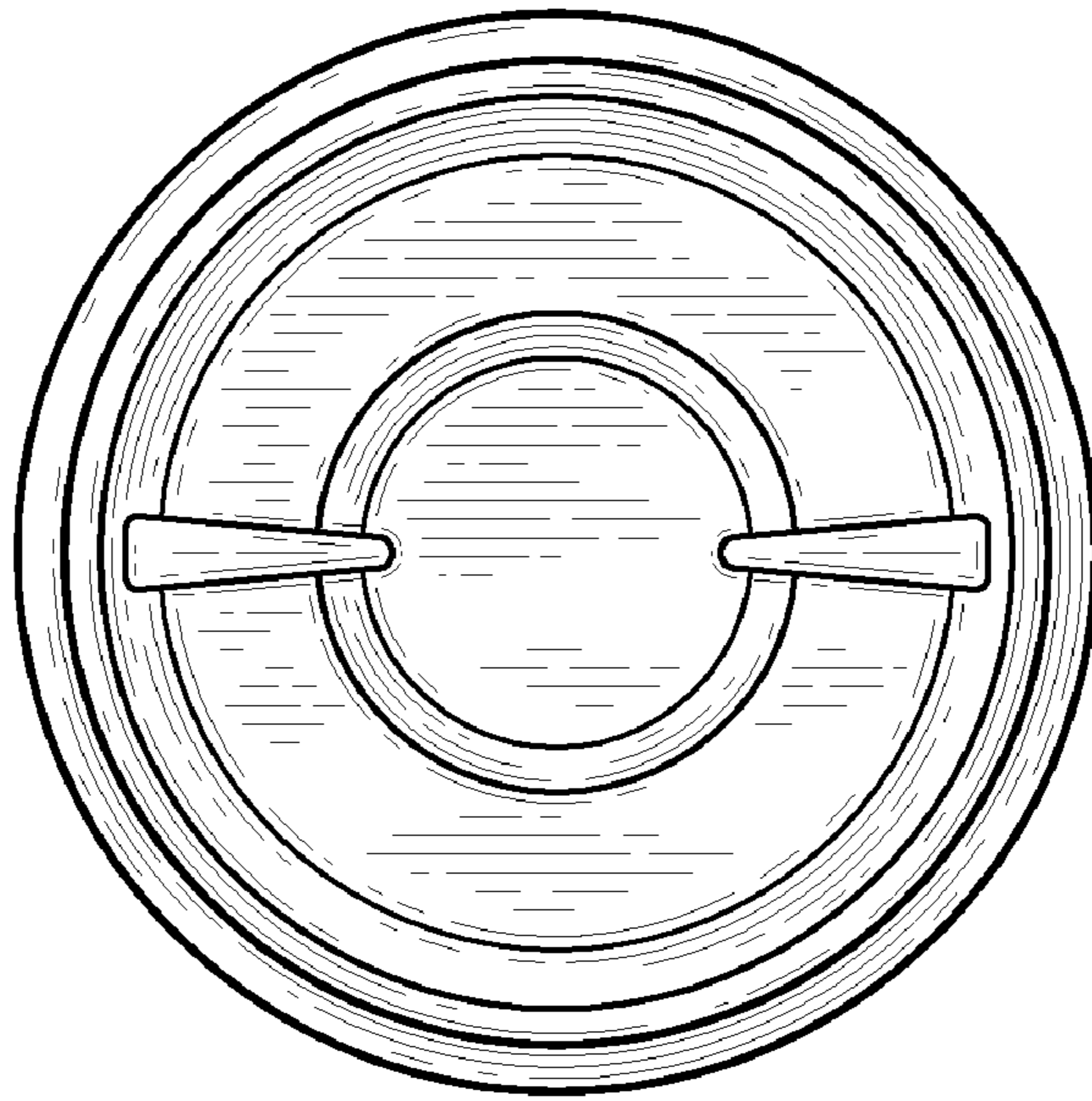

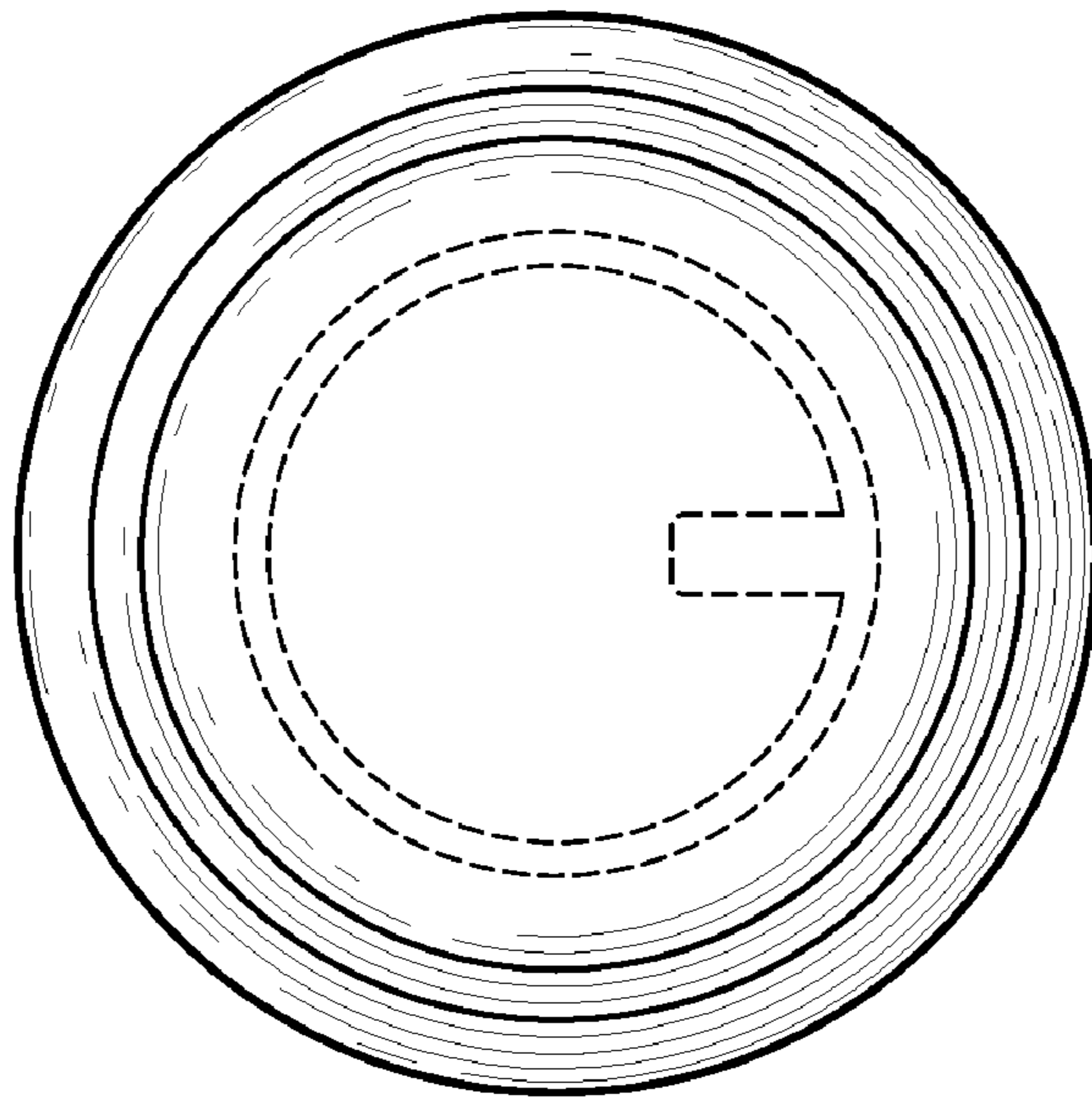
