FIG. 1 is a top view of the fruit catching net and frame.

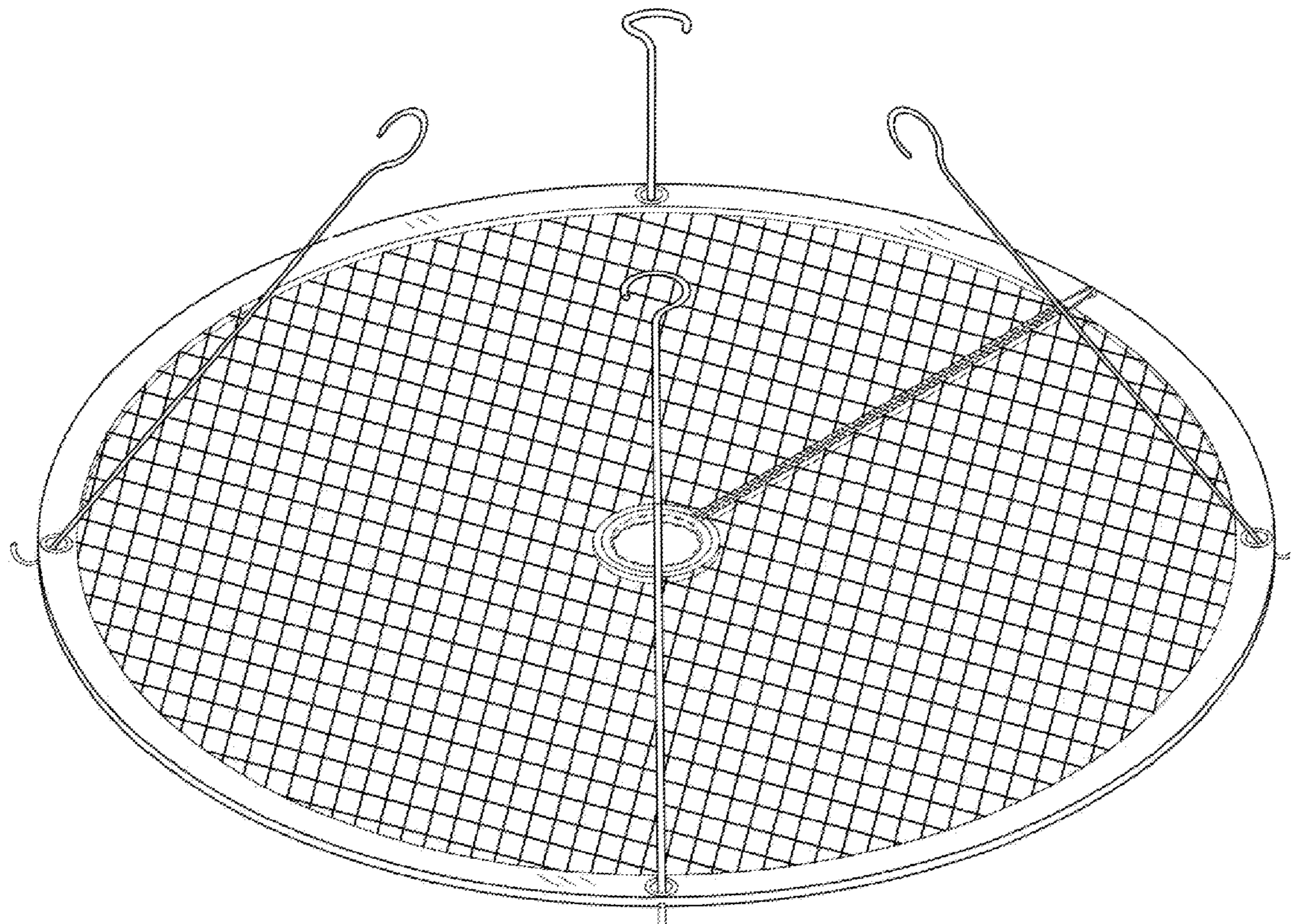
FIG. 2 is a bottom view of the claimed design.

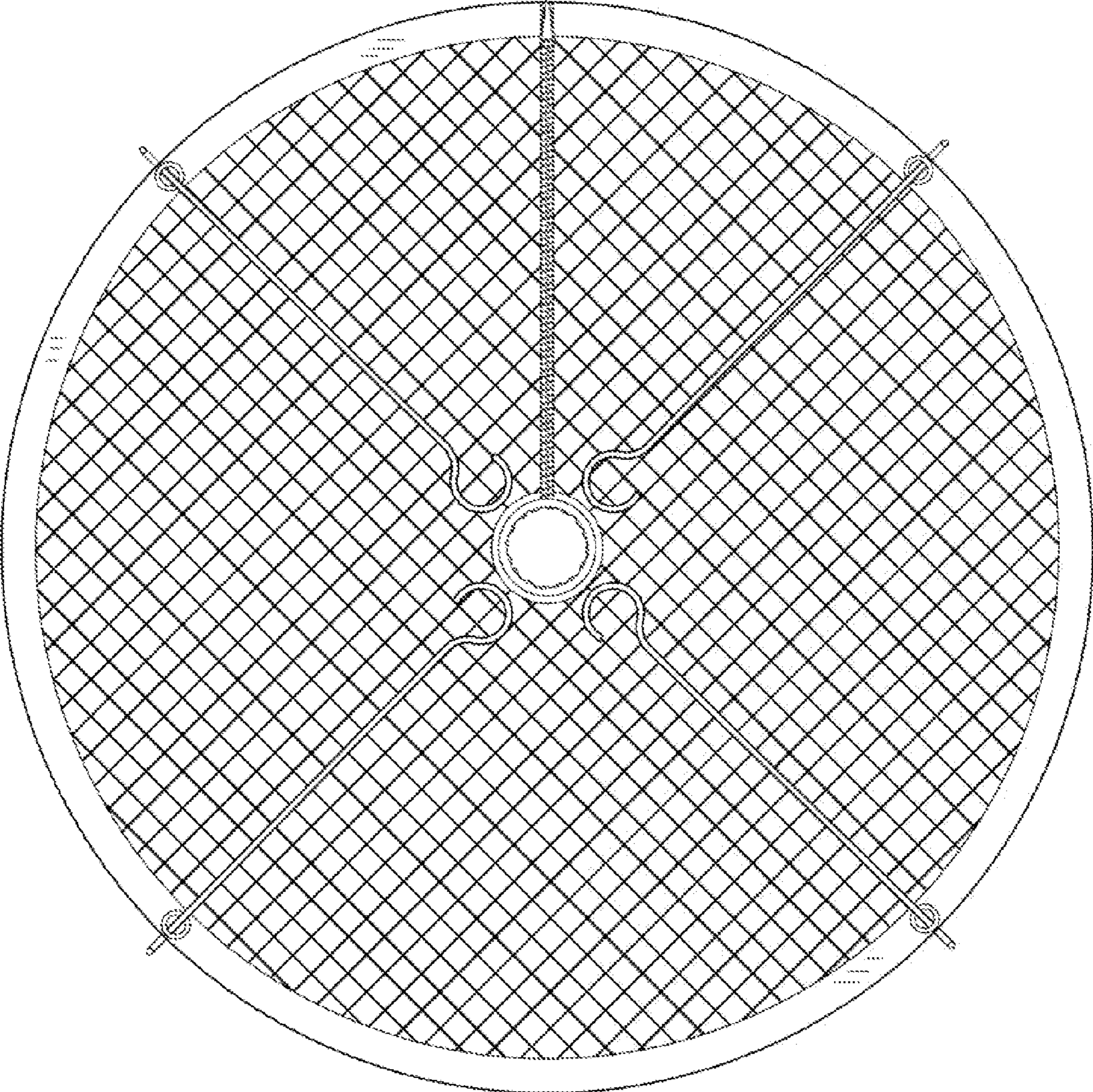

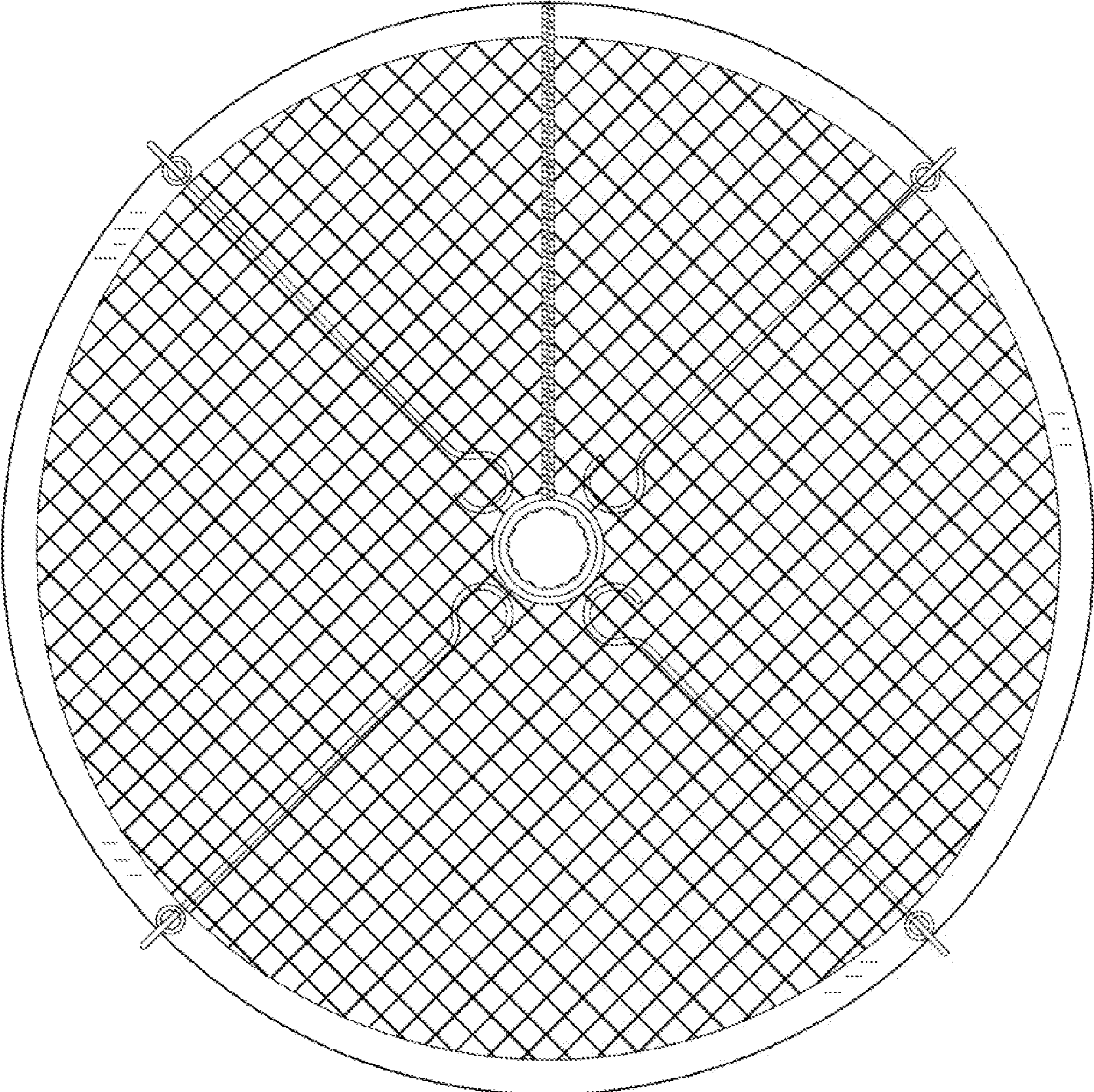

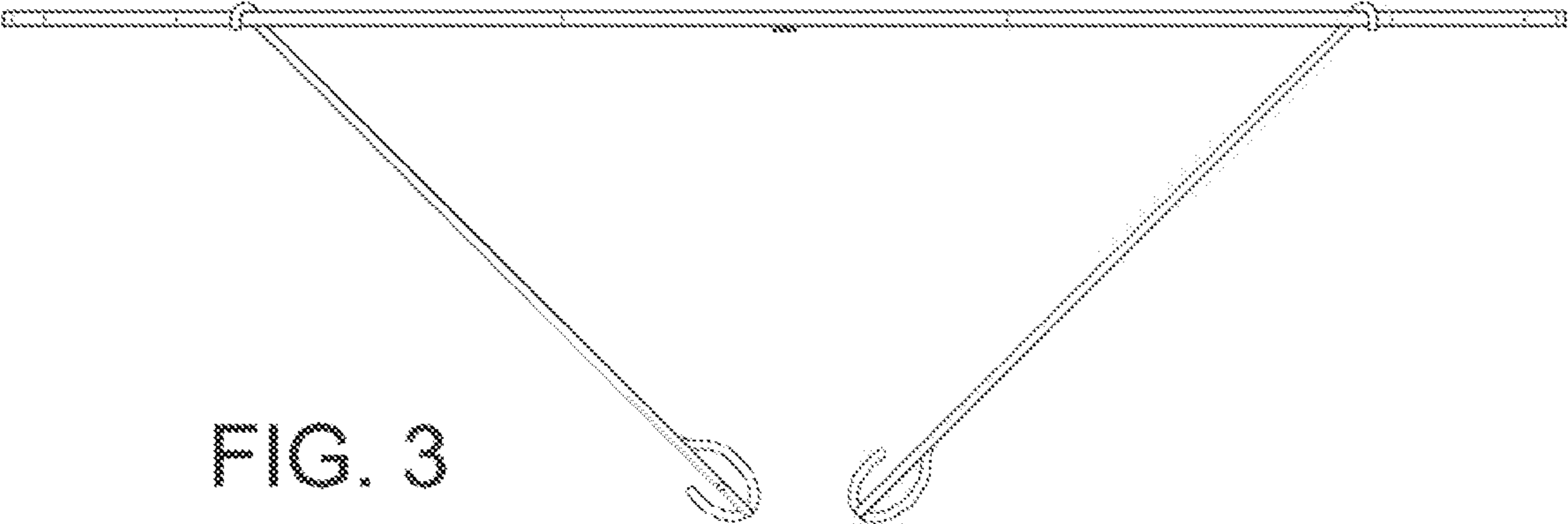

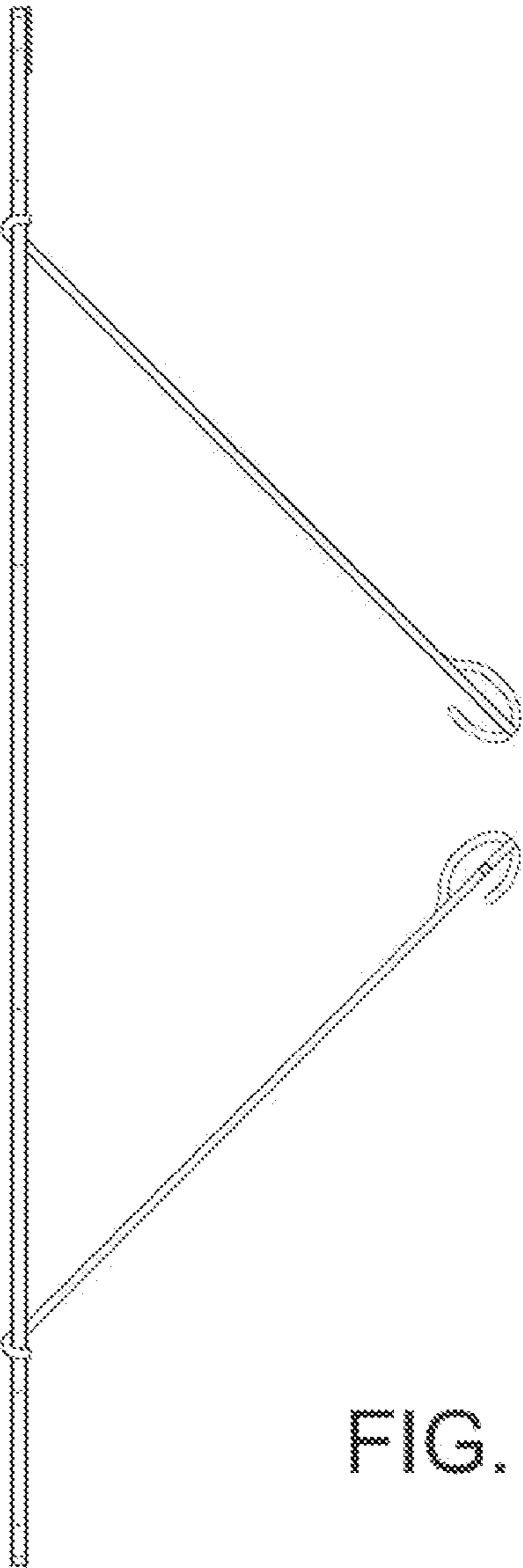

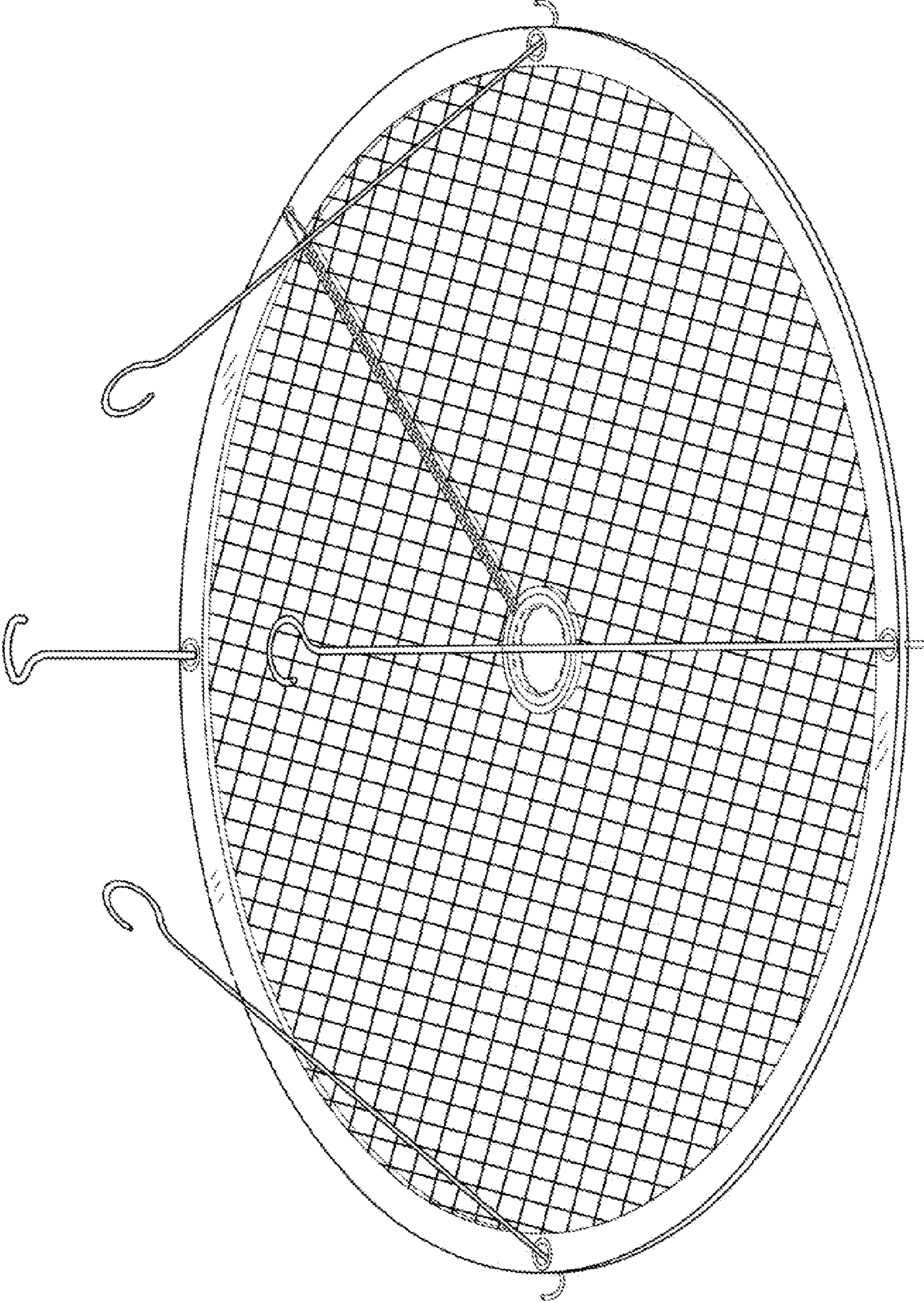
