FIG. 3 is a top view of the high profile corner shield of FIG. 1.

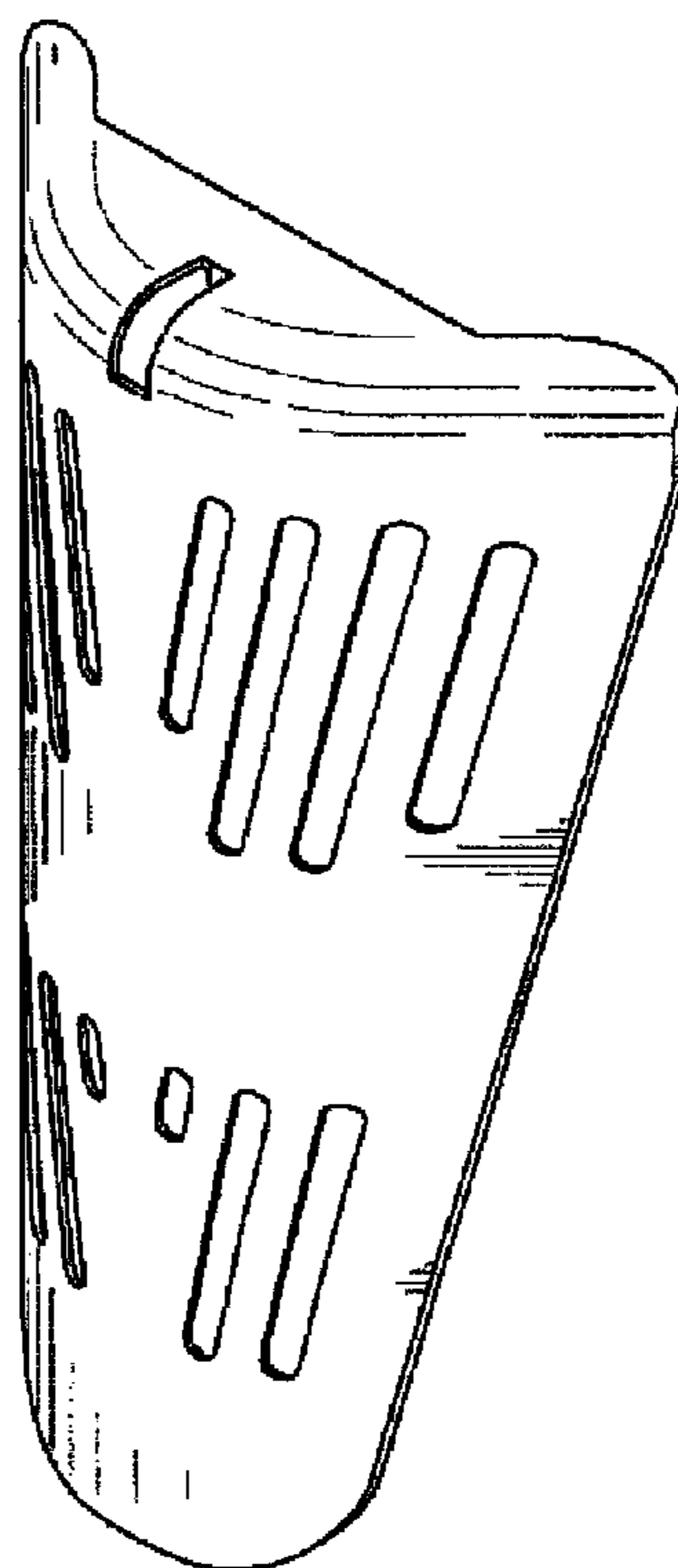
FIG. 4 is a bottom view of the high profile corner shield of FIG. 1.

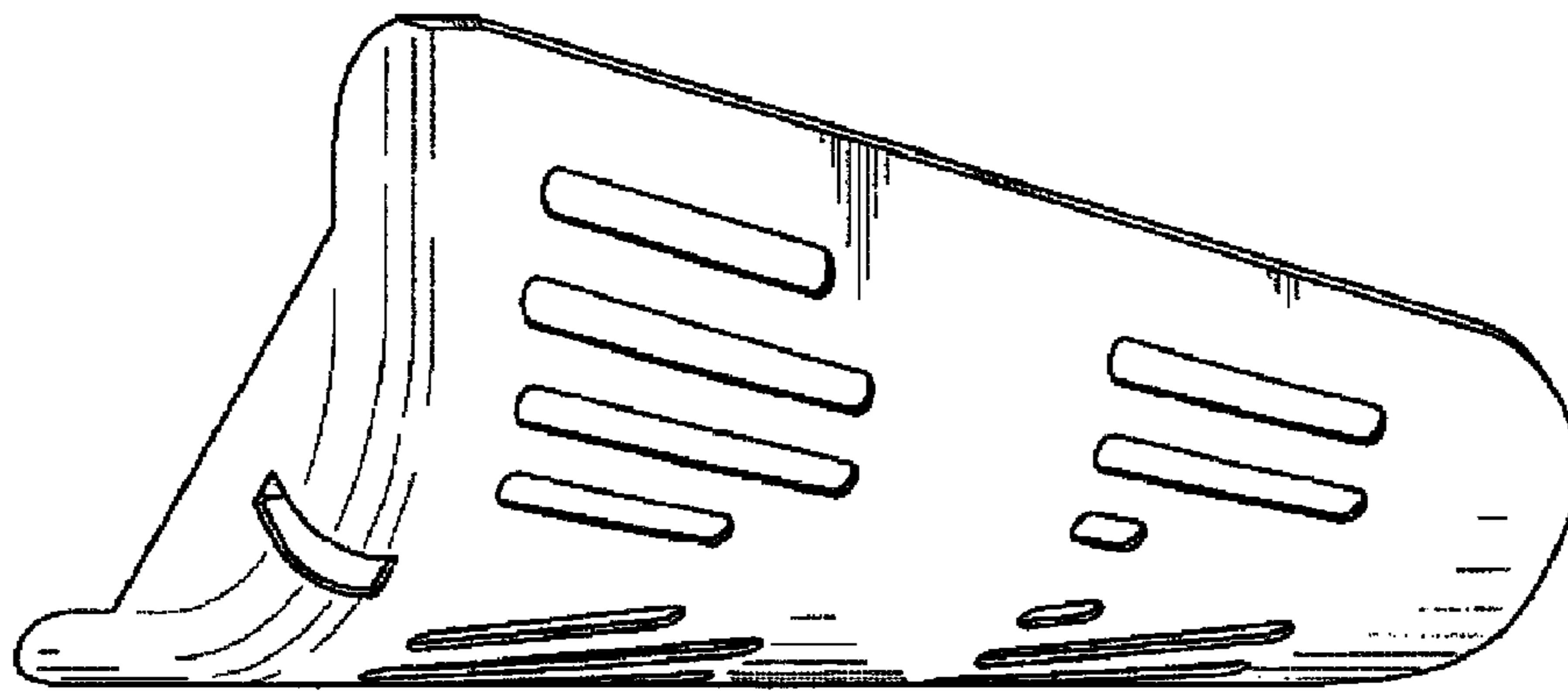

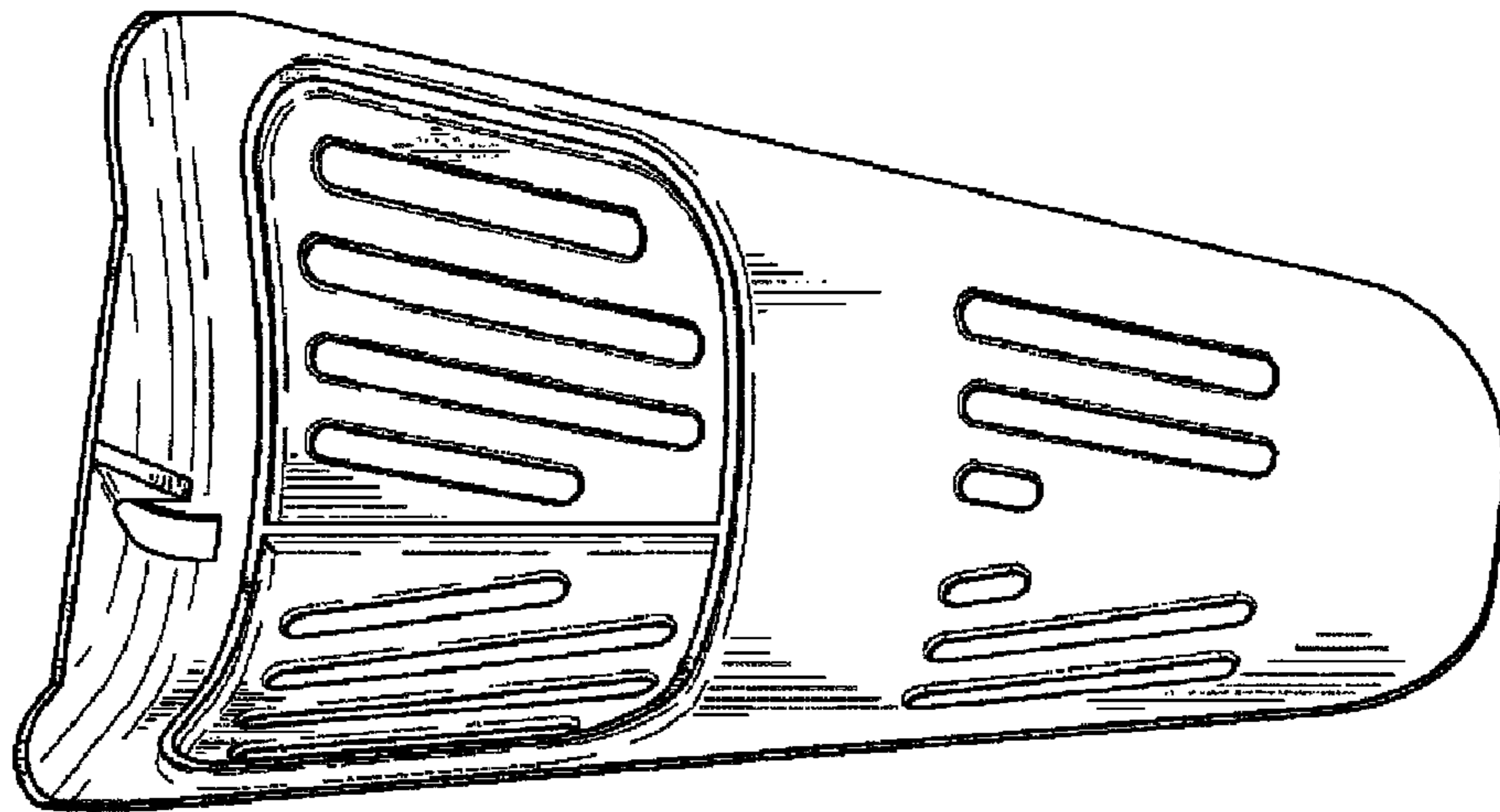

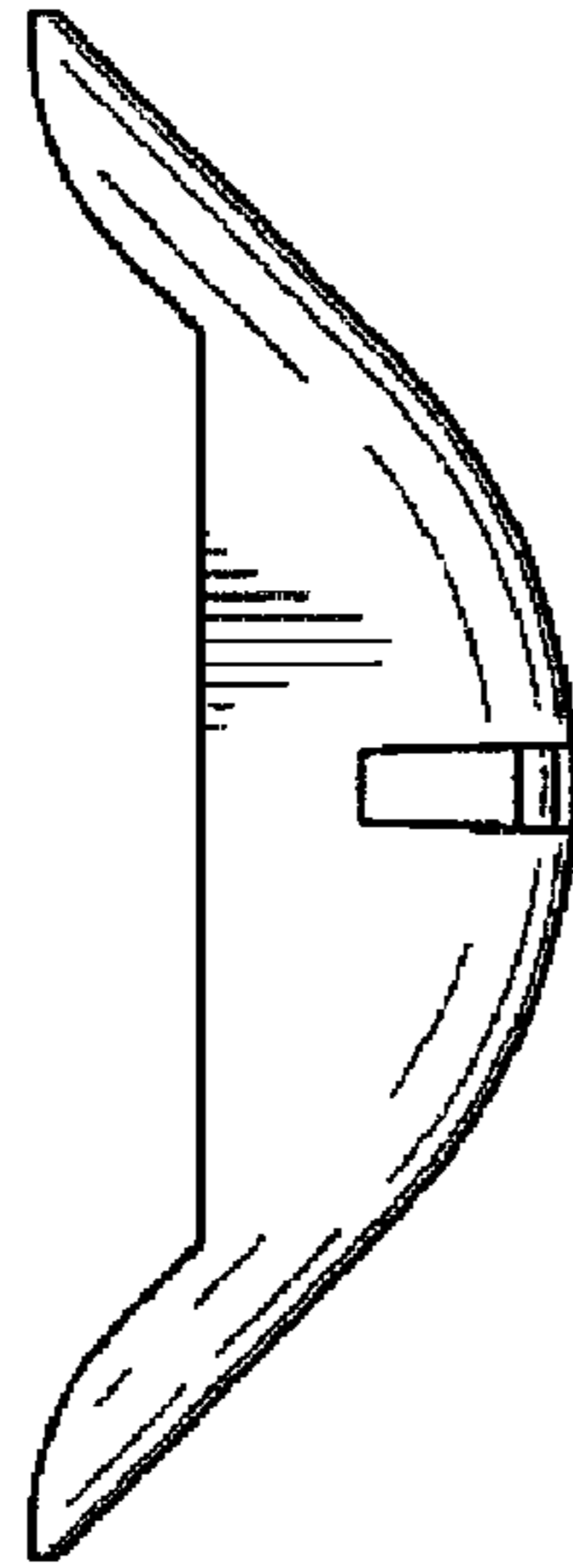

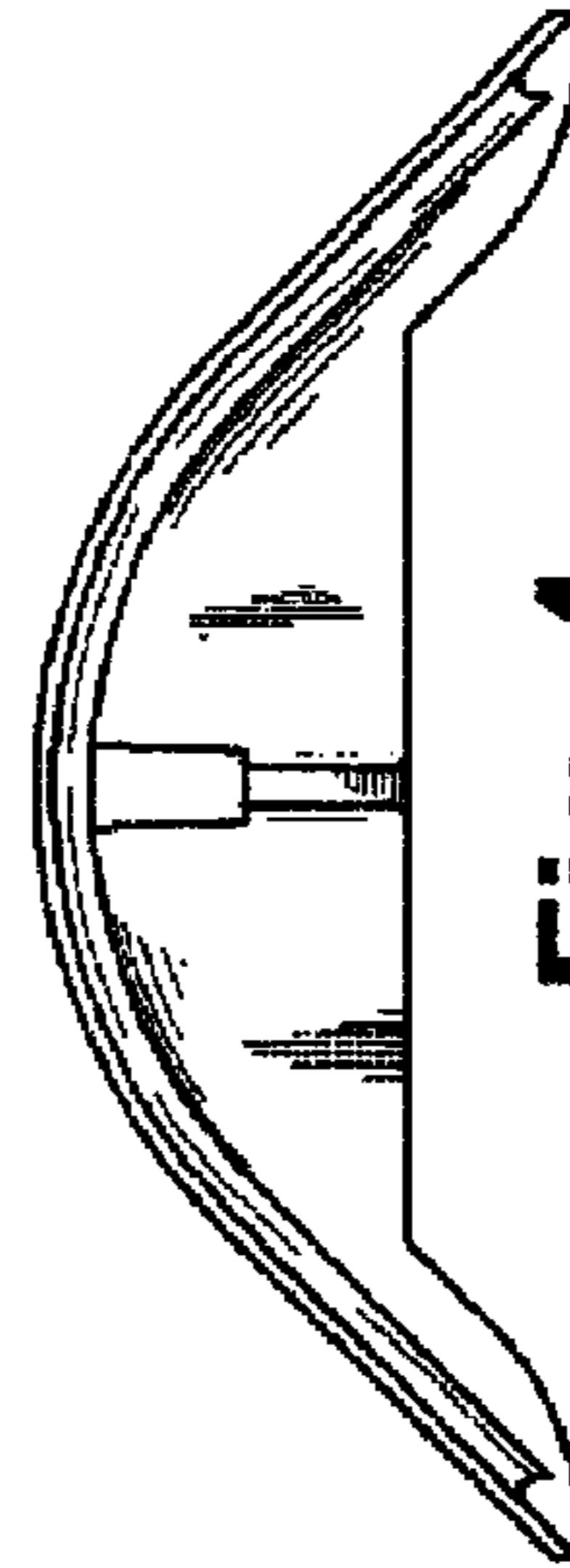

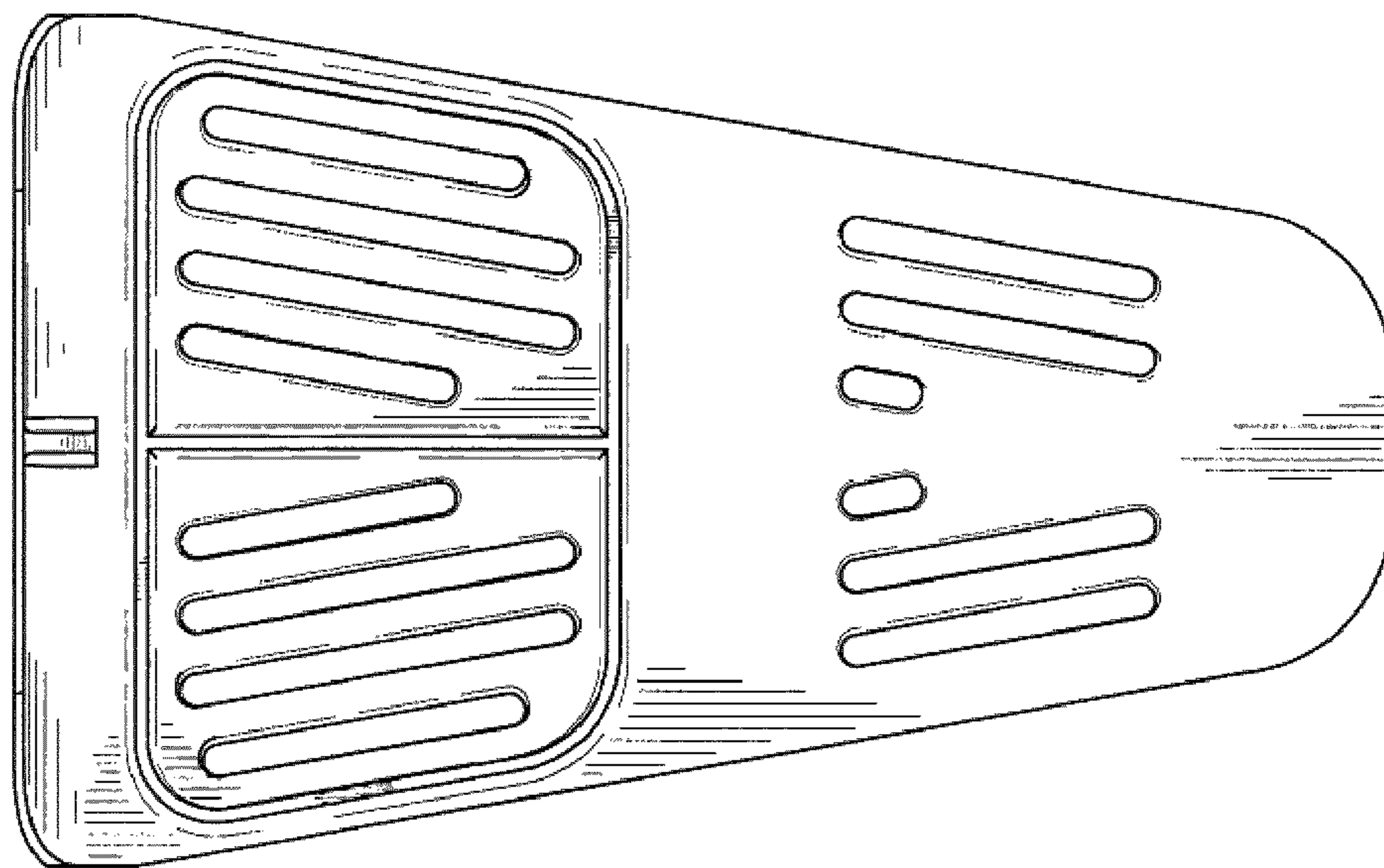

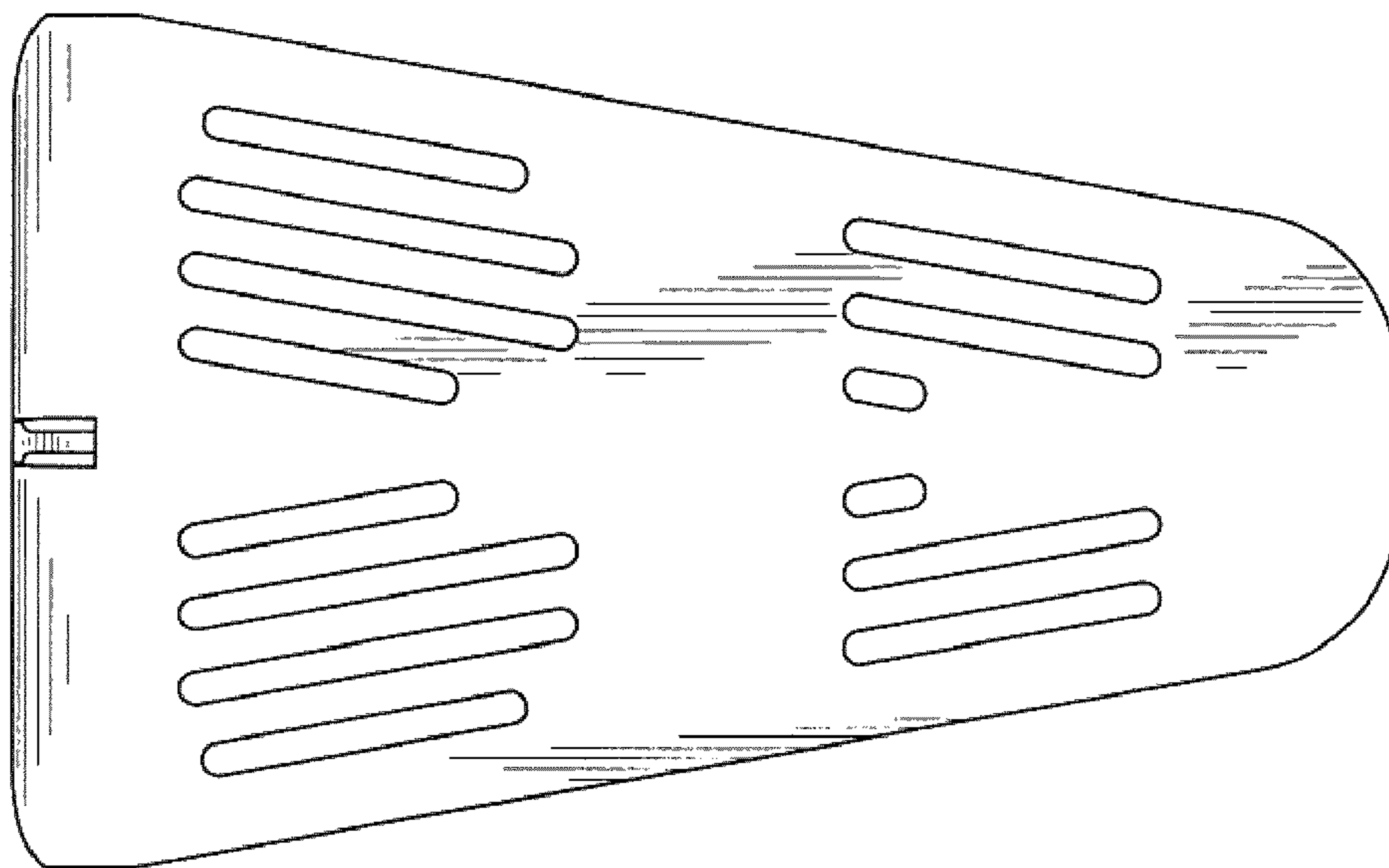

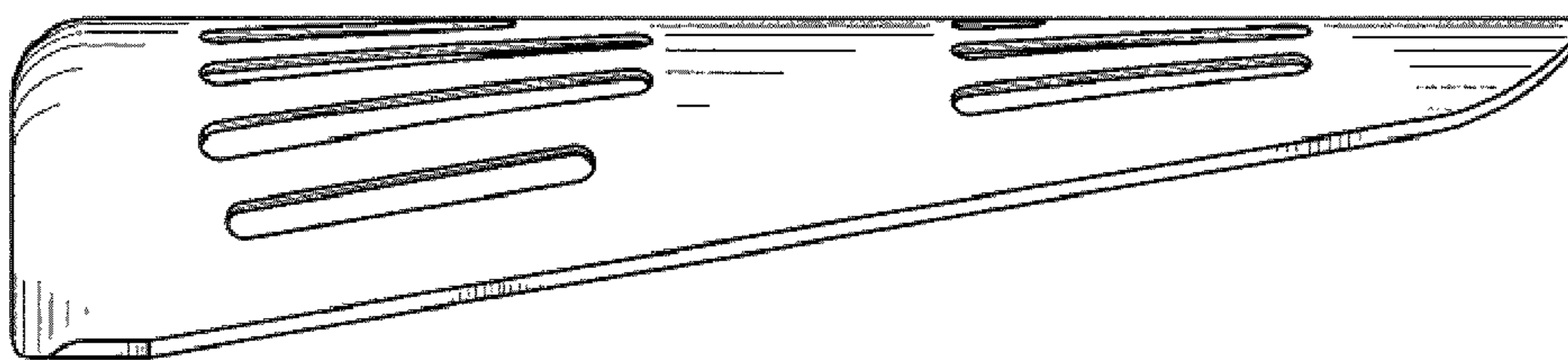
