**DESCRIPTION**

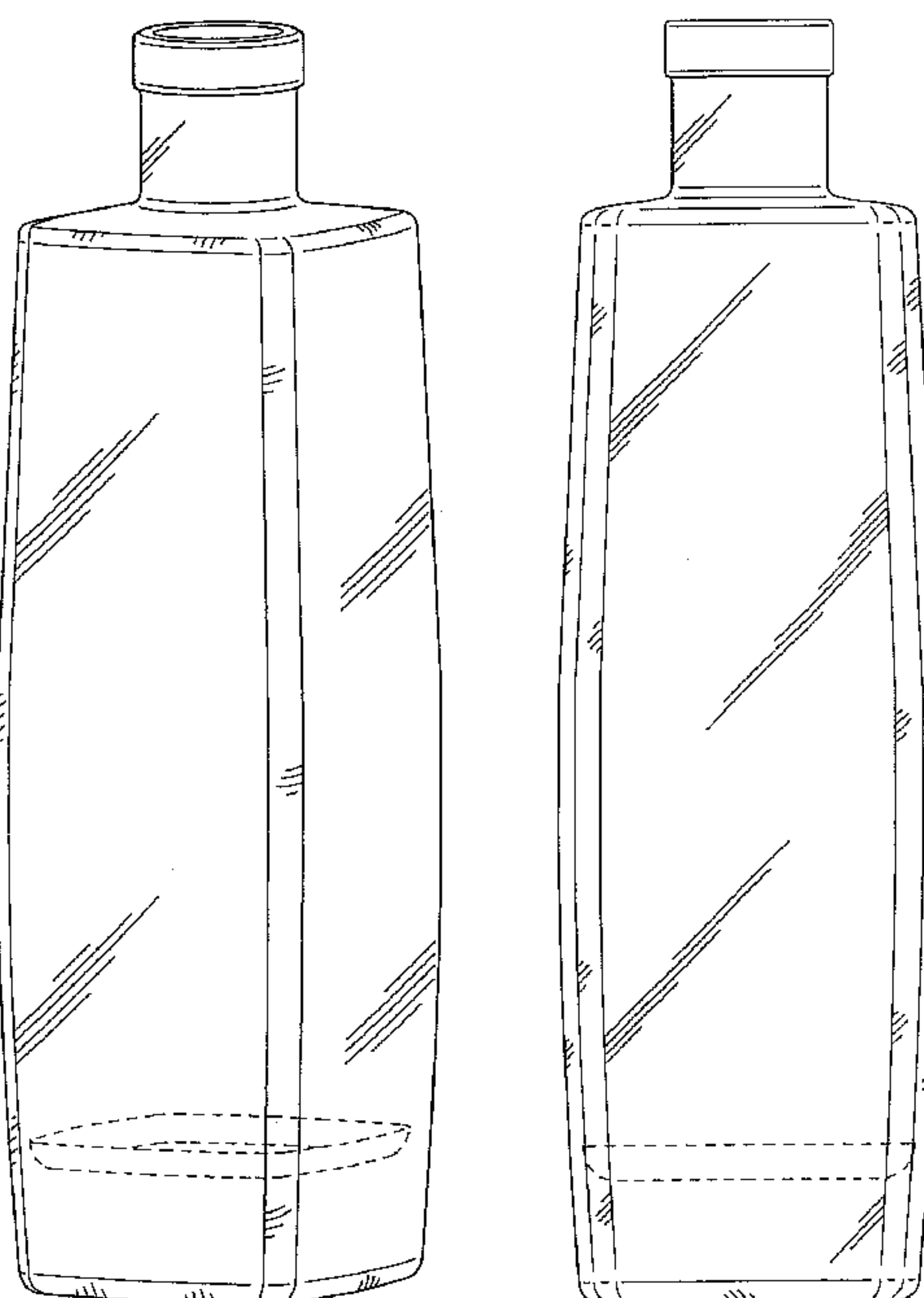
FIG. 1 is a perspective view of a container showing my new design.

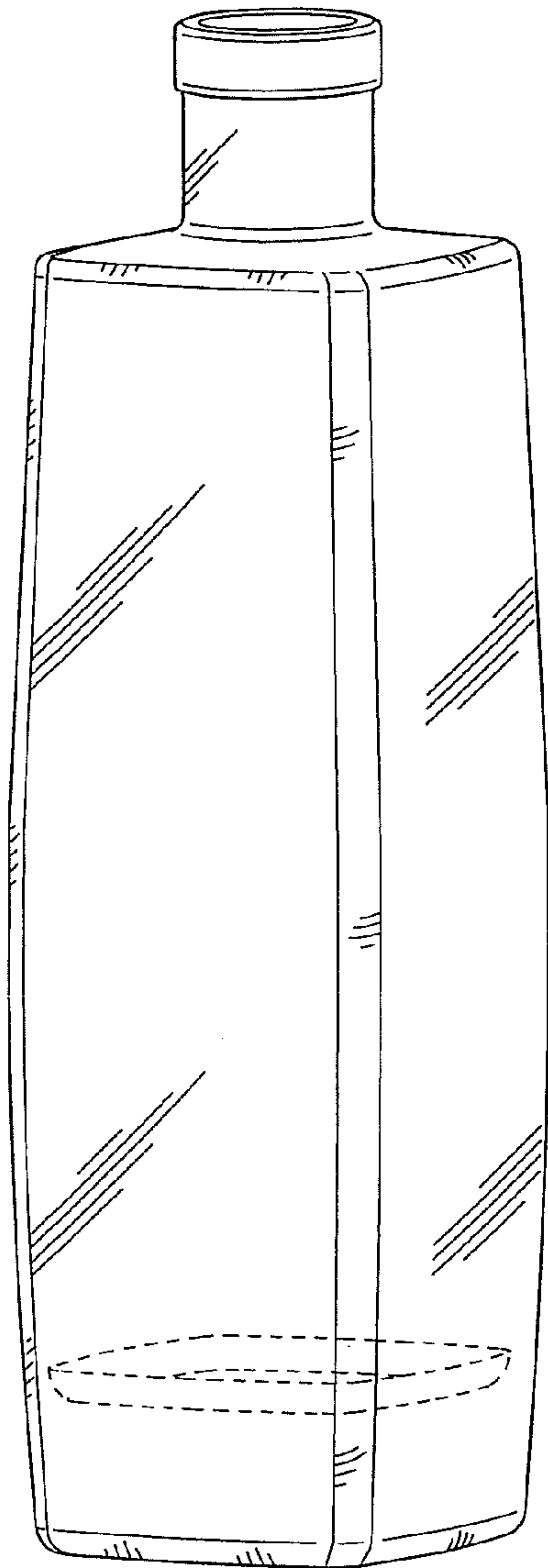
FIG. 2 is a front elevational view thereof, the two side elevational views and the rear elevational view being identical to FIG. 2; and,

FIG. 3 is a top plan view thereof, the bottom of the container forming no part of the claimed design.

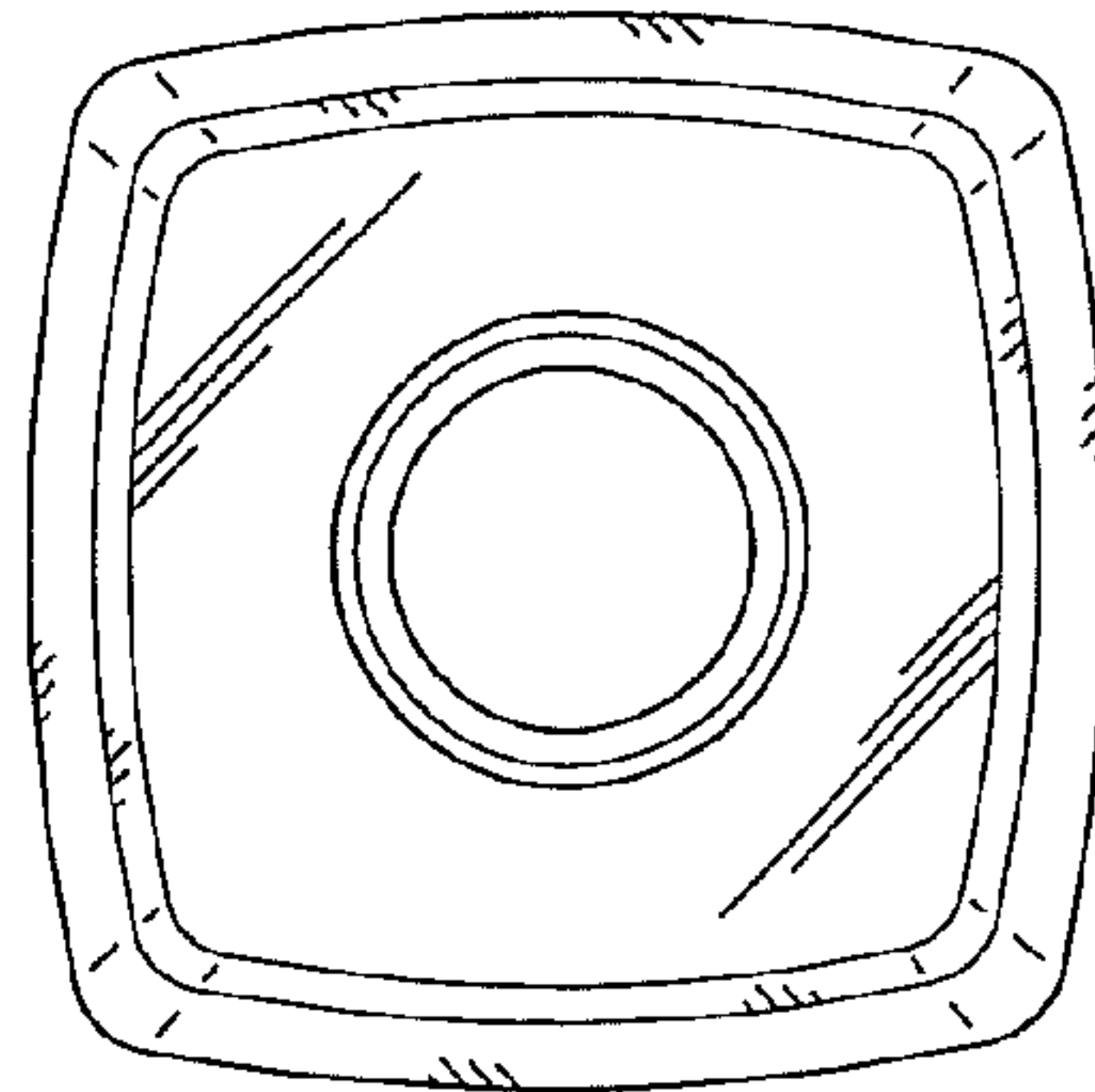
The broken line showing of an interior ring in FIGS. 1 and 2 is included for purposes of illustration only and forms no part of the claimed design.

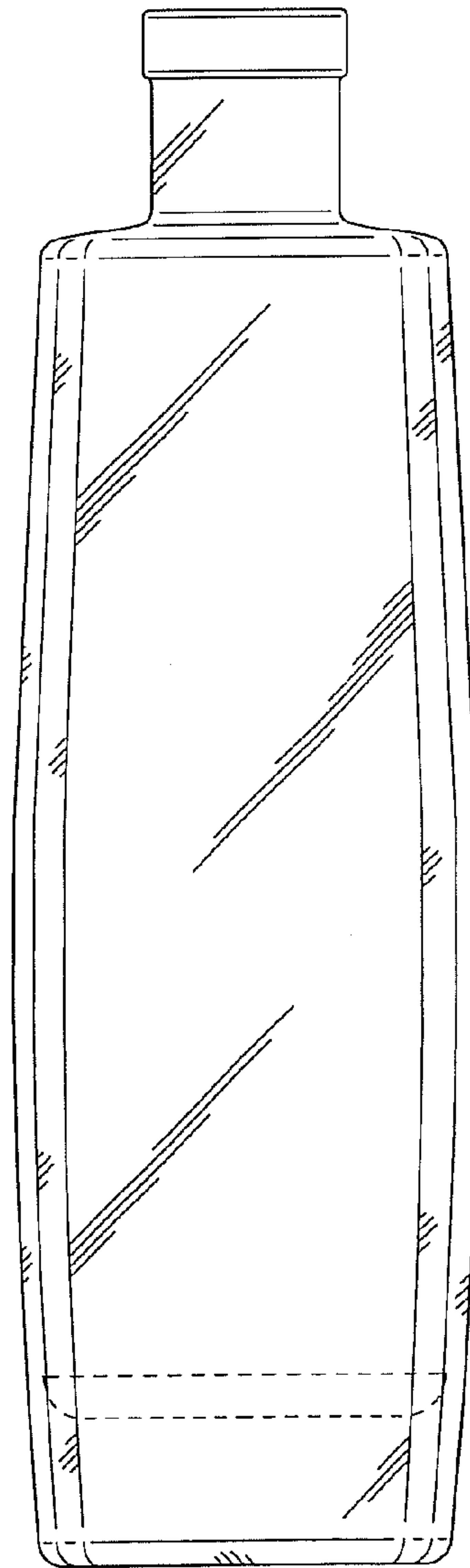
