DESCRIPTION

FIG. 1 is a perspective view of a scale showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right-side elevational view thereof, an elevational view of the left side being a mirror image;

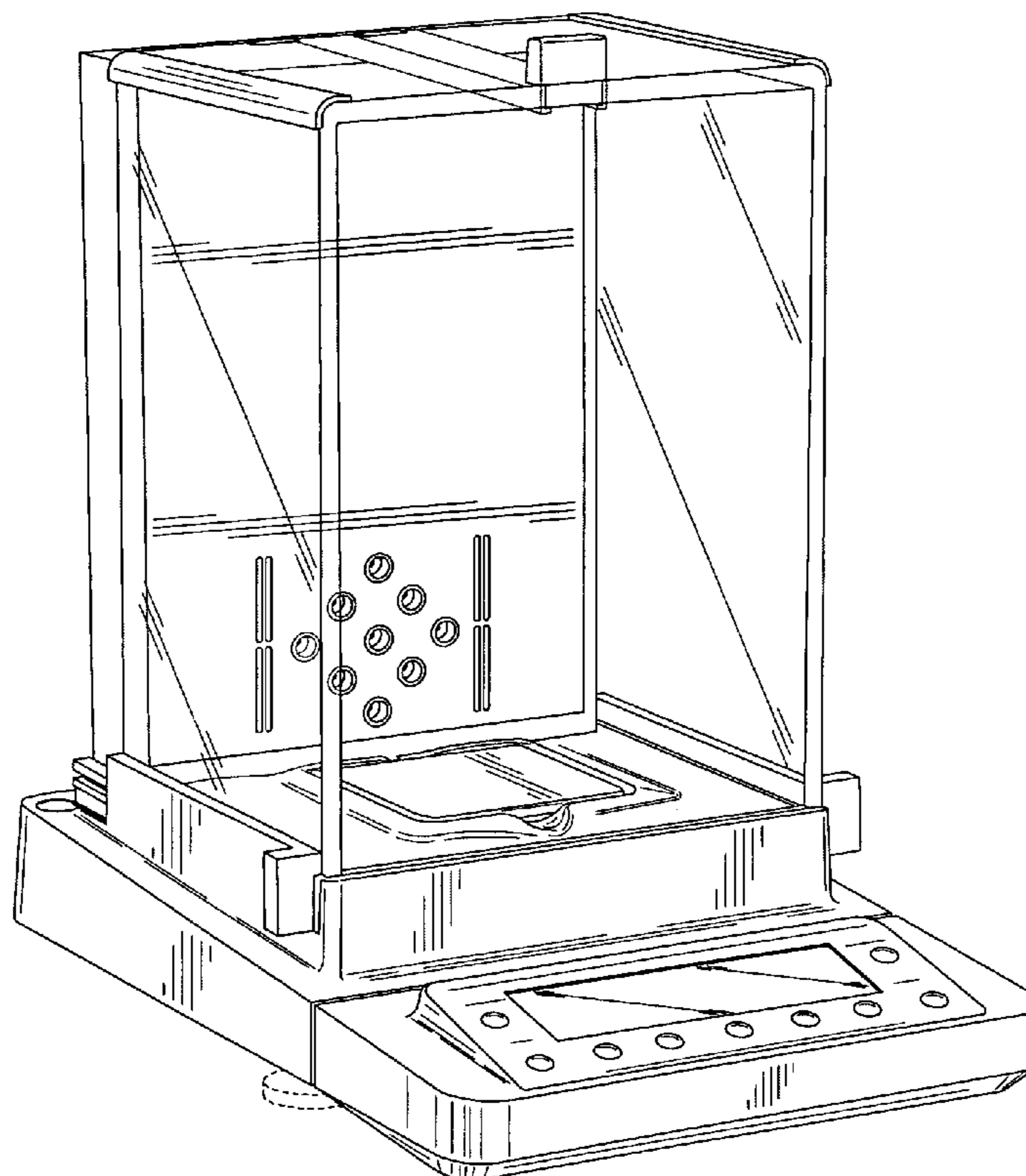
FIG. 4 is a rear view thereof;

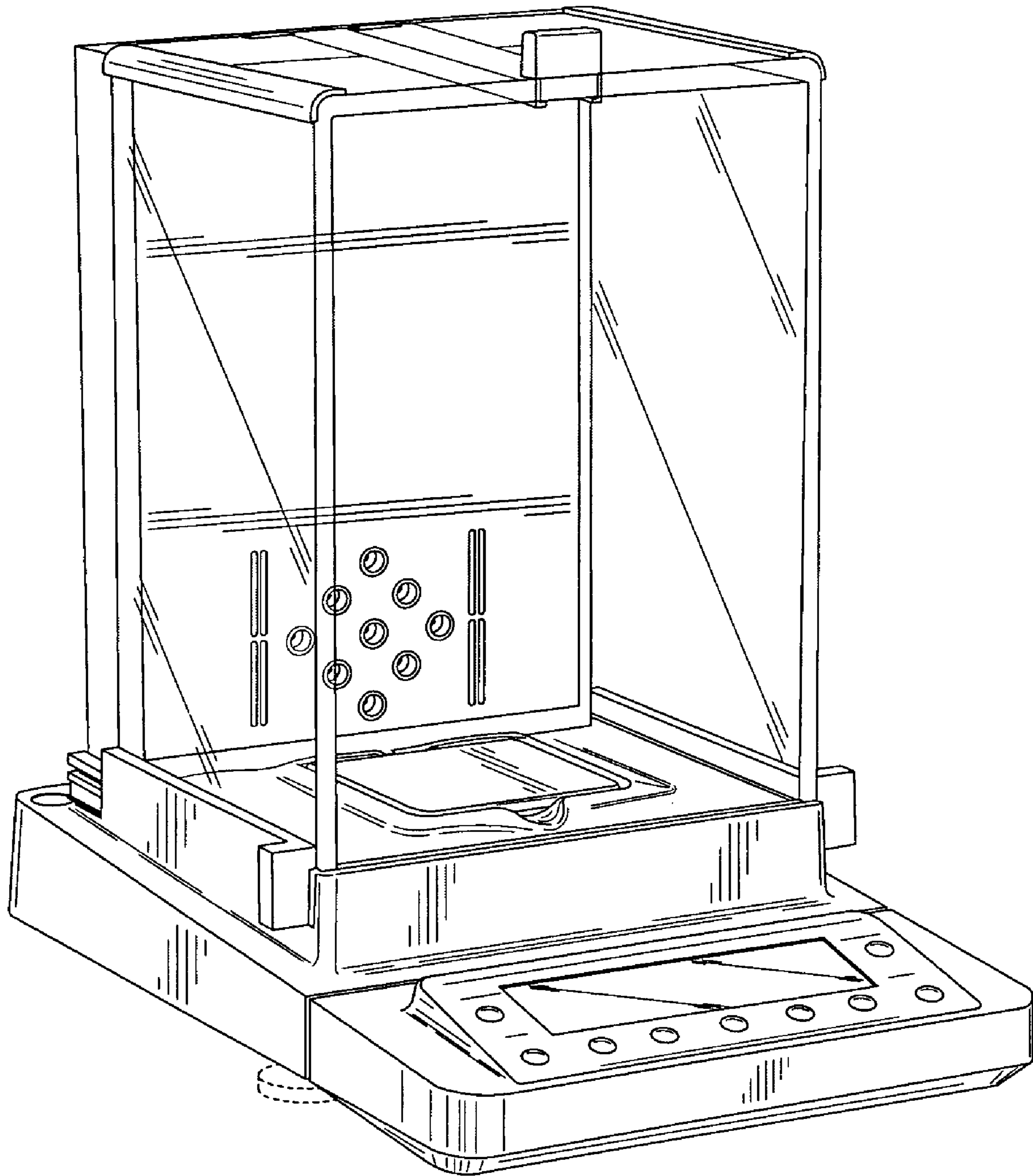

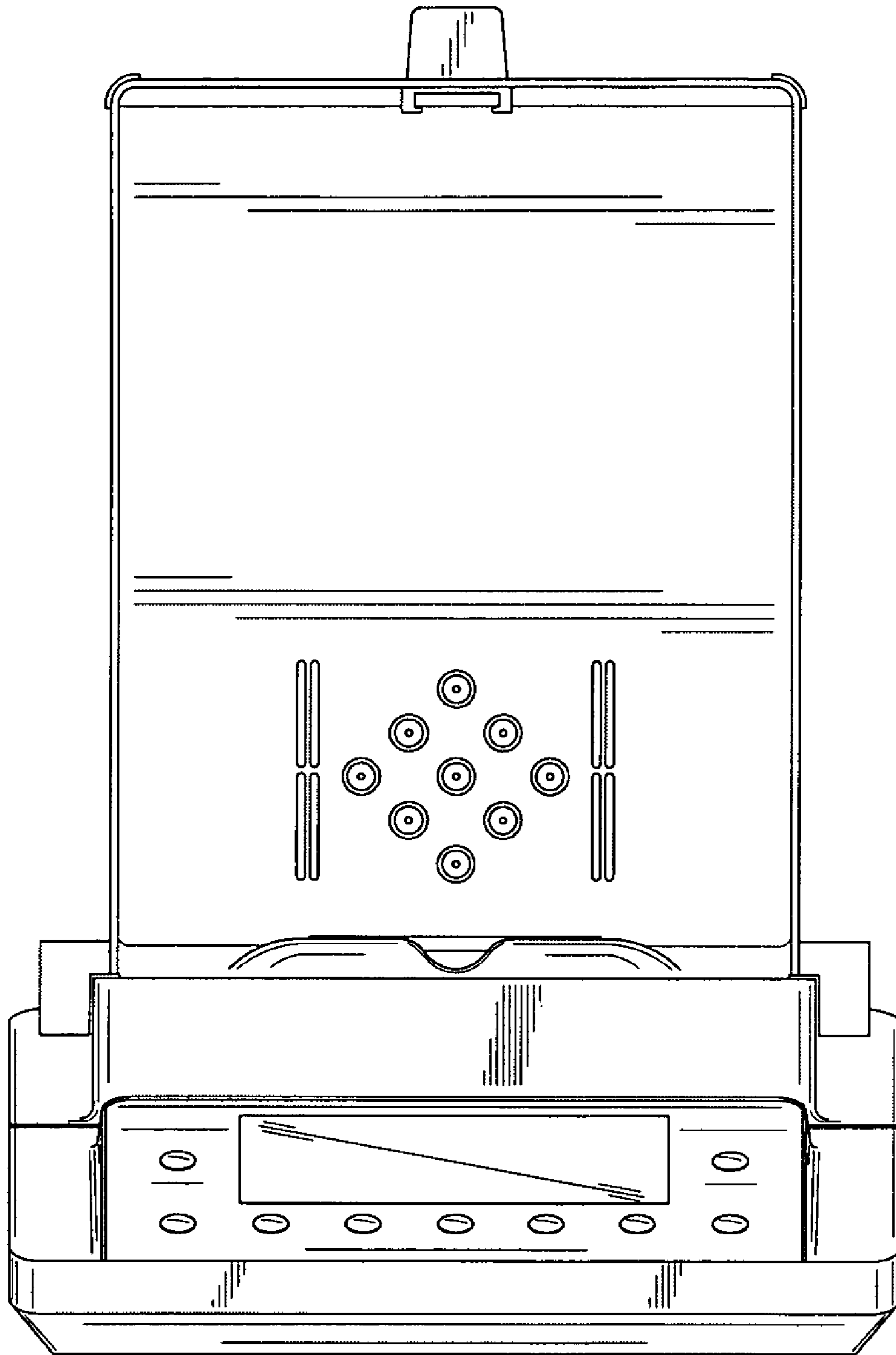

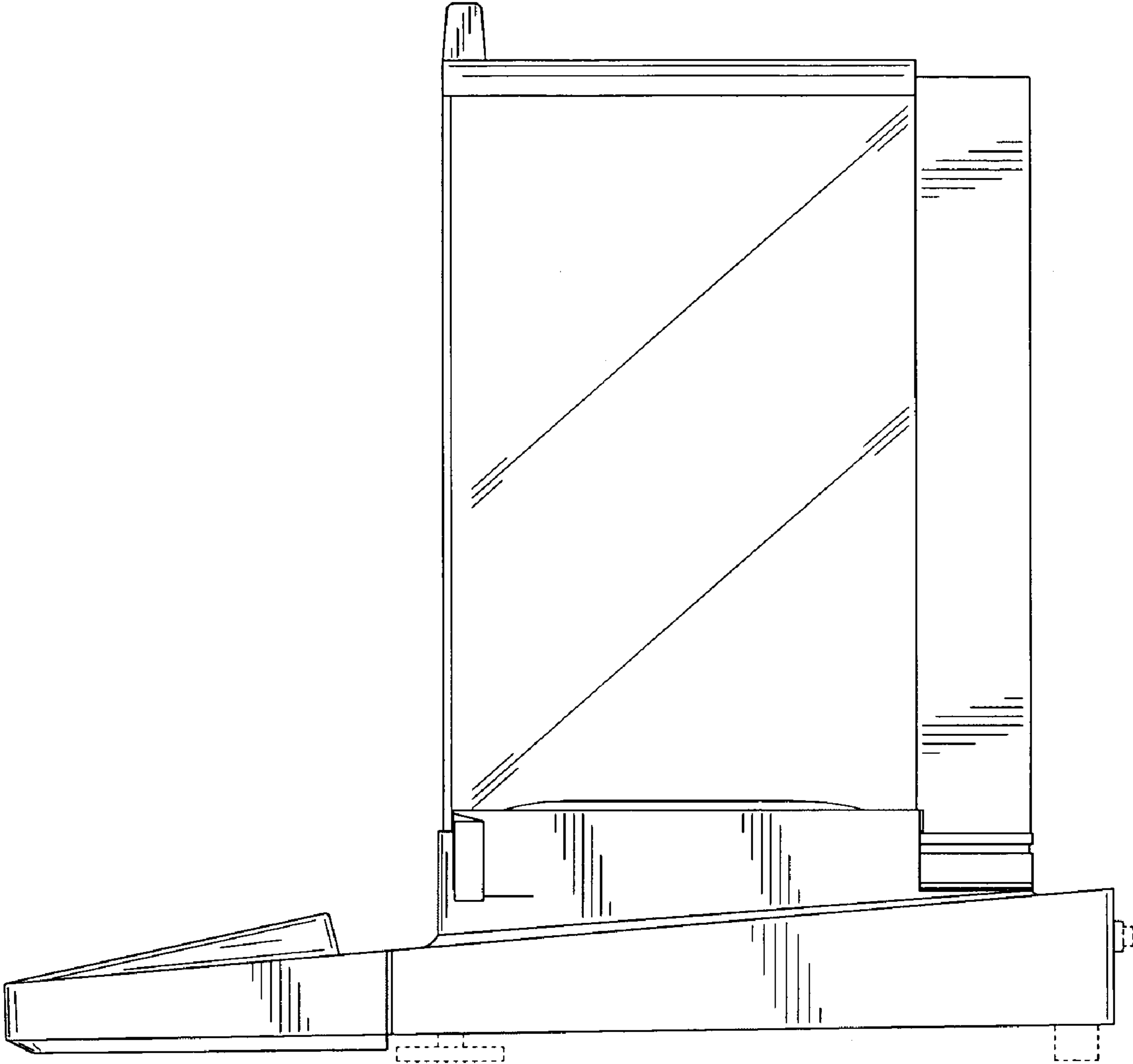

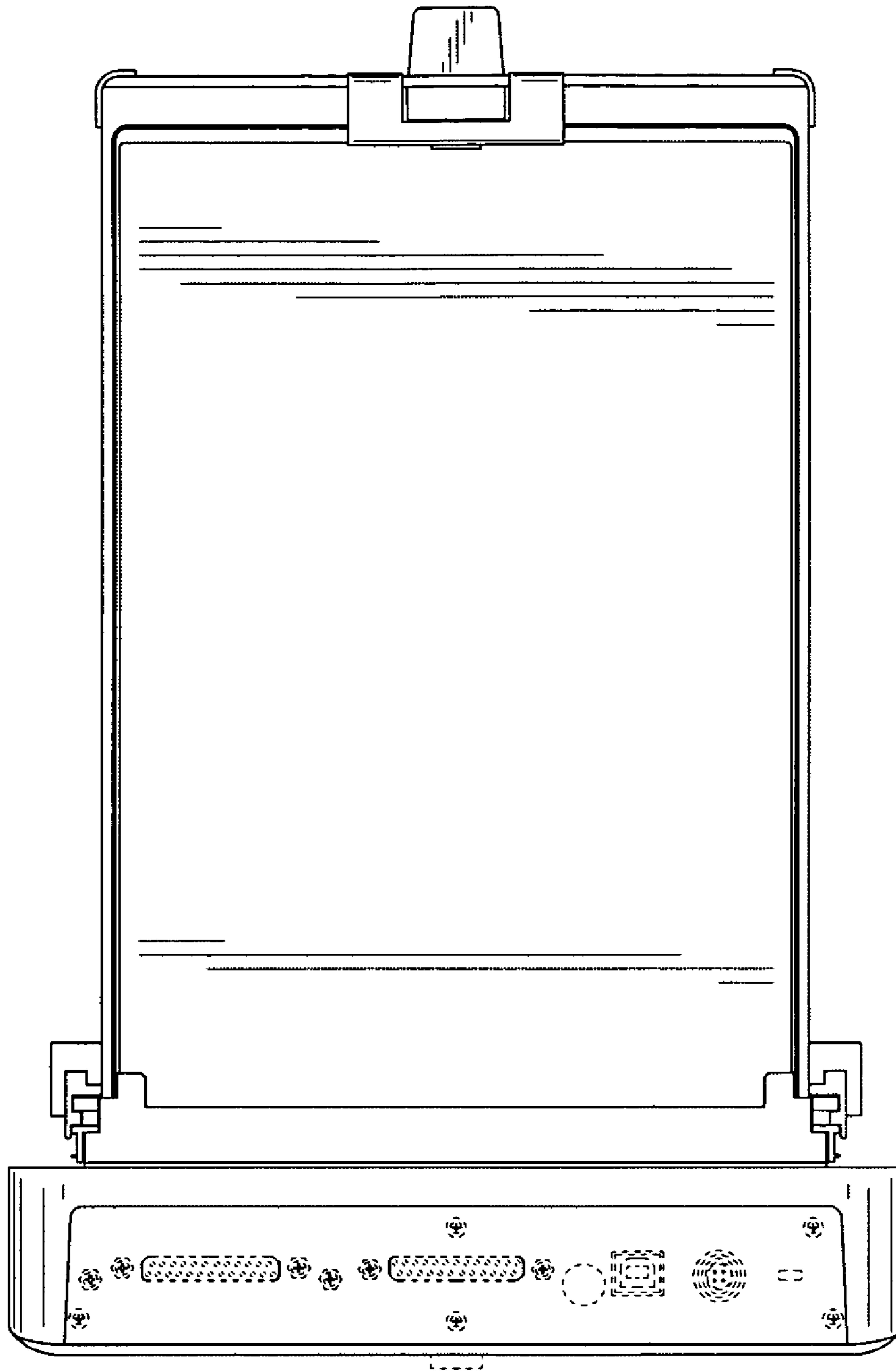

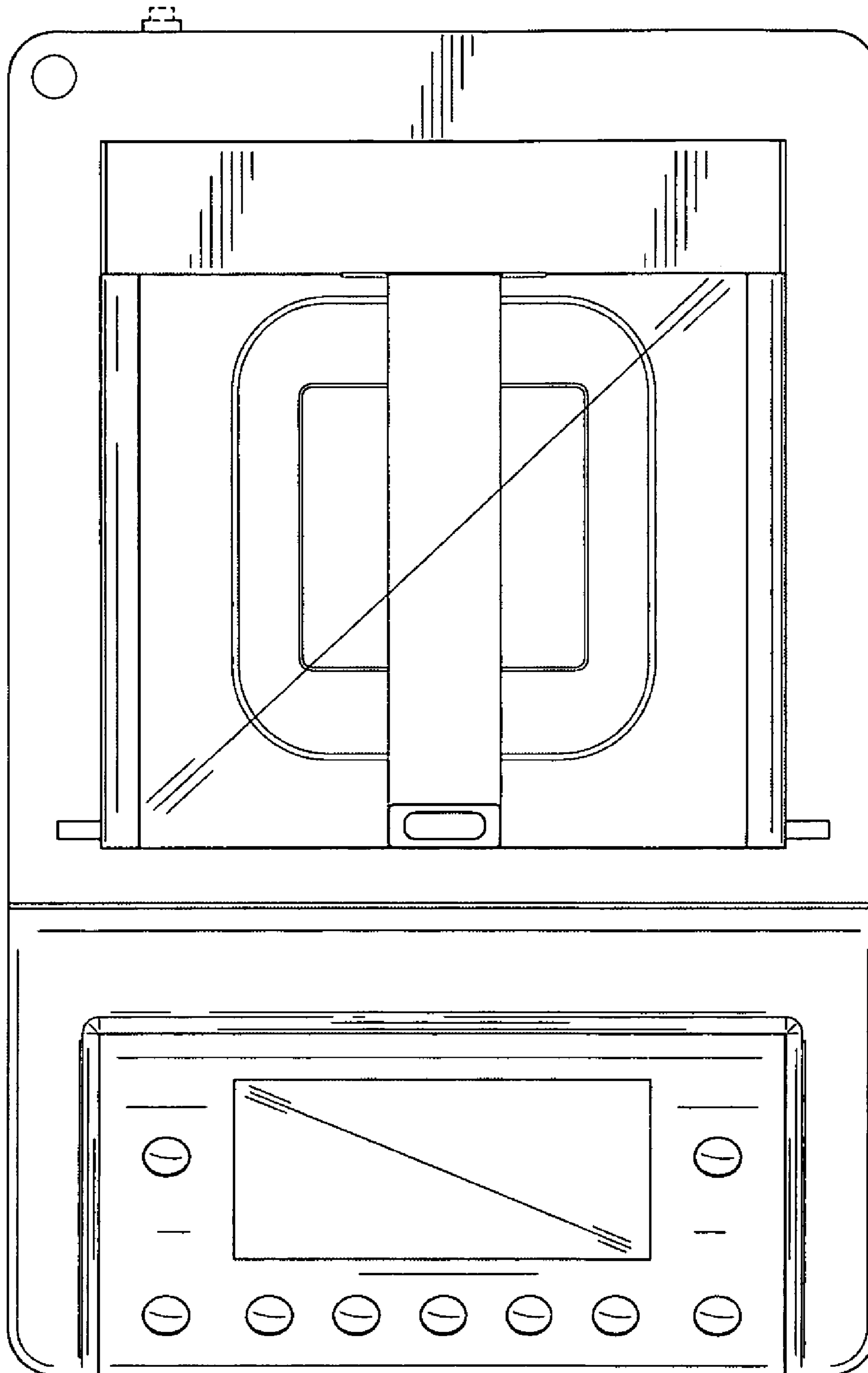

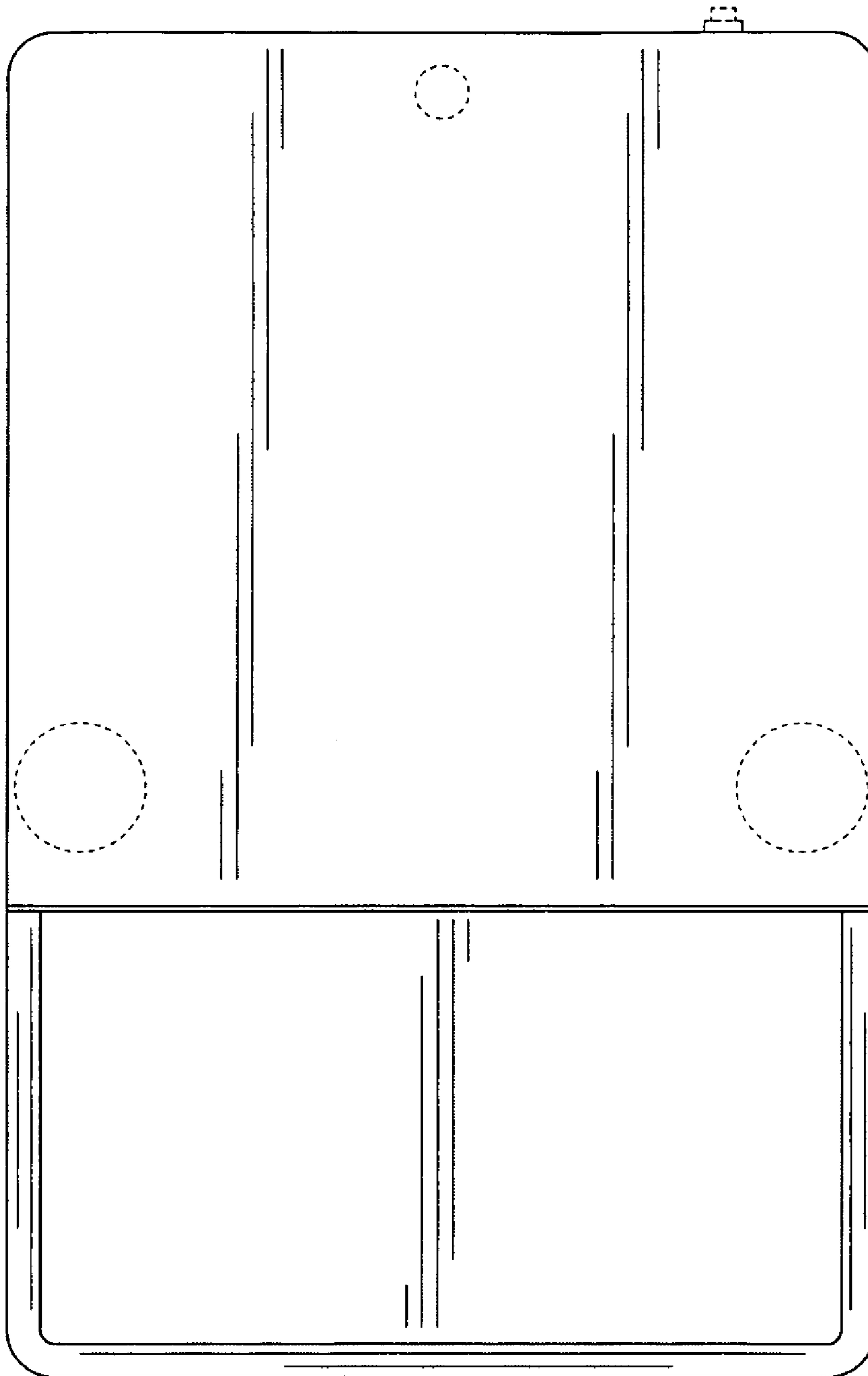
