The ornamental design for a front face of a vehicle wheel, as shown and described.

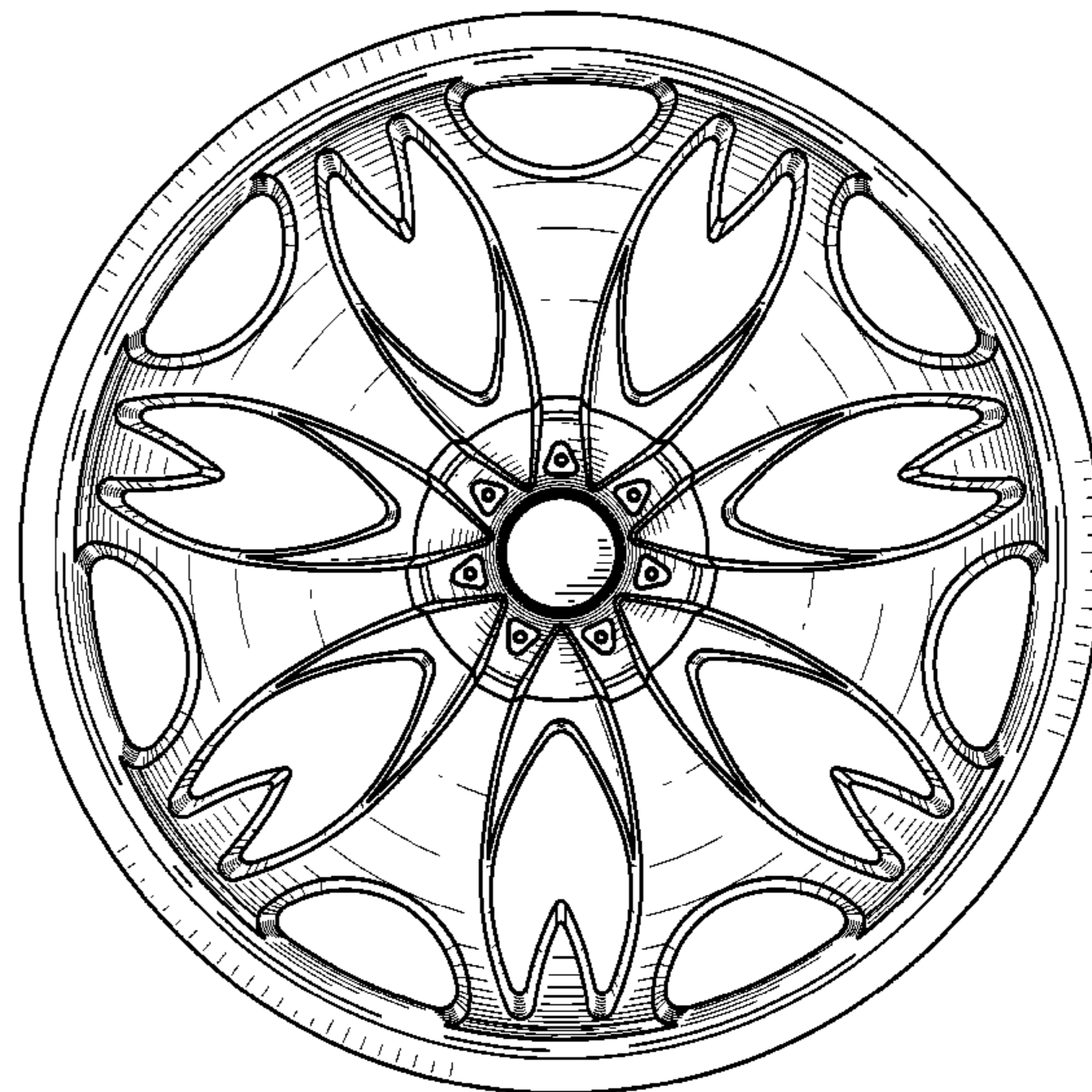
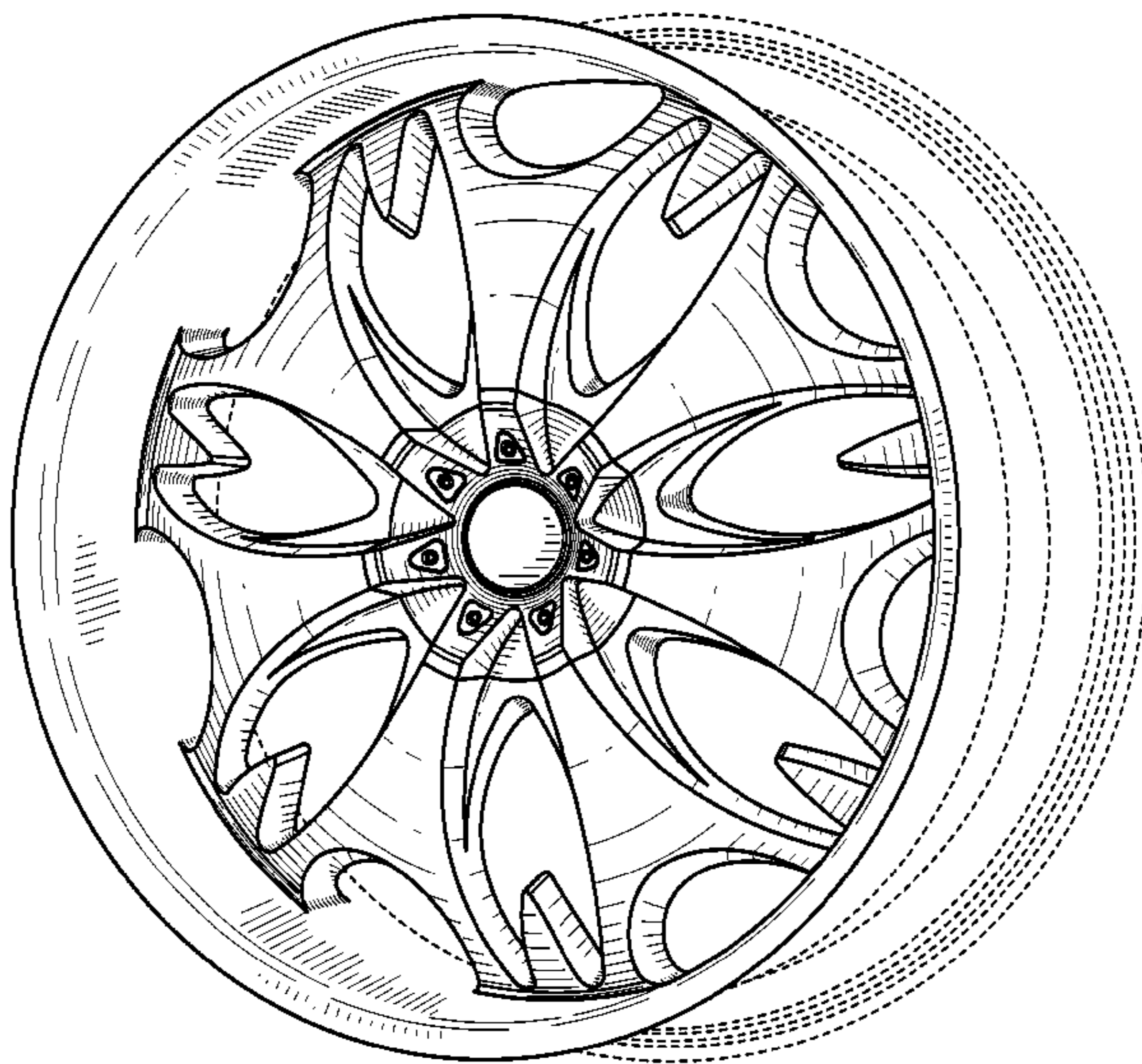
DESCRIPTION

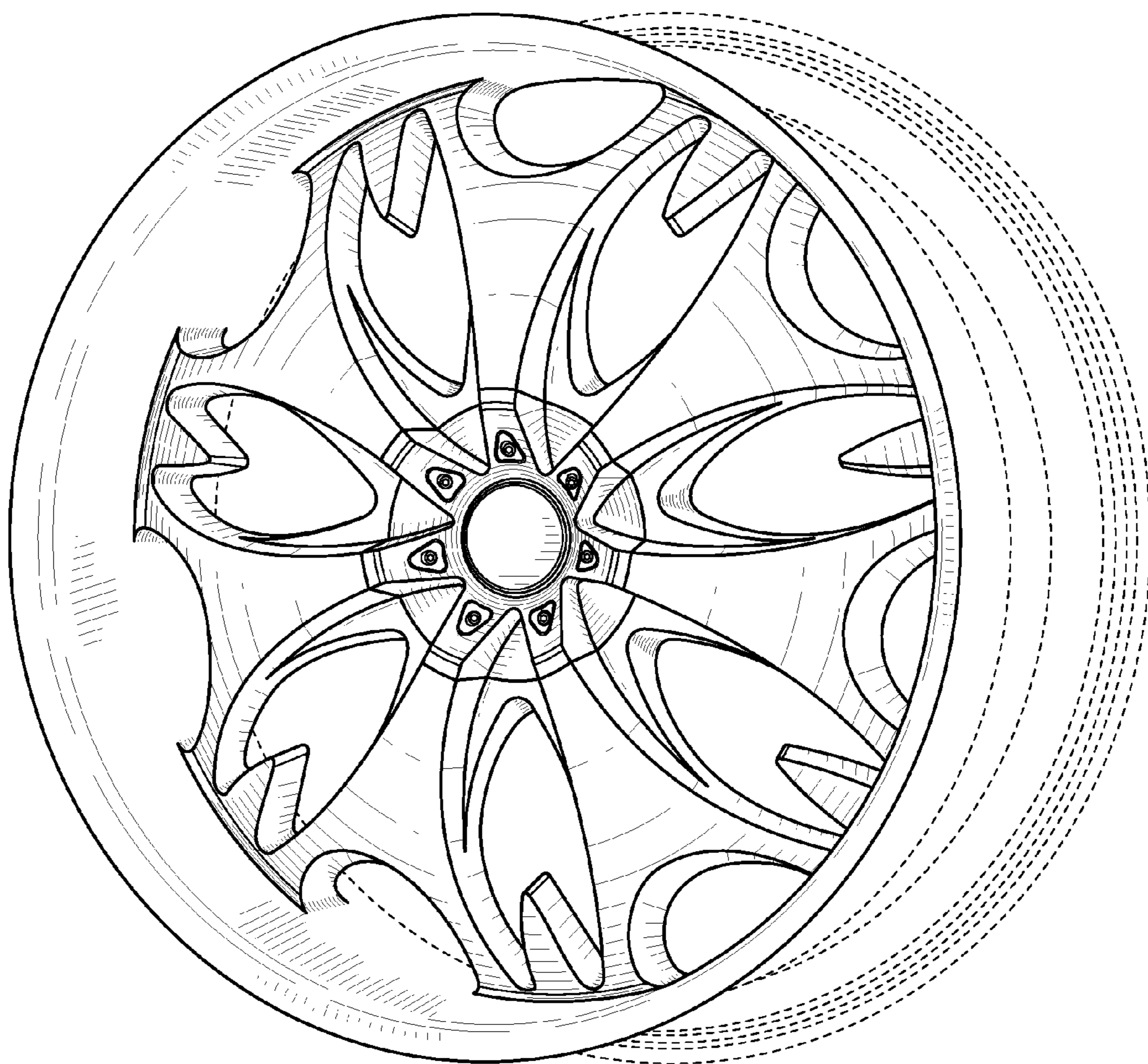

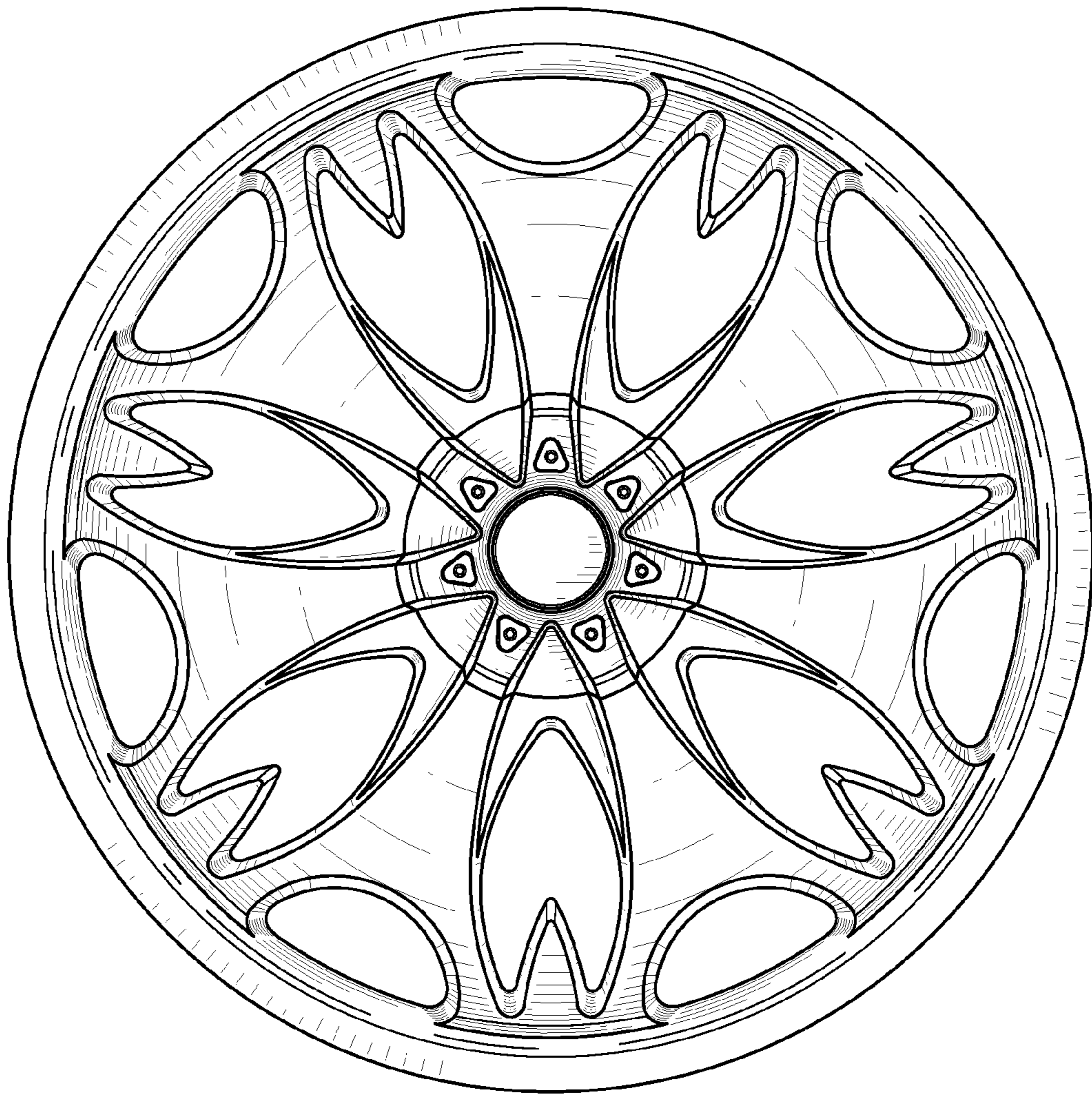
