DESCRIPTION

FIG. 1 is a perspective view of a mower blade showing our
new design.

FIG. 4 is a front elevation view of the mower blade of FIG. 1.

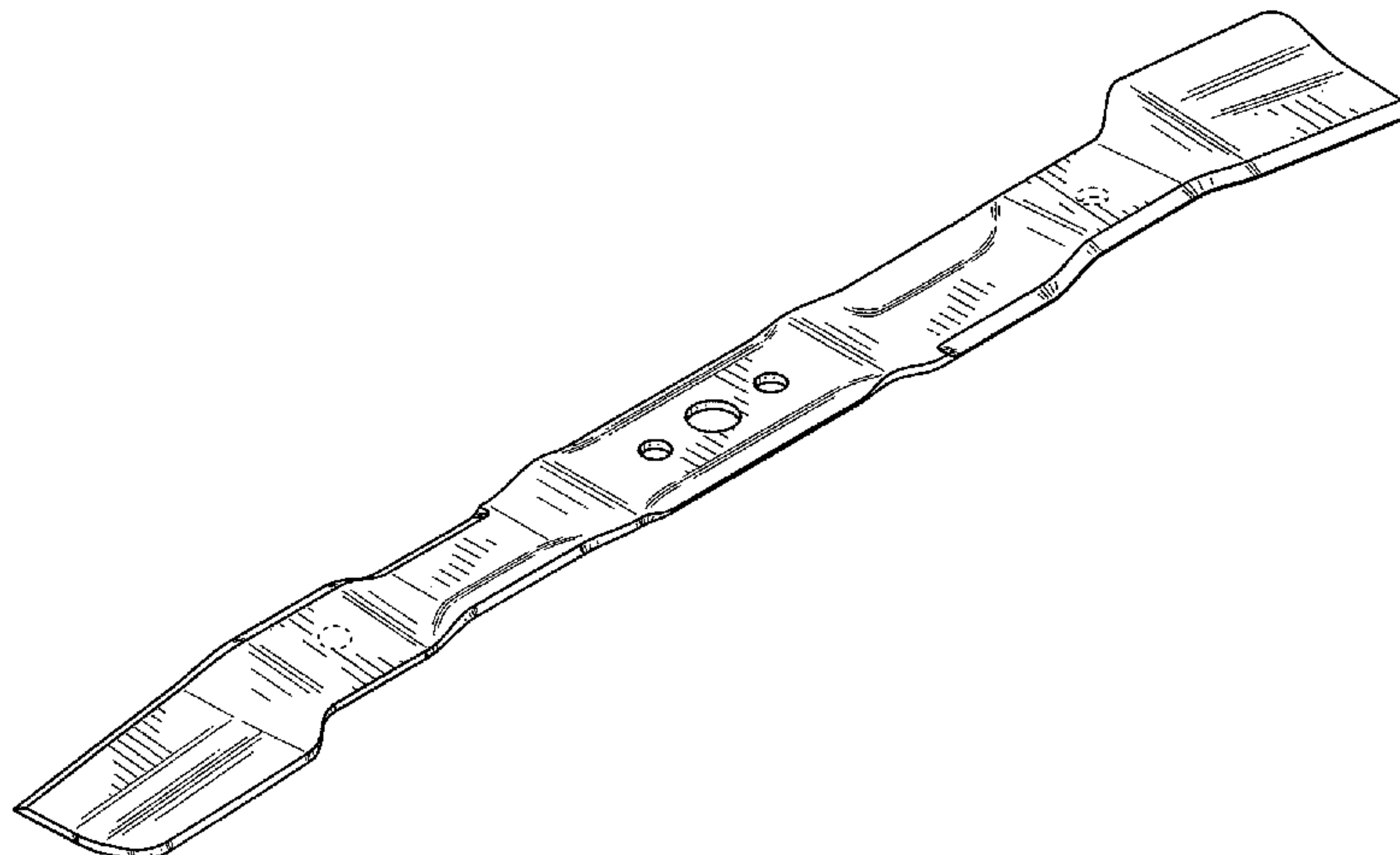
FIG. 5 is a rear elevation view of the mower blade of FIG. 1.

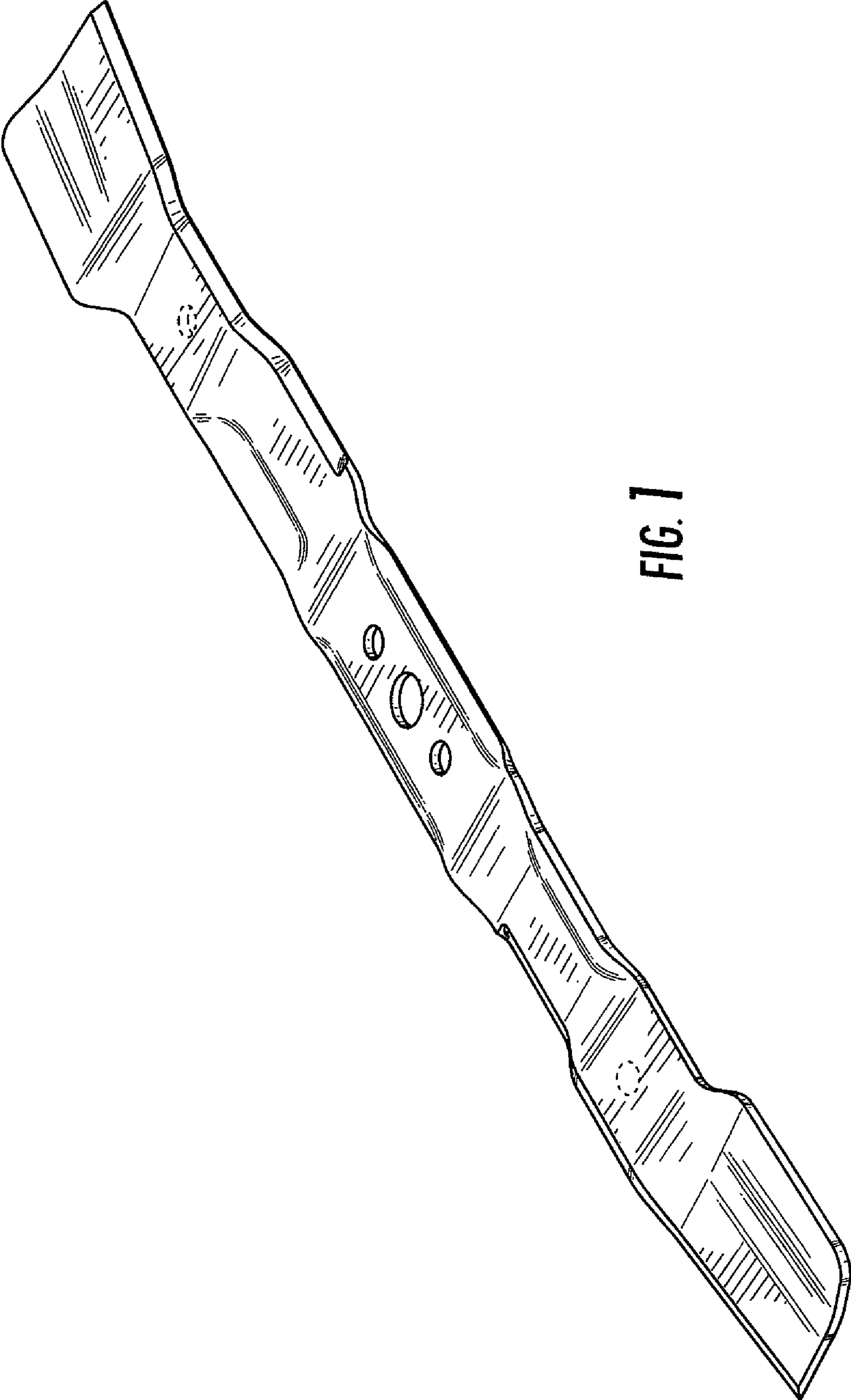

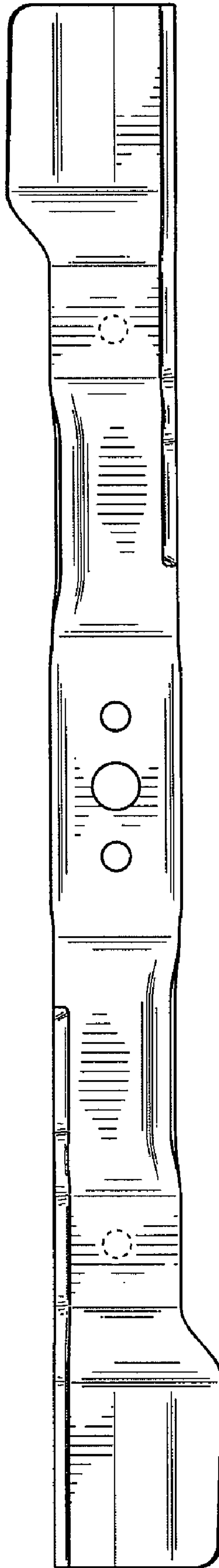

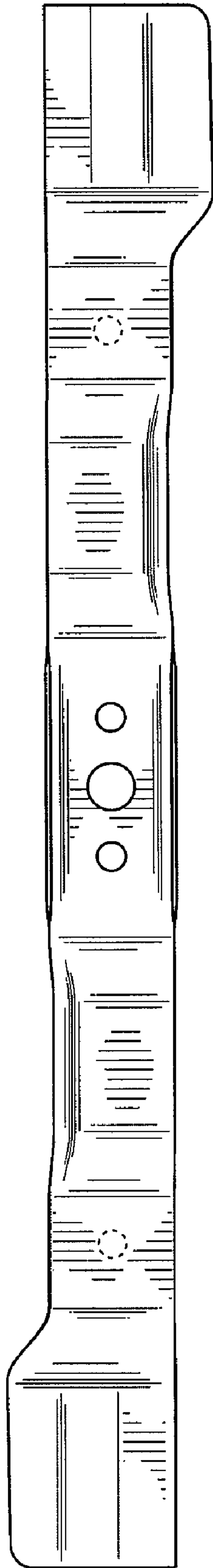

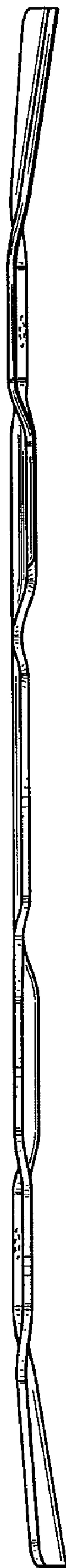

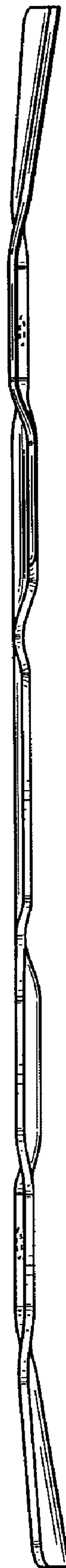

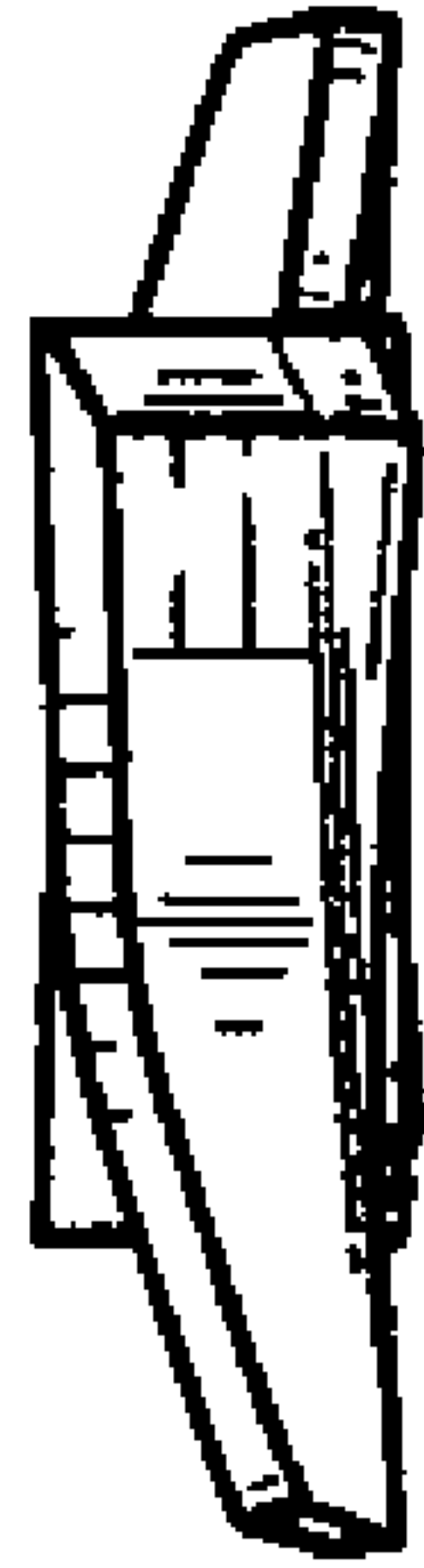

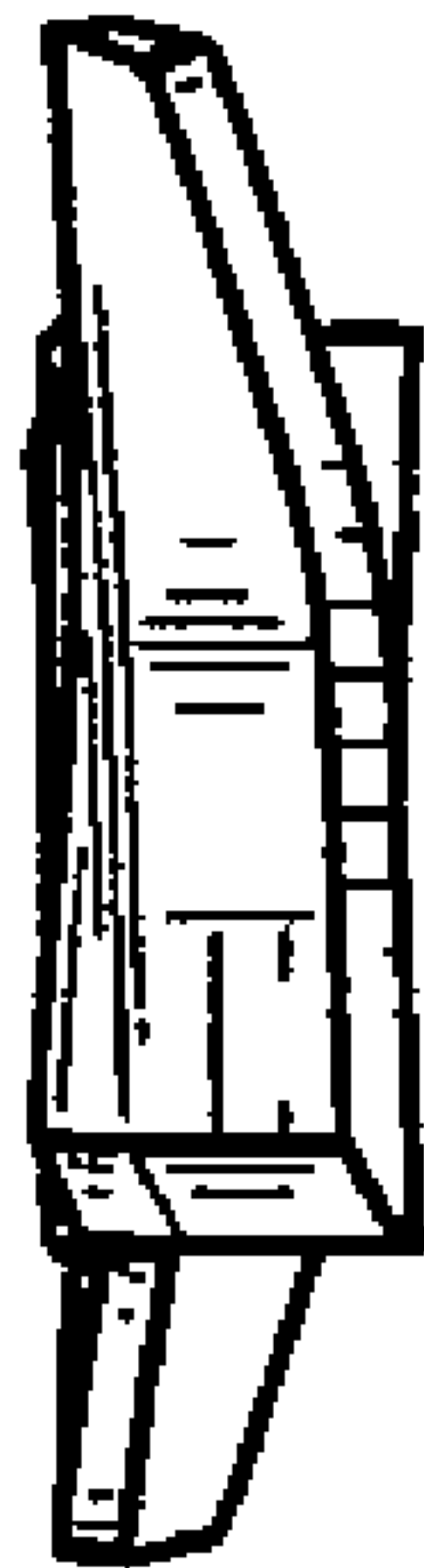
