FIG. 1;

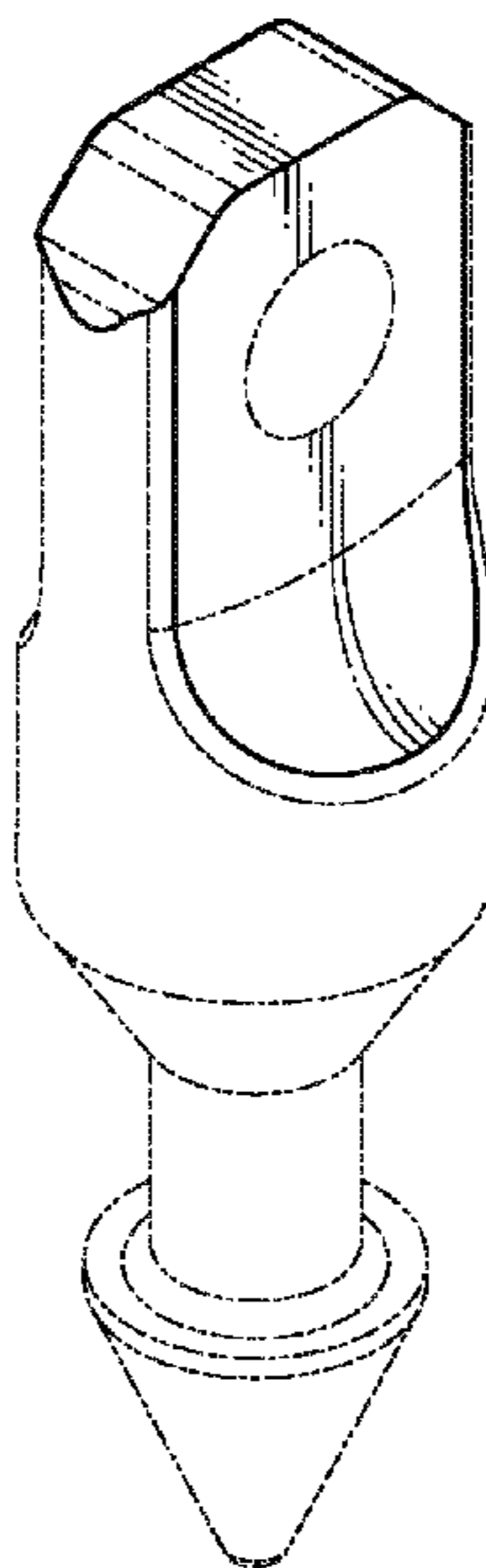
FIG. 3 is a front elevational view of the spearhead shown in

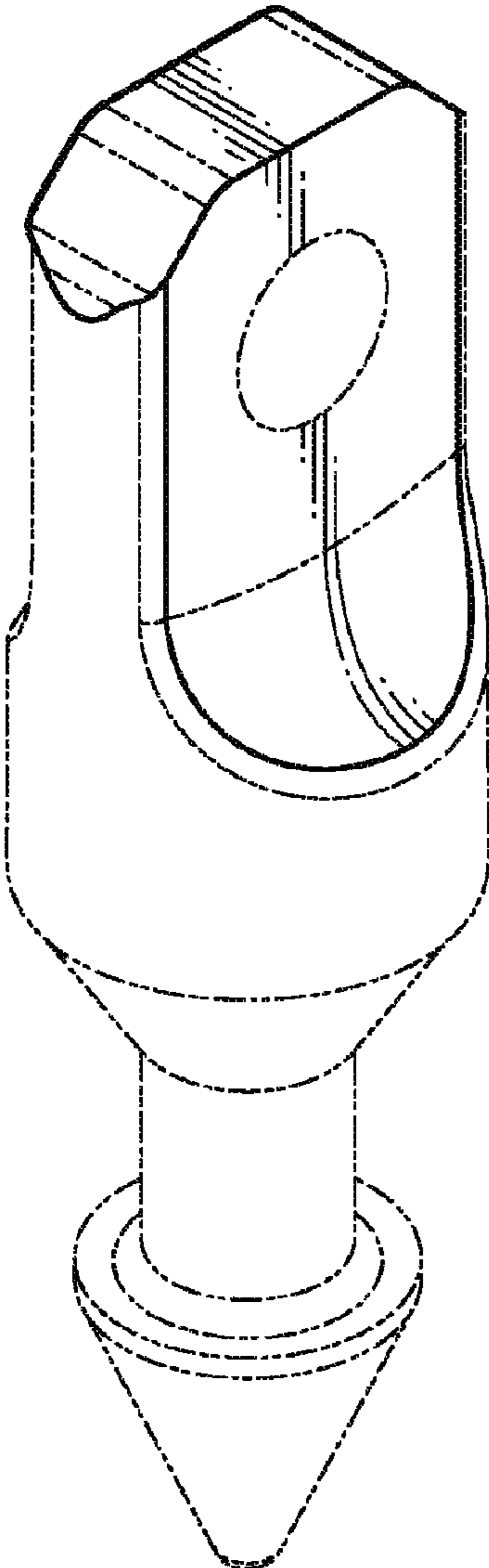

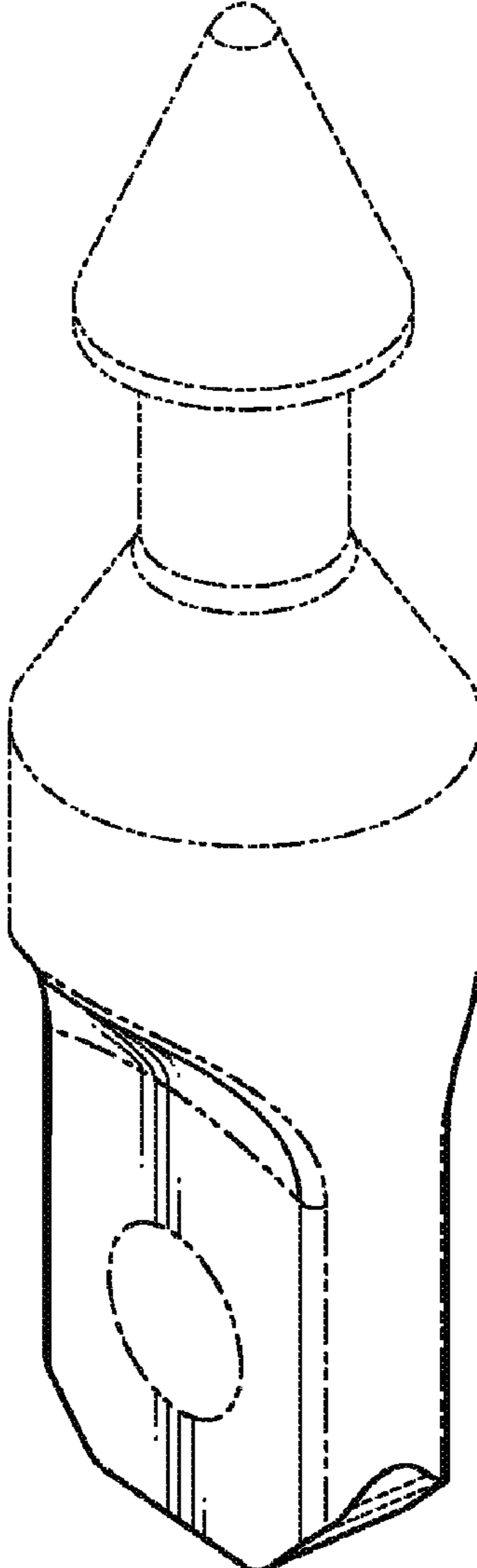

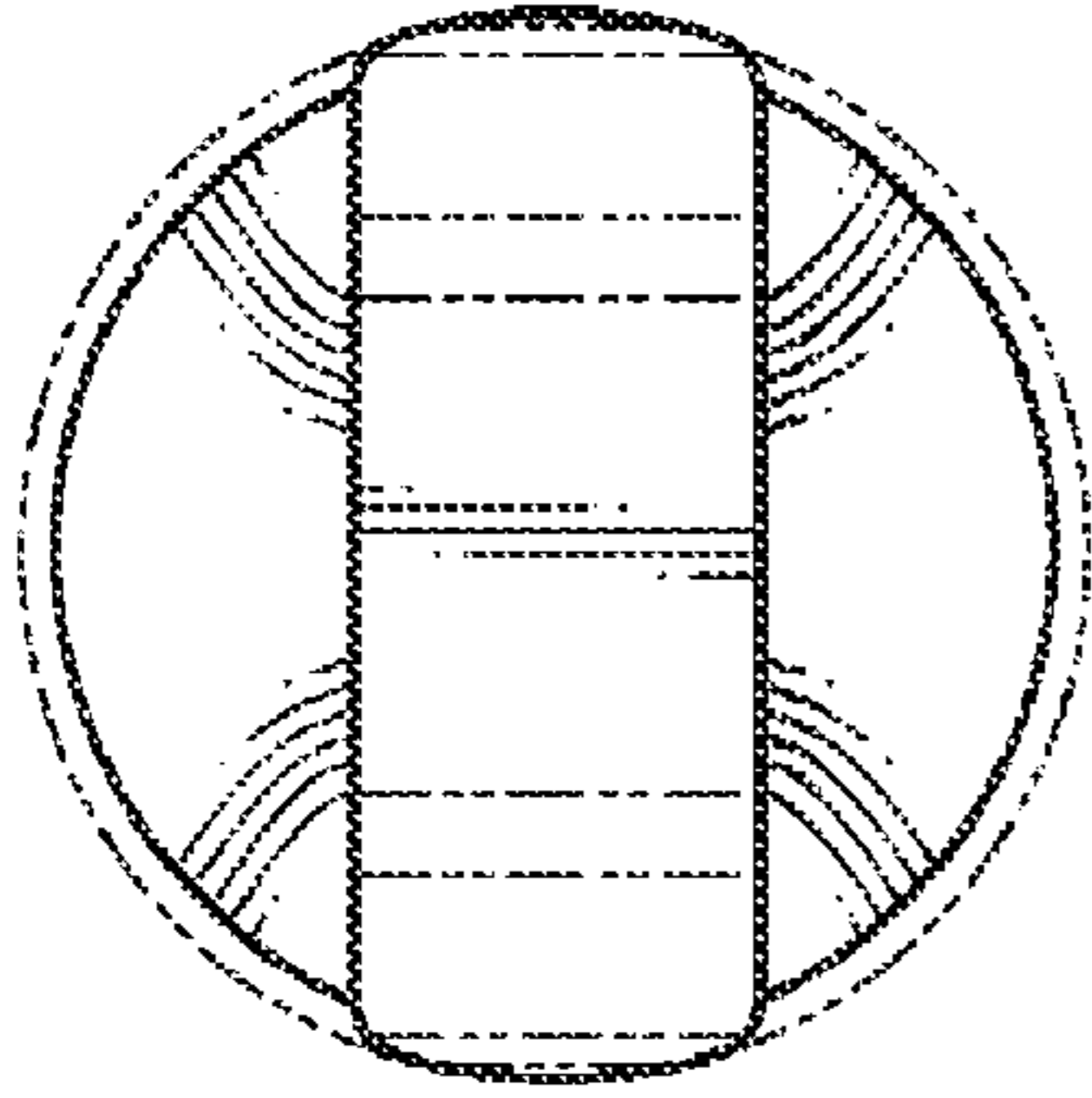

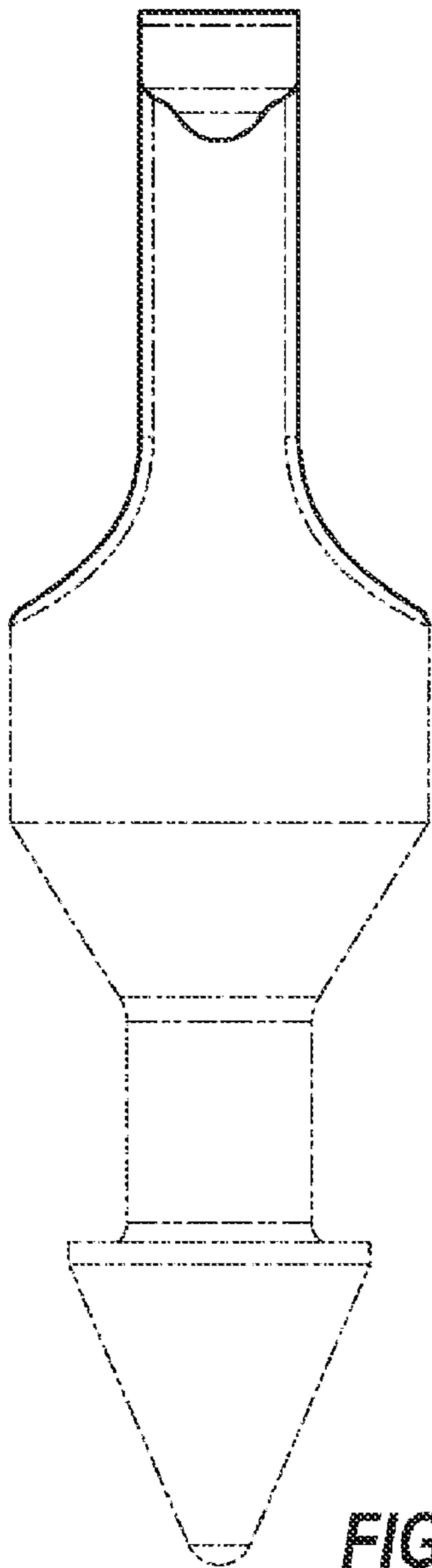

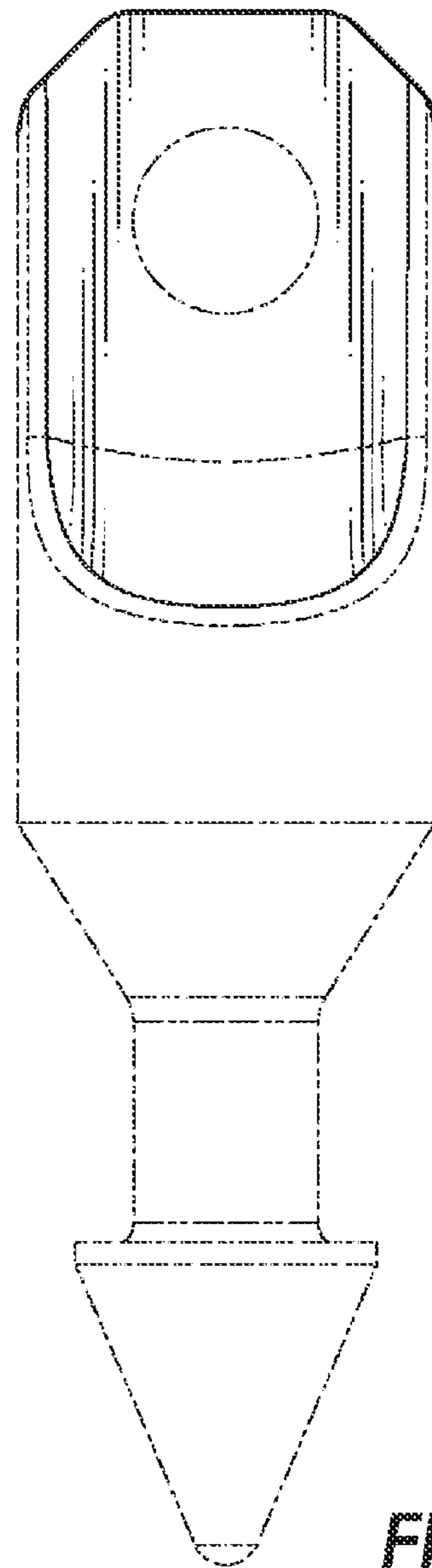
