(57) **CLAIM**

The ornamental design for a load lock roller ball support, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a load lock roller ball support.

FIG. 2 is a side view of the load lock roller ball support.

FIG. 3 is a side view of the load lock roller ball support.

FIG. 4 is a side view of the load lock roller ball support.

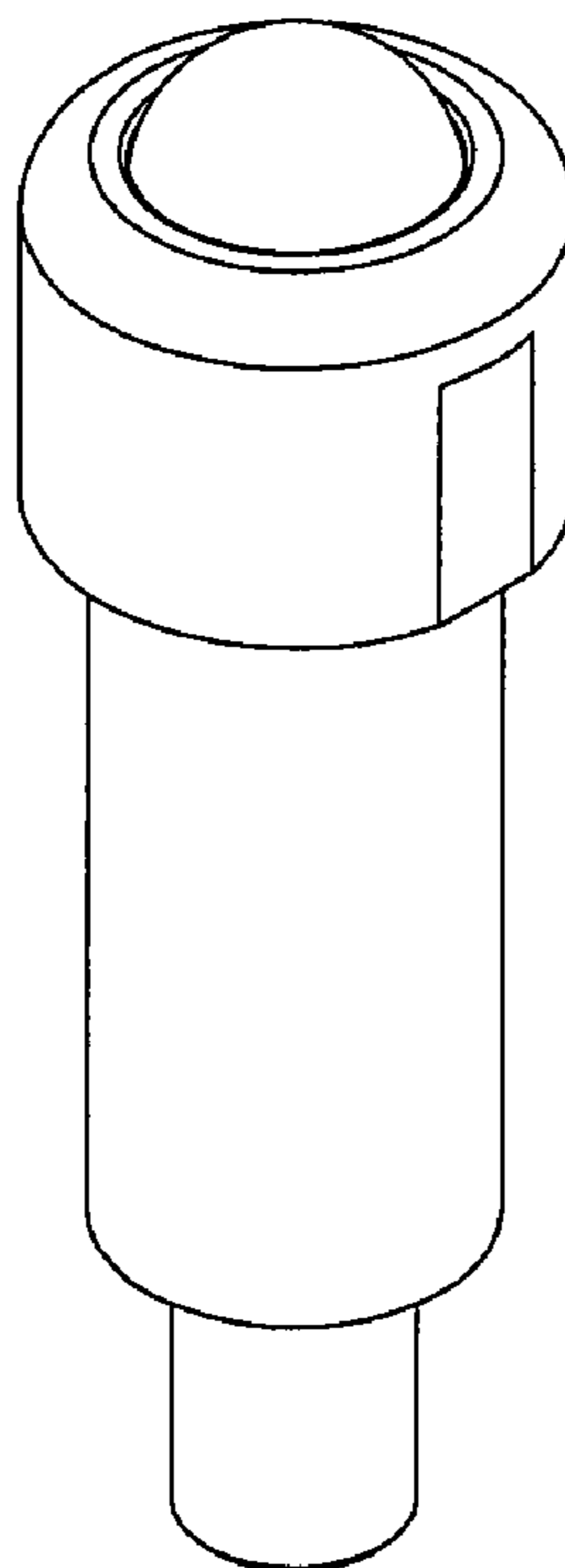
FIG. 5 is a side view of the load lock roller ball support.

The present invention generally includes a load lock roller ball support. The load lock roller ball support includes a vespel ball held in a stainless steel body. The ball is maintained in the body by a stainless steel cap that is coupled to the stainless steel body.

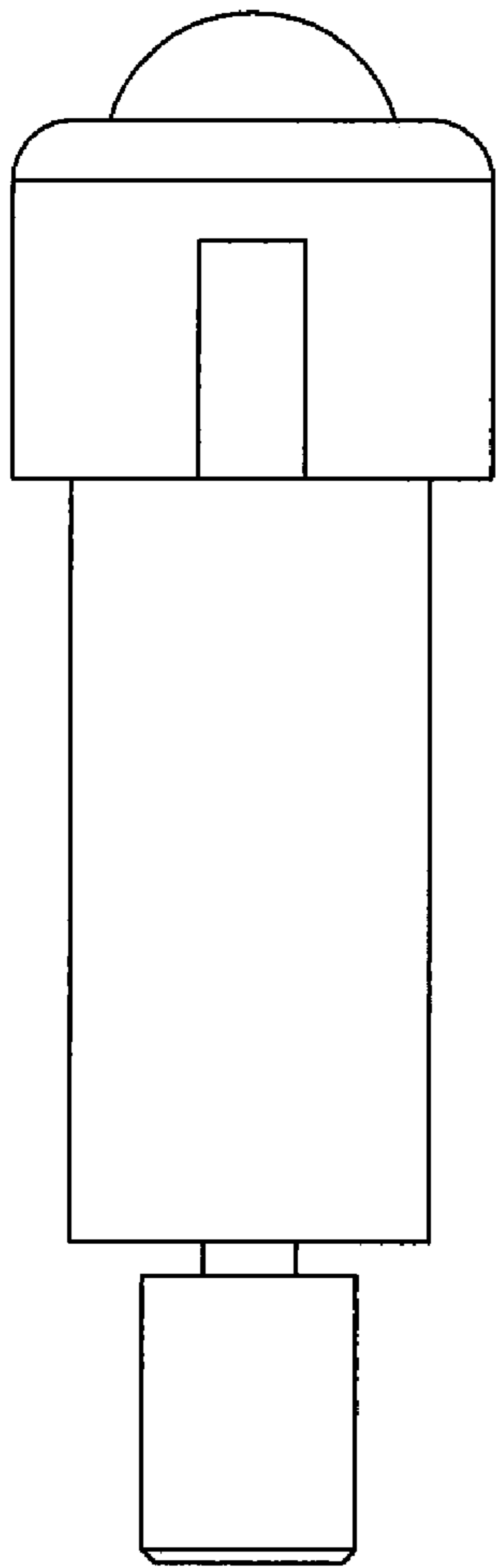

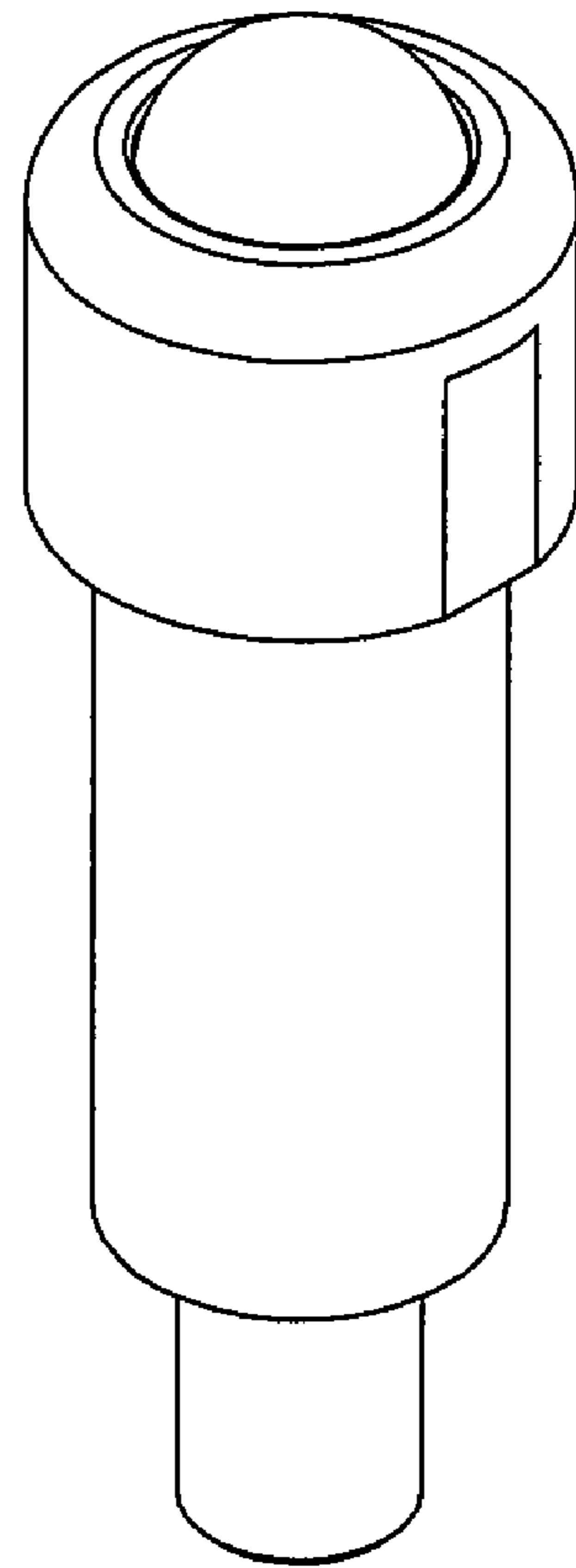

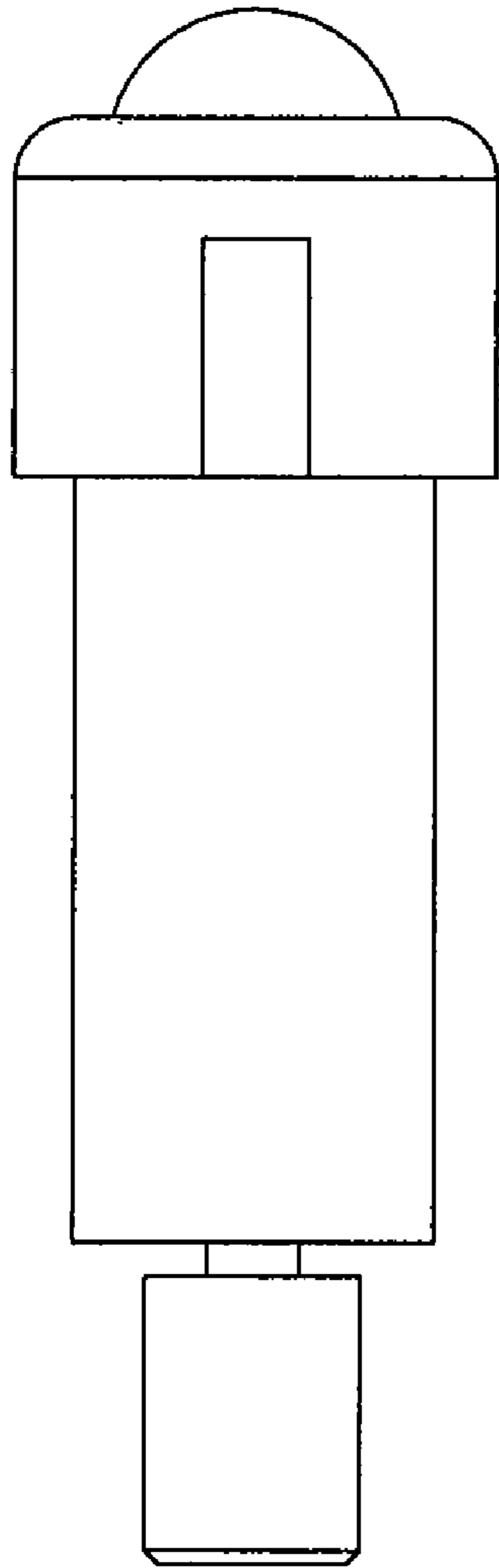

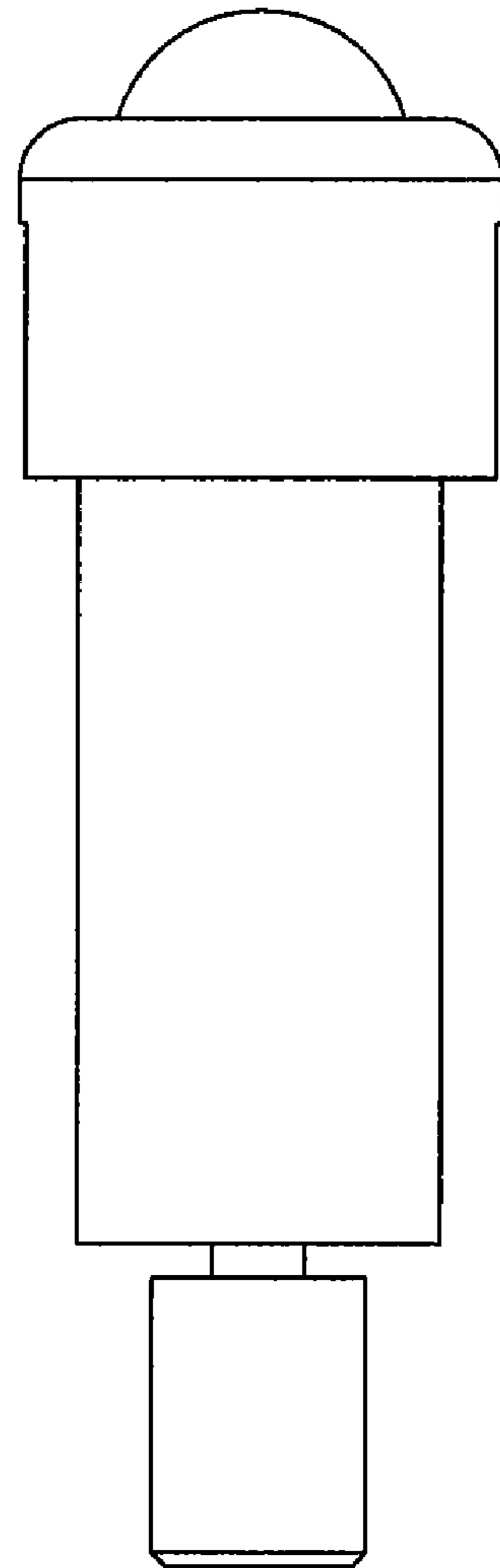

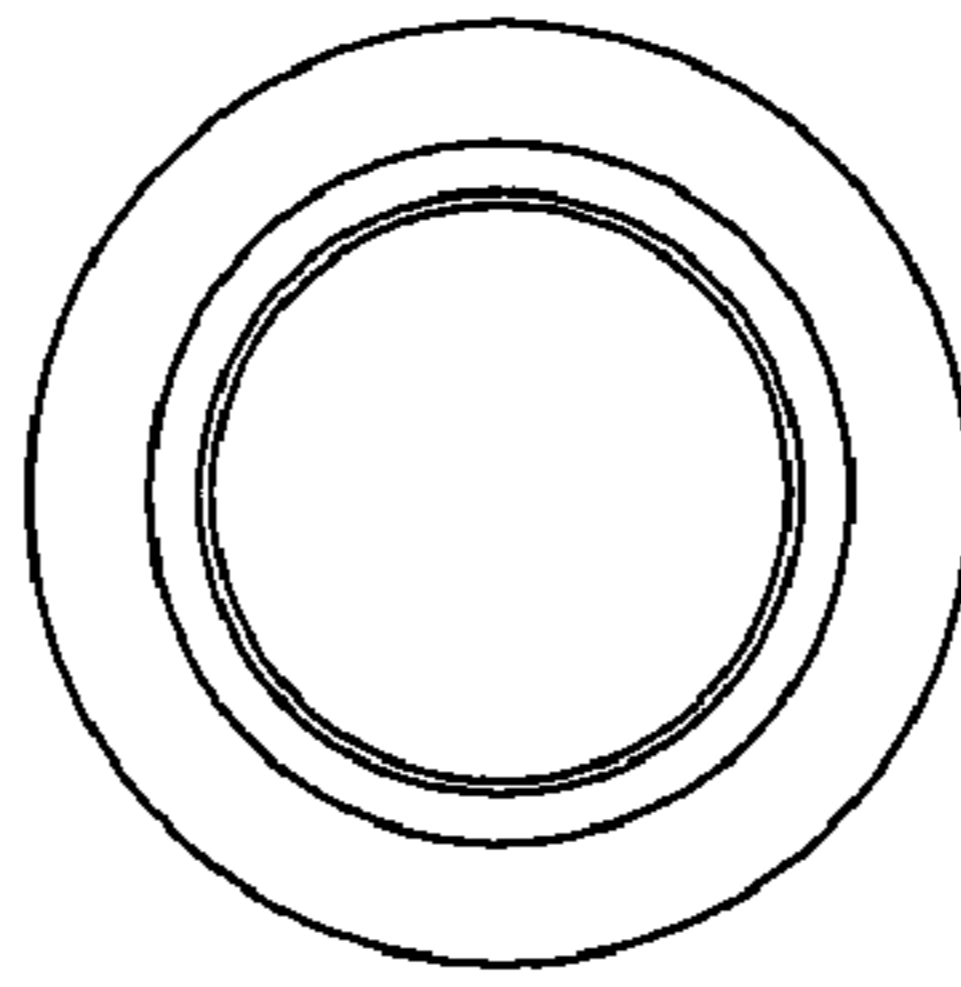

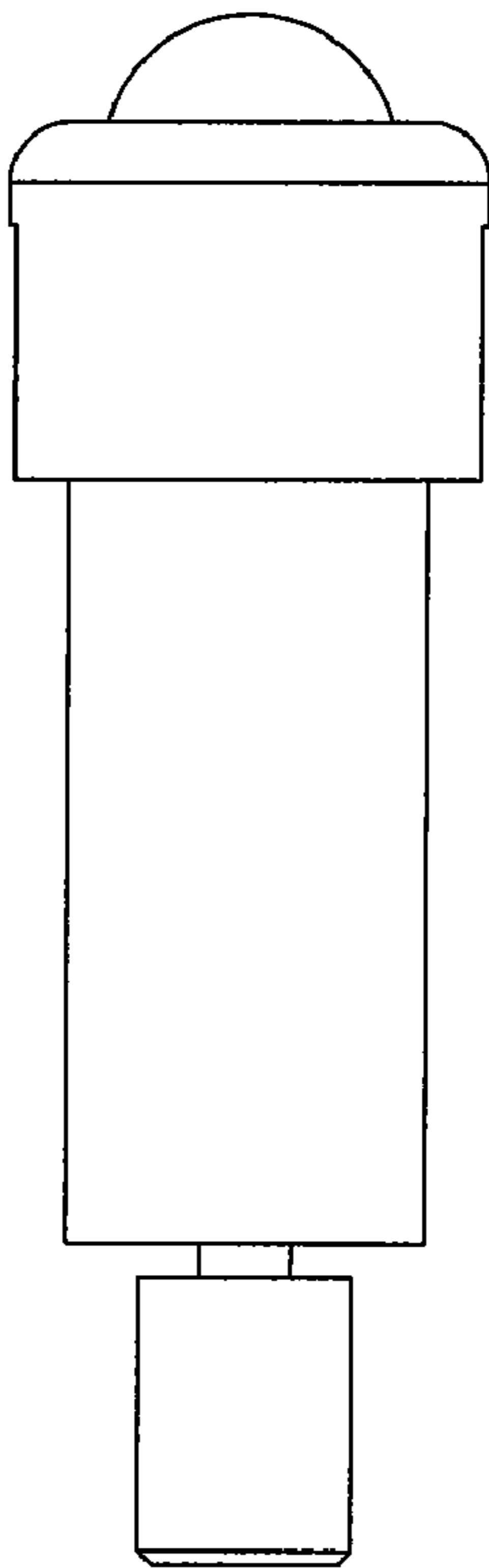

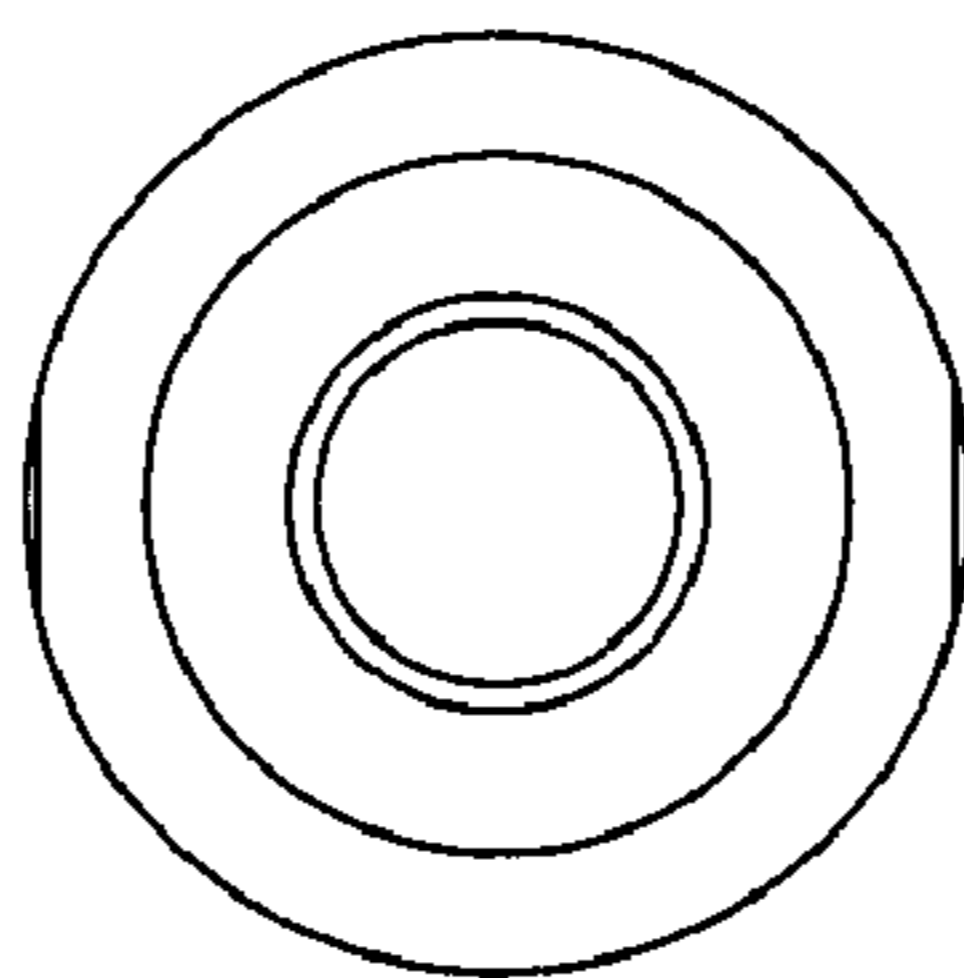
