described.

DESCRIPTION

FIG. 1 is a perspective view of sunglasses taken from the
front, top and right side thereof, showing my new design;

FIG. 2 is a perspective view taken from the rear, top and left
side thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a right side elevational view thereof, the left side
elevational view being a mirror image of the right side eleva-
tional view.

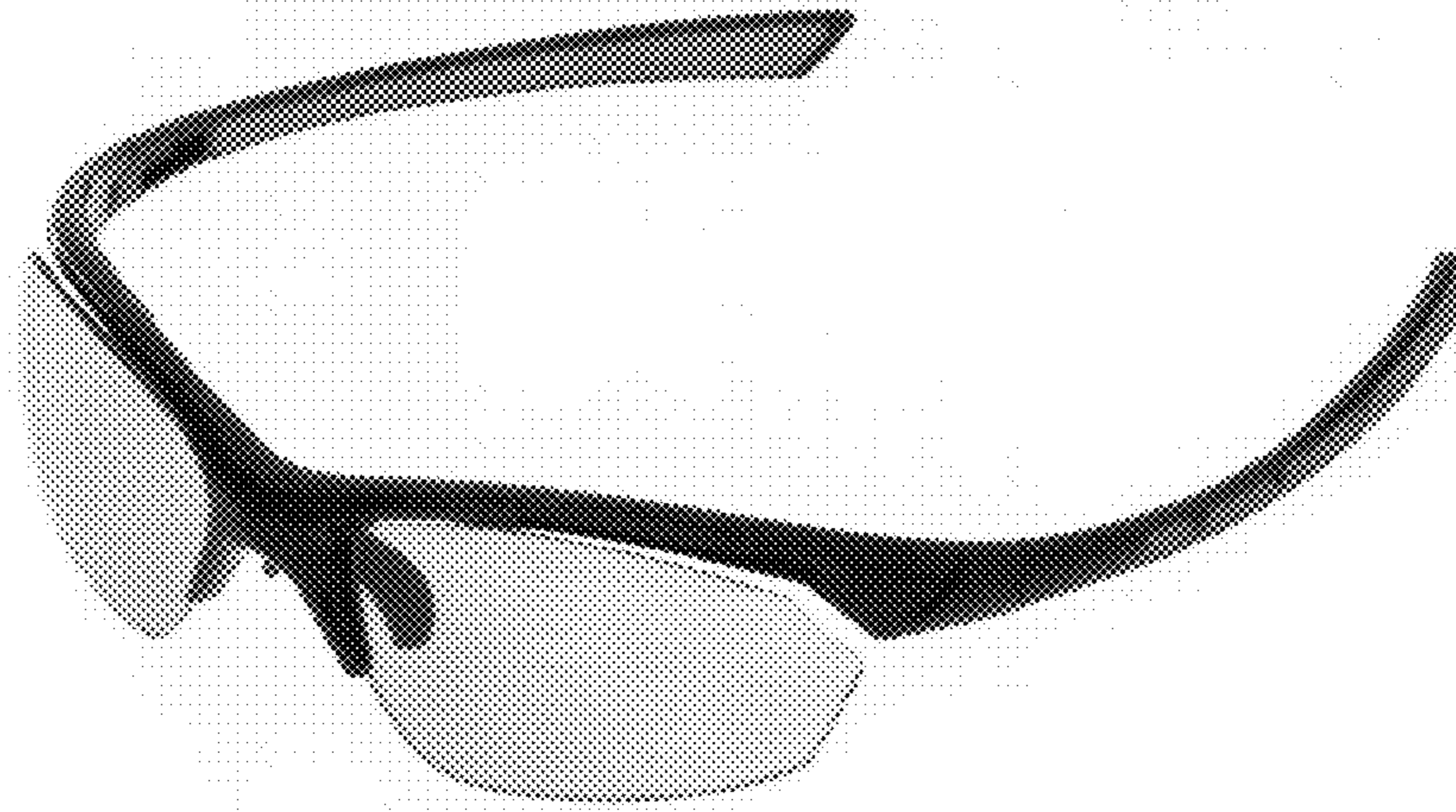

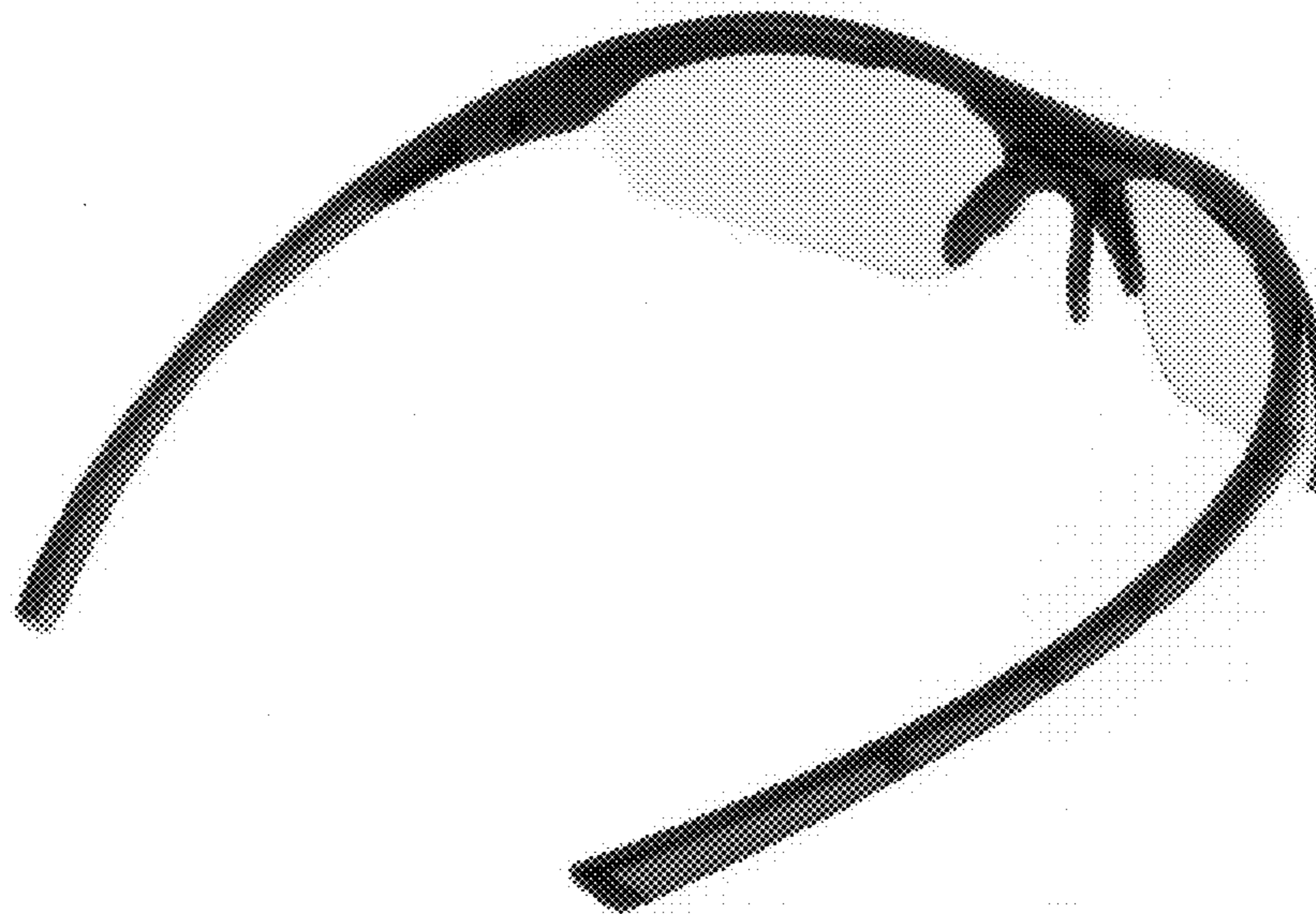

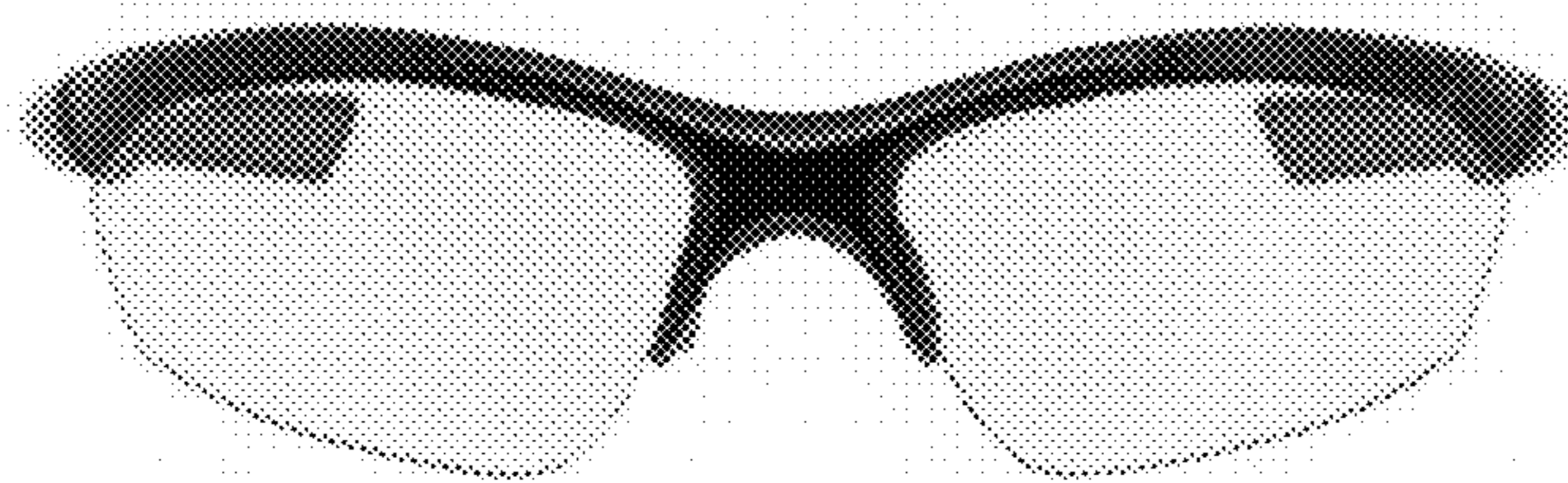

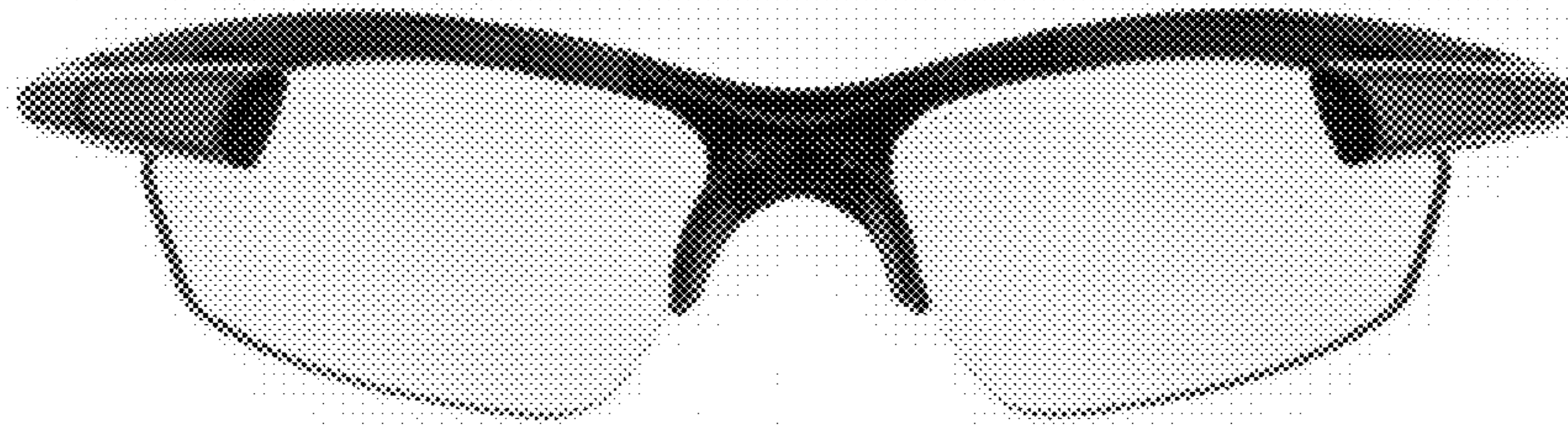

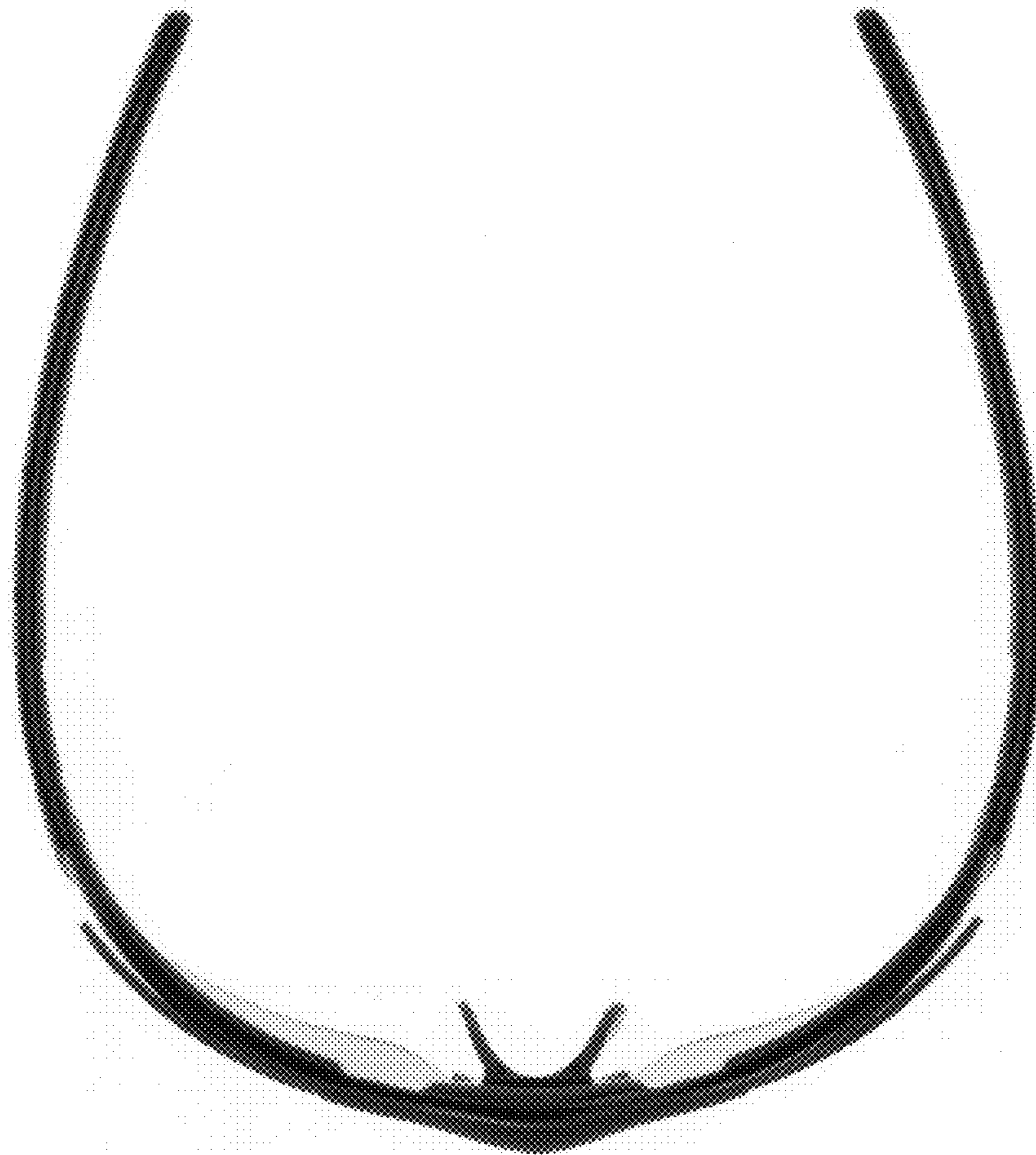
