FIG. 4 is a front perspective view thereof;

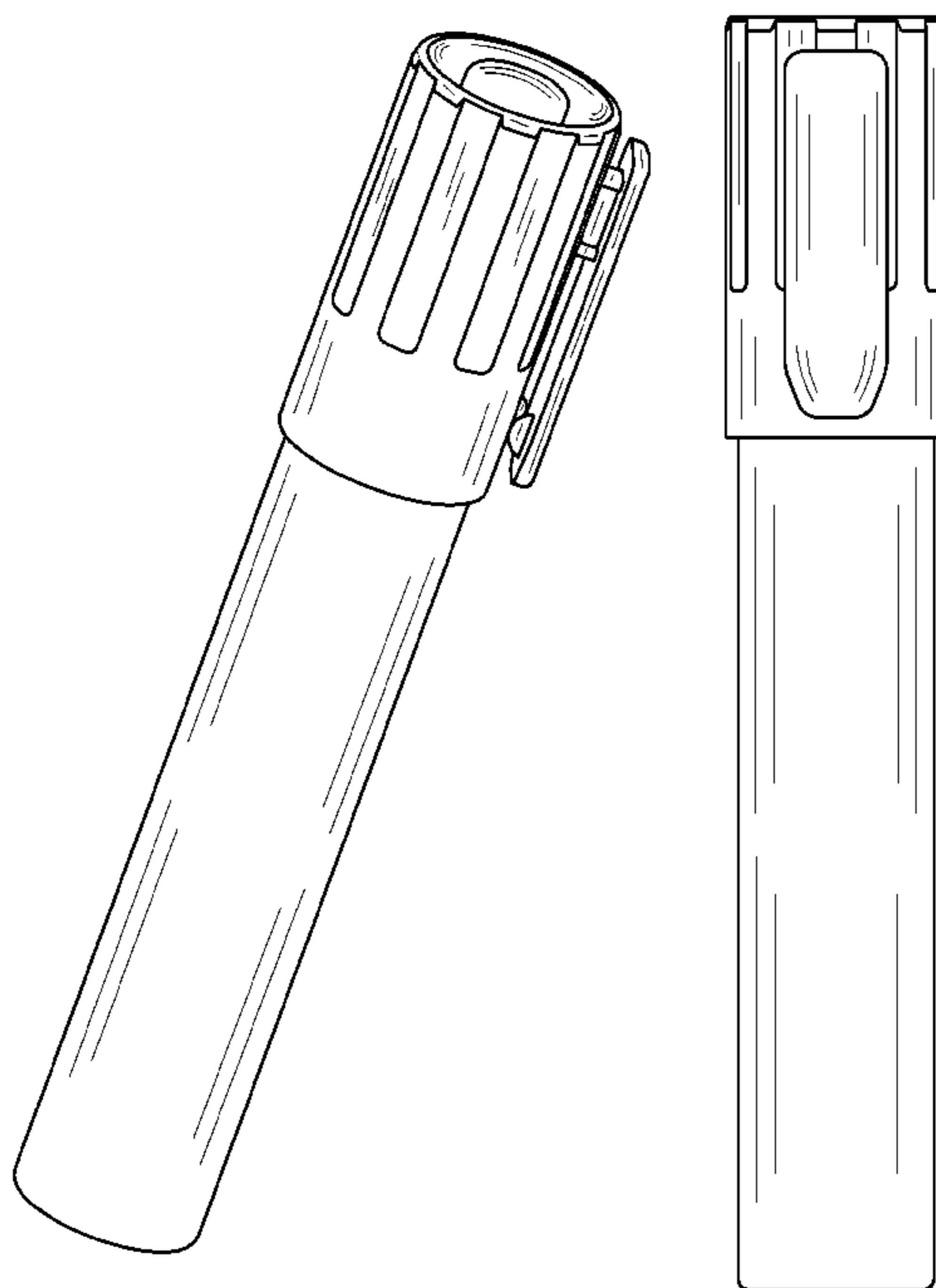
FIG. 5 is a left side elevation view thereof;

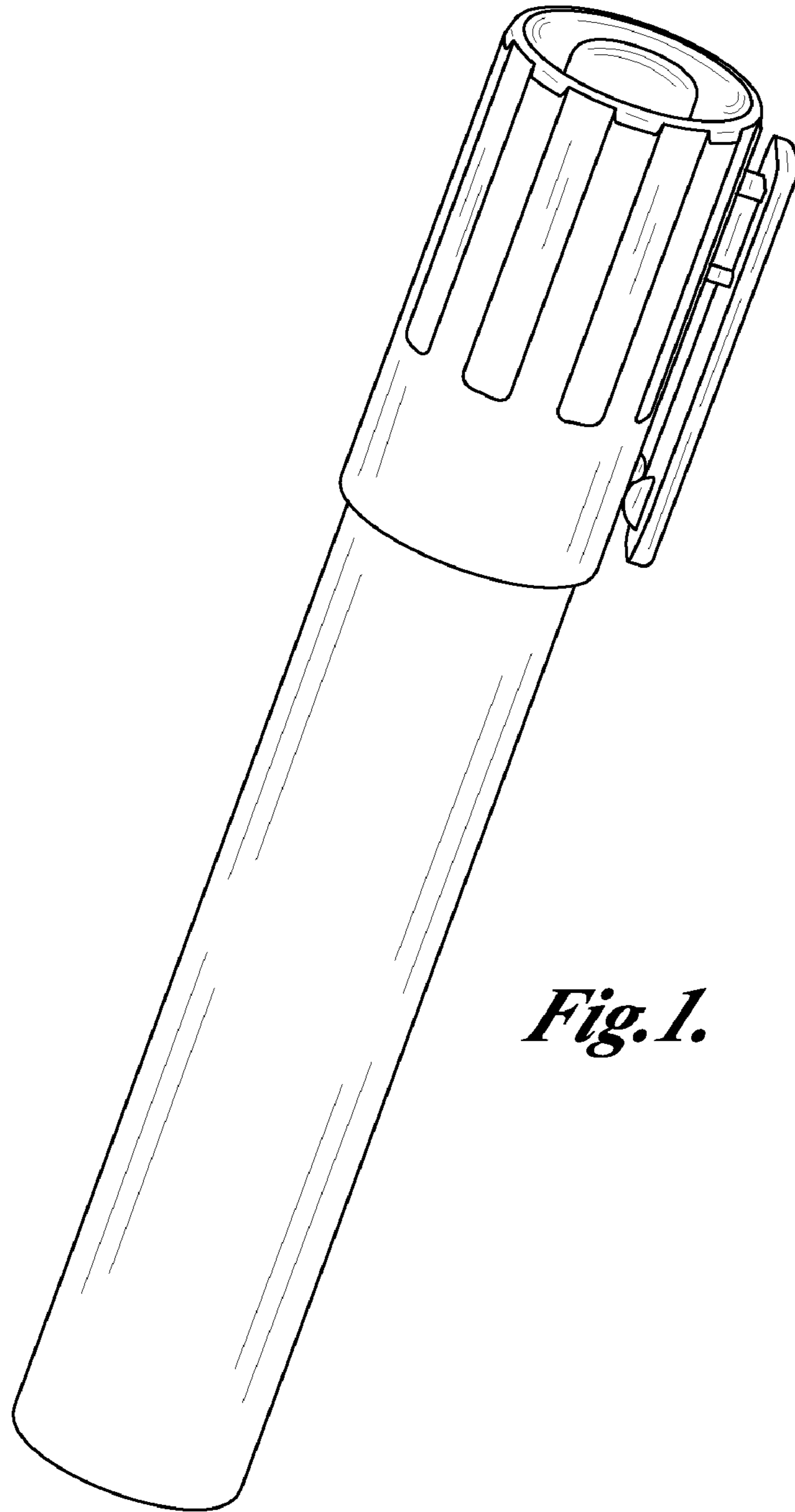
FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a rear elevation view thereof.

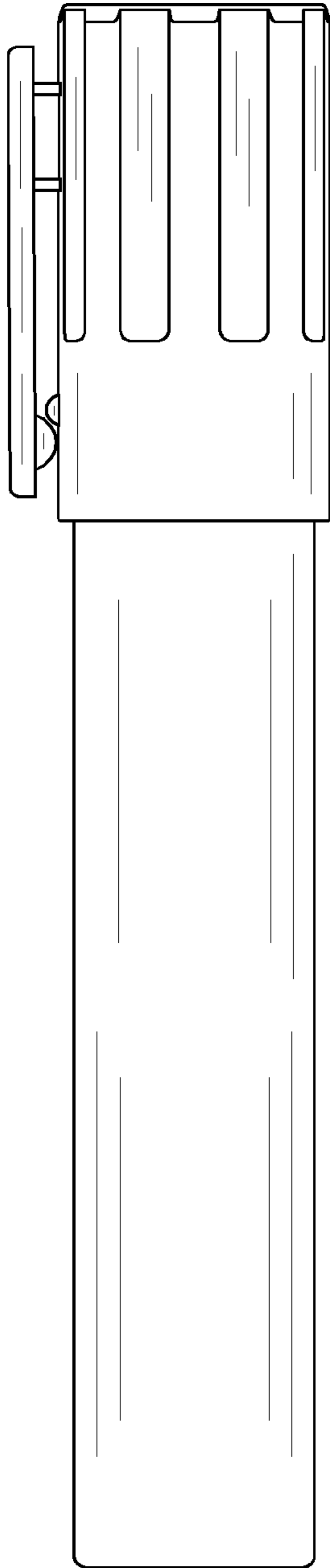
The broken lines showing portions of the top are included for the purpose of illustrating environment and form no part of the claimed design.

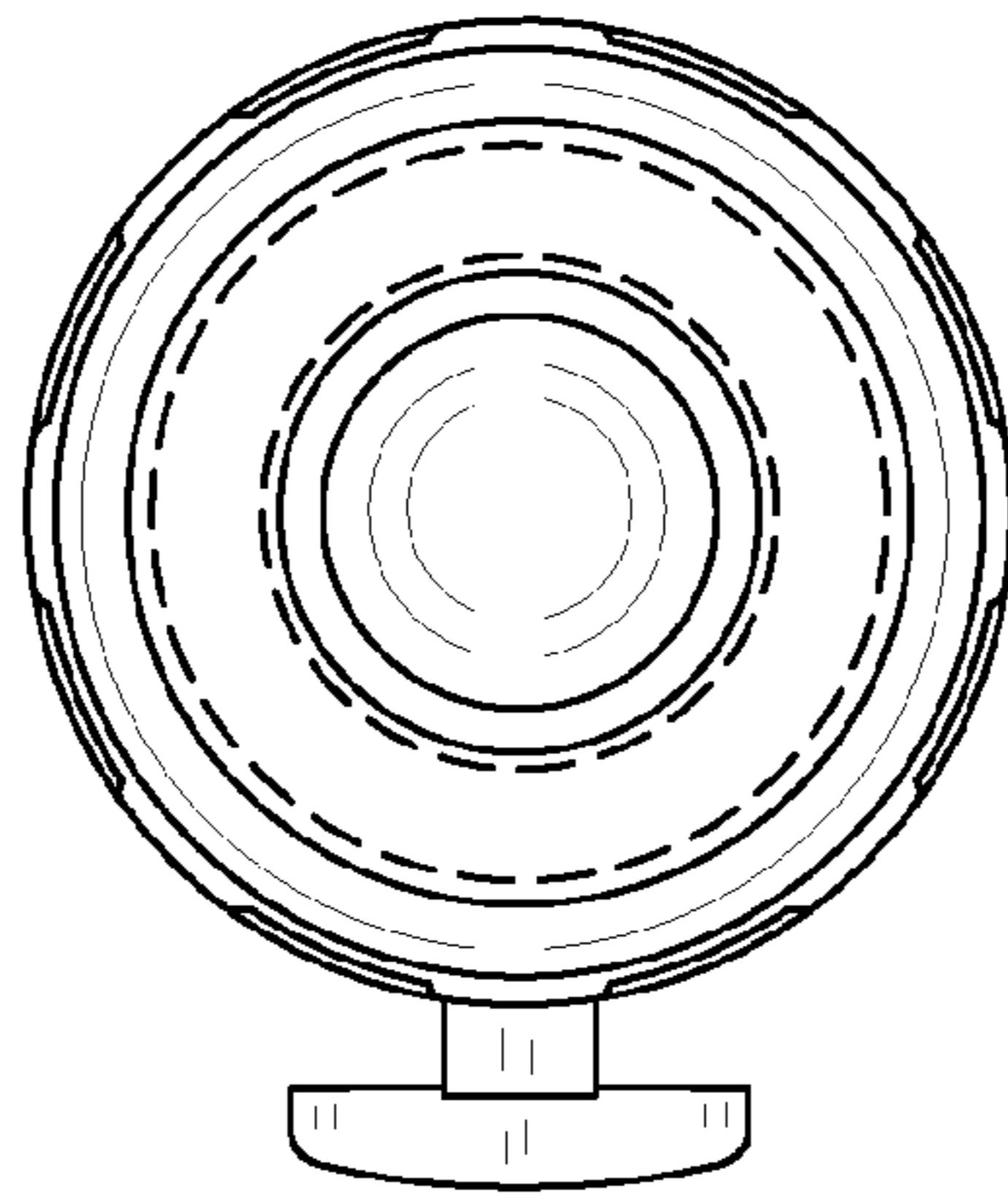




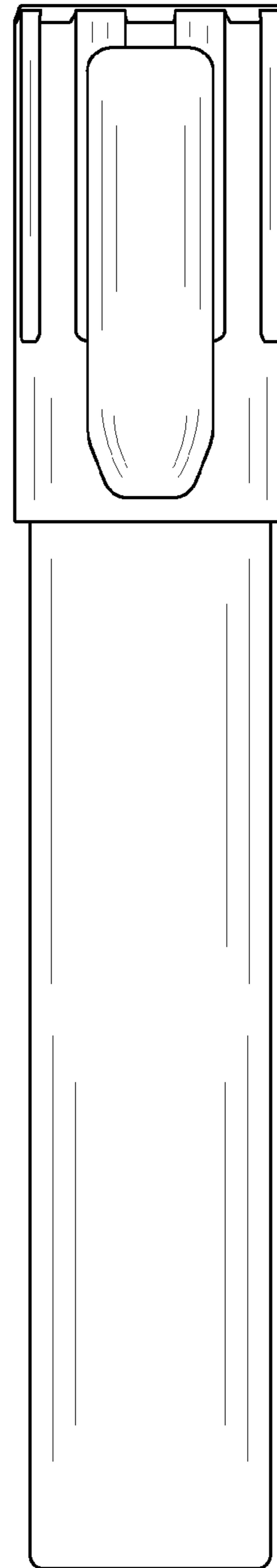

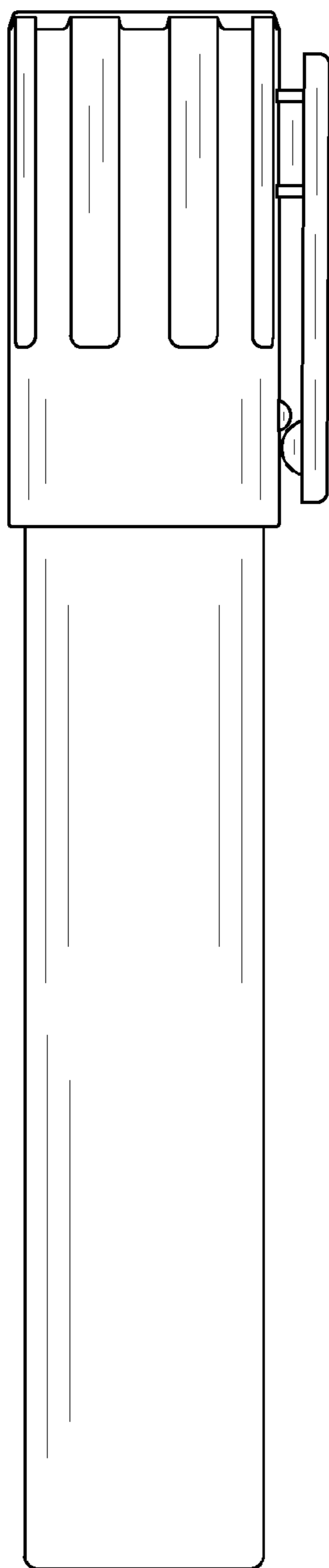

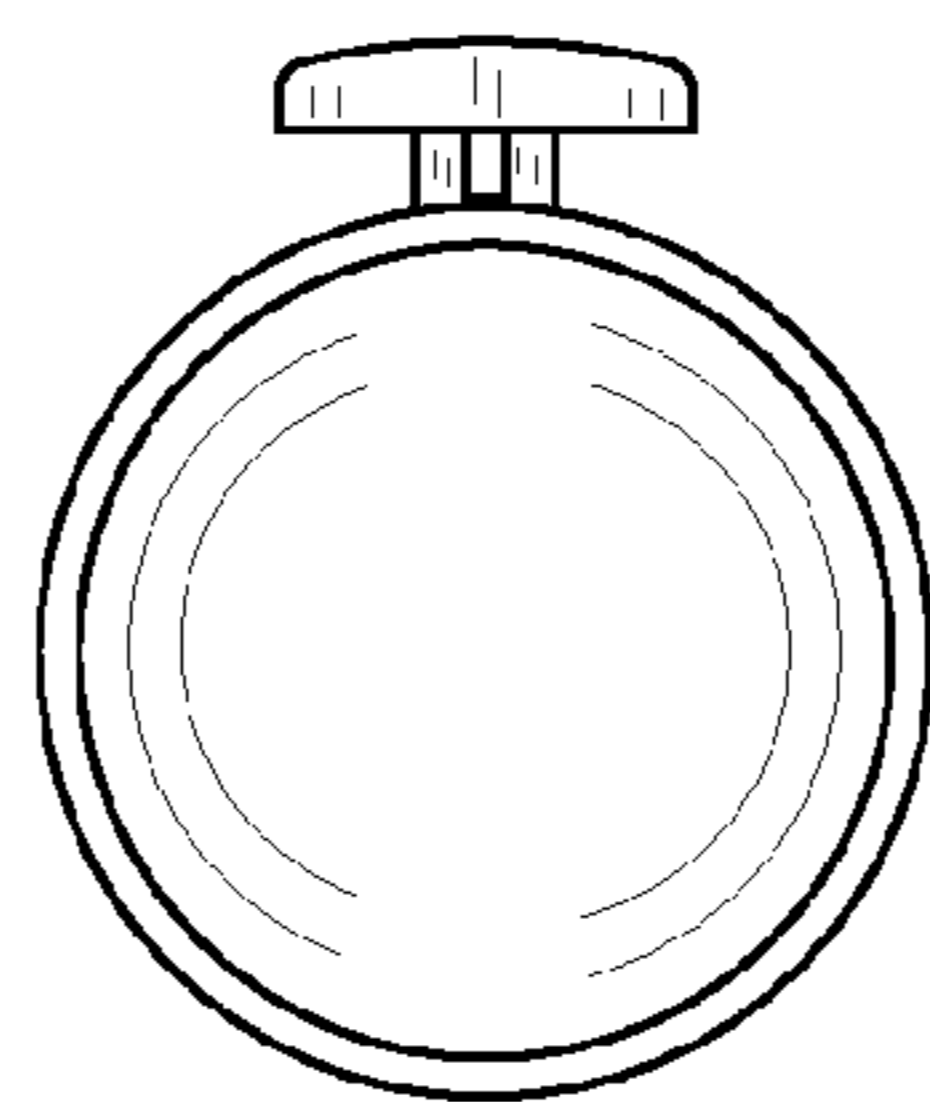

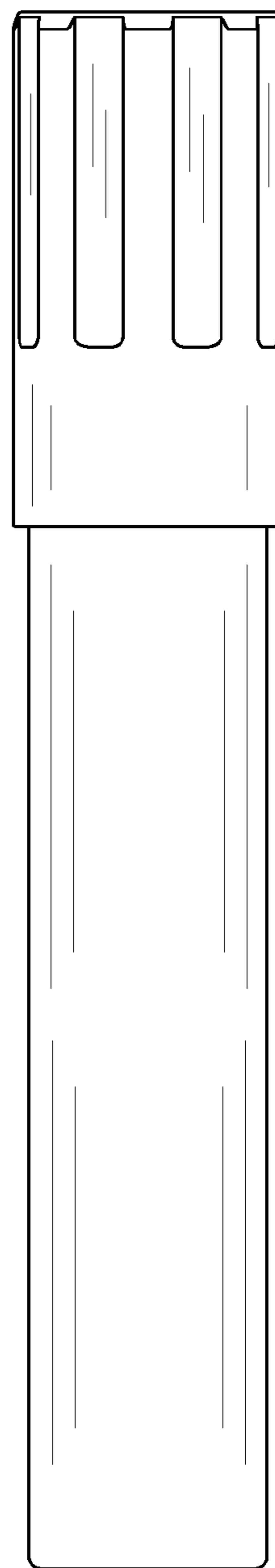
