(57) **CLAIM**

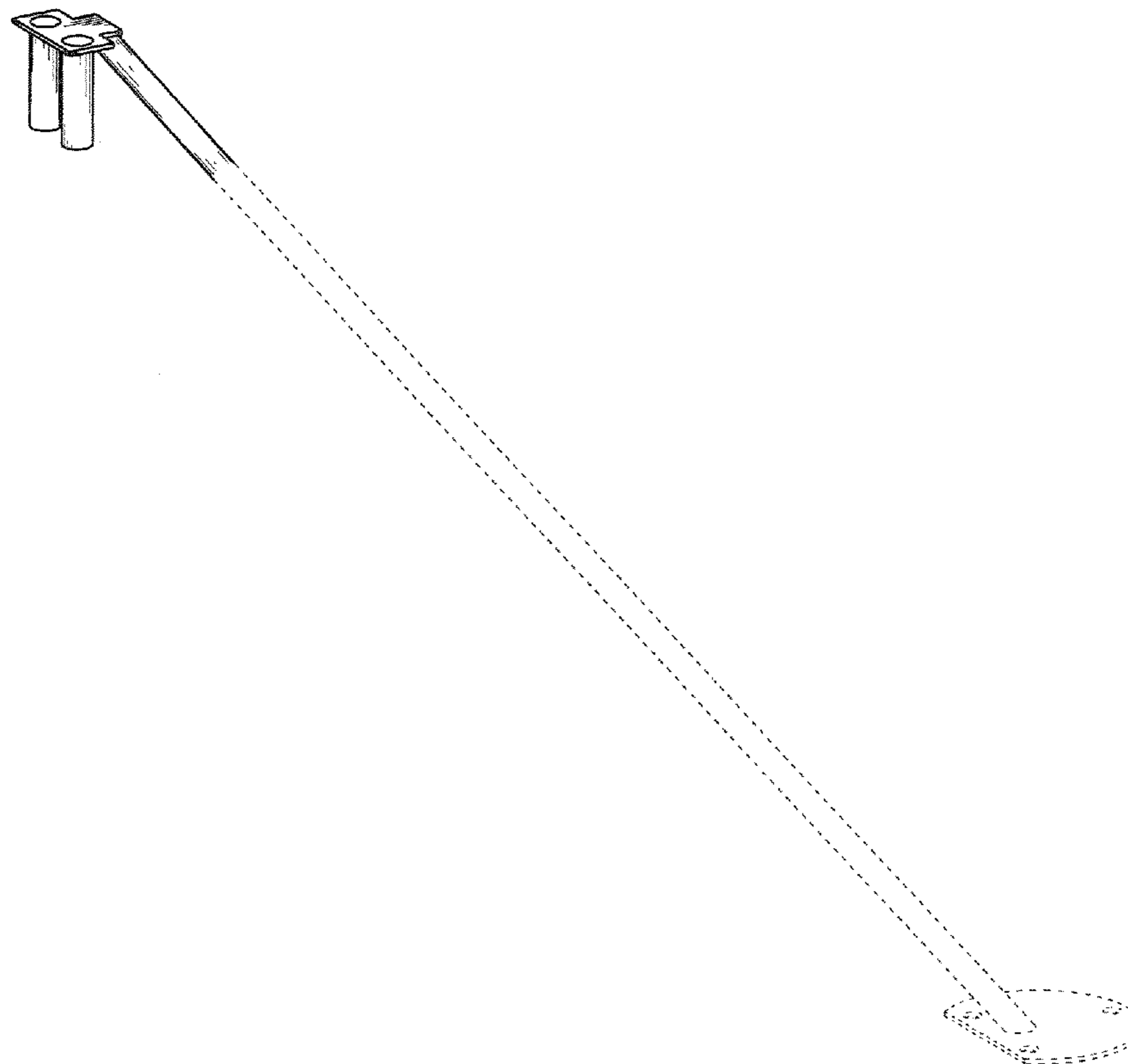
The ornamental design for the prefabricated building part, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a prefabricated building part, of my new design;
FIG. 2 is an enlarged perspective view of the part of FIG. 1;
FIG. 3 is a top plan view thereof;
FIG. 4 is a right side elevational view, the left side elevational view being a mirror image thereof;
FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a rear elevational view thereof.

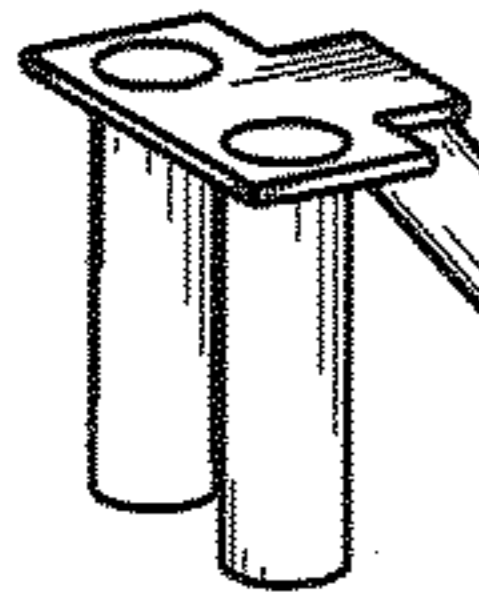

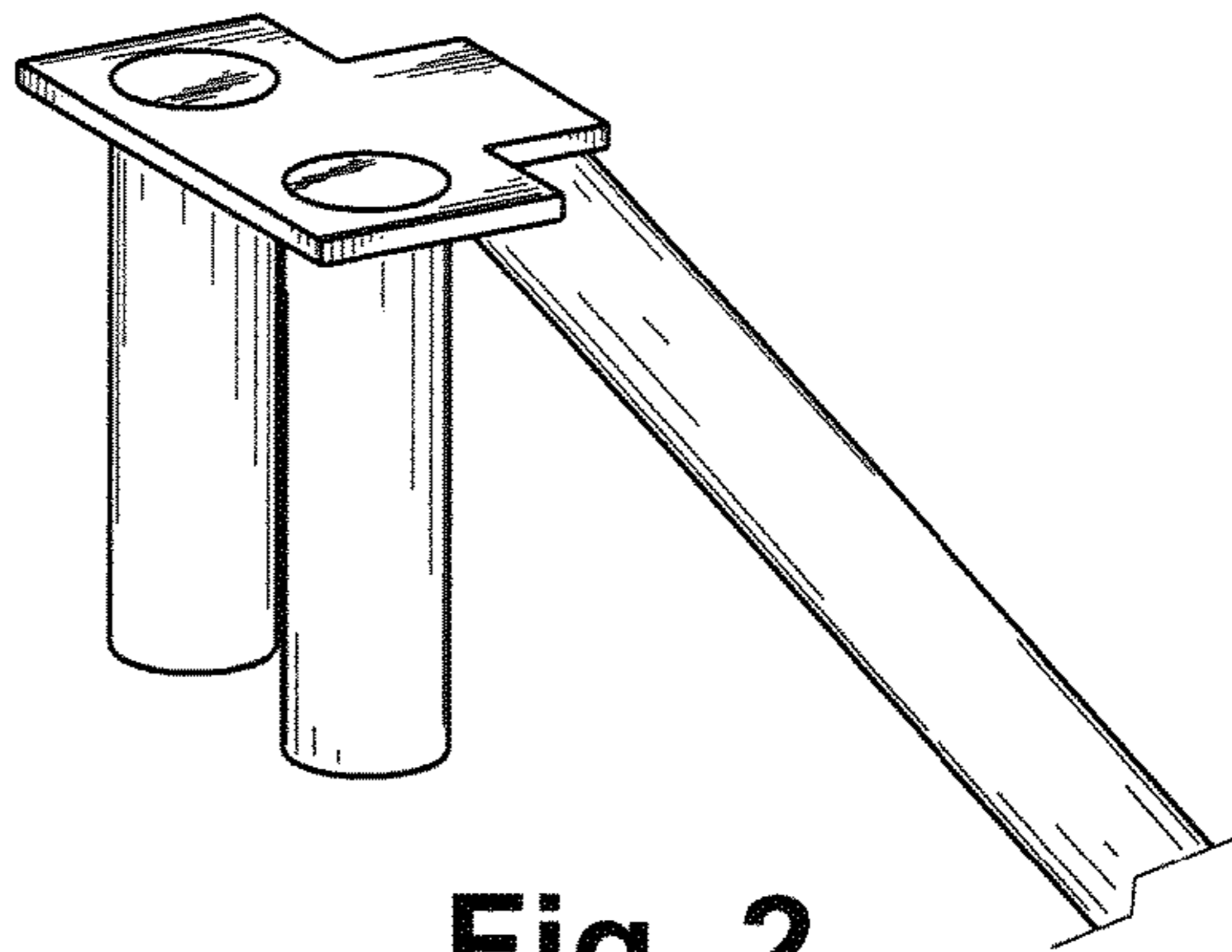

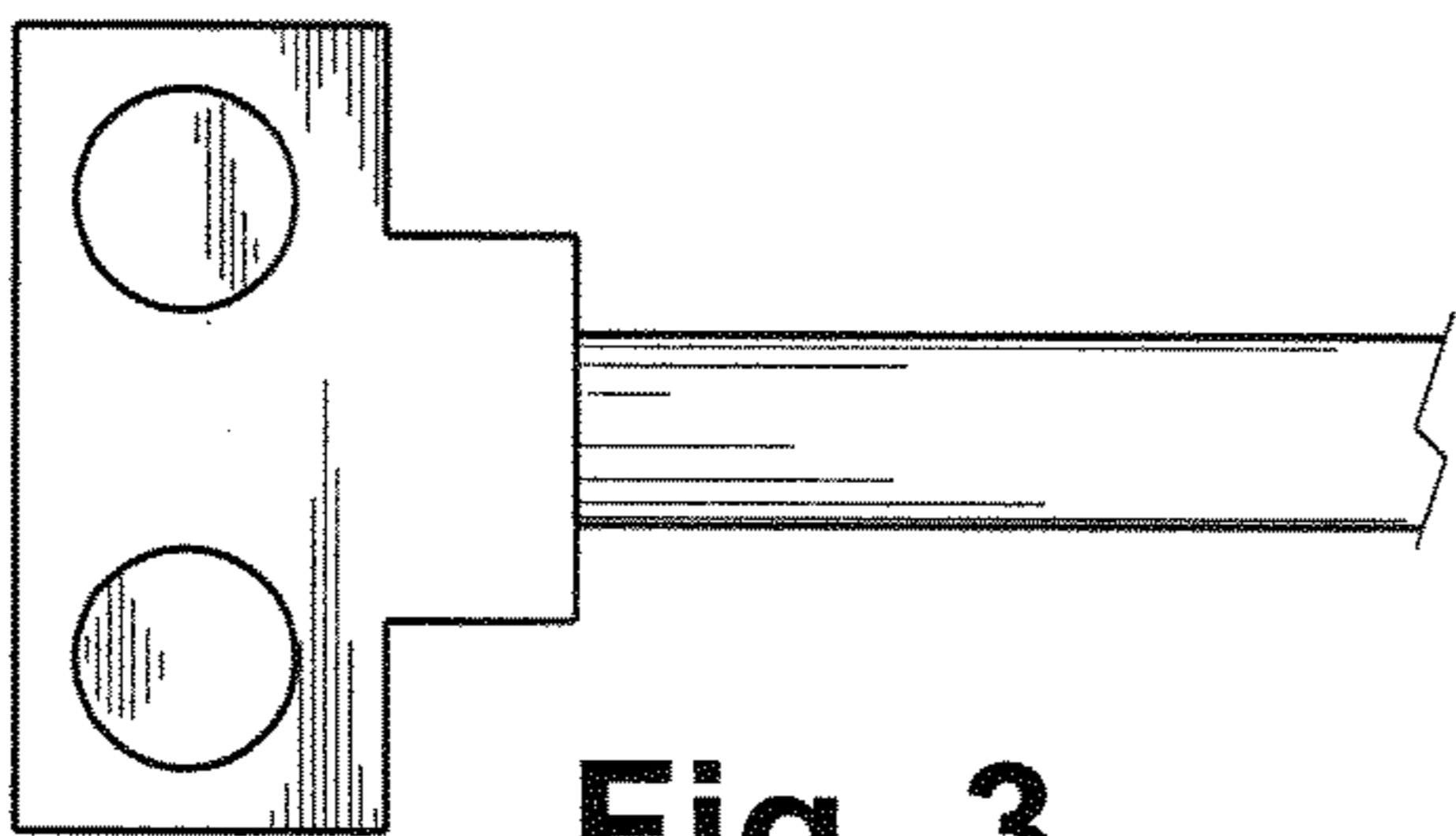

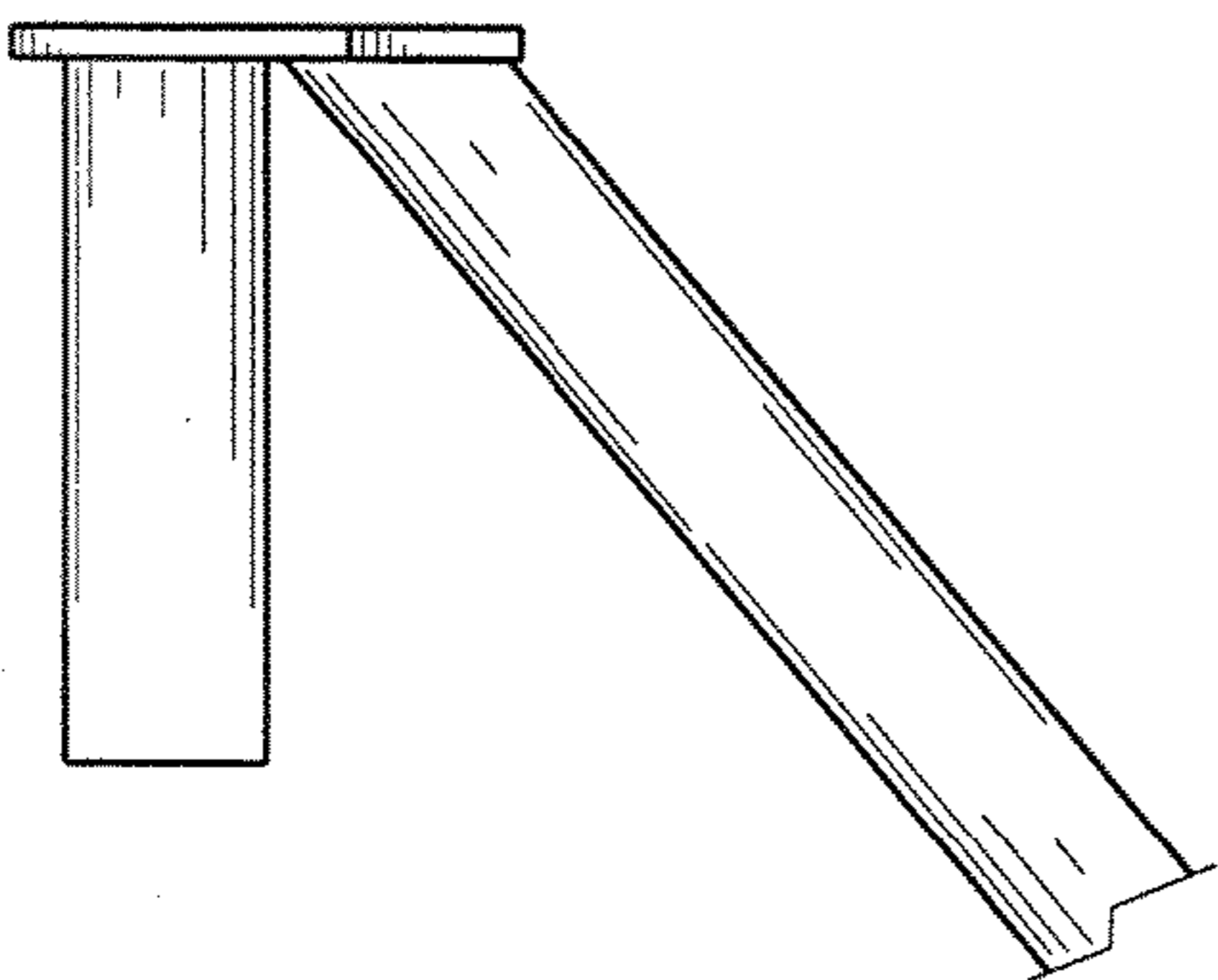

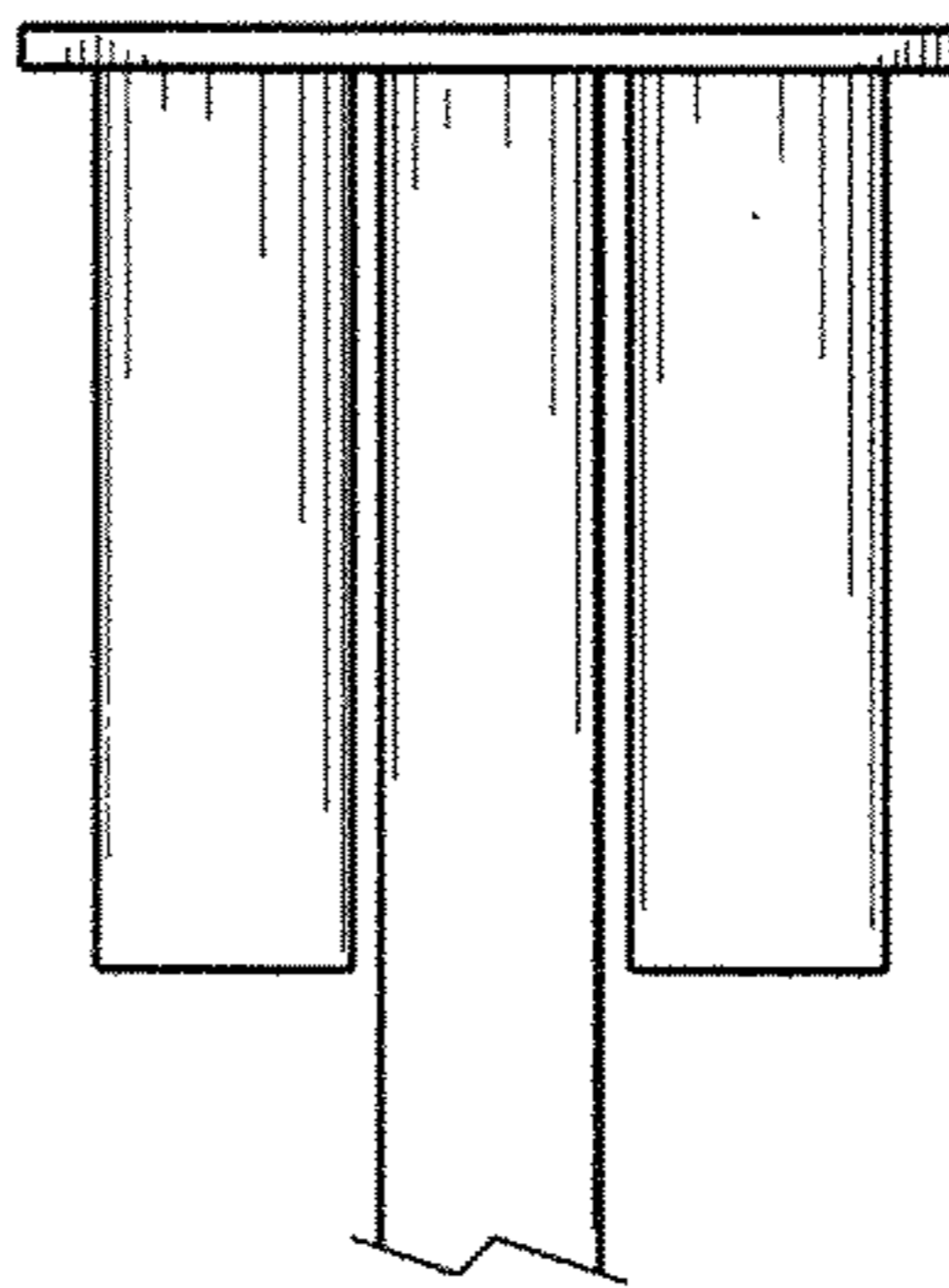

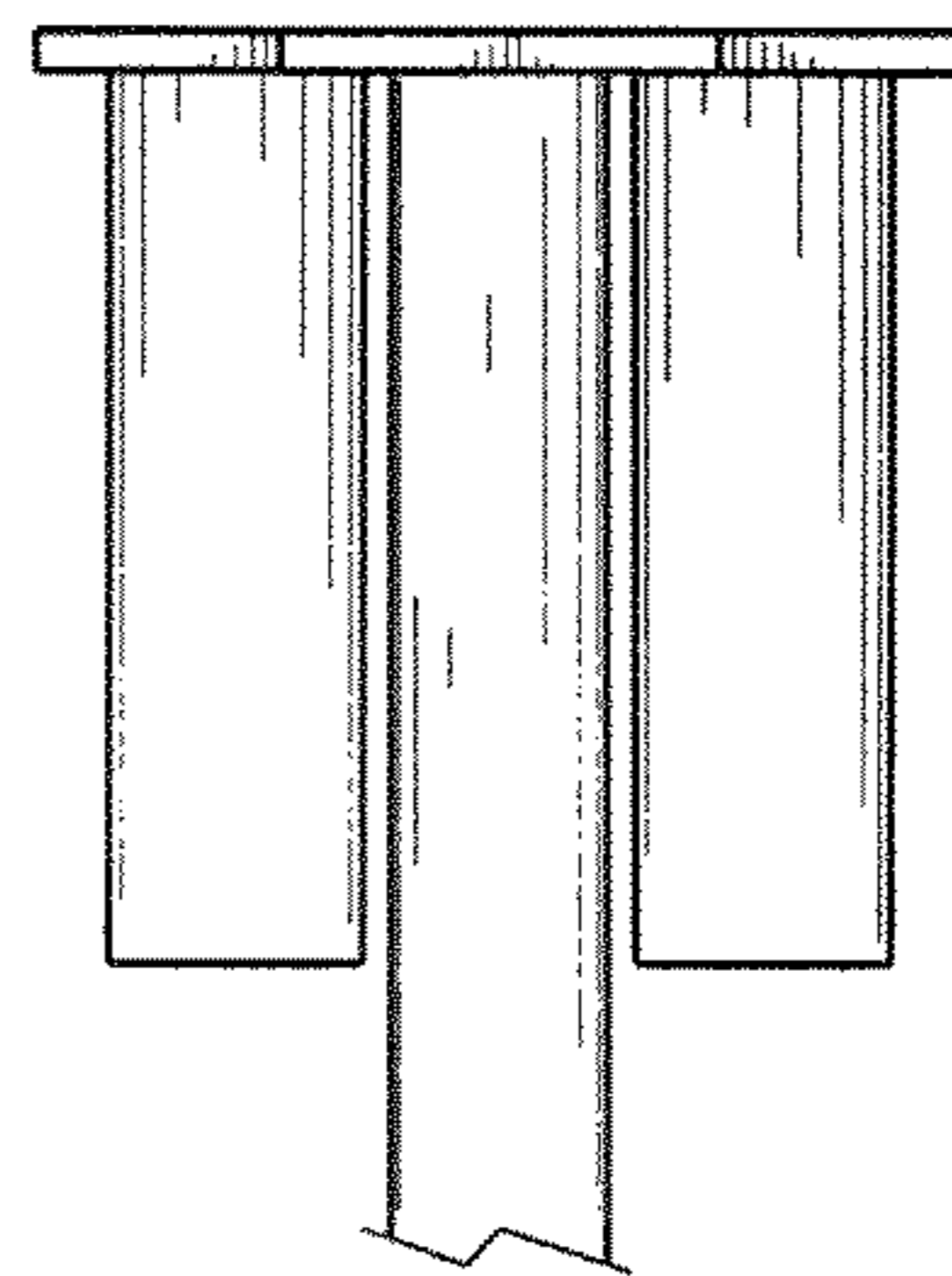
