FIG. 1 is a perspective view of the cleaning sponge roller;

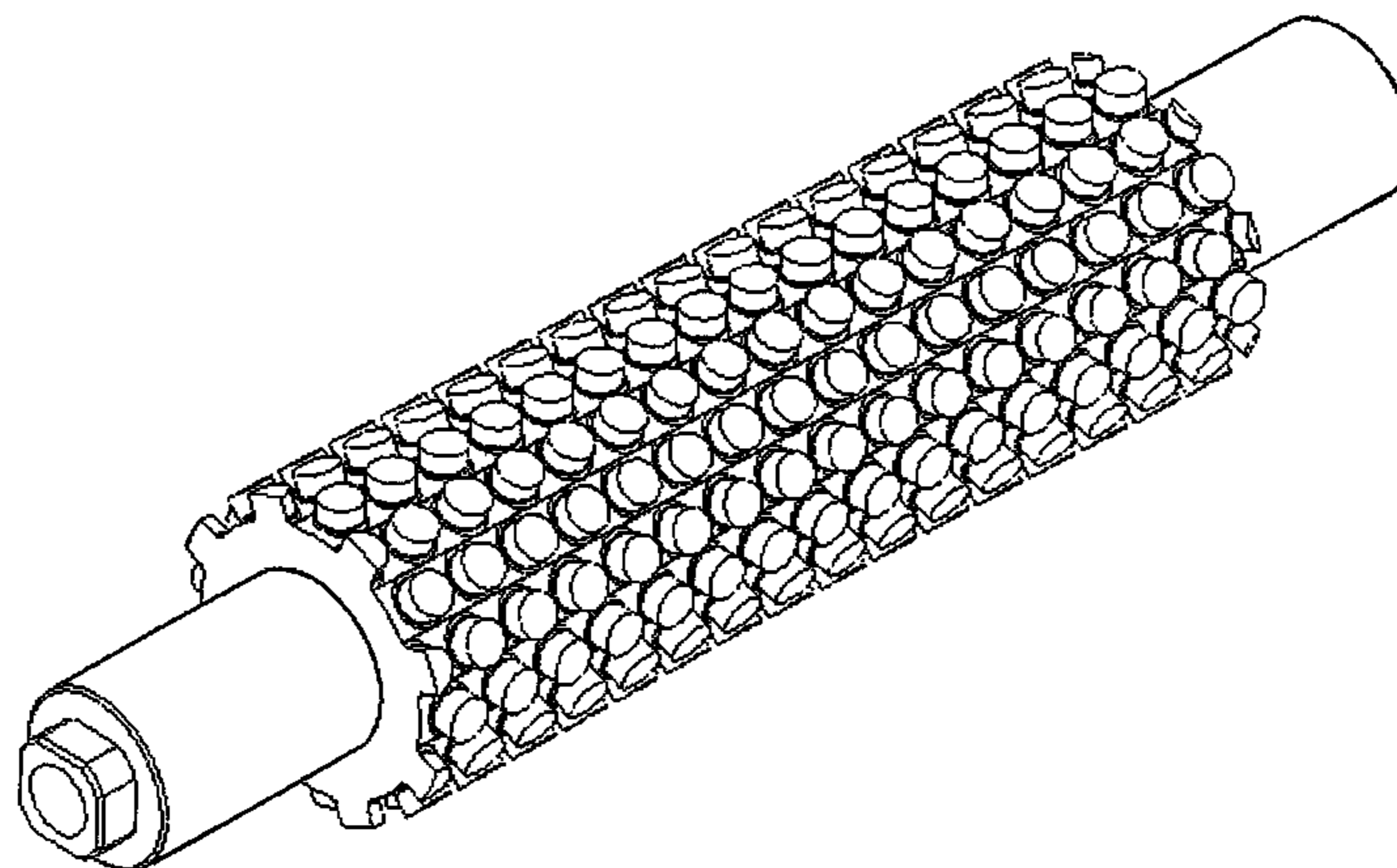
FIG. 2 is a front view of the cleaning sponge roller;

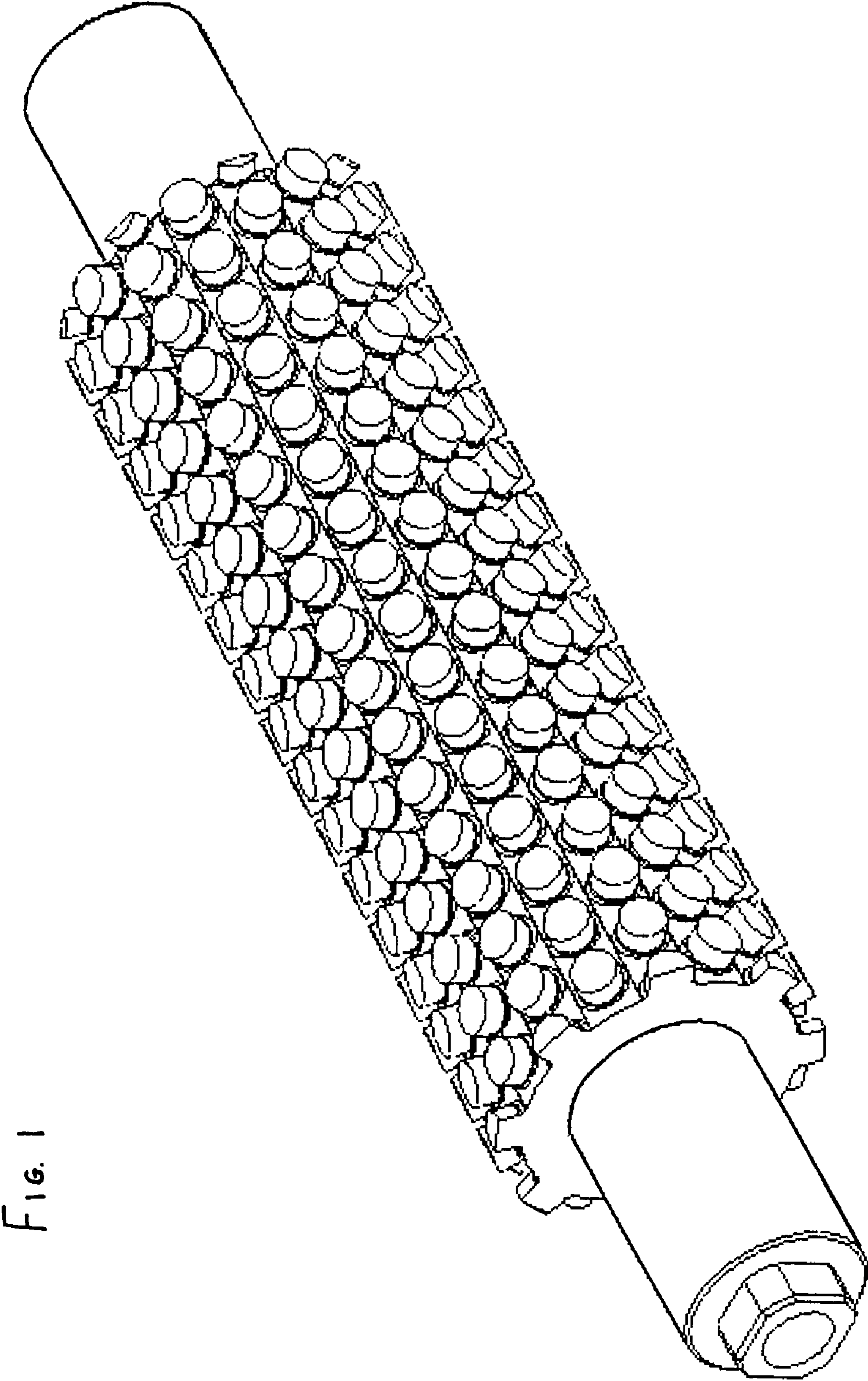
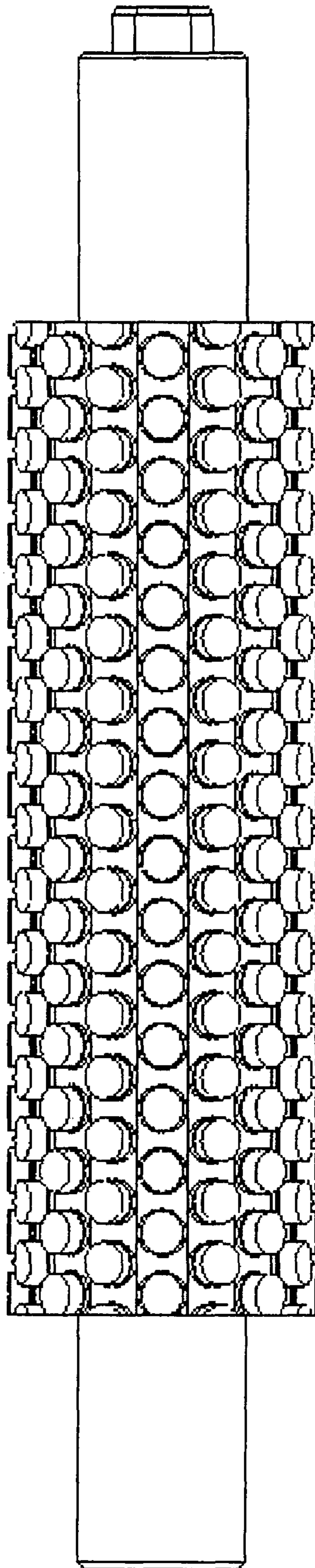

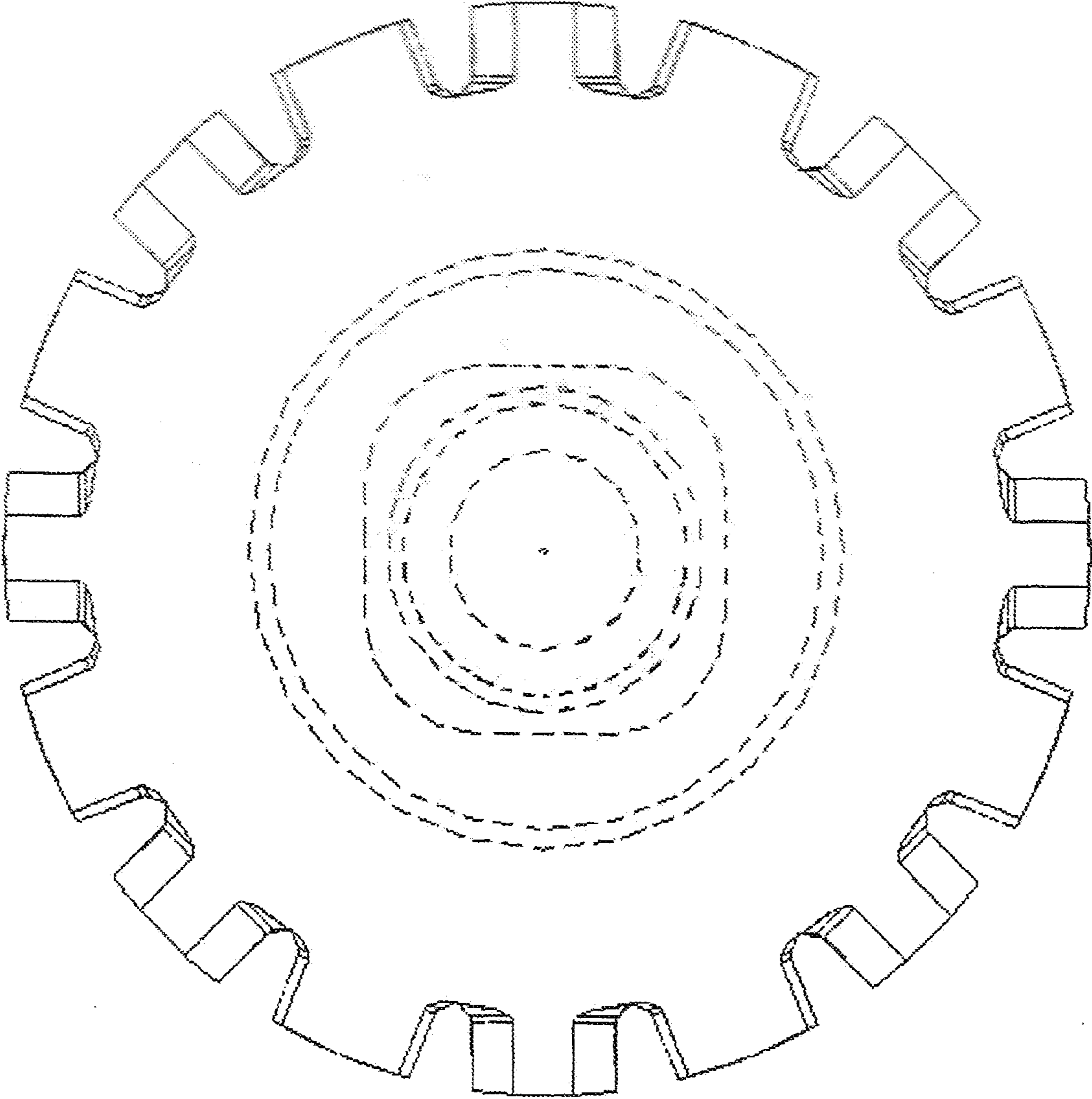

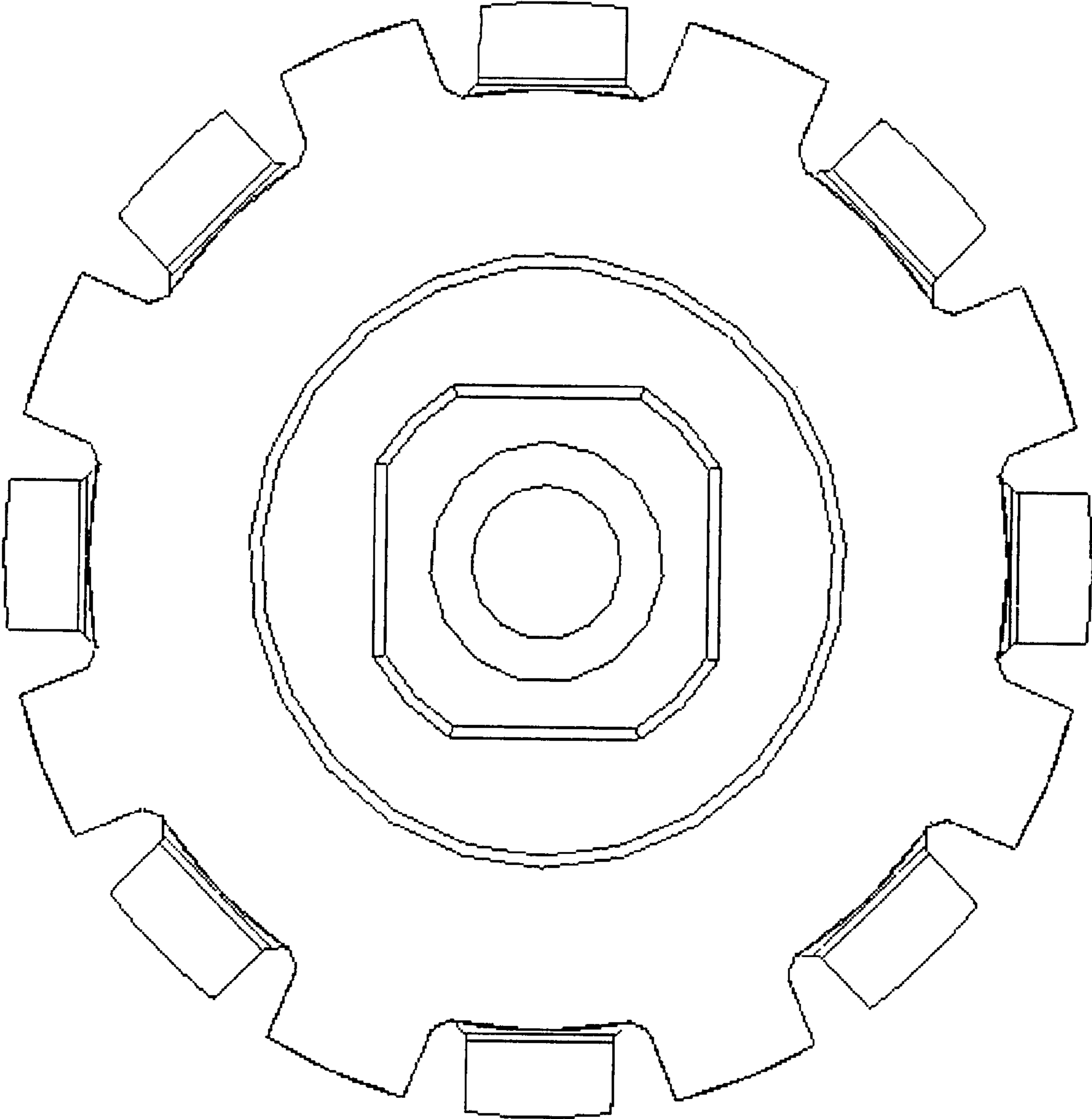
