(57) **CLAIM**

I claim the ornamental design for a grave cover, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the grave cover;
FIG. 2 is a bottom plan view of the grave cover;
FIG. 3 is a right side elevational view, the opposite side appearing the same; and,
FIG. 4 is a first end view, the opposite end being identical.

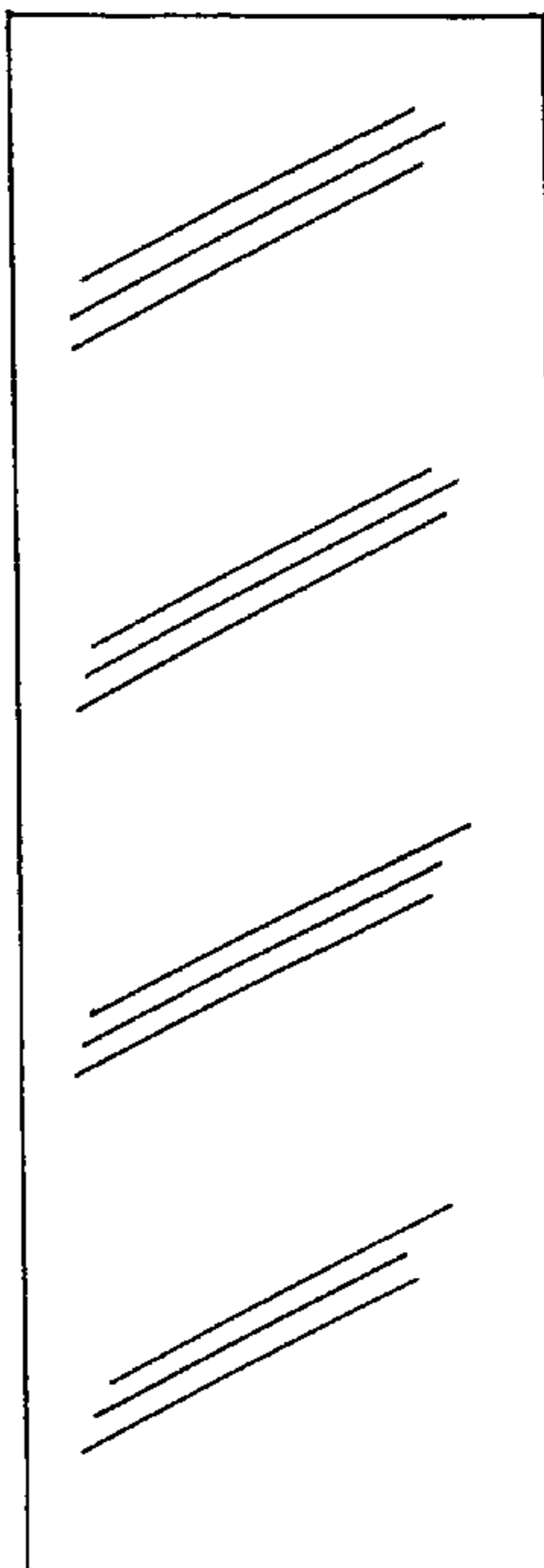

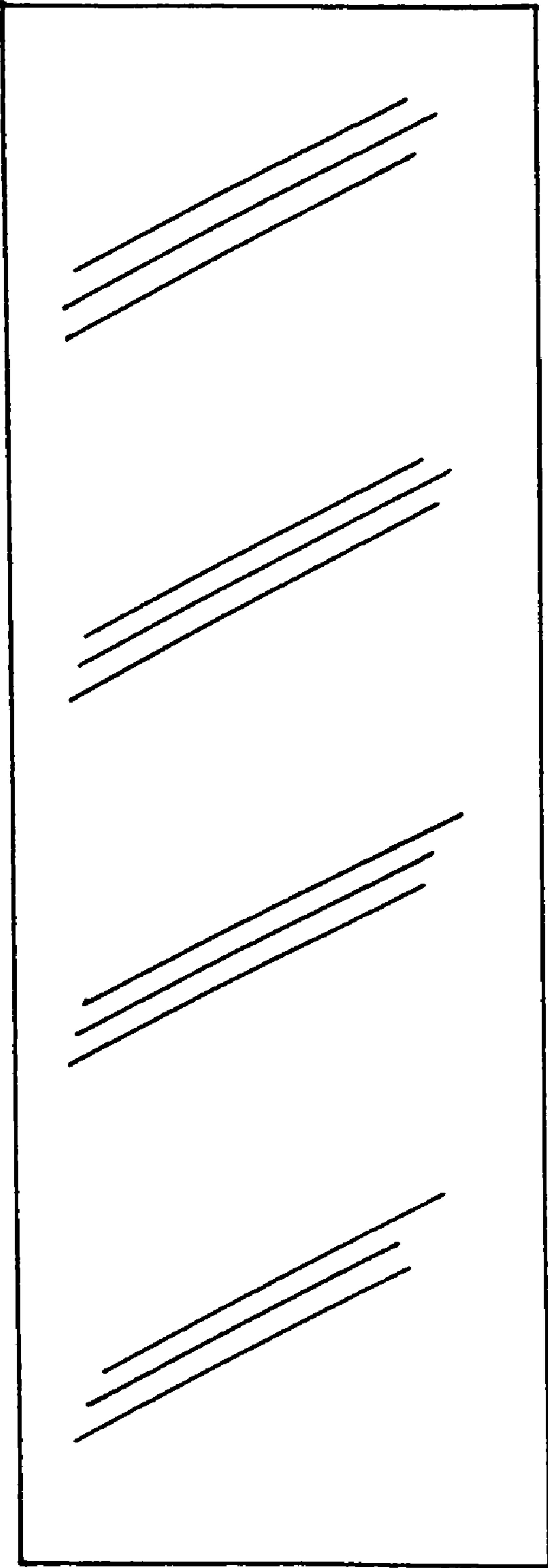

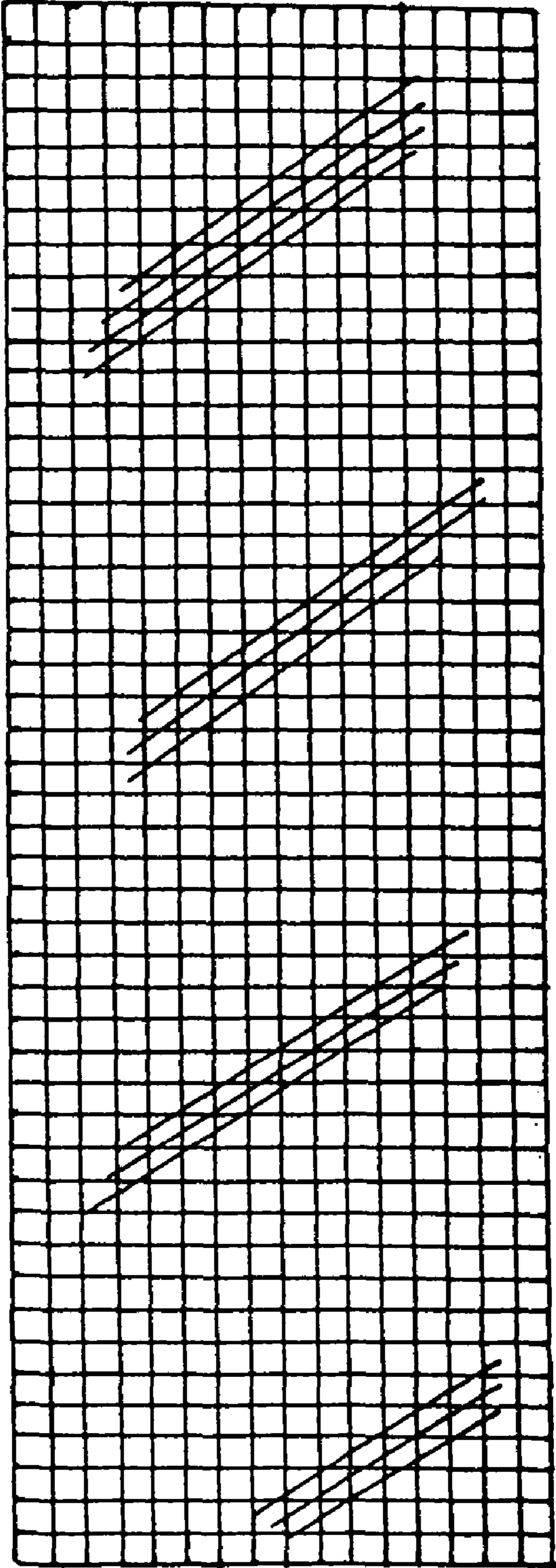
