FIG. 2 is a back view thereof;

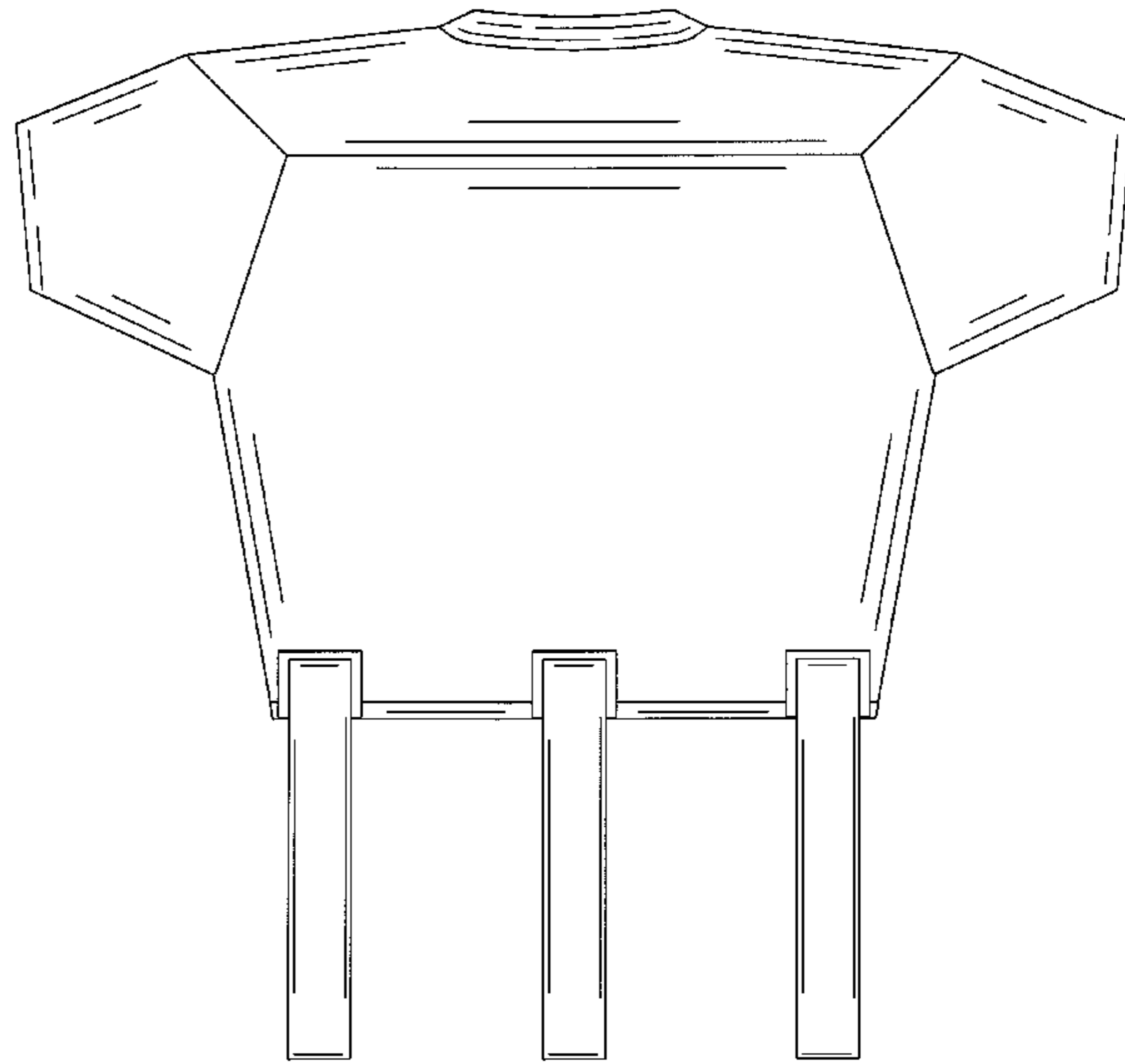
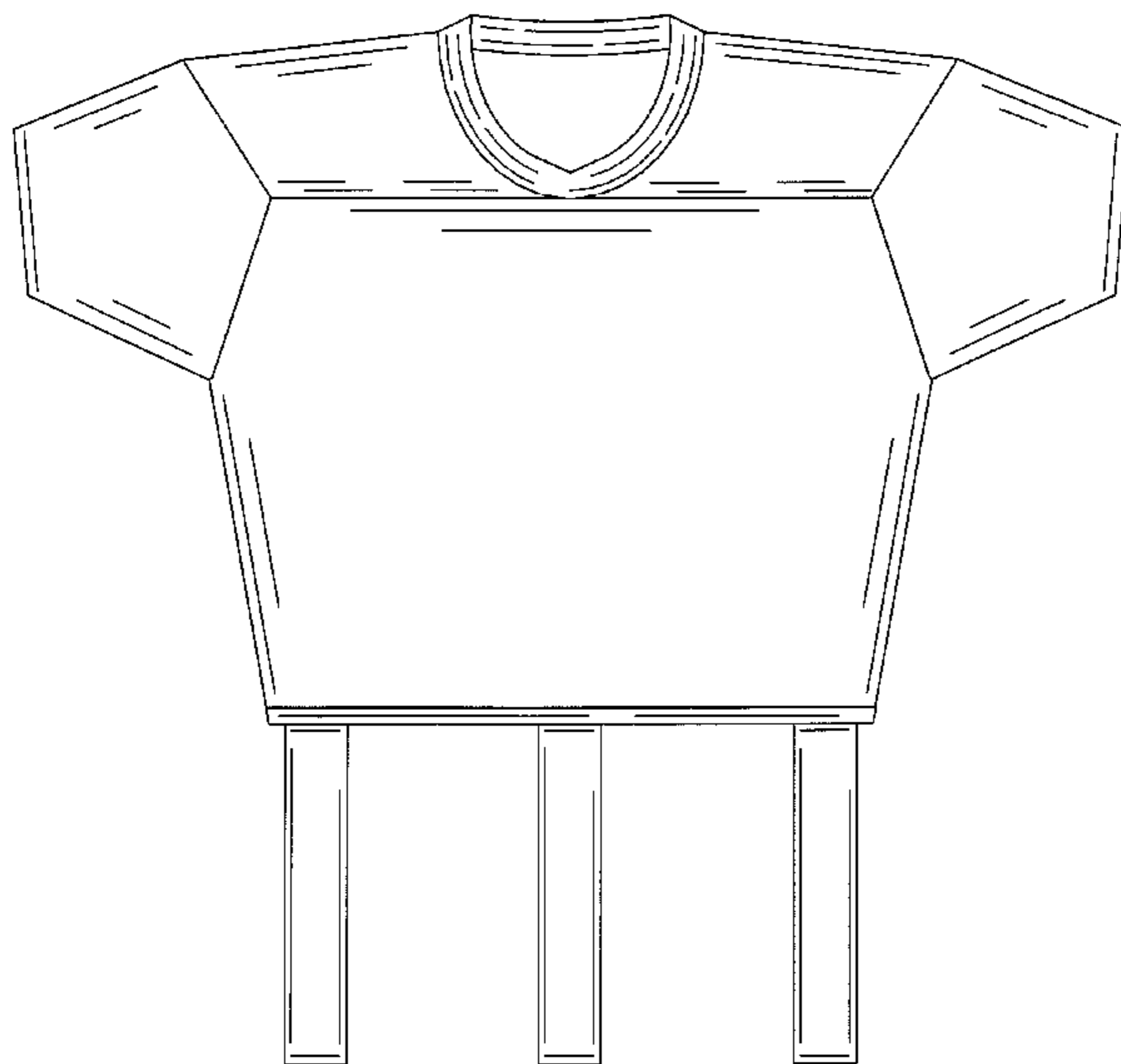
FIG. 3 is a left side view thereof;

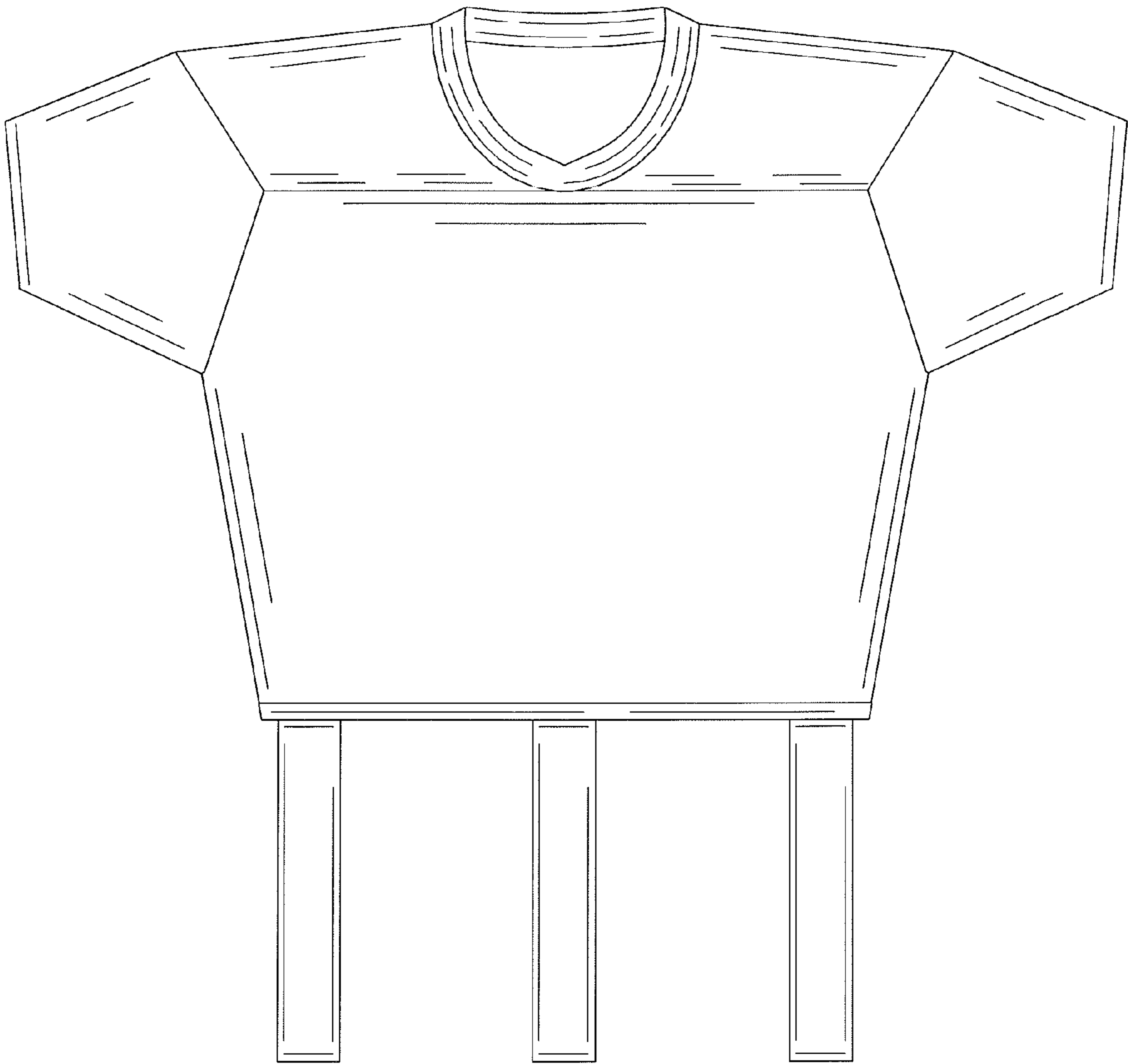

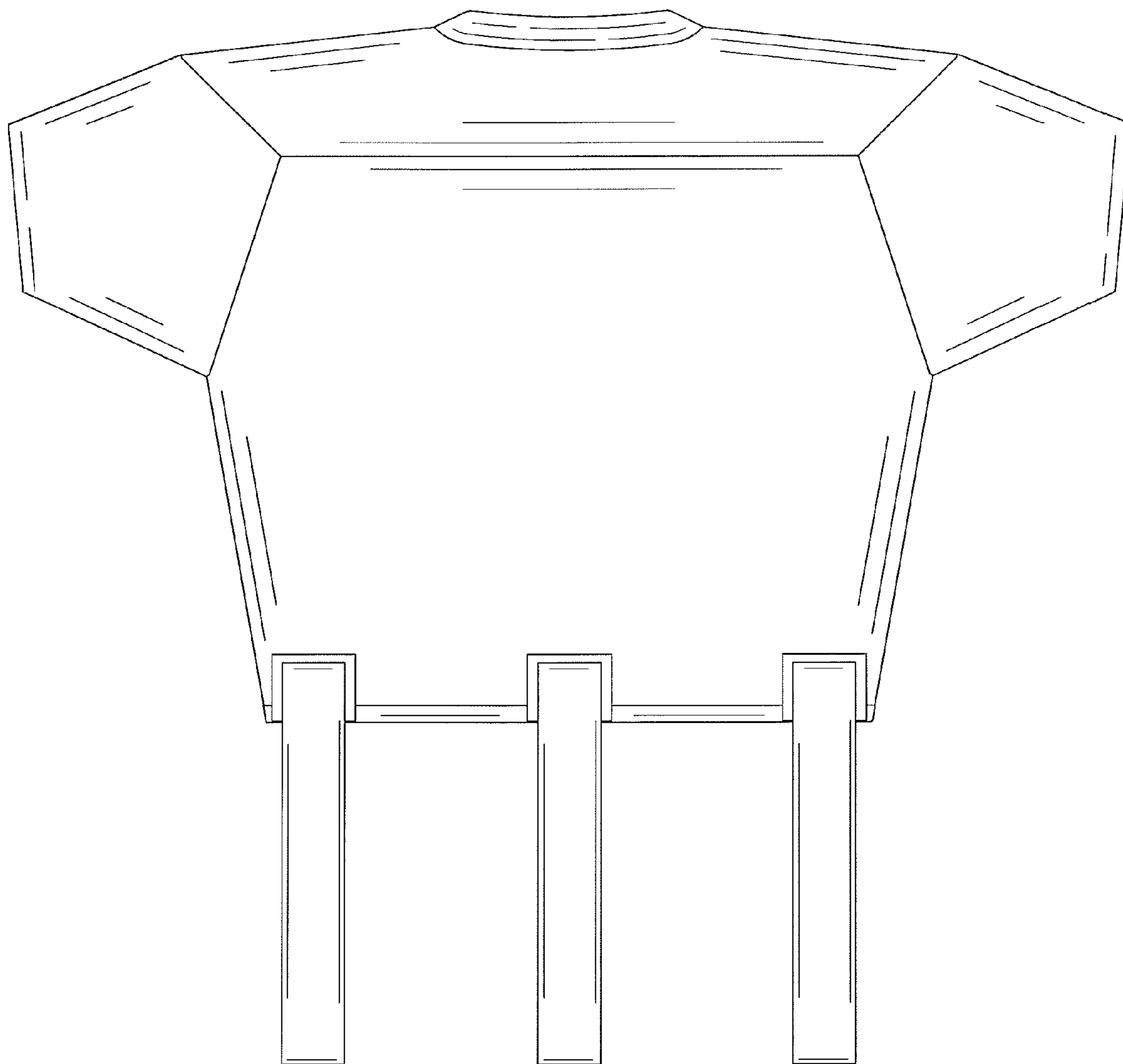

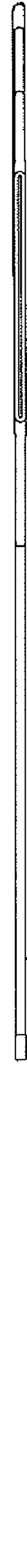

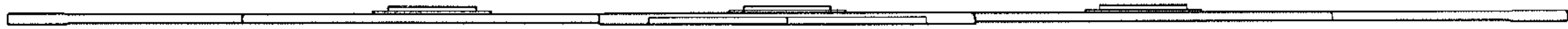

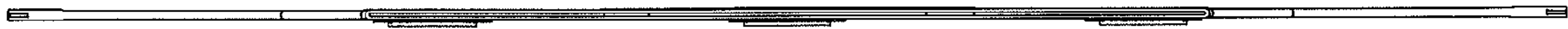
