(57) **CLAIM**

I claim the ornamental design for a fleece wrap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a fleece wrap, illustrated in a worn configuration, showing my new design;

FIG. 2 is a front elevational view thereof, illustrated in a flat configuration;

FIG. 3 is a rear elevational view thereof, illustrated in the flat configuration;

FIG. 4 is a left-side elevational view thereof, illustrated in the flat configuration, the right-side elevational view being a mirror image thereof;

FIG. 5 is a top plan view thereof, illustrated in the flat configuration;

FIG. 6 is a bottom plan view thereof, illustrated in the flat configuration;

FIG. 7 is a perspective view of a second embodiment thereof, illustrated in a worn configuration;

FIG. 8 is a front elevational view thereof, illustrated in a flat configuration;

FIG. 9 is a rear elevational view thereof, illustrated in the flat configuration;

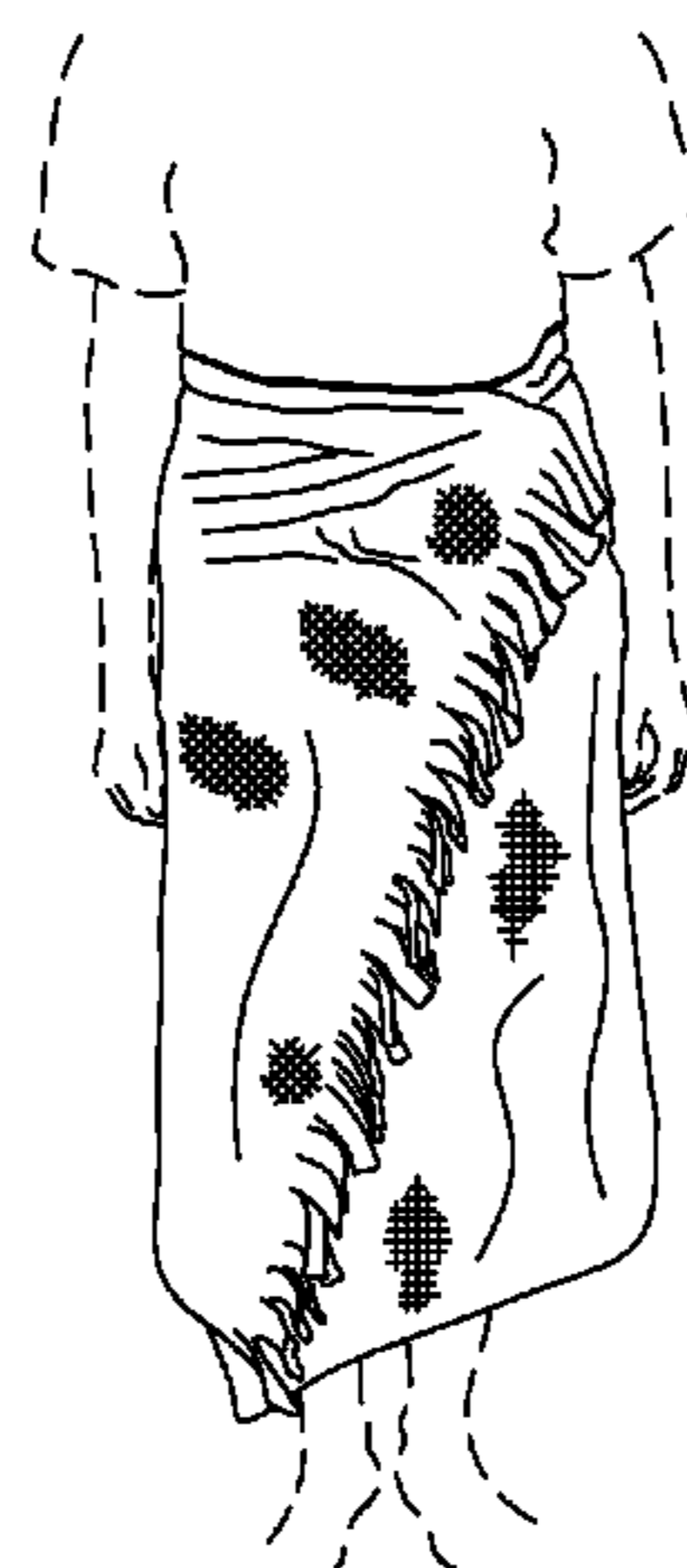
FIG. 10 is a left-side elevational view thereof, illustrated in the flat configuration;

FIG. 11 is a right-side elevational view thereof, illustrated in the flat configuration; and,

FIG. 12 is a top plan view thereof, illustrated in the flat configuration, the bottom plan view being a mirror image thereof.

The broken lines showing a person in FIGS. 1 and 7 are included for the purpose of illustrating the invention in use, and form no part of the claimed design.

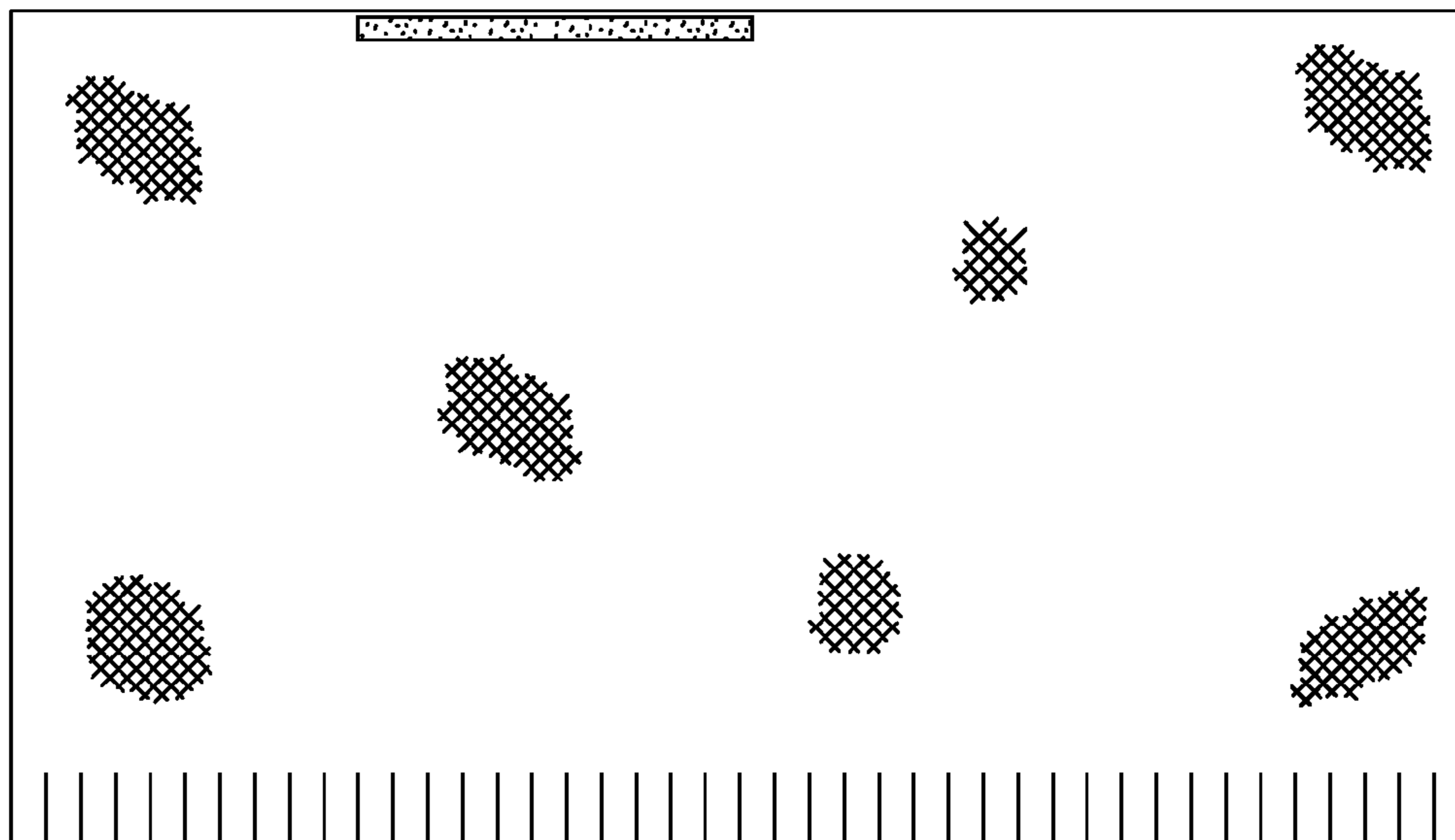

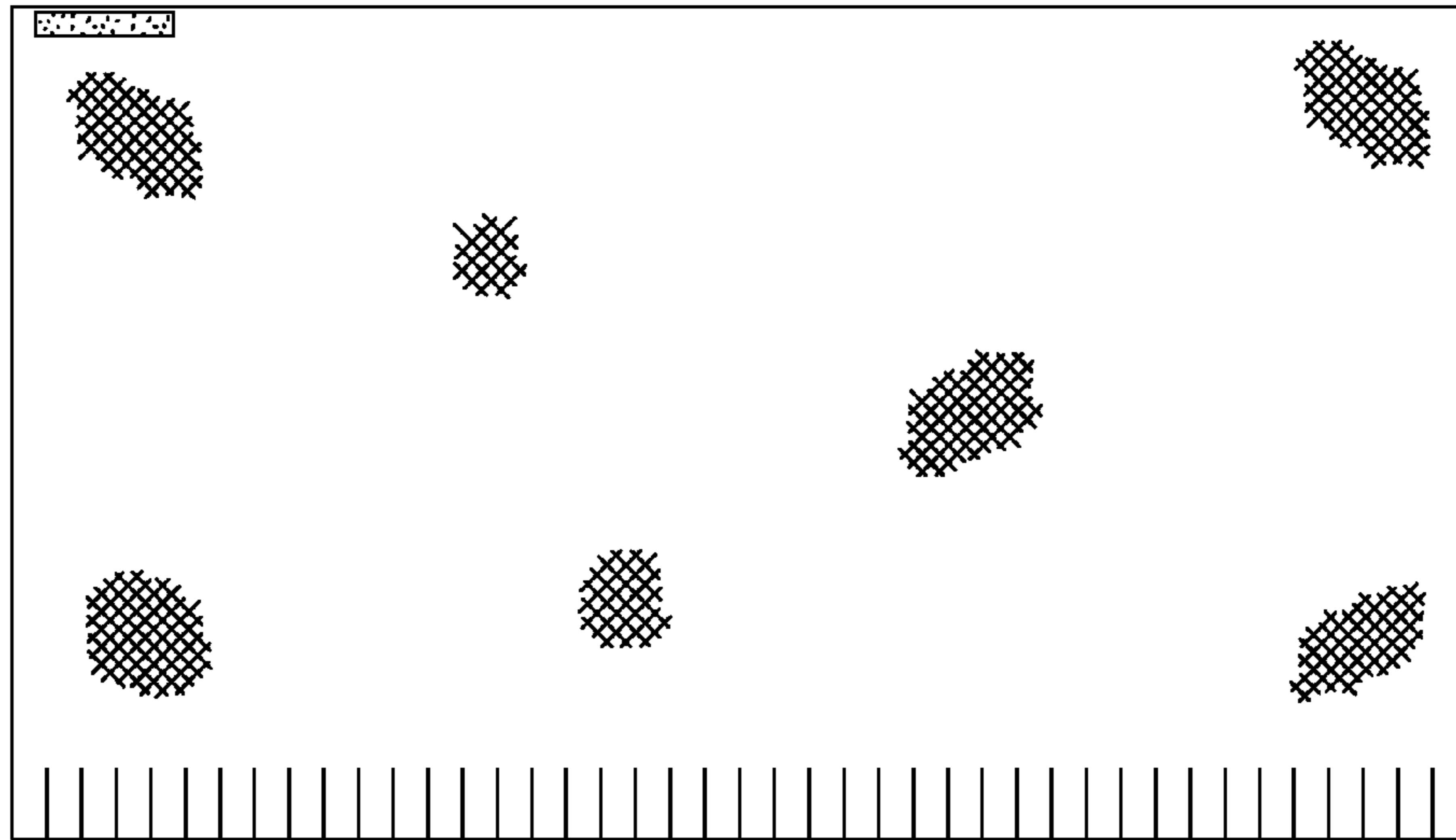

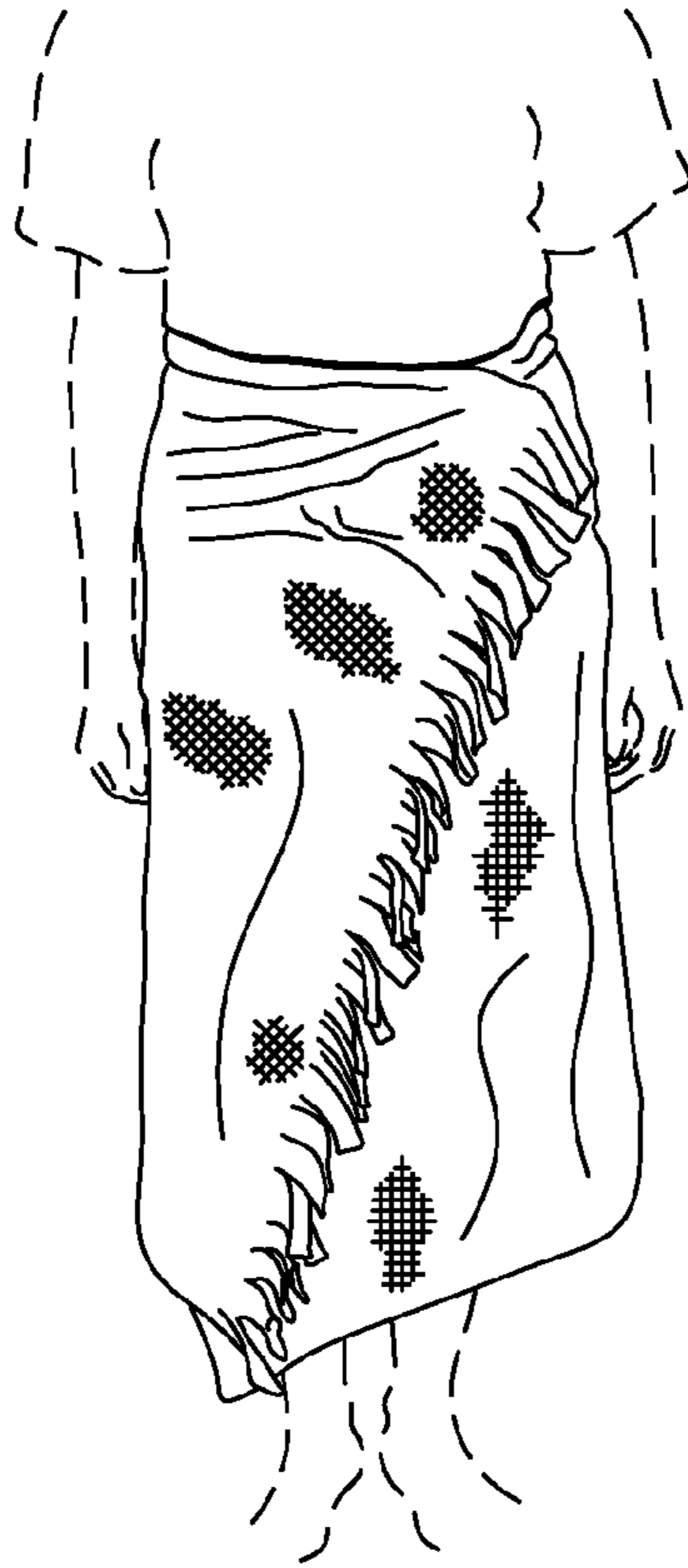

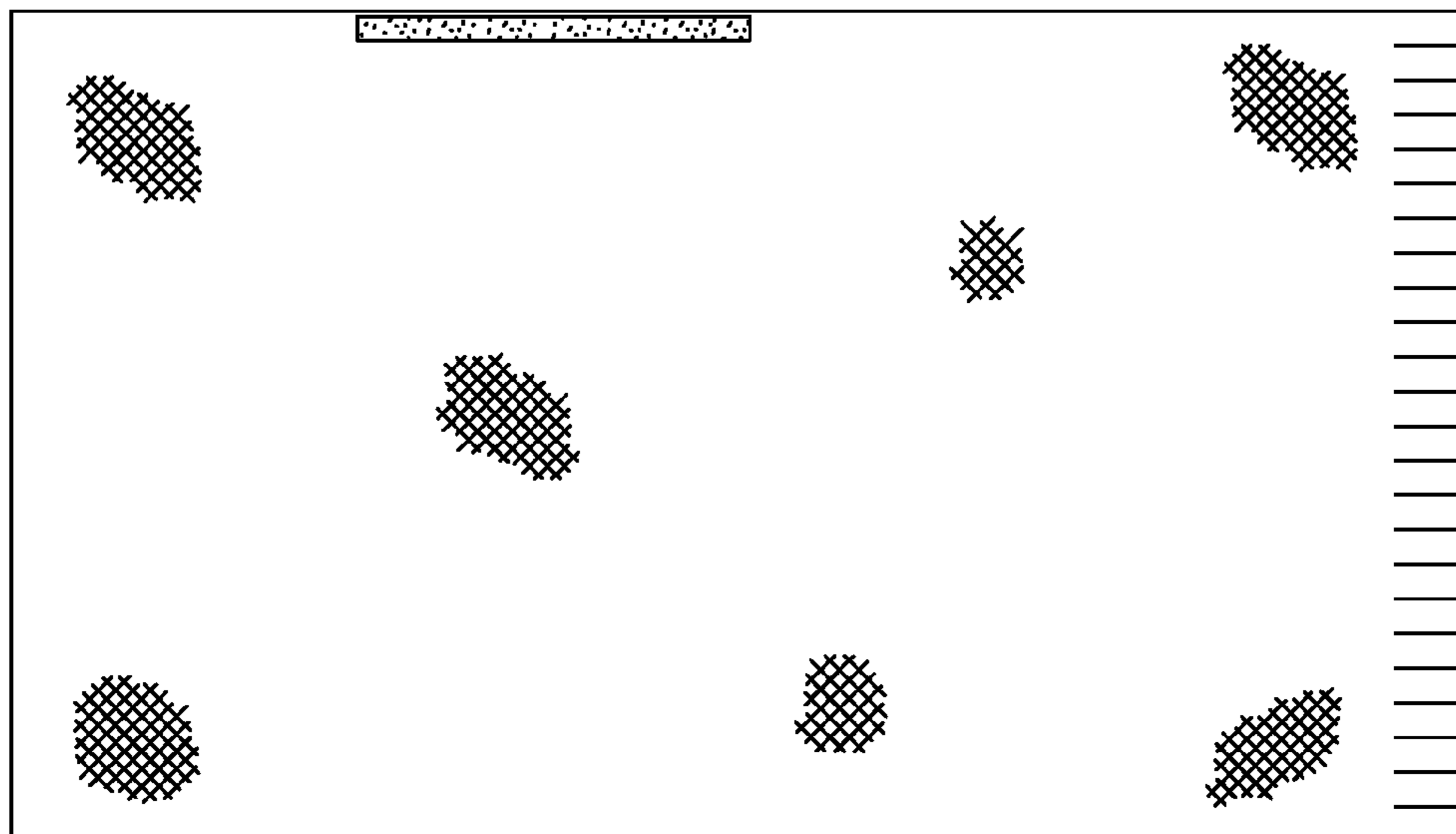

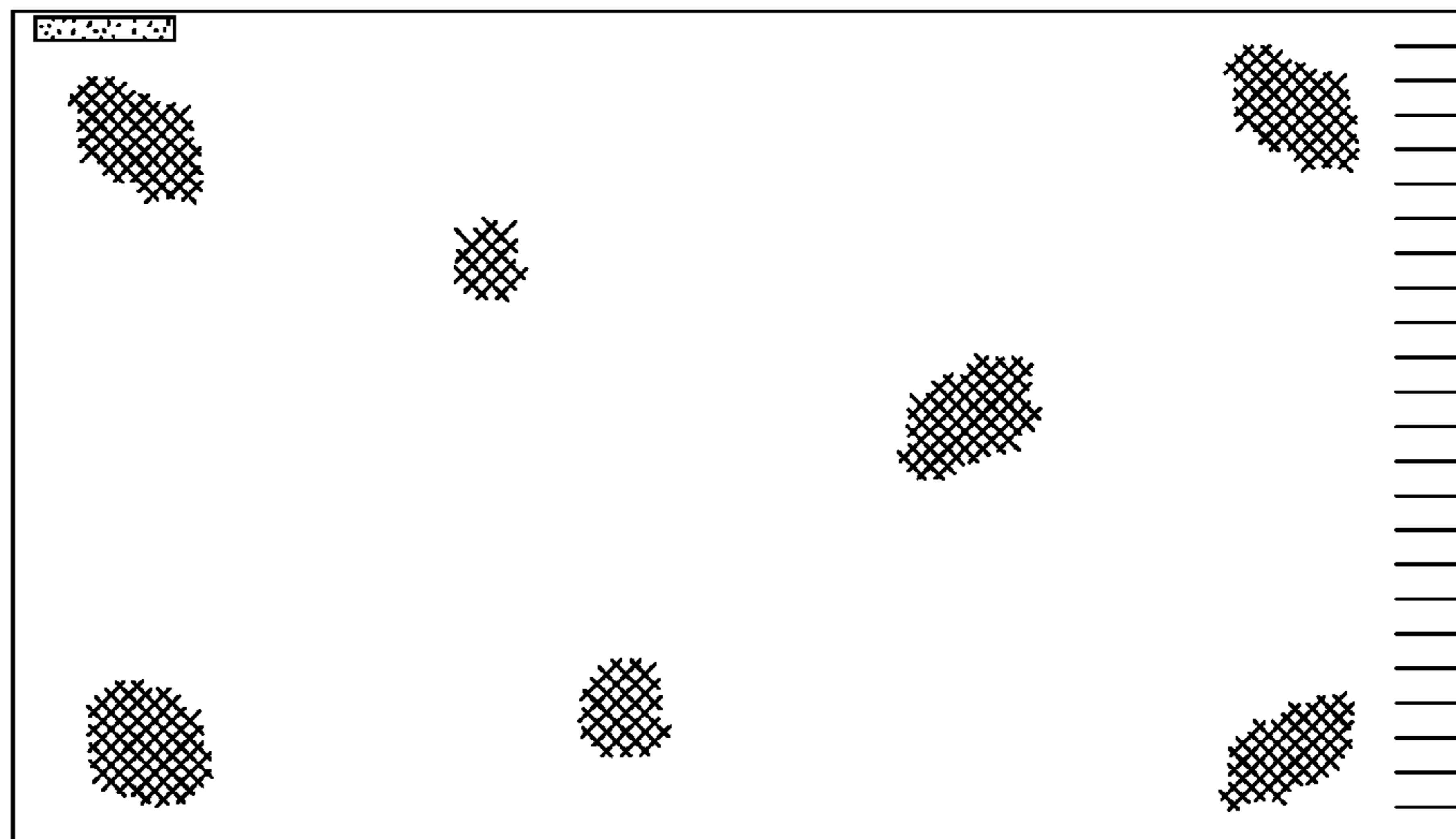

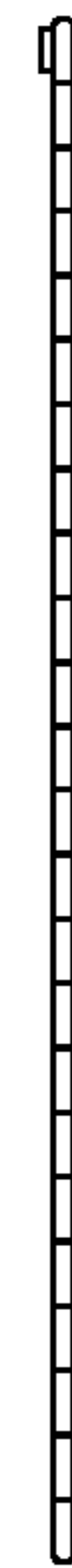
