The ornamental design for a sandal bottom, as shown and described.

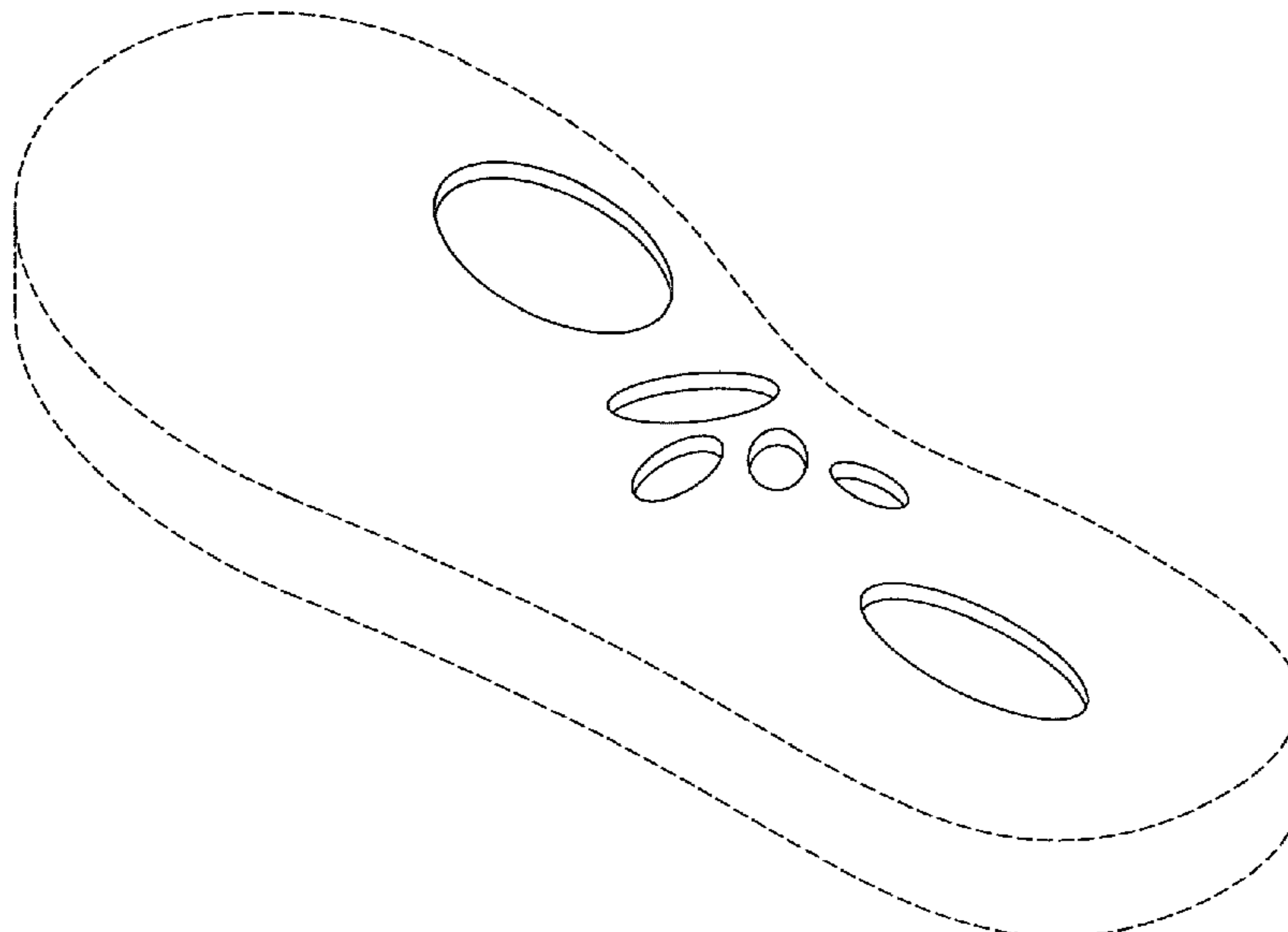
**DESCRIPTION**

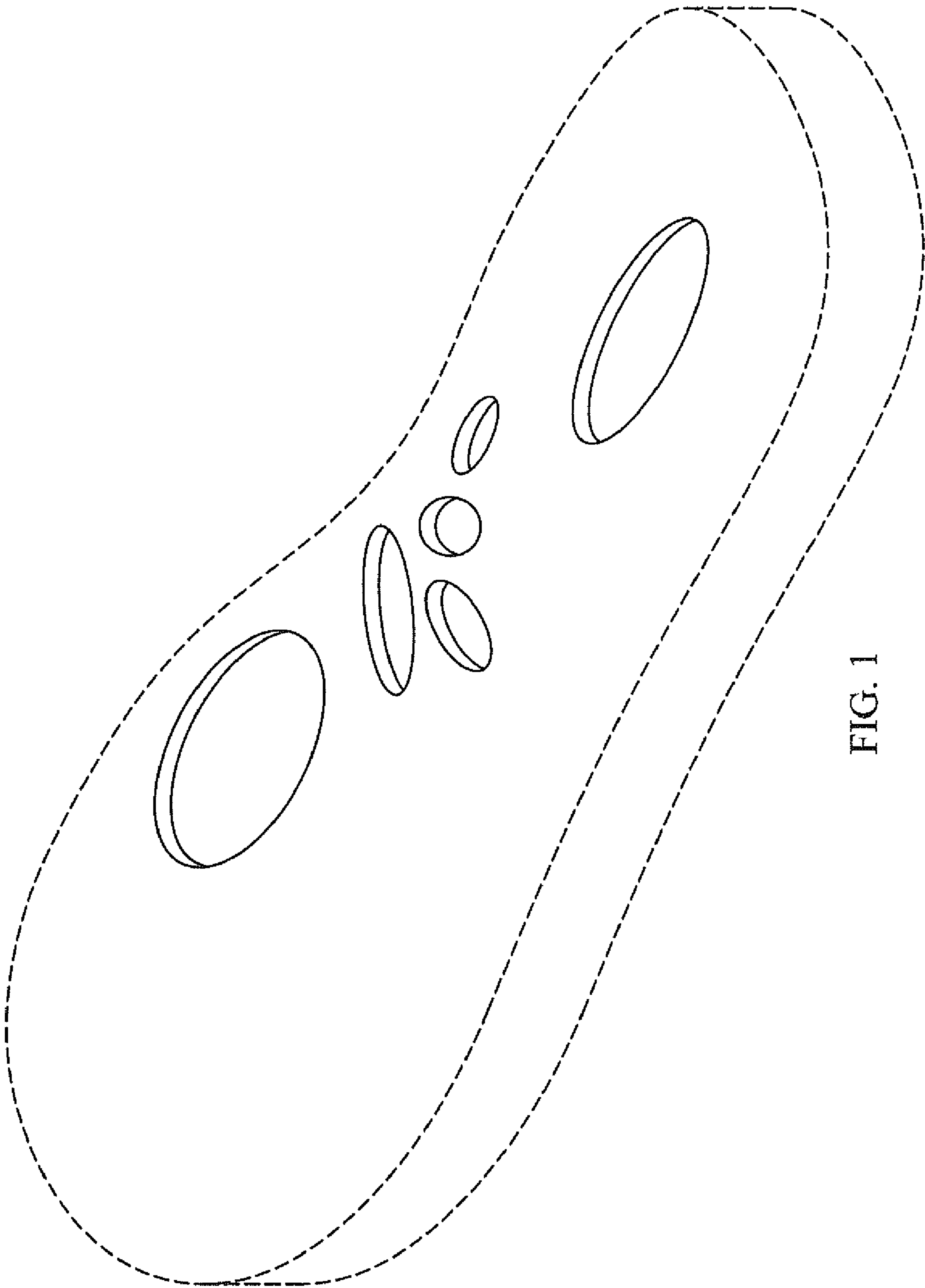

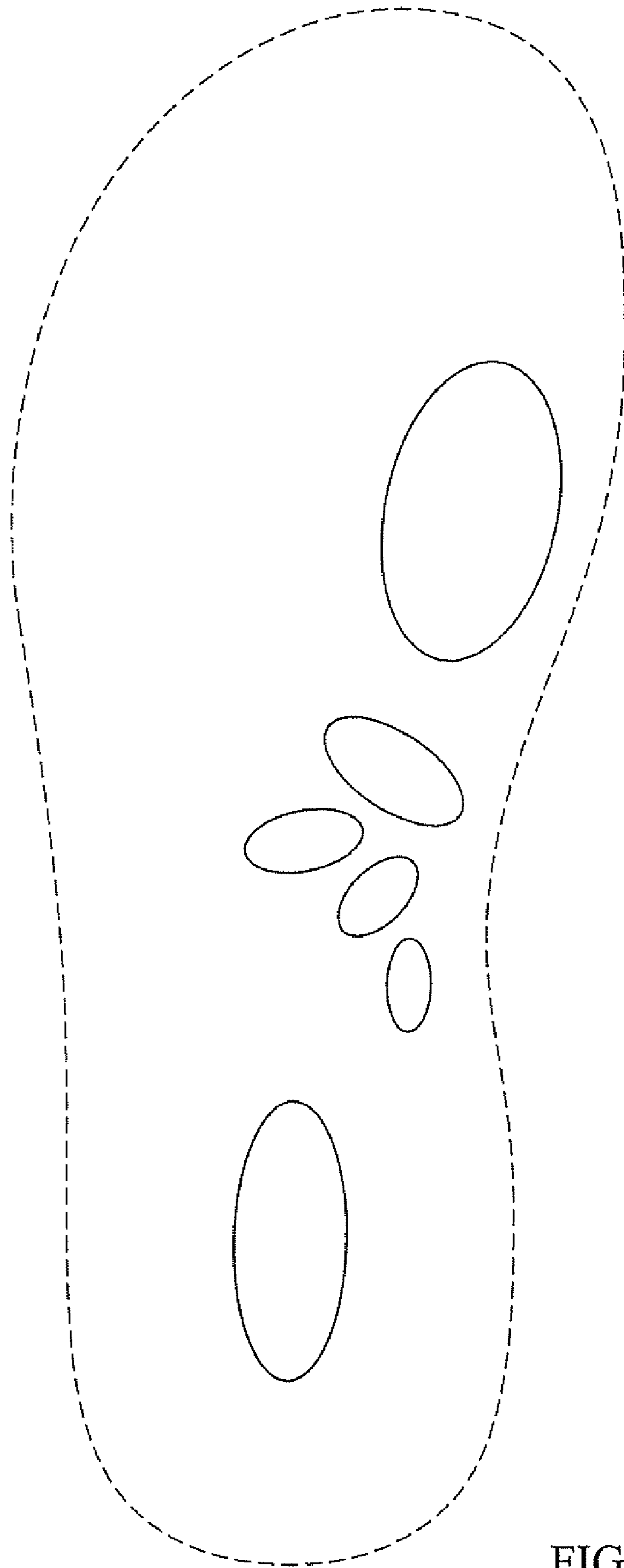
