The ornamental design for a nonwoven fabric, as shown and
described.

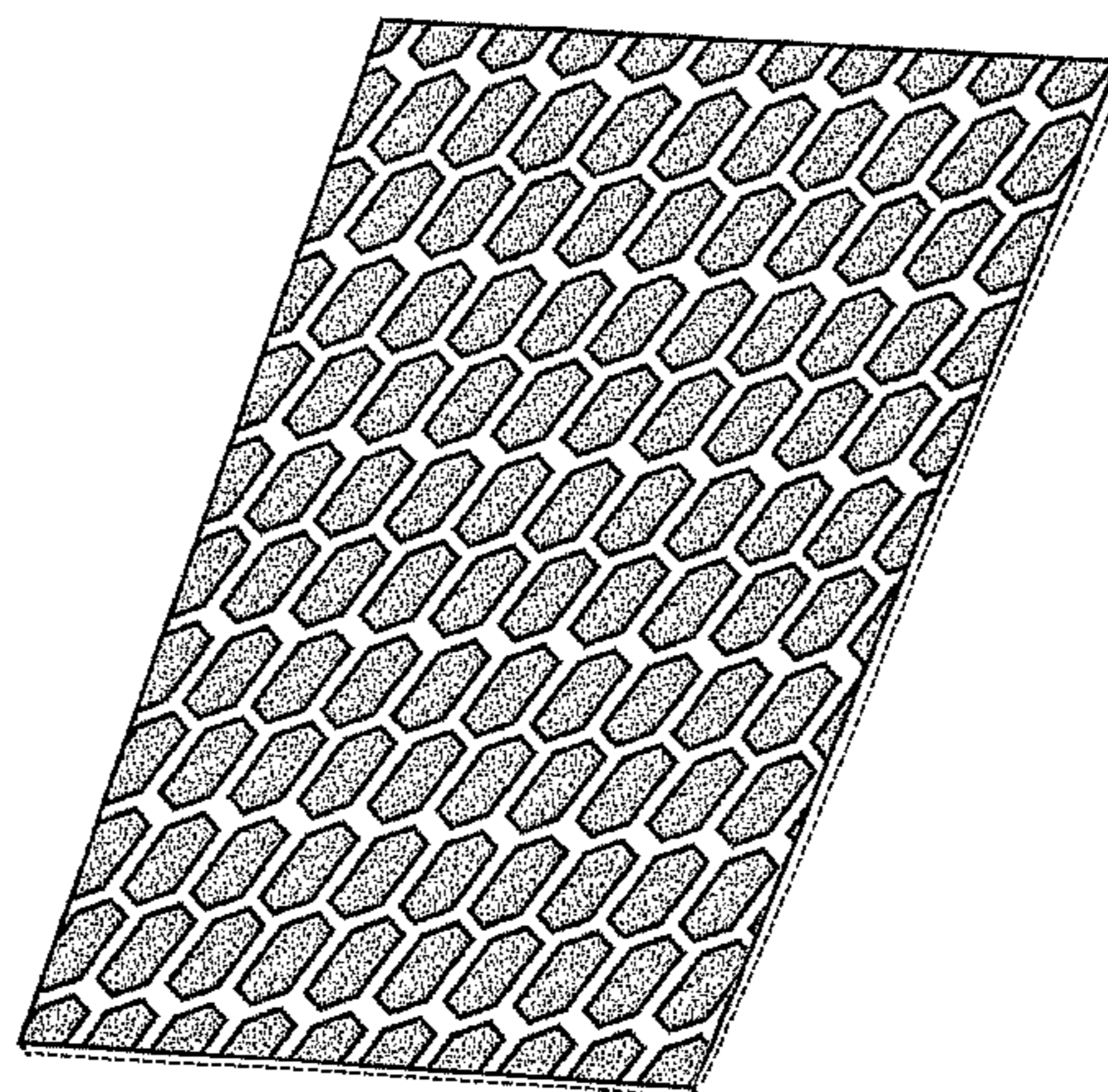
DESCRIPTION

FIG. 1 is a fragmentary perspective view a nonwoven fabric;
and,

FIG. 2 is a top plan view of the nonwoven fabric of FIG. 1.

The drawings show a nonwoven fabric having no specific
length or width, with a pattern that repeats uniformly through-
out the surface of the fabric. The broken lines in the drawing
represent unclaimed portions of the design. The bottom sur-
face of the nonwoven fabric forms no part of the claimed
design.

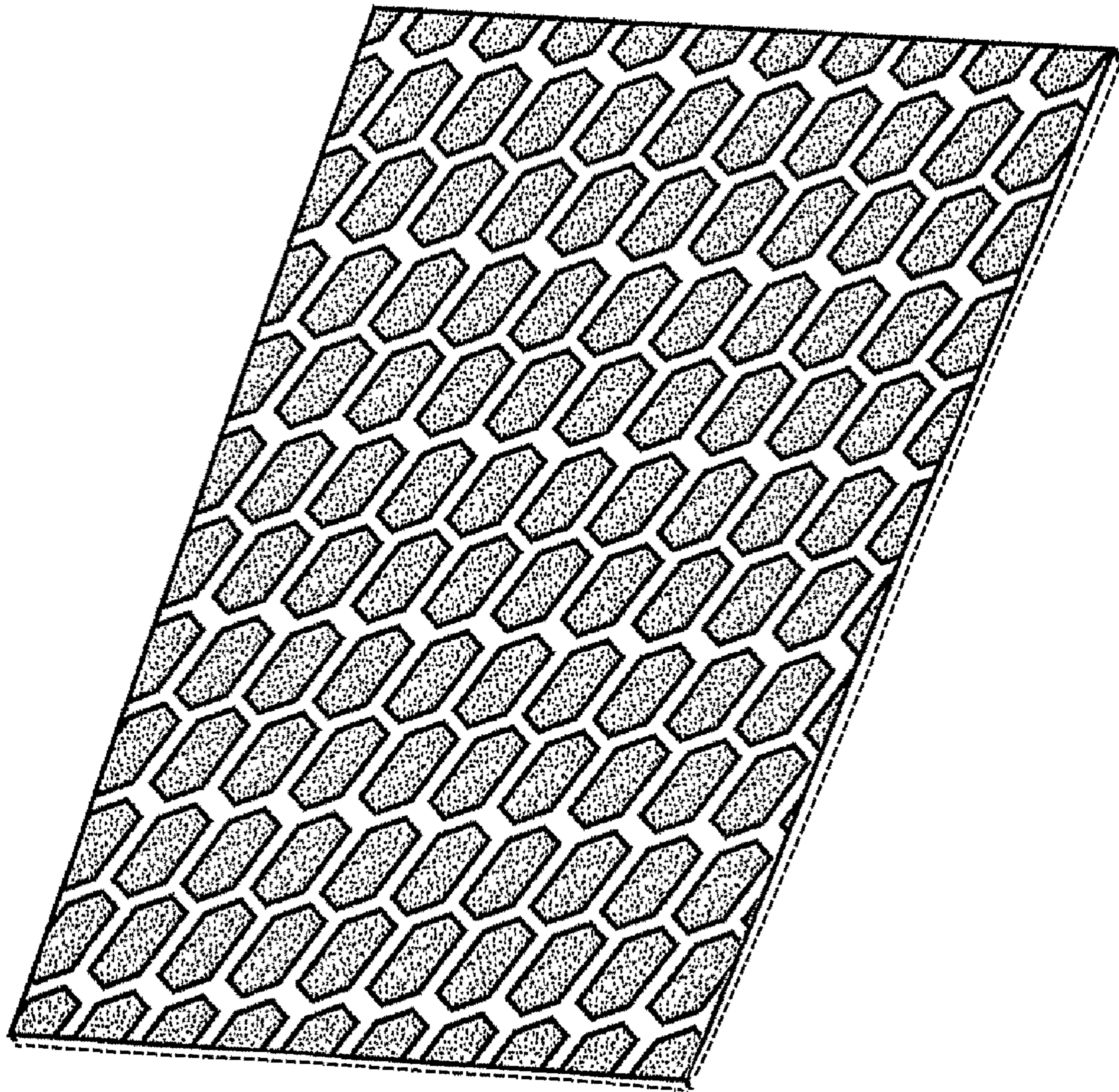

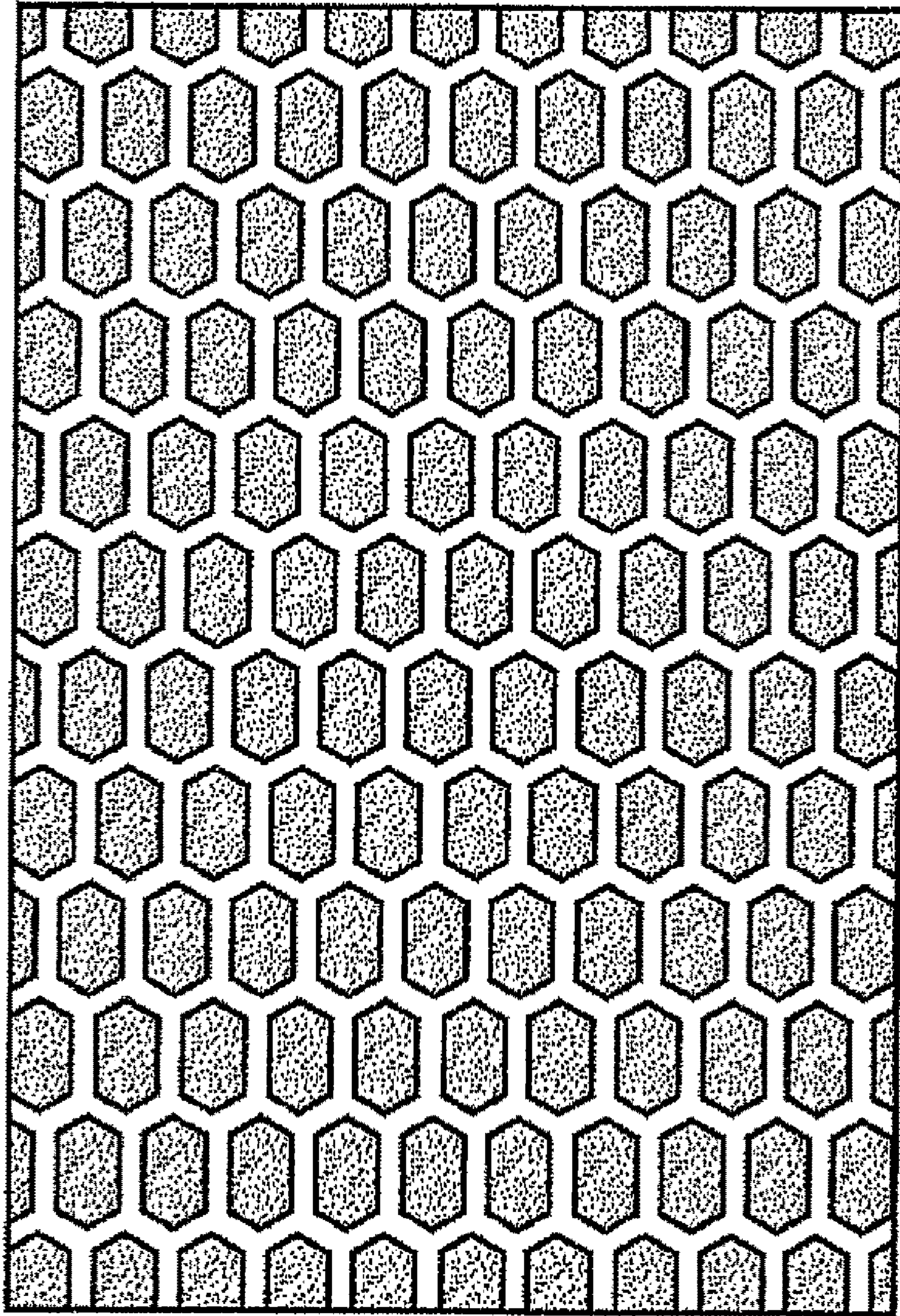
