FIG. 4 is a rear view of the design therefor;

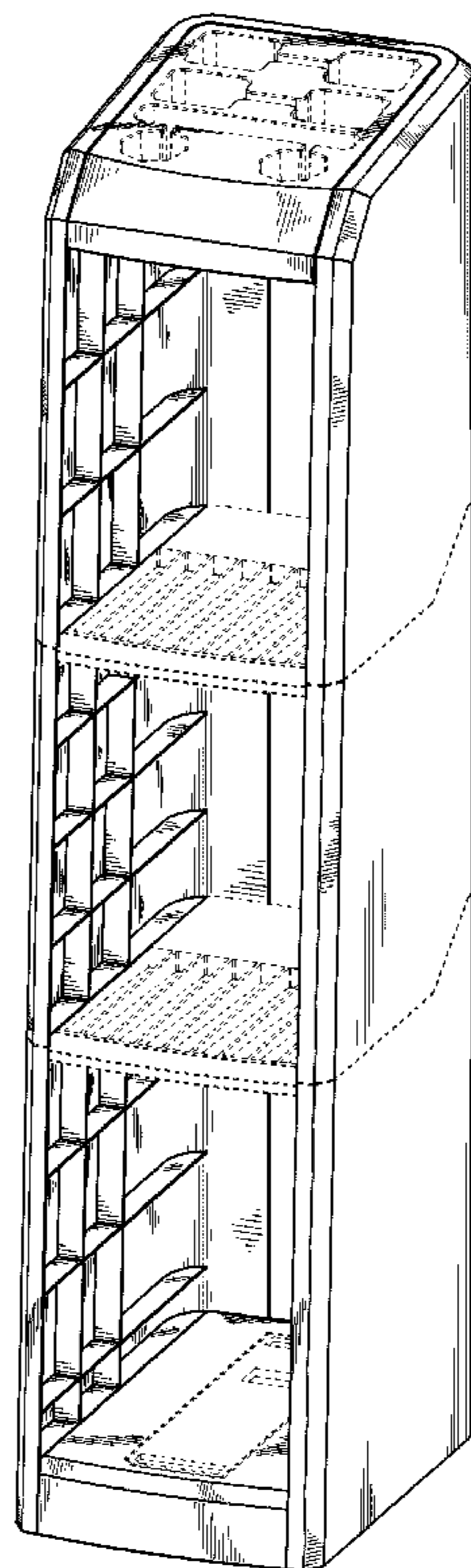
FIG. 5 is a first side end view of the design therefor, mirrored on the opposite side;

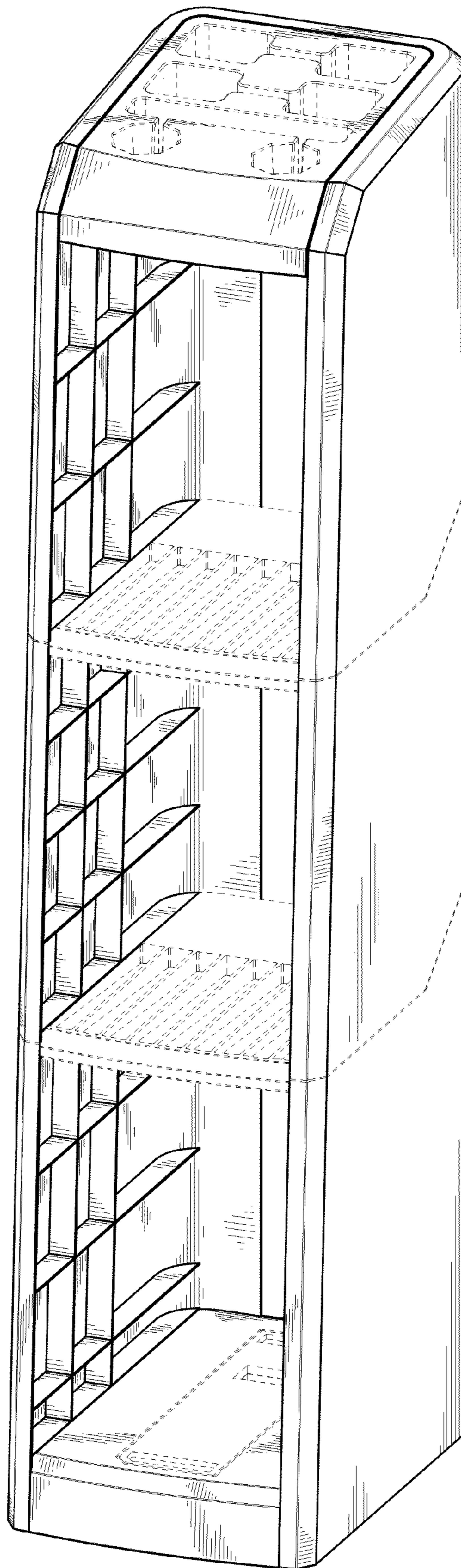

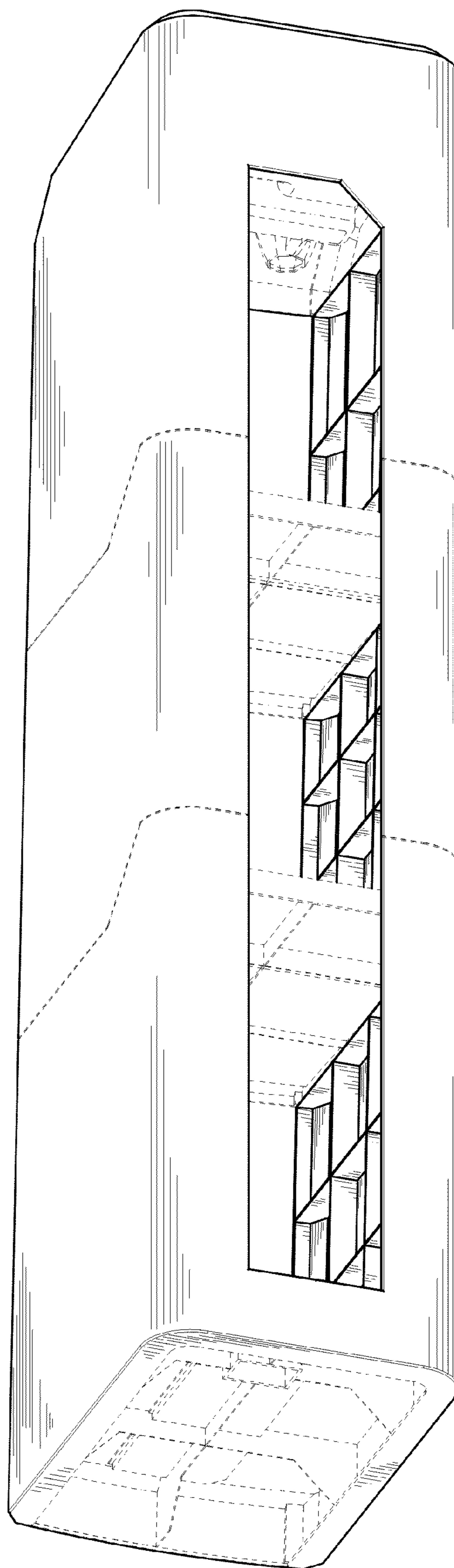

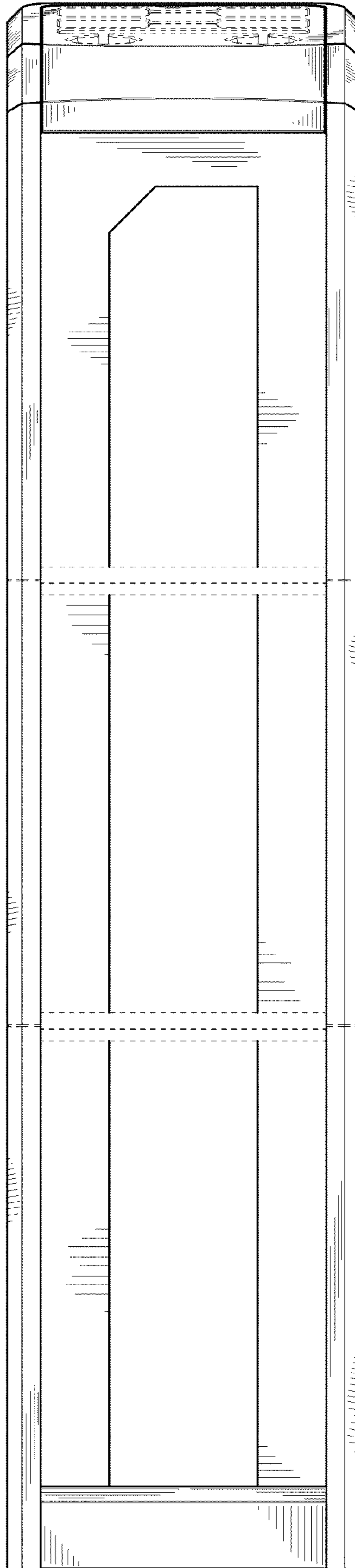

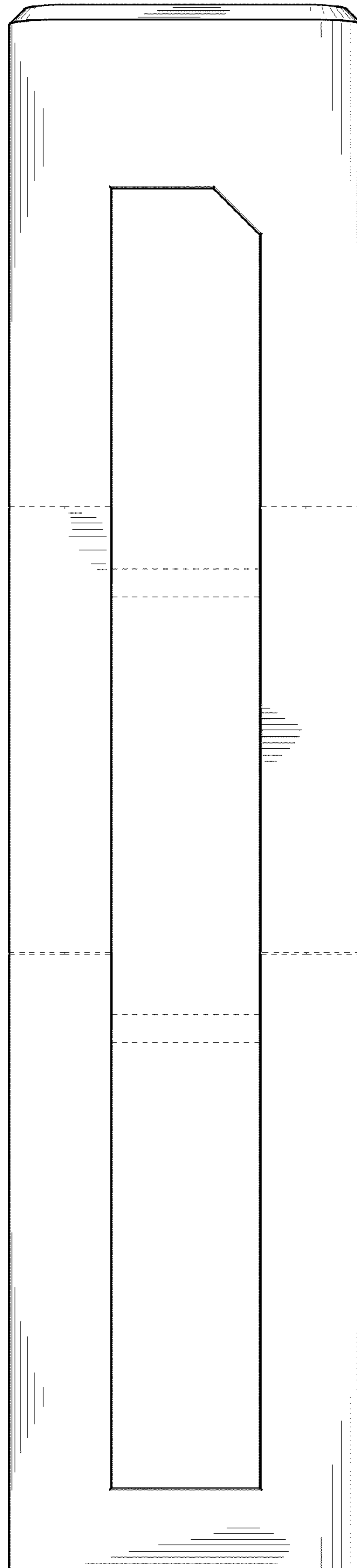

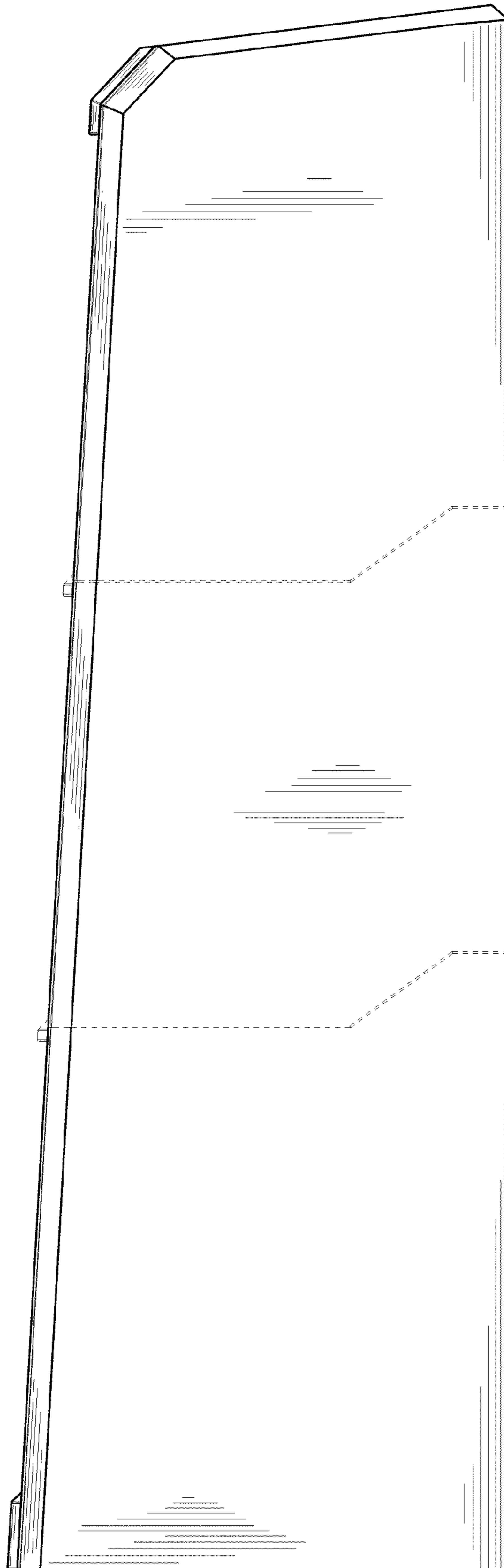

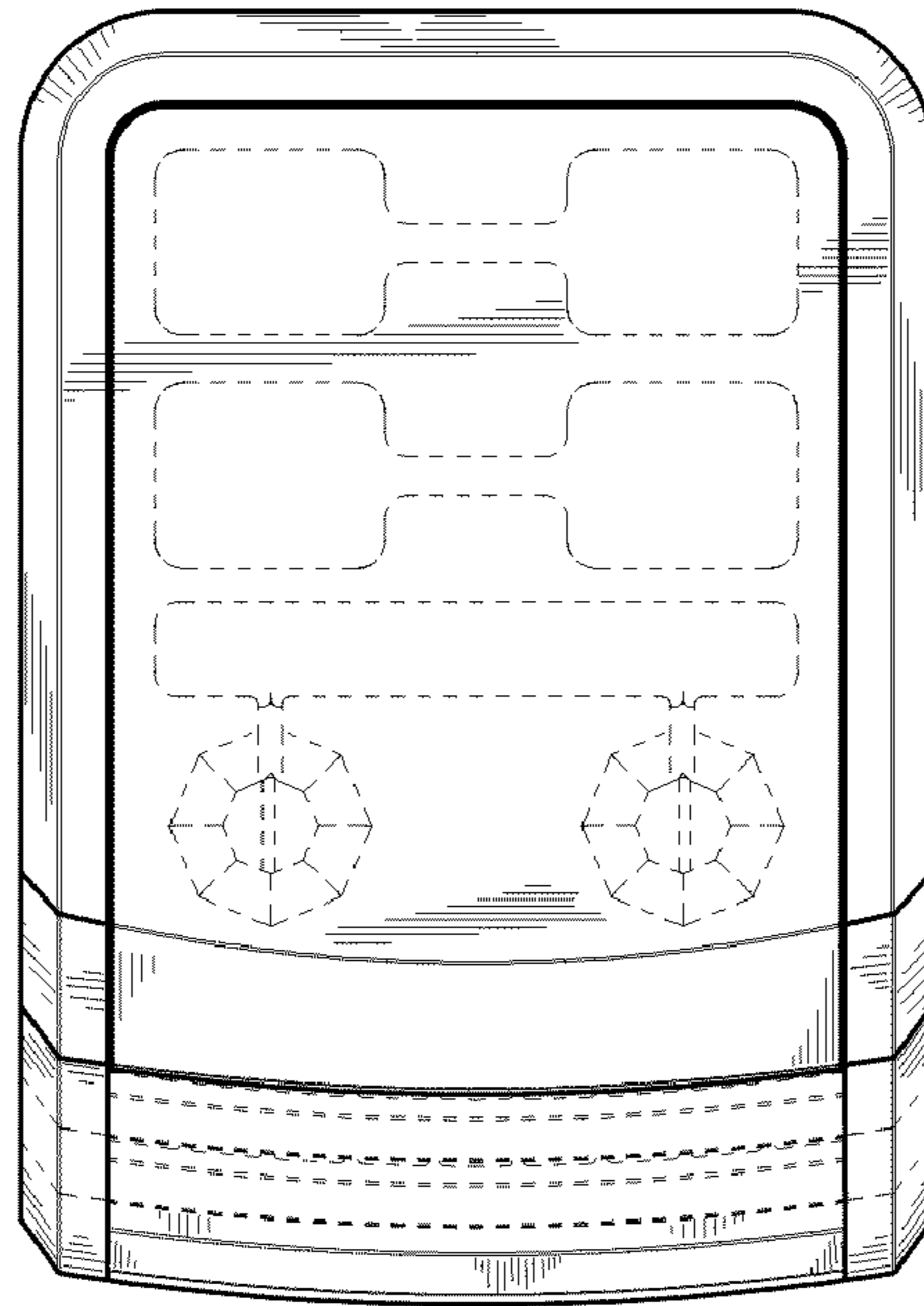

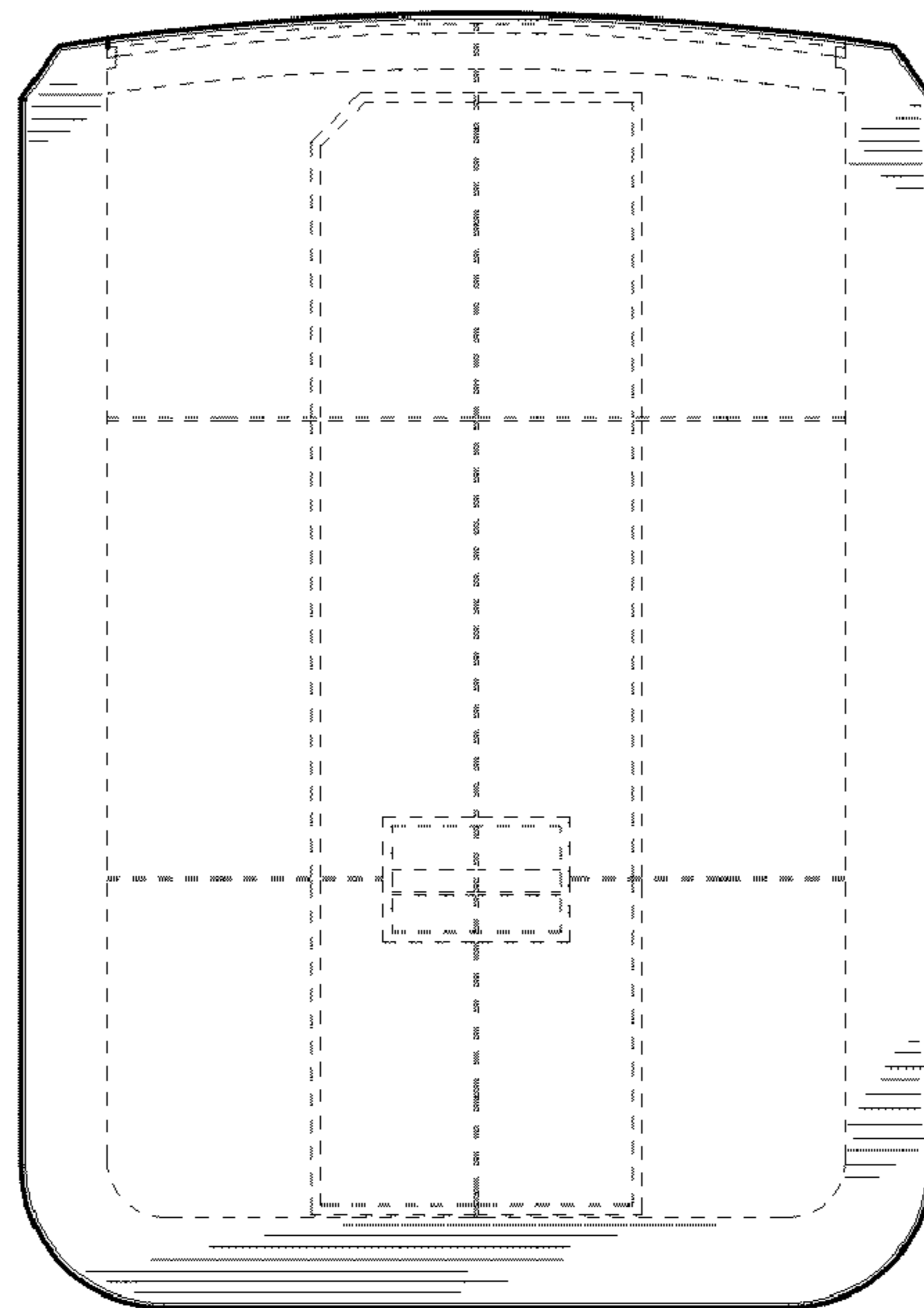
