FIG. 2 is an enlarged perspective view of the seat control interface according to the invention;

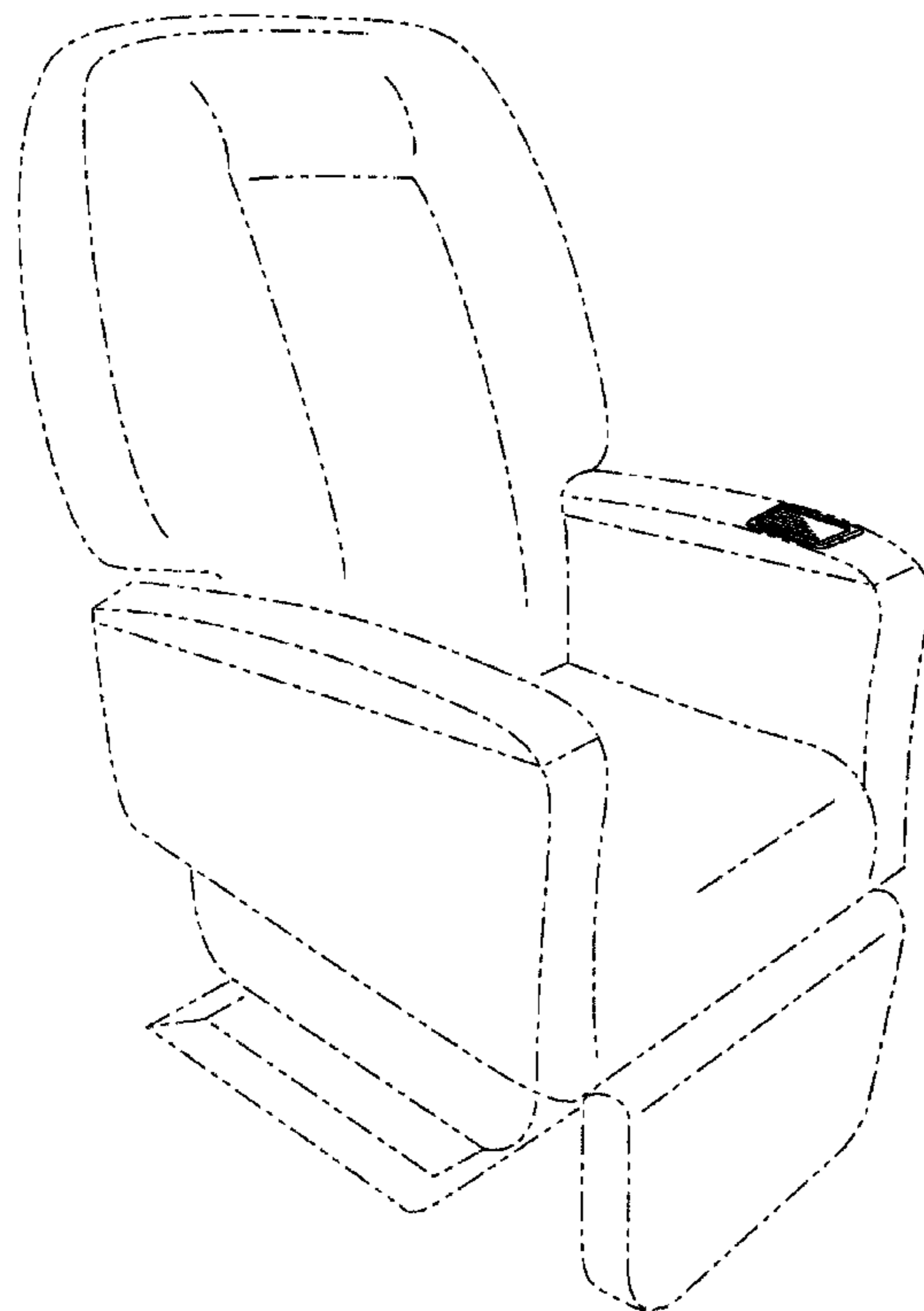
FIG. 3 is an enlarged side elevational view of the seat control interface according to the invention;

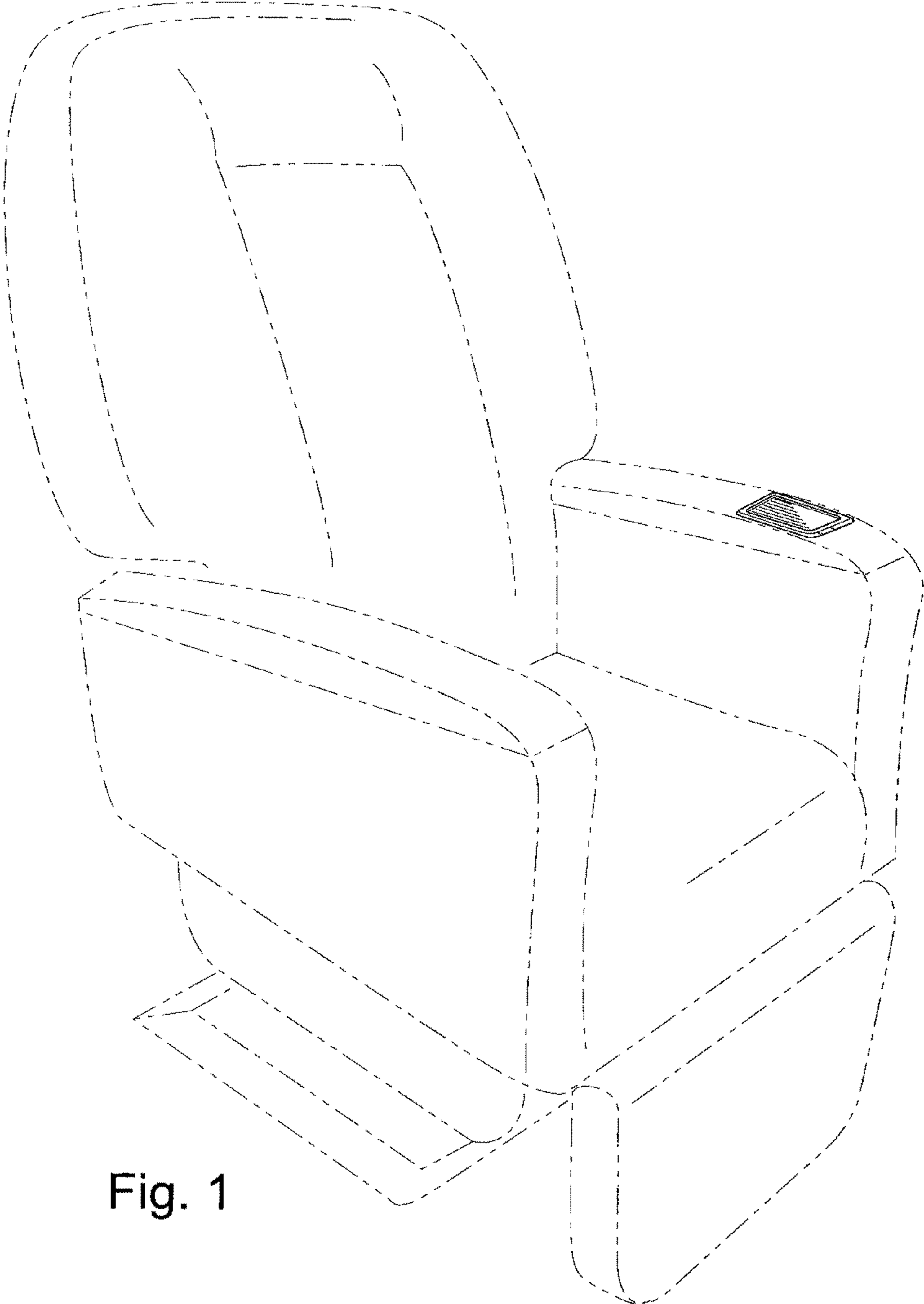

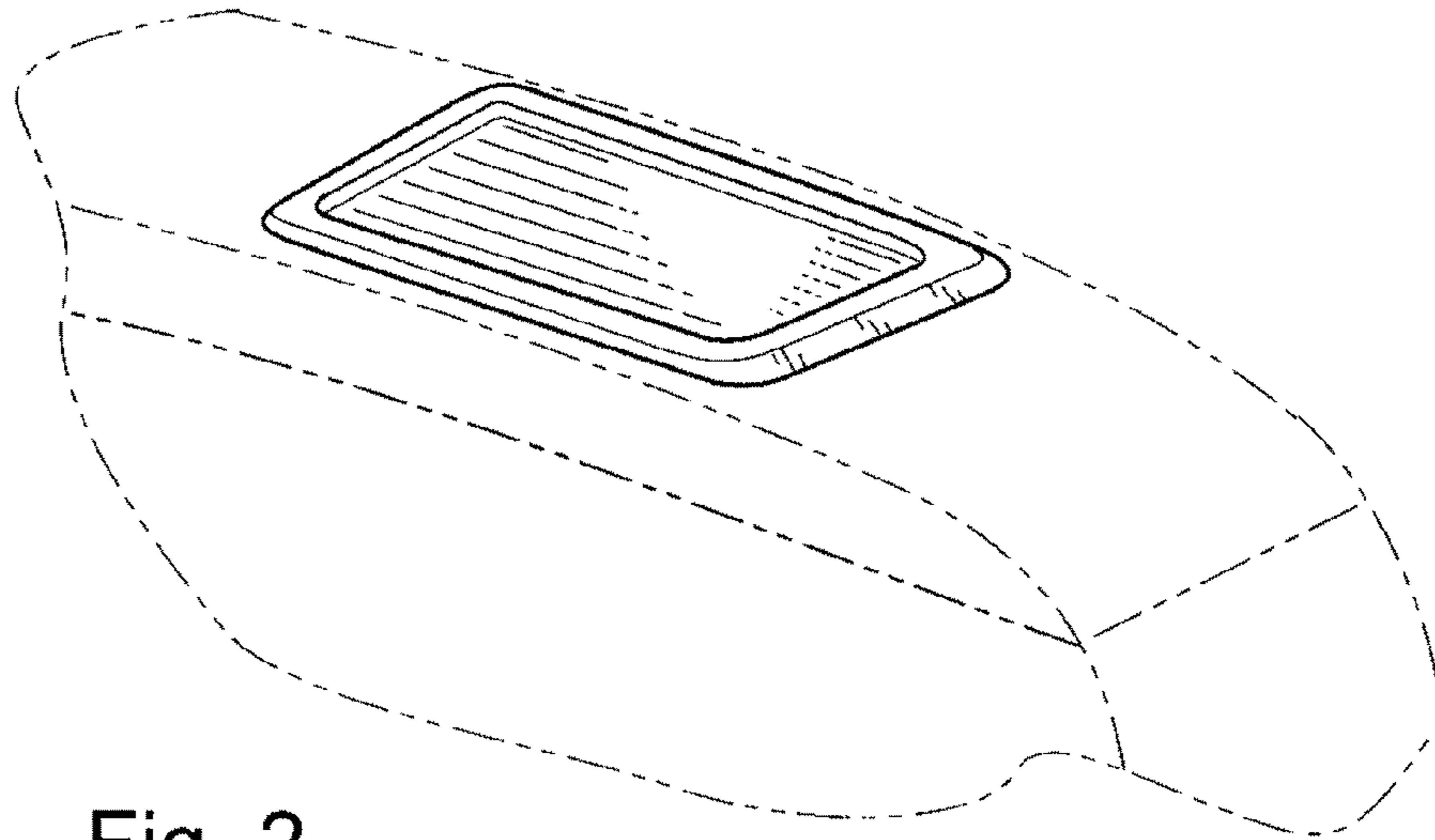

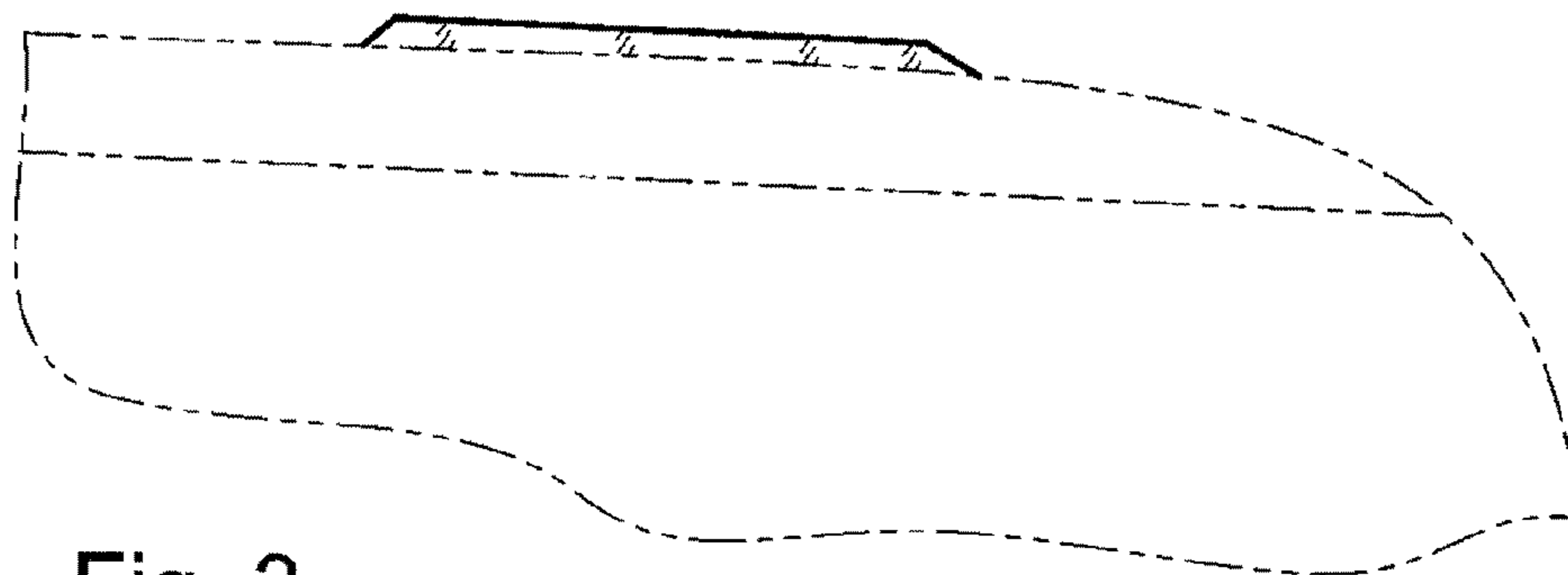

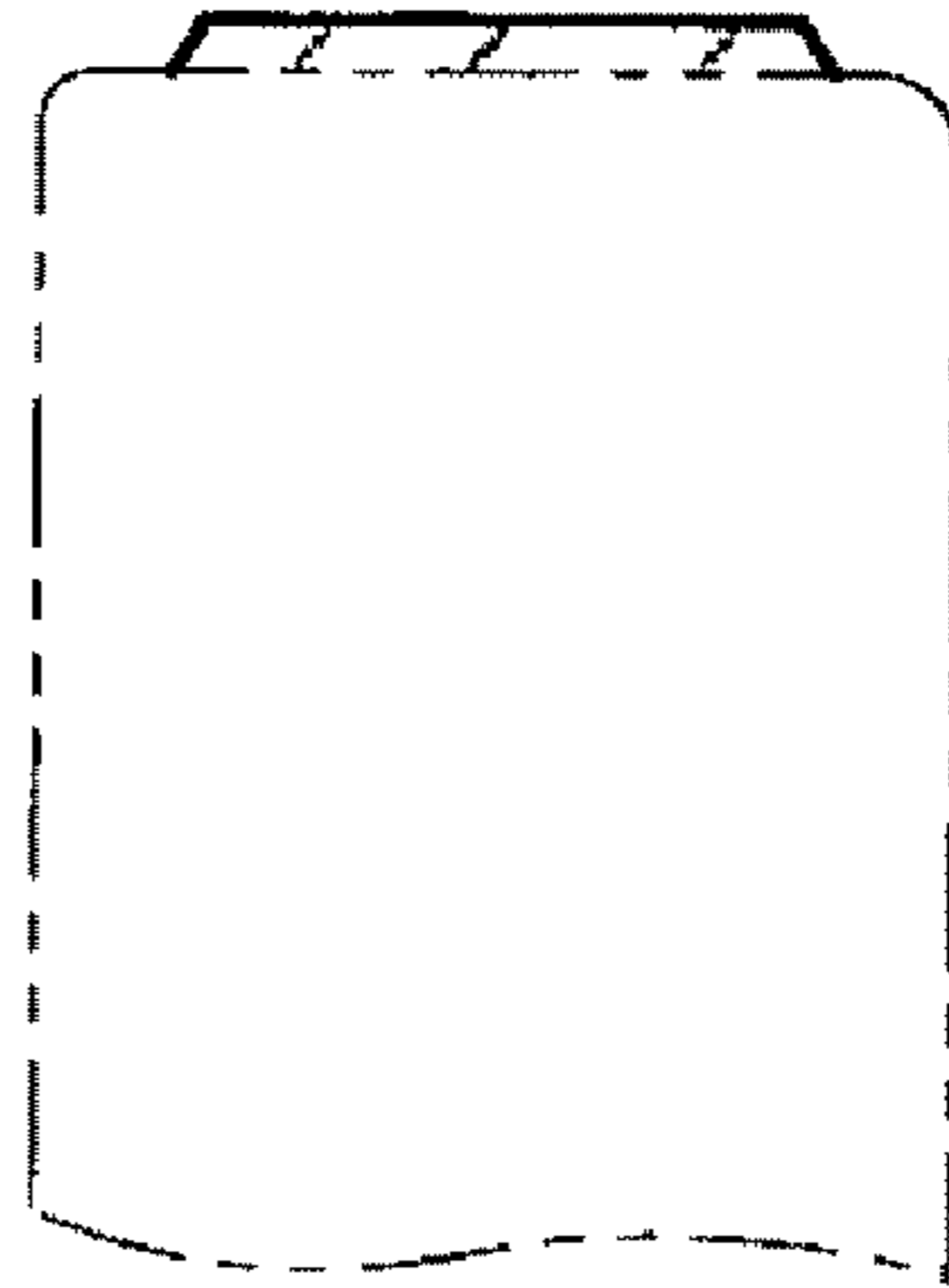

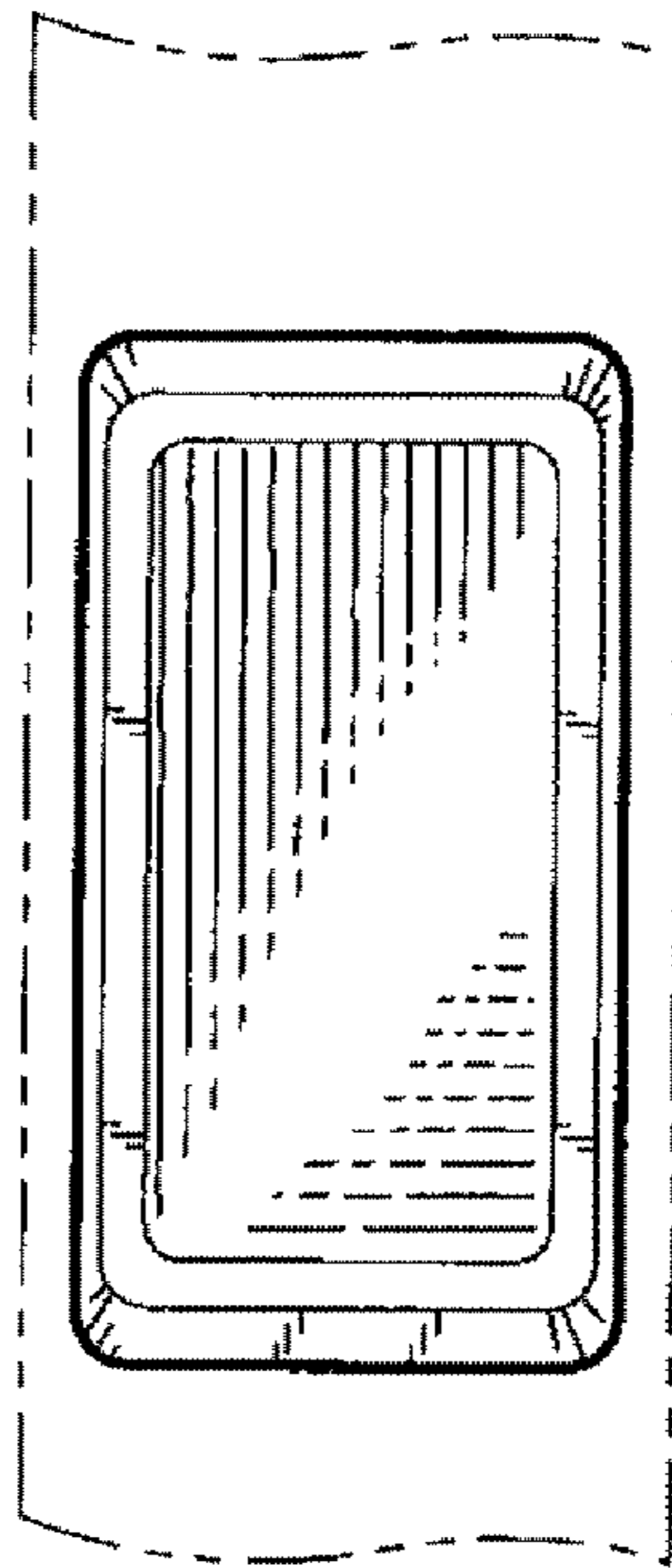
