(57) **CLAIM**

The ornamental design for a beverage container with message indicator, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a beverage container with message indicator comprising a first embodiment of a new, original and ornamental design;

FIG. 2 is a top view of a beverage container with message indicator comprising the first embodiment of the new, original and ornamental design;

FIG. 3 is a left-hand side view of a beverage container with message indicator comprising the first embodiment of the new, original and ornamental design, the right-hand side view being a mirror image thereof;

FIG. 4 is a bottom view of a beverage container with message indicator comprising the first embodiment of the new, original and ornamental design;

FIG. 5 is a rear view of a beverage container with message indicator comprising the first embodiment of the new, original and ornamental design;

FIG. 6 is a front view of a beverage container with message indicator comprising a second embodiment of a new, original and ornamental design;

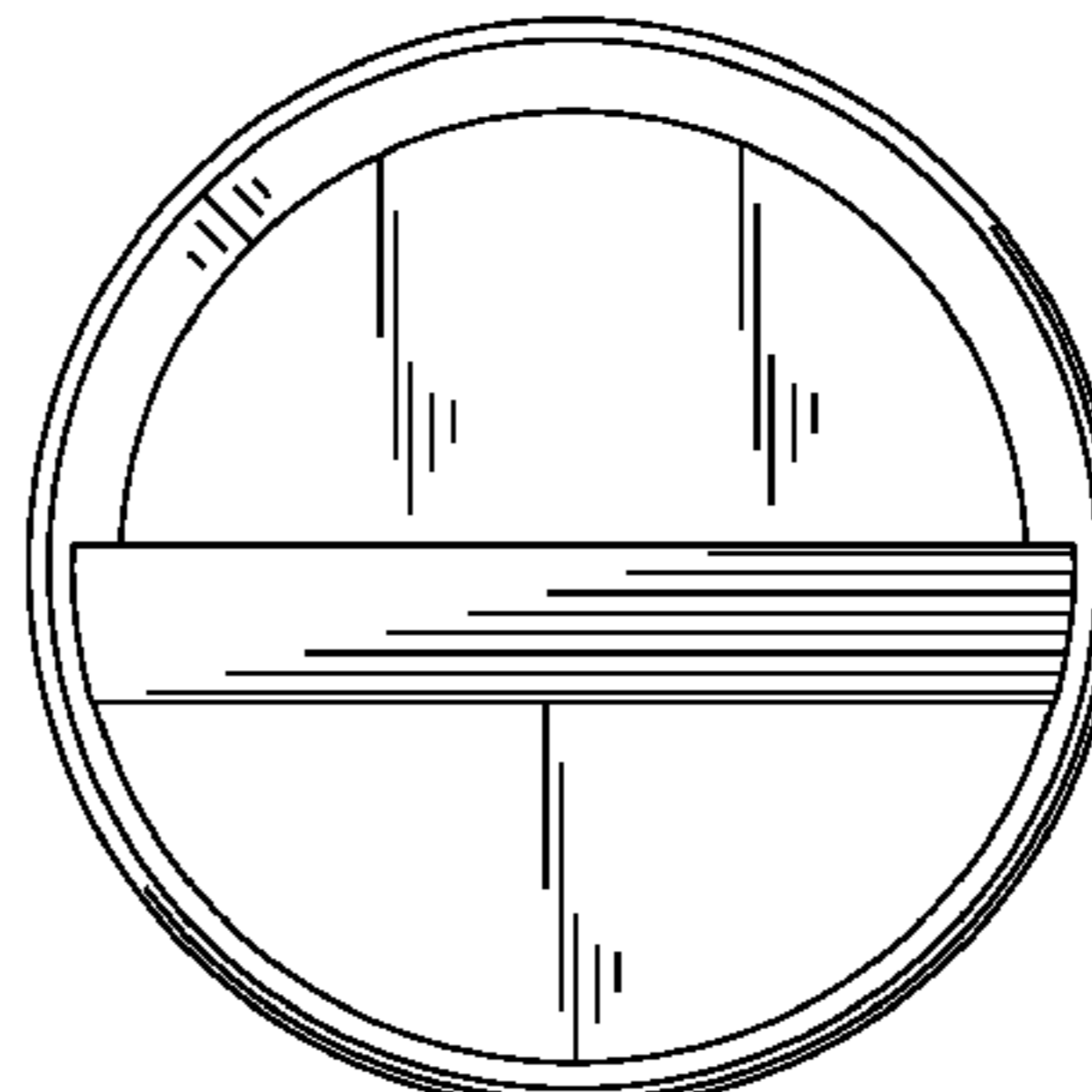
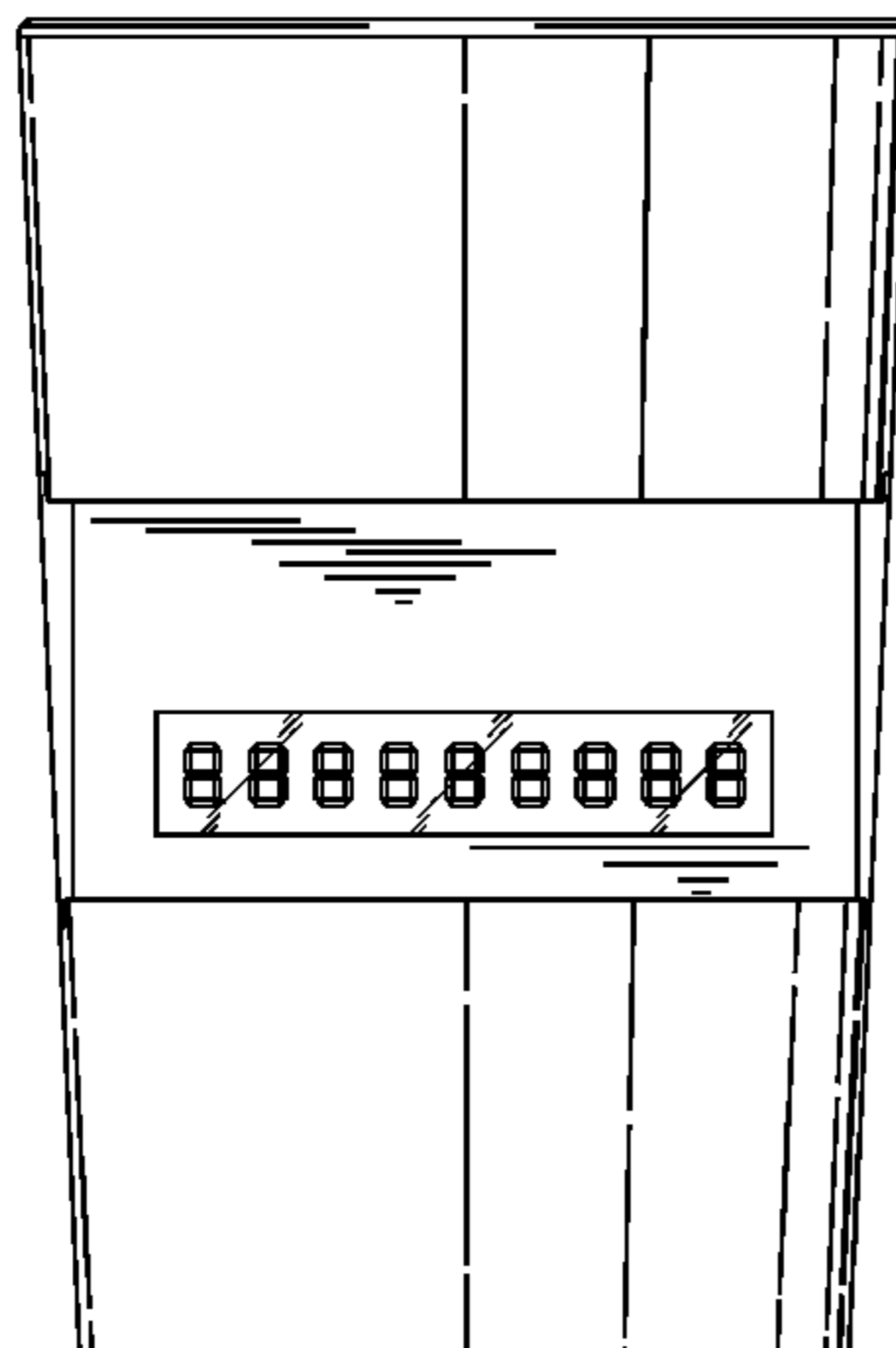
FIG. 7 is a top view of a beverage container with message indicator comprising the second embodiment of the new, original and ornamental design;

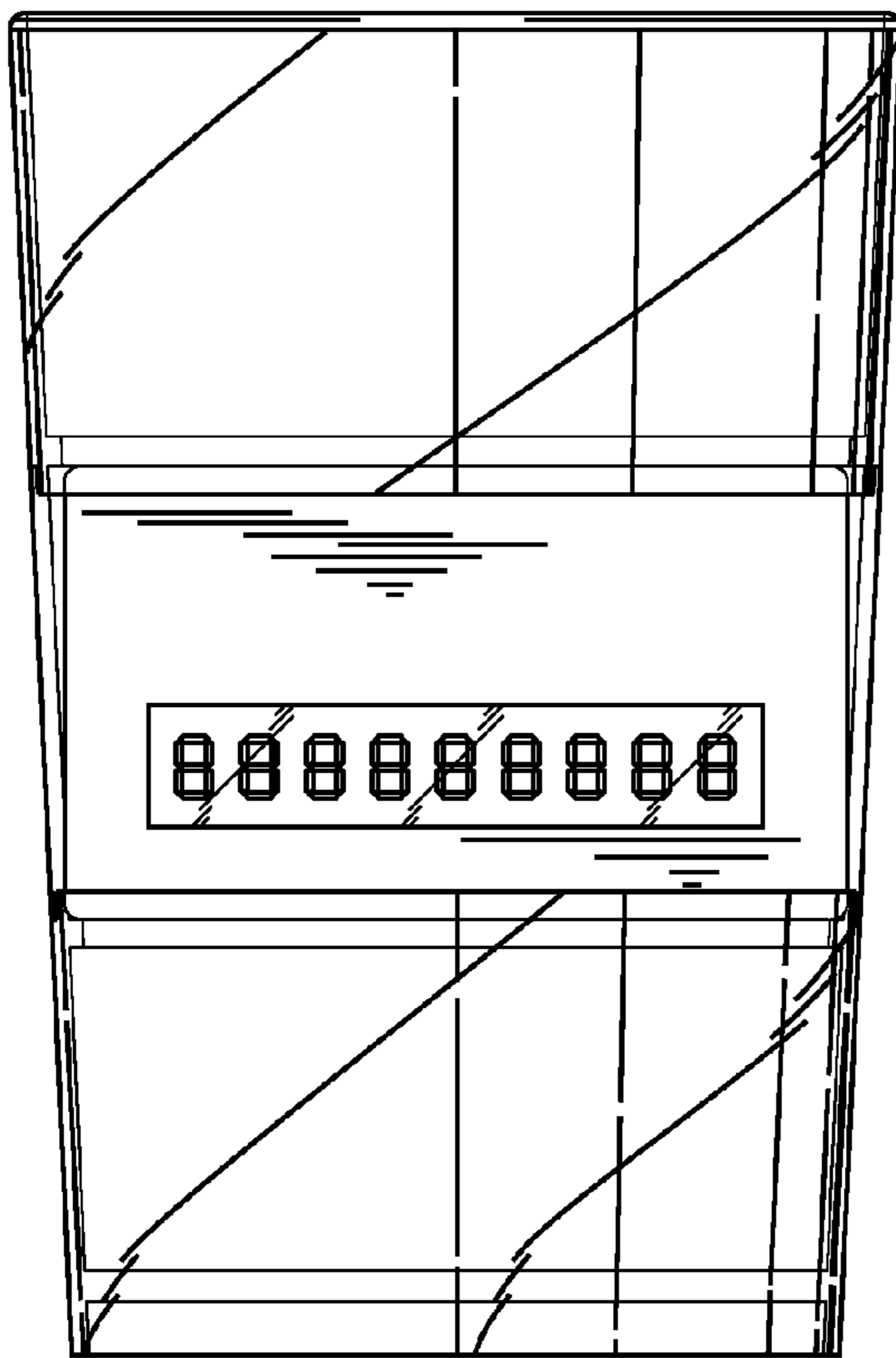

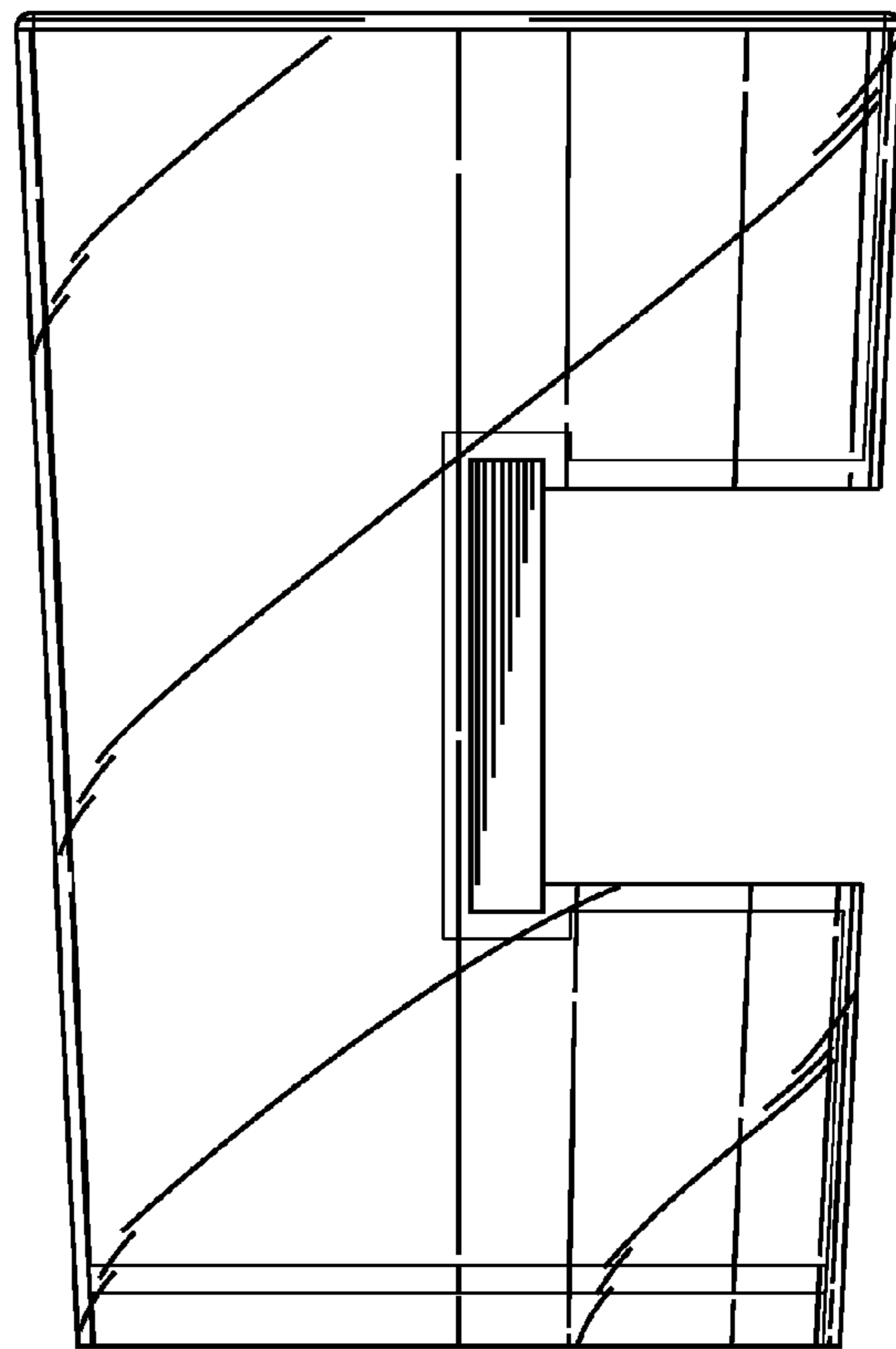

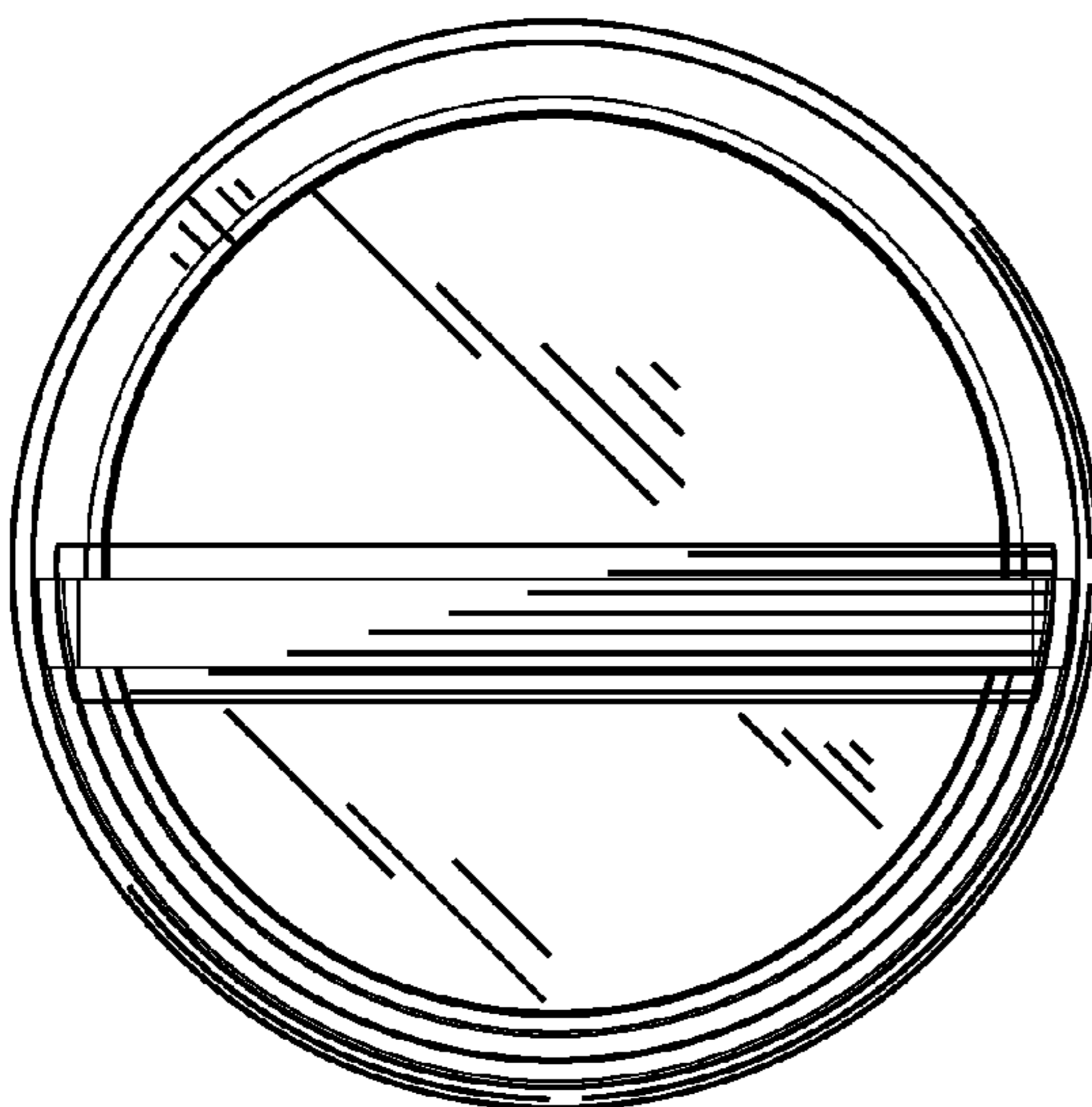

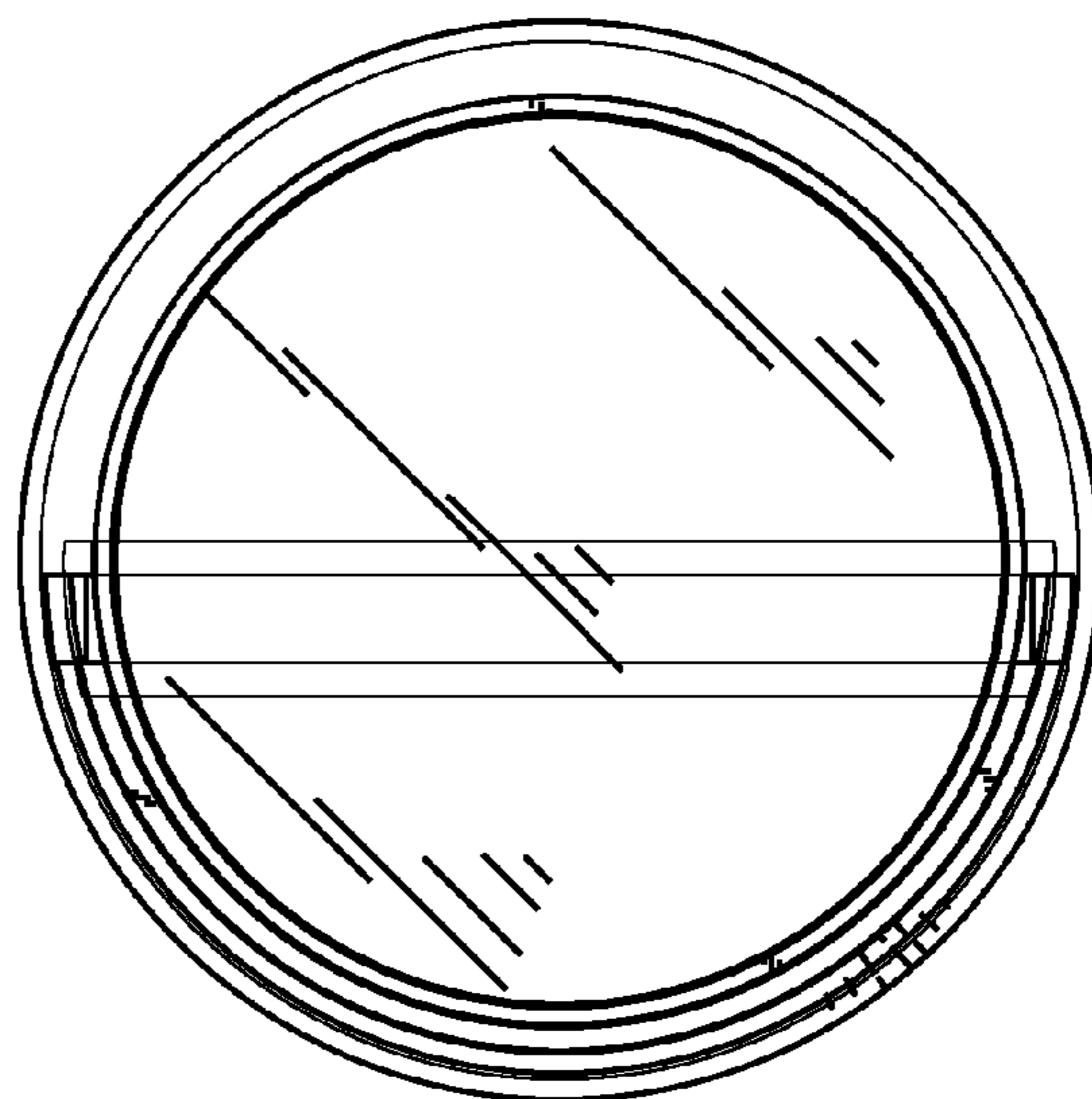

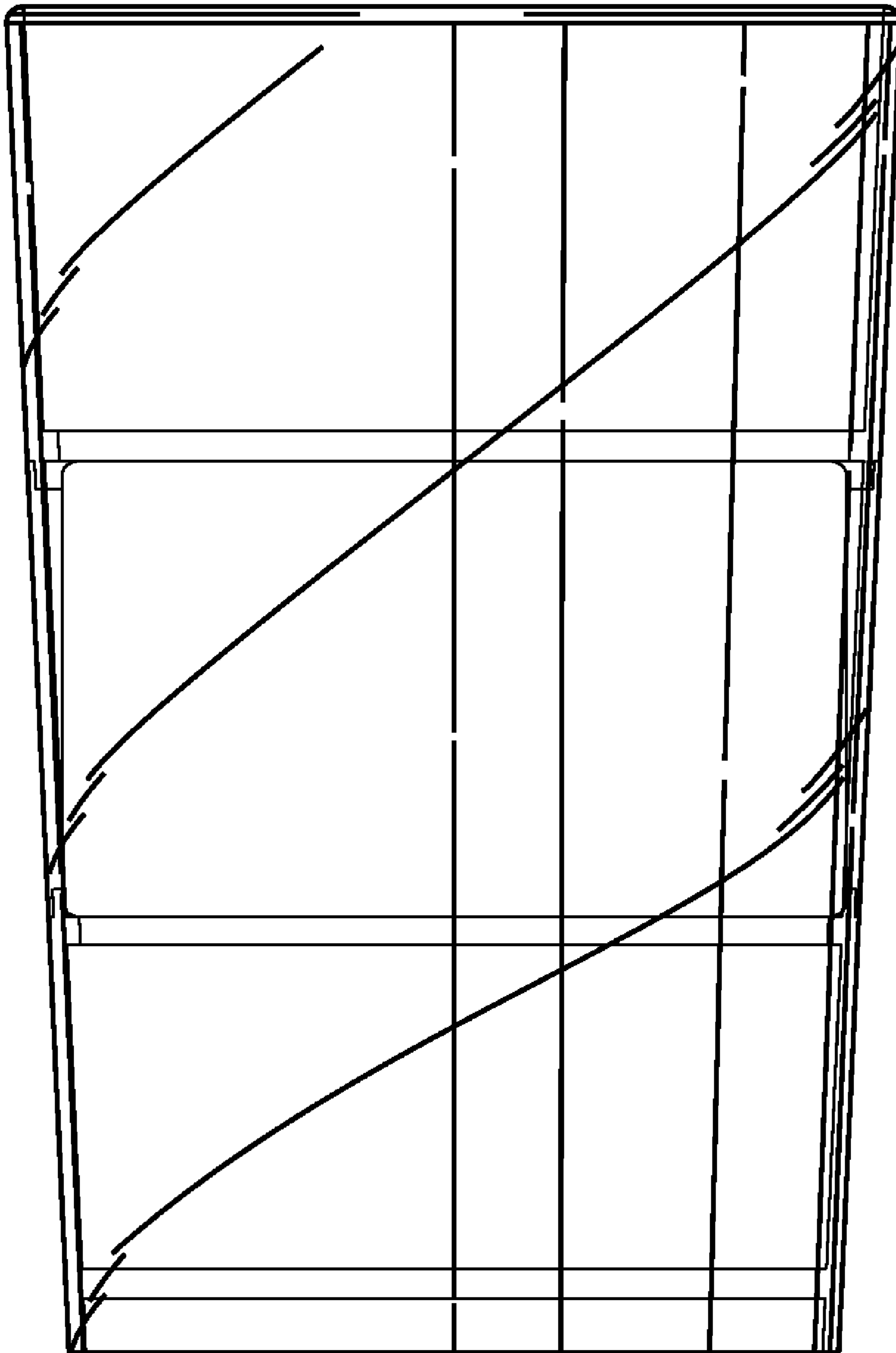

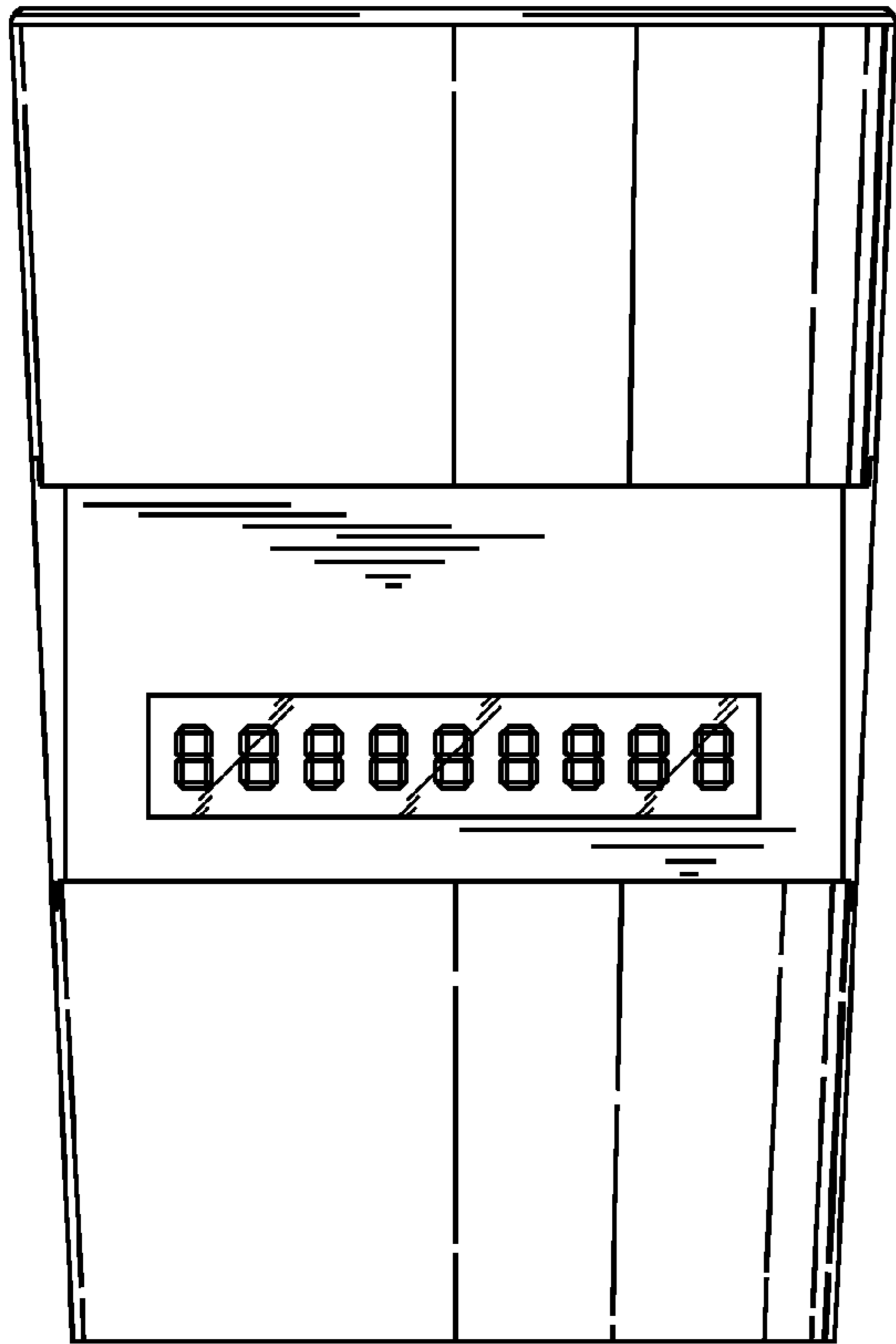

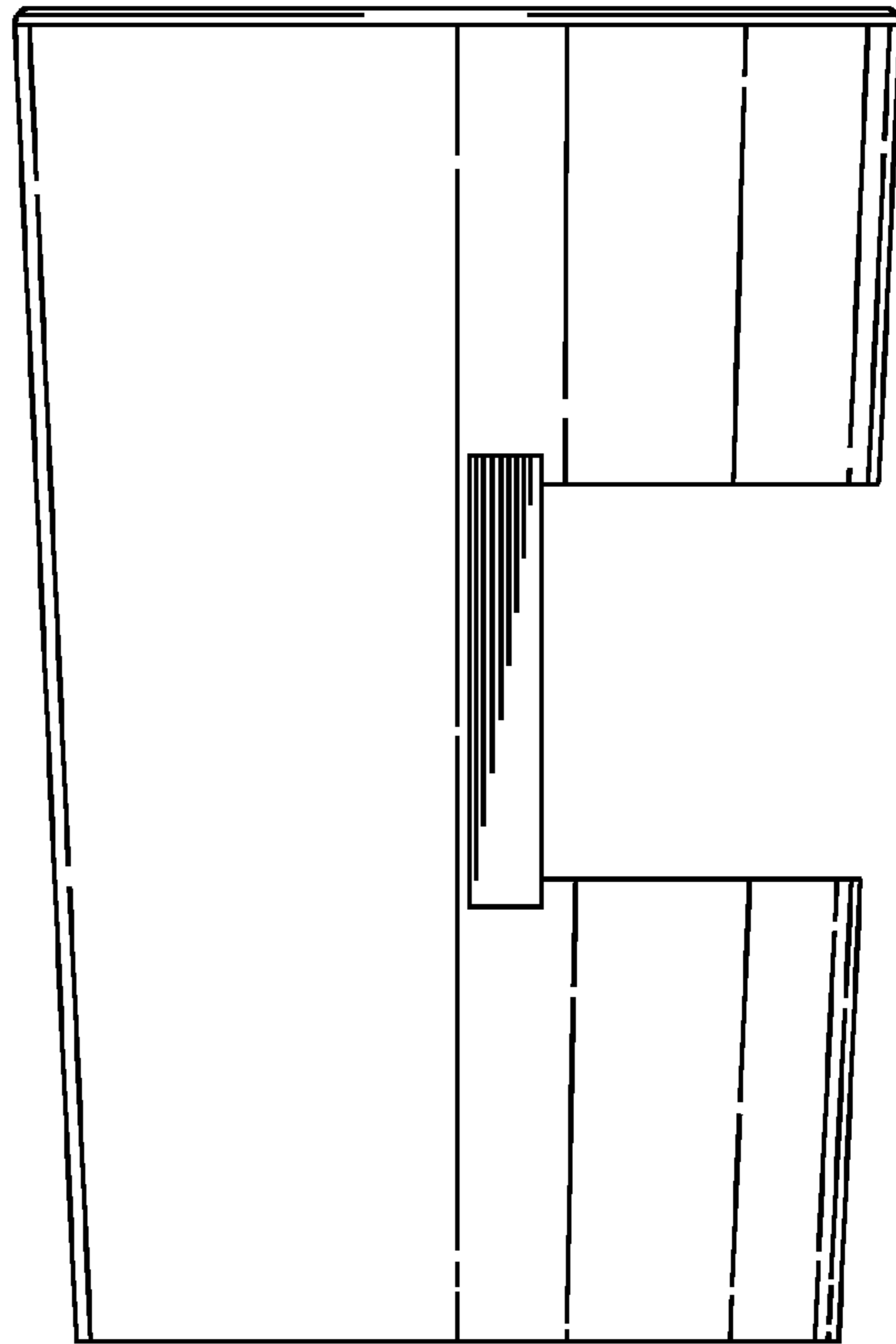

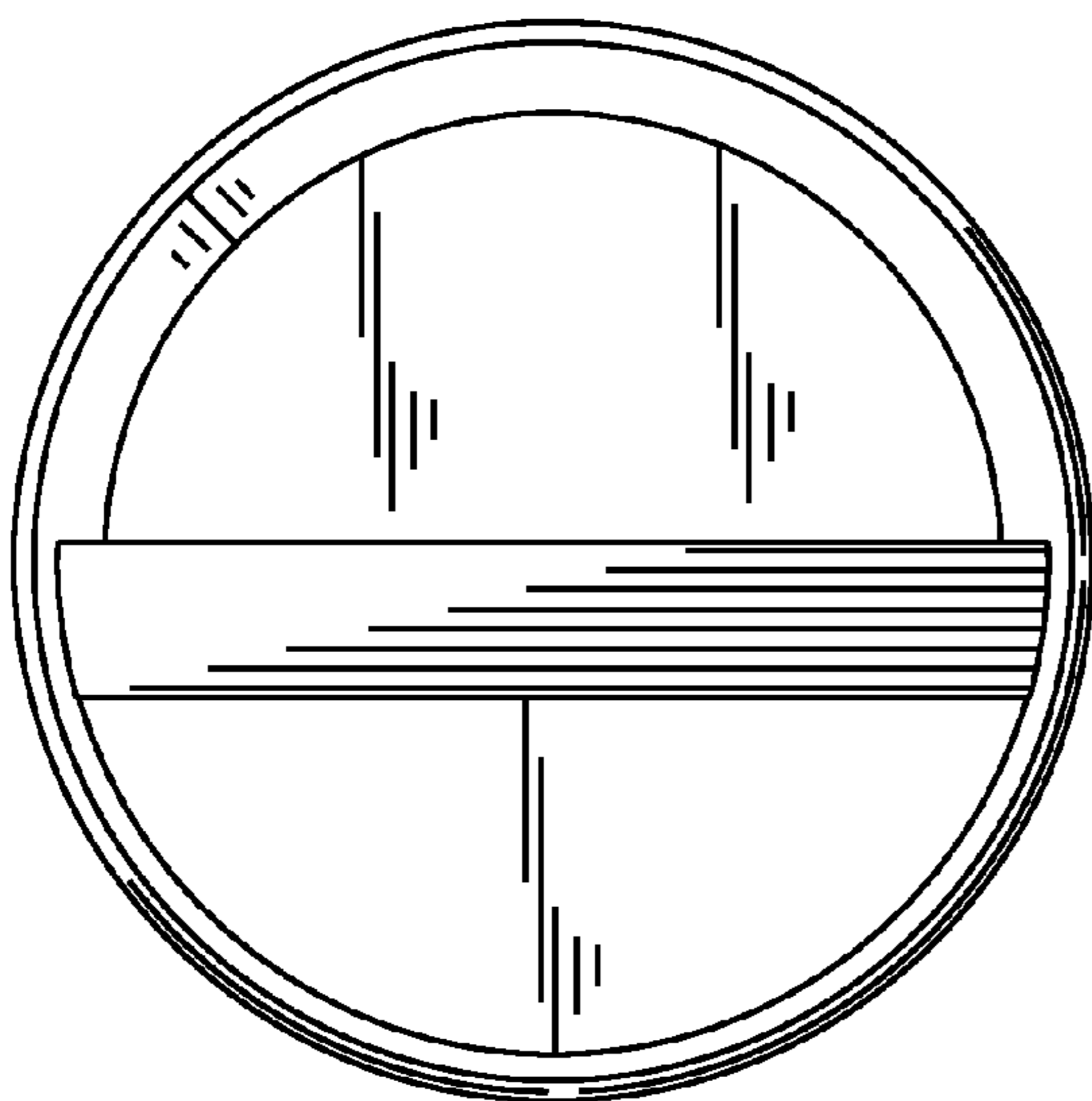

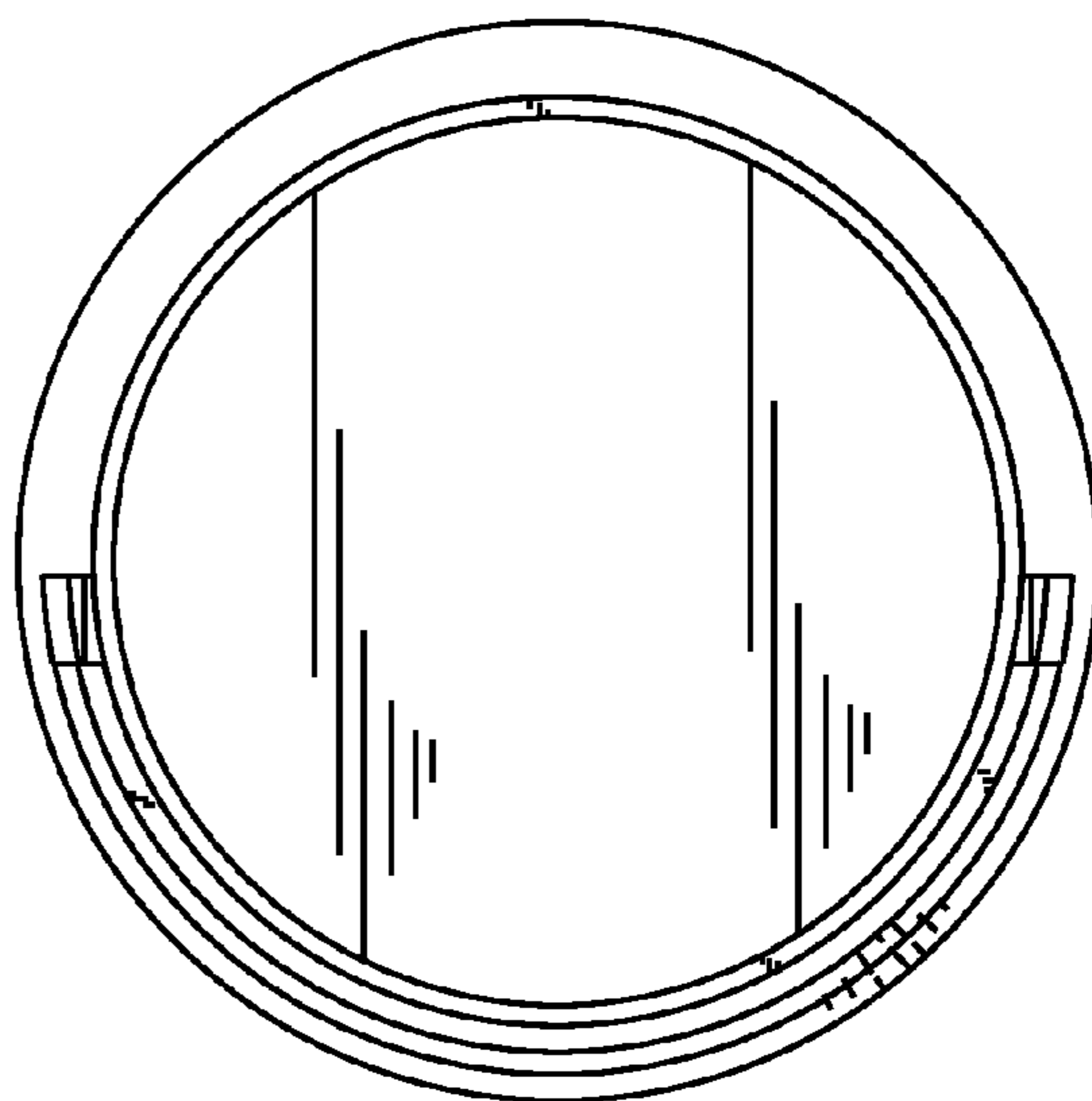

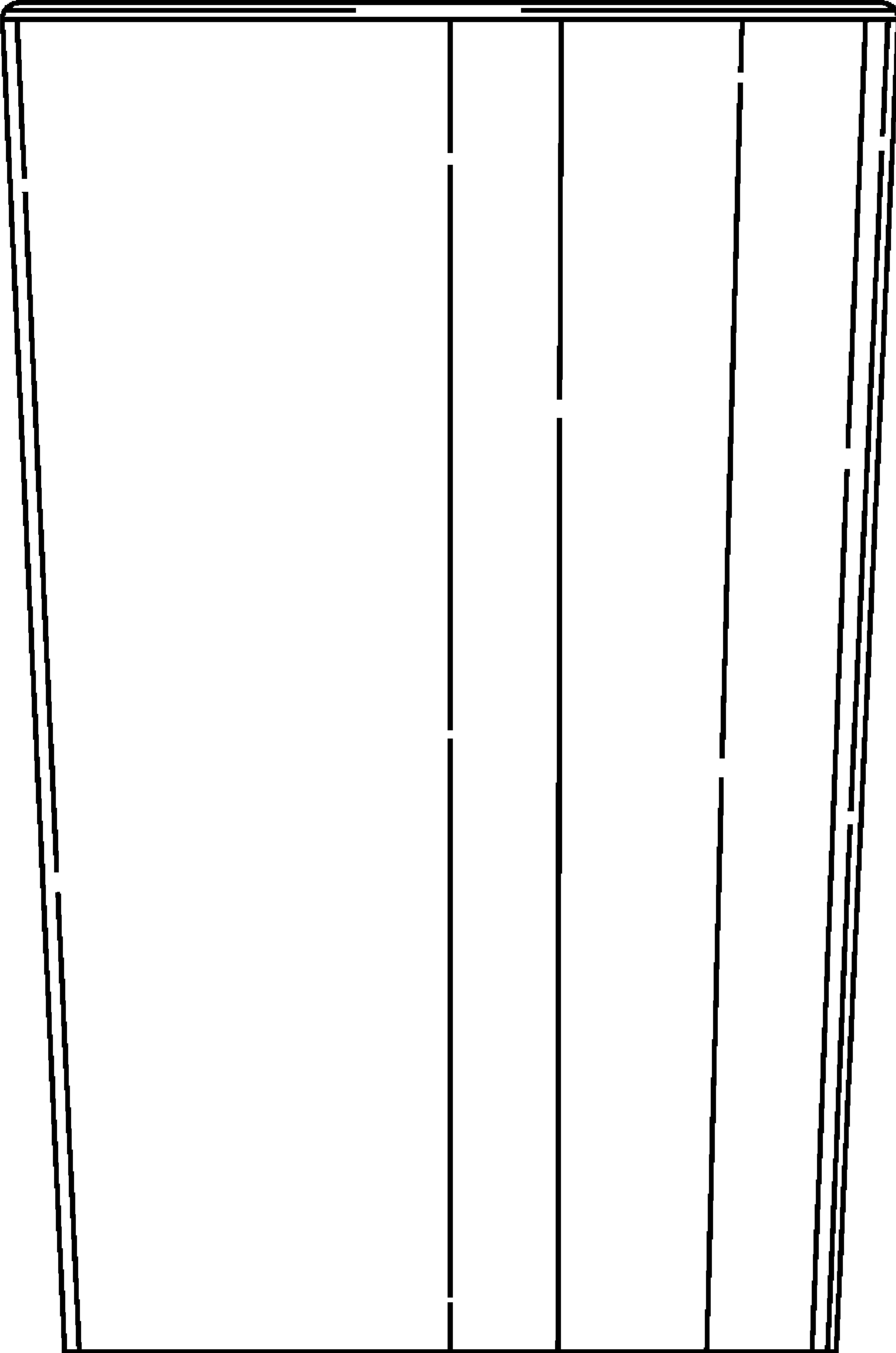
