FIG. 2 is an opposed side view of the grazing reindeer of FIG. 1.

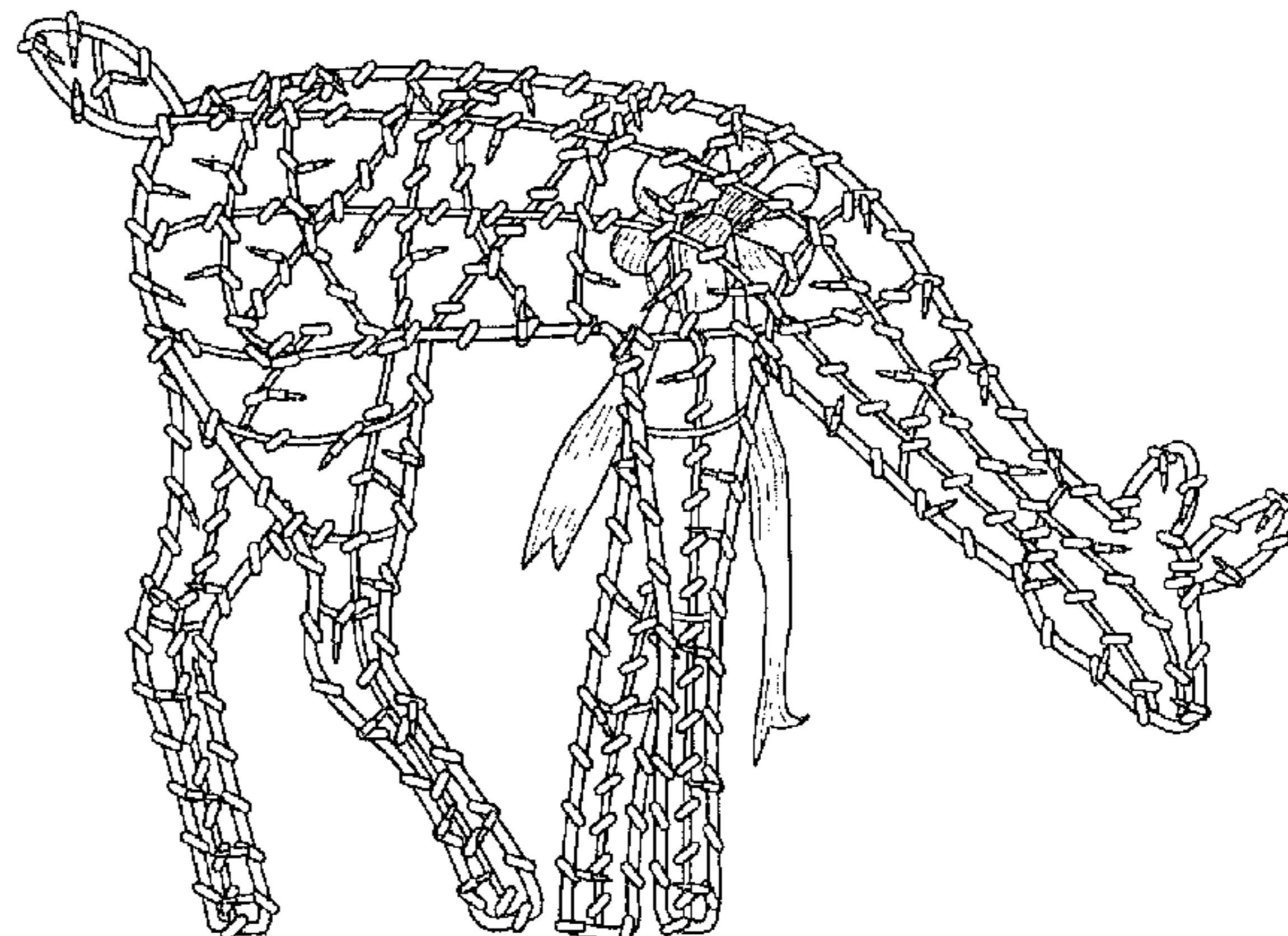
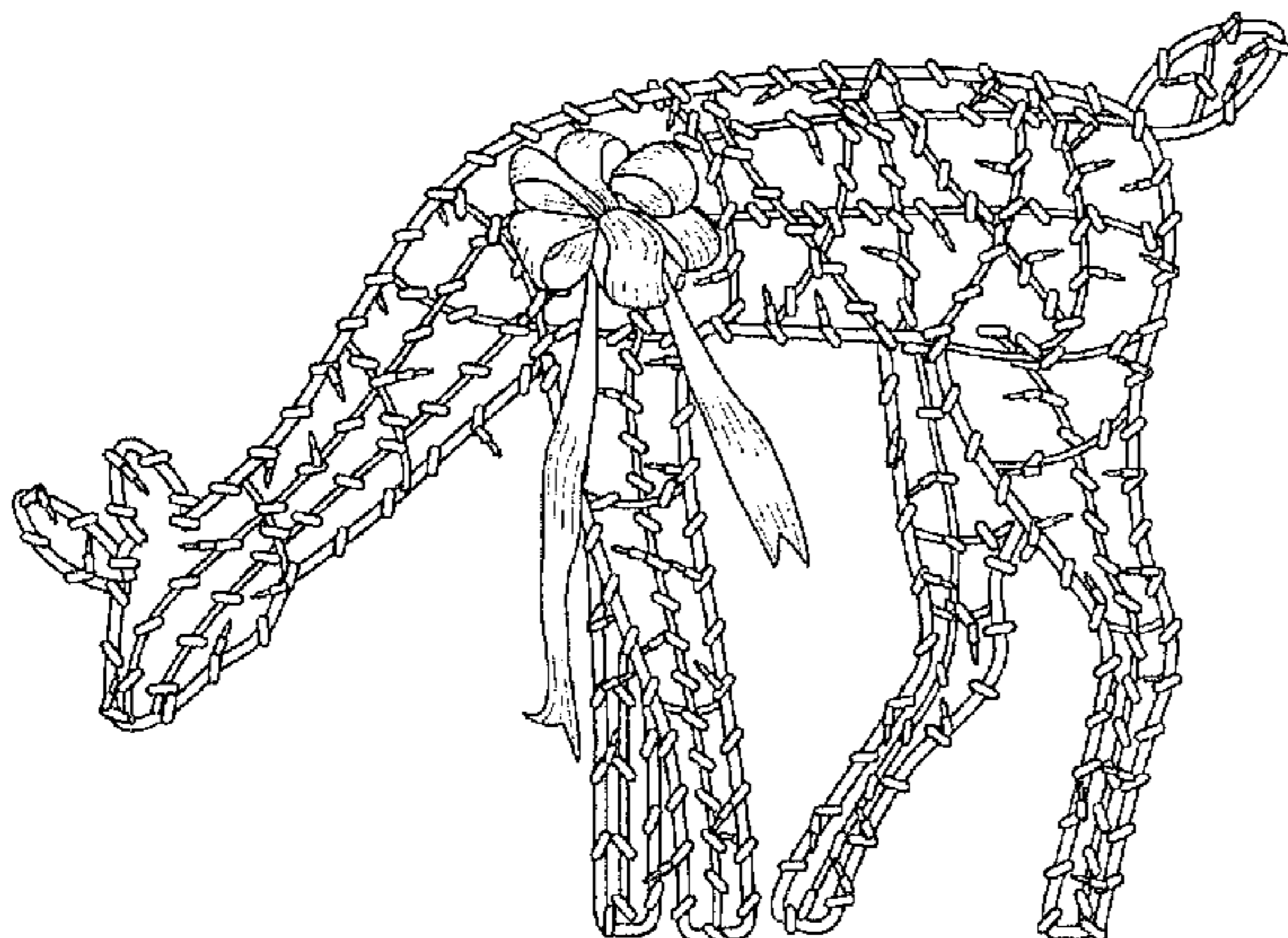
FIG. 3 is a front view of the grazing reindeer of FIG. 1.

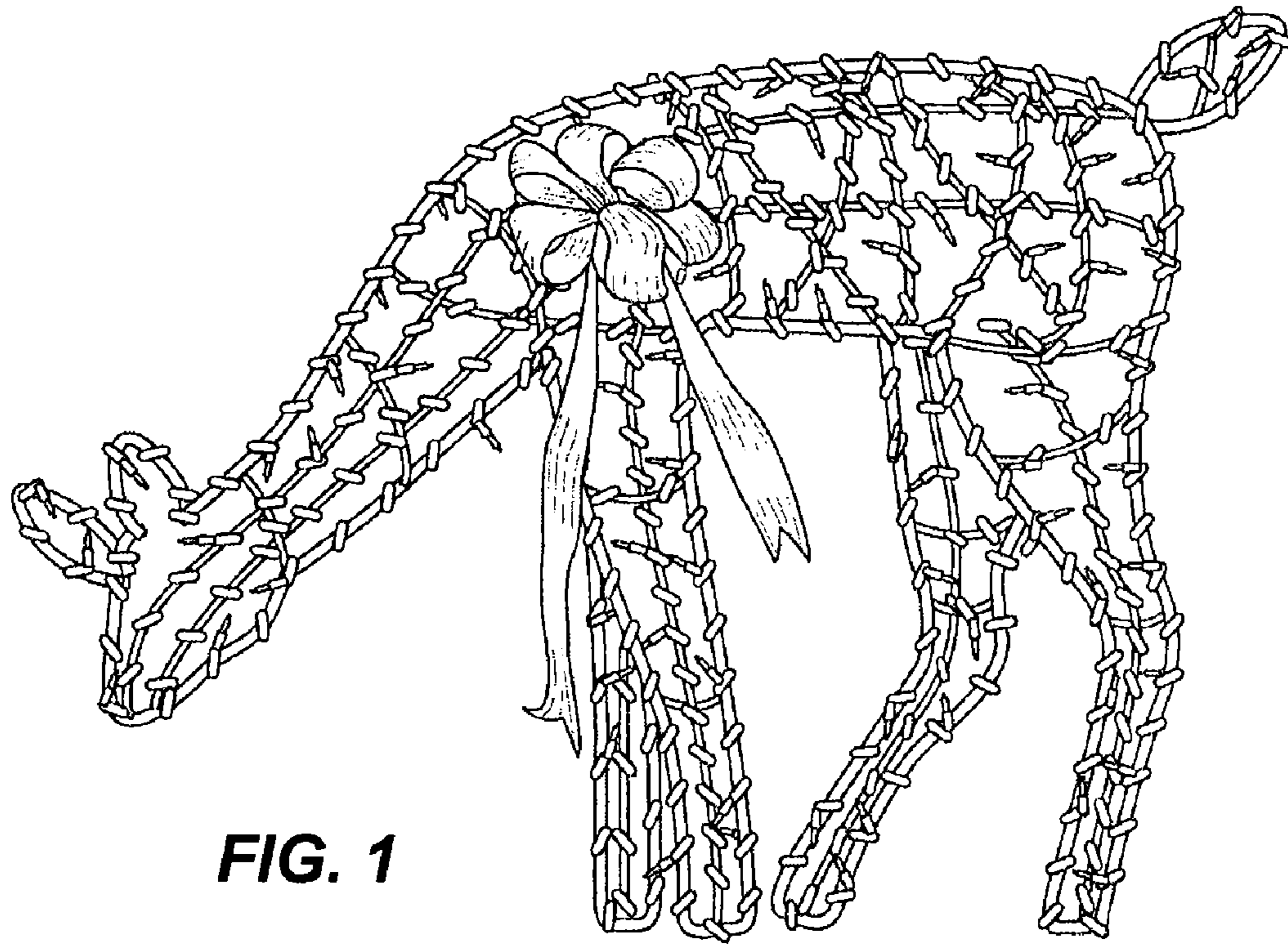

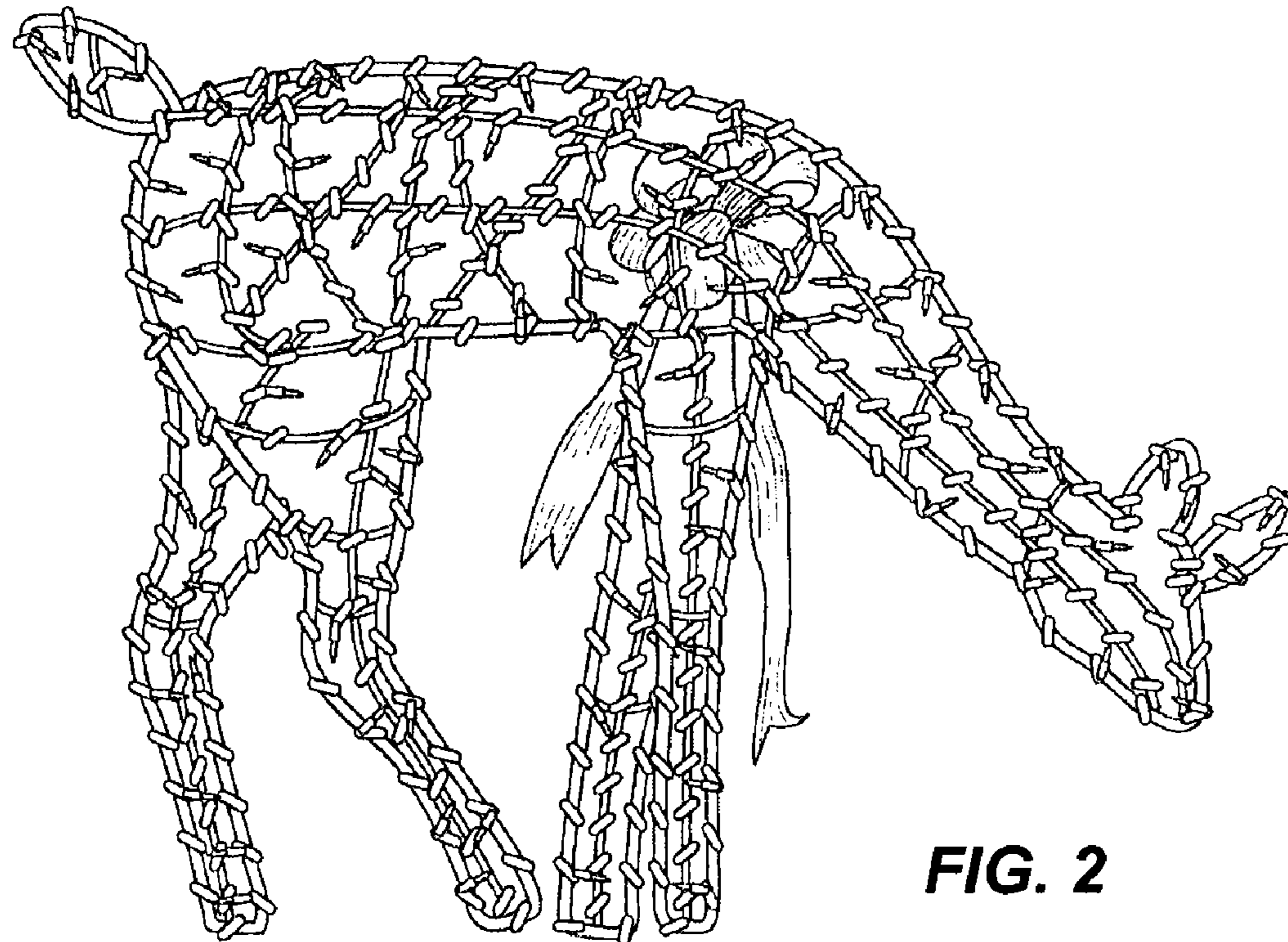

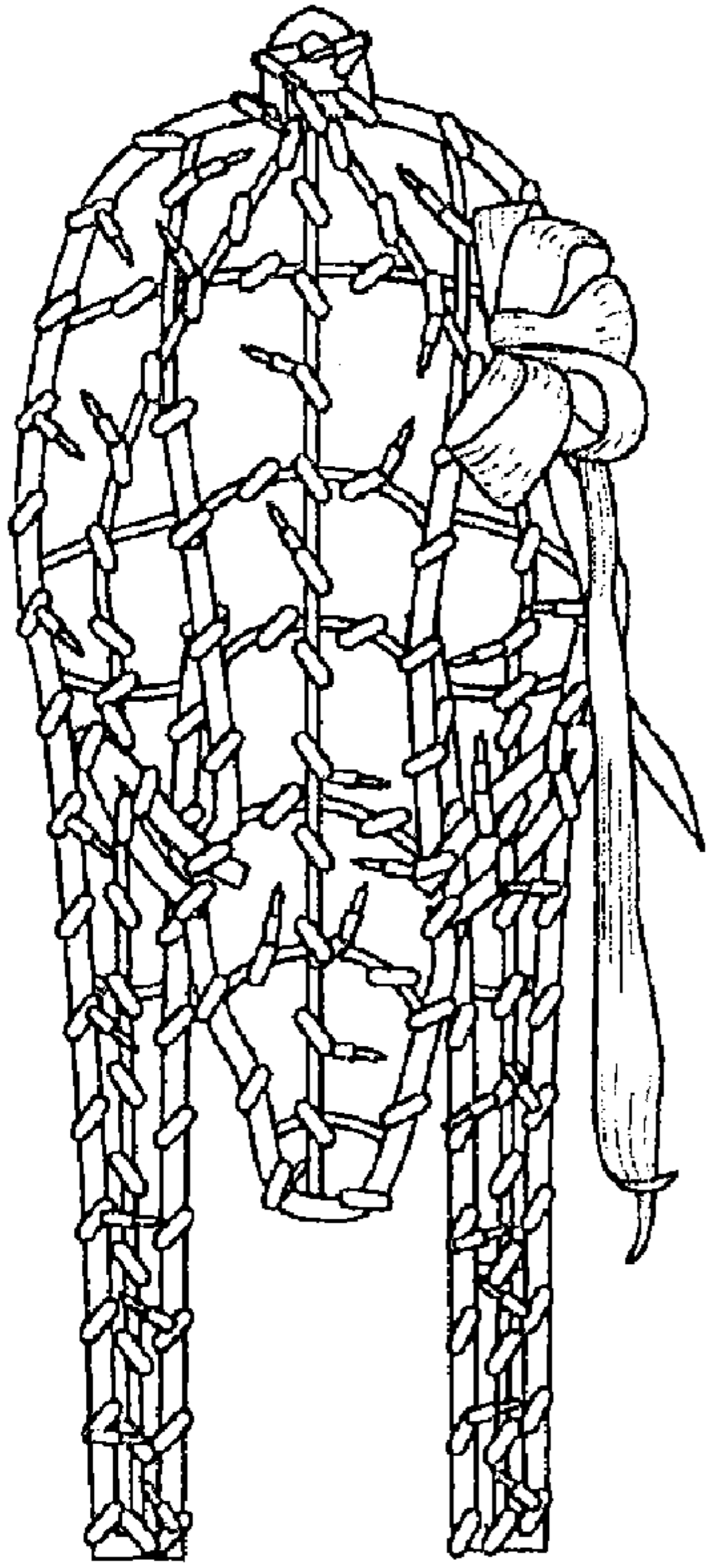

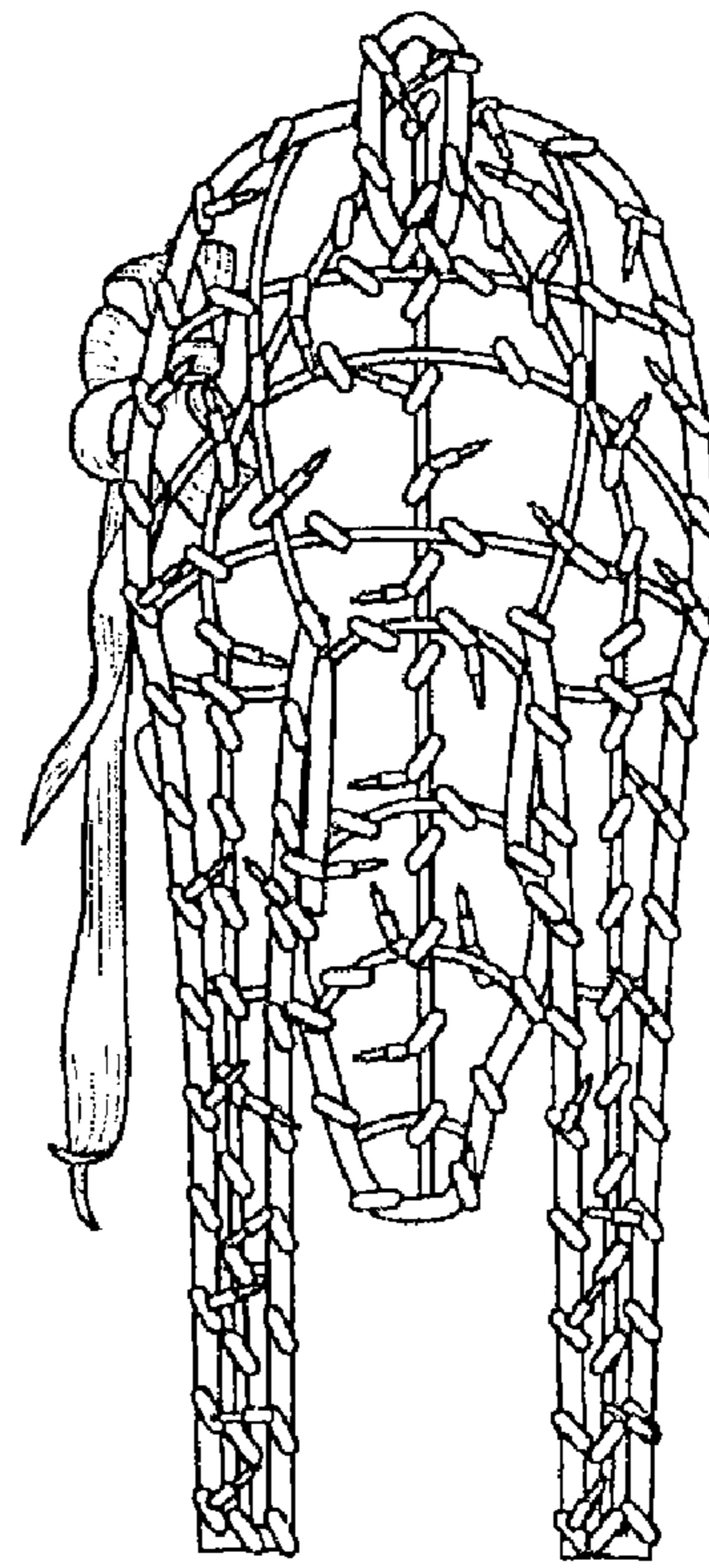

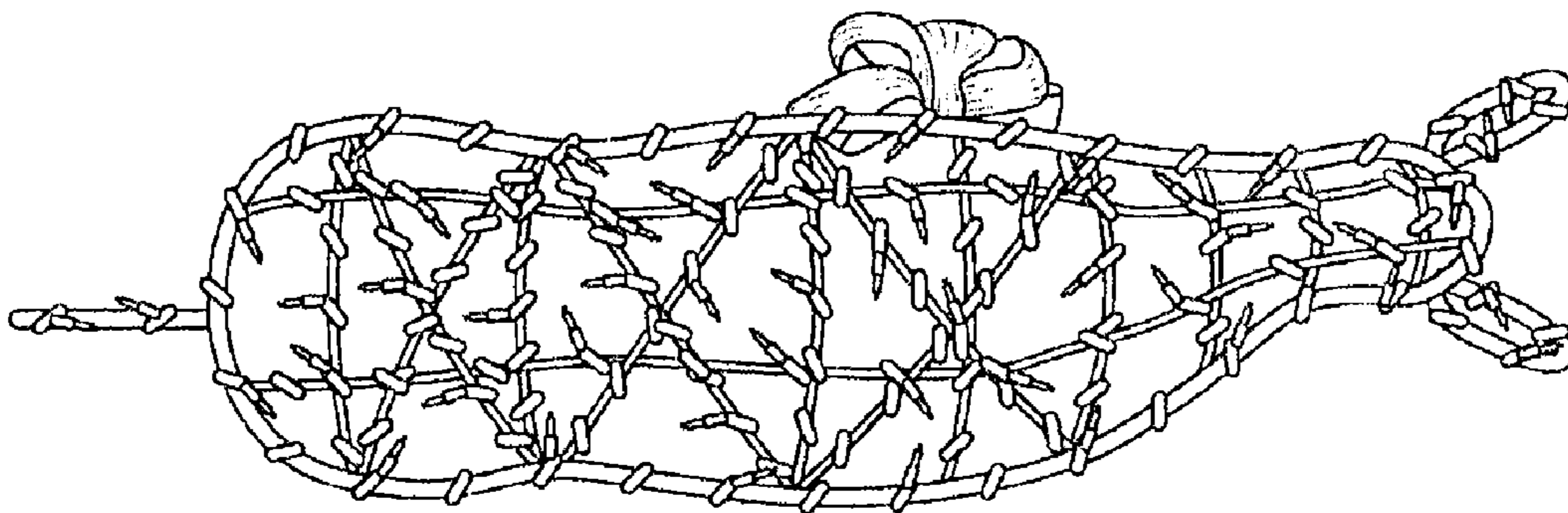
