(57) **CLAIM**

The ornamental design for a portable electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable electronic device in accordance with the present design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

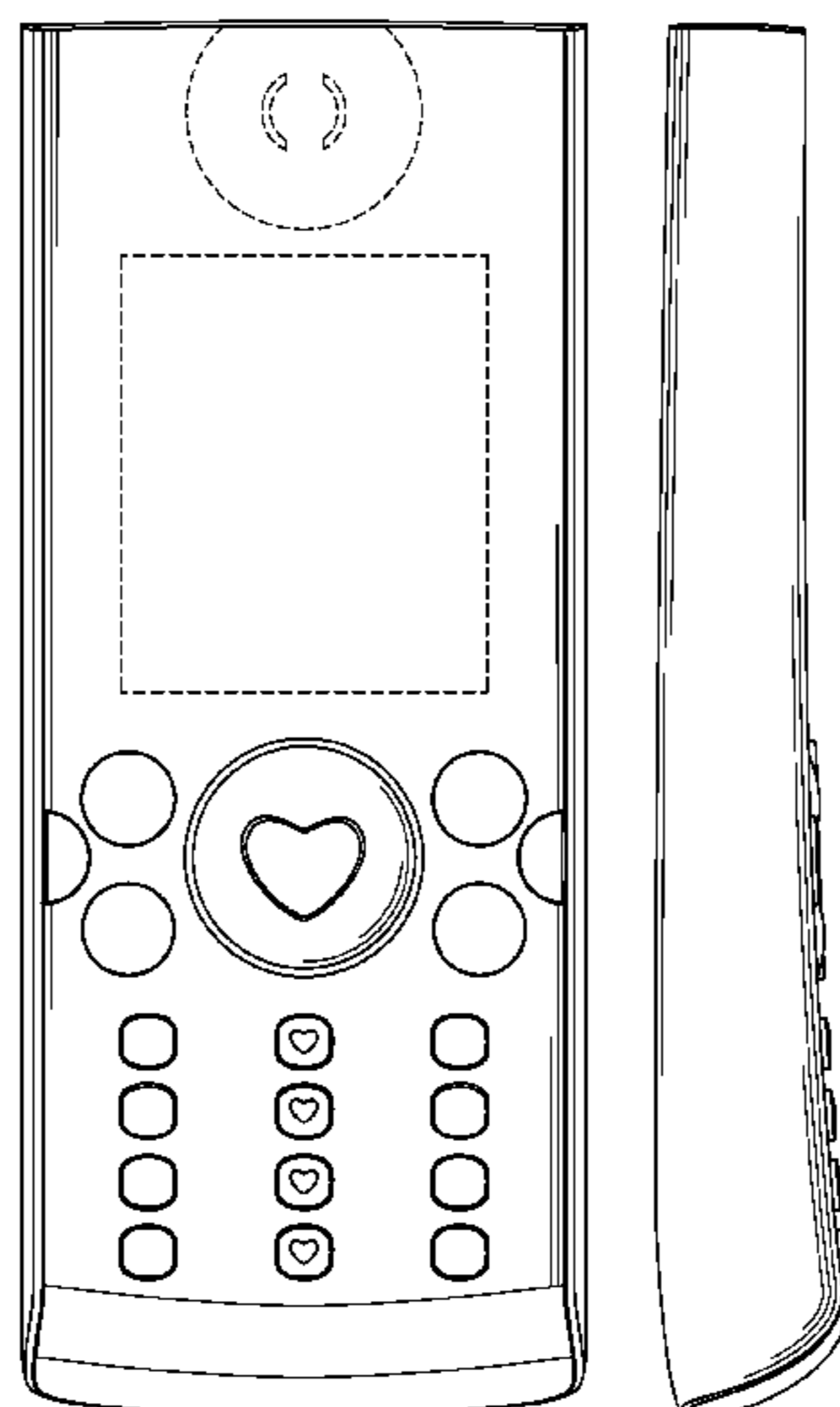
FIG. 5 is a top plan view thereof; and,

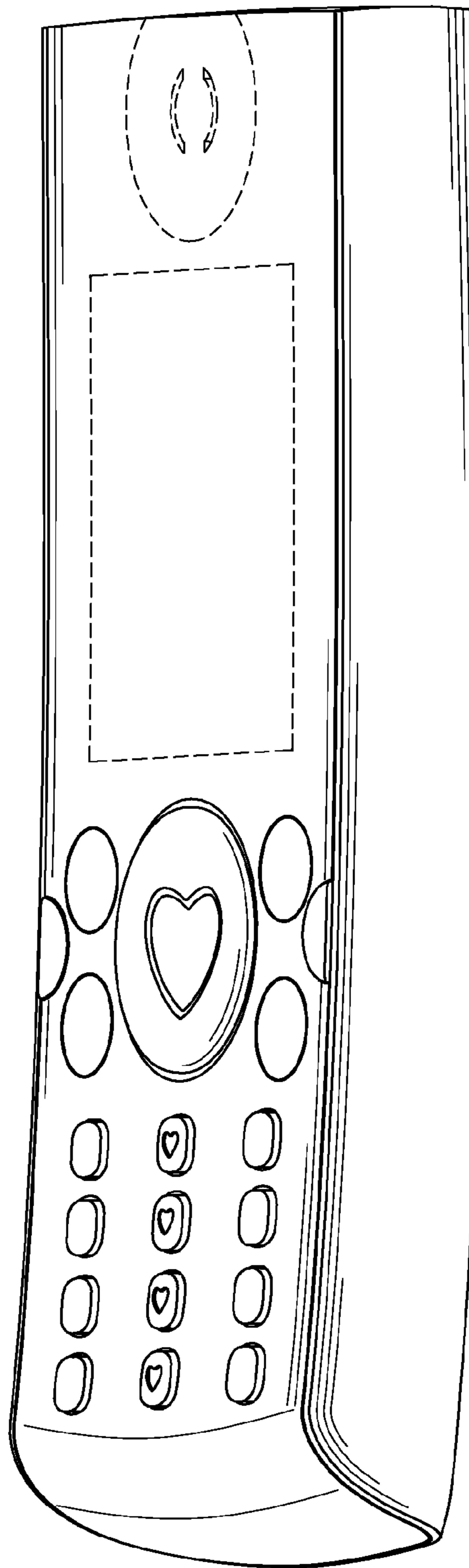

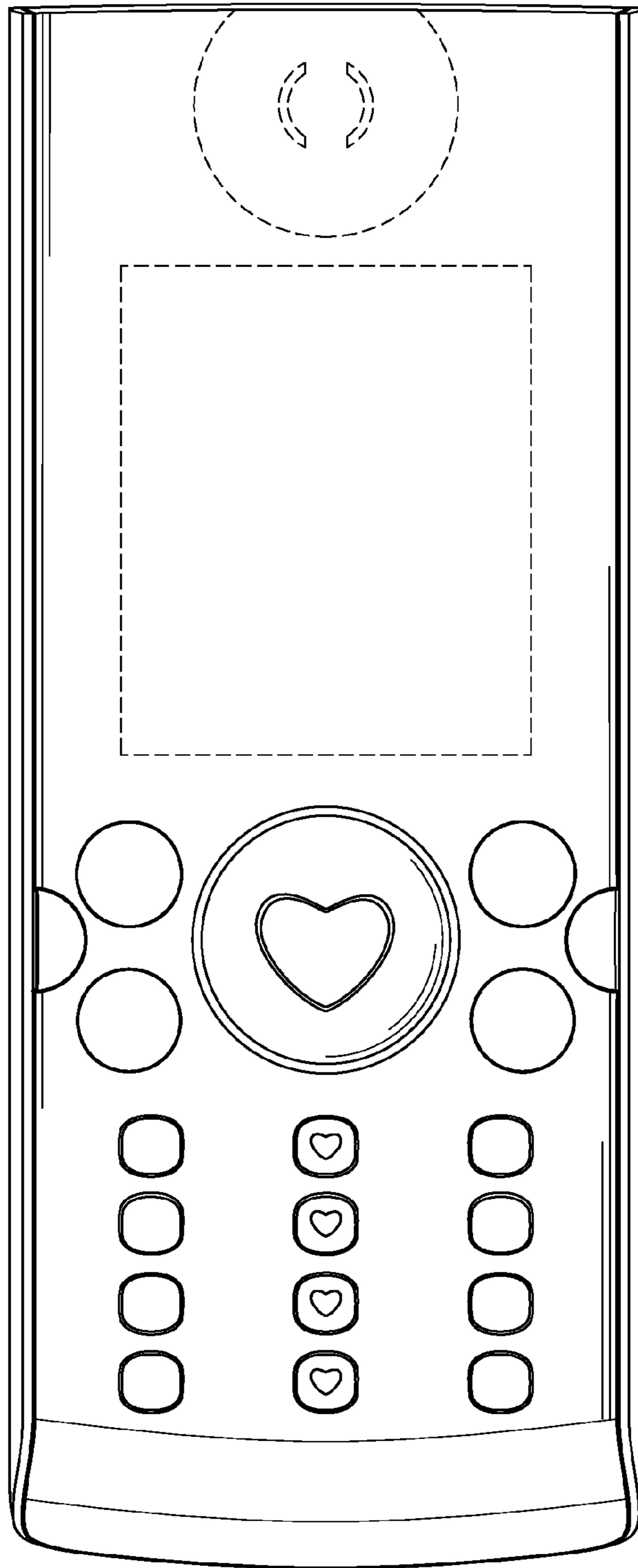

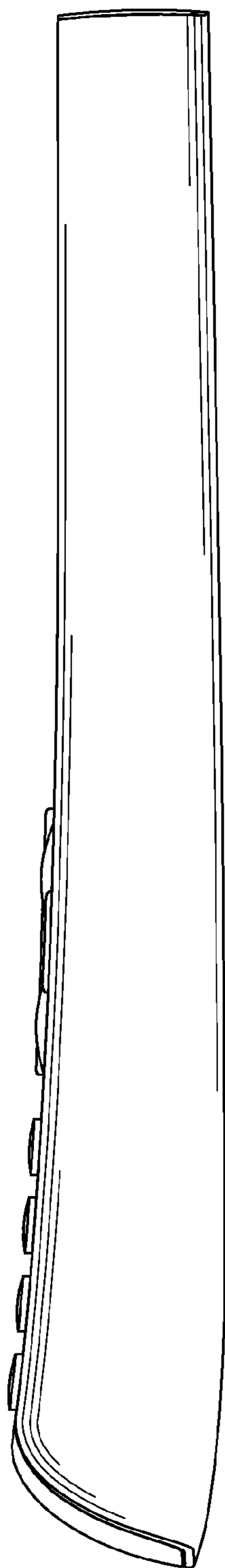

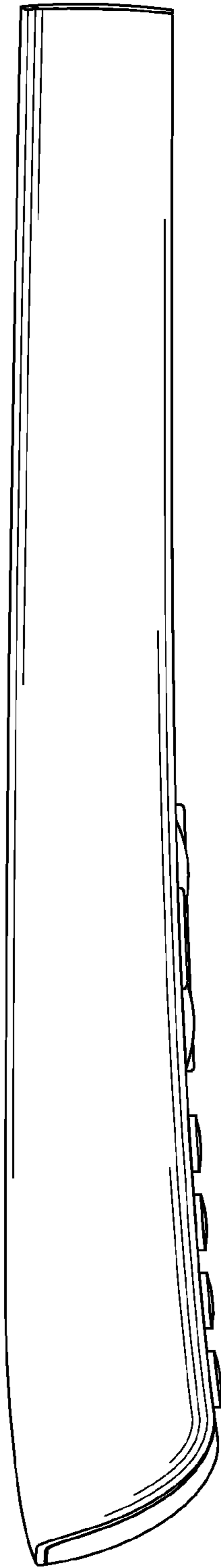

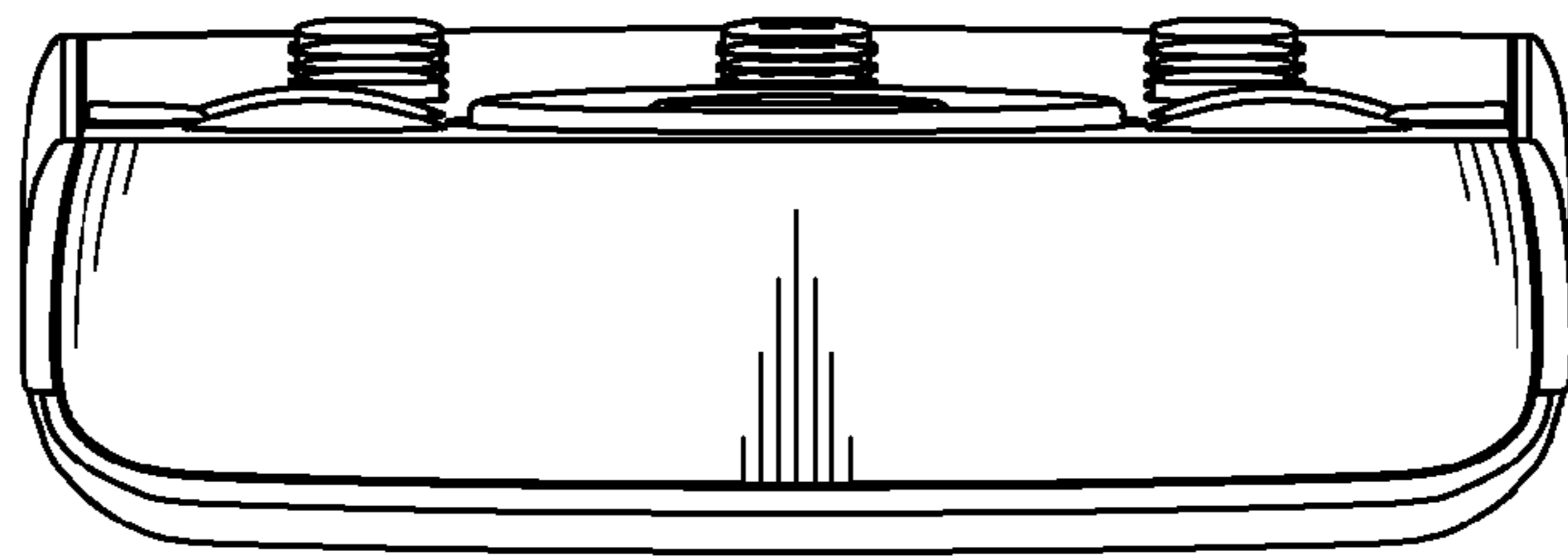

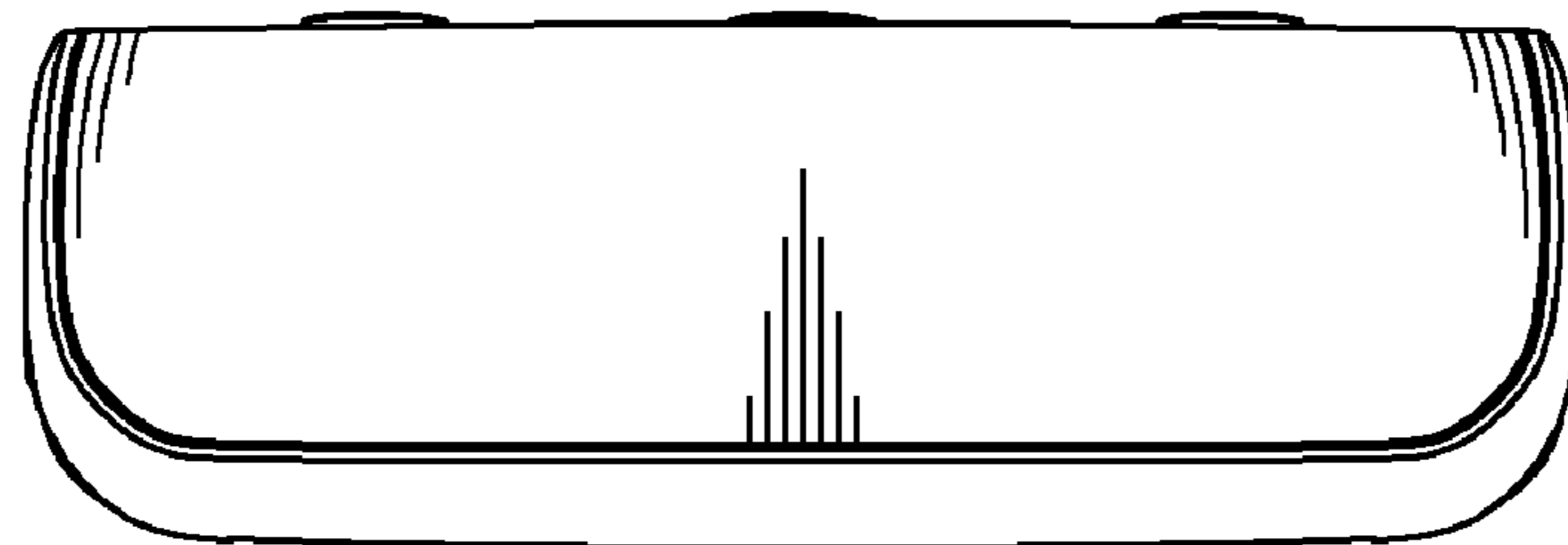
