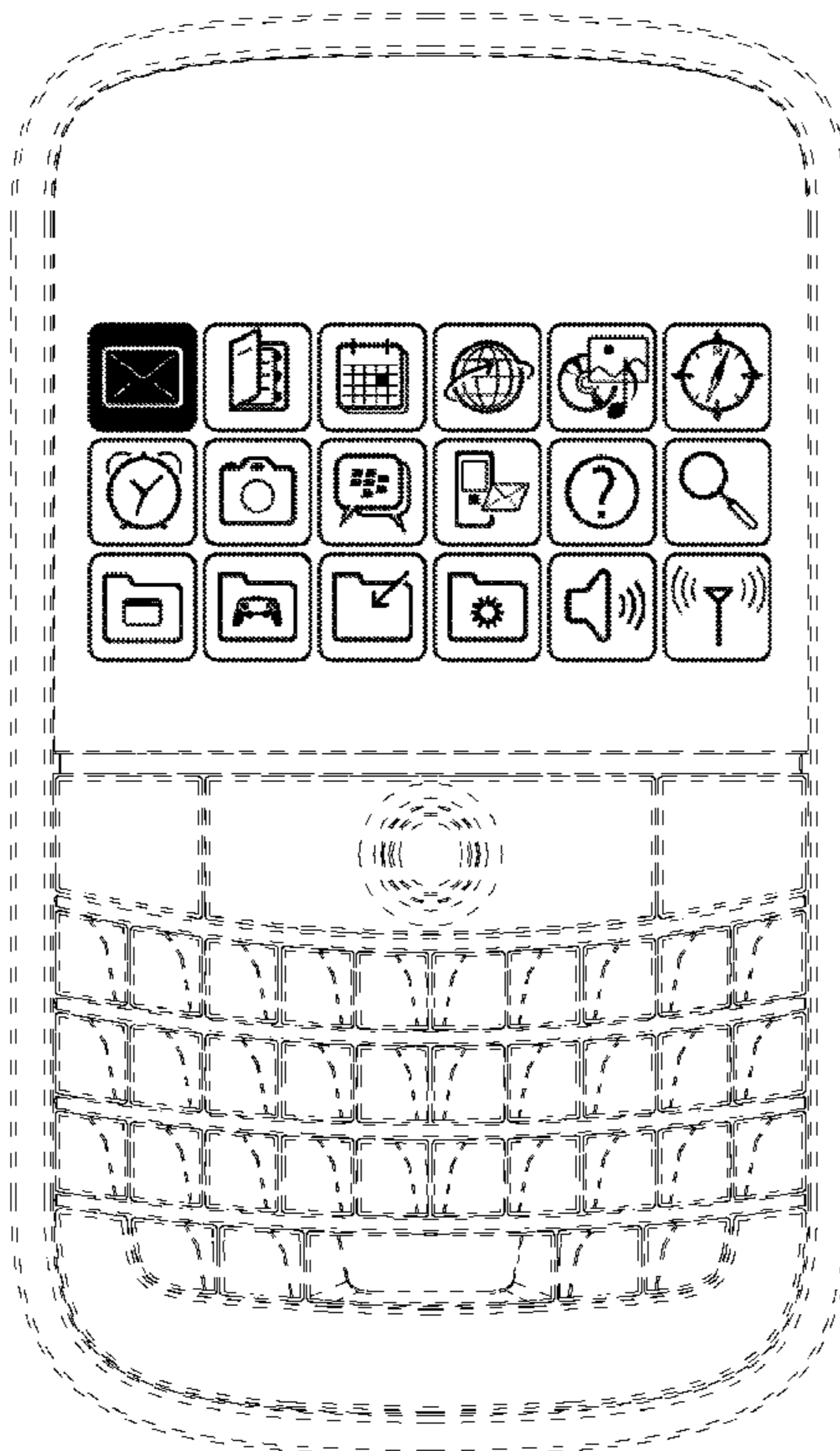
We claim the ornamental design for a set of icons for a hand-held electronic display device, as shown and described.

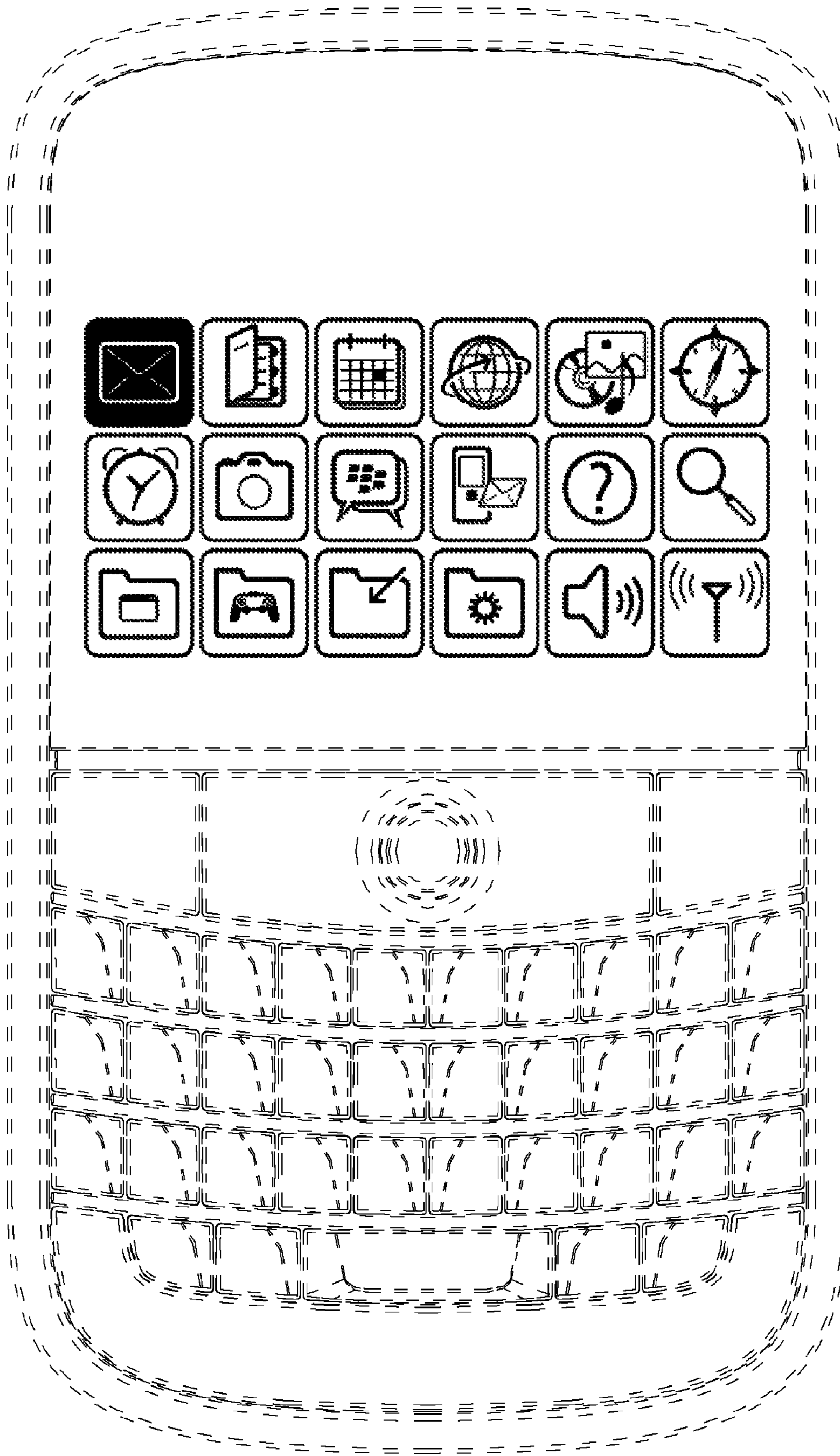
**DESCRIPTION**
