(57) **CLAIM**

We claim the ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf club head, as viewed from the front, above and one side, according to one embodiment.

FIG. 2 is a perspective view of the golf club head of FIG. 1, as viewed from the rear, below and one side.

FIG. 3 is a front elevation view of the golf club head of FIG. 1.

FIG. 4 is a rear elevation view of the golf club head of FIG. 1.

FIG. 5 is a side elevation view of the toe of the golf club head of FIG. 1.

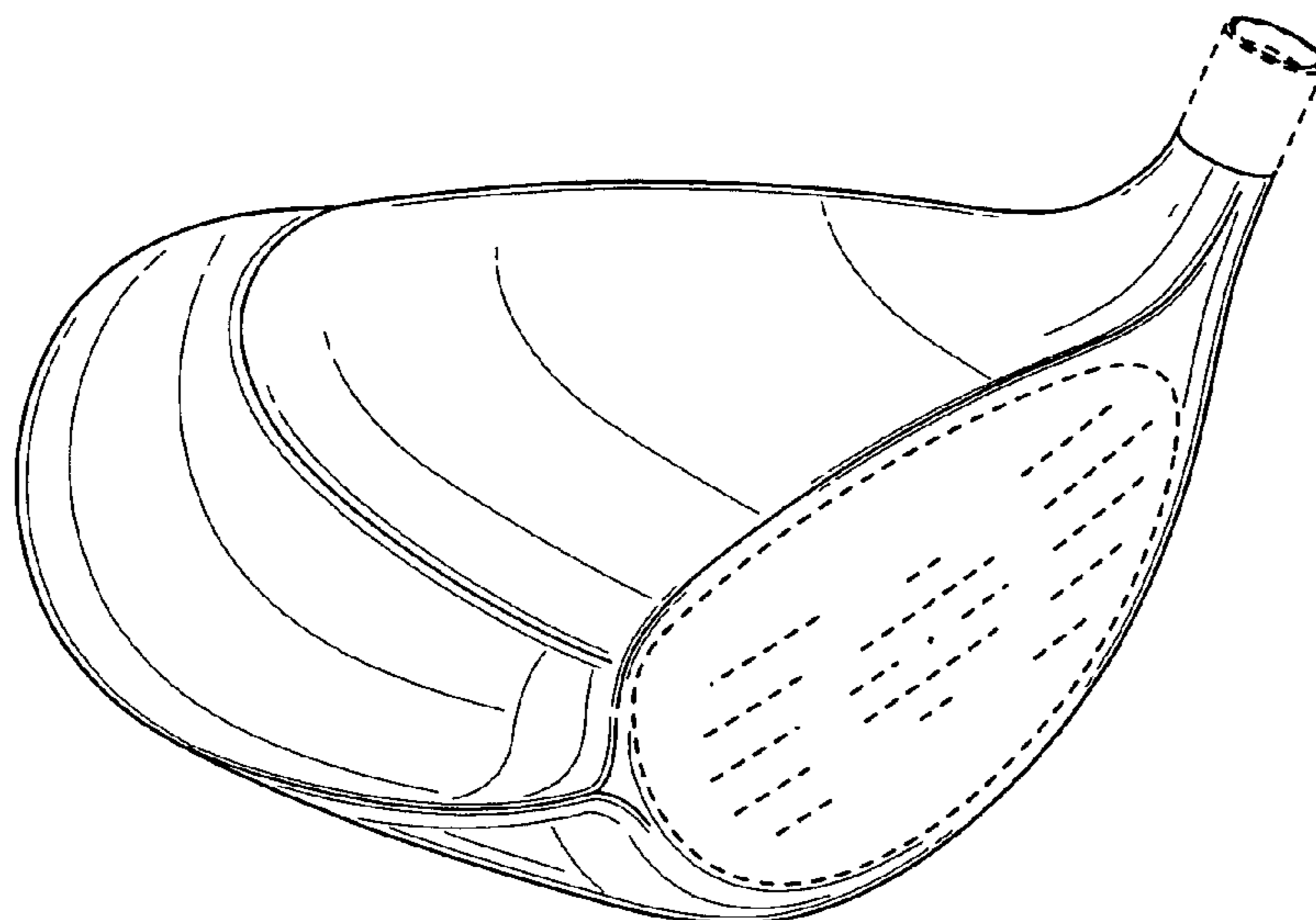
FIG. 6 is a side elevation view of the heel of the golf club head of FIG. 1.

FIG. 7 is a top plan view of the golf club head of FIG. 1; and,

FIG. 8 is a bottom plan view of the golf club head of FIG. 1.

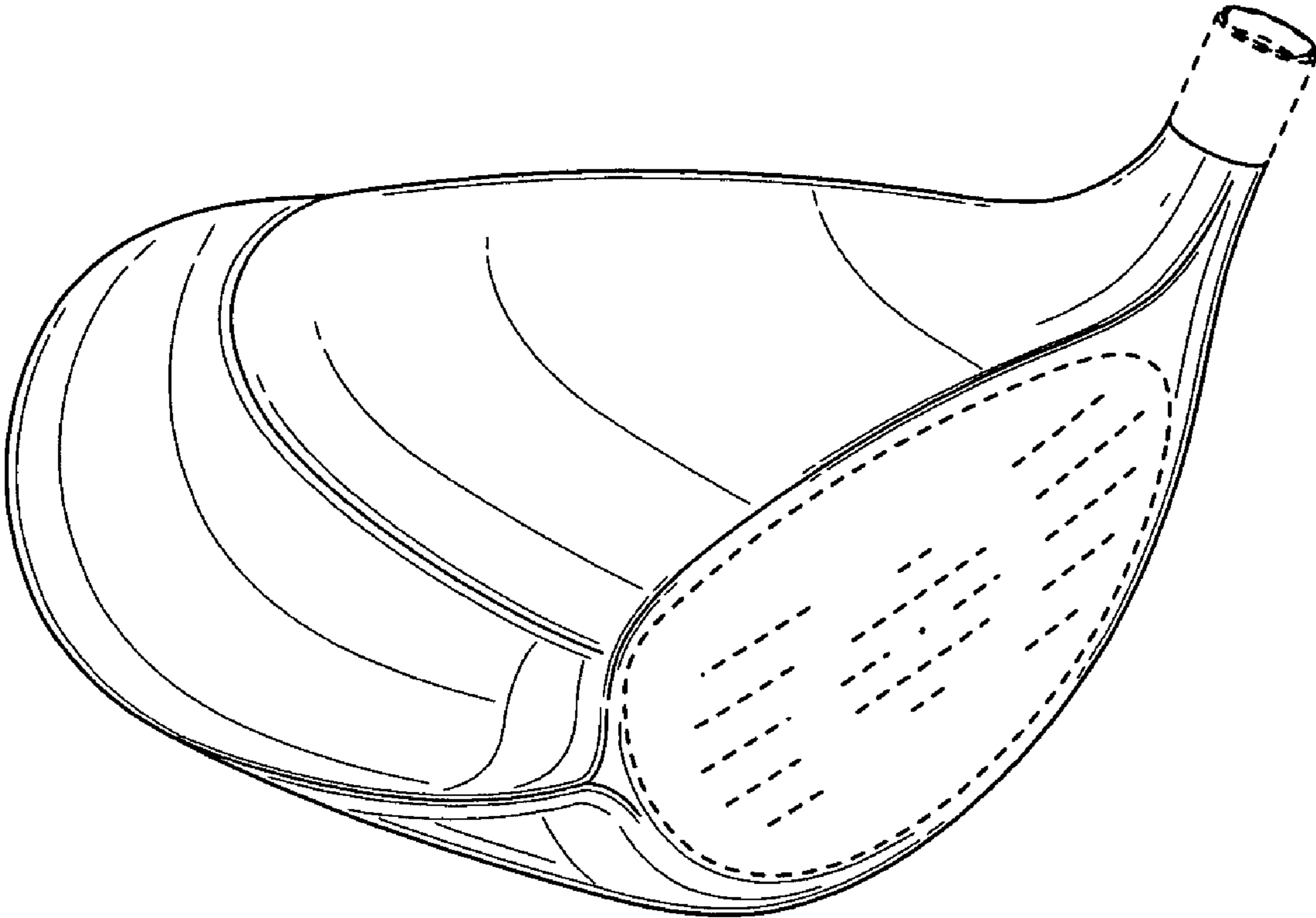

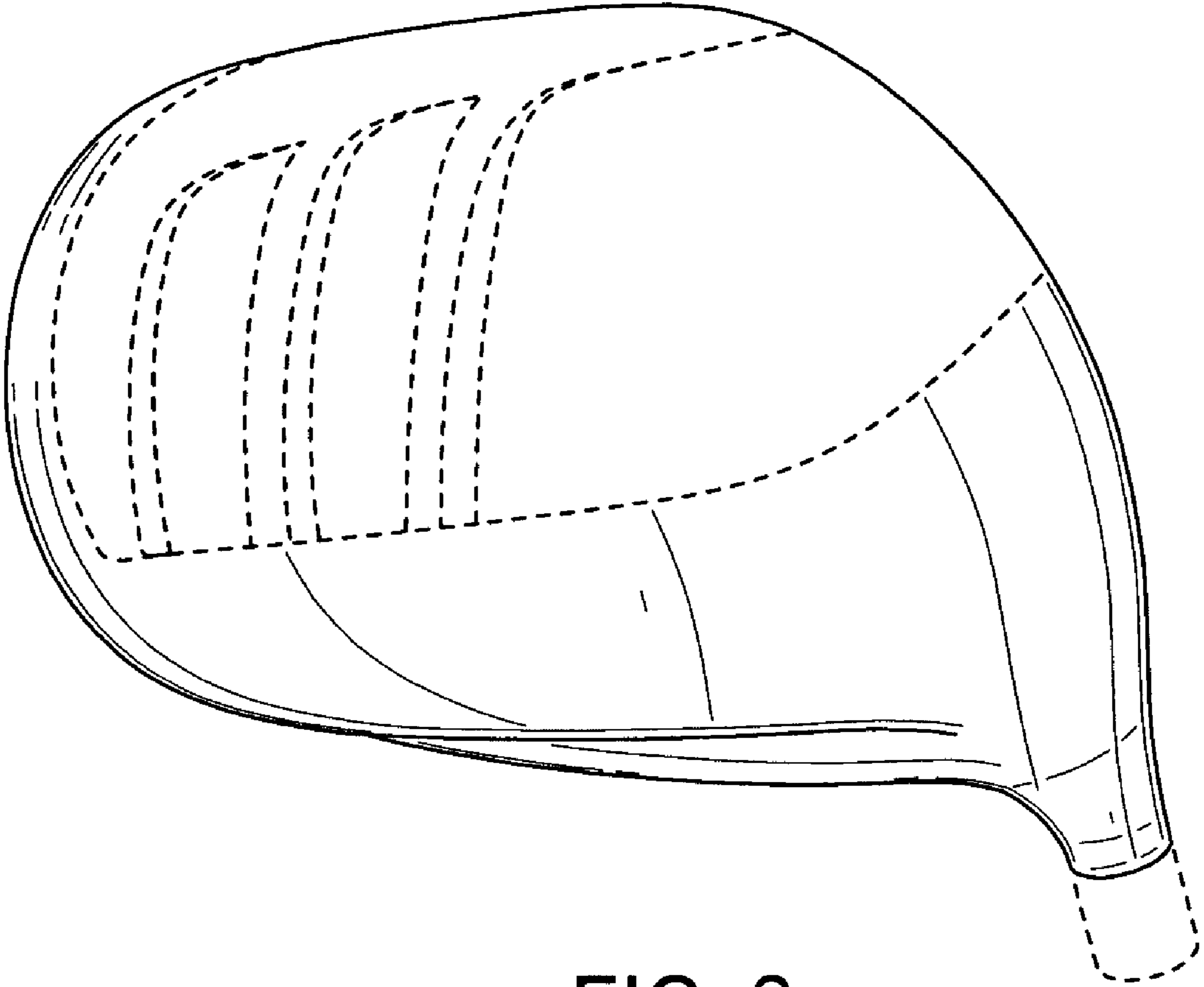

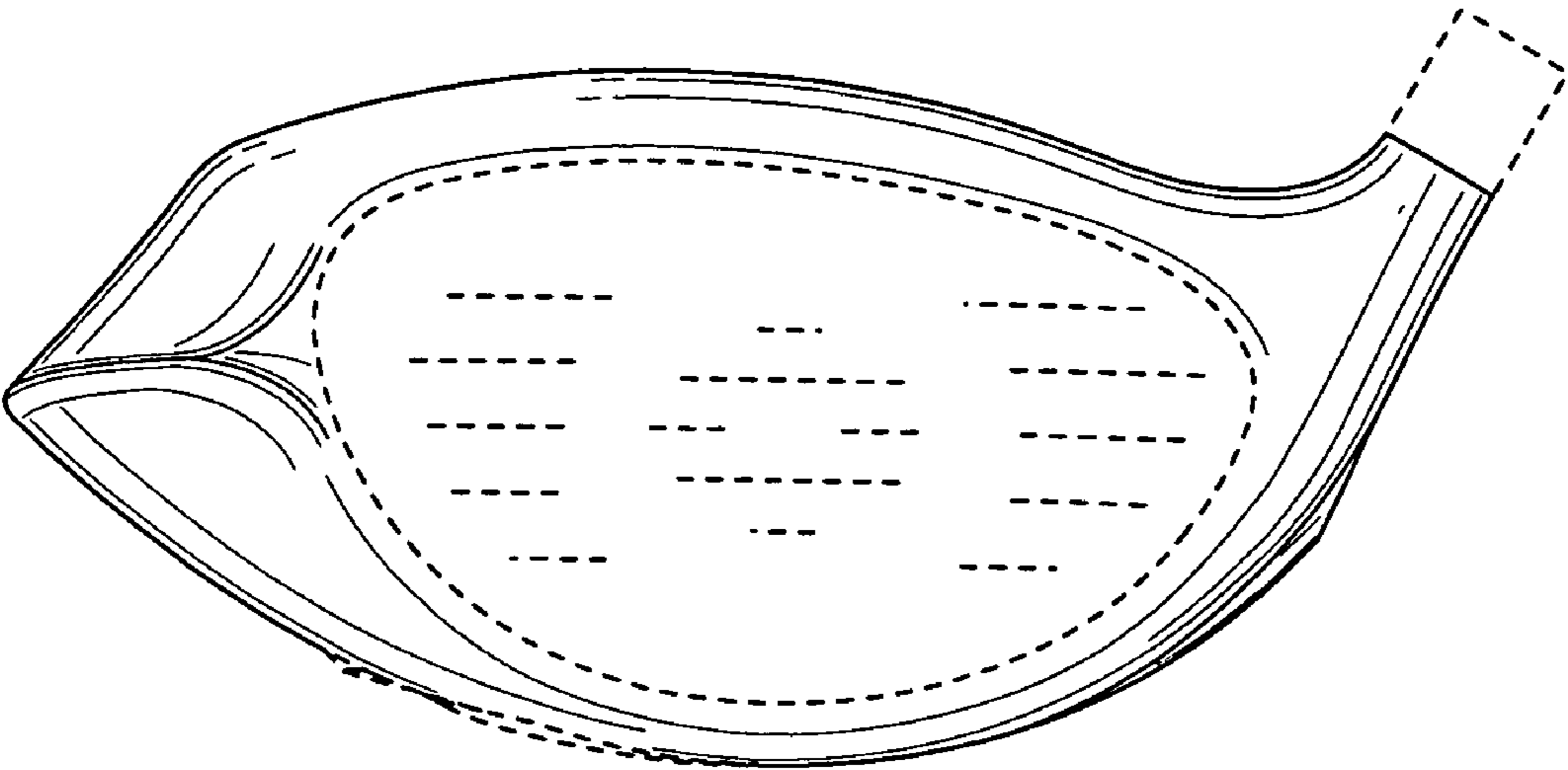

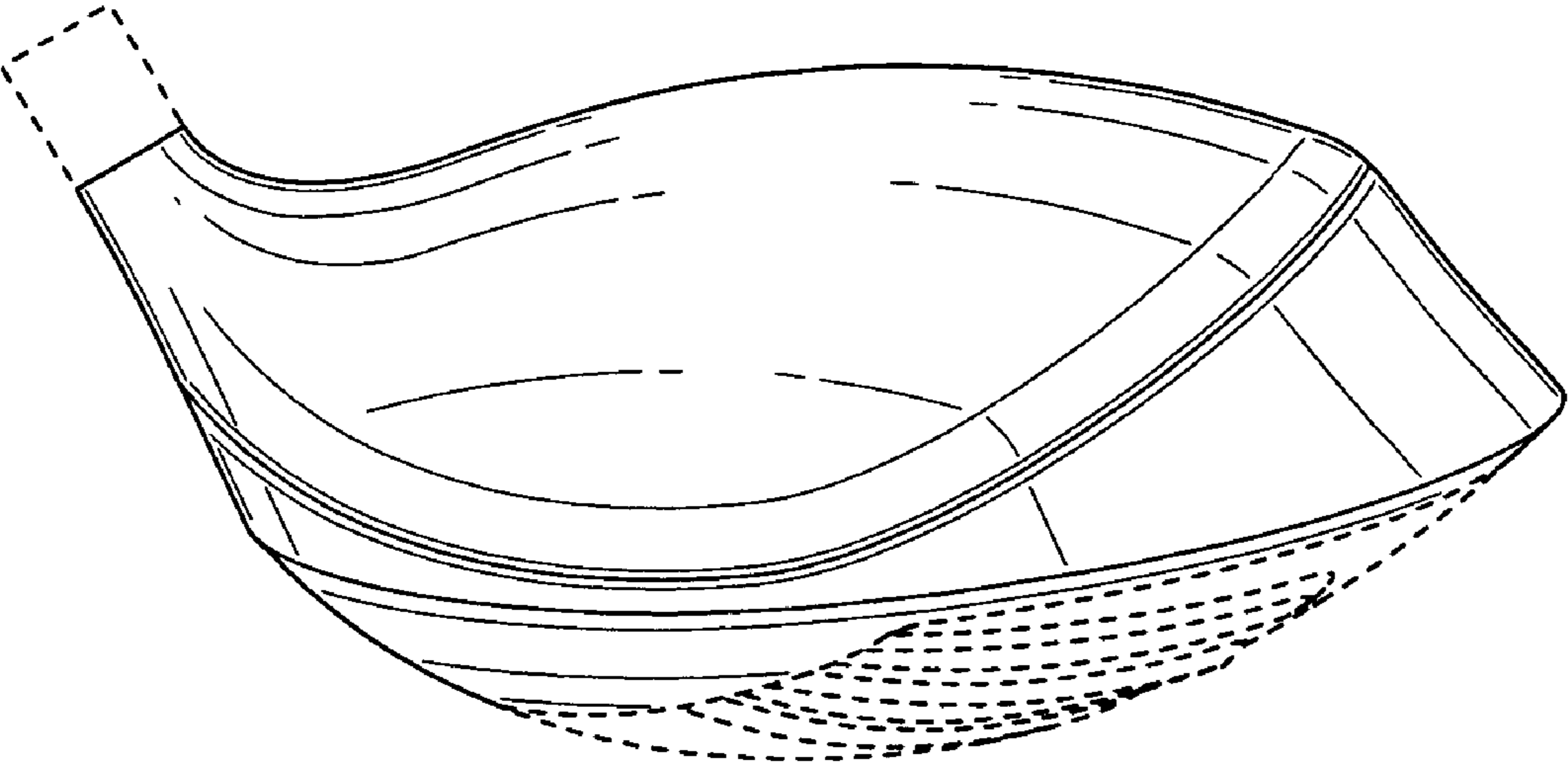

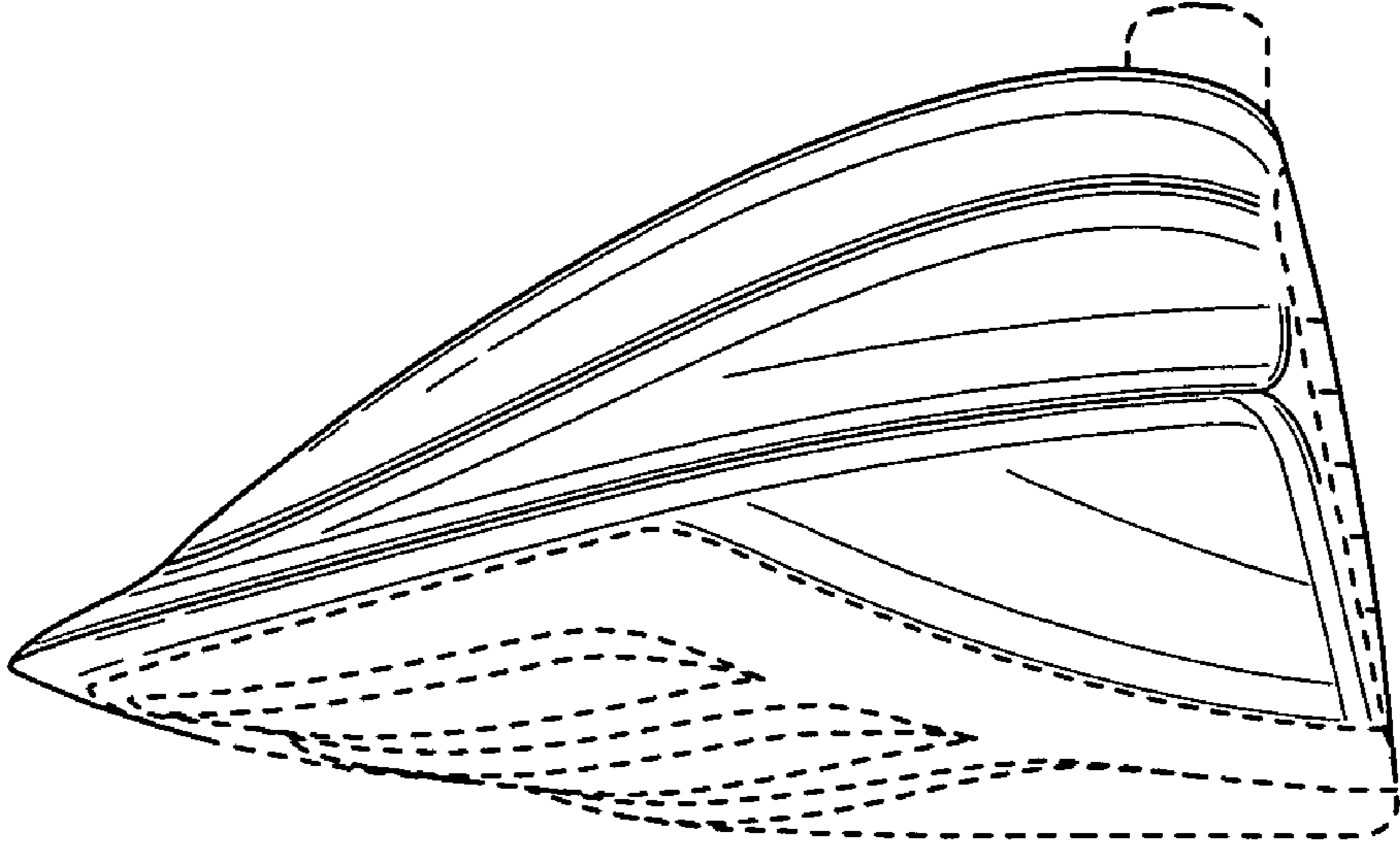

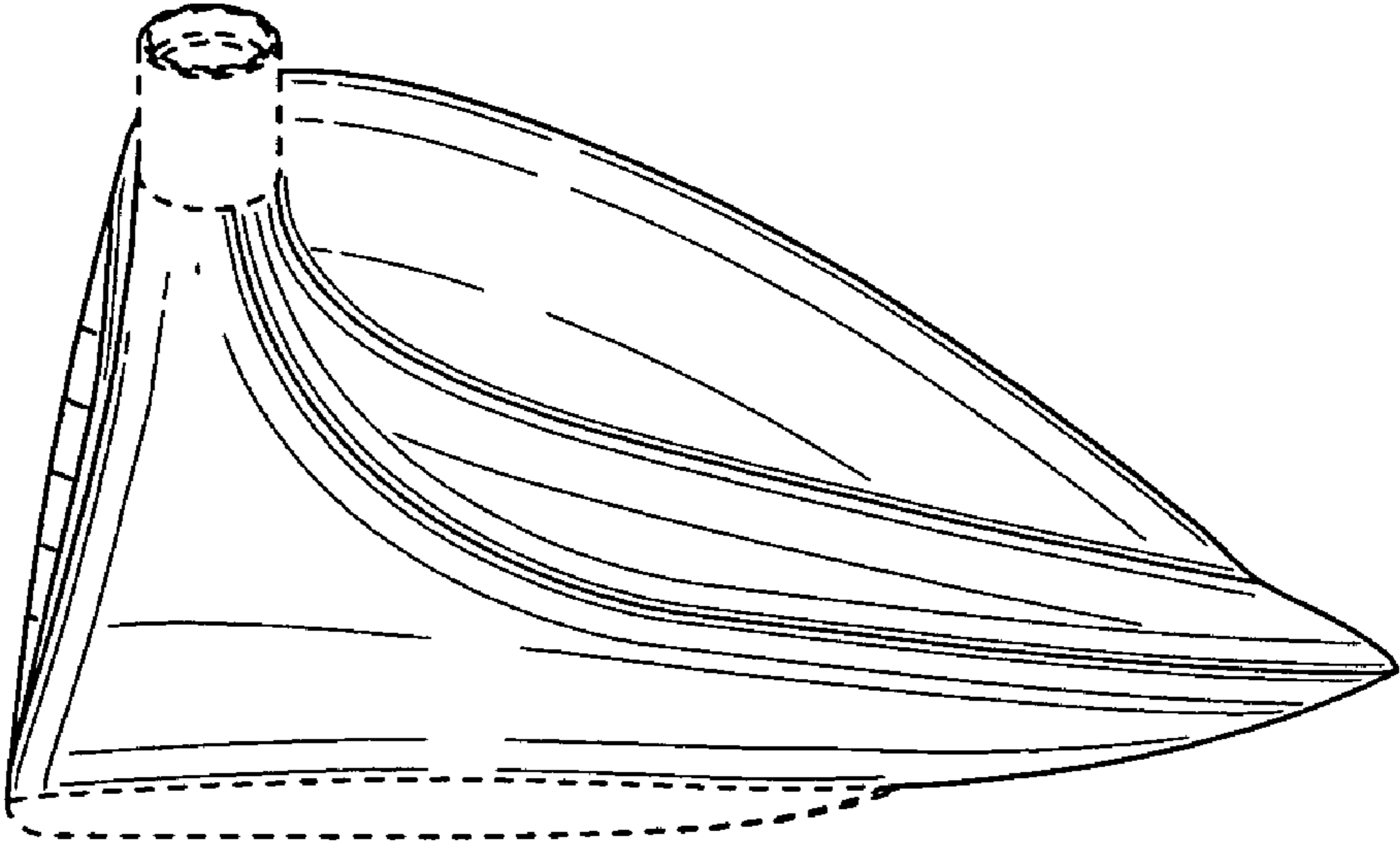

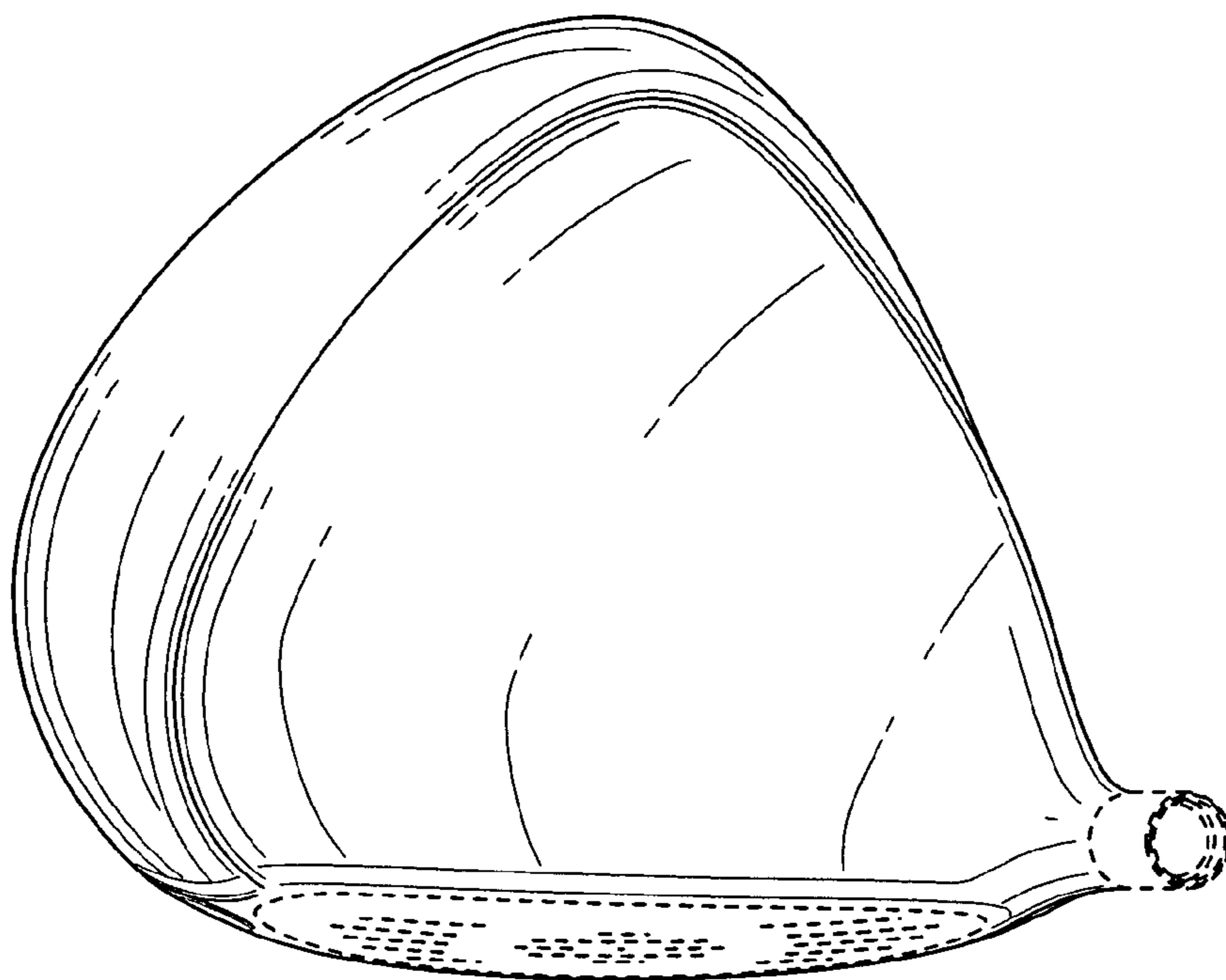

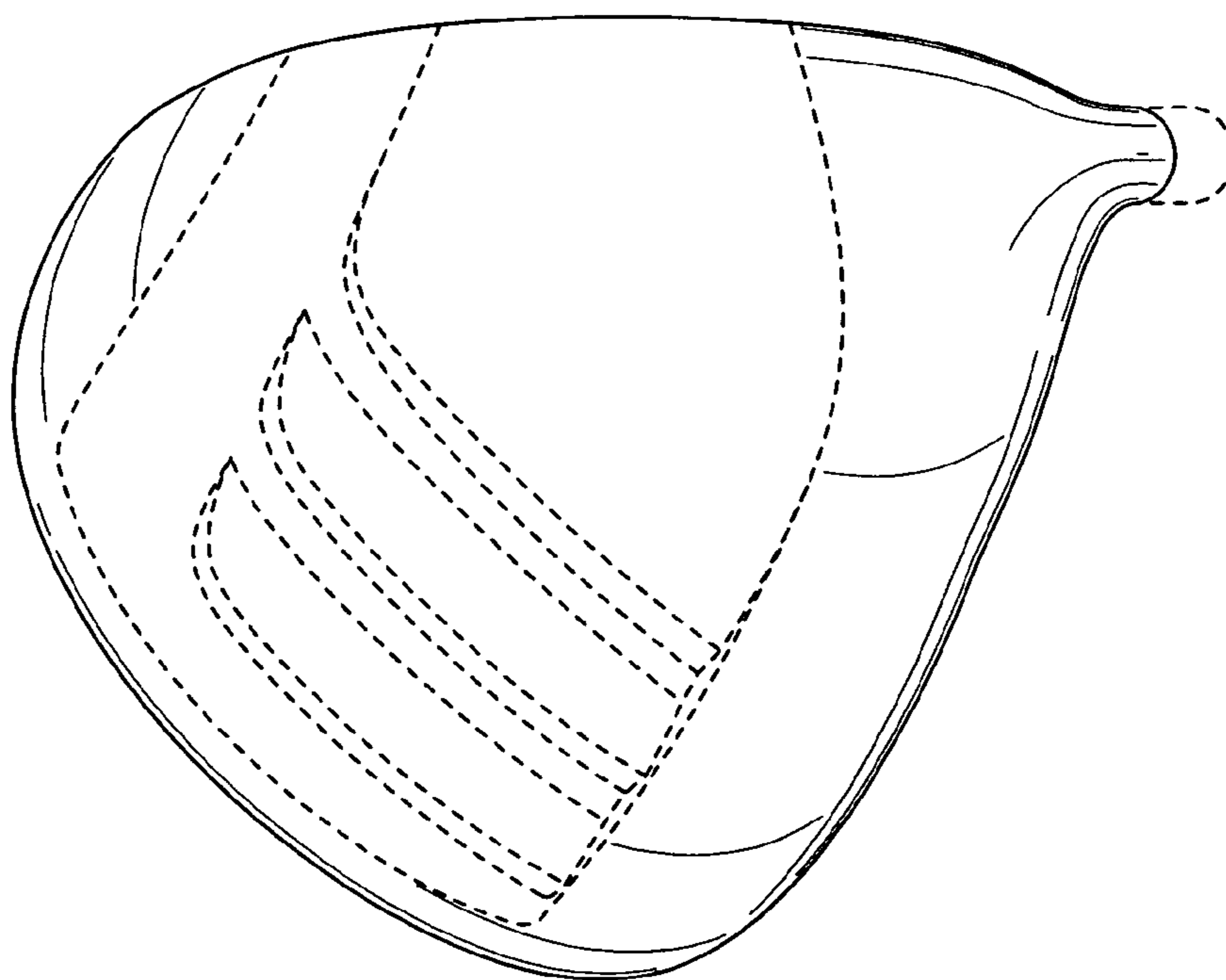
