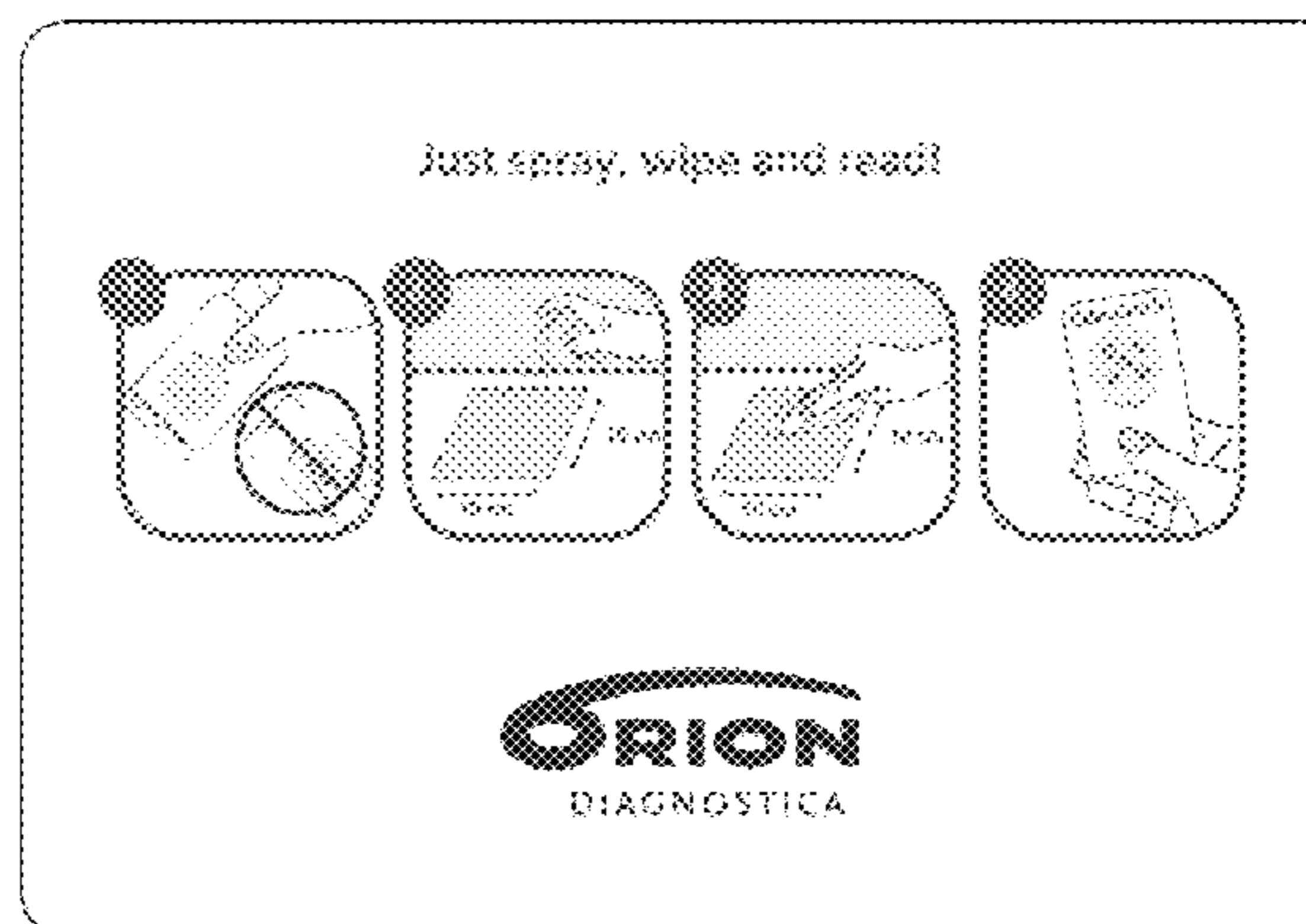
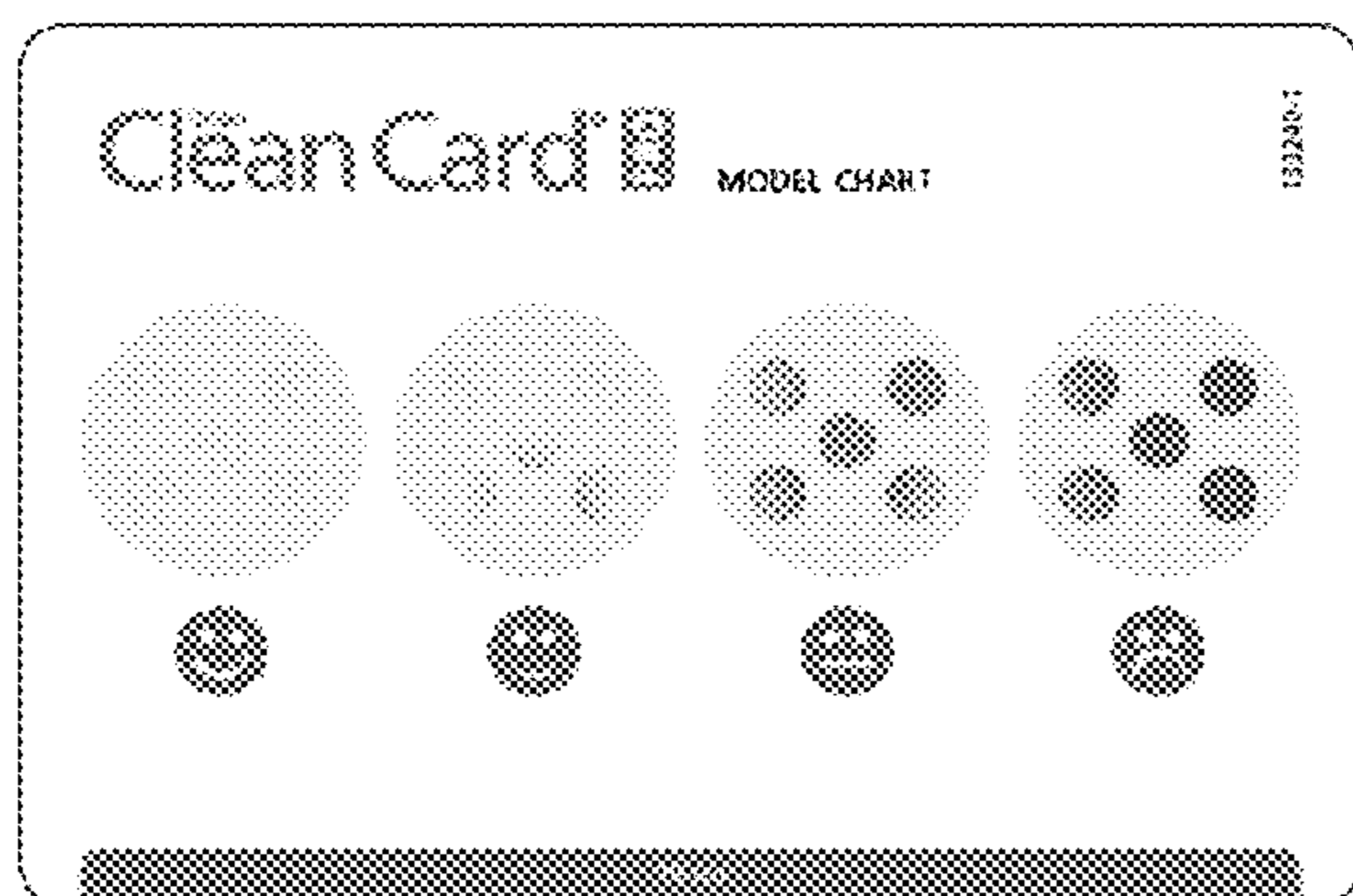
The ornamental design for an analytical test interpretation card, as shown and described.

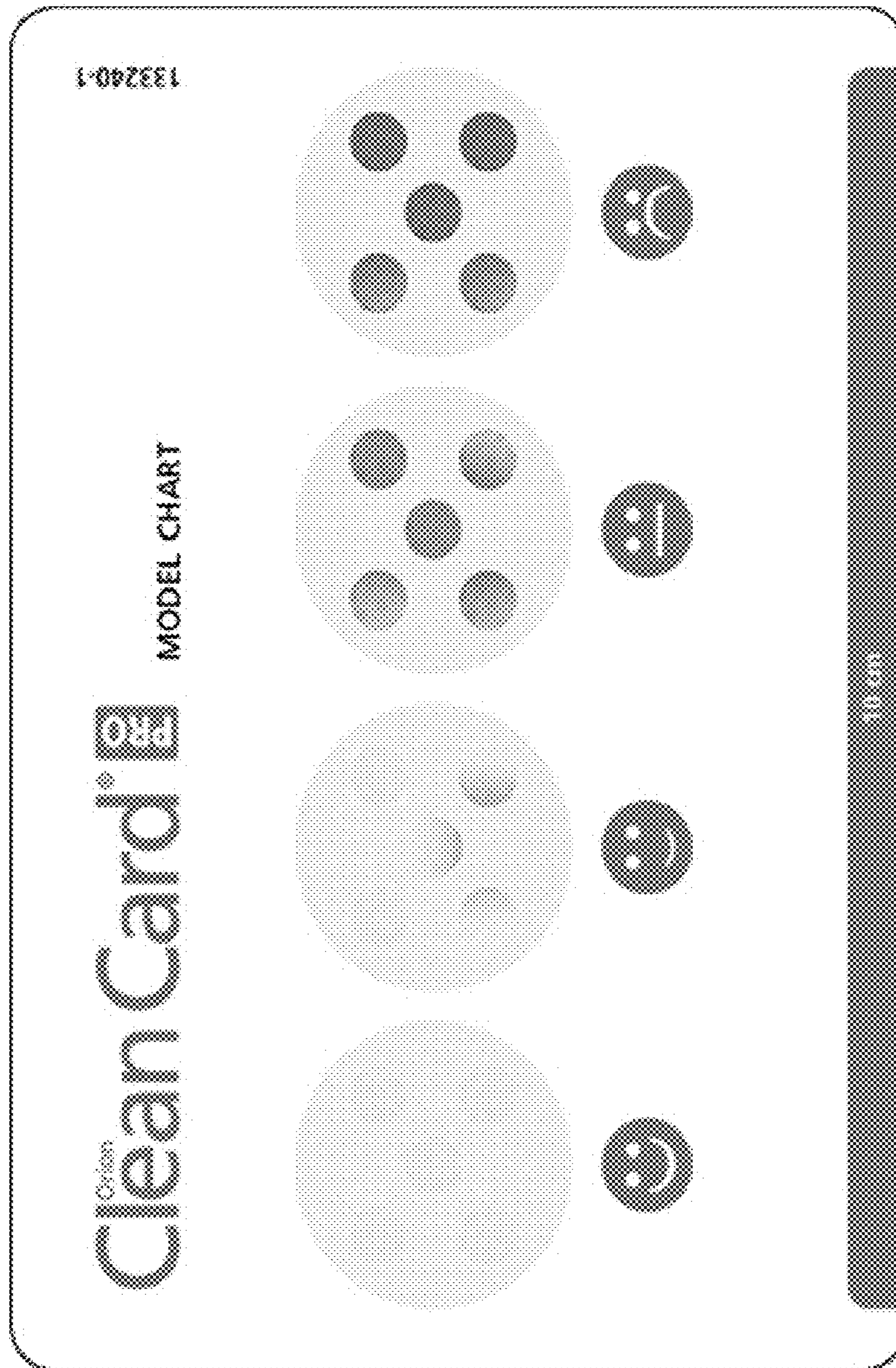
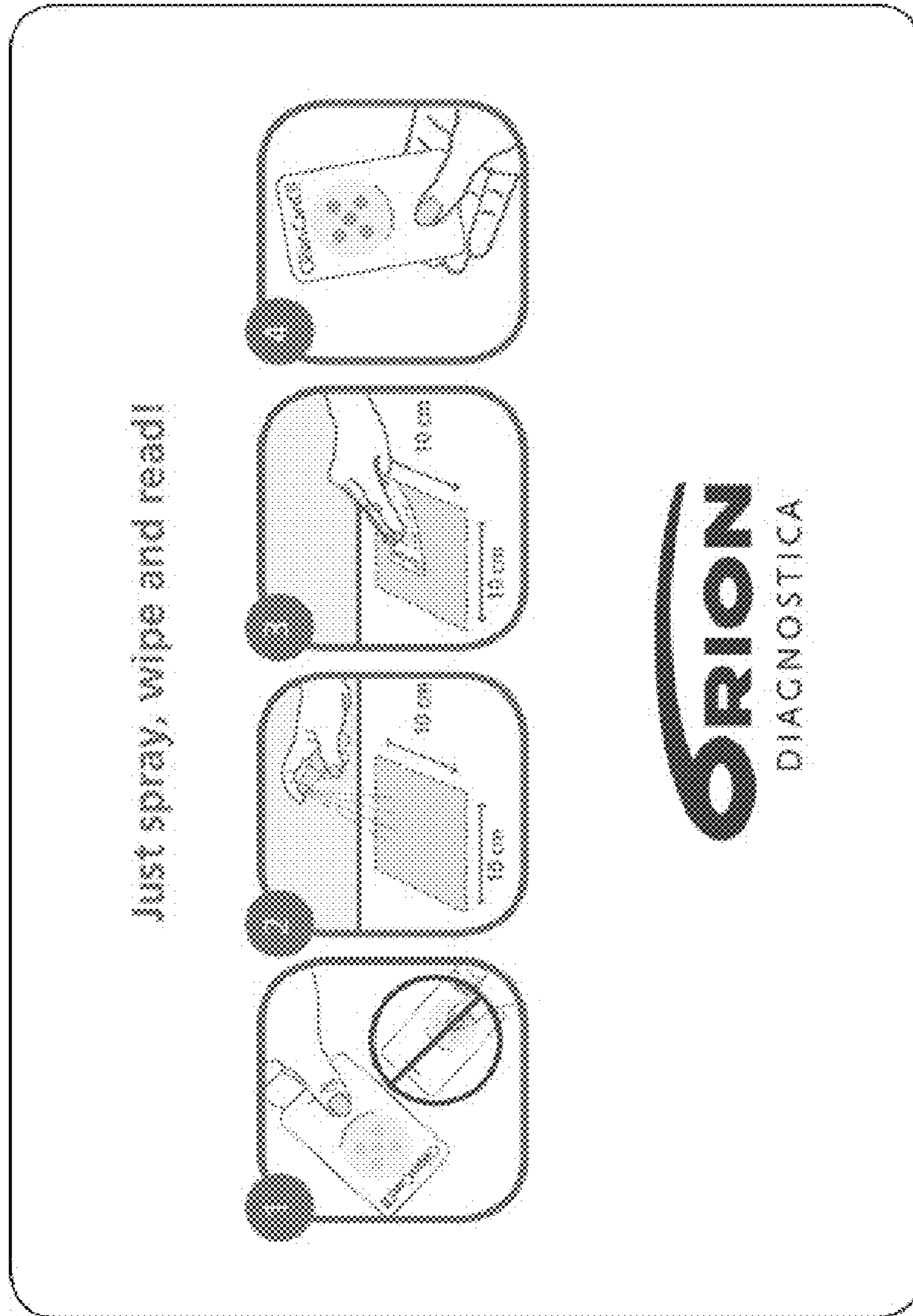
