We claim the ornamental design for a feeding bowl for animals, as shown and described.

**DESCRIPTION**

FIG. 2 is a perspective view from below of my new feeding bowl for animals of FIG. 1;

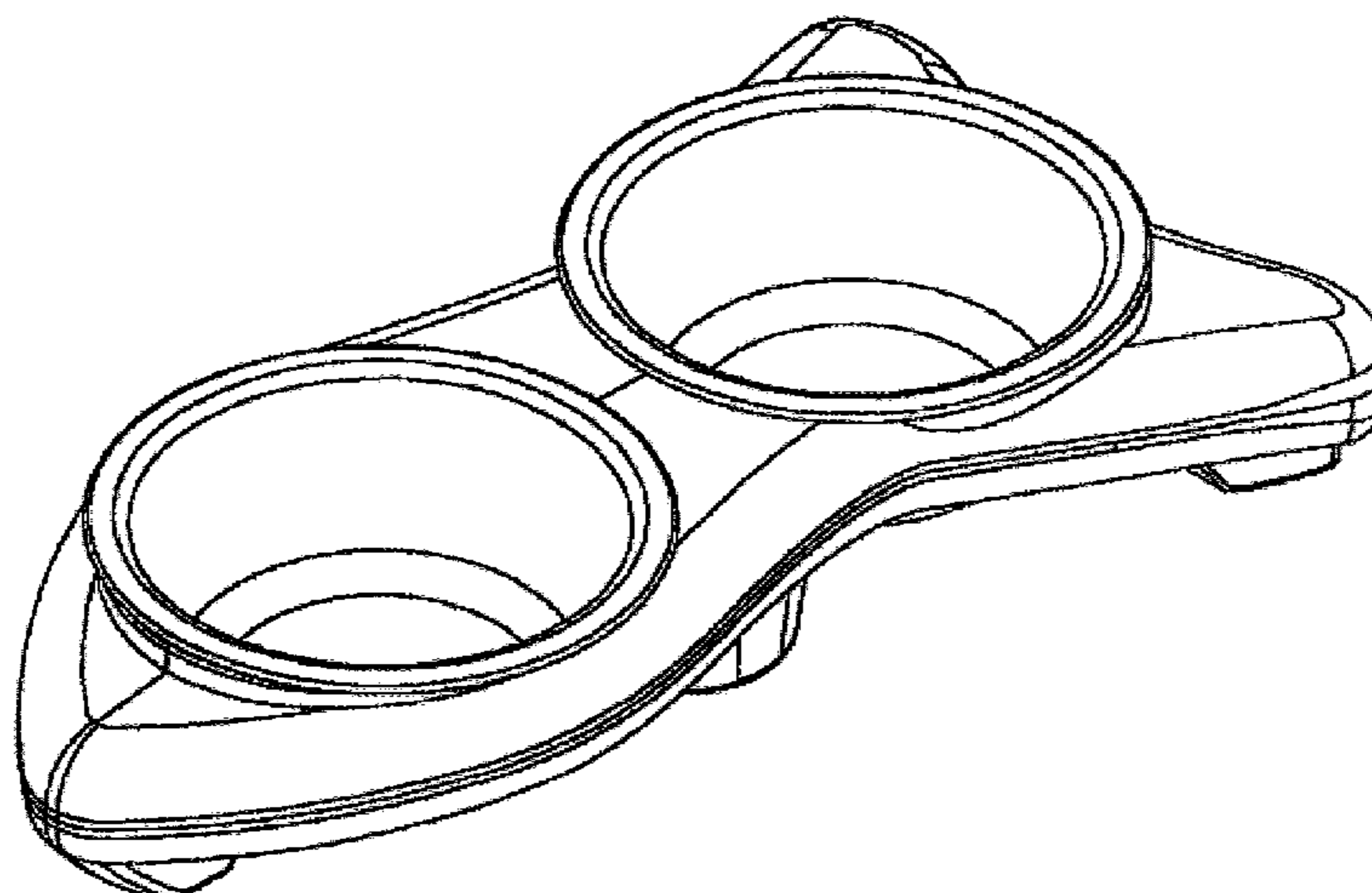
FIG. 3 is a side view as seen from the left of my new feeding bowl for animals of FIG. 1;

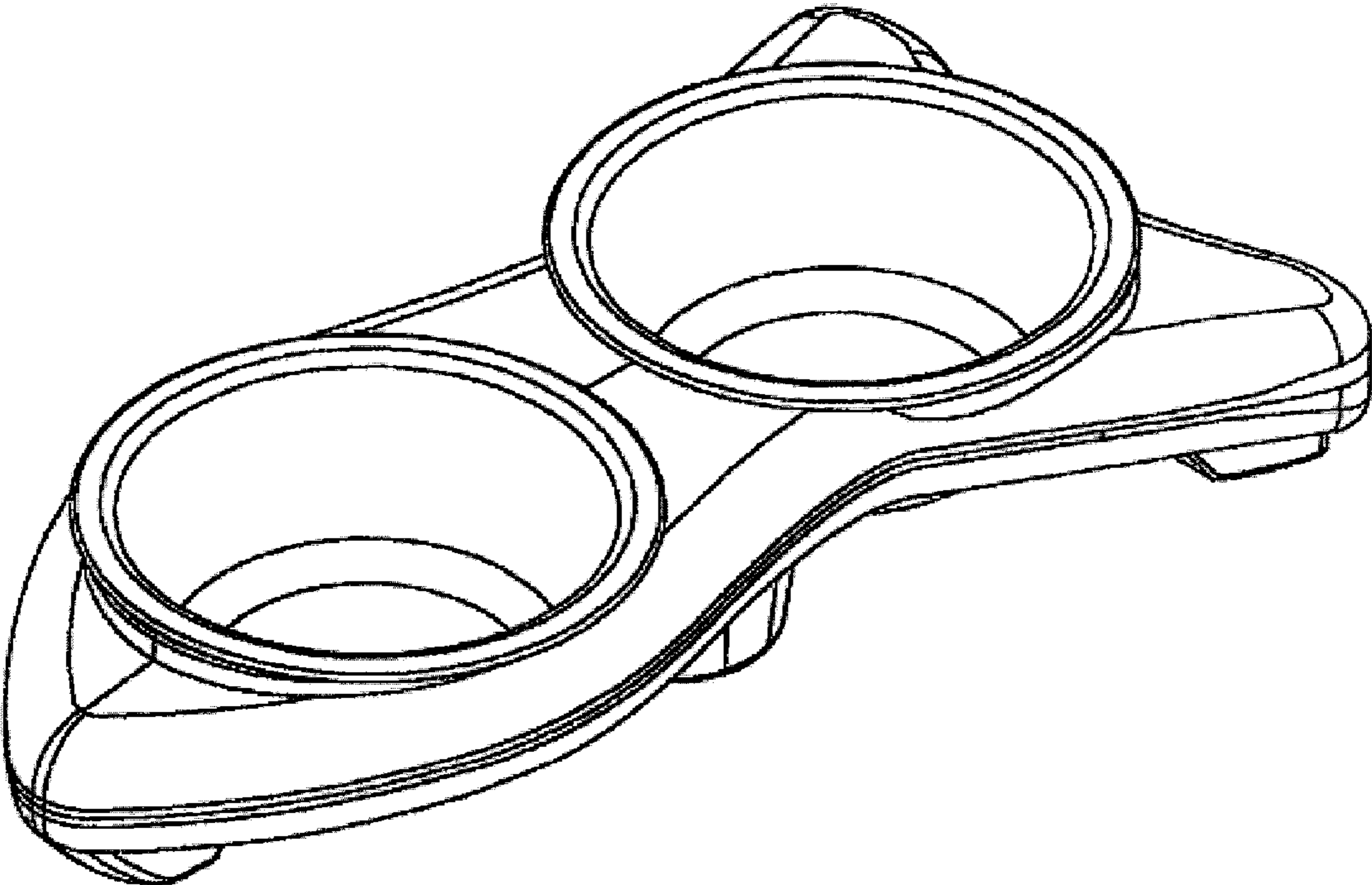

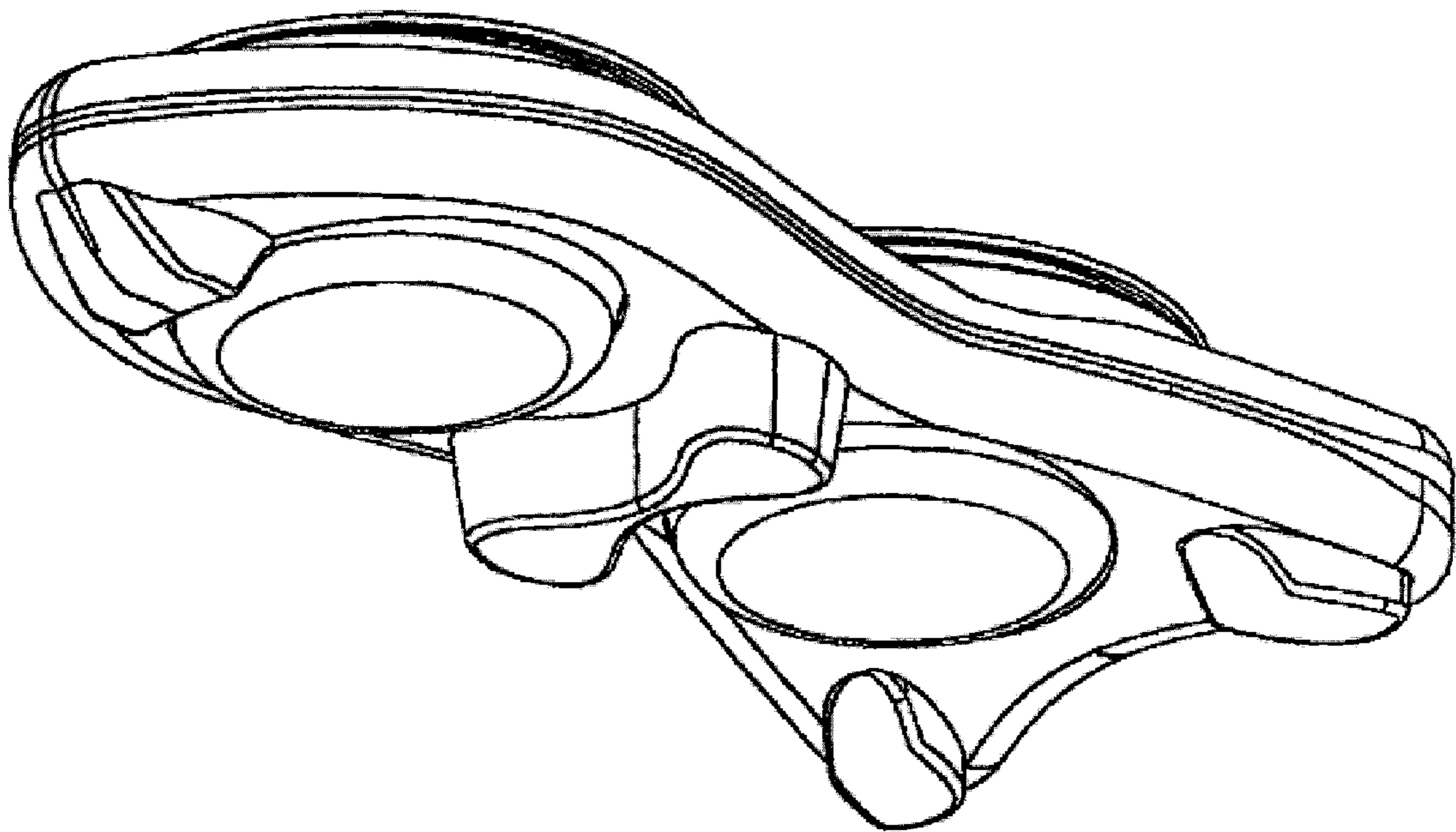

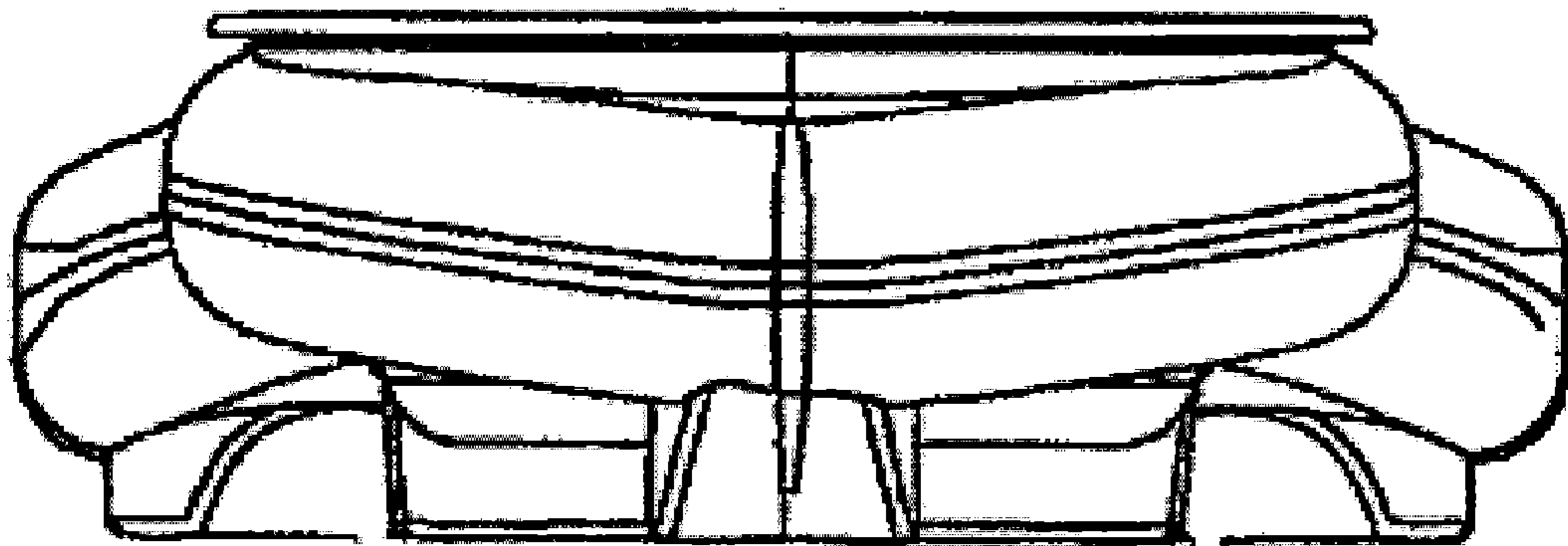

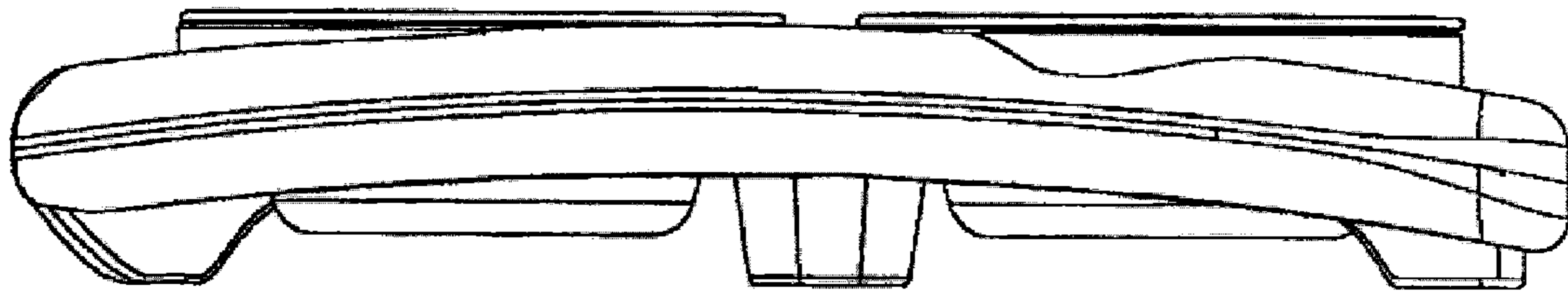

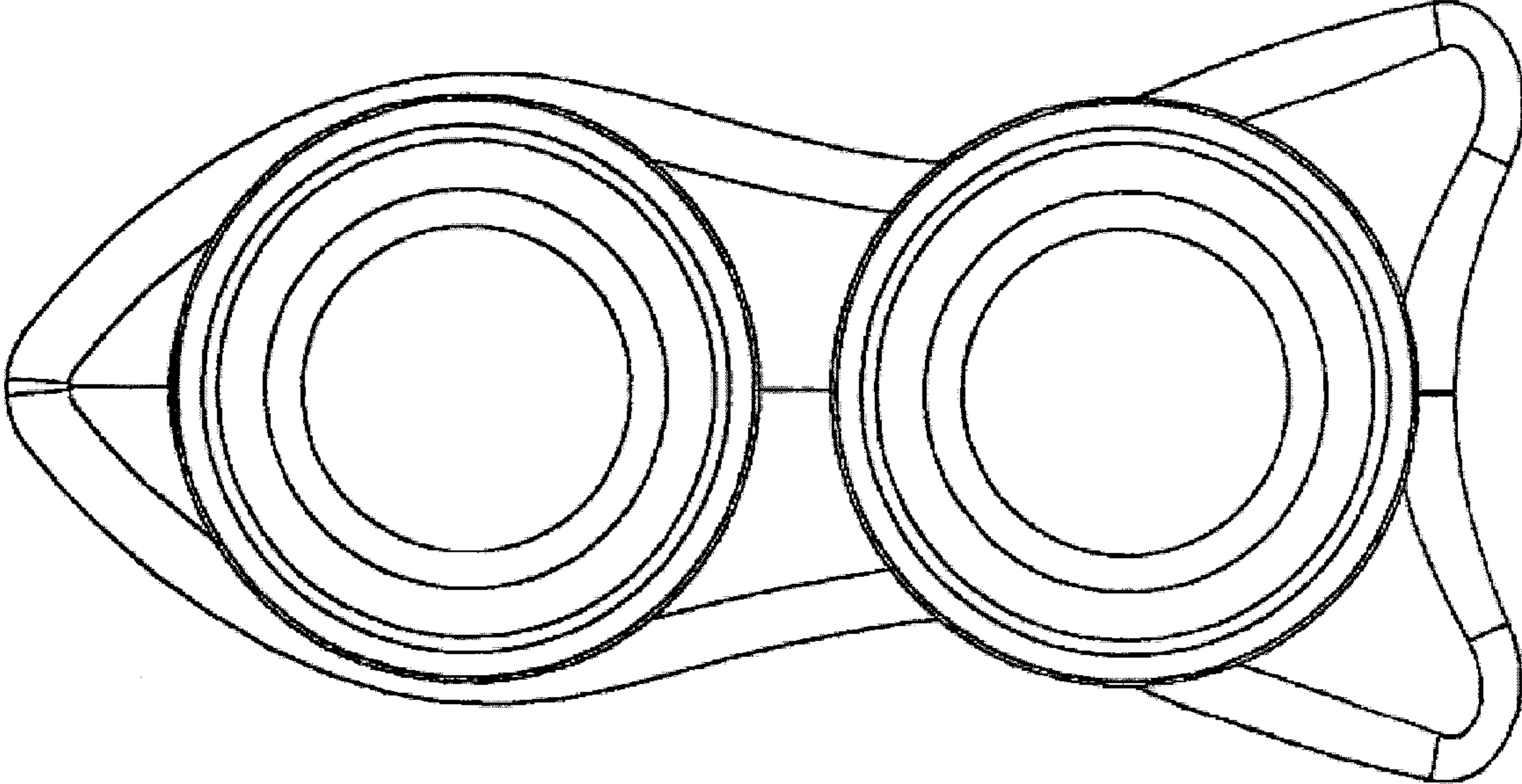

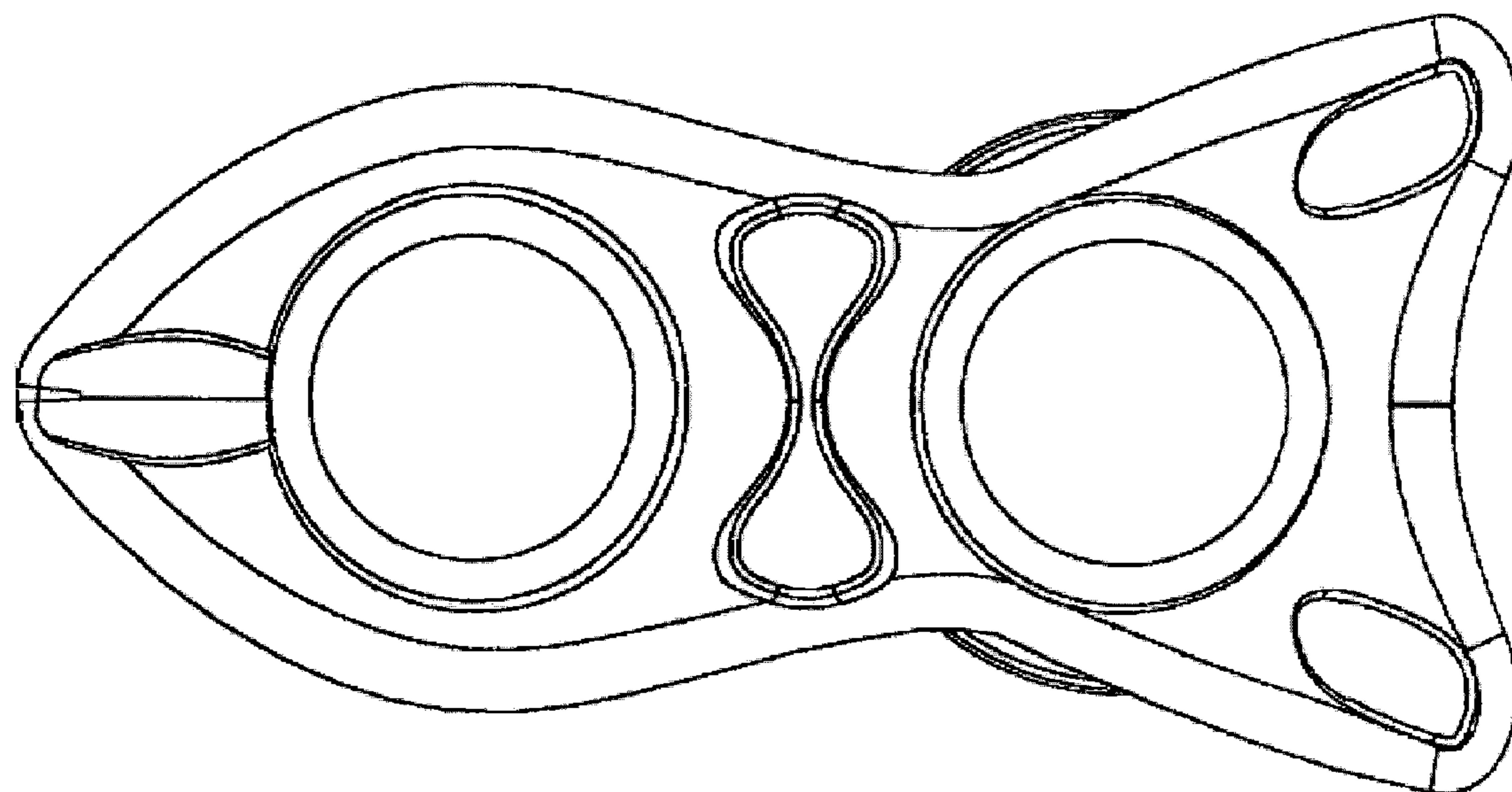
