(57) **CLAIM**

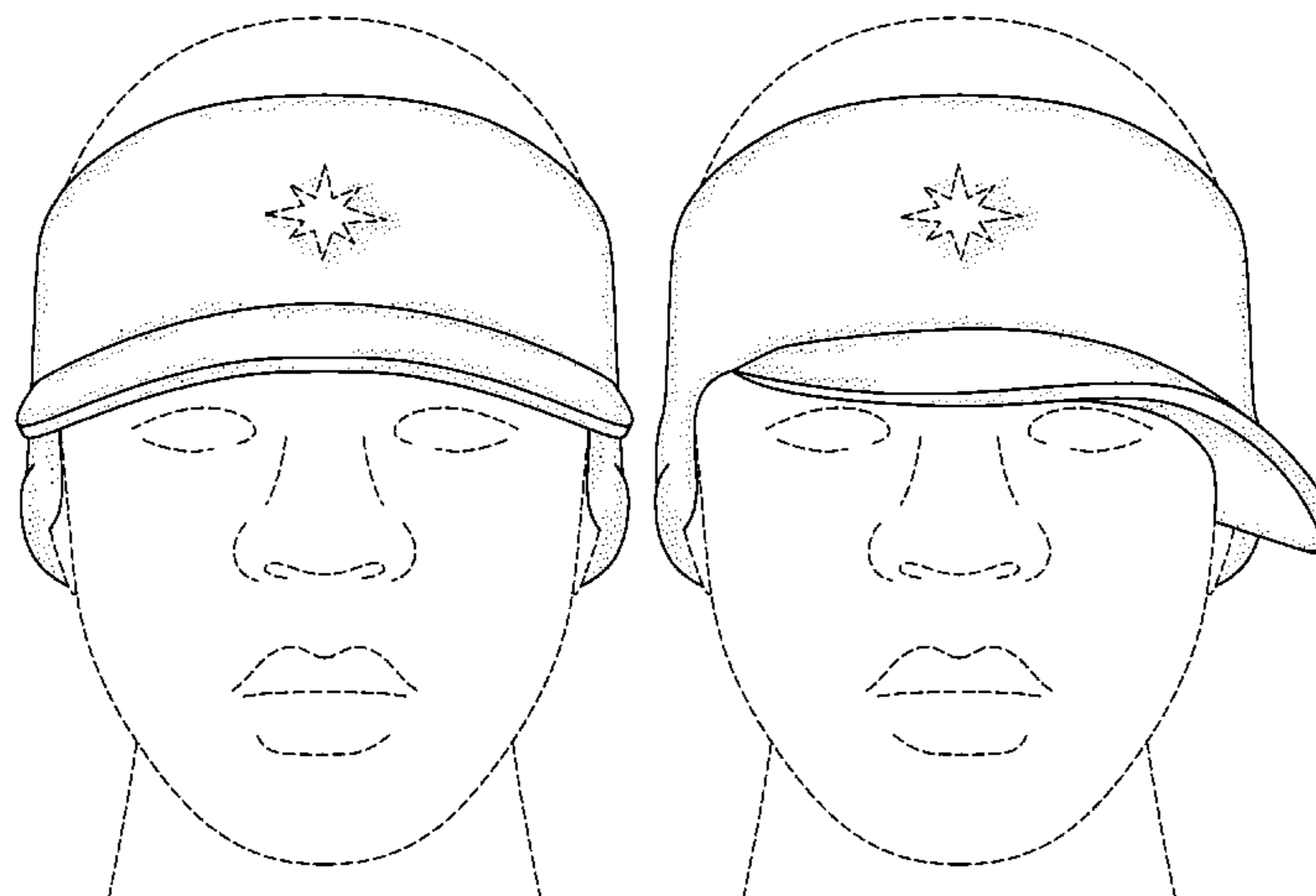
The ornamental design for a headwear article, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a headwear article;  
 FIG. 2 is a rear elevation view thereof;  
 FIG. 3 is a right side elevation view thereof;  
 FIG. 4 is a left side elevation view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a front elevation view of the headwear article of FIG. 1, with the bill offset to the right side;  
 FIG. 7 is a rear elevation view thereof;  
 FIG. 8 is a right side elevation view thereof;  
 FIG. 9 is a left side elevation view thereof;  
 FIG. 10 is a top plan view thereof;  
 FIG. 11 is a front elevation view of the headwear article of FIG. 1, with the bill offset to the left side;  
 FIG. 12 is a rear elevation view thereof;  
 FIG. 13 is a right side elevation view thereof;  
 FIG. 14 is a left side elevation view thereof; and,  
 FIG. 15 is a top plan view thereof.

The broken lines showing a human head in the drawings illustrate environmental matter and form no part of the claimed design. The start-like shape in broken lines shown on the center of the crown defines the bounds of the claimed design and forms no part thereof.

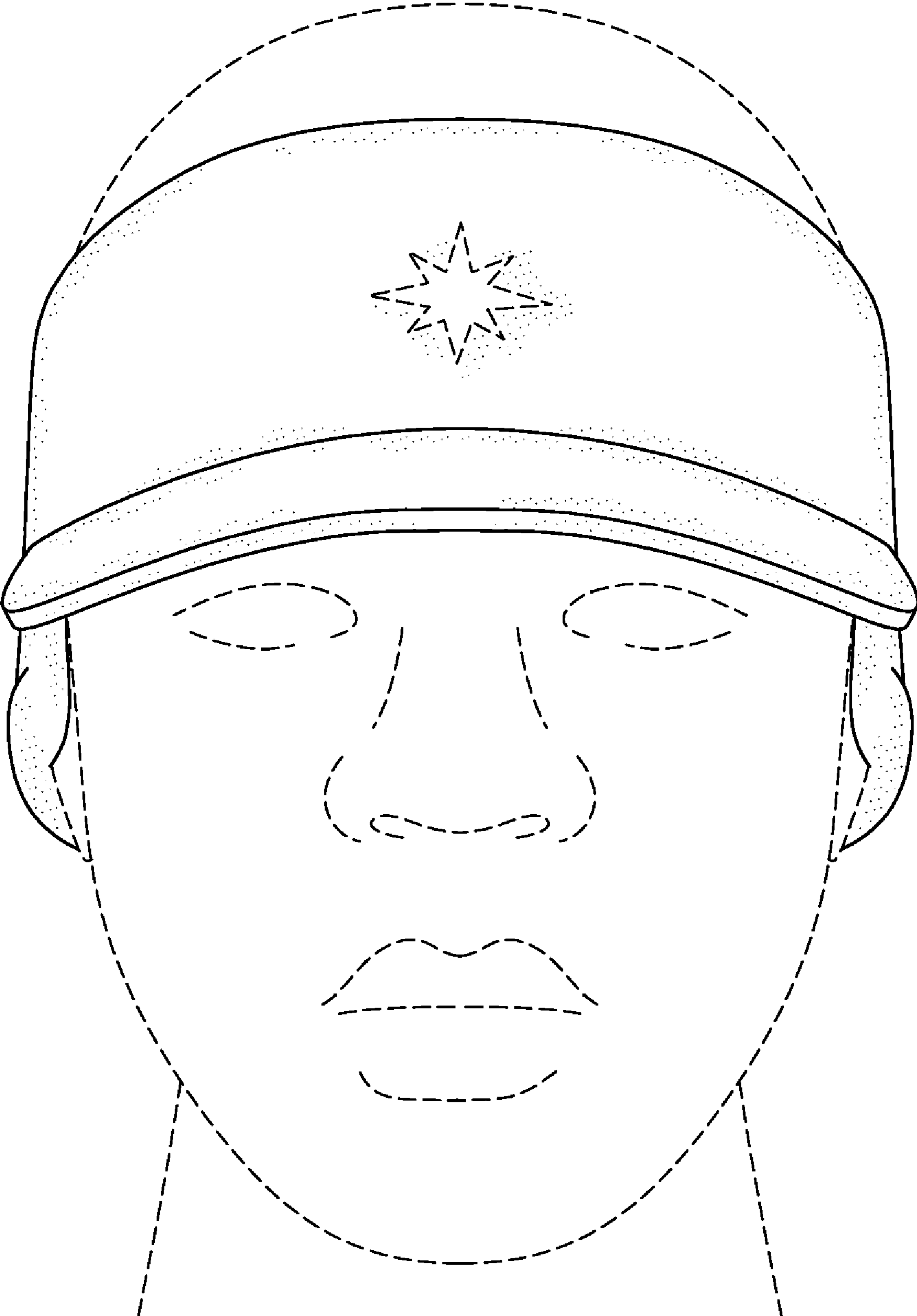

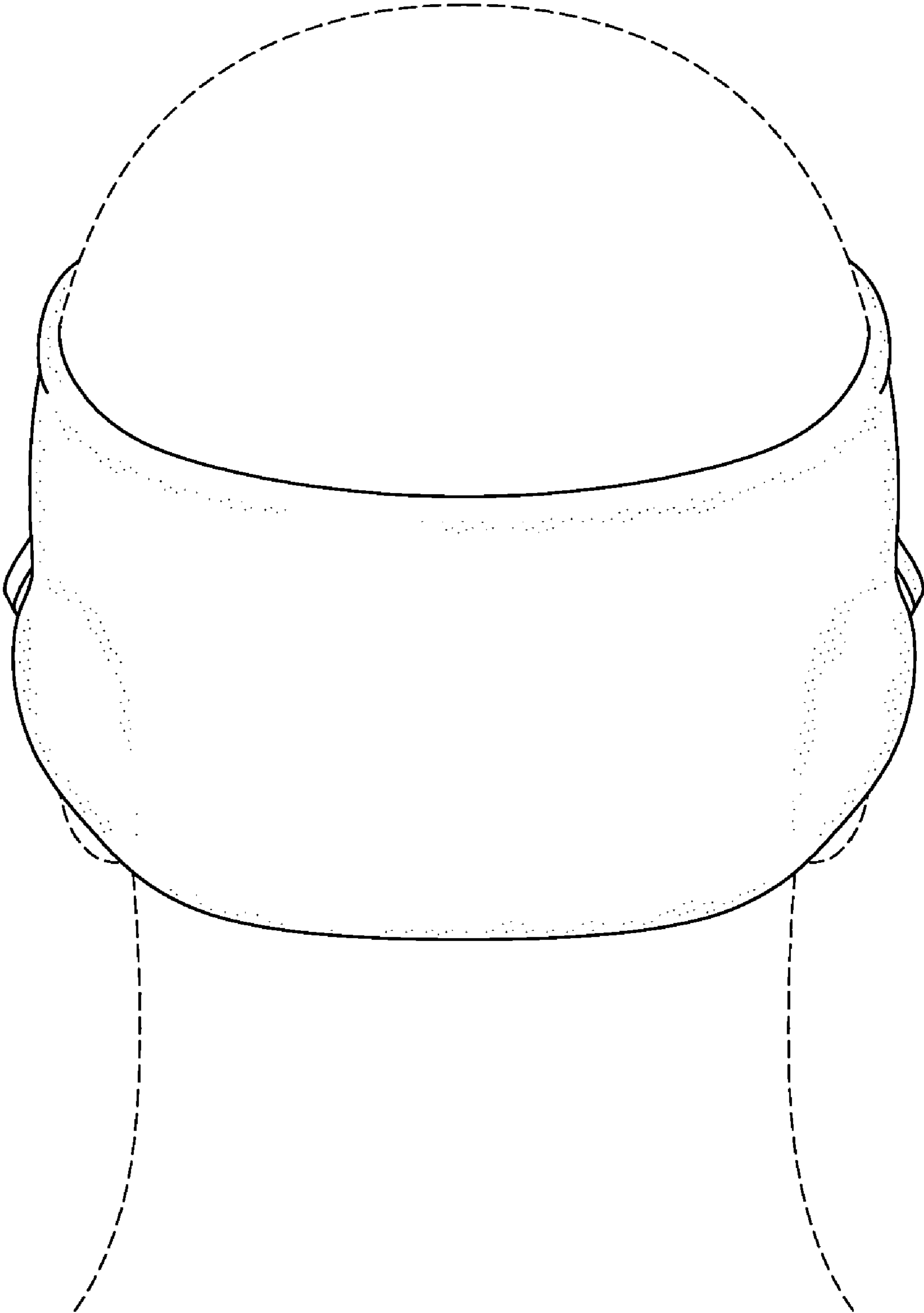

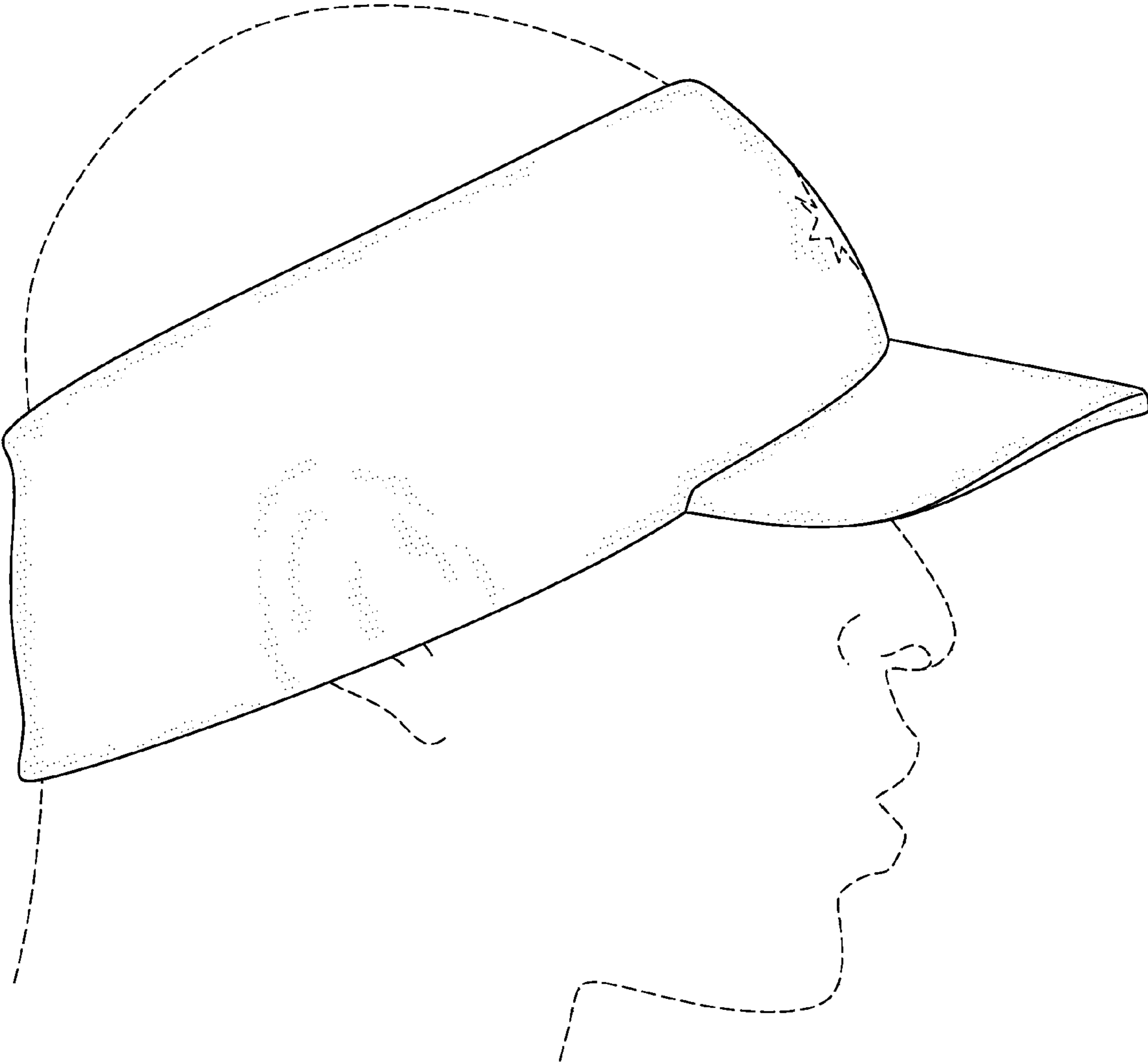

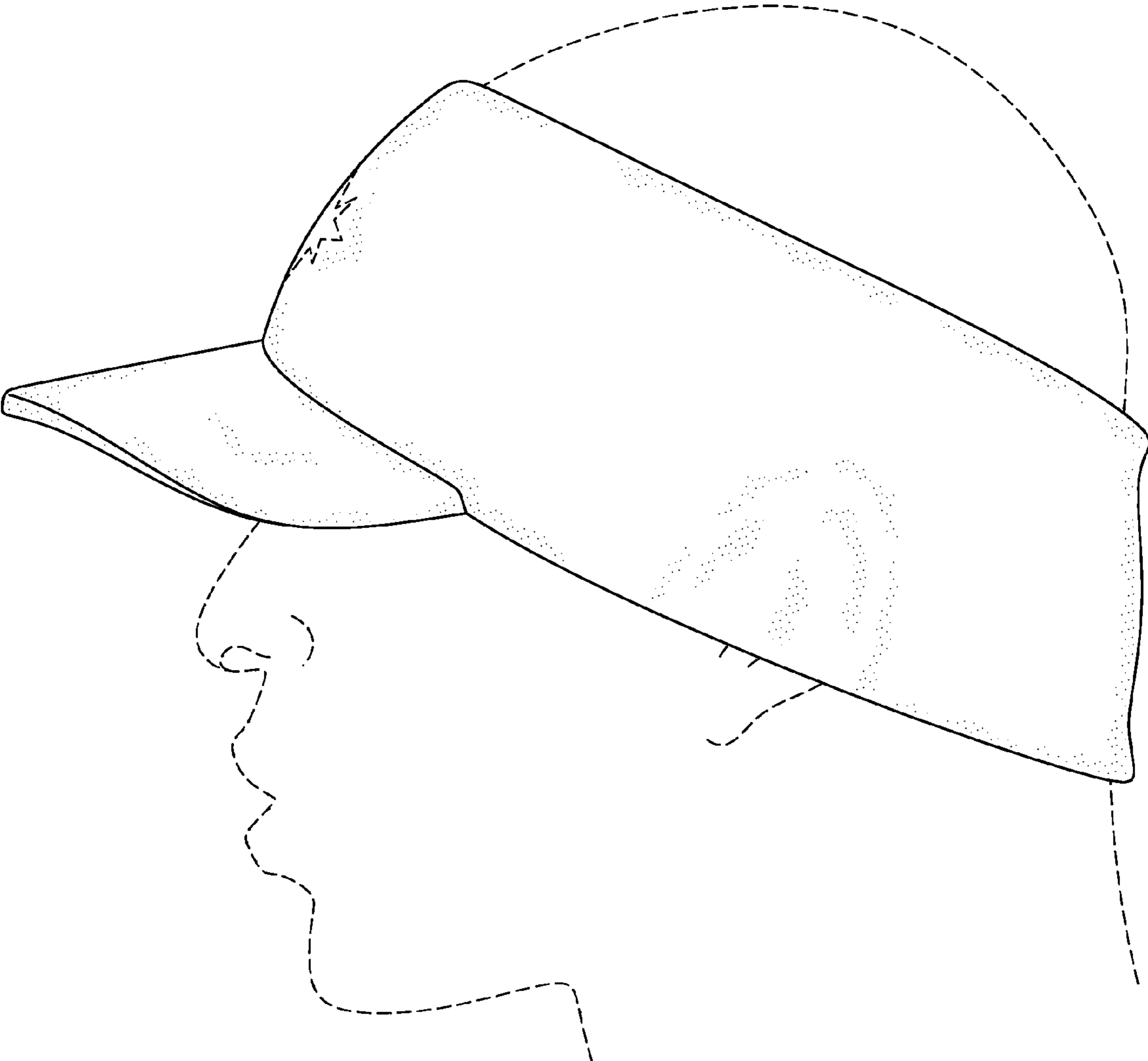

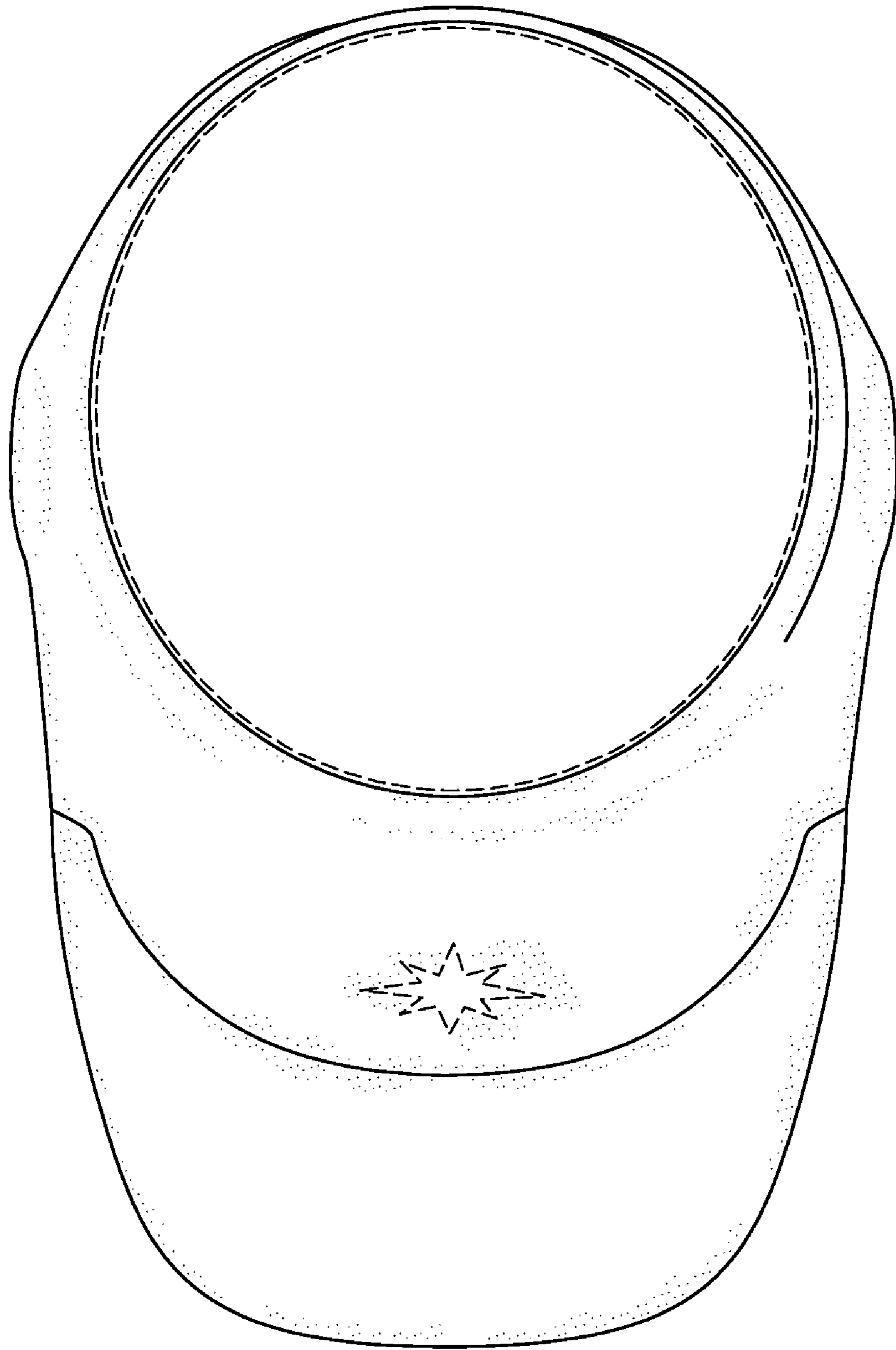

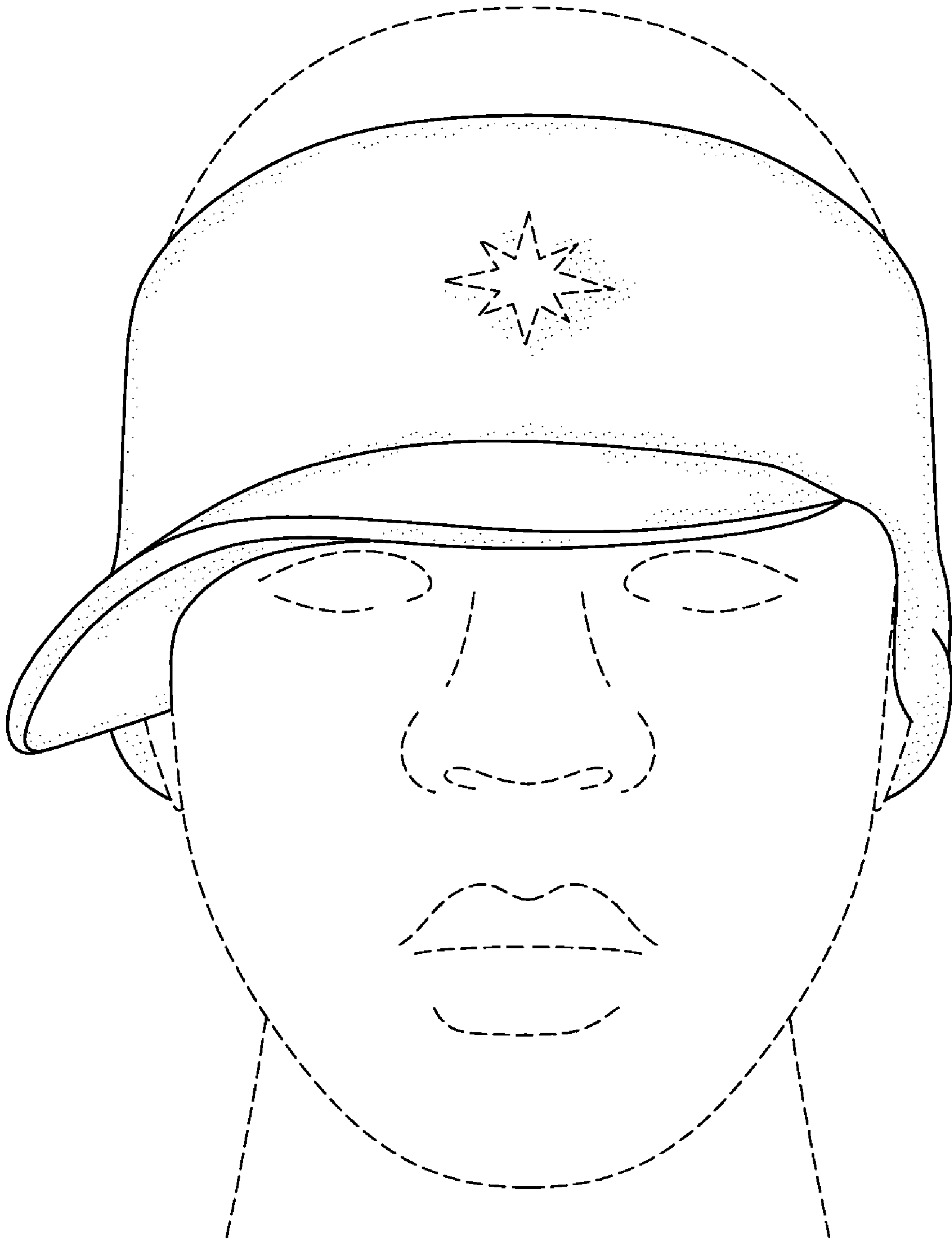

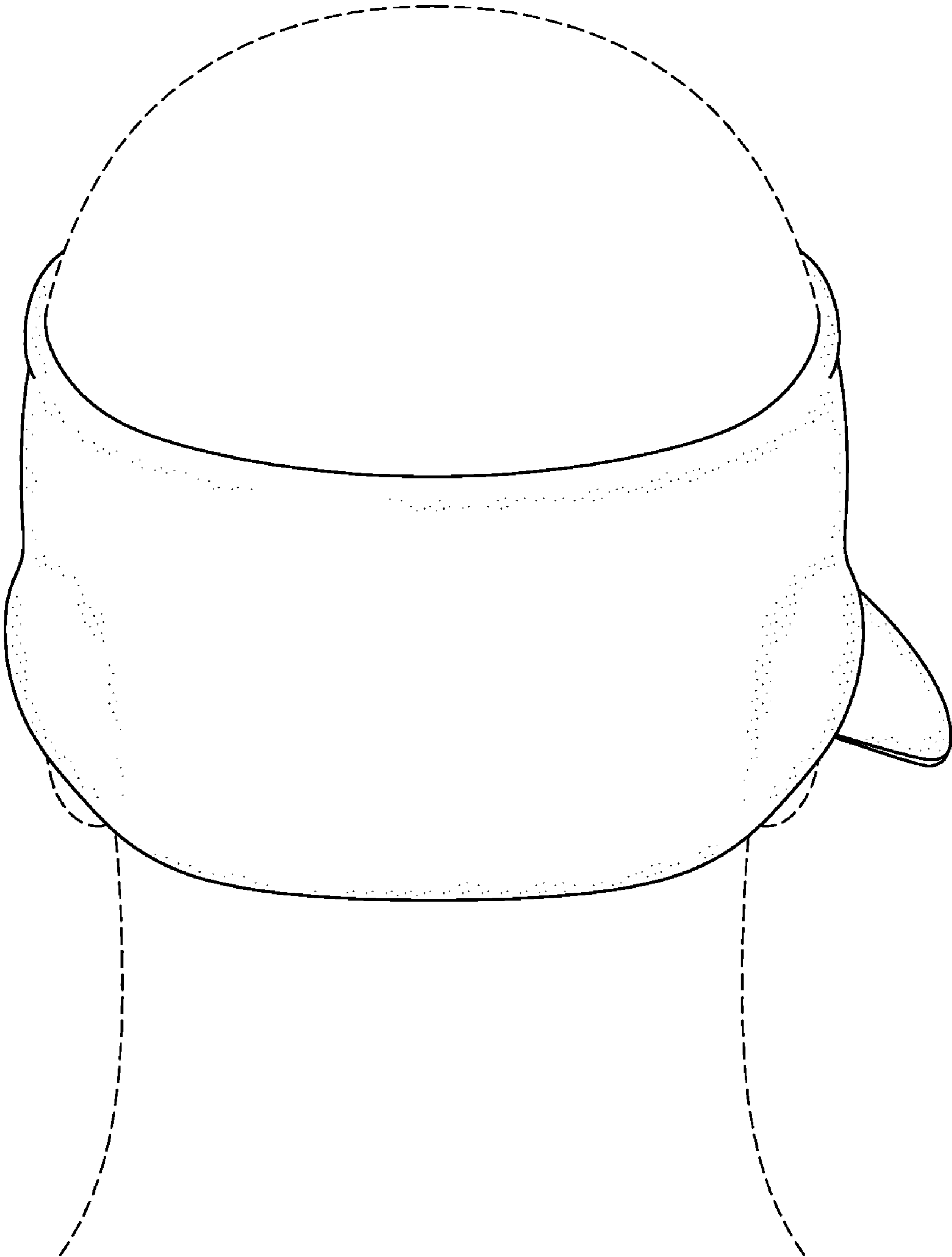

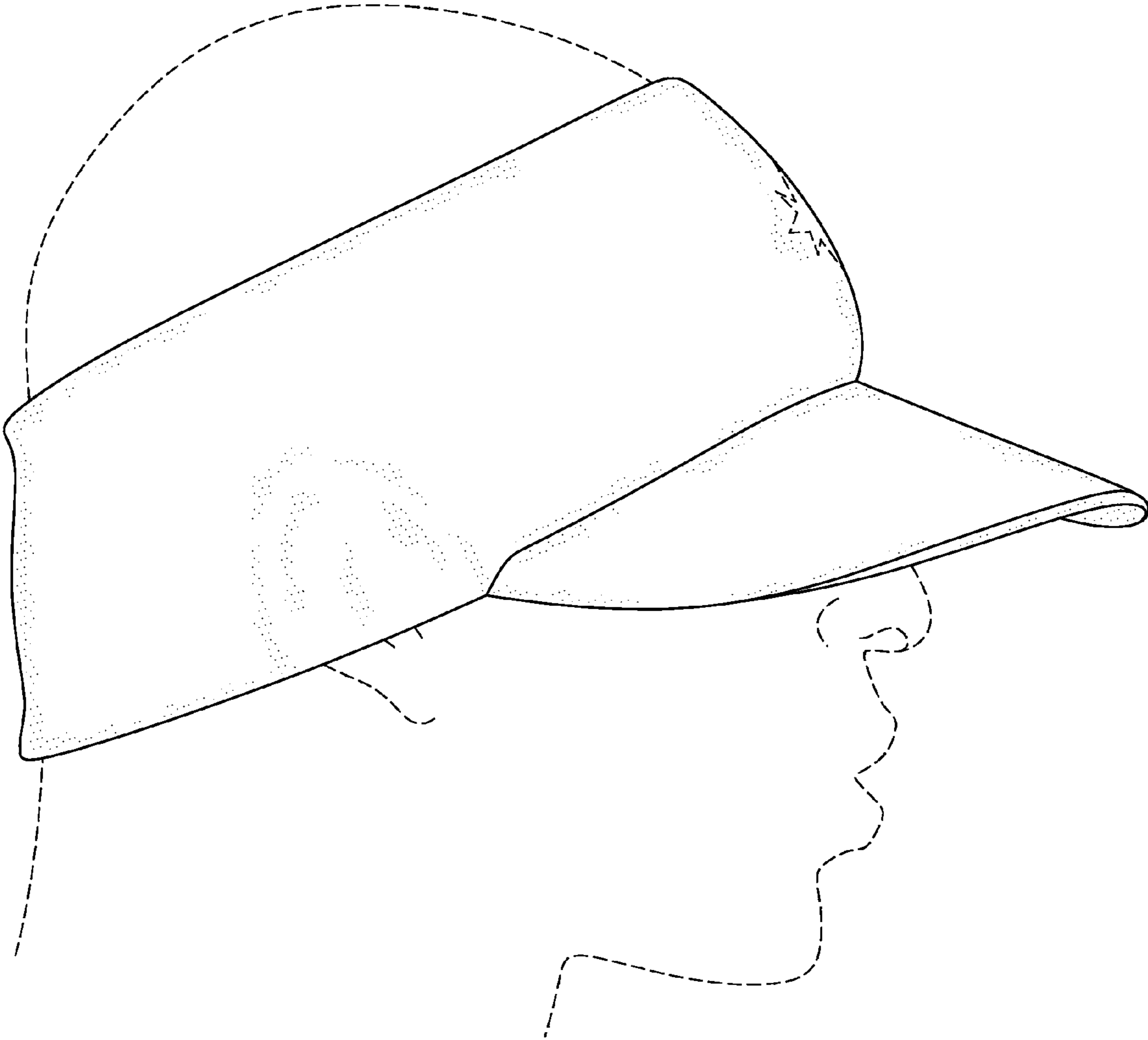

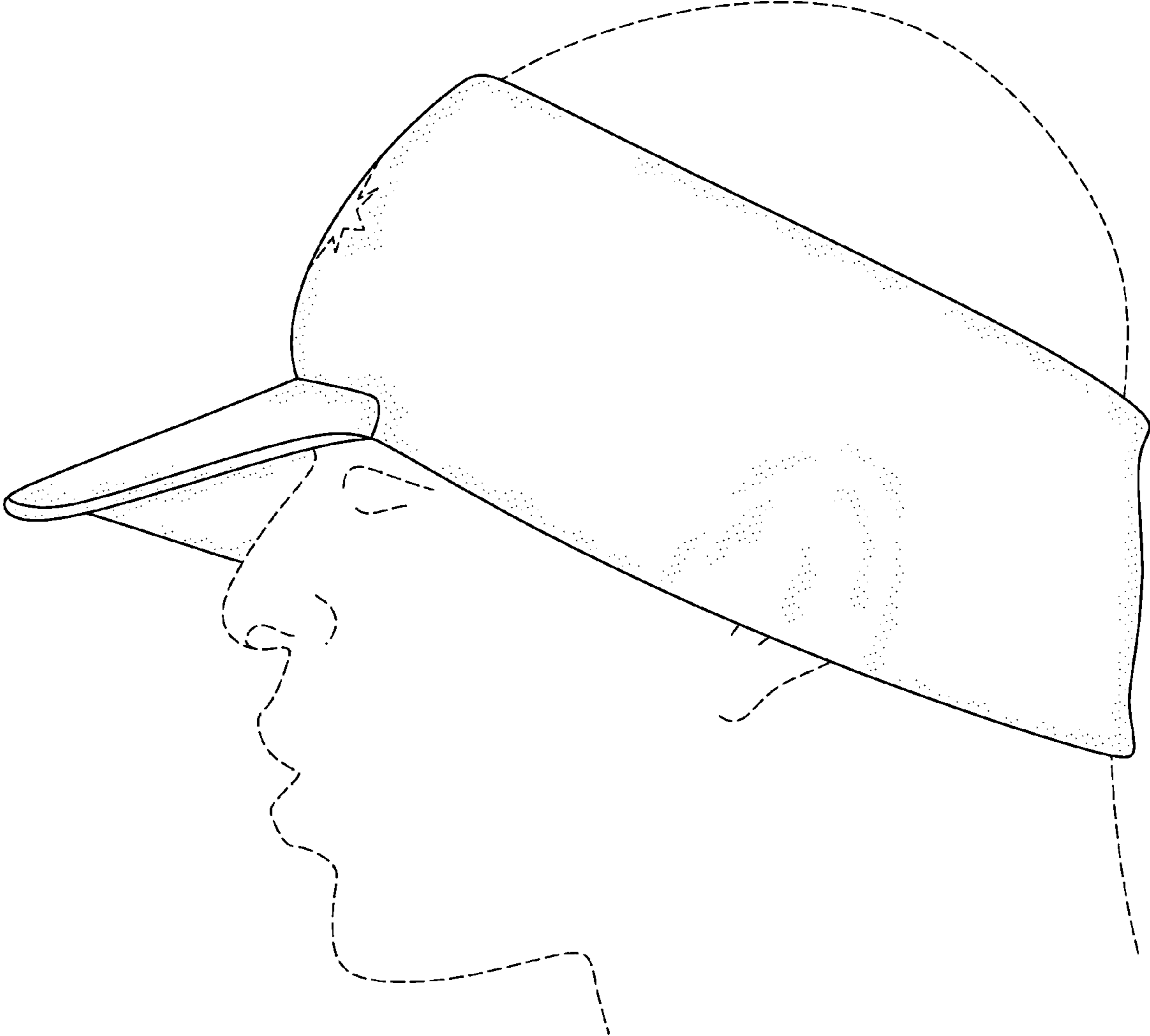

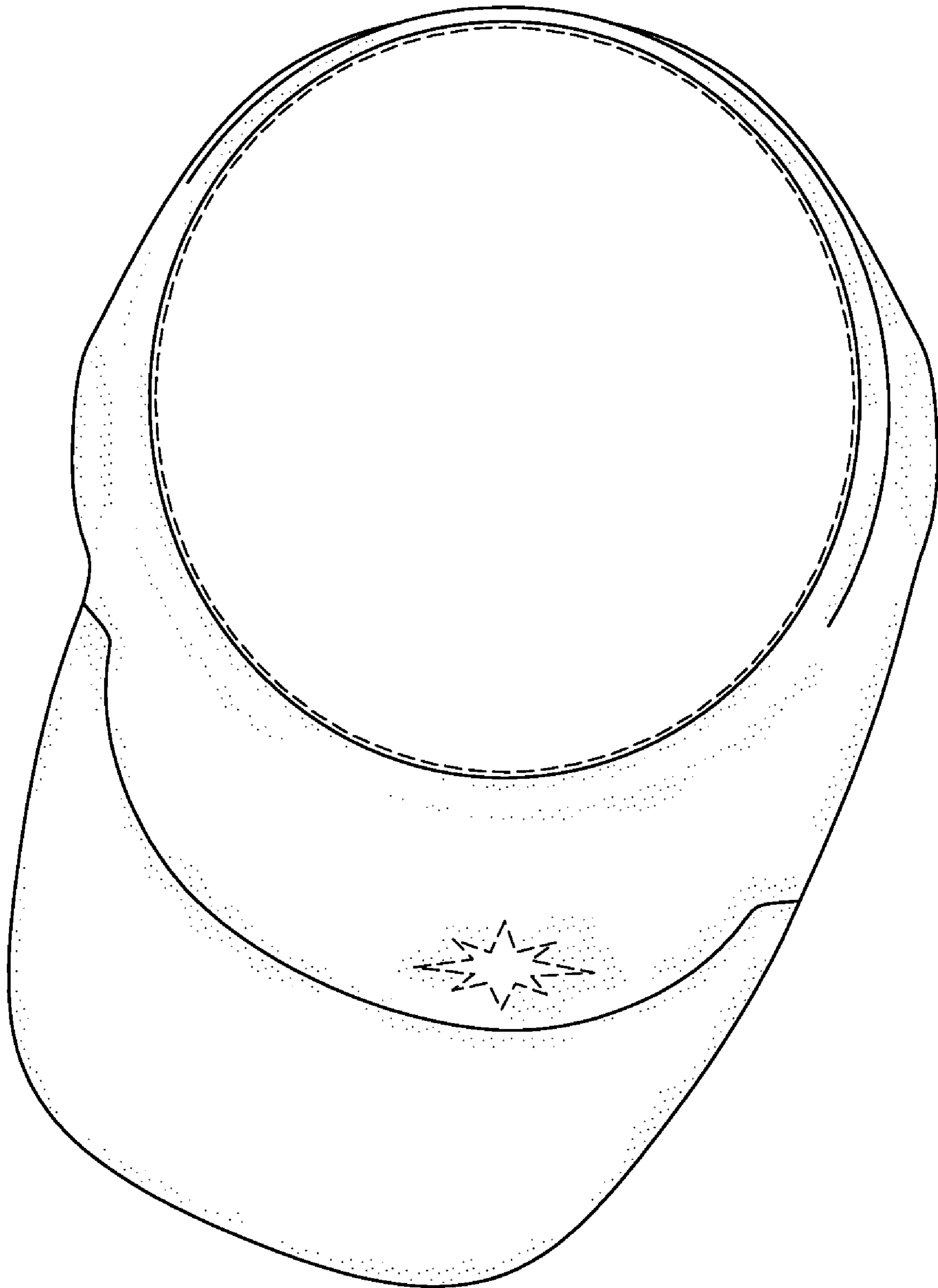

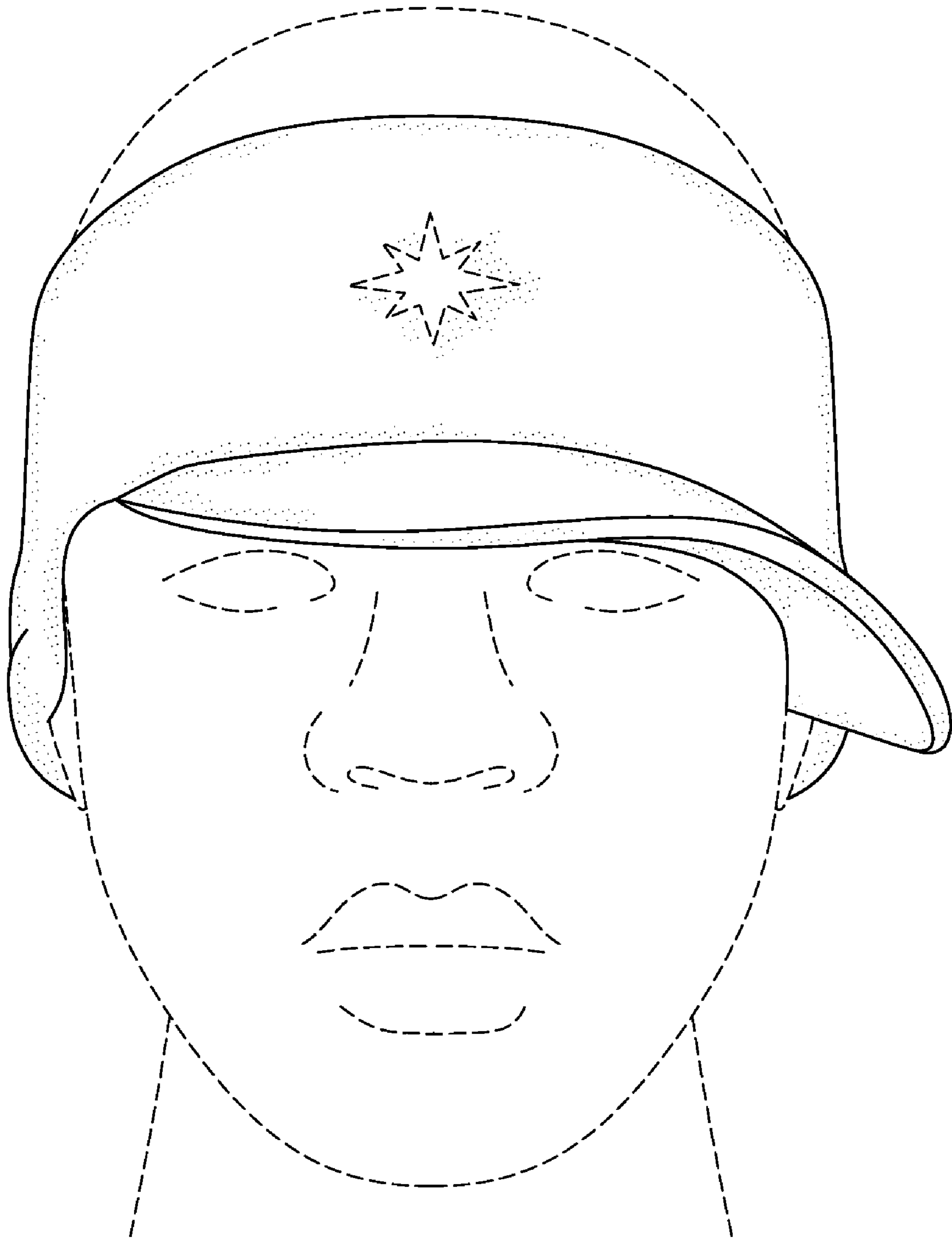

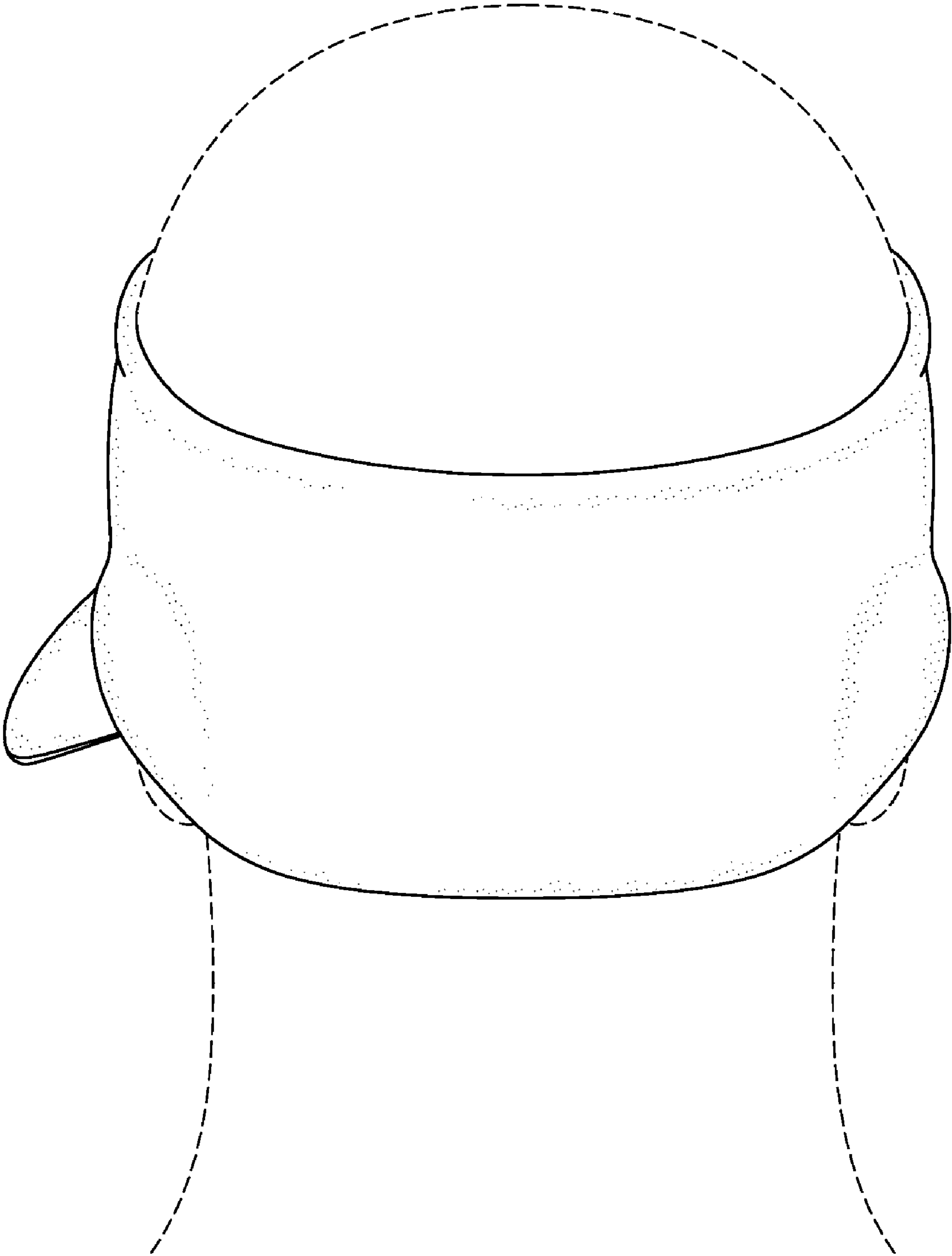

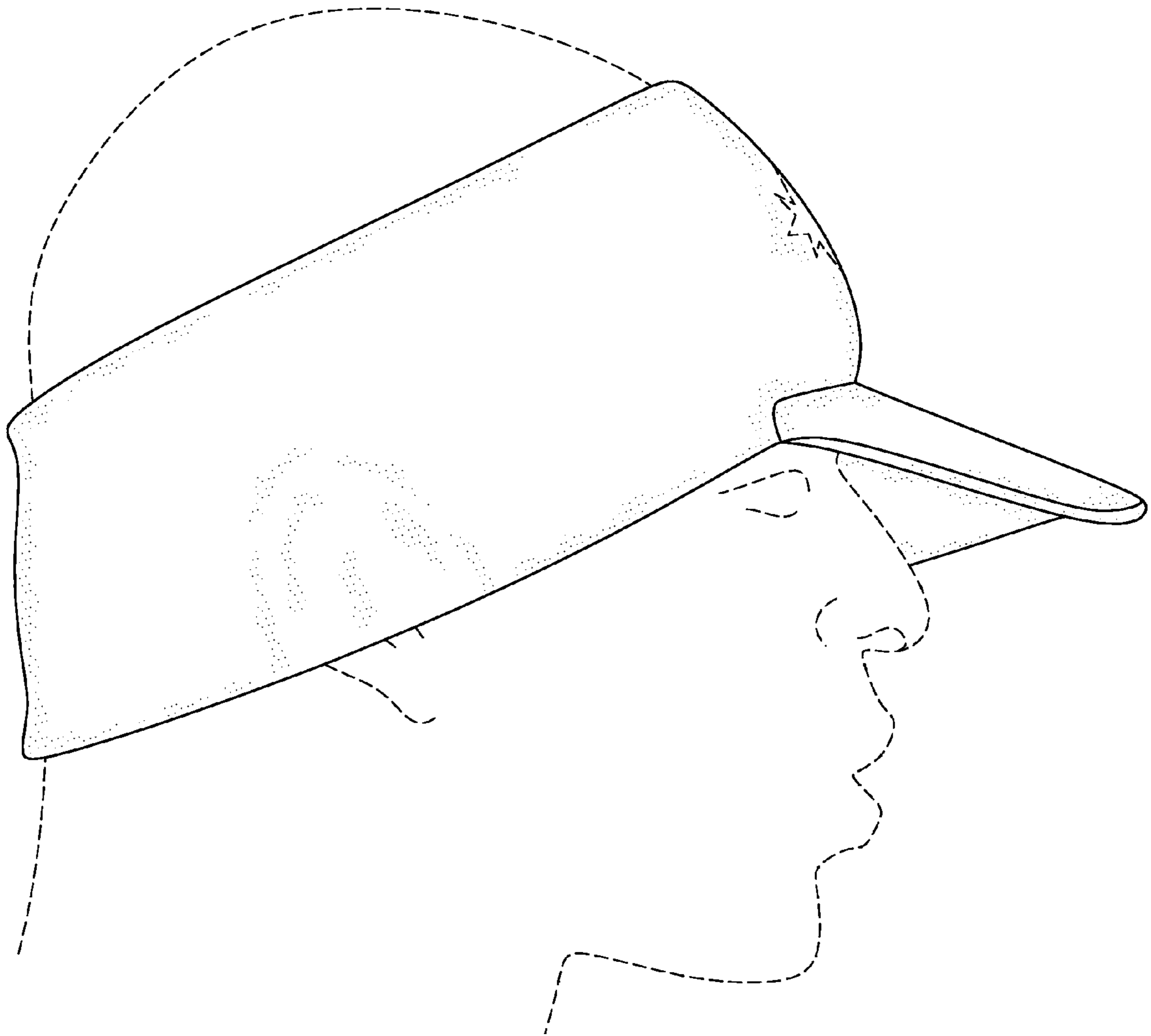

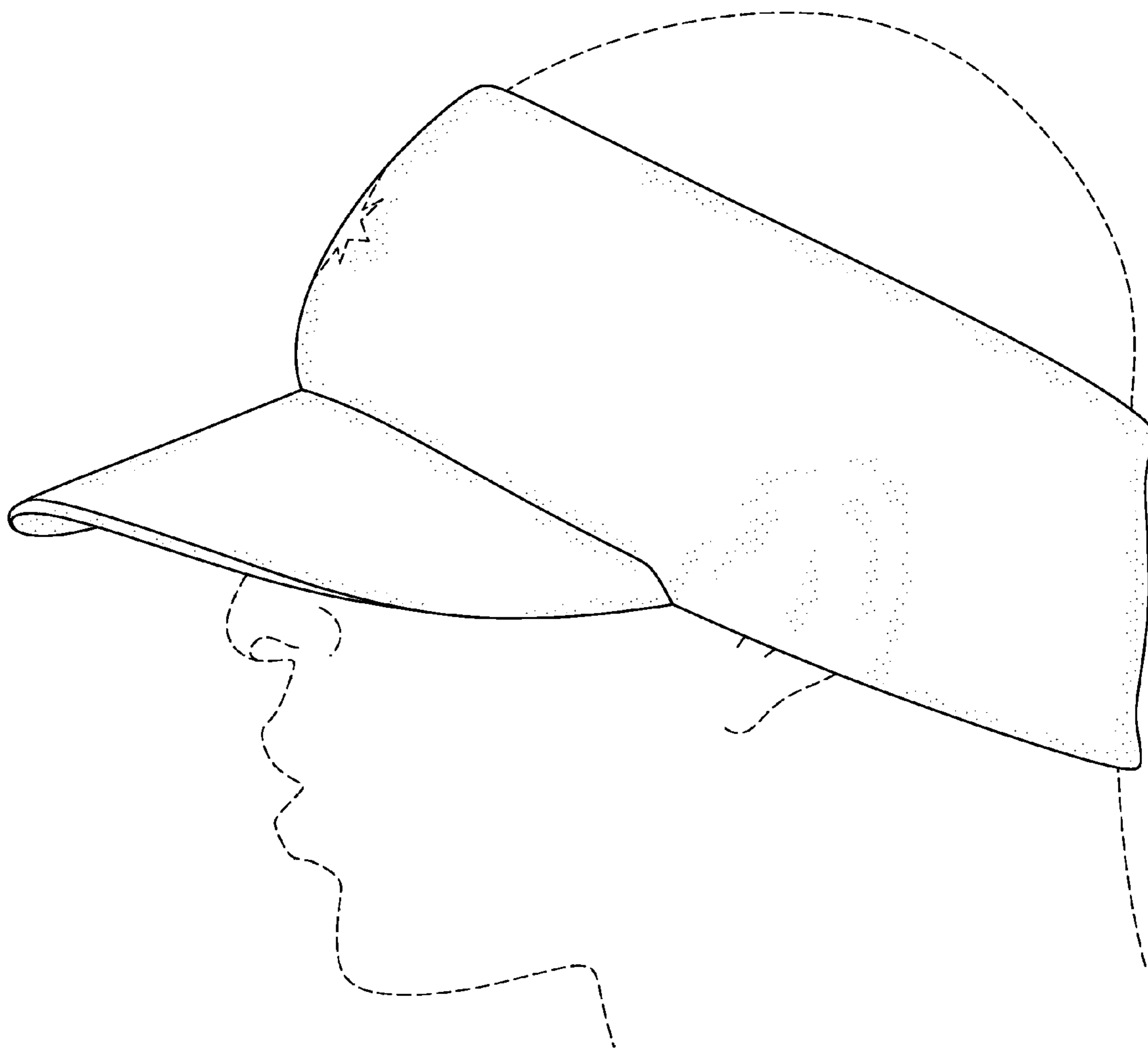

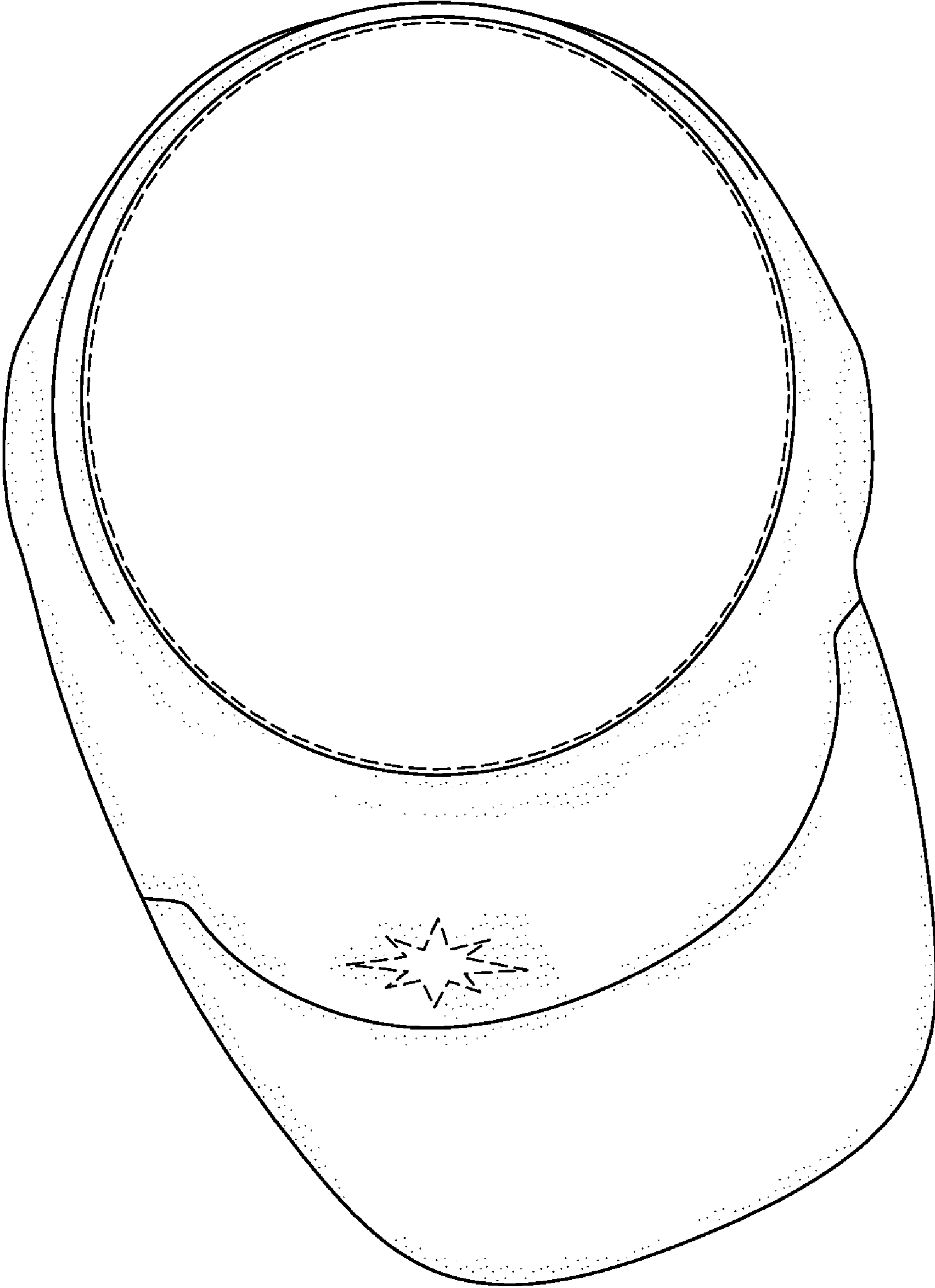
