(57) **CLAIM**

The ornamental design for a keychain USB cable, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a keychain USB cable showing my new design, according to a first embodiment;

FIG. 2 is a front view of the design shown in FIG. 1, the rear view being a mirror image thereof;

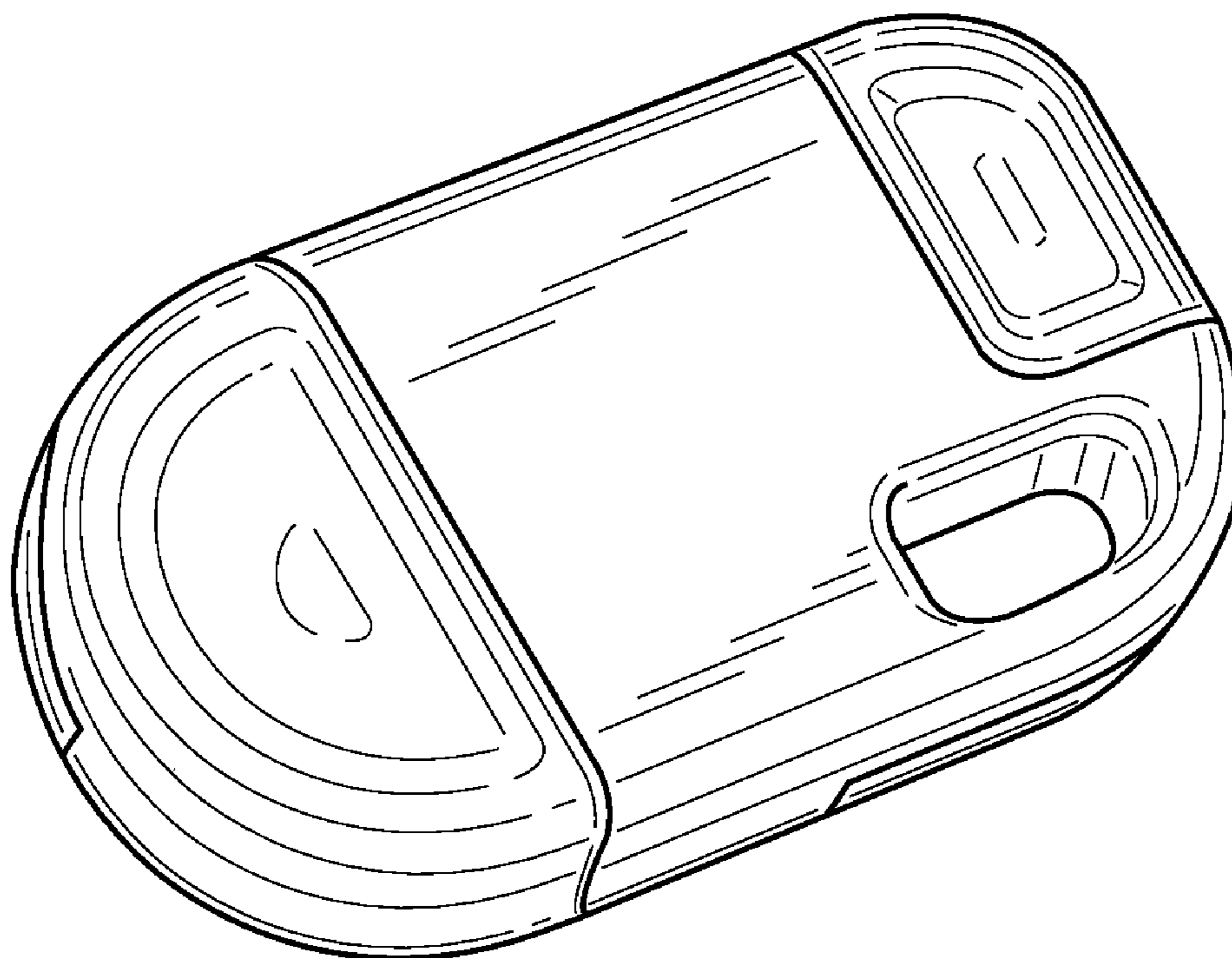
FIG. 3 is a left side view of the design shown in FIG. 1;

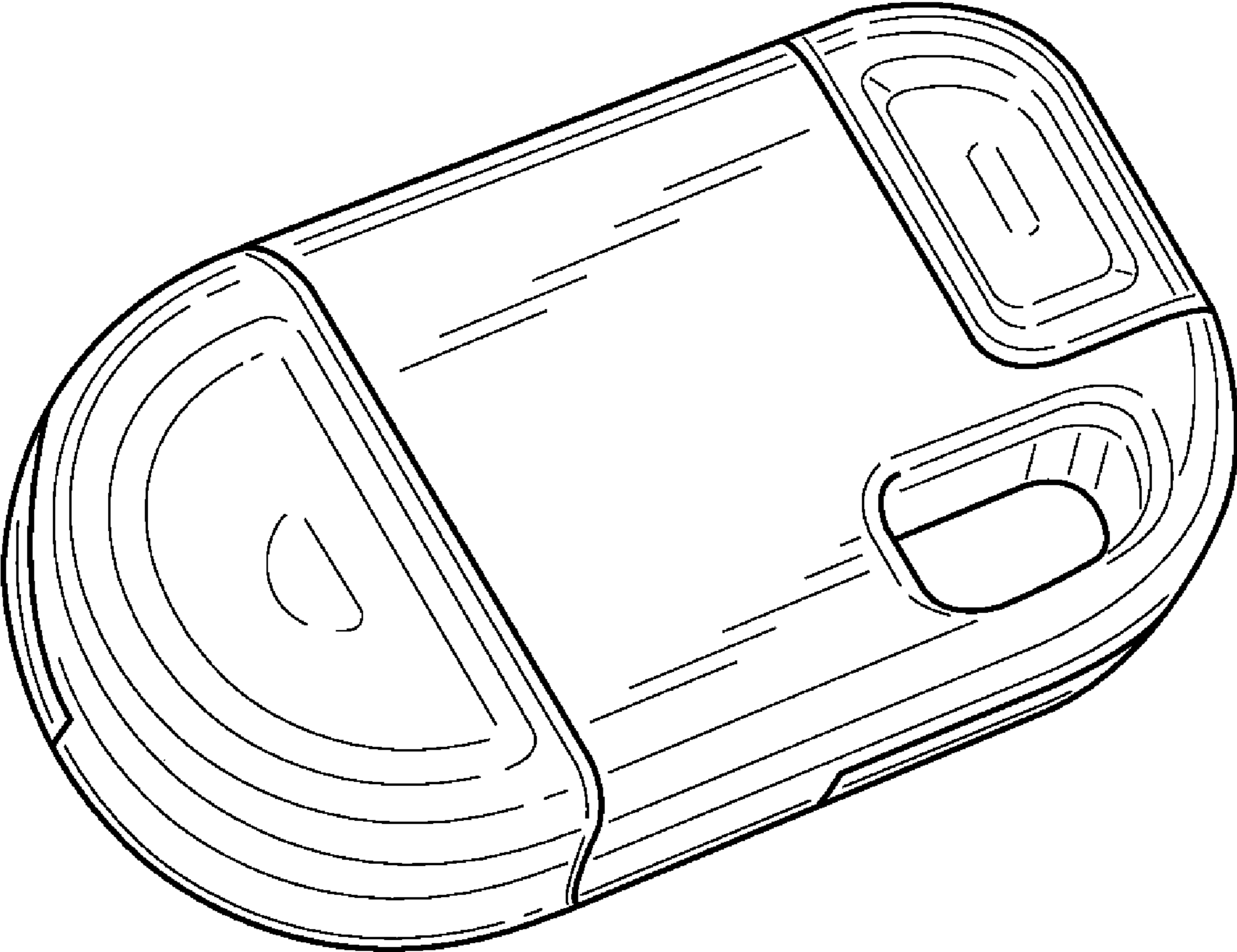

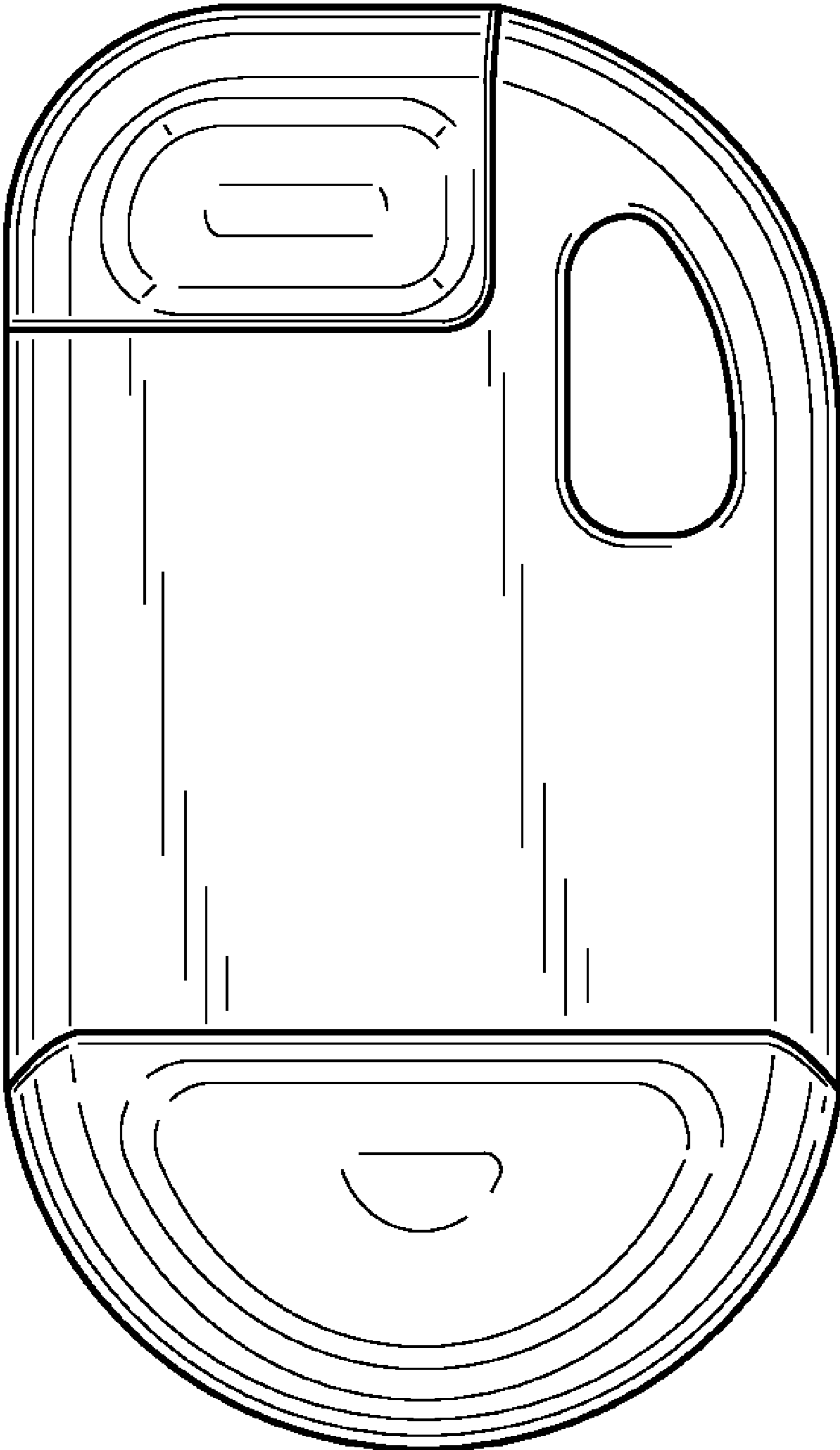

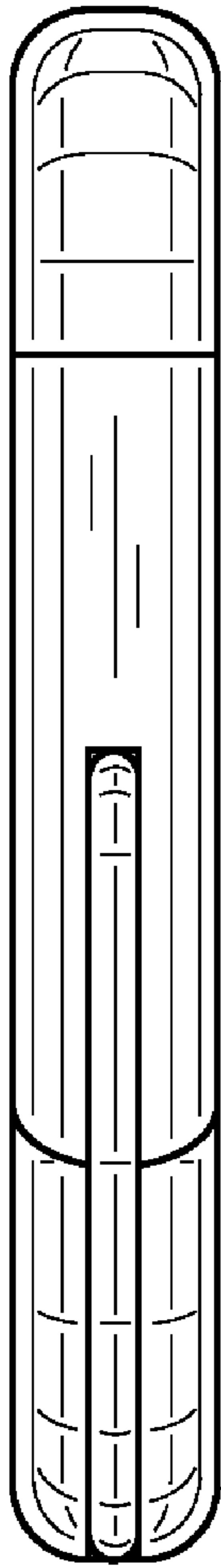

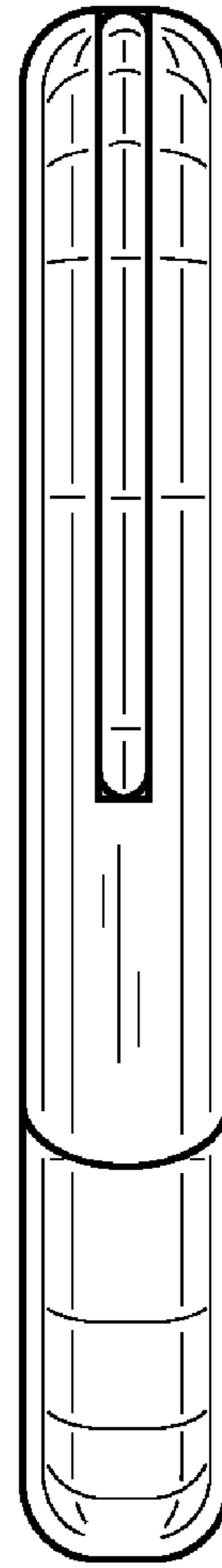

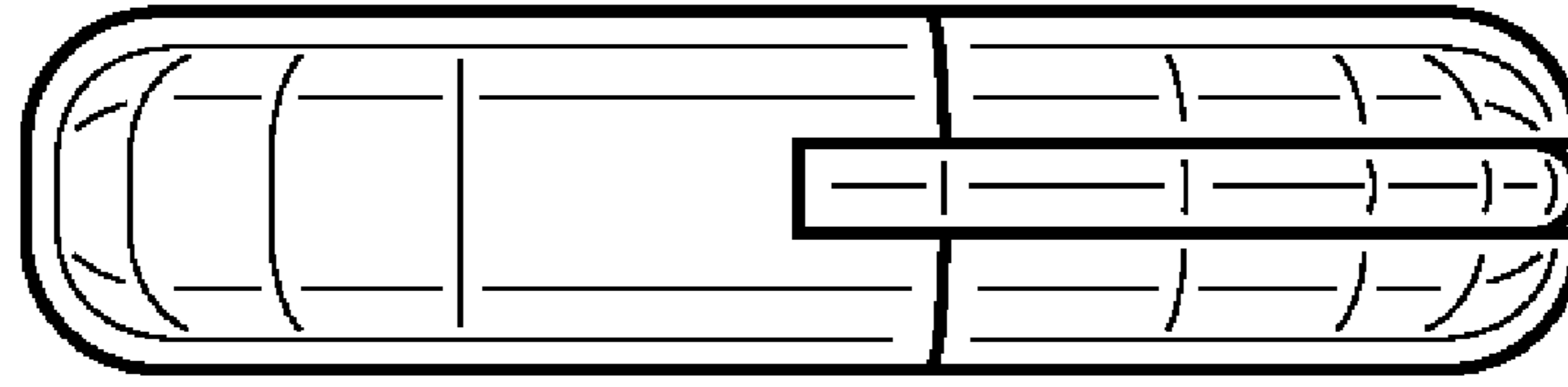

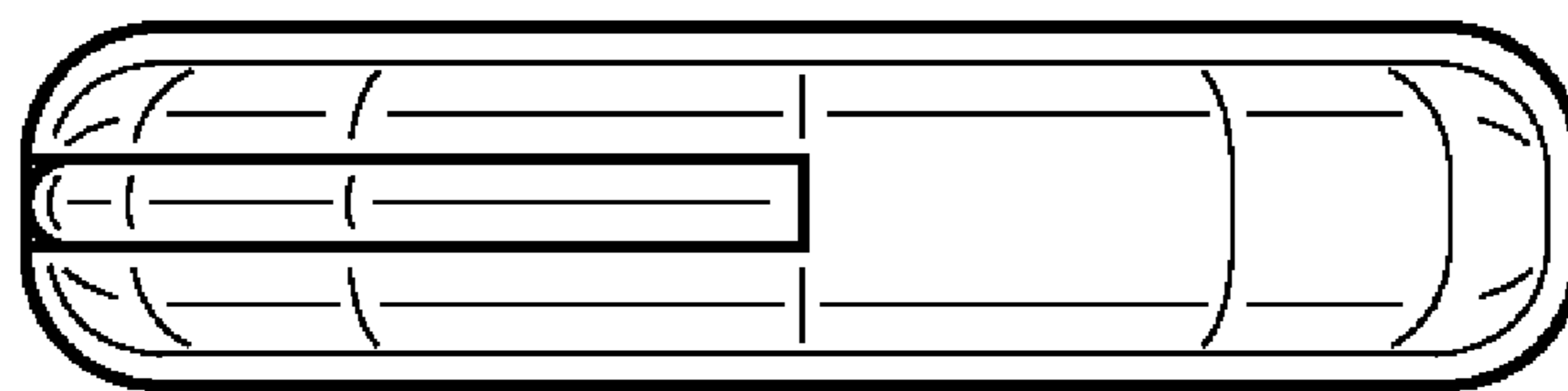
